Renewed anger in N'Delta over oil blocs ownership, others, stakeholders disagree

onths after the Petroleum Industry Act (PIA) was signed President Muhamadu Buhari, the dust raised over some issues not addressed is yet to settle in the Niger Delta. Issues concerning the lopsided allocation of oil blocks which is allegedly skewed in favour of the North and the 3% allocation to the host communities in the PIA have continued to generate discussions and tensions in the region.

While the promoters of the allocation to host communities want 10% of profit made by oil companies be be given to them to address environmental degradation and developmental issues, those opposed mostly from the north believe that will be giving too much to them; hence they settled for 3%.

The Niger Delta plays host to much of the oil which is the main source of revenue that drives the Nigerian economy. The region has, however, suffered untold neglect and abandonment by successive governments that have paid lip service to the plight of the people in the region which is mainly environmental pollution that has grossly impacted the economy life people. Although of the

the federal government has previously set up bodies like the Niger Delta Development Commission (NDDC), the Presidential Amnesty Program and appropriate 13% derivation to oil-producing states, these have not been able to address the decay in the region due to poor funding and management. The people of the region have on every available opportunity called on the federal government to address the lopsided oil blocks distribution so that the people of the Niger Delta will also have a stake in their Godgiven resources.

Recall that Senator Ita Enang, in 2016, drew the attention of the Senate to a critical and raging issue that bothers on the inequitable distribution, saving that 83% of oil blocks in Nigeria belong to northerners while the Niger Delta that hosts the petroleum gets nothing.

Enang, who was then the chairman Senate committee on rules and business said: " some people who own oil blocks in the North are richer than their states and even some oil producing states. Now it is still said that Niger Delta is taking too much when one person's profits from the oil blocks is more than the entire derivation revenue to Niger Delta region."

He called on the federal government to revoke all the either through the PIB or an act of the executive. Despite the PIA coming on stream with the president's signature, the troubling issues are still left unattended while that of the host communities has not be given the desired attention.

The convener and former Secretary, South South and Middle Belt Movement, Tony Erha, says the controversial PIA is not made to address the problems of the oil states. According to him, " an act which seeks to spend only three per cent of the operational budgets of oil companies on host communities yet cede over eighty per cent of oil blocks to a people from the north is the worst sin committed to the people of the Niger Delta."

He stated that what Nigeria has done with the allocation of eighty per cent of oil blocks to the people of a particular region is to transfer the wealth of the Niger Delta to "northerners" and leave the producing area with a mere three percent as provided for in the PIA.

Patrick Osagie Eholor, a Benin-based rights activist, said the PIA should have clearly defined what constitutes host impacted communities rather than leave that to the discretion of oil companies. in it nor favour to a particular region."

He, however, called on oil companies to relocate their headquarters to their operational base in the Niger, saving that if that is done development will come to the region.

According to her: "Since this incident, I fear for my safety and that of my kids...Security operatives especially Ibro and others have made threats and called my relatives, friends, and staff, and searched for my assets to seize and monitor my phone calls and those of friends and relatives. For that reason, I have exited my law firm and sold all my assets, and moved abroad until peace reigns.

"I have done nothing wrong except to ask for a divorce and it pains me that I have to use this medium to address thorny issues but fear that at this point, I would have to put my side of the story on record. It is obvious that a campaign of calumny to total discredit and put me in bad light has begun. "Despite all that has happened, I reiterate that I asked for a quiet divorce which if he had been granted, we would not be where we are today. Divorce is never an easy process for both parties. I reiterate that I hope we can settle our issues privately and I would remain at His Excellency's service should he need

my help, anytime."

The third wife of Alhaji Atiku Abubakar, while reacting to speculations on social media accusing her of disposing of the couple's Dubai real estate illegally, among other allegations explained that she requested for a divorce from her husband and mentioned prominent Nigerians who had mediated in their matter.

Her words: "For some time now, especially in the last few weeks, there has been a whole lot of rumors in circulation about the state of my marriage to his Excellency Alhaji Atiku Abubakar, the Waziri Adamawa, GCON. The stories got more vicious as they continued to circulate. I deem it necessary to defend myself against the calculated propaganda to malign my character and position me in a bad light and damage my name. Without resorting to nonsensical talk, I would address the two key issues at hand: (1) That I asked for a divorce because His Excellency got married again.

"That I asked for a divorce because His Excellency got married again On June. 26, 2021, I asked His Excellency to grant me a divorce in light of the breakdown of our marriage. And, during that period, I told his Excellency that I remain at his Excellency's service to continue to assist him in his activities even If I am no longer married to him. Suffice it to say that several friends of his Excellency tried to mediate in this matter. I thank them most graciously and remain grateful for their efforts Peter Okocha Senator the new wife takes up the baton so I can also focus on giving the kids more care.

"Despite not informing us officially according to northern/ Islamic culture, I knew about his Excellency's new wife from the time Excellency was dating her and when his Excellency eventually married her. I have graciously invited our new wife to my son's wedding in Dubai in 2018 without any ill feelings and congratulated his Excellency when our new wife put to bed

She added: "The Matrimonial home in Asokoro where we reside was gifted to me by him even before we moved into that home from a previous residence. Indeed, His Excellency caused his Private Secretary to process the DEED of assignment documents for the house, which he did and handed. me the documents. I then commenced processing the title to the property.

"During the initial mediation discussion, Excellency denied that he gifted the house even after I showed him the document with the signatures of his aide, his Excellency asked me to give him the deed of gift. When I asked him, where will I and the kids stay when we come to Nigeria, he told me that since I am the one that asked for a divorce, I should find a place to stay, and subsequently, I moved out. "Hence, during my last visit to Nigeria in December, 2021, I stayed at a hotel. I have long released these assets to him and hereby reiterate that thee titles are at his disposal to pick up whenever he deems fit.

Nigerians fear 2023 polls in danger over electoral bill Stakeholders, others disagree as Buhari refuses to sign **By OBAH SYLA (Deputy Editor) and KELVIN OVIRI**

here are fears in some quarters that next year's general elections are imperilled by the President's refusal to sign the electoral bill passed by the National Assembly.

As the country awaits President Muhammadu Buhari's assent to the Electoral Act Bill 2021, many Nigerians have decried what they termed as the spineless posture of the National Assembly in bowing to him by accepting to rework areas which he cited for his refusal to greenlight the bill.

Most Nigerians expected the National Assembly to have stood up to the executive arm of government and overridden the President. They believe that they should have vetoed him on the Electoral Bill 2021(Amendment) by a two-thirds majority vote due to its importance for the transparency and security of the country's electoral system.

According to them, the legislators should have done better to uphold the honour of the National Assembly and show the clear distinction between both arms of government on issues of governance with a firm stance on the bill.

The President's rejection of the bill led to a public outcry for the National Assembly to override him. But the National Assembly in its initiative ignored the calls from Nigerians and reworked sections of concern in the bill. The National Assembly believes that it will be difficult to veto a President whose party is in power apart from the many political, religious and ethnic intrigues and sentiments involved.

Hon Oghene Egoh, a member Amuwo-Odofin representing federal constituency, House of Representatives, spoke on the issue in an interview. Egoh who is also a member of the House committee on the Electoral Bill 2021(Amendment), noted that the decision that the National Assembly took to rework the areas of concern as highlighted

by the President was in the best interest of Nigerians who are clamouring for free, fair and credible elections

He remarked: "Now there is confusion in the Electoral Act Bill 2021 with regards to the issue of a consensus candidate as amended by the Senate. We in the House of Representatives, saw that the best thing was to have both direct and indirect primaries and removed consensus. Why we did that was because we saw that consensus was the easiest way to oppress an aspirant. So we decided that the consensus candidate option should be removed.

"On second thought, we knew we were going to have a meeting with the Senate which has already included the consensus option. We saw from the comments of Nigerians that they are very interested in the electoral bill because they want to ensure that there is a free and fair election. In fact, Nigerians are not happy that the President did not sign the bill. They reached out to us, from my constituency and everywhere, so we decided that for the electoral bill to be signed we need to include a consensus option.

"We do not want a situation where we will send it to the President and he returns it because there is no consensus option. So we did it to satisfy Nigerians. But in doing this we decided to put some clauses in Section (84) to ensure democracy will not be robbed through the consensus. So, we said, if there are people who want to contest an election, everybody has to sign to agree on a consensus. If one or two aspirants say they are not part of it, then you cannot use the consensus option.

"So we have tried to democratise the consensus option so that people will not say the house rescinded their decision just to satisfy the President. We have done it also to satisfy the entire electorates and Nigerians. We know nothing is perfect but electoral bill is near perfect and it satisfies the yearnings of all our people. We included the direct, indirect, and the consensus option with clauses that made it very democratic.

"The time left for the President to sign the bill is very short. So if we send it to the President and he refuses to sign, you find out that it will be too late for us to say that we want to veto him. Do not forget that the word veto is used with serious care. It takes time to get a two-thirds majority to veto a President whose party is in power. Besides political inclination, tribal and religious sentiments always come in."

However, a former national chairman of the All Progressives Grand Alliance (APGA), Senator Victor Umeh, said disagreed with the consensus option as passed by the Senate.

According to him: "When the Senate passed its version and included consensus without specifying how a consensus candidate can emerge to become an option of nomination, I disagreed with the Senate but agreed with the House of Representatives to the extent that the House of rejected that Representatives consensus option.

"I pointed out that the Act premises the steps they will take to nominate a candidate. If you choose direct primary or indirect primary, vou must specify the steps. If you then choose consensus, the Bill did not specify the steps you take to get a consensus candidate; so, to that extent, I felt that the provision for the consensus candidate was vague.

"Now, with the amendment from the House of Representatives which included the clauses for the adoption of a consensus candidate, I am gladly satisfied with all the three options. The amendment states that all the cleared aspirants for an elected position must in writing endorse a particular person as the consensus candidate. If all other aspirants withdraw in writing and endorse a consensus candidate a special convention must be used to affirm its candidacy.

"Now that the three options have been provided, I do not see what the President can hold on to not to give his assent to the bill. Everything is now clear. There is nothing vague in the provisions anymore. It is left for the party to choose the option to select a candidate that they want to represent them in the general elections. If these clauses were not added, the President can say he will not sign. You will not blame him."

Before the decision of both chambers of the National Assembly to accommodate other forms of primaries as stated in clause (84), Buhari refused to sign the amended Electoral Act Bill 2021. This spurred mixed reactions from Nigerians at home and in the diaspora.

Mr. Ibekwe Noyenren supported the action of the President, stressing that it was undemocratic to make it mandatory for political parties to adopt direct primaries. He said: "Let me state clearly

that President Buhari did not refuse to sign the amended Electoral Bill 2021 into law, but he simply declined to assent to it because of the insertion of undemocratic clauses recommending a mandatory application of direct primaries for political parties to choose candidates.

"Buhari is right in declining and the legislature in its wisdom has admitted that Buhari is right and has gone further to begin tinkering with the bill to accommodate other forms of a primary election."

Pastor. Ufuoma Bernard, founder of Godism, also supported Buhari's refusal to sign the bill. He said: "The major reason Buhari refused to sign the Electoral Bill 2021 (Amendment) into law and returned it to the National Assembly is the clause on direct primaries. He feels it should

be optional. The parties should choose between direct and indirect primaries based on expediency."

Mr. Nelson Eware, a political analyst and Senior Special Assistant (SSA) to the Delta State Governor, said that the inclusion of direct primaries is an infringement on the rights of political parties.

According to Nelson, "The President's refusal to sign the Electoral Act Bill 2021 (Amendment) was in order because the Constitution provides that political parties shall determine the mode of primary elections to be conducted for aspirants. Therefore legislating on a single mode of party primaries is an infringement on the rights of political parties to determine the mode of primary suitable for them.

"Although for time constraints he should not have waited till the very last day to withhold his assent. Personally, I am in sync with the reasons adduced by the President because the direct primaries conducted recently by the ruling All Progressives Congress (APC) were all marred by fraud and irregularities. It is chaotic, expensive to administer, and could pose a very huge security risk."

Mr. Dickson Ogubor feels that Buhari who came to power, defeating the incumbent President Goodluck Jonathan in 2015 through massive support of Nigerians, has betrayed the trust reposed on him over his refusal to assent to the bill.

He said: "How can a president who came to power through free and fair elections, defeating an incumbent President, refuse to sign this all-important bill? This amendment will give all the registered members of the various political parties the privilege to decide first-hand who emerges as their party's flagbearer. It is sad that the President that most of us supported can reject this kind of bill."

Electoral bill faces fresh danger from govs, others

igerians are once more apprehensive that there may be fresh plots by powerful interests to scuttle the amended electoral bill transmitted to President Muhammad Buhari on Monday.

A day before the bill was sent to the President for his assent, The *Trumpet* was reliably informed that some governors, especially those of the All Progressives Congress (APC), are leading the opposition to the reworked bill.

The governors who are uncomfortable with the new clauses in the bill are said to be mounting pressure on the President to withhold his assent until the two clauses are amended or dropped.

The clauses in contention are

resignation by appointed political office holders, including ministers, commissioners and others before the 2023 election primaries as well as what they termed 'unworkable' consensus option in picking candidates by political parties.

What has been in practice in Nigeria is for appointed political office holders to remain in office while contesting in their party's primaries.

The Office of the Attorney-General of the Federation and Minister of Justice, Abubakar Malami is allegedly uncomfortable with the re-amended bill.

Meanwhile, civil society leaders who spoke to The Trumpet yesterday warned that Nigerians would not tolerate another ambush against the important law that will guarantee transparency and credibility of the electoral process.

Ariyo-Dare Atoye, Executive Director, Adopt A Goal For



Development Initiative, said: "We are aware that dissenters are already scheming against the reviewed electoral bill re-transmitted to the President.

"We want to put it on record that the main fear of these detractors is the credibility and transparency that a new electoral act will guarantee.

Therefore we wish to urge the Attorney General of the Federation, Abubakar Malami, not to conspire with these dissidents to obstruct the signing of the re-transmitted bill by the President."

Ariyo-Dare recalled that this is the sixth time that the electoral bill will be transmitted to Buhari in the last six years for his assent and cautioned that the President must not entertain any further distraction from anti-democratic forces.

Also speaking to The Trumpet, Samson Itodo, Executive Director of Yiaga Africa, said: "from a principled position, the consensus procedure is antithetical to democratic principles and principles and will result in the subversion of popular will. If not democratically

conducted, it could violate the rights of aspirants to equal participation in party primary election and it limits the choice of voters to candidates who did not emerge from democratic primary elections. The safeguards Assembly though plausible, may not insulate the process from manipulation and capture."

He called on the President to urgently assent to the retransmitted Electoral Bill 2022 within seven days in fulfilment of his promise to bequeath to Nigeria an electoral system that guarantees the sanctity of the vote.

Itodo stressed that an expeditious assent to the bill has become critical given the paucity of time to prepare for the off-cycle governorship elections and the 2023 general election.

"It will bode well for our democracy if the President assents to the bill immediately. This is the President's moment to stand with Nigerians and override the selfish interests of politicians with public interest and assent to the bill," the Yiaga chief added.

It was however learnt that the governors and some ministers were not happy with what they termed "alleged two dangerous clauses in the re-amended bill on Electoral Act."

The clauses include the provision for consensus and another which makes it mandatory for all political office holders to resign if they want to contest for any elective post in 2023.

Again, a source at the National Assembly disclosed that the battle between the lawmakers and the governors has once more shifted to the Presidency. "This time, we will not go back for any reconsideration of the bill,' the source said defiantly.

Before the Clerk to the National Assembly, Mr. Olatunde Amos Ojo, transmitted the authenticated copies of the Electoral Bill 2022 to the President, those opposed to the reworked document accused the lawmakers of inserting the two new clauses on consensus and resignation by all political office holders before contesting for the 2023 poll.

While the senators and members of the House of Representatives agreed on consensus, they recommended that before such a candidate can emerge, all contestants must sign a written agreement that they have consented to the adoption of the aspirant.

The re-amended bill also gave as condition that if one of the contestants is dissenting, no one can become a consensus candidate, Instead, all the contestants will either go for direct or indirect primary election. It was further learnt that the Senators and the Representatives put the difficult clause on consensus to stop the governors from imposing any anointed aspirant on the political parties. They contend that the governors "can no longer work to the answer." Political pundits and many Nigerians will be keen on the outcome of this fresh battle which may again truncate the hope for an enduring law to safeguard the electoral process.

Buhari launches N62b HIV Trust Fund As Dangote appeals for support toward eradication of AIDS in Nigeria

Muhammadu esident Buhari has launched a N62 billion trust fund to help Nigeria end AIDS as a public health threat and place more people living with HIV on treatment annually

Speaking at the launch of the HIV Trust Fund of Nigeria (HTFN), Buhari pledged that his administration would continue to prioritize health interventions to address killer diseases and public health emergencies.

"At the last United Nations General Assembly High Level Meeting on HIV/AIDS, I made a call for a renewed global action to address the HIV/AIDS epidemic in Africa.

"Ending AIDS as a public health threat in Nigeria will require increased domestic funding. We have continued to make good our commitment of placing more people living with HIV on treatment annually using national resources.

"However, strong domestic resource mobilization with an enduring partnership and shared responsibility is required to sustain the response to HIV and other emerging public health emergencies," he said. Buhari noted that Nigeria's

HIV response.

He commended the National Agency for the Control of AIDS (NACA) and the Nigeria Business Coalition Against AIDS for their efforts in establishing the HIV Trust Fund of Nigeria to secure a generation of babies free of HIV.

He also expressed delight with the attendance in person of notable global key players in HIV response and from the private sector at the event and the pledges made.

"Going forward, I hope The HIV Trust Fund of Nigeria will galvanize more of the private sector and other partners to surpass the target of Sixty-Two Billion Naira in the next five years," he added.

In his remarks, the Secretary to the Government of the Federation, Boss Mustapha announced that since 2005 about 6.2 billion dollars has been spent on HIV response in Nigeria.

Imo assures traders on reallocation of market

The News Agency of Nigeria (NAN) reports that the state Commissioner for Commerce, Simon Ibegbulem, stated this in Owerri, yesterday, when he led a team of journalists to inspect the project.

Ibegbulem said that the project, which was over 40 per cent completed, would be rounded up and inaugurated by December 2022.

He said the market, which is located at the heart of Owerri metropolis, was pulled down by former Governor Rochas Okorocha's administration. He disclosed that the market had 2,925 lock-up stalls and would have modern facilities, a bank, police post and fire service, among others, when completed.

He said on completion, the state government would collaborate with the market association to ensure that traders, who lost their shops in asked to pay less, as a way of compensating them for their losses," Ibegbulem said.

Speaking, Commissioner for Information and Strategy, Declan Emelumba, explained that the governor decided to rebuild the facility, because it remained the only Owerri ancestral market.

"When the governor assumed office, Owerri people visited him and lamented the abandonment of the market after it was demolished. They pleaded with him to rebuild their only ancestral market and the governor assured them that he would rebuild it. So, he has fulfilled his promise," Emelumba said.

He further said the project was being executed through a Public Private Partnership (PPP) arrangement.

Émelumba also conducted journalists round the fashion cluster, being built by the state, in conjunction with the Federal Government to promote small and medium enterprises.

The facility is equipped with over 500 modern machines for sewing and designing and solar panels for 24-hour electricity supply. Emelumba said the facility would provide the platform for trained tailors and fashion designers, who had no capital to acquire their own machines, to rent and do their businesses. He said the state government also gave N250, 000 startup capital to 1,500 youths, who were trained in dressmaking, hairdressing, shoemaking and welding, among others.

Court okays Customs bid to contest N2b judgment debt •ExxonMobil protests against verdict

The Supreme Court has granted the Nigeria Customs Service (NCS) board's application to challenge the February 6, 2014 judgment of the Court of Appeal that awarded a N2.048 billion judgment debt in favour of Innoson Nigeria Limited. A five-man panel of the

court, in a unanimous ruling, upheld the prayers of Customs the applicant canvassed through its counsel, Tayo Oyetibo (SAN) by a Motion on Notice filed on November 9, 2020.

The panel comprised Justices Olukayode Ariwoola, John Inyang Okoro, Helen Moronkeji Ogunwumiju, Abdu Aboki and Tijani Abubakar.

Justice Aboki, who read the panel's decision on January 14, 2022, agreed with the lead ruling of Justice Abubakar that Customs' argument was meritorious.

The court held: "Having granted the application, therefore, the following orders are hereby made: "Leave is hereby granted to the applicant to appeal as an interested party against the judgment of the Court of Appeal, Ibadan Division in appeal number CA/1/258/2011. "Time is extended to the applicant to seek for leave to appeal against the judgment of the Court of Appeal on grounds of mixed law and facts. "Leave is hereby granted to the applicant to appeal against the judgment of the Court of Appeal, Ibadan Division, on

Court awards Ubani N12m for illegal detention

The Federal Capital Territory High Court, Abuja has awarded the sum of N12 million in favour of Dr Monday Ubani for unlawful detention by the Economic and

Financial Crimes Commission (EFCC).

The former second vice President of the Nigerian Bar Association (NBA) was detained illegally by the anti graft agency for over 20 days on the ground that he stood surety for a woman

(Dr.Mrs Ngozi Olejeme), who jumped bail.

Consequent upon his detention and the tension generated, Ubani dragged the EFCC to court, asking for N5 billion in damages and public apology.

Delivering judgment on the

matter, the trial judge, Sylvanus Oriji was of the view that the detention infringed on the right of Dr Ubani and therefore entitled to the reliefs sought for.

The judge declared the detention illegal and awarded the sum of N12 million as damages

to the plaintiff against the sum of N5 billion sought for.

The court, in the judgment, however, refused to order the EFCC to offer public apology to the applicant for the illegal detention.

Responding, Ubani said the decision had further settled the already established law that a

surety has not committed any crime when the person he stood surety jumps bail.

According to him, the only legal implication for the surety is to show cause or forfeit the bail bond. Arresting and detaining such a surety, he said, amounts to a flagrant violation of the rights of that individual.

Pupil sues Abuja secondary school for N2.1bn

Junior Secondary School student of Baptist High School Abuja, Mr. Davies Dada, has dragged the school to court over alleged negligence, which led to bodily injury he suffered while in care of the school.

Dada, is specifically claiming the total sum of N2.1 billion from the school as compensation for cost of medical treatment, cost of instituting the legal action, general as well as examplary / punitive damages.

According to the student, in a suit number: CV/2437/2021, the school failed in its duty as "loco parentis" by not noticing or providing necessary care and attention to him - after he fell and could no longer walk while participating in the school's Physical and Health Education Practical Examination for the Basic Education Certificate Examination 2020/2021 academic session.

The alleged neglect of the school to either informed the claimant's parents or provide urgent medical attention, the student said resulted in him suffering what doctors called "Slipped Upper Femoral Epiphysis (SUFE)" on his the student's House Master but

In the suit filed by claimant's lawyer, Arinze Obetta, problem started on July 5, 2021, when the student was asked to participate in a 100 meters race, despite a reported health condition.

In a Witness Statement on Oath, the mother of claimant, Mrs Sandra Davies, alleged that but for the defendant's negligence, her son would not have participated in the said Physical and Health Education Practical Examination, which resulted to physical and psychological injury, suffering, pain and monetary expenses.

The deponent claimed she had earlier informed some members of staff of the school of claimant's health condition after they noticed he was limping during the second term holidays of 2020/2021 session.

According to her, they had taken the lad to a hospital in the Wuse Area of Abuja, where doctors after treatment advised that student should not be allowed to stress his right leg.

She added that the information was not only passed to

right leg and "Prophylactic Pinning-in-situ" on the left. the drugs to be administered on claimant were handed over to the Matron (head nurse of the school) for proper administration.

She however lamented that all these were ignored by the school while senior students were also allowed to punish his son by asking him to do "frog jump" despite his health condition.

Nigeria-Cameroon trans-border drug traffickers in NDLEA's net

ational Drug Law Enforcement Agency's NDLEA's) operatives have arrested three trans-border drug barons while attempting to smuggle 48,000 tablets of 225mg Tramadol through Mubi, Adamawa State to neighbouring Cameroon.

Over 1,500 kilogrammes of imported Loud and other illicit substances have also been intercepted in raids across Lagos and Edo states.

The spokesman of the NDLEA, Femi Babafemi, in a statement, said those arrested

at Tsamiya Junction, Madanya Road, Mubi, in Mubi North Local Government Area of Adamawa State are Mohammed Hussaini, 32; Adamu Bella, 18, and Mohammed Umar, 18.

He said the suspects claimed the drugs were being taken to Bagira town along Nigeria-Cameroon border to be delivered to some Cameroonians for onward delivery to Maroa in Cameroon.

Babafemi added that similar interdiction operation was carried out at Alaba Rago area of Lagos, where operatives of the state command of the agency intercepted 1,200 parcels of imported Loud, a strong variant of cannabis suspected to have been smuggled into the state from a neighbouring country with a total weight of 1,229 kilogrammes. The NDLEA's spokesman said that in another raid last at Suru Alaba, Ajeromi-Ifelodun Local Government Area of Lagos State, operatives arrested one Ibrahim Musa, 25, with 18,530 tablets of Tramadol, Rohynol, Diazepam, Exol-5, and 138 bottles of Codeine. Babafemi also revealed that at the Murtala Muhammed International Airport, Lagos, operatives at the SAHCO export shed of the airport during their routine cargo search intercepted a consignment

of 22 international passports of six different countries concealed in a bag of gari among other food items.

He disclosed that nine of the passports were three each of UK, France and Portugal, while the rest were: Nigeria -eight; Ghana -four, and Cameroon -one.

He said also at the airport, operatives equally recovered 12 parcels of cannabis weighing 4.95 kilogrammes concealed in a carton of Golden Morn packaged for export through the SAHCO export shed.

Babafemi explained further that in Plateau State, a team of NDLEA officers last Friday arrested two suspects; Emeka Ezenwa, 37, and Julius Akingbe, 45, for being in possession of 126.5 grammes of methamphetamine concealed inside a DVD player coming from Lagos, while a raid in Kampani Zera- Wase local government area of the state on Friday led to the arrest of Fatima Sadiq, 20, who was caught with 21.3 kilogrammes cannabis.

Six feared dead as illegal gold mine collapses in Cross River

The police have confirmed that an illegal gold stone mine has collapsed in Umai community, in Biase Local Government Area of Cross River State, in South-South Nigeria.

The police however declined to confirm the number of people who lost their lives in the collapse, asking journalists to be patient as investigation is still ongoing.

Cult clashes leave five dead

o fewer than five residents of Ilesa, Osun State, have been killed during clashes between two rival cult groups and suspected land grabbers.

One witness, Mr Bisi Oyetade, said the hoodlums, who also operated as land grabbers, were told to stop extorting workers at the site by some suspected cult members, said to be relations of the house owner.

Oyetade explained that in the process, clashes broke out and a suspected cult member was overpowered, dragged to the bush and hacked to death by the gang protecting the new building.

He said that the hoodlums

regrouped at night and avenged the death of their

colleague. The group stormed Ijoka

Area of Ilesa and killed another suspected cult member.

He added that in a bid to maim their opponents, an innocent woman was shot dead by the warring suspected cult members on Friday night.

According to him, the rampaging youths resumed their hostilities on Saturday and ended up killing two innocent residents.

The police have since launched an intensive manhunt for the suspects while some patrol vans of Ijamo and Ayeso Police Divisions in Ilesa were seen patrolling the town in order to restore peace and order.

All efforts to speak with the Police Public Relations Officer, PPRO, DSP Yemisi Opalola, on the matter proved abortive.

Ooni declares curfew in Ife as robbers invade community

he Ooni of Ife, Oba Adeyeye Ogunwusi, has declared restriction of movement from 11pm to 5.00am daily, following a sudden rise in incidents of armed robbery within his domain.

Confirming the development, Lowa Adimula of Ife, High Chief Abraham Adekola, who is the third in line to Ooni, said the Ooni-in-Council had to put up the measure on behalf of the monarch, to curtail criminality in the town.

Chief Adekola, who said Oba Ogunwusi was in Sokoto on official assignment, when the armed robbery incidents started happening, added that the palace chiefs had to act after briefing the royal father, in a bid to arrest the situation.

Adekola, who assured that no one would be molested before or during the curfew, said since the restriction was imposed, there was a drastic reduction in cases of armed robbery in the town.

"It is true, restriction of movement had been imposed in the name of Baba Ooni. He is in Sokoto on an official assignment but after consultation with him, we agreed to impose restrictions from 11pm to 5am daily until the situation improves.

"During the restriction, no night party, vigil or movement. It is just to check criminality in the town."

the visit was to strengthen the existing collaboration between the two organisations.

While speaking on the activities of the Special Female Squad both in Federal Capital Territory and other states in the Country, the Commander noted that the NSCDC ADS was primarily established as a response to

the clarion call by the Federal Government, through the Office of the Minister of Interior, Engr. Rauf Aregbesola, who tasked the NSCDC Commandant General to develop a robust scheme that would tackle the menace of insecurity in Schools.

This pragmatic move of course, is in tandem with Federal Government's safe school initiative and since formation the Special Female Squad has not rested on her oars.

"Immediately the SFS was established, we leveraged on the maximum support given by the Commandant General, who had already set up a committee of intellectuals in corps that conducted a vulnerability studies on all schools across the federation. It was deduced that from over 82,000 government and private schools in the country, about 62,000 had no perimeter fencing or any security measures put in place to forstall external aggression and this informed determination to put an end to kidnapping and incessant abduction of school children accross the country," she said.

She explained further that the corps has employed a non-kinetic approach in tackling insecurity by carrying out sensitisation and awareness programmes accross primary and secondary schools accross the 36 states and the Federa Capital Territory, Abuja; as the students are being exposed to necessary security tips that will enhance their knowledge and make them develop a security conscious mindset in their dayto-day activities.

In her response, AIG AIsha'atu Abubakar, praised the NSCDC Commandant General for giving the female personnel the opportunity of exercising their fundamental strength, by contributing their quota to protection of lives and property of the citizens; adding that women are diligent and dogged agents of positivity when given the much needed support and encouragement.

She affirmed that her office would facilitate a more elaborate interactive session, security workshop and seminars between the two agencies, so as to foster and strengthen the existing synergy and engender stronger collaborative effort in the fight against insecurity.

burning the head in a pot. They told the police in the presence of a mammoth crowd that they wanted to use it for money ritual.

The police have taken the body away to a mortuary," a source told our correspondent on Saturday.

The Ogun State Police Public Relations Officer, Abimbola Oyeyemi, confirmed the incident.

Oveyemi stated that the three young boys have been arrested by men of Ogun State Police Command.

I learnt money rituals via Facebook, says Ogun teenager who killed lover

teenager, Soliu Majekodunmi, who slaughtered his girlfriend, Sofiyah, for suspected money ritual purposes has explained that he learnt the practice through Facebook.

Majekodunmi said he typed 'how to make money ritual' on Facebook and got the detail, adding that the link instructed him to behead and burn a female skull in a local pot.

Majekodunmi and three other suspects spoke on Monday when they were paraded at the state police headquarters, Eleweran, Abeokuta, Ogun State.

Majekodunmi, who had fled but was later arrested, said after learning the money ritual skill on the internet, he conspired with

others to execute what he learnt. The 18 year-old suspected killer,

while speaking with newsmen on how he killed his girlfriend, said he squeezed her neck and beheaded her immediately after he had made love to her.

He said he conspired with his friend, Mustakem Balogun, to lure the slain girl to their apartment in the Oke Aregba area of Abeokuta, where she was killed.

They confessed to killing the girl, claiming that they concluded on money ritual because they wanted to ride exotic cars and live in luxury apartments.

The suspects added that they purchased three pigeon eggs known as 'Eyin Aparo' in Yoruba language and other fetish ingredients which they added in the local pot. They, however, said the sum of the money-making ritual ingredients cost N2,500 which they contributed among themselves.

The State Police Public Relations Officer, Abimbola Oyeyemi, while parading the suspects said the incident was a result of bad parenting.

The police spokesperson urged Nollywood actors to desist from promoting money ritual movies, just as he urged religious bodies to desist from preaching prosperity.

He said, "This can only be described as a superlative degree of callousness. It is despicable and barbaric at this time for somebody to still have it in mind that money can be made if he sacrifices the life of a fellow human being. More so, what is it that teenagers want to use money for that will lead them to this type of heinous crime? It is still beyond the comprehension of a normal human being

"I want to say that many parents have failed in their responsibilities. This is a result of bad parenting. It is a result of complete failure of parental responsibility because if this thing has not been encouraged by the parents, I do not believe that any properly brought up child will want to embark on this type of criminality.

"I also want to advise that the generality of people have a lot of work to do, the religious bodies, entertainment bodies and everybody that has one thing or the other on protecting life and properties.

"The religious bodies should stop preaching only prosperity, you should be preaching morality more than the way you preach prosperity. Nollywood actors and the movie censors board have a lot to do to regulate the type of film they produce because some of them(ritual suspects) learn it in movies."

Sunday Olatunbosun, who spoke on behalf of the slain girl's family, urged the police to help ensure justice over the death of Sofiyah.

He said, "We want justice for her and I am speaking on behalf of the family, all that we want is justice, nothing else.

"Her mother is in a very critical situation, even we needed to give her sleeping pills before she was able to sleep. Her father is late and the situation of her mother is very critical at the moment. We had to take her away from Abeokuta to Ifo area because of the incident."

EFCC detains airline MD over \$900,000, other Hajj funds

The Economic and Financial Crimes Commission, EFCC, has detained the Managing Director of an airline (name withheld) over alleged diversion of Hajj funds.

According to available information, he arrived at the headquarters of the EFCC at about 11.00am on Monday.

As at press time, he was still with the anti-graft agenciy which invited him over a case of alleged diversion of 50 per cent of funds paid to him by the National Hajj Commission and additional \$900,000 for the airlift of pilgrims in 2019.

He allegedly received the funds as mobilisation, but did not execute the contract.

The spokesman of the EFCC, Wilson Uwujaren, confirmed the development to newsmen.

My boss promised me N30m to get human parts, suspect alleges

suspected ritualist, Timothy Odeniyi, has been nabbed by operatives of the Ondo State security outfit, codenamed Amotekun, for allegedly being in possession of human parts.

The 35 year-old suspected ritualist was paraded by the security outfit after he was caught with the human parts.

Odeniyi was getting set to leave for Lagos when he was arrested at Ondo Town motor park with the human parts.

However, there is a dispute over the source of the human parts.

While the Ondo State Commander of Amotekun, Chief Adetunji Adeleye, said the suspect killed the victim, removed the human parts and hurriedly buried the corpse, Odeniyi insisted during the parade that he exhumed the corpse from a grave.

The suspect, a truck driver, said his former boss in Ibadan, the Oyo State capital, introduced him to the business of making money through rituals.

Odeniyi said: "I went to the burial ground to cut the legs and hands of one of the corpses buried there. "Before I was caught, I had planned to take the human parts to the person that sent me in Lagos.

"He promised to pay me N30 million once I deliver the items. "I only went to the burial ground in Sabo area of Ondo

town to cut the parts. "I didn't kill anybody and this is my first time. I used to be a trailer driver. The person that sent me used to be my boss when I used to drive truck.

"I used to dump it in a waste bin and he will send those who will pick it."

But Adeleye said: "We want to intimate the public on the need to be very careful.

"Of late, the trend is shifting gradually from daily kidnapping to ritual killings.

"The public should be generally careful about the craze to make money by this young men.

"We have a suspect in our custody, Timothy Odeniyi, who was caught and arrested with legs and hands of human being wrapped in paper.

"Upon interrogation, he took us to where he severed the body of the person killed and hurriedly buried the person in a shallow grave.

"He was arrested in Ondo Town and committed the crime on January 30, 2022.

"We want to warn the public to be careful of who they go out with.

"We have a number of them that we are still investigating that will go out with their girlfriends solely for her purpose of killing them for ritual purposes.

"I think the public should be wary and careful about this."

Adeleye equally revealed that no fewer than 35 suspected kidnappers, armed robbers, ritualists and vandals were arrested in the outgoing month.

He said: "Underage herders as well as criminals who disguised as scavengers were also arrested in various parts of the state.

"Within this January, we arrested about 150 suspects of various crimes and out of them 32 are still currently with us.

"Some of them are suspected kidnappers, armed robbers and some of them were involved in the vandalisation 132 KVA power lines under construction.

"Some of them were ex-convicts that ran away from prison cells, some of them jumped bail and rearrested.

"Some of them pretend as if they are scavengers, but we found weapons, guns, locally made

pistols in their trolley.

"The teenagers among the suspects were caught contravening the underage anti-open grazing law. "They were found to be grazing with about 300 cows. They were about 10 to 11 years of age.

"We are still waiting for their

parents to come and face the music. Some of them will be handed over to the police for further investigation, especially the homicide issue.

"After discreet investigation, the remaining ones will be taken to court for prosecution."

n a video that has gone viral, three boys, all below 15 years, were hanging around someone's gate. When the owner of the compound asked what they were doing there, they said they were there to "hustle". When asked what that meant, they boldly responded that they were looking for "yahoo, yahoo work^ to do.

This graphically shows the abysmal level that Nigeria has degenerated to. These young children, who are supposed to be among the leaders of tomorrow, have only one consuming and dangerous ambition of joining the fast growing ranks of the "yahoo, yahoo" criminals. Money ritual: Nigeria's new normal (1)

eaching Oral African Literature affords me the opportunity to critically engage magic, sorcery, animism, and voodoo as ritual practices. No doubt, these practices are global but there is an unspoken conspiratorial conviction about their primordial origin in Africa where they are domiciled and perpetually revalorised. Therefore many people view them as African phenomena. In truth, Africans cannot deny their collective predilections towards these practices because they formed part of their indigenous religion, tradition, and culture before the advent of Western ideologies which, according to Chinua Achebe, led to things falling apart. Beyond the spiritual, symbolic roles of these ritual practices, they provide a framework for traditional societies to formulate codes of moralities and existential ethos. These practices have continued over time but continuity should provide a balance where hierarchies of different tensions are resolved which in turn form a historical logic. The re-enactment of rituals for money and sundry purposes lacks any historical logic. In the days of yore, magic, sorcery, animism, and voodoo as ritual practices served various purposes for Africans. When there was drought and famine, Africans offered sacrifices to their gods. When sickness ravaged the land, sacrifices were offered.

When circumstances confounded the living, they consulted the dead to ask questions. Generally, through constant propitiations via ritual processes, Africans lubricated the spiritual thoroughfare between them and their ancestors. In contemporary times, these practices currently represent significations of spiritual vulgarity in many parts of Africa including Nigeria. The most offensive is the morbid recourse to these practices by Nigerians for diverse purposes including wealth creation. Today, magic, animism, and voodoo as ritual practices have become, unfortunately, avenues to advance material progress, victory in elections, success in businesses and many other indulgences which represent the idolization of mammon, the irreverent, vindictive god of wealth. Every day our newsreel is inundated with various accounts of how young men of different ages engage in rituals to make money. These accounts summarily violate the inner sanctum and sensibilities of a normal, well-disposed person. They grate at our humanness and question the future of our society. Currently, the African practice of spiritual regeneration through diverse ritual processes has become a source of diabolic fetishism to create wealth. I watched in utter horror a video where young men were defecating in public and eating their human waste for money rituals. No arrest was made, no voice of admonition, and no one bothered to show concern. Rather, people were busy video-recording the scene to circulate on various social media platforms. Indeed, our generation is collapsing fast. I read the story of a 28-year-old young man who, after graduation, could not secure a job. According to the account, the young man used one of his testicles to undertake a ritual and enter into a convenient with the devil, the suzerain

ruler of the kingdom of perdition. Afterwards, the young man became a billionaire. Promptly, a chieftaincy title was conferred on him by the elders in his village. He built a hospital, constructed roads, reconstructed the market square, demolished the local church, and built a cathedral. Three years later, thunder strike mangled his body beyond recognition. He writhed in pain and confessed his dealings with the devil before he died. According to another account, a 24-year-old young man performed a money ritual. After the ritual, he was given a dog to take home and instructed to allow the dog to bite his mother. After biting his mother, the woman died within two weeks and was put in a mortuary. Then he slaughtered the dog and ate the meat alone. Thereafter, his Building Material business blossomed and he became a billionaire. The inherent catch-22 is that he must not bury his mother. To this day, the woman is still in the mortuary one year after she died. The boy gave the church and the village elders stupendous money to look away and not talk about the burial. Any day the woman is buried, the boy's wealth will vanish. The two scenarios above represent millions of other cases where our young men, in their pursuit of self-glorification and inordinate craving for materialism, indulge in despicable, horrendous practices, subverting African spiritual heritages to perpetrate evil. Apparently, the youths are not the only ones involved in these kinds of heinous practices. Politicians are involved too. There are politicians in our country who indulge in human sacrifices and ritual practices to win elections. Contractors are involved too. Different people are also involved for different reasons ranging from promotions, luck to travel abroad, success in sports betting, and many more. Many women in their husband's houses today performed one ritual or another to get married and remain in the marriage. The husband victims of such marriages behave like a zombie, one whose senses have been taken away This is true Today, ladies are on the prowl looking for men to harvest. Young girls wear Kayamata beads on their waists to talk to men who, in their hypnotized conditions, do the biddings of these girls. Some women offer sacrifices and rituals with animals, sometimes with human beings. I remember as an undergraduate, I went to one of the beaches in Lagos with my friends to play over the night. While touring the beach, I saw pure horror - a big woman, completely naked, and on her knees. Two men slaughtered a goat over her head and the blood sprinkled all over her body. Then, the men chanted 'obey-billions, obey-billions, and more billions'. The mental image of that scene stayed with me for many days. Given the geography of those who indulge in these practices, it is therefore morally wrong to call these people Yahoo yahoo boys. No, yahoo yahoo is not the entire problem. It is a pure money ritual, simple. Of course, one can argue that many young people who engage in internet fraud also engage in rituals to hypnotize their victims and command them to part with money. I agree. But if we continue to call money ritual Yahoo Yahoo, we inadvertently exonerate those who do not engage in internet fraud but also engage in

money rituals. Many people in the music industry, Nollywood, doctors, lawyers, prostitutes, big market women, and different people all engage in rituals for diverse reasons. Therefore, we must quickly change the nomenclature to Money Ritual instead of Yahoo Yahoo. We all use Yahoo, the famous web link, don't we? In English, yahoo means 'a stupid person'. If therefore we wish to call ritualists stupid people, then it is euphemistic and does not adequately capture their deranged mentality. So let us stick with calling them Money Ritualists, simple. Gradually, our society is gravitating towards a dangerous new normal. Money ritual, a ritual for wealth or for whatever purpose is steadily but surely assuming a part of our social narrative and progress. I do not know if there is any law against money ritual or its prohibition in our constitution. Human life has lost its sanctity among people. Young girls are easily beheaded these days, mothers are killed or buried alive. human parts have become sought-after commodities because they are used for money rituals Everywhere you turn, the story is the same, people of different ages and vocations engage in money rituals. It is indeed a shame of a country the despicable things our people embrace in their pursuit of the cosmetic illusions of materialism. We have degenerated to these regrettable levels because our social structures are too weak to checkmate these developments. Many parents have abandoned their responsibilities of raising their children properly. In fact, some parents put their children under undue pressure to bring money home like their peers.

2023 presidential race gathers pace as more aspirants join

s the 2023 general election inches closer and political parties continue to search for credible candidates among the many presidential hopefuls, the number of aspirants will increase as today in Abuja, a former governor of Imo State, Senator Rochas Okorocha, has officially declared his intention to run.

National Leader of the All Progressives Congress (APC), Asiwaju Bola Tinubu, opened the floodgates of declarations when told President Muhammadu Buhari at Aso Rock Villa of his intention to contest the APC presidential ticket,

Ebonyi State Governor David Umahi followed suit by visiting Buhari and since then more personalities have been voicing out their wish to run in 2023.

Also from the fold of the APC is former governor of Abia State and Senate Chief Whip, Orji Uzor Kalu.

Although Vice President Yemi Osinbajo is yet to declare, his name has featured prominently among APC hopefuls.

Declaring on the platform of the PDP are known faces like former Vice President, Atiku Abubakar, two former Senate presidents; Anyim Pius Anyim and Bukola Saraki while supporters are rooting for governors Aminu Tambuwal of Sokoto, Bala Mohammed of Bauchi, Nyesom Wike of Rivers to vie for the party's ticket.

Party debutants like Sam Ohuabunwa and Dele Momodu have also declared to contest on the PDP platform.

Senator Rochas Okorocha is not a first timer in the presidential race. The senator representing Imo West Senatorial district, a 3 times presidential aspirant led the Igbos through the All Progressives Grand Alliance (APGA) to join forces with President Muhammadu Buhari of the then Congress for Progressives Change (CPC), Asiwaju Bola Tinubu of the Action Congress of Nigeria (ACN) and the All Nigerian Progressive Party (ANPP) to form the APC.

He took his first shot at presidency 20 years ago as an aspirant under the platform of ANPP with Gen. Muhammadu Buhari then former Head of State, Chief Nnia Nwodo, and Chief Harry Akande.

Again in 2007 he ran under the platform of PDP coming second to President Umaru Muda Yar'Adua where the likes of Prof Jerrry Gana, Gen. Gusau and Gen. Marwa were contestants

Okorocha indicated his readiness for 2023 on the floor of the Senate last Wednesday when he notified the Senate President, Ahmad Lawan

He made his intention known in a letter which Lawan read at the floor of the Senate, Wednesday 26th January, 2023.

Okorocha who is from South East Nigeria is one of the prominent aspirants hoping to clinch the presidential ticket of the All Progressives Congress (APC) should the ruling party zone its ticket to the South East.

Okorocha in the letter went ahead to itemize expected qualities of a 21st century Nigerian President topmost among which is that the next president must be a detribilize Nigerian.

He said "our citizens are concerned about the quality of persons to run the affairs of our nation, one who can address some of their major concern which includes; a detribilized Nigerian who can unite our country.

Matters arising from Ekiti 2022 APC, PDP governorship primaries

The two leading political groupings, All Progressives Congress (APC) and Peoples Democratic Party (PDP) held primary elections to determine their standard bearers in the June 16 governorship election in Ekiti State last week.

While Biodun Oyebanji, the immediate past Secretary to the State Government won the APC ticket in a landslide victory, a former House of Assembly member and state party chairman, Hon. Olabisi Kolawole, became the PDP's candidate.

The elections have been won and lost but fallouts from the shadow polls may make or mar the chances of the parties and their candidates.

The PDP primary though less rancorous, it did not go without a few challenges while that of the APC was more controversial with seven aspirants rejecting the outcome.

Seven aspirants, Kayode Mojo, Demola Popoola, Femi Bamisile, Bamidele Faparusi, Dayo Adeyeye, Opeyemi Bamidele and Afolabi Oluwasola withdrew from the poll few hours before the poll for lack of confidence in the process.

In a statement on Thursday, the aspirants were dismayed by the list of local government election committee and ward election committee allegedly made up of party members and political appointees who had openly endorsed the candidacy of Biodun Oyebanji.

They demanded that the party reconstitute the primary election committees across the state before they can participate in the

Popoola 239 and Oluwasola Afolabi 47. They all rejected the outcome of the exercise as well as results declared by the chairman of the election committee, Governor Abubakar Badaru of Jigawa State who dismissed their rejection. Badaru absolved the 7 member committee of any complicity in the whole excise while describing the APC Ekiti State governorship primary election as free, fair and credible. The committee chairman defended his action of cancelling a meeting slated for the morning of the election on Thursday with the aspirants. He said the meeting was called off because there was a security report that thugs were being mobilised to invade the venue of the meeting.

"It is on record that the government of Governor Kayode Fayemi has given its unwavering support to the candidacy of Biodun Oyebanji, it is common knowledge that the Governor and most appointees of the governor are openly rooting for and supporting Biodun Oyebanji's aspiration to become the flag bearer of our great party.

"What is more disturbing is the fact that a simple glance at the names of the persons appointed as members of both committees would reveal that it is made up of appointees of government who are all supporters of a candidate in the primary election they are appointed to superintend on", they said in their protest.

Ekiti APC has 183,560 registered members across the 177 wards and voters were expected to queue behind the poster of their preferred candidates using the "Option A4" otherwise known as direct primary mode of election.

Oyebanji, the winner polled 101,703 votes out 104,983 total votes cast. Though a total number of 107,877 voters were accredited for the primary election.

Even though other aspirants announced their withdrawal before the commencement of poll, they received votes from their supporters.

Opeyemi Bamidele scored 760, Femi Bamisile 400, Kayode Ojo 767, Dayo Adeyeye 691, Bamidele Faparusi 376, Demola

However, grapevine source told The Trumpet that Badaru was irked by the news of the threat by the aggrieved aspirants to boycott the election and decided to botch the meeting.

While submitting the report of the exercise to the party at APC headquarters in Abuja on Friday, Badaru said the committee followed to the letters, primary election guidelines and constitution of the party as well as the extant electoral laws including the 2010 Electoral Act as amended.

He said, he directed each aspirant to nominate 20 persons that would work with the committee as local organising committee in the collation and transmission of results, saying the modality was adopted to make the process more credible and acceptable. He told journalists that there were pockets of violence in 11 out of results from affected wards

Badaru said: "elections were conducted in 166 wards while, 11 wards were disrupted and we canceled those areas but in the 166 wards, people actively participated".

He dismissed as untrue the withdrawal of 7 aspirants from the process, saying "that is absolutely not true. We got to the state on the 26th January, and called a meeting with all aspirants, which seven, (7) of the eight, (8) aspirants attended.

"We discussed the guidelines and agreed on specific terms. Their allegations maybe, party members, probably loyal to the governor, were chosen to serve as returning officers in various wards and local governments, which was also raised at the meeting and I told them, our guideline is to use the party people to do the job.

"They provided 20 names, which we incorporated into returning officers, and this was communicated in the early morning to all.

"We incorporated all the 20 people sent, to participate in the exercise. But you can see from what happened that they are supposed to have agents in all the 177 wards.

'Atiku should appreciate those who campaigned for him in 2019'

Col. Chinyere Obi (retired) is a chieftain of the Peoples Democratic Party (PDP) and National Coordinator for the House-to-House Campaign for former Vice President Atiku Abubakar during the 2019 general election. In this interview, she lamented that the Atiku failed to appreciate efforts of those that laboured for his campaign. She, therefore advised the PDP presidential hopeful to start the 2023 campaign by first sending letters of appreciation to those that campaigned alongside with her in 2019. Excepts by Politics Editor, JOSHUA OMOLOYE.

You were one of the directors of Atiku's House-to-House campaign in 2019. Why the sudden change?

Let him know that this is his retired Colonel B. He knows me by that name. I don't think there's anybody in Atiku's crew that can work the way I worked. Anywhere he goes, I go with him. Even the drivers- Pilot one, Pilot two, Pilot three, I always give them N5,000 in every state we go during the campaign. There was a time this same Atiku Abubakar saw me in Lagos and said, "Colonel na everywhere you dey?" and I said, "where do you want me to stay again if not by your side". I've known him since 1985 and I know his wife, Rikiyatu, she was my friend, she comes to my house in FESTAC then. When I saw that yes, he's the kind of person I can support, I didn't take his money, I spent N12.7 million and I never collected one naira from it. The only money I collected was the one Ola gave us in Yola, that was N150,000. All the nineteen states coordinators that came, I put them in Gongola Hotel. Everywhere I go, I support him, he's my good friend. Even when he sent people to Lagos for inauguration, I inaugurated thirty-six states and for each of the states I have the proof that I went, even the picture we took together is in my car now. So, why am I saying this? Even when he left the country for Dubai after the 2019 election, we were the ones that suffered for him in Supreme Court. Everyday I give those boys money, even the boys that came to Dubai to see him,he never gave them one naira for ticket. They paid their money, they went there but he never gave them a kobo and he's telling me he wants to come back again? Tell him I said it's a lie! He's not coming because when you are climbing a tree, and people you met down, you did not treat them well, how do you think you can climb again and come down? Atiku has messed us up. They used me to speak nine languages before the primary. I will kneel down and tell people Hausa, Yoruba, Igbo, whichever one Calabar. I know what I suffered for him. I usually pay 20,000 everyday. I will charter bus when we are going,I will be sharing T-shirts. I shared customized kettles to his friends. I did pictures for him, I did enlargement pictures for all of them and then you didn't recognize all the groups, you didn't even say "thank you", no appreciation. There is a woman in

Enugu, her case is paining me. She used her house to go and collect four buses mentioning: Atiku this, Atiku that. They have sold that woman's house now. She went to bank, borrowed money and bought five buses, that woman now is in stroke and you didn't appreciate anybody and you think you, Atiku Abubakar will come back again? "Walai.....because that man used us and the people you used are still those who are going to vote for you. It is these people who are still going to use their voters card to vote for you and then you didn't do them good, not even money. Nobody needs your money because we know you won't. But that doesn't mean you won't say thank you to the people who stood by you come rain, come sun?They were there for you. How many groups did you have? Almost 14,000 groups and these people that fought for you, you never said okay all the coordinators, you send letters to them telling them thank you despite the fact that I didn't win but I still appreciate you people, but he never did it. Even God said you must say thank you before he does another one. So, tell him I'm saying let him wake up now to write letters to those coordinators and appreciate them before he will come. Thank you very much.

But frontline campaigners of Atiku like Dokpesi and others have equally said that 24 stakeholders have endorsed him. Has that not defeated your protest?

They will just take his money and go. Didn't Gbenga Daniel eat his money and go? Do you know how many billions he spent on Gbenga? When time reach, didn't Gbenga leave him as DG? So whether Dokpesi or no Dokpesi, whether it is hundred states, let him prepare and appreciate them. Let him tell his people, all the coordinators are in his system.

Buchi has the system, so let them go to the system, download their names and write a letter to all coordinators, let them relay it to their own groups and say "thank you, we appreciate you people, we love you people. It is appreciation I'm talking about not his bloody money. After all I know how much I put into his campaign. So let him call all the coordinators, it is an advise and appreciate them before Dokpesi or Tinubu or anybody support him. Let him start from the grass root.

Revisiting oil well ownership, other critical host communities' issues

eaders of the Niger Delta have continued to Cry out over what they consider as the refusal of the Petroleum Industry Act (PIA) to tackle critical issues including the ownership of over 83 per cent of oil blocks in the Niger Delta by non-indigenes of the area.

The leaders expressed their disappointment over the inability of the bill to handle core issues affecting the Niger Delta, including the relocation of International Oil Companies (IOCs) to their area of operation.

They also expressed concern over the circumstances under which the National Assembly allocated a mere three per cent of revenue to host communities in the Niger Delta, while a fund for the exploration of oil in frontier basins, mostly in northern states, received 30 per cent.

Before its passage, the National Assembly delayed the Petroleum Industry Bill (PIB) due to regional loyalty and political differences. The bill was with them for more than a decade, with successive sessions of the Senate and House of Representatives failing to approve its provisions of sweeping reforms for the oil and gas sector. The Senate finally passed the bill on July 15, 2021, while the House of Representatives did the same on July 16, thus ending a long wait since the early 2000s. President Muhammadu Buhari, on Monday, August 16th, 2021, signed the Petroleum Industry Bill into law. Its key objective is to overhaul and transform the Nigerian oil gas industry. The Petroleum Industry Act provides legal, governance, regulatory and fiscal framework for the Nigerian petroleum industry, the development of host communities, and other related matters. The oil and gas industry has a significant impact on Nigeria's economy. Though the industry contributes less than 10% to the country's gross domestic product, it contributes about 90% of the foreign exchange earnings and 60% of total income.

the Petroleum Minister largely without any transparent process. It was usually an avenue to settle themselves and their cronies. Many past public officials, particularly those that served during the military era are today proud owners of oil blocs, with some of them selling the blocks for billions of dollars. The issue of 83 percent ownership of oil blocks by Northerners, came to the front burner in 2016 when. Sen. Ita Enang who was the then Chairman of the Senate Committee on Rules and Business, advocated for equitable distribution of oil block licenses in the country. Sen. Enang claimed that 83 percent of the nation's oil blocs are owned by people from the North part of Nigeria. Enang said oil blocks should be revoked and re-awarded to ensure the principle of federal character. He alleged that most of the owners of the oil blocks were richer than their states."Some people who own oil blocks in the North East are richer than their States. At least one person is richer than the entire six or seven states of the North East."Now it is still said that the Niger Delta is taking too much when one person is taking from the profit he makes from each of the oil blocks more than what even the derivation that the totality of the states is taking."Most of these oil blocks were awarded long ago. Most of the owners are so rich that the country becomes poorer for it."We should revoke all the oil blocs, re-allocate them either through this bill (PIB) or an Act of the Executive. This is the wealth of the nation.Sen. Enang accused the wealthy operators in the oil sector of being responsible for the theft of oil and illegal bunkering in the Niger Delta. "We talk about people stealing oil. Oil is not stolen with teacup. Enang added.It was reliably gathered that PIB deliberately refused to attend to this critical issue. Edo-born philanthropist and rights activist, Patriot Patrick Osagie Eholor, said the PIB was designed as a tool for resolving Nigerian oil industry development challenges rather than as palliatives to host communities. The PIB should have clearly defined what constitutes host and impacted communities, rather than leave that to the discretion of the companies." Going further he said: "On the issue of ownership, the bill should have made it compulsory for members of the board of trustees of the trust to come from host communities and give communities a stronger role in the selection process, financial management, and administrative procedures of operating the trusts. Needs assessment, monitoring, and evaluation for projects and programmes should be jointly

conducted by both the communities and companies. "The PIB should've clearly set out timelines for implementation of projects and penalties for defaulting companies. "But, because we have chosen to play politics with everything, Nigerians would continue to bear the consequences of our actions when nepotism and parochialism are promoted ahead of patriotism, equity, and justice."

Erha Tony Erha, Convener and former Secretary of the South-South and Middle Belt Movement, has said that the controversial Petroleum Industry Act, which seeks to spend only three percent of the operations budget of oil companies on hosts communities yet cede over eighty percent of the oil blocks to people from the north is"the worst sin" committed against the people of the Niger Delta. Erha, who spoke to the Trumpet on telephone, lamented that it was sad that the restof Nigeria has rather taken the Niger Delta and its peoples for a ride and has not only continuously exploited the region of its rich mineral deposit but have also collaborated to deny the people opportunities to participate in the ownership and the benefits derivable from the oil industry. "They don't have regard for collective living in the sense that it is the minorities that are saddled with the responsibility of carrying the majority groups along. "They take what belongs to the area and don't develop the area. Is that how a federation is run?Do you call a country a federation when it does not have fiscal federalism? Let everyone take what belongs to them and send 50 percent to the centre," Erha said. "What the Nigerian government has done with the allocation of over 83 percent of the oil blocks to people from the north is to transfer the wealth of the Niger Deltapeople

to northerners and leave them with a bare three percent as provided for in thePetroleum Îndustry Act." Erha while reacting to the refusal of the international oil companies to relocate their headquarters and main administrative bases to the Niger Delta region, despite the ultimatums given to them by the South-South governors forum, the National Assembly, and different youth groups in the Niger Delta, he said it is economic rascality. "This shows the collective disdain that they have for the region. How can you have your operational base in the Niger Delta, yet you do not want to stay there to run your business? "The reasons are obvious. It's part of the whole plan to deny the people of the region their due benefits from their oil resources. If the companies stay in the region, they will appreciate the people better and will offer them the benefits of host communities; benefits like employment, payment of taxes to the state governments, development of the host communities and participation of the people in the industry" he said. He however blames the political leadership of the South-South for failing to stand their ground and ensure that the oil companies are brought back to the region. He said that if Nigerians do not sit together and chart a way to establish true federalism, the country will be heading to a precipice. "It bothers me that the ruling All Progressives Congress (APC), which anchored its cardinal objectives on restructuring had turned full cycle against that standpoint and has jettisoned it as soon as it took overpower. "It's time for Nigeria to restructure or be balkanised," he lamented. Comrade Alagoa Morris, an environmentalist and rights activist has taken a wipe on those making calls for the relocation

of International Oil Companies to the Niger Delta. He saidit is not by force for business owners to establish their headquarters in our region. He accused state Governors of the region who organize their retreat in other states of not prasticing what they preach. Why can't they organize their retreat within their state? He quaried. "The Edo state government recently organized their retreat for political appointees in another state. The Douye Diri's led administration went to either Akwa Ibom or Cross River state to organize their retreat. Why can't they do it in Bayelsa state? Why is the amnesty office not in Bayelsa, Delta, Rivers, or any other state in the Niger Delta? What is it doing in Abuja? "The truth is that the high level of insecurity in the region drove them away. Shell was in Warri operating until Warri boiled, the ethnic crisis and other volatile situations caused the company to relocate to Port Harcourt and so whenever there is danger they flee. They were drilling oil without fear before the Niger Delta crisis. Oil companies' workers go about their businesses alone with their cameras snapping here and there, but after the uprising in the Niger Delta, they lost that freedom. "If the 13% derivation fund coming to the Niger Delta is properly utilized, if there is relative peace in the region, these people will come back on their own, they are human beings and they are sensitive to what happened in their environment. We should work towards having peace in the Niger Delta, every money coming to the Niger Delta should be used for the development of the host communities and the state capitals. We must ensure that there is enduring peace in the Niger Delta. When all these are in place our own businesses will thrive and they will come back voluntarily." While responding to 83 percent of oil well ownership by northerners, he said, "I do not have the current statistics in the first place. But talking about the Petroleum Industry Act not dealing with the issue of 83% ownership of oil blocks by Northerners, I want to ask; Who are those that have the other 17% out of the 100%? Well, I aligned myself with the thought of Senior Advocate of Nigeria, Femi Falana, who said that there is no need giving oil blocks to individuals, these are our national wealth and should be given to the state that owns them."

INSECURITY IS HIGHER IN LAGOS

The National President of Niger Delta Nonviolence Agitators Forum (NDNAF), Wisdom Ikuli has accused the International Oil Companies of not being sincere, stating that the insecurity in Lagos is higher than that of the Niger Delta. Ikuli said, "The major reason given by the multinationals for their relocation to Lagos is insecurity, but it is a general knowledge that insecurity in Lagos is higher than the security challenges in the Niger Delta region, even though they conspire with different media houses to downplay the security issues in Lagos state while exaggerating and amplifying every negative issue in the Niger Delta. "The relocation of the Multinationals headquarters is long overdue, it is non-negotiable. They cannot continue to exploit our land and in the process pollute, devastate, degrade our environment while paying taxes to Lagos State Government and also developing other areas at the expense and detriment of the owners of the

crude oil and gas." Ikuli added. The founding National coordinator of HOSTCOM, Prince Okareme Maikpobi has said that the local content act made it mandatory for oil companies to establish their operational headquarters in the area of their operation. He said "The relocation of the oil companies' headquarters to the Niger Delta has been our cry for years. We have made our point very clear, we are currently at the implementation stage. So I do believe that they will relocate. Maikpobi however advised more southerners to show interest in the oil block allocation. stressing that oil blocks can only be allocated to those who bid for them. "The marginal fields or oil blocks were recently advertised and everybody was encouraged to apply. Those that qualified in the first bidding round were those that were invited for the second bidding. So there was no discrimination in it to say the person must come from a particular region to succeed. Is Emeka Ofor, not from the South? What about Mike Adenuga and Daniel Etizie are they not from the south? Our people must show adequate interest in this area. Maikpobi added.

NIGER DELTA LEADERS REACT

One key area the Petroleum Industry Act refused to address was the 83 per cent of oil block ownership by non-indigenes. According to the DPR oil blocks and oil wells are awarded based on the bids made by interested persons that are being considered by the DPR and qualified persons awarded the oil blocks and oil wells. But Trumpet investigation has revealed that in the past oil blocs allocation was done to favour persons from northern Nigeria, many of whom have now become richer than their states and geo-political zones. Oil blocks are awarded at the

NNPC's dirty deals fuel oil subsidy controversy, stakeholders warn

 Governors, NLC, TUC want forensic audit of corporation

 House probes subsidy furore, current status of refineries

There is a consensus among the Nigeria Governors' Forum, Nigeria Labour Congress (NLC), Trade Union Congress (TUC) and other stakeholders in the oil sector that the prevailing dirty deals by the Nigeria National Petroleum Corporation (NNPC) is fuelling controversy over the subsidy regime.

This suspicion over swelling corruption in NNPC has attracted attention of the House of Representatives as the Speaker Femi Gbajabiamila, on Wednesday, set up an adhoc committee to investigate the actual volume of Premium Motor Spirit (PMS) otherwise called fuel or petrol consumed on a daily basis to determine the level of subsidy being paid by the government.

Gbajabiamila also set up another adhoc committee to investigate the actual state of refineries to ascertain what it will cost to bring them back to life again.

The Muhammadu Buhari-led federal government recently failed in its efforts to remove the touchy issue of subsidy on petrol, when it recommended an 18-month extension of the Petroleum Industry Act (PIA) to the National Assembly.

The implication of the pronouncement is that the burden of the policy, which has been described as a major drain of the nation's resources, would be passed to the coming government, effect from May 29, 2023, if the National Assembly approves an extension of the PIA's implementation.

The implementation of the PIA, which stipulates the removal of petrol subsidy ought to be in February 2022 and was later shifted to July 2022. However, due to pressure and threats of protest by the NLC and the TUC, the decision was recently suspended. A joint meeting among the governors, NLC and TUC over the controversy on withdrawal of oil subsidy, urged the federal government to constitute a forensic examination of the NNPC, claiming that the corporation had always bandied falsehood and untruth in its financial records. thereby fuelling controversy over subsidy regime in the sector. The meeting, which was held at the Nigeria Governors Forum (NGF) secretariat in Maitama, Abuja, brokered a partnership between the NGF and the labour, in tackling the huge corruption at the NNPC.

and Governor of Ekiti State, Dr John Kayode Fayemi, argued that the nation's economy is at the precipice.

"It has become necessary for the two groups to carefully verify all of the NNPC's estimates to ensure that whatever action is taken on subsidy, it would be the people that get direct benefits and not a few wealthy individuals and their cronies in the country", he Governors Forum and Governor Godwin Obaseki of Edo State, to the meeting stressed that governors cannot ignore the economics of petroleum.

He argued that all the countries surrounding Nigeria including, Niger, Mali, Cameroun and Ghana have their fuel pump prices at the equivalent of a US dollar, stating that Nigeria has a pump price that is far less than a dollar and is uncomfortable postponing the evil day."

Also speaking at the meeting Governor Godwin Obaseki of Edo State warned that Nigerians have a choice of continuing to behave like "Father Christmas (Santa Claus)" or take concrete actions on a problem that is permanently with it rather than throwing away N3tr on subsidy.

Obaseki suggested that the nation can, in the interim, increase productivity to reduce

had always been shrouded in lack of transparency on the part of government.

The unionists argued that the conflicting figures that always came from the managers of the petroleum sector had always tended towards inefficiency and corruption.

Oil belongs to N'Delta people, not Nigeria

Tor the record and for posterity, it is imperative to state that oil found in the Niger Delta region belongs to the people of the area. It is not owned by Nigeria. God provided every habitat with natural resources, including agricultural crops for subsistence. Oil, among others, is one of the natural deposits God provided for Niger Delta people for existence. The region had existed before Nigeria was created, and the oil was never part of sovereignty it ceded to bring about the country. This explains why other regions in the country have control over natural resources in their domain. Therefore, it is morally wrong for the government to single out the most valuable resource of a particular region for confiscation, while leaving other regions to enjoy their resources exclusively. That the Federal Government has oppressively expropriated the oil in the Niger Delta region by transferring ownership to itself, and using the law to legitimize the process, does not make it morally right. The obnoxious Petroleum Act of 1966 which the people are no longer gennow forms part of Section 44(3) of the 1999 Constitution was used to legitimize this illegality. It confers on the Federal Government, ownership and control of all petroleum resources found in, under or upon all land or waters in the country. However, this is at variance with practices in advanced democracies where host communities, states or regions own the resources and pay taxes and royalties to government. In law, whoever owns the land, owns the resources therein, and this principle is supported by the Ad Coelum Doctrine. Why singling out petroleum resources in a particular region for acquisition? If the intention of government was sincere, the law should have been extended to cover all natural resources, including food and cash crops across the country. The Niger Delta people believe strongly in their soul, spirit and body, that the oil belongs to them but that the federal government has unjustly used its might to seize it because of their helpless polyethnic minority condition. It is most likely this could not have happened in a monolithic majority group in the country for fear of resistance.Depriving the Niger Delta region of its oil while leaving other regions or communities to exploit natural resources found in their areas, amounts to injustice. Zamfara and Osun states, for example, are currently enjoying the benefits of gold mining, just as other states or regions in the country are reaping from their agricultural crops.Yet, the Niger Delta people are not only deprived of their oil resource, they also bear the brunt of oil exploration, including destruction of their ecosystem. Fish, crops, weather, water and other organisms in the region suffer pollution and contamination. Oil has

brought miseries to the people to the extent that even basic agricultural and fishery activities which provide succour for erative, due to environmental When you degradation. complain, those whose only contribution to the economy is their population are quick to remind you that the region is already enjoying 13 percent derivation proceeds, in addition to input from intervention agencies like the Niger Delta Development Commission (NDDC) and Ministry of Niger Delta Affairs, thus, does not deserve further support. This is population-induced arrogance. When groundnut, cocoa and palm produce were Nigeria's economic mainstay, the parts of the country where these

derived, produces were namely, the North, West and East separately received 50 percent of the revenue in line with the derivation principle as contained in the 1963 Constitution.Why then is the government reluctant to raise the derivation revenue that should accrue to the Niger Delta region to 50 percent when the 1999 Constitution has given a window for upward review. The 13 percent derivation principles as contained in Section 162, Sub-section 2 of the 1999 Constitution (as amended) is intended to adequately compensate the people of the region for confiscation and damages arising from oil exploration and production. While the region is still contending for an upward review of the 13 percent, about 59 of Representatives lately had vexatiously pushed for a bill to expunge the derivation principle under the 1999 Constitution.Obviously, the intention of the 59 legislators is to deny the Niger Delta region of the 13 percent derivation revenue to enable redistribution of the proceeds to shore up revenues in their region. This motive is not only thoughtless and heartless, it smacks of parliamentary hypocrisy and insincerity, capable of plunging the region into pointless crisis that could worsen the country's economic woes. Are these lawmakers bereft of ideas that can shore up revenue pots in the northern states or they are being mischievous? just Rather than channel and expend energy on how natural resources that are spread across the northern states can be explored and harnessed for growth of the region, they are ridiculing the legislature and exposing the limit of their intellectual capacity for good governance. It was these same northern legislators that contributed to the delay in the passage of the Petroleum Industry Bill (PIB) over their insistence that allocation to host communities from oil companies operating expenditure must be reduced from 10 to 3 percent. They had opposed the initial 10 percent as recommended in the original draft. The PIB was eventually passed into law on August 16, 2021. Now, they have not only succeeded in this overbearing trajectory; they have introduced 30 percent frontier exploration fund in the Petroleum Industry Act (PIA) despite previous records of unsuccessful geophysical exploration efforts, including seismic surveying, by international oil companies

(IOCs) in the region. Is there any exploration magic they expect the Nigerian Petroleum Development Company (NPDC), a subsidiary of Nigerian National Petroleum Corporation (NNPC) to perform in place where the IOCs could not find oil in commercial quantity? It is a clear demonstration of pursuit of sectional interests aimed at commuting the exploration fund into advantage for the North. In what way has the Niger Delta region offended the Nigerian state and their leaders? Why the show of zero tolerance for development and comfort in the region? Projects meant for development in the area are not only sometimes diverted and moved to other regions, even statutory privileges are occasionally aborted.For example, former President Olusegun Obasanjo relocated the West Niger Delta LNG, Escravos to Olokola in Ogun State and changed the name to OK LNG. Protest by the Delta State House of Assembly that the LNG be returned to Escravos, Delta State, were rebuffed by the government. Former late President Musa Yar'Adua attempted to relocate the Federal University of Petroleum Resources, Effurun to Kaduna until he was pressured to halt the plan by Niger Delta governors. Rather than establish one in Kaduna, he preferred to strip the region of the university. The proposed Oil and Gas Industrial Park designed for fertilizer, methanol, petrochemicals, and aluminium plants earmarked for Ogidigben, Delta State, has been abandoned by the Federal Government. It is hoped there are no plans to move it outside the region. The Petroleum Equalisation Fund (PEF) which was established to administer uniform fuel

prices across the country has consistently failed to extend coverage to the riverine oil communities in Niger Delta in their network, causing fuel to sell above pump price in these areas. The unending construction of the East-West Road stretching from Effurun, Delta State to Calabar, Cross River State has lasted over 16 years with no hope in sight on completion date. It is imperative to calm frayed nerves in the Niger Delta by sincerely compensating the people through measures earnestly designed to develop the area for their oil that have been commandeered by the Federal Government Template used in developing Abuja can be adopted. Direct the IOCs and the indigenous oil companies to relocate their headquarters to Niger Delta, just as ministries, departments and agencies of government (MDAs) moved to Abuja. This will accelerate development of the region. Also, just as NNPC has directed oil companies to make annual budget provision for funding of rehabilitation of schools, houses, roads, hospitals and other infrastructure destroyed by terrorists in Borno State and other parts of the North East Region, similar measures can be extended to oil communities whose properties have been impacted by seismic blasting and corrosion arising from activities of oil exploration. This way, enduring peace can be achieved in the Niger Delta region, rather than see it as a conquered territory whose oil has been taken over as spoils of persecution.

'Removing unserviceable planes at airports difficult due to court cases'

The Director-General and Chief Executive Officer of Nigerian Civil Aviation Authority (NCAA), Captain Musa Shuaibu Nuhu, in this interview with journalists spoke about the recent lifting of the travel ban on Nigeria by the United Arab Emirates (UAE), 5G network concerns, Airline Operators of Nigeria's (AON's) petition to remove NCAA from the Civil Service Structure, expectations for the year, among other recent and important issues in the aviation sector. Excerpts by ADAKU WALTER.

hat is the update on UAE unbanning Nigeria and 11 other countries?

The Country Manager of Emirates Airlines came to my office and he submitted a letter showing us a letter of release by Dubai Airport lifting the ban on Nigeria and 11 other African countries. Of course, we still have some protocols that have to be complied with. I think it is acceptable.

But, what I told him is that the issue of flight operations between Nigeria and UAE is based on BASA. Nigeria as a government, we don't deal with an airline, we deal with the authorities of UAE. So, what I told him is that the Civil Aviation Authority of UAE should write to us officially through diplomatic channels. When we have that, it means the Nigerian Government is in official communication with UAE. As soon as that letter comes in, I am sure it is going to come and we will act on it.

Unofficially, we are not aware because I need the UAE CAA to officially inform me through government to government channels. So, when we get that it becomes official.

Did he state when the airline will resume flight services to Nigeria?

When we receive their letter, then, the Federal Government will have to take a decision on that. We have the Ministry of Aviation, which deals with matters of policies and also, we have the Presidential Steering Committee (PSC) on COVID-19. However, we don't think it will take time to take a decision once we receive the letter officially.

help with the authorities there so that they won't have any problem and the airline can resume flight services to the airport.

Air Peace is a Nigerian carrier and it is our responsibility to ensure that they get any support we can give them like any other Nigerian carrier. We see a lot of countries that their airlines come here and how their governments support them. For instance, when United Airlines wanted to resume flight services to Nigeria, the American Government supported it through their embassy in Nigeria. Everybody is supporting its own and we should support our own airlines, too.

A few weeks ago, NCAA restricted Emirates Airlines operations to Abuja Airport only. Has the authority rescinded its decision?

The whole idea was because they didn't give Air Peace what it requested for. Air Peace requested for three frequencies and they gave it just one and the reason they gave was that Sharjah airport was overstretched. Believe you me there is nobody that will tell you its airport is operating above capacity at the moment. But, if you look at Lagos Airport now, it is operating at above capacity. Lagos was launched in 1978 or 1979, how many people were travelling then and how many people are travelling now? If there is any airport that now? If there is any airport that is operating above capacity it is Lagos Airport. But now, they said they have given Air Peace the slots it applied for and we have given them the slots they wanted too.

Nigeria is planning to roll out the 5G network very soon, while the same network has been suspended in some countries, including the United States. What is your say on this? It is not completely true that the 5G network has been suspended in the United States, rather it was just in some of the places close to a few of the airports within some radius that 5G was suspended in order to fully understand what is happening. The concern raised is about interference with aircraft that are being controlled to land. There is a critical component called radio altimeter; the spectrum by which this equipment operates is close to that of the 5G. So, they are afraid of interference from the radio altimeter and giving aircraft erroneous indication and it is during aircraft approach landing when they are about 2,500ft or so

above the ground. Usually, it is for flights that are put to land.

For us in Nigeria, we don't have auto landing authorisation, our flights don't do auto landing. So, for now, it is of no concern to us, but we are still monitoring the situation and see the development if there are issues that might affect us, then, we will take the necessary action.

What is your say on the letter that emanated from the Airline Operators of Nigeria (AON) to the National Assembly, canvassing the removal of NCAA from the civil service structure?

NCAA is a government agency and not an independent body; we operate under public service rules and government salary structure. We have very experienced pilots with minimum of 4,000 flying hours. That is the recommendation to be a flying instructor, but our pay is poor when compared to what the industry is paying. Our pay within the civil service structure seems to be great, but if you compare that to the closest we need from the industry, our pay is poor. So, people will rather go and work in the industry as a captain, earn some millions of naira, than to come here and earn less than N1 million.

It is normal for humans to do that. If I can work somewhere and get triple of my monthly salaries get triple of my monthly salaries for less work, why will I go and work somewhere else? The only people that come to work for NCAA as flight operation inspectors are people who have retired from flying. People who have attained the age of 65 years or more and we employed them or more and we employed them on special contracts and even as a special contract staff, when you get to 70 years of age, you are supposed to leave. If you employ someone who is 65 years old, it takes you about 18 months to two years to train him and by the time he is going to function as a full inspector and he has three years to go. He has to go by age 70. This is not a very efficient system. We need to find a right balance within the senior inspectors and the younger ones so that we do not have this every four years disruption where we have to start looking for inspectors. It is very disruptive and it is not the most efficient use of resources. We certainly need the elderly people for their experience, but we need to strike the right balance. We need to get people who can be employed as regular staff, people who are under 50 years

old and can come out to work and by the time they retire at the mandatory age of 60, we can still engage them as contract staff for another 10 years. So, you will have people who can work with you for 20 years and this promotes stability in the system. According to the International

Civil Aviation Organisation (ICAO) documents 9737, we are supposed to be a competitive employer, but because we are under the civil service rule, which we must comply with, I cannot compete with the airlines in the hiring of staff and in the other side, the aviation safety inspectors, they come out of school, we employ them, train them, they are here for six years and when they are about to become very productive for the system, the private sector comes and attract them with better salaries and take them away. We need to find a way of balancing this so that the system gets enough technical personnel to function. We are however, working on the government to see how things can be addressed. There is a limit we can pay. We are working with the ministry through the Minister of Aviation, Head of Service and salaries and wages commission to see how we can address this.

On AON letter, they came in and complained that some of their services are delayed and we explained to them that we do not have enough inspectors because they have a lot of work to do. So, we have to priotise the system, but if we have more hands, the work will be quite faster. And I understand the concerns of the airlines; they invested money and they don't want delays. If you delay them, they are losing money.

There is a report that the Dubai Airport Authorities gave Air Peace some stringent measures before the airline can be allowed to fly into Dubai Airport. Can you shed more light on some of these measures?

I am not so sure on the measures you are talking about, but, we cannot choose for Air Peace whether it is Dubai or Sharjah it wants to fly into. It depends on the airline to choose the airport it wants to fly into and the approval given by the UAE Government based on our Bilateral Air Service Agreement (BASA) arrangement with them. We will support Air Peace and if Air Peace is having some issues there, we will see how we can

What are your expectations in 2022?

2021 was relatively a good year for the Nigerian aviation industry, especially the domestic operators. We expect the growth to continue in 2022; we expect more airlines to take delivery of their new aircraft orders.

Can you give the statistics on the number of private jets we have in Nigeria?

I don't have that figure off hand and I don't want to give you an erroneous figure, but our expectation is that the private jet sector will also receive a boost. We believe it will increase.

NIMASA increases conditional survey of flag registration

Grows port state inspection by 24.2 %

irector-General of the Nigerian Maritime Administration and Safety Agency (NIMASA) Dr. Bashir Jamoh, has announced an increase of 43.6 per cent in condition survey for Flag Registration by it last year as against the performance in 2020.

It also recorded an improved Port State Control (PSC) implementation in year 2021 with 24.2 per cent higher than the PSC inspections of year 2020.

Jamoh, who disclosed this during a media interactive session in Lagos, noted that despite the challenges associated with the COVID-19 pandemic, the agency ensured improved port and flag state administration in accordance with the safety requirements of the Merchant Shipping Act 2007

A breakdown of the figures shows that in 2020, the Agency carried out condition survey of vessels under Flag Registration for 276 vessels, while in 2021, the figure increased to 489, representing a 43.6 per cent improvement. Port State Control implementation by NIMASA in 2021 was assessed onboard 673 vessels, which was a marked improvement on the 510 Vessels Boarded for Port State inspection in year 2020 representing a 24.2 per cent increment.

Jamoh also disclosed that the Agency reactivated the online portal for stakeholders to verify Nigerian Certificate(s) of Competency (CoCs) from any part of the world.

"The online certificate verification platform was reactivated last year to reduce falsification of Nigerian Seafarers Certificate and enhance the employment of Nigerian Seafarers.

"We experienced rejection of Nigerian

Seafarers both locally and internationally and the Agency decided to introduce the online certificate verification platform which allows ship owners to easily authenticate CoC's from the comfort of their electronic devices."

While raising concern over the percentage of failures recorded for Nigerian seafarers who sat for the Certificate of Competency examination last year, Jamoh announced that the Agency has commenced investigation into the immediate and remote causes of the trend with a view to addressing it holistically.

In year 2021, NIMASA signed a Memorandum of Understanding (MoU) with the Maritime Transport Coordination Center (MTCC), for capacity development to address the need for reduction of Green House Gas emission in the maritime industry with emphasis on achieving 0.5 per cent sulphur oxide in Bunker fuel.

"Our laboratory is already completed and we hope to enter a public private partnership arrangement this year to manage the laboratory for optimal utilisation.

The Agency also carried out 20 marine accident investigations in 2021, as against 18 in 2020, while also enforcing safety regulations on barges and tugboats under the code named: Operation Sting Ray.

The NIMASA helmsman revealed further that the agency took delivery of more Deep Blue Project Assets, which was flagged-off by President Muhammadu Buhari, adding that some of these assets have been deployed to the Nigerian Navy for its operational use.

"The Agency is collaborating with major international stakeholders in the maritime sector



in other to entrench coordinated response to piracy and other criminalities on the Nigerian waters and prompt reportage and escalation of marine incidences to where action is most expected and to provide navigational advisory to mariners." Jamoh added.

Speaking further, He noted the Agency's commitment to improved strategic collaboration with the Nigerian Navy, Nigerian Air Force, the Nigerian Police, Nigerian Army and the office of the National Security Adviser (NSA)

This move, Jamoh noted has helped to reduce piracy attacks off the coast of the Gulf of Guinea, as there was no single attack on Nigerian waters in the third quarter of 2021, as reported by the International Maritime Bureau (IMB)

Maritime group cautions CBN over e-invoicing policy

Says it will hinder trade facilitation

Save Nigeria Freight Forwarders Importers Exporters Coalition (SNFFIEC), has kicked against the Central Bank of Nigeria (CBN) e-invoicing policy, saying it would militate against trade facilitation and delay in cargo clearance from the seaports.

The CBN had said that all import and export operations will require the submission of an electronic invoice authenticated by the authoriseddealer banks on the Nigeria single window portal, Trade Monitoring System, effective from February 1,2022

The activist group also called on stakeholders in the maritime sub sector to speak with one voice by squashing the proposed CBN policy on e-invoicing.

According to the group, the Single Windows platform is enough to monitor transaction of trade from the shipping industry, adding that the implementation of the policy will further compound cargo clearance from the ports.

National Coordinator of the SNFFIEC, Osita Chukwu, reiterated that if implemented by the CBN, cargo throughput will reduce and goods might be diverted to neighbouring ports in the sub region.

He also accused the CBN Governor, Godwin Emefiele for the proposed ill-advised policy of invoicing, noting that the directive from the apex bank is a mirage.

Osita lamented that the sector revenue generating agencies remit to the Treasury Single Account (TSA), adding that decision from the Ministry of Finance surpassed what the CBN Governor is clamouring

He added that if implemented, stakeholders should expect bottleneck and cumbersome process and procedures of cargo clearance.

"Îf implemented then stakeholders in the shipping industry should expect terrible and difficult process in cargo clearance. The CBN Governor has failed to understand what shipping business is all about," he said.

He further called on the CBN Governor to tackle issues of forex in promoting international trade and not compound the existing challenges faced by operators in the maritime sub sector of the nation's economy.

"Any country that fails to understand and protect the peculiarity in shipping industry is doomed" said.

The Central Bank of Nigeria (CBN) had also released guidelines for the newly-introduced electronic invoicing (e-invoicing) and evaluator for exporters and importers.

The new regulation, it stated, is aimed at determining the accurate value for goods leaving the country or otherwise.

Abuja MoU boss seeks regulation of vessels trading in West, Central Africa

The Secretary General, Abuja Memorandum of Understanding (MoU) on Port State Control, Captain Sunday Umoren, has called on member states to support the body in regulating activities of vessels trading in the coastal regions of West and Central Africa

This is as Umoren raised alarm at the rate of oil spill by foreign vessels in the regions, thereby causing pollution.

"Majorly, the source of pollution is the vessel. For instance, when it comes to oil spillage; there are three reasons for it. One is caused by

operational spillage. This happens probably when their ship-to-ship transfer of oil and some of the oil drops into the water. Another one is when a hose bursts into the sea. The last one is intentional.

"You will see foreign vessels coming for instance to Nigeria because Nigeria would charge them if they are to wash their tank at the shore. So, in the middle of the night, they release the oil that has been washed off their tank into the water. And our duty is to charge Member States to regulate the activities of vessels coming to their country. Abuja MOU can't do it alone," he said.

The Abuja MoU is a regional body set up by

coastal states in the West and Central African region. It is saddled with the responsibility of developing and implementing a common mechanism for port state control activities in the region.

The Abuja MoU duties include the harmonisation of the port state control procedure and practices of all the countries in the region aimed at eliminating the operation of substandard shipping thereby ensuring maritime safety, security, protection of our marine environment from pollution and improving the working and living conditions of ship crew.

According to him, all checks , examinations and due diligence required must have been completed at the designated DEW facilities, which kIDP is one of the nine recently approved by the government.

NCS to challenge N2b Innoson judgement debt

The Supreme Court has granted the Nigeria Customs Service (NCS) Board's application to challenge the February 6, 2014 judgment of the Court of Appeal in Ibadan that affirmed a N2, 048,737,443.57 judgment debt in favour of Innoson Nigeria Limited. In the appeal marked SC.816/2020, the sum of N700, 220,000 was awarded against the Customs and the Attorney General of the Federation in favour of Innoson, with interest at the rate of 22 per cent per annum from the date of commencement of the action and 22 per cent per annum until the final liquidation of the judgment debt

The Customs paid Innoson N700, 220,000, out of the judgment sum, which at the time stood at N1, 881,219,981.17, leaving an outstanding of N1, 625, 119, 514,97

Following an application by Innoson, the Federal High Court, Ibadan, on July 29, 2011, made a garnishee order against three banks in the sum of N2, 048,737,443.57.

One of the banks appealed the decision of the garnishee proceedings in the Court of Appeal, Ibadan. However, the Customs claimed that the bank withdrew its appeal against it and the AGF, whereupon their names were struck out of the appeal, and subsequently, no processes were served on Customs by reason of the withdrawal but the Court of Appeal affirmed the garnishee absolute of the trial court and ordered that the sum of N2, 048,737,443.67 be released from the Customs' account in satisfaction of the judgment debt.

How judiciary is promoting restructuring, by Falana

To many, the recent judgment of a Federal High Court sitting in Abuja, which barred further deductions from the federation account to fund Police Trust Fund could not have come at a better time than now.

This is so because many judiciary observers are of the view that Nigeria is in dire need of restructuring to save the nation from disintegration.

With the seeming political actors' reluctance to listen to the voice of reason and restructure the polity, the courts are expected to lead the way for the nation's survival.

Hence, the pronouncement of the Abuja court is adjudged a promotion of restructuring through litigation.

The verdict followed Rivers State's suit marked FHC/ABJ/ CS/511/2020 and instituted on its behalf by Mr Joseph Daudu, a former President of the Nigerian Bar Association (NBA).

In the suit, the state challenged the decision of the federal government allocating funds directly from the Federation Account to fund some of its agencies claiming that the decision violated section 162 of the 1999 Constitution.

The Rivers State government also claimed that by the federal government's unlawful action, it had deprived it substantial revenue from the federation account, and therefore prayed the court to nullify the unlawful funds allocation from the federation account

Named as defendants were

the Attorney General of the Federation and Minister of Justice AGF, Accountant General of the

Federation, Revenue Mobilization Allocation and Fiscal Commission and Minister of Finance. In its verdict, the court holds that institutions or bodies, such as the Nigeria Police Trust Fund not listed in the Nigerian constitution

cannot be funded directly from the Federation Account. It also contended that it was not the responsibility of the state governments, but that of the federal government to fund

the police. The court's verdict was in tandem with earlier pronouncements of the courts in 10 other cases

Acceding to this, a foremost human rights lawyer and senior advocate of Nigeria (SAN), Femi Falana, described it as a very sound judgement.

The former president of West African Bar Association (WABA) said the Supreme Court had ruled, several years ago, that the Federal Government lacks the power to remove fund from the Federation Account without the authorisation of State Governments and Local Governments

According to him, under the defunct military junta the unitary military government usurped the powers of the other tiers of Government.

"But since 1999, the courts have consistently promoted restructuring by litigation. Before the VAT judgment, State and Local Governments have defeated the Federal Government in not less than 10 cases.

Some of the cases dwelled on physical planning, conduct of local government elections, seizure of local government fund, monitoring of local government fund, collection of entertainment/ hospitality levies, control of land, control of inland waterways and setting up of commissions of inquiry," Falana added.

HISTORY OF THE SUIT The Federation Account Allocation Committee (FAAC) had announced at its April 2020 meeting that the deductions were to commence in earnest.

But about a month after the FAAC meeting, Governor Nyesom Wike-led Rivers State Government filed its suit on May 20, 2020 to challenge the planned deductions and the law on which it was premised.

The Rivers State Government, through its Attorney-General of the Federation, challenged what it described as the unlawful deductions being made from the federation account, state and local governments, to

the responsibility of the state governments, but that of the

federal government to fund the police.

It also urged the court to order a refund of the money deducted from the Federation Account and paid into the NPTF since when it was informed about it at the FAAC meeting of April 2020.

Delivering judgment in the suit, Justice Ahmed Mohammed, declared as "illegal, unlawful and unconstitutional," the direct allocations made so far by the federal government from the federation account to fund the NPTF.

The judge held that Section 161 and Section 162 of the 1999 Constitution were breached by the federal government in making direct allocations to the NPTF from the Federation Account.

He added that Section 162 of the 1999 is unambiguous to the effect that only the federal, states and local governments shall be allocated fund directly from the Federation Account.

The court also held that section 4 of the Nigeria Police Trust Fund Act 2019 relied upon by the federal government to justify the unlawful deductions from the federation account is inconsistent with section 162 of the 1999 Constitution which recognises only the federal, states and local governments.

It also agreed with the plaintiff that the levies imposed on companies operating in Nigeria by the federal government to be paid directly to the NPTF instead of the Federation Account was also illegal, unlawful and unconstitutional.

The Rivers State government had argued that such levies ought to be paid to the federation account for it to be benefit from it.

It said failure to pay such funds into the federation account and rather into the NPTF has deprived it of substantial revenue accruable to the state as taxes.

The court dismissed the Attorney General of the Federation's objections and upheld all arguments of Rivers State that where the provisions of the 1999 Constitution are clear and unambiguous, they must be given their ordinary meanings.

The court also agreed with Mr Daudu that the federal government was completely wrong in the interpretation given to section 4 of the Nigeria Police Trust Fund Act to the effect that the Nigerian Police was established for the federal government alone and as such the funding is solely on the shoulder of the federal government.

liminary objection asked the Federal High Court to decline jurisdiction in the matter on the ground that such suit ought to be filed directly at the Supreme Court.

But the judge dismissed the preliminary objection before going ahead to deliver the verdict.

The court held that the jurisdiction of the Supreme Court can only be invoked when a dispute involves the federation and any of the component states.

On the objection raised by the AGF that the Rivers State government ought to have sought and obtained the leave of the Federal High Court before instituting the suit, the judge said the plaintiff had no reason to seek the court's permission to file the case.

While upholding that the plaintiff's suit, the judge ordered that the funds belonging to Rivers State but were used to fund the NPTF by the federal government should be refunded to the state.

The judge, however, declined to extend similar order of refund to the 35 remaining states on the grounds that they were not parties in the suit and that the Rivers State as the plaintiff in this matter did not file it on behalf of others.

Family seeks justice, probe of Nigerian student's death in Ukraine

The family of 19-yearold Nigerian student, Fadlullah Agboluaje, who allegedly died in mysterious circumstances, is calling for an investigation into his sudden death in Ukraine a few days after leaving Nigeria.

The family's quest for justice has received a boost with 8,460 people signing a petition initiated by one Christopher Juwah to compel Ukrainian and Nigerian authorities to unravel the mysteries surrounding Agboluaje's death.

In an urgent appeal, the family is urging Lviv Polytechnic National University in Ukraine to tell them how the healthy 19-year-old brother, Fadlullah Adedayo Agboluaje died.

The appeal is titled: " Tell us the truth of the death of my 19 years old Son in Ukraine."A helpless Mother's cry.'

Narrating the incident, a sibling to the deceased said: "My mum was with him at the Murtala Muhammed Internaional Airport in Nigeri he traveled from Nigeria on Saturday, January 8, 2022, and landed in Ukraine on Sunday, January 9, 2022.

A child as young as eleven can be married off. This leads to innumerable complications not only for the child, but also for the economy as a whole. UNICEF defines gender equality as "a state of equal ease of access to resources and opportunities regardless of gender, including economic participation and decision making, and the state of valuing different behaviours, aspirations, and needs regardless of gender."

It adds that a total of 44 per cent of the female Nigerian population gets married off before their 18th birthday.

"After we got the news, we began to ask this liaison officer to send us his picture if truly he's dead. He didn't do so until early evening on Tuesday, January 11, 2022. I couldn't look at the picture until Wednesday 12th, because I just couldn't look at my younger brother dead.

"As an older one, you always want to fend for your younger siblings. It hurt too much to look at the picture but my mind needed to have a grasp of the evidence. I looked at the

official autopsy report claimed to have done by the institution.

They are also worried about why Lviv Polytechnic National University has not contacted or reached out to them, wondering if the deceased was not their responsibility, having already been in the school's territory.

The family also want Nigeria's Ministry of Foreign Affairs, its Embassy in Ukraine, and the Ukraine Embassy to tell them what happened and what was done to justify their duty of care for the student.

They further called for answers from the school about what happened to their son and not to be kept in the dark.

According to Emmanuel Adebayor, his exit from the club to Manchester City in 2009 after spending three years in Arsenal was necessitated by his coach, Arsene Wenger, who told him in his office he won't be needed any longer in the club.

The embattled Aubameyang who is presently enmeshed in disciplinary problems with the manager of Arsenal is likely to leave to the club to further his football career in Saudi Arabia or somewhere else.

Adebayor said that even though there are a lot of dissimilarities between his and Aubameyang's, he stated that the Gabonese international is going through a lot at the moment in the club. He added that Arsenal as a club lacks the spirit of forgiveness.

In an interview with Sky Sports News, he said, "I know he's going through a lot because that's Arsenal for you. They never know how to forgive."

Adebayor who played for Arsenal for 3 years started his international football career at the age of 15 in Metz, a Ligue 2 division Club in France before being snapped up by Monaco in 2004 after impressive outings with the club.

He played in nine games for



Monaco in their build-up to the Champions League games before they were defeated by Jose Mourinho's Porto in 2004.

However, he continued his career with the club till he was signed by Arsene Wenger in 2006 where he was likened to the former Arsenal star player, Kanu Nwankwo, due to his physique, and area ball control that saw him wore the Kanu's number 25 Jersey.

If Adebayor had played for the Super Eagles of Nigeria, his parents' country national team, he could have been a complete replica of Kanu Nwankwo but he opted to play for Togo his birth country and took them to their ever world cup outing in 2006.

It is noteworthy to state that Emmanuel Adebayor is the all-time highest goal scorer in the Togolese national team.
