With VP 's entry, presidential race finally takes shape

evelopments in the past 180 - 240hours within the All Congress Progressives (APC) have, in bold relief, painted the colour and picture of the race for the presidential ticket of the ruling political party for the 2023 general elections.

This is because two powerful members of President Muhammadu Buhari's cabinet declared their interest to succeed him.

Transport Minister Chibuike Rotimi Amaechi at the weekend in Port-Harcourt, Rivers State made his public declaration while on Monday, Vice President Yemi Osinbajo stylishly entered the race. Suddenly, political fireworks were ignited and hidden facts started surfacing through actions and uttetances of political actors.

In the main opposition Peoples Democratic Party (PDP), a chieftain, Tunde Akogun, hinted that its power brokers were working on a Peter Obi-Aminu Tambuwal ticket. Also in the PDP and elsewhere in other opposition parties, presidential interest and ambitions have been declared. They include former Vice President Abukakar, Atiku erstwhile Senate President Bukola Saraki, Bauchi State Governor Bala Mohammed, all in the PDP; civil society activist Omoyele Sowore, and Kingsley Moghalu among others. Sowore, a former president of the National Association of Nigerian Students (NANS) and publisher of Sahara Reporters, is running on the platform of African

Action Congress (AAC). Akogun hinted that Saraki, also a former Kwara State governor, is among those brokering the deal for the PDP to field former Anambra Governor Obi and current Sokoto helmsman Tambuwal for the 2023 electoral battle. Atiku has pladged to step down for and support a PDP ticket helmed by a Southeast candidate and not one headed by anybody from another region. Others in the race from outside the region are Atiku himself, Saraki,

Tambuwal, Bala and Zayyad Hayatudeen (all North); Rivers helmsman Nyesom Wike, Akwa Ibom State Governor Udom Emmanuel and Ovation magazine publisher Dele Momodu (all South South) as well as maverick Ekiti PDP supremo Ayodele Fayose (Southwest). Before Amaechi and

Osinbajo, former Imo State governor, Owelle Rochas Okorocha and Kogi's current helmsman Yahaya Bello had publicly declared in the APC. Also in the race on the platform of the ruling party are Ebonyi State Governor Dave Umahi, Senate Chief Whip Orji Uzor Kalu and former Lagos State helmsman Bola Ahmed Tinubu who is among the party's three frontrunners including Osinbajo and Amaechi.

APC is yet to release its election timetable and schedule of activities but some of the aspirants like Tinubu, Osinbajo and Amaechi are consulting with its stakeholders and other influential Nigerians outside the party.

There has been name dropping by aspirants' aide some aides and confidants indicating the purported closeness of their principals to the Presidency. But the Presidency has remained silent since the body language of Buhari does not openly show his preference for anyone.

Buhari may not have given his blessing to any of the aspirants feelers from the but grapevine indicate that power brokers within the Aso Rock Villa have preferences among the contenders.

Although First Lady, Mrs Aishat Buhari, is actively involved not in Villa politicking, her influence cannot be underestimated. She was reportedly an associate of Kogi State Governor Bello but is believed to have recently tilted towards Amaechi .

His conferment this year with a traditional title in Buhari's hometown, Daura is significant. This among others is eliciting opinions suggestive of his preference by the cabal.

Bureaucrats within the Presidency are not left out in the powerplay as most of them are rooting for Osinbajo to emerge as APC candidate.

Political Adviser to the President, Babafemi Ojudu, is believed to be the arrowhead of the Osinbajo Presidency project.

He came to the Presidency as one of political Tinubu's benefactors but he fell out with his former boss and openly professes that the best choice for the job is Osinbajo.

"The groundwork for Monday's declaration Ósinbajo started bv over a year ago. Vee Pee was just looking for an auspicious time to make his declaration," said a source close to Ojudu.

"Did you think the Vice President just woke up and decided he would join the race?

"He is a member of the Federal Cabinet and next in rank to the President who is working closely with President Buhari on the driver's seat. Who then is most qualified to continue and complete the programmes and policies of the administration, than Prof. Osinbajo?'

Considering the influence of the cabal, the race for the APC presidential ticket could be said to have been trimmed down to Amaechi, Osinbajo and Tinubu. But given the odds against the former governor of Lagos, there are fears among his supporters that he might be edged out of the race, probably forcing him to pull his structure out of the APC to a smaller party.

They are saying that throwing up Osinbajo at a time like this could be a grand plot to decimate Tinubu's chances in the Southwest.

A source said efforts are on by some Osinbajo loyalists in the cabal to use anti-Tinubu APC leaders in the Southwest zone to do the legwork for the vice president who is believed to have no political structure of his own. Ekiti and Ondo Governors Kayode Fayemi and Rotimi Akeredolu as well as former Ogun Ibikunle helmsman Amosun, and disgruntled APC forces in Oyo State led by an erstwhile Communications minister, Adebayo Shittu, are being wooed to work for Osinbajo. Ogun State Governor Dapo Abiodun will be automatically drafted into the Osinbajo project. Ojudu, it was learnt, was commissioned woo Information to minister Lai Mohammed and a former governor of Lagos, Akinwumi Ambode, in the new southwest agenda.

the north, Across Tinubu's allies are not reckoned with too much in the Villa. Kano helmsman Abdullahi Ganduje, former Borno governor, Kashim Shettima and a past chairman, House of Representatives Committee on Appropriation, Abdul Mumuni, may have fallen out with the Presidency.

A source said Ambode approached the APC Governors Forum to help beg Tinubu to allow him a second term. Bagudu reportedly begged Tinubu but the latter went ahead and replaced e Ambode with Babajide Sanwo-Olu.

'Terrorists, bandits can't over-run country by 2023'

Media Organisation (BMO) has dismissed suggestions by some highly placed individuals and groups that terrorists could overrun the country by 2023.


It said in a statement signed by its Chairman Niyi Akinsiju and Secretary Cassidy Madueke that claims of a worsening security situation were not exactly true.

"We, at BMO. acknowledge that the country is grappling with some security challenges at the moment but it amounts to a disservice to the security agencies to suggest that the criminals are having a upper hand to the extent of over running the country by 2023.

"What find we particularly galling is the impression created by leaders of religious and socio-cultural groups of little or no action to stem the activities of terrorists.

"This is not only false but also misleading considering how the country had fared recently in the war against insurgency after several years of suicide bombings and mass killings in major cities of Northern Nigeria.

"For the avoidance of doubt, total of 47,975 terrorists and their families have so far surrendered to troops in the region from September 2021 to date.

It is the opinion of some members of the party that Tinubu should play the big(ger) boy by greenlighting Osinbajo's aspiration and supporting him the way he did for the latter to emerge Vice President ahead of 2015.

An erstwhile Special Adviser on National Assembly Matters to two former Presidents, Senator Mohammed Abbah Aji, urged the national leader of APC support Osinbajo to who he said has a solid support base in the north as well as thriving circles of influential supporters across the south which makes him more capable of winning the 2023 presidential contest than any other candidate.

He described Tinubu as a great party leader who should feel vindicated that the good idea brought forward in the person of Osinbajo has continued to flourish.

Aji, a member of the pro-Osinbajo Progressive Consolidation Group (PCG) that has been active since midapplauded 2021, the spontaneous nationwide celebrations that greeted Osinbajo's declaration for the 2023 presidency.

"I have been in politics since the early 80s and I can tell you that the Nigerian electorate is now much wiser, discerning and sophisticated than what you had in the past; the spontaneous rallies are a show of strength, asserting the power of the real people and it's a strong pointer to Professor Osinbajo's bright chances very for ultimate electoral victory," he said.

"Asiwaju is a great leader of our party and his role in bringing about an Osinbajo Vice Presidency has been vindicated; having performed creditably, impressing President Buhari and millions of Nigerians.

"As a leader, when you bring a great idea, you should allow such to grow and Vice President Ösinbajo's declaration for the 2023 presidency is a reflection of very sound growth and the next step is for him to assume the Presidency in 2023."

However, persons who understand Buhari said the President's disposition might not be towards any of the three leading APC aspirants.

One remarked: "All the jostling may end up as a huge joke as President Buhari that we know might spring surprises. He may not have his preference among any of these ones as he may prop up a dark horse.

You should be guided by what happened with the choice of the APC national chairman. Look at how the President's men just raised Senator Abdullahi Adamu and the leading contenders were compelled to step down from the race.

"So, you should not overrule any possibility.

The game is not over until it is over."

"While the moves to outsmart one another continues among the power blocs within the Presidency continue, it is hoped that an acceptable candidate will emerge as APC presidential standard bearer."

Meanwhile, Saraki has said the quest by some presidential aspirants of PDP to form a united front ahead of the 2023 general elections is for the party to wrest power from APC.

said Saraki this informed their decision to canvass a consensus candidate among the aspirants.

presidential The hopeful spoke while briefing iournalists after a meeting with Tambuwal. Bala Mohammed and Bavelsa Governor Douve Diri at Government House in Yenagoa.

Saraki stressed that as an opposition party, the PDP could not wrest power from APC if the party was not united.

He said Nigeria's overall interest superseded individual ambitions and that was why they embarked on the mission to consult Diri and other critical stakeholders on how to reach a consensus on the party's candidate in next year's presidential election.

Describing the PDP as the only hope to rebuild and reposition the country, Saraki noted that Nigeria was in bad shape and needed to be salvaged from the bad governance of the APC adding that despite the propaganda of the ruling party, Nigerians were going through difficult times under the APC and that the only solution was for the PDP to retake power at the centre.

"Our His words: appeal to Nigerians is that we feel your pains, the hardship and insecurity. That is why our ambition is to return this country to PDP and make your lives better. We have come to seek your support as we approach 2023. We have spoken very well and feel encouraged by the governor's words. He thanked Diri for the warm reception and for his words of encouragement.

Diri urged the PDP to forge a united front if the party wants to win the forthcoming election.

Diri insisted that the party must not be factionalised due to individual ambition, but rather forge a common front to pursue victory at the 2023 presidential election.

Diri, who promised to work for the success of the party at the polls, commended the aspirants for putting their individual interests aside for the good of the party, adding: "There is no other way than unity of purpose of the PDP. We must realise that we

are an opposition party. We are not a party in power and cannot afford to be factionalised and fractionalised due to individual ambition.

Thank God for implanting this in the minds of these senior citizens of our party.

"I think this is the first time in Nigeria that presidential aspirants are coming together to talk about the unity of the party and forge a way forward. One thing that I will assure you is that the Bayelsa State chapter is prepared to work for the unity of our party, to take over governance and give Nigerians what we were giving them before the party in power came into office and destroyed the things we built in 16 years."

However, Saraki has said the negotiations among some presidential aspirants of PDP on the possibility of producing a consensus candidate should not be equated to agitating for a northern president.

Rather than considering such a effort patriotic as northern agenda, he said the aspirants are being driven by national interest aimed at a united Nigeria.

this Saraki made clarification after four presidential aspirants of the party; himself, Bala, Tambuwal and businessman, Muhammad Hayatu-Deen met with Governor Ifeanyi Ugwuanyi at his Enugu State Lodge in Abuja.

Emphasizing that series of consultations being made across the country by the consensus team was not a northern agenda Saraki said when we started about three weeks ago, most of the aspirants we had then were mainly in the north. We were talking to the aspirants across the country. Now, because more people have come out in the South and we

are all going to meet. "All the aspirants are going to meet. We are talking about Nigeria. We are not talking about the northern aspirants or southern aspirants.

" I have good news that already, moves are being made by the aspirants in the South to meet and eventually all we all meet and see one consensus, that consensus is a Nigerian that represent all the groups.

"So, I just want to be clear about that, and be reassured it is not about just issue of a northern consensus, not at all, it's a consensus for the PDP and one Nigeria."

He said the meeting with the Enugu governor was fruitful adding that the four aspirants were consulting other governors and stakeholders on possibility of producing an acceptable candidate capable of winning election for the party.

The forum unanimously affirmed that: "We align with the position of IDU, the apex social cultural and administrative body of Isoko Nation over the Delta South Senatorial seat.

"That the Isoko have consistently supported the Ijaw and Itsekiri, following the political trajectory, in every senatorial and governorship election without any political blackmail, subterfuge and propaganda, all through the 19 and eight uninterrupted years respectively.

'Why judge's barring of journalists in terrorism trials is unconstitutional'

ecently, the Chief Judge of the Federal High Court, John Tsoho, issued a new practice direction on terrorism trials.


Under the new practice directive, judges may choose to bar journalists and the public from either covering or witnessing terrorism trials.

Although, the decision was primed to curb distractions, occasioned by the large representations and interests that accompanied such terrorism cases, there are views that the direction was principally targeted at the trial of Mazi Nnamdi Kanu, the leader of the proscribed Indigenous People of Biafra (IPOB).

According to the proponent of the new practice direction, many cases have suffered several adjournments, because of the attention given to the attention given to terrorism matters

But, leader of the defence counsel for the IPOB leader, Chief Mike Ozekhome (SAN), at the last trial date, indicated that the defense team will challenge the new direction.

Chief Ozekhome sug-

gested that the direction was akin to secret trial and meetings of witches and wizards in their coven.

Another lawyer, Aloy Ejimakor, also condemned the new practice direction, stressing that such is unconstitutional by the clear provisions of Section 36 of the Constitution, which requires all trials to be in public.

He added that the new Practice Direction is ultra vires t Constitut and cannot be justified by a Terrorism Prevention Act that is unarguably subservient to the Constitution.

Ejimakor, in a statement, said subsection (3) of Section 36 of the Constitution, states that "The proceedings of a court or the proceedings

of any tribunal relating to the matters mentioned in subsection (1) of this section (including the announcement of the decisions of the court or tribunal) shall be held in public."

Quoting subsection (4) of Section 36 of the Constitution, he said "Whenever any person is charged with a criminal offence, he shall, unless the charge is withdrawn, be entitled to a fair hearing in public within a reasonable time by a court or tribunal."

He noted that the only restrictions the Constitution allows is on a caseby-case basis and it must be narrowly-tailored by the particular court or tribunal before whom the suspect is being tried, not



by an omnibus Practice Directions that seeks to envelope every case in one fell swoop.

argued that He narrowly-tailored exception can found at Section 36, subsection 4(a) of the Constitution, which states that a court or such a tribunal may exclude from its proceedings persons other than the parties thereto or their legal practitioners in the interest of defence, public safety, public order, public morality, the welfare of persons who have not attained the age of 18 years, the protection of the private lives of the parties or to such extent as it may consider necessary by reason of special circumstances in

which publicity would be contrary to the interests of justice.

The second narrow exception is contained in Section 36(4)(b) of the Constitution, which states that if in any proceedings before a court or such a tribunal, a Minister of the Government of the Federation or a commissioner of the government of a State satisfies the court or tribunal that it would not be in the public interest for any matter to be publicly disclosed, the court or tribunal shall make arrangements for evidence relating to that matter to be heard in private and shall take such other action as may be necessary or expedient to prevent the disclosure of the matter," he added.

Lagos CJ petitioned over alleged discrepancies in car auction sale

Lagos State Chief Judge, Justice Kazeem Olanrewaju Alogba, has been urged to investigate the auction sale of a Toyota Corolla on December 19, 2021, by the Deputy Sheriff of the court.

Claimant and Judgment Creditor in a petition dated July 27, 2021 regarding suit no MCL/87 3/2013 between Abiodun Akinkoye Odunayo and Mr. Jude Ator, asked Justice Alogba to investigate the alleged manipulation of proceeds of the sales in the public auction by the Deputy Sheriff.

A petitioner, Mrs Odunayo, said the Toyota Corolla car was a subject of an execution levied in her favour on December 19, 2017, attached and taken to court premises.

According to her, the car was neither vandalised nor destroyed at the court premises, where it was parked during the EndSARS protest, but Kazeem Olanrewaju

remained intact.

Mrs Odunayo stressed that she participated in the public auction for the sale of the car and made a bid up to N1.2 million, while another person bidded N2.7 million.

According to her, the Deputy Sheriff, surpris-ingly informed her afterwards that the final

offer from the highest bidder stood at N552, 000. "I witnessed the public auction together

with others," she said. The petitioner further

claimed that after the sales, the Deputy Sheriff, in a letter informed her that, "a Toyota Corolla with Reg. No. BDG 602 EC was sold by public auction to



the highest bidder in the sum of N525, 000. The only amount recoverable by the Claimant/Judgment Creditor stands at N525,

The petitioner that her petition dated November 30,2021 to the Chief Judge, which was received by the office was not replied three months after.

"It is pertinent to know my lord that I have waited for about three months, since I submitted my petition and I am yet to be contacted or informed of any development in respect of the

petition, copy of which is hereby attached for your Lordship's quick reference and necessary action.

"Waiting patiently for my lord's intervention in this matter of open fraud that someone thinks can be swept under the carpet," the petitioner stated.

However, the acting Chief Register, Mr. T. A. Elias, who in a letter dated March 15, 2022 in response to her petition, stated that her petitions dated November 30, 2021 and March 1, 2022 in respect of the subject matter were not successful.

The letter read: "A discreet investigation of your petition was conducted and no wrongdoing has been found on the side of the Lagos State Judiciary and its appointed Auctioneer.

"You are free to furnish any proof of your allegation, if you so wish. Accordingly, the petition is unsuccessful.'

Court declares restriction of estate dwellers' movement illegal

A Lagos High Court, Ikeja, has declared as illegal the restriction of movement of homeowners within Pearl Garden Estate situated at Sangotedo Village in Eti-Osa Local Council of the state.

The action was perpetrated by CMB Building Maintenance and Investment Company Limited.

Trial judge, Mufutau Olo-koba made the declaration, while delivering judgment, in a suit filed by some of the homeowners against CMB (property and the estate management agents) and the Oyetubo Jokotade Estate Resource Limited (previous landowners).

The N100 million suit was filed by the claimants on February 9, 2015 following dispute with the property developer.

It was filed by Messrs Adesuyi, Francis Felix Obiakor, Martin Ajayi-Obe and Peter Afenotan in representative capacity on behalf of themselves and all interested homeowners within the Pearl Garden Estate.

In the judgment, the judge declared that the interference on the claimants rights by barricading and restricting their movement and that of other lawful residents in and out of the estate by the defendants and their agents was unlawful and an infringement on their

rights. He held that the purported estate charge of N35,000 imposed by the second defendant on the claimants was null and void.

The judge, however, declined to grant the claimants' request for an order against the defendants, granting them N100 million as damages, saying the defendants should only bear the cost of the action.

Experts in the justice administration and correctional sectors have called for a mechanism to ensure integration of ex-convicts into the society.

The experts stressed that attitudinal change towards ex-convicts is necessary to minimise criminalty in the society.

Controversy trails appointment of Ishaq Bello as LPDC chair

ontroversy has trailed the recent appointment of Justice Ishaq Bello as the new Chairman of the Legal Practitioners Disciplinary Committee (LPDC).

The former Chief Judge of the High Court of Federal Capital Territory (FCT), who had upon his retirement on the bench, made an unsuccessful attempt to join the International Criminal Court (ICC) bench, replaces Mr. Emmanuel Ukala SAN, who recently resigned from the position.

However, it was gathered that members of the Body of Benchers (BoB) are not comfortable with the procedure, which brought about the emergence of Justice Bello.

Some who spoke on the issue argued that they were neither consulted in the process leading to the appointment nor given the opportunity during the plenary to ratify Bello's nomination.

They also said due process was not followed in the appointment, stressing that the immediate past BoB Chairman, Justice Olabode Rhodes-Vivour merely announced the appointment of the jurist towards the end of the last meeting of the body.

According to a member,

who spoke on the condition of anonymity, the practice had been that while the headship of the LPDC rotates between the Bar and Bench, both groups must reach a consensus on the choice of the candidate to head the all-important (BoB) committee.

The member said: "Sadly, that did not happen this time. "Due process was not followed; instead, a fait accompli was foisted on the body. That is not the precedent we are used to. The appointment is inchoate.

"I do hope that the new chairman of the Body of Benchers will seek the

earliest opportunity to present the nomination of Justice Bello for ratification at the plenary. Otherwise, it will be a bad signal for both the committee and the Body of Benchers."

The Body of Benchers and the Nigerian Bar Association (NBA) President, Mr. Olumide Akpata are yet to respond on the matter.

Recall that LPDC was recently in the news, following the resignation of Ukala and two other members of the committee over alleged interference by the Body of Benchers.

The two members who threw in the towel were the current Chairman of the NBA Section on Legal

He explained that it was on account of such that the Prison Fellowship International came up with programmes that are remedial to the inmate's behaviour.

Iwuagwu, said the purpose of the 4th correctional officer's workshop was to form a collaboration between the Nigerian Correctional Service and the Prison Fellowship Nigeria.

He urged the Correctional Service to begin to explore and exploit the opportunities that abound within the civil society and faith with a view to reforming the inmates.

He said: "They should look at what these organisations are offering. And in our particular case, we are offering specifically targeted objective programmes that address some of those behavioural attitudes that are disposed to crime and criminality.

"Because crime and criminality are critical factors, if they are not objectively and intentionally addressed, it creates an ugly situation."

Experts canvass ex-convicts' integration

without stigmatisation, the problem of minimising criminality will persist.

According to her, where a crime has been committed, there are three major dimensions that should be addressed, adding that it becomes problematic if any of them is missed.

She explained that the three dimensions are what you do with the offender, the victim and the community where the offence is committed.

"Often we kind of get so concentrated on the offender and forget the other two. So,



to help reduce the risk of the offender committing an offence again.

'It is only when the offending behaviour is reduced, that you and I are safe. But then the other thing is about the victim. I have never seen a society as insensitive as ours. And this thing cuts across. The funny thing is that this was not what our traditional criminal justice system was.

"If society will begin to stigmatise the person when he is in custody and when he is outside the custody, we as a society will be worse for it. Again, as I saiu, to engage with the offender in such a way to reduce the offending behaviour.

"I think it is only when we begin to do this that our justice dispensation system will begin to have a human's face. And that does not negate the focus and interest of the support mechanism that needs to happen for the offender, not because you like the offender but because you want to reduce the offender's chances of re-offending," she submitted.

She stated that it will be good for us as a people, in terms of enhancing security, to have a comprehensive approach to addressing the processes of persons affected during a criminal offence, whether the offender, the victim, the family or the community.

In his remarks, the Controller General, Nigeria Correctional Services (NCS), Mr Haliru Nababa, urged participants to pay attention to the content of the programme.

Nababa, who was repreented by ssistant Cont General, Training and Staff Development, Mr Lawal Gusau, further harped on the importance of training for human capital development.

He said: "Training is an important aspect of staff development without which an organisation cannot progress. You will need the con-

tent of this course for your progress in the Service and the development of the organisation." Also, the Assistant Control-

ler General of Correctional, in

charge of Zone A, made up of Lagos and Ogun states, Mr Uche Nwobi, said the issue of restorative justice is designed

to help the system. According to him, if you go to custodial facilities, there is congestion. "But with the coming of restorative justice, we discovered that a lot of people who should have been in custody are out there, doing their job elsewhere and not within the walls of the prison. Asked about the need for the controversial beauty contest involving Chidinma Ojukwu, he said inmates are eated like every other human

being. "In the system, we don't discriminate against anybody. We give them equal treatment to help them with what will happen after imprisonment," he said.

Earlier, the Executive Director of Prison Fellowship Nigeria (PFN), Bar. Benson Iwuagwu, said the country has a great need for the correctional system to become more responsive than it is. Noting that the common characteristic before now is

Reminiscing on indelible footprints of Oronto Natei Douglas (1966-2015)

I may early years in secondary school, I was very fortunate to have met an uncommon soul called Oronto Natei Douglas, fondly known as OND by friends and acquaintances. Though our meeting was a brief one, it impacted greatly on me. It changed my perspective and approach to life. However, little did it ever cross my imagination that I would be working with OND later in my life, to fight against injustice and build peace for the common good of the Niger Delta and Nigeria.

Until the mid-90s, Oronto and I never met again since our first encounter in the late '80s.As the religious enthusiasts would say, divine appointment brought us together and never to part again. We worked together until that sad day of 9th April 2015 when death took him away. During the colourful ceremonies of Oronto's funeral, the stoic side of my frail being was cajoled to saying it was celebration of life, but my inner being was immersed in an unending flow of tears and mourning. Oronto's death was a personal loss that created a huge vacuum in my life that I have to endure for many years.

As I reflect on the good times I shared with OND, I find his great legacies very comforting. However, one statement he had repeatedly said to me (which I have since classified as one pillar of Oronto's creed), came knocking strongly on my mind. OND, my mentor and brother by grace and divine connection, had told me over a thousand times that life is not about the steps you have taken but the footprints you have left behind. As I grew older, I began to appreciate, even more, the wisdom in this significant statement.

On this seventh memorial of OND, I am certain that many like me are remembering Oronto for the uncommon and indelible footprints he left behind. Oronto was an uncommon and extraordinary soul that traversed Planet Earth in the soil of the historical Ebela Kingdom in Ogbia, where crude oil was first discovered in commercial quantity in West Africa.

In his native home of Okoroba, he left his footprint as the first and youngest pupil of St. Mark's Primary School he challenged his teacher, who went to equity with unclean hands. This was OND's first recorded public victory over injustice and oppression. Oronto later joined his uncle, Ikiriko Apusubh Okogolo, of blessed memory in Abeokuta, who was serving in the Nigerian Army, and continued his primary education at the Army Children School, Alamala, Abeokuta, Ogun State.

On completion of his primary education, he got admitted to the United Comprehensive High School (UCHS), Wasimi, Abeokuta, for his secondary education. He led the arts and school drama and debate team to several contests within and outside Ogun State and returned victoriouswith numerous laurels. During his apex class at the school, he was appointed as the Deputy Senior Prefect. His academic performance in UCHS remains outstanding till date.

Propelled by his passion to always stand for truth and justice, Oronto proceeded to study Law at the Rivers State University of Science and

Technology (RSUST), now Rivers State University, Port Harcourt. He also holds a master's degree in Environmental Law from the prestigious De Monfort University, Leicester, United Kingdom. At RSUST, he became the Editor-in-Chief of the University's Press Club. He also championed the activities of the Civil Liberties Organisation (CLO) in the university. Throughout his tertiary education at RSUST, he fought for the overall interest of the students. He was an intellectual freedom fighter.

Oronto belonged to the special breed of humans who never forget their roots. They understand that the reason God made you anindigene of one tiny village is for you to turn around the fortunes of that community and make it aplaceothers would desire to be. This was exactly what Oronto did in his ancestral home of Okoroba.

In the late '90s OND initiateda programme tagged: Education First for his home town. It was an annual programme where Oronto personally gave out prizes and award scholarships to the best performing pupils. This step alone changed the attitude of the pupils. There was intense hard work, as pupils engaged themselves studiously to win the prizes.

This programme blossomed so much that the community benefited greatly. To boost the growing standard at the primary school, Oronto built and equipped a state-of-the-art kindergarten school (E.K. Clark Preparatory School, Okoroba for the community. The school was to prepare the little kids of the community before they are enrolled into the primary school. It was tuition-free. He provided uniforms, shoes, school bags, books and other study materials needed by the kids. This school changed the narrative and face value of his community. If all who have passed through schools can return and give a fraction of support to the schools they attended, schools would not have been under the current state we find them in the country.

One of his personal beliefs is that

the sure way to liberate a people from poverty is to give them quality education and he lived his life demonstrating this belief.

Apart from his unique contributions to advance the education of the people of his native hometown, Oronto contributed even in greater measure outside his home of origin. He built and equipped a library at UCHS, Wasimi, Abeokuta, Ogun State, his alma mater. Other libraries he built and equipped include the Melford Okilo Library in Ogbia Town; Goodluck Jonathan Library in Okoroba; Prof. Bruce Powell Library at the Federal University, Otuoke; Obigboc Mikimiki in Opume; Prof C.T.I Odu Library in Twon Brass; Obafemi Awolowo Library in Irele-Ikole Ekiti, Ekiti State; Resident Tuodolo Library in Bomadi, Delta State and a library in Umuobuna-Ohaozara in Ebonyi State.

It is also interesting to note that because of Oronto's love for education, he converted his only building in Yenagoa to a public library and named it in honour of Prof. E. J. Alagoa, one of Nigeria's leading historians. The library is equipped with laptops, desktop computers and e-readers that are available for use to registered members. It boasts of about 60,000 e-books, 70, 000 digital materials that include journals and videos, 12,000 hard cover and paperback editions of books on various subjects. Sadly, this library is no longer functional because there is no one to provide funds to keep it going. He was to commence the building of another library in lkot Nseyen in Ikono Council of Akwa Ibom State, before the cold hands of death snatched him away.

Oronto's selfless service to humanity cannot be exhaustively highlighted in a short eulogy of this nature. He stood for the Ogoni throughout his life, particularly in the darkest chapter of the community's history in the era of the dreaded Sani Abacha. He was a member of the legal team that defended Ken Saro Wiwa and the eight other Ogoni pro bono. He was beaten and battered, locked up and subjected to unimaginable humiliating and inhuman conditions in course of his work in defence of the Ogoni.

For the rest of the Niger Delta, he was a voice and a mobiliser. He challenged the international oil companies (IOCs) operating in the Niger Delta to the extent that they described him as a bitter pill to swallow. OND founded and cofounded several community-based organisations (CBOs) and Non-Governmental Organisations (NGOs). Notable among them are the Ijaw Youth Council (IYC), Environmental Rights Action/Friends of the Earth, Chikoko Movement, Niger Delta Resource Centre, Ogbia Study Group, Community Defence Law Foundation and Douglas Educational Foundation, among others.

It is also pertinent to note that Oronto's activism was a contributory factor in the establishment of the Niger Delta Development Commission (NDDC), Ministry of Niger Delta, the Presidential Amnesty Programme (PAP) and the 13 per cent oil derivation fund being paid to oil-producing states. He also stood for democracy in Nigeria. He was at the forefront of the fight against military dictatorship in Nigeria.

During the administration of former President Goodluck Ebele Jonathan, when Oronto served as Special Adviser, he launched the Bring Back the Book (BBB) Initiative in Lagos, Benin, Jos, Yenagoa and Abuja to revitalise the reading culture in Nigeria, especially among the youths so as to empower and prepare the Nigerian youth for the opportunities and challenges they would be facing in the future.

The BBB provided books and computers to schools and student in Oronto's quest to end book famine in Nigeria. He also played key roles in conceptualising the idea of the Youth Enterprise with Innovation in Nigeria (YouWiN) programme that empowered many young Nigerians during Jonathan's administration. He was a brain box in GEJ administration and many attributed GEJ's election loss of 2015 to Oronto's ill health.

Oronto's life can be summarised as a life of sacrificial living. To him, living was giving and giving was living. He gave his best to the service of humanity locally and internationally. His wish was the younger generation to do better than him. Through his scholarship and philanthropy programme, he transformed many down-trodden lives for good. He was a God-fearing man who loved humanity especially the less privilege.

As I continue to reflect on the life of this great patriot, seven years after, I see Oronto's legacies everywhere around us to remind us of a glorious past, but a few questions come to mind. Has the democratic government of Nigeria, Bayelsa State, Ogbia Kingdom and his hometown, deemed it fit to immortalize this great soul? Are the legacies of this detribalised Nigerian being preserved? Will the great works of OND go in vain without a reward? It is better late than never.

Indeed, OND left uncommon and indelible footprints behind. May God bless his inheritance and continue to rest his great spirit in eternal peace. Amen.

ICPC vows to checkmate illicit financial flows in real estate

As commission intensifies investigation of completed, unoccupied estates

• To sanction land holding without development after stipulated years

• *ICPC* boss decried impact of corruption, others on economy

The Independent Corrupt Practices and Other Related Offences Commission (ICPC) has vowed to checkmate Illicit Financial Flows (IFFs) in Real Estate across the country.

The Director of Asset Tracing, Recovery and Management (ATRM) of ICPC, Mr Adedayo Kayode, made this known at the opening of a two-day capacity building for investigators, prosecutors and tax inspectors on IFFs organised by the Commission in collaboration with the Ford Foundation.

Mr Kayode further noted that the commission shall intensify its ongoing investigation of completed but un-occupied estates in the country as part of measures to address IFFs.

While presenting a paper titled "Illicit Financial Flows in Real Estate", Kayode identified the continuation of on-going investigation of completed but un-occupied estates across the country as a solution in tackling the menace.

He said, "The ICPC in accordance with its mandate to curb corruption is presently investigating cases of myriad of completed but abandoned estates scattered around the Federal Capital Territory with the intention of identifying those that instruments of IFFs.

"Furthermore, we are collaborating with the National Assembly to investigate, study and promulgate appropriate legislation to stem the tide of corruption in the real estate sector. We need a coordinated and concerted approach to fight IFFs: the law enforcement agencies need continuous investment in capacity building to trace and follow the money, their need for implementation and investigation of breaches of the Beneficial Ownership rule, data availability is a must and intelligence sharing."

Meanwhile, the director also mentioned that as part of measures to curb IFFs, the Commission shall commence the implementation of sanctions on land holding without development after a specified period of time.

He listed enforcement and compliance investigation of Capital Gain Tax on Real Estate transactions and strengthening international cooperation on investigation of cross-border real estate purchase transactions as more solutions to combating IFFs.

Others according to him includes full implementation of beneficial ownership regulation, and regulation of Foreign Exchange trading and movement.

Kayode, who noted that IFFs are laundered in order to disguise or conceal illicit origins, lauded the effort of government in the recent SIM card/NIN matching and deactivation of non-compliance as a good step in the right direction.

"A key sector to the laundering of IFFs at their origin globally is the Real Estate which is due to its informal, little regulated nature proves very attractive. Key culprits involved in the laundering of IFFs in the real estate sector are top public officers.

"The laundering activity is conducted in collaboration with real estate developers and accomplices in the Land Administration departments.

"Launderers of illicit wealth in the Nigerian real estate sector often engage in cash purchases which are done through the use of foreign exchange often procured from Bureau De Changes. Often times after purchase, the property titles are not changed to reflect the new ownership," he stated.

The Chairman of ICPC, Prof. Bolaji Owasanoye (SAN), earlier in his opening remarks, decried the impact of corruption, IFFs and tax evasion on the economy, noting that they have resulted in massive resource leakages and hampered the development of the country.

"The IFFs impact a country's economic and social development in a myriad of ways. Undocumented flights of wealth to and from - as well as within a country - have severe repercussions on government revenues, wealth that could otherwise be invested in public spending and other forms of economic and social reforms.

"Nigeria is losing billions of dollars from expected revenue due to poorly structured contractual agreements and tax laws which encourage IFFs. The drain on resources and tax revenues caused by IFFs has thwarted the expansion of basic social services and infrastructure programmes that are targeted at improving the wellbeing and capacities of all citizens, in particular, the very poor," the ICPC boss said.

He added that new paradigms and policies to counter IFFs would be established to produce an unbroken chain of work from tracing, freezing, seizing, confiscation and recovery of illicitlyobtained assets, through transparent management and liquidation of such assets, to distribution of the proceeds to high-priority development needs.

Also speaking at the capacity building on IFFs, the Chairman of Inter-Agency Committee on Stopping Illicit Financial Flows from Nigeria, Dr. Adeyemi Dipeolu, disclosed that poorly negotiated and hidden contracts contributed to the IFFs.

"This capacity building is being organised to help investigators, prosecutors and tax inspectors to deal with IFFs. We want to develop core people who will make sure that agreements signed for the country and government do not lead to illicit financial flows," he remarked.

Alleged €211,000 fraud: EFCC presents first witness against suspect By PAUL MICHAEL, ABUJA

Economic and Financial Crimes Commission (EFCC) has presented its first witness against one Ifekwu Dominic in a case before Justice S.O. Solebo of the Special Offences Court sitting in Ikeja, Lagos on April 11, 2022.

Dominic is being prosecuted by the Lagos Zonal Command of the EFCC on a five-count charge bordering on conspiracy to obtain money by false pretence, obtaining by false pretence, and possession of documents containing false pretence.

One of the counts reads: "Ifekwu Chukwuma Dominic, aka John Alfred, and Okechukwu, aka Connie Miller (at large), between 2014 and 2017, within the jurisdiction of this Honourable Court, with intent to defraud obtained the aggregate sum of 211,000 Euros from Imelda Dorflinger under the false representation that you Ifekwe Chukwuma Dominic had inherited gold from your father and needed the said money to pay taxes in order to enable you to have access to the gold, a representation you knew to be false."

Another count reads: "Ifekwu Chukwuma Dominic (aka John Alfred), on or about 22nd June 2016 within the jurisdiction of this Honourable Court, and with intent to defraud, had in your possession document titled "Cashier Cheque", where you falsely represented to Imelda Dorflinger that you have been issued a cheque valued at \$590,000.00 and which document you knew contained false information."

He pleaded "not guilty" to the charges prompting the commencement of his trial.

During the proceedings, the witness, Mma Adamu Alhaji, an operative of the EFCC, who was led in evidence by the prosecuting counsel, I.O. Daramola, told the Court that the EFCC received a petition against the defendant sometime in September 2021 in which the defendant was accused to have defrauded his victim, Imelda Dorflinger, a German national, by posing as one John Alfred, with whom she developed an online friendship.

Court convicts undergraduate for cybercrime in Ibadan

Justice Ladiran Akintola of the State High Court, Ibadan, Oyo State, has convicted one Ogunleye Olawale Sylvester to six months community service before for internet fraud.

The Ibadan Zonal Command of the Economic and Financial Crimes Commission (EFCC) on Tuesday, April 12, 2022.

The convict, who is a second year student of Olabisi Onabanjo University, Ago Iwoye, was amongst those suspects arrested by officers of the Nigerian Army and handed over the EFCC for prosecution.

The convict pleaded guilty to one count charge. The count reads: "That you Ogunleye Olawale Sylvester on or about 11th November 2021, at Ibadan within the jurisdiction of this Honourable Court, with intent to defraud, impersonate David Miguel a white man from United States of America."

Upon his plea, the prosecution counsel, Sanusi Galadanchi reviewed the facts of the case and tendered indicting documents as evidence. He thereafter urged the court to convict and sentence the defendant as charged.

In his ruling, Justice Akintola convicted and sentenced Ogunleye to six months community service and ordered that he restitute the sum of \$550USD (Five Hundred and Fifty United States Dollars), and forfeit one Tecno Spark 3 mobile phone to the Federal Government of Nigeria.

Lagos court sentences drug baron to six years imprisonment

Justice Ayokunle Faji of a Lagos Federal High Court, has convicted and sentenced a drug baron, Aniede Chimezie Bright, to six years jail term, for attempting to export 7.10 Kilograms of a banned substance, Methamphetamine, to Madrid, the Spain capital.

Justice Faji, convicted and sentenced the baron after he changed his earlier not guilty plea.

Earlier, the convict had pleaded not guilty to a count charge of unlawful export of the said banned substance, when he was first arraigned before the court sometimes in 2021.

The Nigeria Drug Law Enforcement Agency (NDLEA) in the charge marked FHC/L/109c/2021, stated that the convict was arrested with the banned substance on March 28, 2021, at the Gate 'C' of the Departure Hall of the Murtala Muhammed International Airport, Ikeja-Lagos, during the outward clearance of passengers Royal Air, Maroc, flight to Madrid, Spain via Casablanca, Morocco.

Charge against the convict reads: "that you Aniede Chimezie Bright, Male, Adult, on or about the 28 March, 2021 at Gate 'C' of the Departure Hall of the Murtala Muhammed International Airport, Ikeja-Lagos during the outward clearance of passengers Royal Air, Maroc, flight to Madrid, Spain via Casablanca, Morocco without lawful exported 7.10 kilogrammes of Methamphetamine, a Psychotropic Substance, under International Control and you thereby committed an offence contrary to and punishable under Section 11(b) of National Drug Law Enforcement Agency Act, Cap.

N30, Laws of the Federation Of Nigeria, 2004."

The offence, according Mr. Abu Ibrahim, NDLEA prosecutor, is contrary to and punishable under Section 11(b) of National Drug Law Enforcement Agency Act, Cap. N30, Laws of the Federation Of Nigeria, 2004, However, at the resumed trial on March 31, 2022, the convict through his lawyer, E. C. Ezeoke, signified his intention to change his not guilty plea. Consequently, the Judge adjourned for review of fact and sentence.

At the resumed hearing of the matter on Monday, the prosecutor, Mr. Abu Ibrahim, of the review of fact of the charge has tendered some exhibits, which includes: the Convict's confessional statement, his international passport, part of the analysed drug, the bulk of the drug and others which were admitted by the court.

Upon review of the facts of the charge and tendering of exhibits, the prosecutor urged the court to sentence the convict according to section 11(b) of NDLEA Act.

But his counsel, Ezeoke, pleaded with the court to tamper justice with mercy in sentencing the Convict.

The CBN Governor and political affiliation

y the Central Bank of Nigeria (CBN) Act of 2007, the apex body is mandated to manage the monetary policies, 'issue legal tender currency in Nigeria; maintain external reserves to safeguard the international value of the legal tender currency; promote a sound financial system in Nigeria; act as Banker and provide economic and financial advice to the Federal Government '. It is currently being headed by Godwin Emefiele, who has served as Governor of the apex bank since June 4, 2014, having been appointed by the President Jonathan administration and reappointed by President Buhari. By the terms of engagement governing the bankers' bank, the CBN ought to be insulated from politics and politicking. It is worrying that, contrary to established conditions of service, the incumbent governor is deeply enmeshed in politicking.

In recent times Godwin Emefiele has been rumoured to nurse ambitions for the 2023 presidential ticket of the ruling party race. Many groups have reinforced the rumour through public displays and street activities. Cars branded with his name and campaign slogan have been seen around the country. The social media is also agog with such. The peak of it all came during the 26th of March 2022 APC National Convention when certain individuals thronged the venue and openly campaigned for him to be elected Nigeria's next president. This has raised fears and concerns from several quarters over the sensitivity of Emefiele's office. The Central Bank governor has neither identified with, nor dissociated himself from the many groups and their campaigns towards 2023.

The silence on the part of Mr. Emefiele is deafening. It contradicts the legally established neutrality of his office. The Central Bank of Nigeria is the chief implementer of the government's monetary policy. Policies from the Bank affect all states and individuals in

Nigeria irrespective of their political parties or orientations. Thus, anyone heading the apex bank should not be seen, conceived, portrayed, or perceived as being politically partisan, aligned with any political party. If he is, he is likely to be perceived as compromising or manipulating the monetary rules and fiscal policies of the country in favour of certain interests based on their political affiliations.

We condemn a situation in which our public officials continue to violate public service rules and other laws of the land without receiving appropriate sanctions. All arms of government, especially that which implements the law need to call Emefiele and others in his shoes into order without further delay.



If he does not have such a plan or an aspiration, he should also publicly so declare and then repudiate any passion or support for the groups clamoring for him to run for political office.

Such canvassing groups too deserve to have some words of admonition. While we respect their freedom of expression, they should be careful not to drag Emefiele into murky waters. Such a thing portends danger to our political system and nascent democracy. It brings a conflict between stakeholders and vested interests. Perhaps Emefiele needs to remember that his appointment was made by the PDP administration, but the current APC leadership retained him. This may not be unconnected with the professionalism with which he handled his office. One of the terrible things Emefiele can do at this point therefore is to compromise the integrity of the Central Bank.

The Central Bank of Nigeria needs to be always professional. The Governor, in the person of Godwin Emefiele, needs to be professional too. He should be politically neutral because people cannot afford to see policies of the CBN as being politically motivated. Emefiele needs no distraction at all from any political group because the economy is in dire straits. On the contrary, this is the time the Governor needs to be focused on the implementation of robust monetary policies that would support the fiscal policies of the government to grow the economy and address inflationary pressures.

The South-East Governors Forum recently declared an open opposition the against secessionist in the region, groups notably the Independent People's of Biafra, (IPOB). They also threatened to launch counter-secessionist groups, in a bid to stand up more to the IPOB. The sit-at-home development has really taken a toll on the region's economy as banks, shops and other organisations remained shut on Mondays over the fear of attack.

As the Trumpet newspaper gathered, Governor Soludo ordered all public servants in Anambra State to always report to work on Mondays, like every other weekday. Meanwhile, on Saturday April 2, Soludo asked the Nigerian government to handle the trial of Nnamdi Kanu with speed or release him from detention.

With this declaration, the point here remains that

if Nnamdi Kanu is guilty as charged, the call from Governor Soludo should not be for the speedy release of Nnamdi Kanu, but that his case should be decided as fast as possible, to prevent societal negative elements from taking advantage of his trial to inflict more pain on the society. ASUU reveals conditions for resumption of lectures

Academic Staff Union of Universities (ASUU) Abuja zone says there will be no resumption in the ivory towers until a renegotiated 2009 agreement is signed, implemented and the University Transparency and Accountability Solution (UTAS) deployed.

Dr Salawu Muhammed Lawal, the ASUU Zonal Coordinator, disclosed this during a press conference at the University of Abuja in Gwagwalada.

According to him, the members are ever ready to return to their duty post as soon as their demands are met by the Federal Government.

He said: "You would recall that the Academic Staff Union of Universities (ASUU) declared a four week rolling strike at the University of Lagos National Executive Council (NEC) meeting held on February 14. "Owing to the failure of

the Federal Government to act within that period, the national action was rolled over for another eight weeks following the resolution taken at an emergency NEC meeting at the Festus Iyayi National Secretariat on March 14.

"The action as you are probably aware is to among other things, compel the Federal Government to sign and implement the draft renegotiated 2009 ASUU-FGN Agreement submitted to it by the Prof. Munzali Committee since May 2021.

"Deploy for use in the Nigerian university system, was the home-grown payment and personnel solution called UTAS developed by ASUU as replacement for the failed IPPIS.

"As usual, the Federal Government has ignored ASUU's call for full implementation of that famous agreement and other memoranda signed with the union.

"No meeting has been held between the two parties since the commencement of the ongoing strike. The only exception is our union's re-submission of UTAS for a retest.

"The summary is that unless and until the renegotiated 2009 agreement is signed and implemented and UTAS deployed, there will be no work in public universities"

'FG spends N12bn monthly on feeding schoolchildren'

Federal Government spends about N12 billion on the National Home-Grown School Feeding Programmes (NHGSFP) monthly under the Ministry of Humanitarian Affairs, Disaster Management and Social Development (MHADMSD).

Dr Umar Bindir, National Coordinator, National Social Investment Programme (NSIP) of the Ministry said this on Monday in Abuja at a two-day stakeholders consultative workshop on the development of a national policy for NHGSFP.

He emphasizes the need for the country to have a national policy on school feeding programme to ensure sustainability.

According to him, the national school feeding programme which was launched in 2016 was cost intensive as over N10 million children were captured under the scheme with each given a meal of N100 per day by the Buhari administration.

"Today we are focusing on the National Home-Grown School Feeding Programme with the support of the World Food Programme (WFP) to develop an inclusive policy for NHGSFP.

"This is to ensure that it is sustainable, measurable and highly impactful as directed by Mr President.

"As we speak we are feeding an average of 10 million children with the potential of that number increasing to 12 million probably in the next few weeks or months.

"Based on the impact of the

are healthy, the children of the poor and vulnerable attending school longer it is necessary that the programme is sustained," he said.

Mr Kim Do-Hwan, Head, Capacity Strengthening and Policy Coherence, UN World Food Program (UNWFP), gave his remarks.

He said the objective of the workshop was to engage critical stakeholders, who would jointly identify and agree on key components of a national school feeding policy.

Do-Hwan continued that the policy development process would take into account broad considerations that would benefit the NHGSFP as it was being implemented across the country.

He further said that the policy would serve as a foundation for the success and sustainability of the NHGSFP.

"It will remain as a guiding document that ensures continued investment from national and sub-national stakeholders beyond any singular political dispensation.

"The NHGSFP is a key pathway for the government of Nigeria to achieve one of its own objectives to advance progress towards the Sustainability Development Goal (SDG 2) on zero hunger.

"This aims to end hunger, achieve food security, improved

programme – attracting children nutrition and promote sustainable to school, ensuring the children agriculture."

Do-Hwan consequently assured UNWFP's commitment to support the achievement of SDG² in the country through effective partnerships, knowledge sharing and capacity strengthening.

Police to prosecute husband of late Osinachi, as FG vows to ensure justice

The Federal Capital Territory (FCT) Police Command says it would charge Mr. Peter Nwachukwu, husband of the late gospel artist, Osinachi Nwachukwu, to court for culpable homicide.

It was gathered that the suspect, who is already in police detention, has been transferred to the FCT Command's Homicide Department for further investigation.

The Command's Public Relations Officer, Josephine Adeh, who made the disclosure, said Nwachukwu would be charged to court as soon as investigation into the matter is concluded.

Adeh, in an interview told our Correspondent that Nwachukwu, who is currently being detained at the Lugbe Police Station in the FCT, was arrested after the younger brother to the deceased reported the matter at the police station.

"We arrested the husband based on the report we got

from the younger brother of the deceased gospel singer that he suspected the husband for culpable homicide, and we will communicate to you as the case progresses," she said. But a police source, who would not want to be

mentioned in print, said that following the transfer of the case to the homicide

department, the police has made certain revelations that would aid its investigation.

The source said that the police already have a voice recording of the deceased, where she narrated her ordeal while on admission at the hospital. In the said voice recording, the deceased was alleged to have said that her husband should be held responsible if anything happened to her.

The source said the voice message was recorded in Igbo language, which has since been translated by Igbo police officers to the police. It added that the suspect, who has since been transferred to the FCT homicide department,

has been behaving funny and not cooperating with the police. The source said that the suspect has written different statements as to how his wife died.

Accordingly, the suspect was said to have confessed that he used to beat his wife in the early years of their marriage, but had since stopped beating her.

Nwachukwu was said to have told investigators that his wife suffered cancer of the lungs, which he said was detected at the National Hospital and the Gwagwalada Specialist Hospital, and that she had been on admission at the National Hospital for about 21 days before she passed on.

The Oyo State Police Command says it has launched a manhunt for a middle-aged man for allegedly assaulting his wife.

This was confirmed by a top police source, after an incident which occurred in the accused's residence, where he was seen beating his pregnant wife over Sahur (pre-dawn meal).

It was gathered that the distasteful incident happened around 4am at their residence, in Ogbere Housing Estate, Ibadan, Oyo State.

According to an eye witness, "This man always beats his wife over any little misunderstanding they have. I was able to record today's event. He's a Muslim, so I think they had an argument over Sahur."

"This man didn't mind that she was pregnant with his second child and started pouncing on her. She wailed for hours before she was able to flee to her parent's house. Meanwhile, the man has fled his house after being declared wanted by security

personnel."

In a related ugly development, a pregnant woman, two month-old baby, and two others have allegedly lost their lives during an early morning fire at the Bonny-Bille-Nembe Jetty in Port Harcourt, Rivers State.

Also, over 40 boats were burnt in the fire, said to be caused by persons who attempted to load illegallyrefined products, popularly known as 'Kpofire' in the local parlance.

The fire started at about mid hour, even as the victims, which also included a male adult, were reportedly burnt beyond recognition.

Nigerians, businesses reach crisis point under constant collapse of national grid

Nigeria has some of the brightest minds in the world, with most of them either born and bred in the country or in the Diaspora doing well in most countries of the world. Surprisingly, over six decades after Nigeria's independence, the country constantly remains under the spell of epileptic power supply and total darkness. Lamentably, with the several billions of dollars successive administrations had injected into the power sector, the nation still grapples with the worse power crisis ever, **JOHNMARK UKOKO** writes.

From the days of the Electricity Corporation of Nigeria (ECN) to the National Electricity Power Authority (NEPA), Power Holden Company of Nigeria (PHCN) and the current unburdened power sector under the Transmission Company of Nigeria (TCN), Generating Companies of Nigeria (GenCos) and Distribution Companies of Nigeria (DisCos), the story remains the same and has even become worse.

Nigerians have had to grapple with epileptic power supply for several years, leading to the death of many Nigerians either during operation in hospitals as a result of power outage or in firms that rely on uninterrupted power supply only to be disappointed by public power cut and many local manufacturing firms that had to shut down their plants due to lack of electricity or had to relocate to the neighbouring countries where stable power supply is guaranteed.

In the current political dispensation, successive administrations have injected huge sums of money into the power sector, but Nigerians and the business sector wriggle under constant collapse of the national grid, thereby leaving Nigerians and the businesses without public power supply.

public power supply. President Olusegun Obasanjo was reported to have spent \$16 billion on the power sector, without commensurate impact to the extent that at the twilight of his administration, Chairman, House of Representatives Committee on Power, Hon. Ndudi Elumelu, who represents Aniocha Federal Constituency of Delta State, wondered where the \$16 billion went.

Former President Goodluck Jonathan administration also spent several billions of dollars in the country's comatose power sector and at the end of his administration, power generation stood at a mere 5,000 megawatts.

Brilliant minds like the late Bola Ige, Prof. Bartholomew Nnaji and other great Nigerians were appointed as ministers of power under President Obasanjo, the late former President Umaru Yar'Dua and Jonathan without much improvement in the sector.

When President Muhammadu Buhari's administration assumed office, with his change mantra, he promised to fixed the country's troubled power sector once and for all and to fulfill his pledge, Buhari appointed former governor of Lagos State, Babatunde Raji Fashola as Minister of Housing, Works and Power with a view to overcoming the country's perennial power challenges.

Four years after, in the saddle, the story was the same, it was one national grid collapse after another news that Nigerians were told by

Fashola, prompting President Buhari to replace Fashola with Saleh Mamman.

When the former Lagos State governor was removed from the power sector, many Nigerians hailed the move, based on the fact that Fashola is a lawyer and as such is novice in the power sector, which ordinarily should be the turf of electrical and mechanical engineers.

They described Mamman's appointment as "a round peg in a round hole," but two and half years after, President Buhari sacked Mamman over poor performance, as his tenure witnessed several collapses of the national grid like his other colleagues, who held sway before him.

Mamman was sacked in September 2021 and was replaced immediately by Abubakar Aliyu, who was before his redeployment, Minister of State for Works and Housing.

for Works and Housing. At his resumption of office, Aliyu promised to turn the fortunes of the power sector around saying: "Nigeria was in Slumber for over 30 years until President Buhari took over in 2015."

He said due to the power sector reforms embarked upon by the Buhari administration, foreigners are now willing to invest in the sector.

Speaking earlier in the year at the Nigeria international partnership forum in Paris, France, he said the government was wooing foreigners to invest in the sector, just as he showcased all the policies and practical steps the government had taken to attract foreign investors into the sector.

But in spite of the promises, the country had witnessed collapse of the national grid four times this year alone and with each collapse, the entire country had been thrown into total darkness for days.

Most Nigerians have, therefore, insisted that Aliyu like Mamman, Fashola and all the Minister of Power beginning from the late Ige hadfailed to delivered on the promises they made to Nigerians.

Speaking to The Trumpet on why the country had been unable to fix its power sector challenges, Chief Executive Officer (CEO) of the Centre for the Promotion of Private Enterprise (CPPE), Dr. Muda Yusuf, blamed the sector's challenges on policies and political interference.

He said the power sector reforms had not adequately addressed the challenges and delivered the desired outcomes, while citizens expectations remain largely unmet, adding that the privatisation of the power sector had failed and that the constant collapse of the national grid had become an embarrassment to the country.

"The entire experience in the power sector has given privatisation a bad name. There are issues of due diligence, technical capacity, financial capacity, political interference, metering issues and other challenges," he lamented. Yusuf, who blamed the DisCos owners

for arbitrary billing and their failure

to provide Nigerians prepaid meters, insisted that they were responsible for payment defaults by many Nigerians, adding that electricity theft, technical losses and cost reflective tariff were some of the issues hampering the growth of the sector.

He also raised concerns about the capacity of the Nigerian Bulk Electricity Trading (NBET) Plc to effectively play its role of providing liquidity to support the country's electricity supply chain.

Yusuf raised the issue of scarcity of gas to supply for power generation, adding that there was the need for more holistic approach to the multiple challenges facing the country's power sector.

On the effects of the constant failure of the national grid, Managing Director of Liberty Industries Nigeria Limited, Abuh Kamal, said he could not understand why the grid continued to crash, saying the government should sanction engineers working in the sector.

He said the constant collapse of the grid had compelled many manufacturers to relocate to neighbouring countries where stable power supply is guaranteed.

"To be candid, the Federal Government should no longer tolerate all the excuses being given by the Minister of Power. He should be fired. Not just him, but with the top engineers working in the sector.

"If government comes hard at them, there will be a remarkable change in the situation. I am aware Nigeria has brilliant engineers as other professionals. So, I can't understand why the power situation has not improved since 1999 when huge amounts had been invested in the sector," he lamented.

Others who responded to the power crisis, said seven years into the President Buhari's administration, the power situation has not improved.

As President Buhari asked Obasanjo a few years ago after the Elumelu Committee discovered that his (Obasanjo's) administration pushed a whopping \$16 billion into the power sector: Where is the power?

While Nigerians may not know how many billions of dollars President Buhari's administration will spend on the sector in his eight-year tenure, till years to come, one thing is certain, Nigeria will also likely ask President Buhari in the years ahead: Where is the power?

Only time will tell if Nigeria will ever join the league of countries that enjoy uninterrupted power supply in the 21st century.

But the question many Nigerians are asking is: "How will Nigerians and businesses survive with the incessant collapse of the national grid and the high cost diesel and other petroleum products? Only time will tell.


control to break existing barriers that impede women from thriving in their chosen careers.

encouraging While everyone, particularly women to be intentional as it relates to building self confidence, Uba stated: "To break the imposter syndrome, we as women, need to hold business ac-





Union leaders bar FG officials from gaining entrance to FIIRO

It was further learnt that the purported strike had nothing to do with the disruption of the internal audit, as management of the agency and the union members have always been engaged in the FIIRO's activities since October 2021 when the strike started.

NCFRIM-IMAAN driving leadership despite daunting challenges

n 2019, Nigeria pledged to the Global Refugees Forum to include matters of refugees, Internally displaced Persons (IDPs) and their host communities in the national development plans and strengthening of the country's protection capacity, ensuring availability and access to durable solutions for refugees and IDPs.

Sustaining Nigeria's role in regional and sub-regional efforts in adjusting the root causes of displacement and Concerned Persons of Interest, was also included in the plan.

As party to the 1951 United (Geneva) convention Nations relating to the status of refugees and its 1967 protocol, Nigeria joined the global community in December 2018. in order to operationalize the pledges, the country produced implementation road map, which was approved by high level stakeholders' meeting on 30th November, 2021, to which we are committed.

Nigeria has already made significant progress in terms of localizing and operationalizing the programme on migration, starting from a favourable asylum policy, land provision for refugees/IDPs/returnees, and inclusion in strengthened national education, health and water system to assist displaced women, men and children and the affected host communities.

In furtherance of its pledge, it invested in inclusion, protection capacity and durable solutions, aligning with the national development agenda and the Sustainable Development Goals (SDGs). The National for Commission Refugees, Migrants and Internally Displaced Persons (NCFRMÍ) under Hon. Imaan Sulaiman-Ibrahim has domesticated these policies and programmes to effectively implement, initiate and facilitate constructive dialogue on migration, map-out sustainable strategies for migration activities as well as promote resilient migration governance in Nigeria. The NCFRMI is partnering

and collaborating with CSOs, NGOs, CBOs and faith based organizations for migration development with the support of International Organization for Migration (IOM) and other international partners to bring development to the grassroots and concerned persons, as the civil societies organizations are key partners in leveraging the Nigerian migration governance structure put in place by the dynamic leadership to aid policy formulation and implementation, and have continuously advocated for the proactive leadership shown by the Federal Commissioner who has remained a rallying factor for various humanitarian partners in the country.

Peering into the extra-ordinary achievements of NCFRMI, Guild of Civil Societies and Media Executives for Equity, Justice) in Nigeria, (GOCMEJ) President, Kenneth Aigbegbele Omoba posited that migration governance in Nigeria has been on a continuous improvement

The Skill-Up Project programme is geared towards training the persons in shoe-making, welding, tailoring, catering, tilling, videography, graphics, website design, making, design, carpentry, hairdressing and barbering with starter kits given to each participant spread across the country to empower them with the ability to develop their creative energies and become selfreliant.

Presently, the management of NCFRMI, in spite of the daunting challenges confronted on daily basis in changing the narrative, shifting the goal post in a new way of doing things by encouraging and advocating for the IDPs not to remain in camps while they enjoy mundane things, but sustainable and durable solutions aimed at teaching them skills that would eventually enable them to cater for themselves and their dependants. that

Aigbegbele added believes "GOČMĔJ that in developmental approach, the Commission is faced with daunting task of catering for the millions of internally displaced persons across the nation.

"The approach, commitment to work by the present management, strategies put in place and resort to development approach will ameliorate the Nigerian situations, as NCFRMI is a frontier humanitarian organ saddled with the responsibilities to provide protection and support for IDP's, Migrants, Refugees, Stateless Persons and Returnees) from any point of the globe just like the recent returnees from Ukraine affected by the invasion of the nation by Russia."

The Commission has successfully carried out repatriation and reintegration of such persons from Libya, and other countries over the years and has also facilitated the safe return to Nigeria refugees with the desire to return and presently seeking asylum in Cameron, Chad and the Niger Republic.

He lauded the Commission's overall goal in strengthening the institutional framework for the realization of the rights, dignity and well-being of vulnerable persons through the mitigation of impact and achievement of durable solutions to internal displacements in Nigeria as documented, implemented, advocated and canvassed by the Imaan-led leadership.

The project Zero Hunger Initiative spearheaded by the Hunger present management, is aimed at bringing immediate relief to vulnerable Persons of Concern and their families facing food insecurity, incorporating a whole societal approach to providing assistance and support to Persons of Concern. The program is also designed and developed to streamline and enhance accessibility, distribution and availability of mainly food and non-food items, thereby eliminating waste and duplication of efforts, which pilot phase has already commenced with DEPOWA, Nigerian Army, etc. while it has also launched and piloted this initiative in Abuja, Nasarawa, Kaduna, Wase in Plateau, Ikorodu in Lagos and Borno State respectively.

This same initiative has been endorsed by the African Union (AU) and domiciled in its yearly calendar, thereby endorsing the theme and actions of the Commission by advancing the cause with its (each-one-feed-one initiative) and adopted '2022, as the year of Nutrition', strengthening resilience in nutrition and food security on the African continent.

The NCFRMI has embarked upon a massive media campaign, sensitization and awareness blitz in order to prevent and reduce the risk of statelessness among the displaced population. It has also

partnered the National Identity Management Agency (NITDA) and the National Population Agency in capturing and profiling of Persons of concern in order to provide them with identification that will allow them access necessary services such as health, financial services and a whole lot of other incentives.

Nevertheless, project Reliance has been very effective and has conducted assessments on food/ non-food items distribution, reducing the suffering of migrants and displaced persons. It is a comprehensive empowerment programme initiated by Hon. Imaan Sulaiman-Ibrahim, geared towards making refugees, migrants and displaced persons sustainably reliant by helping them with start-up capitals and starter packs in various trades and businesses of their choice, partnering with CBN to re-launch and capture more Persons of Concern, encompassing states like Kebbi, Lagos, Ebonyi, Imo, Enugu, Niger, Kwara, Nasarawa, Cross Rivers, Borno, Katsina, Zamfara, Bauchi and Rivers state. The NCFRMI is also collaborating with the National Primary Health Development Agency Care (NPHCDA) on health grounds to roll-out Covid-19 vaccines to all persons concerned.

GOCMEI's states categorically, that the NCFRMI has changed the conversation, shaped opinions and as well created a template to work with stakeholders, CSOs and NGOs as never seen before in any government office or department, that the management of NCFRMI has their eyes and ears closest to the grassroots, vulnerable people and Persons of Concern unlike before and they have the support of the multi- stakeholders across the country who are on daily basis partnering with the Commission to enhance its mandate.

Just as the Federal Government is keen in alleviating 100 million Nigerians from poverty level, the NCFRMI is at the forefront with the support, direction of the Office of the Honorable Minister of Humanitarian Affairs, as its supervising Minister and the motherly role played on sustainable basis to make NCFRMI effectively driven and focused on the task ahead. The NCFRMI has been open to all stakeholders, CSOs, NGOs and supporting agencies including development partners as it has recognized that all hands must be on deck for the successful delivery of its mandate to Nigerians far and near.

GOCMEJ has, therefore, passed a vote of confidence on the present leadership of NCFRMI on its review of migrant policy, policy on refugees and concerned persons and has pledged total support of the civil societies, NGOs, and executives under its umbrella across Nigeria, to assist in delivery of the mandate of NCFRMI.

n the music business, there's no 'almighty formula' to 'blow' its an industry where 1 + 1 will NEVER give you 2" - Legendary Hustler, 2015.

With this in mind, we all know that anything goes and anyone can blow at any time with any method, but no one with a proper understanding of how the Nigerian music industry works would anticipated have 'unprecedented' the success of Ogun State born singer, Habeeb Okikiola otherwise known as 'Portable Olalomi' or 'Dr Zeh' 'Portable who was a totally unknown name in the music industry, in Nigeria, In Africa and in the world until 12th of December 2021 when a video went viral on Instagram showing Portable on his knees thanking rapper, Olamide for blessing him with a verse on a song that would take the world by storm even before its official release.

From that moment on, the phrase 'Zaazuu Zeeehhh' became a thing and as they say, the rest is history.

But how did this history come about exactly? Who had the vision to release a song from this seeming 'diamond in the rough' without following 'due processes?

By 'due process', mean, till date, T there's no well written biography of Portable Olalomi, no photoshoot, no EP, no record of him spending time with producers to work on his sound, no known stylist, no official photographer, never granted an interview on radio, tv or even Instagram live, absolutely nothing, just vibes and insha Allah.

Despite all these, Portable in a space of 10 days became the hottest viral sensation, got a number 1 song in the country, in just a few days he was on stage performing with the biggest acts on the African continent -Wizkid, Davido, Burna Boy, Olamide and Tiwa Savage - a feat that hundreds before him who have spent years in the industry cannot boast of.

reasonable Anv record label or industry consultant with all the requisite music knowledge business definitely would not have released a debut for Portable song Olalomi in December. There's data to show that it's difficult if not totally impossible for a new song let alone a new artist to 'blow' in the month of December - for obvious reasons but 'Zazzuu' did it.

A record label would surely not have released a song for Portable Olalomi in his 'rough' state, with no proper skin care routine in place, feeding, making him look good, getting a stylist on board to define his looks and getting professional photos to make him look appealing and presentable, but again, 'Zazzuu' did it without all these.

the Like known Mavin Records model that applied to superstars like Rema, Ruger and Ayra Starr, get them in a studio, groom them and have them spend time with different producers for about 6-months to prepare them for the journey ahead. None of these applied to Portable Olalomi and if he had gone this route, he surely would not have 'Blown'. His success was embedded in the raw, ugly and uncut version of his persona, any attempt to refine and package him would have ended in premium 'tears' for the investor.

Now that he's here, special shout out has to go to rapper Olamide for taking the chance to feature on his song and a bigger shout out has to go to his manager and promoter, Quadri Taoreed, also known as Kogbagidi who saw the vision and went with his guts.

As expected, the intellectual industry experts are already predicting doom and an early demise for Portable Olalomi's career and rightly so.

But for someone that has defied all the odds and logic that got him to this point, it is only expected that his team will now take this as a serious business and begin the process of refining him, plugging him into the right collaborations and strategies that will ensure longevity for him. Vibes and insha Allah can only get you so far, sustaining the momentum is no easy feat and if he wants to be relevant for a long time, then there's need for serious introspection and a proper structure.

NFF search: who gets Eagles coaching job? Osimhen eyes Simeon

fter former interim coach of the Super Eagles, Augustine Eguavoen, stepped down and the entire technical crew was sacked by the NFF, Nigerians have been skeptical about who takes over the coaching affairs of the nation's senior men's football team.

Following the Super Eagles' exit from the TotalEnergy Africa Cup of Nations (AFCON) in Cameroon and their inability to secure the World Cup qualifying ticket to Qatar 2022, it is expedient that some things need to be put right to chart a way for the nation to re-attain the feat it once had in world football where Nigeria emerged 5th April 1994 FIFA in rankings.

However, the Nigeria Football Federation (NFF), aware of the daunting task to Super reposition the Eagles for future tournaments, with the AFCON 2023 in Cote D'Ivoire imminent. are seriously in search of a head coach to fill the void left by Gernot Rohr.

Apparently, the NFF has set the machinery in place to rebuild technical crew the of the Super Eagles, mandating its Technical and Development Sub-Committee to make recommendations within 5 days to the Executive Committee on new coaching crews for the Super Eagles, other national and teams.

Why the rebuilding of the Super Eagles is sacrosanct, and to quell the wide speculations about hiring a local allegedly coach as posited by the Minister of Youths and Sports, Sunday Dare, the President of NFF Amaju Pinnick stated that the football governing body has zeroed on acquiring the services of a foreign coach.

Following the resolution to hire a

foreign coach for the Super Eagles, snippets from the Glass House have revealed that some foreign coaches have been penciled to be considered for the Super Eagles' job with Portuguese José Peseiro among the list. Spain's Valverde, Ernesto Paris former Saint-Germain coach Laurent Blanc, and Philip Cocu rumoured to be among the crop.

Who finally gets the job among this crop foreign coaches of is a puzzle that the exclusive right of the NFF to solve. But with urgency to finish the Super Eagles' coaching the football project, governing body will not gamble with time to announce to Nigerians the successor of Gernot Rohr.

Portuguese Jose Poseiro, the coach earlier contacted by the NFF to take over the Super Eagles after the sack of the German coach last year, is a football tactician who has coached in several clubs in Portugal, Spain, Saudi Arabia, Greece, Africa, Romania, and Venezuela.

Poseiro, as an assistant coach in Madrid in 2003-04 the season, proceeded to Portugal to manage Sporting ČP, a Primera division club, which ended as runnerup in the UEFA Cup in 2005.

He has also coached in several clubs besides Sporting CP in Portugal like Porto, Victoria Braga, Guimaraes, Oriental, Nacional. União Montemo, and União Santarém, the club he started his coaching career in 1992.

The 62 years old gaffer also had a brief spell in Africa with Al Ahly of Egypt, winning the Egyptian Premier League in the 2015-16 season. He won the Portuguese Cup with Braga, AF Madeira Cup with Nacional, and helped Porto to the finals of the Portuguese Cup where they ended as runner-up.

Following, Spain's Ernesto Valverde rumoured to have been included in the list for consideration has

managed top-flight clubs in Spain, with the most recent being Barcelona.

The football manager, confines outside the Spain, managed Olympiacos on two occasions, winning the Greece league title three times and the Greece Cup twice.

Though without coaching spell in а Africa, Valverde who also coached Athletic Bilbao with a Spanish Super Cup added to his honour, won a treble with Barcelona in the 2017-18 season. He was also named the La Liga Coach of the Year in 2015-16 by the Union of European Football Associations (UEFA).

Contending with the Portuguese and Spanish football coaches for the Super Eagles job, is the former French national team's coach, Laurent Blanc.

Blanc, according to records, has coached four teams in his career with many honours won. His spell with Bordeaux in France Ligue 1 recorded a treble in the 2008-09 season while his PSG's three seasons reign hauled in over ten trophies for Paris De Princes with three consecutive wins of the French Ligue 1 title.

Going by the names and personalities of the coaches, the NFF has work to do to get the perfect fit for the African style of football and to give the team a blend of local talents and touch exposed foreign of players to go beyond the feat recorded by Clemens Westerhof in 1994



Don't dare Nigeria on Pay-TV tariffs, Lawan warns Multichoice

Asks S'African firm to stay action

enate President Ahmad Lawan has read the riot act to Multichoice Nigeria. He warned the Southern African firm not to dare Nigeria by going ahead to hike the tariffs of its services while the matter was yet being investigated.

Consequently, he inaugurated a seven-member adhoc committee headed by the Senate Deputy Chief Whip, Senator Aliyu Sabi Abdullah, to investigate the while warning that no foreign operator in the country should take Nigeria for granted.

The committee was set up by the Senate on 30th April, 2022 against the backdrop of an announcement of tariff hike by Multichoice, a pay TV service provider, popularly referred to as DStv.

"No operator should take us for granted. We mean business. We want you to be here. Nigeria always provides the climate for you to do your businesses but don't abuse the laws of our country.

"Our consumers here are people who are innocent and we are prepared to protect them.

"Meanwhile, stay action. No increase. No increase. And that is to say don't dare our country. No increase in tariffs," the Senate President warned.

"The reason for setting up this adhoc Committee is well known and this is in consistent with what we are supposed to do as members of parliament, as distinguished senators.

"When the legitimate interests of our people are threatened, we are supposed to ensure that we protect them.

"It has been the practice of many companies, especially foreign companies operating in Nigeria to treat the Nigerian consumers of their products in a different way and manner that is not consistent with global best practices.

"I'm not going to preempt the outcome of this investigation but one thing is clear, that the Senate is prepared to go all the way to unearth the exact situation that is happening with respect to how much Nigerian consumers of the DStv or Pay-TV tariffs are charged and how does that compare to other jurisdictions in other countries.

"DStv, one of the operators, has shown the tendency to increase the tariffs without due consultation with stakeholders and we feel this is not the right way to go about it and therefore we even need to find out whether or not what we are paying already is not out of the roof and different from what other countries are charged. "So your task as a committee is to look at the issue very dispassionately with a very clear mind and focus on what we need to know.

"The Consumers Protection Council and other agencies of government and even NGOs and CSOs are supposed to attend this kind of investigation. We need to know what roles actually such government Institutions established for the purposes of protecting Nigerian consumers perform. What are their problems if they are not doing well.

"The report, at the end of the day, is supposed to be a report that will guide the Senate to take resolutions that will ensure that Nigerian consumers of the products, Pay-TV, are fully protected but at the same time that will not emasculate the businesses. We want to see a winwin situation for both consumers and operators.

"But let me be very clear at this point, we are going to take on any operators who decide to charge Nigerians tariffs that are not charged anywhere outside this country.

"I also want to add here that any operators, especially foreign, who doesn't want to respect and obey our laws should leave. Afterall, it is only in this country that most of these operators behave the way they do, whether

they are telecoms or DStv or whatever.

"In other climes, they do better. They respect the consumers. They respect the laws of the countries where they operate. It is only in Nigeria where they don't give us any respect and I think we will take them on.

"I pray that they do the right thing so that they will not run into any trouble of fighting the injustice. What happened in the past should provide us lessons and issues that we should look at.

"Infact if Nigerian consumers were extraordinarily cheated, they should be paid back. They do that in other countries. So I hope that all operators will cooperate with this committee. That when they are invited to appear before the committee they will appear."

Senator Aliyu Sabi Abdullahi said: "the investigation into the activities of the Pay-TV service providers is long overdue as their activities, over time has reaped off Nigerians of their hard earned income.

"It is mind burgling that barely two years of the price hike by the Multichoice which was followed by a big uproar by Nigerians, comes another unexpected increment without proper consultation with critical stakeholders.

"This incessant hike in tariff without recourse to constituted authourities is a thing of great concern that calls for questioning.

"This investigation is an opportunity to right the wrongs and bring this service providers to operate within the confines of the law as obtainable outside the shores of the country."

I'm delighted mentoring politicians, says Atiku I contested governorship election four times'

Former Vice President Atiku Abubakar has said that he mentored many young politicians and that he was delighted doing so.

Encouraging young politicians not to be daunted by challenges in politics, he disclosed that he contested for the governorship position four different times before he finally won it in 1999.

Atiku disclosed this during an interaction with leaders of his support groups from across the country in Abuja. He said he was delighted that more young people were participating in politics today and that it was his dream to mentor the young generation and hand over his political structure to them.

According to him, "it is encouraging that these days I see many young people come to me declaring intentions to run for various political positions, some state assemblies, some national assembly and even some aspiring to be governors.

"The beautiful thing is that

this shows that our democracy is being strengthened. I also started early like many of you. I started in my late 30s. During our time, our direction was to fight the military and return the country to civil rule.

"In joining politics, you have to be focused, principled and courageous. For example, I contested for the governorship position four times before I was finally elected. That is politics for you. You have to be determined and be courageous."

He thanked leaders of the

groups for the roles that they played during the 2018-19 election and commended them for their discipline and determination to be better organized than the last outing.

That we are more organized now is a reflection of the fact that we are now more experienced and with experience comes more knowledge and what that means is that if there was any mistake that we made last time, we are in a better position to avoid such mistakes now, he added.
