# Aisha Buhari's push for female VP may raise dust

resident Muhamadu Buhari's wife, Hajia Aisha, is apparently not on the same page with him over her insistence on a female Vice President emerging from the 2023 general elections.

The First Lady is urging political parties aspirants consider having women as running mates for candidates at all levels in the elections as part of her drive for the emancipation of women in politics.

However, President Buhari will most likely go along with his 2party's eventual plan for a running mate to its standard bearer for the presidential poll. No strong or even serious presidential female aspirant has indicated interest in the ruling All Progressives Congress that could eventually be considered as a running mate to its presidential candidate.

Also, her demand for a female vice president might not sit well with Nigeria's northern conservatively orthodox establishment Islamic whose interpretation of the religion limits women's participation in politics and leadership.

Like her husband, Aisha Buhari has not openly backed any of the APC's presidential aspirants for any of which indication camp or campaign a running mate will emerge from.

But Aisha maintained that it was "high time women were adopted as running mates at all levels considering their voting strength and active involvement in political processes."

She made this call while playing host to presidential aspirants from various political parties at a Ramadan (Iftar) breakfast at the State House, Abuja.

"As we approach the 2023 election with greater hope, I am confident that Nigeria will continue to grow from strength to strength on the pedestal of our democratic tenets," she said.

APC national leader, Bola Tinubu, Governor Dave Umahi of Ebonyi. Minister of Labour Employment, Chris Ngige, and Governor Bala Muhammed were among the presidential aspirants who honoured the invitation of the First Lady.

Buhari also seemingly has a different view of women's participation in politics.

He had in Germany responded to a BBC interview where his wife also seemingly guestioned leadership ability and claims that her husband does not know 45 out of 50 persons appointed in his government.

sarcastically responded: "I don't know which party my wife belongs to, but she belongs to my kitchen and my living room and the other room."

Buhari's comment went viral on the internet and made big headlines in almost all the major newspapers in the country.

The President's body language has constantly pointed in the direction conservatism terms of women's participation in politics. From the outset, he refused to recognise the office of the First Lady. He rather prefers to call it "Office of the wife of the President."

His stance on women holding vital public offices frustrated Aisha who wanted a functional office as First Lady. Probably her inability to cope forced her to relocate to Dubai, where she flew from to meet with the presidential aspirants.

Meanwhile, an Abujabased Islamic scholar and cleric, Ustadh Abu Jabir Abdullah Musa Abdul (Penabdul), has said that the Holy Qu'ran especially the Hadith forbids women from aspiring to positions like the office of the Vice-president (VP) of a country, where they would hold 'General or Absolute' powers.

According to him, "positions like the office of the V.P. will place such women in a position where they can order the deployment of troops and other members of the country's Armed Forces. This type of power which is 'general

or absolute power' Islam forbids and frowns at.

'The caveat, however, that women in Islam, can aspire to the pinnacle of their various professions in life as professionals. The positions they could aspire to could be State Governors, Ministers, Director of industries, Directors of Ministries, Directors of Government Parastatals, agencies and banks. Women could also be chief executives of Industries, banks and other commercial ventures.

"There is no dispute among the scholars that one of the conditions of the Imam or leader is that he should be male. Ibn Hazam reported in his book Maratib al-Ijma' that there was scholarly consensus on this point. In the section he says: "Out of all groups of the people of the Qiblah [i.e., all Muslim sects], there is not one that allows the leadership of women."

The evidence for this

is the general meaning of the ayah: "Men are protectors maintainers of women because Allah has made one of them to excel more than the other." (al-Nisa 4:34].

"It is also clearly indicated by the hadith of Abu Bakrah who said that when the Prophet (peace and blessings of Allah be upon him) heard that the Persians had appointed the daughter of Chosroes as their queen, he said, 'No people who appoint a woman as their leader will ever prosper." (Reported by al-Bukhari, 13/53).

Another Islamic cleric, Alhaji Tajudeen Adigun, disagrees with this position, saying the Holy Qu'ran is expressly clear about positions. Allah, he maintained, is the one that gives power to whosoever he pleases and as such if a woman gets any position, it was only possible because God allowed it.

First Ukrainian corn cargo leaves Romanian Black Sea port since Russia invasion By **OROWO VICTORIA** Ojieh with agency report

A cargo carrying over 71,000 tonnes of Ukrainian corn finished loading in the Romanian Black Sea port of Constanta on Thursday, the first since Russia invaded Ukraine on Feb. 24, the manager of port operator Comvex said.

Ukraine's seaports have been blocked since the war started more than two months ago, the world's fourth-largest grain exporter has been forced to send shipments by train via its western border or through its small Danube river ports into

This is the first Panamax vessel with Ukrainian corn to leave the port," Comvex President Viorel Panait said.

According to the agency's source, the ship taking the cargo is the Unity.

"Supporting Ukrainian grain exports means preventing a colossal wave of global hunger triggered by the blocking of Ukrainian ports," Panait added.

Comvex operates Europe's fastest-loading grain terminal, which can process up to 70,000 tonnes per day, as well as a mineral handling terminal, said Panait, who is also president of the Constanta Port Business Association.

Earlier in the week, the finished loading operator around 35,000 tonnes of Ukrainian iron ore, with a second ship expected to be loaded around May 15, he said.

"Compared with the initial moment, when everyone was searching for alternatives, transport corridors for these exports are slowly taking shape," Panait said.

Around 80,000 tonnes of Ukrainian grains have been sent to Constanta so far, with another 80,000 approved and en route, Constanta Port's manager said on Tuesday.

Romania, a member of the European Union, shares borders on the Black Sea, a major shipping artery for grain and oil, with Bulgaria, Turkey, Georgia, Ukraine and Russia.

But, more work is needed on the port's connecting infrastructure, Panait said.

"The infrastructure around the port is a problem for all economic activity in Romania. Slow access generates additional costs in these industries."

Panait welcomed plans by the Romanian government to rehabilitate several rail lines connecting ports to the Ukrainian borders.

# Amaechi consults with Delta APC leaders, delegates, meets Asagba

Rt. Hon. Chibuike Rotimi Amaechi has taken his consultations for the 2023 presidential primary to Delta State where the All Progressives Congress (APC) welcomed his

candidacy.

Amaechi who met with the leadership of the APC and delegates in Asaba, Friday, urged delegates to vote for him for his competence and not just because he is from the South South. He also paid a visit to the Asagba of Asaba, Obi Chike Edozien.

Speaking to the delegates, Amaechi said: "There are two essential elements that takes people to power, governance and infrastructure. If you combine this two, you create an economy. I am ready for you to run a referendum on my past activities. Governor for eight years, speaker for eight years, and Minister for seven years. Let anybody who says Amaechi should not be President ask 'what is his capacity?' as Minister for Transport, I was on this track, Warri-Itakpe rail line. When we came, there were bushes and trees on the track. And knowing that South South is part of Nigeria, I got the President to approve money, it wasn't a loan, it was funded from the budget. Today, you can travel from Itakpe to Warri,

Warri to Itakpe and then to Abuja.

"The point I'm making is, it was there 32 years before we came, if we did not do it, it would have continued to be like the forest that we met. I'm working extremely hard to make sure Lagos-Calabar rail line starts. We've awarded the contract, we are looking for the loan. What affects you is that from Benin, there's a spur to Onitsha, and there's a new bridge into Onitsha. If I don't become the President of Nigeria, nobody will do that project, because it is \$11 billion and that is for now one of the biggest projects in the world. So this is not the time to play with your votes. It is our future. The day we do Lagos-Calabar which goes up to Onitsha, that is the day you'll see some developments coming back here. Just give us another six months, you'll see the impact of the second Niger bridge.

"As Minister, I don't think the Nigerian people will say I'm an absent Minister. I'm a Minister that is present almost all the time, because I know what it is to deliver to the people. I have that capacity to deliver. Vote for me because I have the capacity to turn Nigeria around, and when I get there, please hold me accountable.'

Amaechi recalled how, when he was governor of Rivers, he would hold town hall meetings in different local government areas to give account of the monies received by the state government and projects they were being spent on, including payment to contractors to ensure they were equally held accountable. He assured that with him as President, things will change for good.

"I don't have the solution to every problem in Nigeria, but things will certainly come to change. If you read my declaration, you will see 'hope is in the corner,' all you need do is to push it a bit and you'll see the difference. The electability of a candidate is necessary for APC to win. Please give me your votes at the primaries," he said.

Responding to accolades that he helped resolve the differences in the APC in Delta State, Amaechi said: "It was necessary if APC will win the South, for the party to be united. For Delta, all it took was call my friends and say, look, three persons cannot be governor, so let us allow one person go and everybody will have peace. I think that was the deal breaker."

Earlier, the Chairman, Delta APC, Engr Omeni Sobotie, thanked Amaechi for being instrumental to the resolution of all issues within the party in the state and bringing them back together as one. He affirmed that the party is going into the primaries as a united front.

"I want to announce to everybody that APC Delta, in the last 48 hours something happened. For the first time since 2015, we are going to go into the battle of 2023 as a united front. We no longer have any differences in APC. I want to acknowledge the man with whom God has done this for us, Rt Hon. Rotimi Amaechi. God has used him as an instrument to effect total reconciliation in the party. I also want to tell you that the Deputy President of the Senate (Omo-Agege) is so excited that you've been able to achieve this.

"In our midst is a man who has the courage of a lion. When you have courage, you are in the majority. But for your courage sir, the South South would have been put to shame. We stand with you, we stand behind you. We have 88 statutory delegates here, by the time we add the adhoc delegates it will be 161. We want to assure you that all the votes will be cast in your favour," the chairmán added.

#### Lagos birthday shooting: Widow of late Obieshi disagrees with police, says husband was assassinated

istraught widow to slain birthday guest, Mrs Vivian Ifeyinwa Obieshi, has picked holes with the accidental discharge position of the Lagos State Police Command, saying her husband, Mr Chikere Obieshi, popularly known as Jesus Brother JB, was assassinated at the venue of the birthday.

She said her husband was killed because of his good nature, adding that he didn't want to attend the said birthday party.

Mrs Obieshi, who spoke to The Trumpet at her Egbeda home in Alimosho Local Government Area, described her husband as a loving and caring man, who would not hurt a fly.

According to her, when the celebrant of the party, one man popularly known as Asiwaju, invited her husband, he was initially

sceptical about attending but changed his mind to only grace the occasion and not to waste time adding, "he said he would only go and give the celebrant his own token and return back home.'

The 28-year-old woman, who is just recuperating from a successful surgery, said amidst tears, "I am heartbroken and bitter, and what I want is justice for my husband, justice for JB, justice for JB Communications because the only wrong thing he did was to be a brother's keeper."

'Anywhere he enters, he makes friends and tries to put smiles on the faces of everybody. This is why I am saying that this is not a case of an accidental discharge, this was a planned deal. I want justice for him and want all those involved to be brought to light and all those involved to be brought to justice.

Speaking further, Mrs

Vivian said, "My husband was invited to a birthday party by someone nicknamed Asiwaju before he was killed. I have never heard him tell me that Asiwaju invited him for a birthday, he was invited to the party just close to the bus stop, close to our house and he called me. That place he was invited to, he doesn't like going to such places but because he was somebody that likes honouring invitations, before he entered there he called me, he was like, let me just show my face, honour the invitation and come out, I'm coming in the next few minutes you will see me, I was like it's

"But a few minutes later, I started hearing there was a gunshot at the bus stop, at Da-Silver Club and the so-called Asiwaju that invited him for the birthday jumped over the fence, ran out and he is nowhere to be found, no



communication, he could not even reach us the family or to tell us what happened or anything.

'So I feel this was a perfectly signed deal. Before the incident on Sunday, the celebrant had called my husband telling him of a birthday, later that night he called him that it had been cancelled, that they should move it till Sunday. If it was far, he wouldn't go because he knows the condition of his family, he knows my condition. I believe vividly that this was a set-up."

Describing a video, which she claimed she saw, "From the video that I saw, the Asiwaju was very anxious, he felt something was going to happen. My husband was spraying him with money, he was just standing uprightly, not moving, not dancing. Immediately the gunshot was aimed, he flew over the fence, took his car and left, so I believe this was a clear assassin's case.

"I want the Inspector General of Police and everybody to critically look into this case, I want justice for me and for my children, I want justice for JB Communications. I know my husband's soul is not going to rest until justice is served."

The widow's suspicion stemmed from the fact that when the incident took place, the police did not contact her; rather she called the police on the morning she was informed of JB's death. She said all effort to reach her husband on the phone was unsuccessful, stressing that an officer later picked up her call and she told the officer to give the phone to her husband out of disbelief.

"Just give the phone to my husband, I want to hear my husband's voice, he was like you should come to the station. This was when I knew that something had happened."

Earlier, the Lagos State Police Command had given a statement describing the incident as accidental and that the suspected killer policeman was not on duty as of the time of the incident.

"A shooting incident occurred at La Silver Bar, Egbeda which resulted in the death of two persons and injuries to others. Upon receipt of the information, the Lagos State Commissioner of Police, CP Abiodun Alabi, ordered an immediate full-scale investigation into the circumstances surrounding the unfortunate incident.

"While the investigation is ongoing, findings so far reveal that the shooting was accidental and involved an off-duty police officer, Inspector Mohammed Hussini, serving at the State Headquarters, Ikeja. Findings equally reveal that the off-duty officer is a friend of the celebrant, Ifeanyi, aka Obama, and was not at the party in any official capacity.



> The General Manager, LASBCA, Gbolahan Oki, who led the enforcement exercise after the state governor, Babajide Sanwo-Olu, lifted the suspension over the Ikoyi highrise building collapse, stated that the demolition of the building was necessary to avert a total collapse of the building, which may have cost lives and property of citizens.

> The LASBCA boss further stated that the construction

of the buildings was ongoing before they were pulled down, to prevent them from collapsing willingly.

On the two-storey building in Oribanwa, he noted that the agency's personnel discovered the distressed building earlier and sealed it up after serving all statutory notices, including a stopwork order.

Stating that all the processes yielded no positive response from the recalcitrant developer, the General Manager maintained that some building owners/ developers were bent on contravening the state's building laws, threatening that the agency would continue to compel compliance, to avert further building collapse across the state.

On the two other buildings, Oki disclosed that they were removed for being built on access roads in violation of the Lagos State Building Control Law.

He observed that no responsible government will watch its citizens die an avoidable death without taking the precautionary measures to avert it.

The General Manager, therefore, called on building owners/developers to seek appropriate authorisation from the agency before the commencement of any construction, subject their existing buildings to the Structural Integrity Tests, and obtain all necessary building permits.

## Delta police arrest suspected drug dealers, recover illicit drugs

Operatives of the Delta Police Command, led by CP Ari Muhammed Ali, have continued to make great strides in the fight against criminality, armed robbery and drug smuggling, following the seizure of illicit drugs and cocaine in the state metropolis.

The Command's Crack Squad, while acting on information, raided a suspected criminal hideout at Azugwu Street, Umuonicha quarters in Ogwuashi-Uku,

and arrested three suspects, namely; Izuagbe Theophilus 'm' age 20yrs; Okofu Henry 'm' age 22yrs and Confidence Ugochukwu 'f' age 19yrs.

Exhibits recovered from them include 147 wraps of dry weeds suspected to be loud, 47 wraps of substances suspected to be cocaine, seven wraps of colorado, and 44 wraps of weeds suspected to be Indian hemp.

Suspects are in custody and the investigation is ongoing.

This was disclosed to The Trumpet by the Command Spokesperson, Bright Edafe.

In another development, operatives attached to Safer Highway Patrol, deployed along Benin-Sapele Road in Sapele, while conducting stop and search, intercepted a Toyota Camry car with reg no. APP 134 UP, driven by one Osasere Megegbe 'm' age 45, in company of one Edosa Monday 'm' aged 35, both of no 12 Emah Community Road, Ekiadolor, Benin City."

"During the search, one cut-to-size double barrel gun was found concealed inside the engine compartment. The suspects were promptly arrested, the gun and vehicle recovered at the station. Upon further investigation and interrogation, two additional long single barrel guns shrouded under the back sit of the vehicle were also recovered. Suspects are in custody and will be charged to court upon completion of investigation.'







# If not a state, FCT deserves two ministers - Tambuwal

okoto State governor and presidential aspirant of the Peoples Democratic Party (PDP), Aminu Tambuwal has advocated that the Federal Capital Territory (FCT) deserves two ministerial slots in the federal executive cabinet.


Tambuwal's insistence was at the meeting held with PDP delegates from the FCT Thursday night in Abuja.

"So I understand that the issues are, so what is important is for you to work with us on this campaign train. This is a project

Speaking on behalf of the FCT delegates, Hon. Sunday Dogo Zakka, Chairman of FCT PDP, pledged that the FCT will support the Sokoto governor. He said "you have been there for the party we will continue to appreciate you because you have been there for us. You have been there for the party.

# 2023: Jonathan not interested to run - Ononuju

But Dr Ononuju, a Bayelsa born politician and a close associate of Jonathan said the former president is not interested in contesting either APC or any other platform.


In a statement made available to The Trumpet Friday in Abuja, Ononuju said


## Politics useless if not beneficial to my people - Senate Deputy Chief Whip

# 2023: Amaechi, Abe return to the trenches for the soul of Rivers APC

olitical analysts in Rivers State are miffed at the endless and rancorous circus show being displayed by the former governor of the state who is the current Minister of Transportation, Rt. Hon. Rotimi Chibuike Amaechi and his once trusted friend and confidant, Senator Magnus Ngei Abe.

Anyone who has been following the political trajectory of these two great sons of Rivers State cannot but pause and wonder about the Lucifer who has put a seemingly irretrievable wedge between the duo with inevitable collateral damage.

The relationship between the two political gladiators began at the Rivers State House of Assembly after the 1999 elections when both won elections from their various constituencies. Amaechi represented Ikwerre while Abe represented Gokana, on the platforms of PDP and APP respectively.

It was Abe's exceptional brilliance at debates on the floor of the House even as the Minority Leader, that endeared him to Amaechi who was the Speaker. Amaechi often consulted Abe who is an accomplished lawyer on anything that needed any legal interpretation before the House would conclude debate on such issues.

Soon, the two young politicians bonded more which resulted in Abe defecting to the PDP to seal the bond of friendship with Amaechi.

The friendship also brought Abe very close to the then Governor Peter Odili, who was Amaechi's benefactor, and this earned Abe's appointment as Commissioner for Information in the second term of Odili as governor.

Abe stood with Amaechi through thick and thin even while Amaechi was in political exile in Ghana after falling out of favour in the Odili political family.

That was why upon Amaechi's swearing-in as governor following the Supreme Court declaration, he promptly announced Abe as his Secretary to the State Government,

Abe later ascended to the National Assembly, the Senate, to be precise and spent two terms.

From the National Assembly, Abe started thinking homewards for the next logical rung to climb in the ladder of his political career and it became the governorship position.

But here he encountered what was to him like a benumbing anathema, akin to the Caeser-Brutus scenario as Amaechi emerged from a blind angle and impudently asked him to perish the ambition.

Amaechi had become the leader of APC in the state when he defected to the party from PDP, pulling most of his loyalists including Abe along

with him.

A governor of the Ogoni extraction had been a long-standing demand within the political space in Rivers and Abe had felt that his relationship with Amaechi would make the realization of that desire even much easier. There have been rumours and gossip over issues bordering on power tussle between both camps, which made Amaechi to pitch his tent against Abe. According to an insider Ameachi even swore that Abe would be governor over his dead body!

Amidst the rancour and acrimony occasioned by Amaechi's rejection of Abe's governorship bid, he, (Amaechi) had gone ahead and anointed the immediate past Director-General of Nigerian Maritime Administration and Safety Agency, (NIMASA), Dr Dakuku Adol Peterside to fly the governorship flag of APC in 2015.

This necessarily marked a turning point in the once blossoming relationship between Amaechi and Abe as they went their separate ways politically, though still in the same party, APC which became factionalized into Amaechi and Abe camps.

The crisis triggered in the APC by the avoidable face-off between the two gladiators culminated in the deleting of APC on the INEC ballot papers for all categories of elections conducted in the state in the 2019 general election as Abe's faction succeeded in convincing the court that they were unjustly shut out of the congresses conducted by the APC in the state.

Ahead of the 2023 elections, the storm seems to be gathering very



ominously again against the Rivers APC chapter as the two factions remained fixated on their extreme positions not to reason with each other to find peace.

Observers had expected that after the fate it suffered in the 2019 elections where it fielded no candidate the election over internal crisis; the APC would look inwards ahead of the 2023 election and sort out its challenges.

But it appears history is about to repeat itself again as the faction led by the Minister of Transportation, Rotimi Amaechi has announced Arch. Tonye Cole, the INEC rejected candidate in 2019 as the consensus governorship candidate of the party for the 2023 election, a development the faction loyal to Abe, has sworn would not stand.

In a three-paragraph statement addressed to party members, one of the elders of APC in the state, Senator Andrew Uchendu had broken the news of the emergence of Tonye Cole as the consensus governorship

He said, "Last night, our Leader, CRA, (Chibuike Rotimi Amaechi) set up a Committee of Elders of about 19 members to meet immediately and decide on the Governorship candidate of our party.

"We all met for about two hours and unanimously chose Tonye Cole. The committee immediately communicated this choice to our leader.

"I was a member of that committee and therefore invited all of you to accept this decision and communicate the same to all our members. It is in our overall interest to do so. Let us get down to work for all our candidates", he pleaded.

But upon hearing what had transpired, Senator Abe roared that nobody could enslave Rivers people, no matter the quantum of the person's wealth or social status in the society.

In a statement issued by his spokesman, Parry Sarah Benson, Abe noted that Rivers people could not be enslaved by anyone through crooked manoeuvring, and advised his supporters to brace up for the fight ahead which he said would not be easy.

"I have said it before and want to say it again, that Rivers people have never been slaves to anybody and nobody no matter the amount of money he has, nobody can enslave us here in Rivers State. We can chart our own destiny.

"Let me assure you all that the road ahead will not be easy but you have the power, the capacity and audacity and I know that we can do it. We will do it and we'll win.

"I will present myself to the Rivers people and if they decide to choose a better person over me through a transparent process, I will support

"We must have a clear and transparent process. But if they bring somebody through a Kangaroo process, we will not accept. We will challenge it", Abe maintained.

He stated that the party needed everybody to be able to succeed, saying that to achieve this, the party leaders must make room to accommodate everybody.

He said: "As far as possible, we must be able to work together to bring our party together. Let us not deceive ourselves; this party needs everybody to be able to succeed. We must be able to make room for one another.

"We must be able to accommodate one another. In politics disagreements are normal and it is expected. What is not normal in politics is hatred such as people have been preaching amongst us here, the Rivers people.

"Whether you are APC or PDP; whether you are with Magnus or with Amaechi, you are a Rivers man. You are the proud son of your father and your mother.

"You deserve the best and the reason why we are doing politics is so that we can offer you the best. And that is why I am here. We have a track record of saying something and standing by what we said", he pushed.

Observers say the crude intransigence on the part of Amaechi and Abe over who gets what in the party could again scuttle the chances of the party to get a foot holding in 2023 election and ultimately consign the party to perdition in Rivers.

Oba Adedokun Omoniyi Abolarin is from the Aniyunlogba ruling house in Ile-Obasolo, Oke-Ila Orangun. He was born and raised at Gbenla in Ibadan. His mother is from Ipoti-Ekiti in Ekiti State. His late father was a Primary School Headmaster while his mother was a teacher before she finally decided to go into full-time trading as a housewife.

It was therefore no surprise, that Oba Abolarin, after graduating with a Bachelor's degree in Political Science from the then the University of Ife in the year 1980, decided to go into teaching, after a brief working experience as an Administrative Officer in the Ministry of Aviation, immediately after completing his one-year mandatory National Service.

From 1981 to 1989, Oba Abolarin lectured at the then Oyo State College of Arts and Science (OSCAS) in Ile-Ife. That was when he took the opportunity to go back to the University again to take a first and second degree in Law.

As was the case with most children of his age and time, Oba Abolarin youthful experiences while growing up was tough

Kabiyesi, I observed that you recently conferred a chieftaincy title of Aare Agbaakin and Yeye Aare Agbaakin of Oke-Ila Orangun, on your former school mate at the University of Ife, Chief Oyewole Olaoye and his wife, Chief (Mrs.) Anne Ndidiamaka Olaoye. What were the other qualities other than being your former schoolmate, you and your council of Chiefs considered before finding Chief Olaoye and his wife worthy of these titles?

Kabiyesi: There were so many qualities which I found in Chief Olaoye and his lovely wife, which qualified them for these exhorted titles in my kingdom. Those of them in Adeleke University, are ten presently, and to the glory of God, they are there as students courtesy of the Springtime Development Foundation, Ede. Happily, my little girls of the other day, are now big beautiful, cerebral hardworking, girls with big, big ideas and dreams.

You just imagine if these girls, because of the unfortunate nature of their births, were on the streets engaging in different vices, what benefit would they have added to the society? Nothing! Absolutely Nothing! When I see them, it gives me a lot of joy to continue to do what I am doing, not minding the pains and hardship.

## AfDB President visits Ooni of Ife, Speaks on Effects of Russia-Ukraine's War

The President of African Development Bank, Dr Akinwumi Adesina, on Monday, 25th April 2022 paid Ooni Adeyeye Enitan Babatunde Ogunwusi Ojaja II, a courtesy visit in his palace in Ile-Ife.

Adesina, who immediately went into a closed-door meeting with the Monarch in his palace, was said to have discussed with the Ooni on the need for him to mobilize his kingdom and the entire Yoruba race, to be prepared for

the inevitability of a global food crisis.

The AfDB boss was said to have spoken extensively on the need for African countries to get their priorities right, especially now, that the continent has the most vulnerable countries and is hardest hit, by the conflict between Russia and Ukraine, climate change and the Covid-19 pandemic, which the AfDB President stressed has impeded the economic and development progress in the Africa continent.

Adesina pointed out that Africa, with the lowest GDP growth rates, had lost

as many as 30 million jobs on account of the recent pandemic.

He told the Ooni that the tripling costs of fertilizer, rising energy prices, and rising costs of food baskets, could worsen in Africa in the coming months. He explained further, that 90 percent of Russia's 4 billion dollars exports to Africa in 2020 is made up of wheat; while 48 percent of the wheat valued at \$3 billion U.S. dollars was also exported to the continent by Ukraine. These are the two countries that are presently at war, thus making it impossible for this food chain to continue. Ukraine, as AfDB President also pointed out, is the exporter of 31 percent of maize to African countries.

AfDB President, therefore cautioned that to fend off a food crisis in Africa, Africa must rapidly expand its food production. He stressed, "The African Development Bank (AfDB) is already active in mitigating the effects of a food crisis through the African Food Crisis Response and Emergency Facility – a dedicated facility being considered by the Bank to provide African countries with the resources needed to raise local food production and procure fertilizer.

"My basic principle is that Africa should not be begging. We must solve our own challenges ourselves without depending on others". # Perm Sec makes case for military, civilian driven Defence Ministry

■ Calls for societal synergy in combating insecurity

The new Permanent Secretary of the Federal Ministry of Defence, Dr Ibrahim Kana has stated that one of his aspirations for the Ministry is to see to the deployment of more military personnel alongside their civilian counterparts to take up key positions in the Ministry.

He stated this on Wednesday when he paid his maiden visit to the Defence Headquarters, where he met separately with the Nigerian Army, Nigerian Air Force and the Nigerian Navy. Adding that the right mix of civilians and military personnel working side-by-side at the Ministry of Defence will reduce the bottlenecks usually experienced in handling and treating official matters affecting the Services while also enhancing cooperation and collaboration.

Dr Kana further stated that under his watch, special attention will be given towards improving the standards of education and healthcare in schools and medical facilities run by the military, due to the critical roles these infrastructures play in enhancing

morale among troops.

He also emphasized the need for improved synergy especially now that the various Services continue to expand in sizes and roles as well as delve into each other's responsibilities and expertise.

"As the Services expand and delve into each other's expertise, the need for synergy and cooperation is expedient," he noted.

Dr Kana also averred that surmounting the security challenges confronting the country requires whole-of-society and multi-disciplinary approach. He enjoined all stakeholders to mobilise in support of the military and security agencies who are at the forefront of ensuring Nigeria's national security.

While assuring the military of the support of the Ministry of Defence in the fight against terrorism and other contemporary security challenges, he said the Armed Forces remain a vital arm of the ministry and also a leading institution in the national security architecture of the nation.

The seasoned technocrat pledged to sustain ongoing reforms in the military and foster seamless collaboration to fast track the restoration of peace and tranquillity in troubled areas of the country.

Dr Kana commended the effort and resilience of troops and pilots in the ongoing fight against terrorism and other security challenges in the country while disclosing the ministry's desire to ensure provision of quality education for children and wards of military personnel by repositioning Command Primary and Secondary Schools across formations and Units. This, he said, will further boost the morale and fighting will of the troops.

In his remarks, the Chief of Army Staff, Lieutenant General Faruk Yahaya congratulated Dr Kana on his appointment as the Perm Sec, Ministry of Defence. Noting that both the Army and the ministry enjoy a functional working relationship and sued for its sustenance. Gen Yahaya expressed appreciation for the Perm Sec's willingness to support the NA in the execution of its constitutional mandate.

On his part, the Chief of Air Staff (CAS), Air Marshal Oladayo Amao, while welcoming the new Perm Sec, congratulated him on his appointment and assured him of NAF's readiness to support him towards a successful tour of duty.

He noted that going by the impeccable milestone achieved by the Perm Sec as noted in his citation,

the needed synergy between the Services and the ministry would be much better.

The CAS further stated that the culture of jointness in all operations has come to stay amongst the Armed Forces. He, however, added that because the solution to the current security challenges requires a whole-of-society approach, the Armed Forces would require the support of the Perm Sec and the Ministry of Defence.

# **Troops nab ISWAP logistics suppliers, 119 terrorists**

- Neutralize 85 terrorists, rescue 798 civilians in Borno, Taraba, others
- 1,158 terrorists and their families surrendered
- Recover 7,732,000 litres of crude oil, 10,821,605 of AGO
- Gen Irabor engages stakeholders in Southern Kaduna

Troops of Operation Hadin Kai and Hadarin Daji of the Armed Forces have in the last three weeks recorded tremendous success in combating terrorists and criminal elements across the country as two logistics suppliers of the Islamic State West Africa Province (ISWAP) and 119 terrorists were arrested in Borno, Taraba, Katsina, Kaduna and Zamfara States.

It was also gathered about 85 terrorists were killed by the troops while a total of 798 civilians held captive by the terrorists were rescued.

This was disclosed on Thursday by the Director of Defence Media Operations, Major General Benard Onyeuko in a bi-weekly briefing on the operational activities of the Forces. Gen Onyeuko gave the names of the logistics suppliers/informants as Mallam Abba Sidi Lawan and Abdurrazaq Hudu while adding that a prominent ISWAP Commander, Abubakar Dan-Buduma and scores of the terrorists were killed.

According to him, the operation "led to the destruction of terrorist enclaves and their central workshop where vehicles are fabricated for vehicleborne Improvised Explosive Device (IED)."

He added that ISWAP "fighters on 5GTs

He added that ISWAP "fighters on 5GTs attempted to attack Nigerian Petroleum Product Company Depot in Diffa near Nigeria/Niger border

the attack was repelled and an unspecified number of terrorists were killed.

"Consequently, own troops recovered 49 AK 47 rifles, 728 rounds of 7.62mm, 4 MG's, 1 G3 rifle, 3 60mm mortar, 1 AA gun, 1 SMG, 6 Magazines, 1 hand grenade, 1 UXO anti-tank RPG bomb, 11 dane guns, 1 gun tripod, 1 binocular, 5 bandoliers, and 8 crowbars.

"Other items recovered include; 7 motorcycles, 31 bicycles, 4 heavy-duty generators, 3 Canoes, 3 tricycles, 4 motorcycles, 22 sewing machines, 1 video camera, 4 grinding machines, 8 mobile phones, 4 cars, 4 trucks, 1 Toyota buffalo vehicle, 8 drums of grains, medical syringes and 43,000:00 Naira cash."

Gen Onyeuko further disclosed that a total number of 1,158 terrorists and their families comprising 164 men, 367 women and 627 children surrendered to troops within the period under review.

He added that troops of the Operation Hadarin Daji recovered 592 rustled cattle, 45 different assorted weapons, 80 rounds of different caliber ammunition, and 50 motorcycles.

Meanwhile, troops of Operation Delta Safe operating in the creeks of Niger Delta were said to have recovered 7,732,000 litres of crude oil and 10,821,605 of AGO.

"Within the period under review, own troops discovered several illegal refining sites with 133 ovens, 194 metal tanks storages, 127 dugout pits, 5 wooden boats, 12 receivers, two ovens, two engines, two pumping machines, one oxygen cylinder, one motorcycle, one Jetta vehicle, 4,000 polythene bags of illegal refined black oil and five trucks. Cumulatively, Seven Million Seven Hundred and Thirty-Two Thousand (7,732,000) litres of crude oil and Ten Million and Eight Hundred and Twenty-One Thousand Six Hundred and five (10,821,605) litres of AGO was recovered." he said.

He further added that troops of Dakatar Da Barawo discovered and destroyed several illegal refinery sites, 145 ovens, 201 storage metal tanks, 9 pumping machines, one Yamaha 40HP outboard engine, 55 dugout pits, 58 drums of AGO, two wooden boats, 100 polythene bags illegally refined AGO and one tanker loaded with illegally refined AGO in Delta, Anambra, Cross River and Bayelsa

"Cumulatively, within the week under review a total of One Million Seven Hundred and Eighteen Thousand (1,718,000) litres of AGO, Three Million Eight Hundred (3,800,000) litres of crude oil, Three Hundred and Fifty Thousand (350,000) litres of sludge, Twenty Thousand (20,000) litres of PMS and One Hundred Thousand (100,000) litres of DPK," he stated.

In another development, the Chief of Defence Staff, General LEO Irabor, was said to have embarked on an operational visit to Kaduna State during which he met with critical stakeholders drawn from 5 local government areas of the troubled parts of Southern Kaduna.

"He also interacted with retired military senior officers of Southern Kaduna extraction to chart ways towards bringing an end to the incessant attacks in the area. The visit has impacted positively the peace efforts in the area," Gen Onyeuko said.

This is coming as troops of the Operation Safe Haven during patrol received a distress call on the activities of criminal elements in Heipang in Barkin Ladi Local Government Area of Plateau State.

"Troop quickly moved into swift action and on sighting own troops the criminal fled in disarray. The exploit led to the recovery of 178 rustled cows," he said.

He added, "In another development, on 21 April 2022, the Commander of OPERATION SAFE HAVEN at its Headquarters in Jos handed over a total of 517 small arms and light weapons recovered from bandits and other criminal elements to the Coordinator North Central Zone of the National Centre for the control of Small Arms and Light Weapons.

"The Commander commended troops for their resilience and successes recorded at stamping out criminal activities and the recovery of numerous illicit weapons. He also commended the spirited citizens who gave actionable information to the troops that led to the huge success recorded.

"The breakdown of the weapons are 26 AK 47 rifles, one FN, two Barreta rifles, 3G3 rifles, six Barreta pistols, one Harris Bing pistol and one SMG. Others include 183 locally fabricated rifles, 163 dane guns, 102 locally fabricated pistols, 19 locally fabricated SMGs, six single barrel guns and pumpaction guns."

#### Oyo NSCDC deploys 2,300 personnel ahead Eid-El-Fitri celebration

# 250 female aspirants obtain PDP forms

total of 250 women have obtained Expression of Interest forms to run for seats ranging from presidential to State Houses of Assembly on the platform of the People's Democratic Party (PDP). It is also reported that a high number of women have indicated interest in APC as well. If it is true, both political parties must be commended for giving women this kind of opportunity to participate in governance. It is a sign that more women are taking the struggle for elective office seriously and the parties have become more flexible in their attitude towards the women folk. We here at The Trumpet call on these female aspirants to serve as good ambassadors for women and prove to the nation that including more women in governance brings about positive change and development.

Since the nation's return to democracy, no State has elected a female Governor. There had been some tokenism in this direction as Lagos, Ekiti, Ogun, and Anambra States had produced Deputy Governors in the past. The nation has not produced a female Vice President. In terms of appointive positions, women have not fared as well as their male counterparts. There is something retrogressively cultural about excluding women from the political space. If therefore 250 women have picked up forms, it is a landmark. It deserves commendation.

Currently, Nigerians have genuine anxieties over the 2023 elections and the candidates running for various offices. Nigerians do not know whom to trust. This is therefore an opportunity for the women aspirants to show that they are the embodiment of the change Nigeria so desperately needs. Indeed, one good thing about bringing in more women is that we will escape the endless recycling of the same old faces

during every election. This is women's chance to prove that the 35% Affirmative Action agitated for will be a welcome development in Nigeria.

When elected, these women should do their utmost to serve the people conscientiously and avoid the pitfalls of some of their predecessors who became distracted by the pursuit of material wealth and ended up looting the nation and spoiling the name of women in the process. We call on these aspirants to be hardworking and thugs which destroys the lives and futures

upright, to shun dirty politics and avoid the unfortunate practice common among politicians of encouraging and employing

of many Nigerian youths. We call on these women to avoid the practice of buying votes or bribing voters with gifts. Nigerian voters are now wise to such tricks and any politician who engages in such acts only earns the outward and insincere praise of Nigerians but on the inside Nigerians do not respect such a person.

Let clean politics be the watchword of these women aspirants and let them be honest to the people during campaigns and avoid making grandiose promises that they know will be impossible to fulfill. Let them also remember that they got the nomination forms virtually free. This places a huge responsibility on their shoulders because whereas a woman professor, for example, could run for the office of president, a male professor would still have to find millions of naira to purchase the same nomination form. There is some concern that some of the aspirants do not actually intend to run for office but intend to strike a bargain with other more powerful aspirants for lucrative positions in government. # Christian shepherding, ideal leadership

Shepherd' and 'flock' are common Christian terms. Shepherding presupposes having a flock. Jesus Christ proclaimed, 'I am the Good Shepherd, The good shepherd gives his life for the sheep' (John 10:14). He is called the "Great Shepherd of the Sheep" (Hebrew 13:20). As imitators and followers of Christ, we are also called into the ministry of shepherding. Apostle Peter wrote this: "I who am a fellow elder and a witness of the sufferings of Christ, and also a partaker of the glory that will be revealed; 'Shepherd the flock, serving as overseers, not by compulsion but willingly" (I Peter 5:1-2). Shepherding the flock was dear to the heart of our Lord and Saviour, Jesus Christ.

"And Jesus, when He came out, saw a great multitude and was moved with compassion for them because they were like sheep not having a shepherd. So he began to teach them many things" (Mark 6:34). "And when they had eaten breakfast, Jesus said to Simon Peter, 'Simon, son of Jonah do you love Me more than these?" He said to Him, "Yes, Lord; You know that I love You." He said to him, "Feed My lambs! He said to him again a second time, "Simon, son of Jonah, do you love Me?" He said to Him, "Yes Lord; You know I love You. He said to him, "Tend my sheep." He said to him the third time, "Simon son of Jonah, do you love Me? "Peter was grieved because He said to him the third time, Do you love Me?" And he said to Him, "Lord, You know all things; You know that I love You." Jesus said to him, "Feed My sheep."
Feed My Lamb! Tend My Sheep!! Feed

Feed My Lamb! Tend My Sheep!! Feed My Sheep!!! This was what Jesus requested of Peter if he loves Him. Today, Jesus is asking us thrice if we really love Him? The canon with which He measures our love for Him is how we treat His lamb or sheep. Christ is the Great Shepherd of the Church, and He has ceded the task of shepherding to us. In Psalm 23 David proclaimed: "The Lord is my Shepherd! We must not love our desires and material things more than the flock of Christ.

What does it mean to shepherd the flock?

1 Peter 5:2-3 gives us the answers thus: (i) Feed, do not fleece the flock of God, (ii) Take oversight of the flock of God (iii) Serve God and His flock willingly (iv) Serve readily, not for personal gain (v) Do not be lords over God's heritage (vi) Be a good example to the flock. These are requisite conditions for good secular and ecclesiastical leadership. These conditions are mere epistemic and theoretical; they call for the praxis. Can or do we practice the act of good shepherding? Do we have good Christian shepherds in today's church and society?

Prophet Ezekiel outlines the traits of irresponsible shepherds. God, through Prophet Ezekiel, cursed irresponsible shepherds. "Son of man, prophesy against the shepherds of Israel, prophesy and say to them, "Thus says the Lord God to the shepherds: "Woe to the shepherds of Israel who feed themselves! Should not the shepherds feed the flocks?" (Ezekiel 34:2). The bad shepherd is selfish, heartless and wicked to the flock. He would use them as his food and skin them for his clothing. He is unconcerned when the flock is sick. He will not seek lost sheep. He does not protect and shield the endangered flock from predators. He allows the sheep to scatter and fend for themselves even in unpalatable terrains (Ezekiel 34:3-8). He offers no protection for the sheep. But God says, "Behold, I am against the shepherds, and I will require My flock at their hand; I will cause them to cease feeding the sheep, and the shepherds shall feed themselves no more; for I will deliver My flock from their mouths, that they may no longer be food for them" (Ezekiel 34:9-10).

On the other hand, we have the good shepherd. As John Maxwell footnoted on Ezekiel 34:11-24, "The Lord of ancient Israel was the Great Shepherd to His flock, Israel. He calls all spiritual leaders to view their role in the same way. The word picture of the shepherd enables us to see what kind of relational skills and attitudes we are to build into our leadership. Ezekiel 34 provides a 10-fold quality of how a shepherd ought to care for his flock. "The shepherd: (i) searches

out the lost sheep (vv. 11-16); (ii) delivers the captive sheep (v. 12); (iii) gathers the dispersed sheep; (iv) feeds the hungry sheep (v. 13); (vi) rests the weary sheep (v. 15); binds the hurt sheep (v.16); strengthens the weak sheep (v. 16); protects the vulnerable sheep (vv. 17-22); equips the needy sheep (v. 23); and directs all the sheep (v.24)." The foregoing qualities are established in Psalm 23!

As secular and ecclesiastical leaders, the security, health, education, feeding, the general well-being and happiness of the people we rule over should be prioritised. We should be responsibly carry out our leadership assignments; compassionately, altruistically without being corrupt. This is because our reward comes from Jesus Christ alone. "Most assurdedly, I say to you, I am the door of the sheep" (John 10:7); "The good shepherd gives his life for the sheep" (John 10:11); "I am the good shepherd; I know My sheep, and am known by My own (John 10:14). Christ is the Chief Shepherd, and Apostle Peter says, He will give us "the crown of glory that does not fade away" (I Peter 5:4). Consequently, the good shepherd looks up to Jesus Christ, not the sheep, for his reward.

Shepherding means more than the provision of food and grass for the flock. In Mark 6:34ff, Jesus was moved with compassion for them, because they were like sheep not having a shepherd, so He began to teach them many things." It is not recorded that He began to give them plenty food to eat. The Psalmist says: "My soul faints for Your salvation, but I hope in Your word." "My eyes fail from searching Your word, saying when will you comfort me?" (Psalm 119:81-82). The comfort of the flock flows from the word, statutes, commandments and ordinances of the living God. Without the word there is no world for the sheep. The Apostles fed the early church with the word. They resisted all distractions that were mitigating the word in the life of the Church. "It is not desirable that we should leave the word of God and serve tables" (Acts 6:2).

We must care for the sheep in humility, (Matthew 18:1ff); seek the lost sheep, even if it is one (Matthew 18:12); the good shepherd protects (Psalm 118:6); gives confidence and is trusted (Psalm 118:8); must put away evil and the enemy (Psalm 118:11); and must make the sheep fruitful. (Matthew 28:19) "Go therefore and make disciples of all the nations... baptising them ... and teaching them to observe all things that I have commanded you." He that shepherds must imitate the Great and the Good Shepherd, Christ Jesus, our Lord and Saviour

Are you a shepherd in your Church or community? Are your sheep lost or scattered? Are there no lost sheep in your neighbourhood? Are you not moved with compassion, seeing the lost, the hungry, the sick, the desolate, and the bereaved? Do you comfort and care for your sheep? Do you love Christ Jesus? Christ is today asking us: 'Do you love Me?' If we affirm as Peter did, Jesus is asking us to feed, tend and again feed His lamb and sheep!

# **Executive Order forestalls the release of Catholic Priest from Abakaliki Prisons**

Bonyi State Governor Dave Umahi Executive Order, which the state governor issued to forestall communal crisis, checkmate banditry and kidnapping in the state, has been alleged to prevent the release of a Catholic priest, Reverend Father Timothy Ngwuta, who has been in Abakaliki prison for over one month.


The Catholic Diocese of Abakaliki in a press statement issued on Sunday 24th April 2022, painted a graphic and pathetic picture of the incident that led to the Catholic priest's incarceration. The statement entitled "From

The statement entitled "From the Catholic Diocese of Abakaliki, regarding the arrest and arraignment of Reverend Father Timothy Ngwuta"-reads as follows: "On Saturday, 11th of December 2021, Reverend Father Timothy Ngwuta, was arrested by the Nigerian Police at Mbeke Ishieke in Ebonyi Local Government Area, where he went to help his friend, Jude Ariom, retrieved a vehicle (Toyota Sienna) that was parked there.

"Before Reverend Father Timothy Ngwuta arrived at Mbeke, he proceeded to the Police station to obtain clearance to move the vehicle whose tyres were deflated. The police at Mbeke permitted him to take the vehicle away after he had settled their bill for guarding the car for two weeks. In the course of inflating the tyres, the local vigilante swooped on him and his companions, demanding further settlements. Fr. Timothy informed them that he had already settled with the Nigerian Police. And that the Nigerian Police was meant to take care of the Local Vigilante as well. After a short while, a different set of local vigilante groups arrived on the scene again, this brought about some altercation between the two

"Fr. Timothy and those who came to assist him, to move the vehicle, were arrested by the local vigilante and handed over to the same police, who earlier had given him clearance to move the vehicle. Fr. Timothy and his companions were subsequently brought to the Nigerian Police Headquarters in Abakaliki the following day and was detained for 12 days. He was tortured. He was later released on bail when his health began to fail him on account of the torture he received while in the Nigerian Police detention. That was on 23rd December 2021. He was required to be reporting to the Police Station weekly. This he did religiously.

"Just when we thought the matter was over, he was re-arrested on Tuesday, March 8, 2022, and, on the 11th of March, 2022 arraigned in court for, kidnapping and murder of the five NELAN Engineers, attack and murder of Police officers, aiding escape, and arson, promoting inter-communal war etcetera. We are worried about how the issue of going to recover a car parked outside a war zone (a different Local Government Area) has metamorphosed into

such an accusation as contained in the charges against him. The identity of the owner of the car was disclosed to the police by Fr. Timothy together with the contact address and phone number. It is rather surprising to hear that Fr. Timothy is shielding him.

"Facts available to the Diocese are as follows: 1-Fr. Timothy Ngwuta comes from Ezaa Effium; whose home town has been decimated by the inter-communal war between the Effium/Ezza-Effium. 2-Fr. Timothy Ngwuta vehemently denies all these charges and sees himself as a victim of circumstances. 3-Fr. Timothy Ngwuta states unequivocally that he innocently went to help a friend retrieve his vehicle and was not aware that the vehicle was used in the commission of the crimes alleged.

"The Catholic Church condemns acts of violence, incitement of violence, wars, kidnapping, arson, or any crime and will not shield anyone involved in such dastardly acts. We urged the security forces to do a thorough investigation and ensure that the priest of God, who has, in conscience, stated before his Bishop, that the accusations are entirely FALSE. Is not to be punished for offences he knows nothing about. Efforts to secure his release on bail

have been hampered by the Executive Order preventing any court in the state from entertaining any matter relating to Effium crisis. Recently the motion for bail was refused on the 12th of April, 2022.

"The church in the name of God, appeals to all the people of Effium and Ezza-Effium involved in the inter-communal war, to lay down their arms and embrace the path of peace. Nothing justifies the senseless killings and maiming of innocent lives. Peace can never be achieved under the barrel of guns.

"Since the matter is before the courts, we will not be making any more statements on the case. We urged all to withhold judgment and let the case run its course.

"We implore all people of goodwill to join us, in praying to God to touch those responsible for the incarceration of Fr. Timothy to listen to the voice of the right conscience. We commend the whole process into the hands of the blessed virgin Mary, the mother of Priests and the star of evangelization. Pray for peace in the state and the country."

Trumpet Religious Desk immodestly sought the opinion of a Lagos based Legal Practitioner, Olu Oyatomi, on the proper meaning or status of Executive Order in law. The order was allegedly issued by the Ebonyi State Government under Dave Umahi. Mr Oyatomi said, "If indeed the Ebonyi State Government issued such an order, it cannot in any way prevent the court of competent jurisdiction from running its course in any matter. He stressed that if it was the Executive Order they cited to prevent the court from looking into the matter as it concerns Fr. Timothy Ngwuta in Ebonyi state, then the act must be reckless and unconstitutional. And as such, it needs not to be obeyed. Mr Oyatomi added, "the court is the final arbiter in matters like this."

The Ebonyi State Attorney General and Commissioner for Justice, Chief Cletus Ofoke in his reaction, dismissed the Catholic Church claim, saying "the Ebonyi State Executive Order never prevented the court in Ebonyi state from entertaining the case involving Fr. Timothy Ngwuta.

Trumpet Religious Desk immediately reached out to Most Reverend Peter Chukwu, the Catholic Bishop of Abakaliki for his comments. We asked him whether the priests under his supervision had no jobs to do, for one of them to be involved in helping his friend to retrieve his car abandoned in a war-ravaged area of Ebonyi State.

The Bishop said, "It is not true, to insinuate that the priests under my supervision have no jobs doing, that is the reason(s) one of them had the chance to be involved in the matter at hand. I have spoken with the priest involved in this matter, and I believed what he told me, that he innocently went to help a friend to retrieve his vehicle and he was unfortunately caught up in the present web of intrigues surrounding this whole unfortunate incident.

"We as a church do not tolerate violence of any form, and we will never condone the involvement of our priest in such un-Godly acts. That is why we are following this matter carefully. Much as we are eager to get our priest out from the Abakaliki prison where he is presently incarcerated, we will allow the law to take its course. All we are urging is for the Nigerian Police to do a proper and thorough investigation so that the truth be made known to the public.

When Trumpet Religion enquired if the priest will be de disciplined when granted bail? The Bishop said," The church business, for now, is first to make sure the priest in question is granted bail and his health properly taken care of. At least he needs to be alive, to be able to face any disciplinary action if the need ever arises. And if the church is even to discipline him, as you are suggesting, it will never be done in the way and manner you think. We will seat him down as members of the same family, tell him where and where he went wrong and try to correct him. So that he does not make similar mistakes now or in the future.

"Our main concern now is to strive to clear the name of the priest and church in this whole mess. This is what is important to the church now, as we speak." The Bishop concluded.





# AfDB cautions African countries against looming food crisis

President of the Africa Development Bank (AfDB), Dr Akinwunmi Adesina, has warned African countries to prepare for an inevitable global food crisis in the next few years.

Adesina was speaking on Africa's priorities, as a guest at the Atlantic Council's Africa Centre recently in the United States of America (USA).

Fielding questions from the council's Africa Centre Chair, Ambassador Rama Yade, Senior Fellow, Aubrey Hruby and Jeune Afrique, he advocated an increased sense of urgency amid what he described as a "once in a century convergence of global challenges for Africa."

He maintained that the continent's most vulnerable countries had been hit hardest by conflicts, climate change challenges and the COVID-19 pandemic, which had disrupted economic and

development progress in Africa. He said Africa with the

lowest Gross Domestic Product (GDP) growth rates had lost as much as 30 million jobs on account of the COVID-19

On the impact of the Russia and Ukraine war on Africa, Adesina lamented the killing and displacement of Ukrainians, describing their suffering as 'unimaginable,' adding that the war's ramifications would spread far beyond Ukraine to other parts

of the world, including Africa.
The AfDB boss explained that Russia and Ukraine supply 30 percent of global wheat exports, the price of which has surged by almost 50 percent globally and reached identical levels as during the 2008 global food crisis, adding that fertiliser prices and energy prices had tripled fuelling inflation.

Adesina warned that the tripling costs of fertilizer, rising energy prices and rising costs of food baskets could worsen in Africa in the coming months. He noted that 90 percent of Russia's

\$4 billion exports to Africa in 2020 comprised wheat and 48 percent of Ukraine'S near \$3 billion exports to the continent were made of wheat and 31 percent of maize.

Adesina cautioned that to fend off a good crisis, Africa must rapidly expand its food production, saying: "The AfDB is already active in mitigating the effects of a food crisis through the African Food Crisis Response and Emergency facility, being considered by the bank to provide African countries with the resources needed to raise local food production and procure

'My basic principle is that Africa should not be begging. We must solve our own challenges ourselves without depending on

He highlighted the importance of the technology sector as a driver for growth in Africa, and prospects for young people on the continent.

He described African youth as one of its greatest assets and commended the contributions of young entrepreneurs in the Fintech, digital, creative arts and entertainment industries.

Adesina added that the need for young entrepreneurs for innovative financing was responsible for the bank's decision to engage with stakeholders and established specialised youth entrepreneurship investment banks to unlock potential and engender economic growth.

## SEC urges NESG to support capital market economic development roles

The Securities and Exchange Commission (SEC) has restated the vital role the capital market plays in the development of any country through the provision of long term funds for infrastructure

development among others.
Director-General of SEC, Lamido Yuguda, stated this when a team from the Nigerian Economic Summit Group (NESG) visited the commission in Abuja recently, to collaborate with the SEC on the development of the economy.

The SEC boss said that the capital market can actually do more in the areas of provision of necessary infrastructure for the country in a bid to support the government in its developmental

"Our collective economic power is bigger than the government and in many countries, the capital market actually funds the government. When you save, the finance is used to create economic value that actually enhances living and this translates to a win-win. While stressing the need for collaboration with the NESG, he said both organisations could do more for the economic development of the country, he said: "You get financial returns and also utility from the investment and this is actually achievable.

"On the capital market, it is a welcome development that we are talking with the NESG for there is something that really needs to happen in this country. When you look at our policy environment, in many areas it is not conducive for the return of capital to investors and we are working hard to

tackle this." He noted that the telecommunications companies are successful because no one is getting the service for free as everyone pays to add: "We all pay for the services, no one gets the services for free, but when we move on our roads, we say we don't want to pay for it. In other countries, people pay for their roads and they are happy doing so because the roads are good.

"We need to collaborate with a group like NESG. Once we are able to put things right, investors will be willing to put in money and there will be returns."

Speaking, Chief Executive Officer of NESG, Laoye Jaiyeola, who expressed concern that the banking sector was being overstressed, urged the Federal Government and corporate organisations to look towards the capital market for their funding needs.

Jaiyeola stated that transactions could be restructured to raise bonds, bills and all the things that would fund whatever is needed to be funded without

going through the banks. He said: "The securities market needs to take the bull by the horn otherwise, we are going to be in perpetual debts as a nation and that will not help us. That is one of the reasons we are advocating an Investments and Securities Act that will ensure that the needed funding for development in Nigeria is given priority and then we can fund Nigeria for a

The short term funding cannot help us and so, we need to begin to move to the long-term. We are passionate about it and we need to raise funds for the needed development funding in

The United Nations Children Fund (UNICEF) says good nutrition is beneficial to and achievable for all Nigerians.

Nutrition Officer of (UNICEF), Nkeriuka Enwelum, made the assertion, yesterday, in Enugu at a two-day dialogue on Sustainable Development Goals (SDGs) as Child Rights, while presenting a paper on child malnutrition situation in Nigeria: An overview.

Enwelum said some benefits of good nutrition include an increase in school participation by one year and adult wages by between five to 50 percent,

among others.

She said that the consequences of malnutrition include impaired brain development and lower Intelligence Quotient (IQ), low birth weight, weakened immune system leading to an increase in infectious diseases and premature

She added that about 45 percent of child deaths were linked to poor nutrition which mostly occurs in low and middleincome countries adding that malnutrition in children leads to wasting, stunting, underweight, while overweight was visible among adults.

Enwelum stressed that malnutrition should be avoided at all costs through provision and eating of all classes of foods, maintaining that failure to prevent and treat malnutrition could result in long-term cognitive and growth impacts and loss of income for households and up to 15 per cent loss in Gross Domestic Product (GDP) for Nigeria.

Dr Chidi Ezinwa of the Department of Mass Communication, Enugu State University of Science and Technology (ESUT), said Nigeria ranked 160th on the 2020 world SDGs index from 159th in 2019.

He said SDGs could not be realised without fulfilling the rights of children in SDG index from 159th in 2019 to 160th in 2020 adding: "The SDGs index above shows that many rights of children are yet to be fulfilled in Nigeria, hence Nigeria is far from realising the SDGs."

He stressed that the SDGs included several rights of children to be fulfilled without which progress would not be made in achieving them.

CAPPA cautions FG against accepting Philip Morris' COVID-19

The Corporate Accountability and Public Participation Africa (CAPPA) has alerted the Federal Government to the possibility of the Canadian government approaching it to accept the Medicgo COVID-19 vaccine (Covifenz), which has not been approved by the World Health Organisation (WHO).

The WHO refused to approve the Medicago vaccine because Philip Morris is a major shareholder in the pharmaceutical company. Public health groups across the globe including in Canada support the WHO decision and have called on the Canadian government to find a suitable investor to replace Philip Morris in the company's shareholding.

Medicago has also signalled that it is seeking alternative investors and wants the Canadian and Quebec governments to help facilitate such a transition. Unfortunately, the transition has not happened.

In a statement issued in Lagos, CAPPA said that as a signatory to the WHO's first public health treaty - the Framework Convention on Tobacco Control (WHO-FCTC) Nigeria should remain committed to its obligations including Article 5.3 which advised Parties to insulate their public health policy from the vested and commercial interests of the tobacco industry.

Guidelines for implementing this obligation make clear that "the tobacco industry should not be a partner in any initiative linked to setting or implementing public health policies, given that its interests are in direct conflict with the goals of public health.

Parties are directed that they "should not endorse, support, form partnerships with or participate in activities of the tobacco industry described as socially responsible."

Executive Director of CAPPA, Akinbode Oluwafemi said: "In as much as we appreciate the Canadian government for supplying COVID-19 Vaccines to Nigeria, we urge our government to be circumspect and ensure the product is not the Philip Morris funded Covifenz. An industry that kills its customers and the rest of us who are exposed to tobacco via second-hand smoke cannot lead the way in solving either the tobacco menace or the coronavirus pandemic."

Oluwafemi explained that Philip Morris is primarily a manufacturer of lethal products

and continues to actively oppose smoking reduction measures across the globe including in Nigeria where its executives through well-publicized articles promote heated tobacco products as a less harmful alternative to cigarettes despite overwhelming evidence to the contrary.

Through an initiative called the Conrad Nigeria Challenge, Philip Morris-funded Foundation for Smoke-Free World (FSFW) supports young people in the education sector, who are subtly brainwashed into believing that the tobacco company is socially responsible and a stakeholder in public good.

"With at least nine other WHOapproved vaccines that are not tainted by tobacco companies' funding in COVAX kitty, Nigeria is not obliged to accept vaccines tainted with industry funding. In fact, Nigeria can contact COVAX directly to obtain the approved products"

Echoing the position of public health groups in Canada, Oluwafemi said rather than pose as a front for Philip Morris that the Canadian government should stand for public health by replacing Philip Morris's shareholding in Medicago and stop partnerships that violate its FCTC obligations.

"The control of one pandemic should not compromise another. COVID-19 vaccines or any other health product from companies with ties to the tobacco industry are not welcome in Nigeria. The acceptance of the Philip Morris vaccine and its use violates the FCTC Article 5.3," he insisted. second page of Business

# Now that Tobacco Control Fund has been operationalised

Sustainable funding is crucial to winning the tobacco control war and no one understands this better than the tobacco industry. Realising that low-and middle-income countries like Nigeria devote meagre or zero allocation to implementing tobacco control policies, the tobacco industry has cleverly etched its footprint in sectors where government agencies are financially crippled.

The industry is particularly active in the agricultural sector and so-called youth empowerment and skills acquisition training that are well choreographed to garner endorsements from public officials who see them as openings for partnerships with a supposed "stakeholder" to achieve "societal good".

But such endorsements and the partnerships that follow are exactly what the World Health Organisation (WHO) discourages and cautions Parties to the Framework Convention on Tobacco Control (FCTC) to be wary about. Article 5.3 of the FCTC specifically urges parties to protect their public health policies from the commercial and other vested interests of the tobacco industry.

The WHO also encourages governments to ban all tobacco industry Corporate Social Responsibility (CSR) activities, establish and/or enforce a

code of conduct to limit interactions between government officials and the tobacco industry, and when such interactions are strictly necessary, they must be transparent. It also suggests that where a code of conduct exists, regular training and awareness on tobacco industry inferences in line with Article 5.3 must be conducted for public officials, among others.

But the tobacco industry is also smart albeit in the negative. To circumvent the recommendations of the Convention, tobacco corporations yearly deploy huge financial war chests into compromising and creating conflicts of interest with public officials, especially in sectors where government intervention is non-existent or inadequate. In this way, the tobacco industry effectively clips the nands of governments in regulating the tobacco business. They also pump huge resources into tobacco advertising, promotion and sponsorships that seem harmless on the surface but are in fact, subtle ways of recruiting the next generation of smokers.

The Centre for Disease Control and Prevention (CDC) reports that in 2019, the largest cigarette and smokeless tobacco companies spent \$8.2 billion on advertising and promotional expenses in the United States alone.

For a country like Nigeria which

is by far the most populous nation in Africa, its huge population which is made up of predominantly youth, is a market opportunity for the tobacco industry. British American Tobacco Nigeria (BATN) which controls over 80% of the Nigerian market continues to break new grounds through its BATN Foundation (BATNF). The Foundation is currently in partnership with virtually all the states of the federation in agricultural production. It has signed MOUs with virtually all of them in implementing their FADAMA projects.

Such projects literally litter Abia, Benue, Kwara, Kogi, Lagos, Niger, Ogun and Osun states, among others. In Lagos, it partners with the state government in organising the yearly Lagos Farm Fair and has been raining fish farmers and various cooperatives on so-called capacity building engagements.

The Conrad Foundation funded by the Foundation for Smoke-Free World (FSFW) allied to Philip Morris International is equally active in the education space, exploiting scholarships for pupils in prestigious secondary schools in Nigeria as an entry point to forge partnerships. Through the Conrad Challenge eligible Nigerian pupils have been funded to travel to the United States and other countries to pursue projects that they came up with. Most of

such kids are blindsided and not made to hear about tobacco harm in the public communication of the promoters of these initiatives.

The dangers of the industry partnerships and the endorsements they get from such entanglements are the motivation behind the recent operationalisation of the National Tobacco Control Fund by the Nigerian government. Section 8 (2) of the National Tobacco Control (NTC) Act 2015 and Sections 23 and 26 of the National Tobacco Control Regulations 2019 provide for annual budgetary allocations, gifts, donations, testamentary dispositions, subventions, license fees, and proceeds of the sale of forfeited items shall go into the Fund. Though Nigerians are yet to see the relevant government agencies charged with enforcing the Act adequately funded to get on with their work, it is reassuring that Nigeria has taken this bold step.

Most developed nations understand this fact and continually explore available options to keep the funding tap open. Such funding options by developed countries implementing tobacco control policies include Taxes on tobacco or health-damaging goods such as alcohol; Treasury appropriation; Value added tax (VAT); Health/sickness or universal health cover insurance levy; Philanthropic donations; and Funds collected through penalties for violations of legislation, among

Unfortunately, these options remain largely unnoticed and untapped by the Nigerian government and create loopholes that the tobacco industry explores to continue business

To wean government agencies off the allure of tobacco industry funds, the agencies must independently have access to the needed resources to be able to carry out timely and proactive interventions required for the successful implementation of tobacco control policies in the

No doubt, a Tobacco Control Fund regime will make funds readily available for them to carry out all public health sensitization activities cessation programs, alternative cropping, and other critical activities. It will also eliminate the reliance of the government on donor and foreign funding and aid the setting up of structures across the country to help people who want to quit and monitor compliance.

Nigerians expect that the operationalisation of the fund will not just be a mere formality. The more delays there are, the more the tobacco industry will addict our youth and unleash a cycle of death already before us.

# Lagos alleges misrepresentation of legal status on collection of tolls

# Says appeal still pending

agos State Government has described as misrepresentation of fact in the statements circulating in the media that it does not have the legal right to collect tolls on the controversial Lekki-Ikoyi Link Bridge and that tolling on the Link Bridge is unlawful.

The state Attorney-General and Commissioner for Justice, Moyosore Onigbanjo, in a statementnoted that the misleading statements were based on the false premise that the Lagos State Government has no pending appeal against the judgment of the Federal High Court in Suit No FHC/L/CS/1405/02 between Ebun-Olu Adegboruwa Esq. Vs. Attorney General of the Federation & Ors.

According to him, in the light of this misrepresentation, it has become necessary to state as follows; "On the 27th day of March 2014, the Federal High Court delivered judgment in Suit No FHC/L/CS/1405/02.

"Thereafter on 28th of March, 2014 the Lagos State Government (sued as 3rd and 4th Respondents) filed a Notice of Appeal against the judgment of the Federal High Court and an application for stay of execution and injunction pending appeal.

"That on 11th of No-

vember, 2014 the Lagos State Government applied for an extension of time within which to compile and transmit the Records of Appeal, at the Court of

Appeal
"However, on the 9th of October, 2017 owing to lack of representation on the part of Lagos State Government, the application for extension of time to transmit the Records of Appeal, filed on the 11th of November, 2014 was struck out and the Court stated: "Since Applicant is aware of today's date and is not in court, we take it that applicant is not diligent in prosecuting its application. It is hereby struck out. Number Deleted.

"From the foregoing quote what was struck out was the application (that came up before the Court of Appeal on 09/10/17) and not the appeal. There is a distinction between striking out an application and striking out an application and striking out an appeal.

an application and striking out an appeal.

"As at date, there is no order striking out Lagos State Government's appeal against the judgment of the Federal High Court delivered on 27th of March, 2014 in Suit No FHC/L/CS/1405/02.

"It is also notable that be-

"It is also notable that before the Federal High Court, the claimant sought ten (10) Declaratory reliefs and one (1) order of injunction [1], to restrain the Lagos State Government from collecting tolls on the Lekki-Ikoyi Link Bridge "However, in its judgment dated March 17, 2014, the Federal High Court did not specifically or expressly grant either the Declarations or the injunction sought. It rather only held that:

"I agree and uphold that the construction of this bridge was authorized and the 3rd Respondent has the power to generate revenue thereon from the subject matter but the existing law did not cover this bridge and the 3rd Respondent can only make the law to that effect before it can collect toll on the bridge.

"Dissatisfied with the lack of clarity and precision in the judgment amongst other grievances the Lagos State Government filed a Notice of Appeal against the judgment on 28th March 2014.

"The position of the law is that once a Notice of Appeal is filed along with an application for stay of execution/injunction pending appeal, the judgment being appealed against cannot be enforced until the application for stay of execution/injunction pending appeal has been determined. This position was upheld in VASWANI TRADING COMPANY V. SAVALAKI & CO (1972) N.S.C.C @ 697 – 698, where the Supreme Court of Nigeria held that: "...whilst by virtue of the provision of the section, an appeal or the filing thereof

could not eo ipso operate as a stay of execution, clearly, in practice, the position should be different where apart from filing an appeal, the prospective appellant also files an application in this Court, by which a stay of execution of the same judgment is sought. In such circumstances, a general appraisal of the whole situation is absolutely necessary and it is most desirable that the court should ensure that, at that stage of the proceedings, it is not possible for any party to present it with a fait accompli..

"Notwithstanding the above position of the law. The Lagos State Government affirms that it will continue to engage with all stakeholders and concerned members of the public in the Lekki axis and will abide by commitments and concessions made at the various stakeholders' meetings."

Onigbanjo stressed that based on the foregoing, the statements that the collection of tolls on the Lekki-Ikoyi Link Bridge is unlawful and without legal basis or right are clearly incorrect, saying that "the Lagos State Government's appeal against the judgment of the Federal High Court subsists and the judgment of the Federal High Court cannot be enforced at this stage."

"Mother Earth is clearly urging a call to action. Nature is suffering. Oceans filling with plastic and turning more acidic, extreme heat, wildfires and floods, have affected millions of people.

"Even these days, we are still facing COVID-19, a worldwide health pandemic linked to the health of our ecosystem.

"Climate change, manmade changes to nature as well as crimes that disrupt biodiversities, such as deforestation, land-use change, intensified agriculture and livestock production or the growing illegal wildlife trade, can accelerate the speed of destruction of the planet," the UN stated.

# Islam forbids corruption, ICPC charges Muslims in Osun

■ Takes anti-corruption campaign to Kogi State Central Mosque

s part of efforts geared towards engaging religious leaders and their adherents in the fight against corruption in the country, the Independent Corrupt Practices and Other Related Offences Commission (ICPC) has taken its sensitisation lecture to some of the mosques across Osogbo, the Osun State capital, reminding Muslims that Islam forbids corruption.

He further sensitised Imams and their congregations on the types and effects of corruption, the core values of the National Ethics and Integrity Policy (NEIP) as well as the role of Muslims in the fight against corruption as contained in the booklet produced by the Ummah Support Initiative (USI), the National Mosque Abuja, with support from ICPC.

Shuaib equally used the occasion to educate

them about ICPC initiatives and its youth programmes.

Leaders of both mosques, Imams Alhaji Abdulhakeem and Yunus Raji commended the Commission for the sensitisation and promised to intensify efforts on anti-corruption sermons as contained in the Holy Quran.

In a similar development, ICPC recently took its anti-corruption campaign to Muslims at the Kogi State Central Mosque, Lokoja.

The sensitization exercise, which is in line with Section 6 (e & f) of the Corrupt Practices and Other Related Offences Act 2000, was aimed at getting participants to join the anti-corruption fight.

Speaking at the event, the Resident Anti-Corruption Commissioner (RACC) in Kogi State, Okoro Ulu James, informed the Islamic scholars and members of the mosque that there was an urgent need for them to collaborate with anti-corruption agencies through their sermons and lifestyles.

He gave them a run-down of the duties of the Commission and some of the offences

contained in the Corrupt Practices and Other Related Offences Act 2000.

The Commissioner advised the participants to report any corrupt practices they witness to ICPC either at the office or through ICPC's reporting channels such as toll-free numbers, Facebook, Twitter, Instagram and other social media handles.

In his remarks, the Chief Imam of the mosque, Alhaji Aminu Sha'aban urged the people to pray fervently, and also put more effort towards eradicating corruption.

While speaking, Garba said that ICPC recognizes sexual harassment as a corrupt practice, noting that contrary to the report that Ministries, Departments and Agencies (MDAs) in the Federal Capital Territory (FCT) do not have Sexual Harassment Policies, ICPC under the chairmanship of Professor Bolaji Owasanoye (SAN), has a Sexual Harassment Policy in place, to guide staff of the Commission in their interaction with different stakeholders and the opposite sex in the workplace.

He further commended HEIR Women

Development for having the workshop at the right time, and the Ford Foundation for supporting the NGO.

Garba called on the victims of sexual harassment at workplaces to have the courage of reporting the matter to the appropriate authority to put a stop to the menace.

Earlier in her speech, founder and Executive Director, HEIR Women Development, Anuli Ola-Olaniyi, decried the prevalence of sexual harassment of girls and young women at work, saying that it makes them unproductive and unable to contribute their quota to national development.

#### Court jails two bankers for stealing dead customer's N2.9m

• As court jails man for misappropriating N1.9m in Makurdi

Justice Elias Abua of the Cross River State High Court sitting in Calabar, Cross River State, has convicted and sentenced two former bankers, Titus Chima Nwankwo and Utibe-Abasi Ifiok George for stealing N2.9m from the account of a deceased customer of a commercial bank.

A statement by the Economic and Financial Crimes Commission (EFCC) said the convicts were jailed on Tuesday after pleading guilty to one-count separate charges bordering on forgery, conspiracy, breach of trust and stealing.

The statement said, "Nwankwo and George were jailed on Tuesday, April 26, 2022, after pleading guilty to one-count separate charges bordering on forgery, conspiracy, breach of trust and stealing, upon their arraignment by the Uyo Zonal Command of the Economic and Financial Crimes Commission, EFCC.

"In view of their pleas, prosecution counsel, Joshua Abolarin prayed the court to convict and sentence the defendants accordingly.

"Justice Abua convicted and sentenced George to three months imprisonment with an option of fine of N100,000.00 (One Hundred Thousand Naira only) while Nwankwo bagged three months imprisonment with an option of fine of N50,000.00 (Fifty Thousand Naira

"The convicts' journey to the Correctional Centre started on June 16, 2021 when a petitioner alleged that they conspired and forged the signature of one Godfried Francis Osso, a deceased customer of a bank and fraudulently diverted the said sum for their personal uses. They were investigated, arrested, prosecuted and convicted."

Meanwhile, the Makurdi Command of the EFCC, on Friday April 29, 2022, secured the conviction of one Damian Oragbai Terhemba before Justice M. A. Ikpambese of the Benue State High Court sitting in Makurdi, on one count charge of misappropriation to the tune of N1,906,000

The charge against reads, "That you, Damian Oragbai Terhemba between 2017 and 2018 in Makurdi within the jurisdiction of this Honourable Court, being entrusted with the sum of N1,906,000 (One Million, Nine Hundred and Six Thousand Naira only) by one Iortule Aondowase for the purchase of a Toyota Corolla Car 2005 Model, dishonestly misappropriate the said sum and thereby committed an offence, contrary to Section 312 of the Penal Code (CAP) 124 Law of Benue State, and punishable under Section 313 of the same Law".

He, however, pleaded not guilty to the charge setting the stage for trial to commence.

In the course of the trial, the prosecuting counsel, George Chai-Yakua, called two witnesses and tendered several documents. Upon closing his case, the convict filed a no case submission but the same was dismissed.

#### EFCC freezes N365m, N30m from ASCSN scribe, accountant's accounts over alleged fraud

The Economic and Financial Crimes Commission (EFCC) has allegedly frozen about three hundred and sixty-five million naira (N365m) personal investment of Association of Senior Civil Servants of Nigeria (ASCSN) Secretary, Alade Bashir Lawal in Meristem securities limited.

It was gathered that the EFCC has also frozen about thirty million naira (N30m) investment of the Chief Accountant of ASCSN, Akorede Fatai, in the same company.

Sources within the union disclosed that the anti-graft agency has also gone after Lawal's property agent.

It was gathered that the property agent has been given a marching order to appear before EFCC, to explain Lawal's local and international property scattered all over Lagos, Abuja and the United Arab Emirates, worth billions of naira, which the agent helped to acquire for Lawal.

It was learnt that ASCSN, which is an affiliate of the Trade Union Congress of Nigeria (TUC), is a senior staff union of senior civil servants from grades levels seven to levels seventeen in both the federal and state civil service of Nigeria.

It could be recalled that the union has in the last few months been enmeshed in a series of crises

The EFCC and Independent Corrupt Practices and other Related Offences Commission (ICPC) had commenced a probe of some officials



The anti-graft agency has now frozen about three hundred and sixty-five million naira (N365m) personal investment of Lawal in the said company due to the ongoing investigations over alleged financial fraud.

The sources within the union said Lawal is also being investigated over money laundering through the ASCSN cooperative account which he has used to divert union funds to his personal account.

There are speculations that the cooperative is unregistered and Lawal has been the only Secretary for over twenty years.

Former member of ASCSN National Executive Council, Andrew Emelieze, confirmed the development to newsmen on Thursday.

Emelieze called on the Head of Service and the ministry of labour to investigate the allegations levelled against the officials.

"We as members of the union are disturbed over the ugly corruption crisis rocking our Union. We are worried that a workers' Union that is supposed to protect workers' interests has become the house of corruption and so we are calling for a forensic audit of the Association of Senior Civil Servants of Nigeria (ASCSN).

"We, therefore, call on the Head of Service of the Federation, Dr Folashade Esan, the Ministers of Labour, Dr Chris Ngige and Mr Festus Keyamo (SAN) and the International Labour Organization (ILO) to seek to investigate the corruption crisis rocking the union".

## N450m Diezani Cash: Court reserves ruling on trial within trial in Bulama's case

Justice Fadima Murtala Aminu of the Federal High Court sitting in Damaturu, on Thursday, April 28, 2022 adjourned till May 30, 2022 for ruling on the admissibility or otherwise of the trial within trial, in a case involving Dr. Abdu Bulama, former Minister of Science and Technology, standing trial for allegedly receiving the sum of N450m from Diezani Alison- Madueke, former Minister of Petroleum Resources, to influence the outcome of the 2015 Presidential Election.

Bulama was the coordinator of former President Goodluck Jonathan's 2015 Re-election

Campaign Committee in Yobe State.

He was re-arraigned on November 8, 2021 alongside a former Commissioner for Integrated Rural Development in Yobe State, Mohammed Kadai, Abba Gana Tata, Muhammad Mamu and Hassan Ibn Jaks on seven-count charges of criminal conspiracy and money laundering following the judgment of an Appeal Court in Gombe State, which upheld the argument of the EFCC, that the lower court erred by discharging and acquitting the defendants following their 'no case submission' upon the closure of the prosecution's case.

Esther Ijewere is an enterprising social activist, women's advocate, Columnist, Author and the founder of Rubies *Ink Initiative for Women and Children - A Non-profit outfit devoted to advocacy, development and social enterprise* solutions amongst others. An Olabisi Onabanjo University-trained Sociologist; Esther is the youngest recipient of The Idea Builders Women Mentoring Women Award, winning Mentee of the year 2010 and "Women Enterprise Award" from Vital Voices International & Exxon Mobil. In this chat with OMONIYI ALLI, Esther spoke about her passion for women, and single motherhood amongst others.

Kindly tell us the story of Women of Rubies, your career path and how it all started?

Women of Rubies were born out of my passion for humanity. I started as a social activist, lending my voice to victims of rape, and other forms of gender-based violence. This evolved into the media, which is the Women of Rubies platform where I use my column and blog as a vehicle of social change to put the spotlight on other women in different sectors who are contributing their quota to nation-building and adding value to the society through their work. I believe Women of Rubies was divinely orchestrated by God to give me a life path, touch lives and show young women that their dreams are

Blogging, through the Women of Rubies platform, has been very interesting. It avails me the opportunity to be more inspired and challenges me to even do more.

Looking back, would you say Women of Rubies and your other initiatives have achieved what they set out to accomplish?

Absolutely! We have accomplished even more than we envisaged ten years ago. Despite the losses we suffered, we have stayed solid and consistent through the years.

Évery project we have embarked on has impacted lives and added value. We have served those at the grassroots and the high earned professionals. 

# Austrian FA name Rangnick as Franco Foda's successor

fter the resignation of Franco Foda as the manager of Austria's senior men's football team, Ralf Rangnick has been appointed to replace him.

Foda has tendered his resignation following his inability to qualify Austria for the Qatar 2022 World Cup having suffered a 2-0 defeat from Wales.

His successor, Rangnick, took over Manchester United in November 2021 in the interim after United sacked Ole Gunnar Solskjaer after a poor run of results.

Despite the German not meeting up to the expectation, having produced inconsistent results this season, with Ajax's manager already announced to replace him by the end of the season, Rangnick has been offered a consultancy role until 2024.

According to the terms discussed with United, the consultancy role will see Rangnick undertake advisory tasks at the club for six days a month.

With this leverage in time, the interim manager of Manchester United will combine the Austria national team's job with his consultancy role at Old Trafford.

Earlier, the Austrian daily Kurier broke the news of a meeting between Austria sporting director Peter Schottel and Ralf Rangnick in Manchester United; a report that was denied by the Austrian Football Association (OFA).

However, with the recent development and the imminent announcement of the Rangnick underway, after the OFA would have finalised the terms, it corroborated the earlier report by Austrian daily Kurier.

Rangnick, after the 1-1 draw against Chelsea at Stamford Bridge, told Sky Sports that "What I can tell you and confirm is I will definitely continue with my consultancy role at the end of the season and for the next two years.

"I'm very much looking forward to it. We haven't spoken, Erik and myself, we've spoken with the board about the contract and the profile of the job, the content of the consultancy role.

"That's why I can confirm I will continue at the end of the season," he added

Reacting to the development, soccer pundit and former Manchester United defender Gary Neville disapproved of Ralf Rangnick's duality of tasks as a sporting director in Old Trafford and Austria national team manager.

He conveyed that the Austrian national team need a lot of commitment from Rangnick who will have to keep tabs on the Austrian players consistently.

Neville wondered how the German coach would be able to pilot the



consultancy role effectively without giving priority to the other.

According to Sky Sports, Neville said, "As Manchester United's sporting director, or consultant, can he really be going to look at Austrian players week in, week out and then selecting them for a national team?

"The Austrian national team have got pride, it's a great country

with great players, so he'll have to watch them play every week. Then he's going to go and coach them for two weeks in September, October, November, and March.

"So then you're thinking 'what's happening to the Man United consultancy and advice? Where's the priority?' because there's a conflict there.

"I don't see how that can work

because if you're a national team manager - and I've worked under a national team manager - I know that they have got to be present watching their players play week in, week out. And he can't be at Old Trafford every single week - not watching an Austrian player play.

"I don't know how that's going to work if it is something that's true.

"It's messy. Man United can't afford to have distractions at this moment in time, they can't afford to have a poor communications plan around the idea that Rangnick's the football consultant, but he's seen watching German football three times a month and then going off to coach the Austrian team.

"There needs to be laser focus, clean lines, people staying in their lanes, understanding what their jobs are, and communicating to the fan base that this is a real change and different than it has been for the last 10 years," he added.

The Austrian FA (OFB) will hold an executive committee meeting on Friday morning when Rangnick's potential appointment is expected to be given formal approval by board members, and an announcement could follow shortly after that, Sky Sports revealed.
