that the equipment worth \$1.5 million was imported from Germany. But the state government led by Governor Udom Emmanuel has abandoned the printing press seven years since his administration came to power.

The printing press consists of a Supra Setter A105 otherwise known as Computer To Plate (CTP) machine and a Goss Community Press with a CONTINUED ON PAGE 2

Uncertainty over presidential primaries as APC, PDP play cat, mouse game

arely 20 days to the primaries of political parties, the two major ones, the ruling All Progressives Congress (APC) and main opposition Peoples Democratic Party (PDP) are still undecided of where their presidential candidates will come from.

The two parties are no doubt caught in the web of zoning and are making frantic efforts to wriggle out without causing for themselves more mistrust by the electorate across regions, tribes and zones.

While the PDP has not made a formal commitment, APC owing to its the political arrangement is more entangled as there is much expectation that the party will produce a southern candidate.

But the APC dashed the hopes of many Nigerians from the southern part of the country by not being decisive in announcing the preferred zone for its presidency and moreso, the increase in number of its northern aspirants showing interest in the race.

Political observers have noticed similar trends in activities and decisions of the two parties in recent times that suggest the two are watching each other' for moves advantage,

especially on which will first it's presidential candidate and from what zone.

It started with the national convention of both parties. The PDP in October 30, 2022 zoned its chairmanship to the north. Dr. Ivorchia Avu from the North Central emerged. The APC likewise on March 26 this year zoned chairman's seat to the the north. Alhaji Abdullahi Adamu also from North Central emerged.

An APC committee led by Kaduna State Governor Nasir El- Rufai prior to the convention, suggested to the party to swap its positions between the north and south, just like the PDP did

There have been changes to election timetable and schedule of activities in both partiee recently, with both finetuning processes at getting round producing nationally acceptable presidential candidates that can win the 2023 poll.

The two parties have a serious task of meeting with deadlines conducting wards, local government congresses in line with INEC directives.

Meanwhile, the National chairman of the Inter- Party Advisory Council (IPAC), Engr. Yabagi Sanni at a meeting between INEC and leadership of parties demanded on behalf of the 18 registered political groupings for extension

of deadline for conduct of primaries from June 3 to August 16, 2022.

Before the closed door meeting, INEC chairman, Mahmood Yakubu Prof reiterated the decision of the commission not to review the timetable.

PDP, both the In southerners and northerners are in the race for the presidential ticket but it is widely believed that the party is looking up north for its standard bearer. It has an array of qualified aspirants in the persons of former Vice President Atiku Abubakar. erstwhile Senate President, Bukola Saraki, Governors Aminu Tambuwal and Bala Mohammed of Sokoto and Bauchi respectively as well as respected business mogul Havatu-Deen Mohammed,

former governor of Lagos State, Bola Tinubu in transparently conducted presidential primary.

thought The of emergence of a Tinubu as its candidature and possibly the nation's President it was further learnt is unsettling some already stakeholders in the party. A source said influx of other gladiators from the South West was a plot to whittle down Tinubu's chance by dividing delegates from the zone

This, the source added was a premeditated design to shop for another person from the South as APC candidate. Hence, the coming up of names like Chibuike Rotimi Amaechi, former President Goodluck Jonathan, Central Bank of

Nigeria Governor Godwin Emefiele, and President of the African Development Dr Akinwumi Bank. Jonathan has Adesina. having denied interest in the race while there is indication that Adesina was not properly contacted by the group that bought nomination forms for him.

Apart from Yahaya Bello whose candidature has not been taken seriously by many, the venturing of Jigawa State Governor Badaru Abubakar and Senate President Ahmad Lawan into the race is causing suspicion as to what game the APC might be playing.

According to findings The Trumpet, the bv leadership of the APC came to a conclusion that the only way not to lose power in 2023 is to field an acceptable northern candidate. The calculation is that a northern candidate will split votes of the north with probably Atiku from the PDP while other geopolitical zones will be up for grabs.

The APC, it was learnt has come to terms with the fact that aside Tinubu, no southern aspirant among the personalities who have collected forms can match Atiku Abubakar. The party acknowledged how tedious it was to defeat Atiku and the PDP with a popular

web offset press. It is meant to be operated by Akwa Ibom Newspaper Corporation (AKNC), publishers of The Pioneer.

It was learnt that the web offset press has the capacity to print 17 colour pages, 32 black and white pages of newspaper and runs 500,000 impression per hour, while the the CTP runs a resolution of 2,400 DPI. Our

correspondent gathered that the facility would have saved the state some costs and served as a commercial printing press for other newspapers among others

Findings revealed that some national dailies had already indicated interest to print their newspapers at the press especially as it would enhace their circulation and early arrival in the South South region to Uyo, the state capital.

The machines were installed and commissioned on May 28, 2015 but were not tested. They didn't print any copy of The Pioneer on the day it was testrun by the experts brought in to manage the press and have been lying fallow, while the complex housing them have remained locked.

When our correspondent visited the printing press, it was discovered that the machines have not worked after the day they were commissioned by Ákpabio, just as the government is yet to officially hand over the press to the management of the state-owned newspaper corporation.

Former General Manager of The Pioneer, Mr. Silas Udo, who was in office when the press was installed told correspondent that the our machines were neither used to print any paper nor was any member of staff trained on how to operate them.

that the He explained that the Akwa Ibom Newspaper Corporation did not officially receive the printing press as it was never handed over to it by the supervising Ministry of Information and Strategy. According to him: "The

press was never used to print The Pioneer in my time. No Pioneer staff under me went for training anywhere to master the workings of the press

"Yes, we did not receive the press. It was a deliberate decision not to receive it as the procedural processes were not done or seen to be done. For example, the checklist to ascertain that what the government paid for are what were sent by the manufacturers was not done.

"It would therefore have been against civil service procedure to sign a Stores Receipt Voucher (SRV). So unless this was done after I left service. The press remained under the administration of the supervising ministry,".

Mr Idorenvin Umoren, the Production Manager of AKNC then, confirmed the position of Udo. He said he was a member of AKNC Rotary Press Pre-shipment Inspection Committee announced by the state government to visit Goss Community Press Company in Germany

He said they were only informed that the machines had arrived in Uvo through Onne in Port Harcourt, Rivers State, and they were expected to receive them. He said no production staffer of AKNC was trained on how to operate them

Meanwhile, Mr. Patrick Usen, the consultant who handled the project has blamed the ministry and called for a probe into the abandonment of the printing press.

Usen explained that the machines failed to work due to improper installation, saying the managers of the project did not follow the procedures necessary to set up a press.

He revealed that if the machines were properly commissioned, the representatives of Hieldelberg, Goss Graphics and himself, who facilitated the process from the purchase and shipment would have been available at the installation and commissioning.

He questioned the manner in which the machines were received. According to him, there was no confirmation of what was received visa-vis what was sent. He disclosed that the auxillary equipment which came with the machines such as forklift, rollers and others for their smooth running were missing.

"Governor Godswill Akpabio had excellent intentions for the state and The Pioneer newspaper in Unfortunately, particular. the ministry truncated that project. They should be held responsible. I don't know where this enquiry will end, but I think that a Commission of Enquiry should be set up to probe the issue.

"That web offset press has not been received till today by The Pioneer, that is, it has not been officially handed over by Goss Graphics to The Pioneer because of the haphazard installation procedures. There was no adherence to good engineering practice of installation. They hurriedly put that up together and called the governor, and I think the machine collapsed and failed there.

"There was no ink, no rolling papers, no printing plate needed to print for the governor to see. All those things were not there, and the machine collapsed that day, he stated.

The consultant called for a technical audit of what was supplied and installed, and how it was installed, as well as possible errors with the installation processes so as to correct the abnormality that has kept the machines from working.

He lamented that the state was yet to pay him his contract fee for the project, adding that he was willing to return for a proper installation of the machines if the government was willing.

He however warned that the Supra Setter A105 (Computer To Plate) machine may have to be upgraded as it may have outlived its lifespan of six years while lying idle.

"There must be a technical audit of what was supplied, what was installed, how it was installed to find out if there were errors with the

The PDP, it is expected might make a categorical statement on the dicey issue of zoning at a make-or-break meeting of its National Executive Committee (NEC) meeting in Abuja. The APC may react to the outcome or pronouncement of the PDP by toeing the line of the opposition party.

Weeks of apprehension over Jonathan's interest or otherwise in the APC presidential race came to a halt on Monday when a group of cattle breeders and nomadic communities contributed reportedly N100 million to buy nomination forms for him with the intention to urge him to contest the 2023 election.

But in a swift reaction, the ex- President through his media office refuted Jonathan's interest in the race and denied having anything to do with the group.

His Media Adviser, Ikechukwu Eze in a statement categorically stated that Dr. Jonathan was not aware of this bid and did not authorize it.

While appreciating the overwhelming request by a cross-section of Nigerians, for Dr. Jonathan to make himself available for the 2023 Presidential election, he said the former PDP President "has not in anyway, committed himself to this request."

He said "buying presidential aspiration form in the name Dr. Jonathan without his consent. knowing the position he had held in this country, is considered an insult to his person. The general public therefore advised to disregard it.

"We want to state that if the former President wanted to contest an election, he would make his intentions clear to the public and will not enter through

the back door." But a story

of his alleged meeting with the APC national chairman, Abdullahi Adamu same night further Monday heightened tension in the party throwing some major contenders into confusion on what game the national leadership of the party might be playing.

The Trumpet recalled several meetings the former president had held with Buhari at the State House in recent times, though on the claim of discussing matters of national interest.

A reliable source said there might be an unwritten agreement between the two leaders after Jonathan willingly conceded victory even before the announcement of results of the 2015 presidential election.

Another source said a group of concerned leaders sold Jonathan's candidature to the Presidency as one that will attract sympathy and appeal across geopolitical zones, adding to the fact that he is a southerner in tune with popular request that power must go to the south in 2023.

Our investigation revealed that Jonathan who might have heeded the call after consultations decided to go to the negotiation table with APC with terms and conditions for accepting to tun on APC ticket.

One of such, the source added is that Jonathan wants to enter the race as APC candidate and not as aspirant.

The condition in the Form 18 is considered a ploy aimed at arm-twisting aspirants not to challenge the decision of the party in court should it adopt a consensus candidate where applicable.

Contenders are barred from going to court without first exhausting avenues for redress and ventilation of grievances.

The aspirants are also expected to sign undertakings to accept the outcomes of the shadow polls and support whoever emerges as a candidate for the general election.

The ruling group also directed them to take oaths not to engage in thuggery, anti-party activities, factionalisation or the creation of parallel congresses and APC organs at any level.

These conditions are contained on page 18 of the nomination form given to the aspirants.

Most of presidential aspirants are said to have expressed concern about the "voluntary letter of withdrawal", which they are expected to sign before a Commissioner for Oaths or a Notary Public.

It was learnt that most presidential aspirants have been seeking legal advice on Page 18 of the nomination form, which they considered

a boobytrap. Denying this insinuation, the party leadership claimed that the conditions were in line with Article 21. 2 (i xii) of the APC Constitution. Many aspirants faulted the conditions as inconsistent with fundamental human

rights as enshrined in the 1999 Constitution. The are:

conditions "Abide to preserve, protect and defend the Constitution of the APC and the Federal Republic of Nigeria.

"Abide by the Primary election guidelines of APC and Nigerian Electoral Act. "Abide to place APC

above selfish interests. "I, my primary campaign organisation and my supporters undertake to accept the outcome of the primary and support whoever emerges as APC candidate for the general election.

"Abide not to engage in dishonest practices, thuggery, being absent from meetings to which he/she is invited without reasonable cause; carrying out antiparty activities which tend to disrupt the peaceful, lawful and efficient organisation of the party or which are inconsistent with the aims and objectives of the party.

"Abide not to give wrong information to any organ of the party or unauthorised publicity of a party dispute all without exhausting avenues or settlement or

"Abide not to file any action in a court of law against the party or any of its officers on any matters relating to the discharge of the duties of the party without first exhausting all avenues for redress provided.

"Abide to always follow the path of justice, honesty and unity amongst fellow contestants and party members. So help me God. "Abide not to factionalise

or create a parallel congress, election, or party organ at any level."

The letter of voluntary "I.. withdrawal says: of the above address ... vying for...hereby voluntarily withdraw my candidacy from the contest...scheduled to hold on...2023. My withdrawal is in the best interest of our great party, the APC.

Apart from addressing the letter to the National Chairman of APC, Senator Abdullahi Adamu, each aspirant is expected to endorse the letter before Commissioner for Oaths or Notary Public as aforementioned.

It was learnt that most aspirants were shocked by the attachment of the condition to the party's nomination form.

A source stressed: "Most of the aspirants have opted for legal advice on whether or not to sign the letter of withdrawal."

Bomb explosion rocks Jalingo

Residents of Jalingo, the capital of Taraba State, have again been thrown into confusion following an explosion that on Tuesday rocked the city.

The blast which is suspected to be bomb explosion, occured at about 9p.m close to the military base which is located in the heart of the city.

The explosion, as noticed by The Trumpet, is coming barely a month to that of Iware community in Ardo-Kola council where several lives were lost, with many others sustaining various degrees of injuries.

At the time of filing this report the number of casualties could not be ascertained.

Confirming the report, the state police command through its Public Relations (PPRO), Usman Officer Abdullahi, told our reporter that he heard the sound and that he has confirmed that it was an explosion, but could

not ascertain the number of casualties.

He however promised to furnish our reporter with details of information as soon as they are made available to the command .

The explosion, as observed by our state correspondent, is the third in the state within one and half month.

The first which occurred barely three days after that of Iware, did not claim lives, but inflicted various degrees of injuries on several persons.

leader. A community Kazeem Akinrimisi, the Sasere of Ofosu who spoke with newsmen noted that he had been farming on the land which the government is planning to sell for over 20 years.

The Sasere of Ofosu revealed that more than 25,000 farmers who registered with the state government had been paying their dues appropriately

Mr Akinrimisi who affirmed that he paid N6 million as dues for farming on the land to the state government in 2021, pleaded with the government to allow the farmers to acquire the land instead of imposing foreigners on them.

According to him, the farmers occupy 74 camps in the community spread over 20,000 acres of land.

Another protester, Ezekiel Olatunji, urged the government to consider the

lands as the farmers' means of livelihood

Mr Olatunii said in 2021, he paid N1.2 million as his due to the state government, saying he had been farming on the land for over 20 years.

The octogenarian who said he was astonished by the government decision to sell the land to foreigners, noted that cocoa is a major foreign exchange earner for Nigeria.

asked Governor He Oluwarotimi Akeredolu to allow the farmers to be paying their dues, even at the expense of paying more if desired by the government.

In a similar vein, Samuel Awolola, said Obada Camp in the community where he belonged paid N9 million out of N10 million as farming dues to the government in 2021.

"The lifespan of the Goss Graphics could be up to 50 years, but the Computer to Plate would last, let's say, for between five to six years. All you need is to change parts and upgrade," he advised.

Efforts to speak with Mr Aniekan Umana, the then Commissioner for Information who supervised the whole process of purchasing, installing and commissioning the press were unsuccessful as he did not pick calls or respond to text messages sent

to his phone.

It was gathered that the state government had talked about bringing in a consultant to man the place. But the plan never worked after the immediate past Commissioner for Information and Strategy, Mr. Charles Udo, visited the place and promised to take the issue of the printing press to Governor Emmanuel

In a telephone interview, the current commissioner of Information and strategy, Comrade Ini Ememobong, said the state government will soon hand over the printing press to a consultant

"Ehen i came into the

office, i visited the facility and commissioned an enquiry government. surrounding issues the press. We are working to reconcile all grey areas.

In line with the governor's determination to continue to achieve results in a most costeffective way, we had to open up the business to private investors who would come and manage the press. "Many have indicated

interest and we are still considering the options. I assure you that before the exit of this administration, the press will be taken over for proper managementt," he said

Court voids sale of recovered assets by Malami's committee

For being "an invalid instrument," a Federal High Court sitting in Lagos has nullified the Asset Tracing, Recovery and Management Regulations, 2019.

The court further nullified all sales and disposals of assets made by the Attorney-General of the Federation (AGF) Abubakar Malami, SAN, under the Regulations.

It held that the Regulations were "ultra vires the office and powers" of the AGF.

Justice Ambrose Lewis-Allagoa made the order in a suit FHC/L/CS/40/2021 filed by the plaintiff, Incorporated Trustees of HEDA Resource Centre, against the AGF as the sole defendant.

The AGF on November 9, 2020, inaugurated the Inter-Ministerial Committee on the disposal of assets forfeited to the Federal Government.

This, according to the Minister, was in accordance with the president's directive in October 2018, following recommendations of the Presidential Audit Committee on Recovery and Management of Stolen Assets and a need for efficient management of the assets.

But HEDA, through its counsel, Omotayo Olatubosun, challenged the AGF's power to set up the committee.

It argued that the Regulations conflicted with the Economic and Financial Crimes Commission (EFCC) Act, Trafficking in Persons (Prohibition) Enforcement and Administrative Act, 2015, National Drug Law Enforcement Agency (NDLEA) Act, 2004 and Independent Corrupt Practices Commission Act (ICPC), 2000, among others, on the matter of disposal of final forfeited assets.

The plaintiff sought nine reliefs, including the nullification of all disposals of assets by the AGF's Committee.

In its judgment, the court dismissed the AGF's preliminary objection argued by its counsel, Tolu Mokunolu, and granted all of HEDA's reliefs as prayed on the motion paper.

Justice Lewis-Allagoa held: "I am entirely in agreement with the submission of counsels to the plaintiff that the Asset Tracing, Recovery and Management Regulations, 2019 are contrary to the statutory provisions of the Economic and Financial Crimes Commission EFCC Act, Trafficking in Persons Cohabitation Enforcement and Administration Act, NDLEA Act and Immigration Act.

"A careful perusal of the above statutory provisions will show the provisions for the Attorney-General of the Federation to make regulations for the agencies for disposal of assets under the various enactments listed above.

"The above statutory enactments are therefore the enabling source of the Attorney-General of the Federation to the regulations. Consequently, the administrative powers to be exercised by the Honourable Attorney-General of the Federation must flow from the enabling statutes. "It is pertinent to state that the powers of the Attorney-General of the Federation do not override the provisions of the enabling statutes stabilising the powers of the law enforcement agencies and anti-corruption agencies and consequently the powers referred to in the commencement clause of the regulations merely are to be exercised in accordance with the Acts not to usurp the mandatory powers vested in the law enforcement agencies and the anti-corruption agencies.

"I am therefore in agreement with counsel for the plaintiff that the executive orders or any other forms of definition can be issued pursuant to session 315 of the Constitution; however, they are limited to enactments

predating the 1999 Constitution. "The Acts under Consideration in this instant suit were enacted after the 1999 Constitution and do not fall within the ambit of session 315 of the 1999 Constitution.

"In all and for the reasons hereinbefore given in this judgement, the questions put for determination in the originating summons are answered in favour of the plaintiff and all the reliefs sought are granted as prayed. This is the judgment of the court read in the open

court"

The Plaintiff's reliefs granted by the judge include a declaration that by the ICPC Act, the Asset Tracing, Recovery and Management Regulations, 2019 "is an invalid statutory instrument the former having conferred no power arrogated by the Defendant to himself in the latter Regulations; "An Order nullifying the Asset Tracing, Recovery and Management Regulations, 2019 as an invalid statutory instrument same being in excess of the provisions of the Independent Corrupt Practices Commission Act, 2000."

IYC condemns Wike's outbursts

Ijaw Youth Council (IYC) has condemned as derogatory a statement credited to Rivers State Governor Nyosom Woke against the ethnic group over their demand for the release of Hon. Fara Dagogo. It described Wike's outburst as insulting and totally unacceptable.

Chief Wike's had on Sunday launched an attack on the Ijaw ethnic nationality following the controversy over the arrest of a federal lawmaker, Hon. Farah Dagogo, and the 48 hours ultimatum issued for his immediate release.

IYC, in a statement reacting to the use of "Thunder Fire You" by Wike on the Ijaw nation during the church service, described the comment as disturbing, inciting and denigrating of the high office he occupies.

IYC, through its National

Spokesman, Comrade Ebilade Ekerefe, noted that such "tactless and disrespectful" comment by Wike was the height of his prolonged disdain for the ethnic nation as a whole and Rivers Ijaw people in particular since he became governor of the state.

It said it was even more shocking that the Rivers governor took his unrestrained verbiage to the hallowed pulpit of a church and desecrated the altar of God.

IYC restates that its only 'sin' that attracted Wike's ire was its demand alongside its parent organ, the Ijaw National Congress (INC), for the release of their kit and kin arrested and remanded in prison on the orders of the governor.

IYC added: "Despite being the fourth largest ethnic nationality in Nigeria and the largest in the Niger Delta, the Ijaw have consistently promoted peaceful and harmonious relationships with other ethnic groups, including Wike's Ikwerre nationality in Rivers State. PDP accuses APC of stealing govt funds for elections

Alleges ruling party wants to muscle 2023 polls

Peoples Democratic Party (PDP) has accused the Buhari Presidency of allowing the mass looting of public funds to corruptly create a war chest for the ruling All Progressives Congress (APC) to intimidate Nigerians and muscle the 2023 general elections.

It claimed that the APC is diverting public funds meant for development purposes and salaries of workers to its coffers by orchestrating the purchase of its presidential nomination form by all manner of persons at an excessive N100 million to warehouse sleaze funds for the elections.

Party spokesperson, Debo Ologunagba, in a statement Tuesday said PDP "has information of how public funds are being withdrawn from Ministries, Agencies and Parastatals of government and

diverted to people who have no verifiable means of livelihood to purchase APC's Presidential Nomination and Expression of Interest forms for individuals without any electoral value and who cannot even win Local Government elections."

He further stated that the party has "intelligence on how public funds are pulled out of government agencies in a surreptitious design perfected by an APC leader in connivance with certain individuals in positions of authority close to top persons in the Central Bank of Nigeria (CBN)..

The PDP recalled that it had earlier alerted on how the CBN under Mr. Godwin Emefiele as its governor has been turned into the finance department of the APC "where APC leaders fraudulently access public funds through nebulous subsidies, shady intervention programmes and discriminatory exchange policies which perpetuate illegal arbitrage system "The rejected APC has

resorted to this underhand method to corruptly rake in billions of naira from public treasury without consideration for the welfare of Nigerians.

"This APC's nefarious action is informed by its realization that its leaders cannot make huge donations to the APC coffers as they will be violating the limits of contribution to political parties as stipulated by law and regulation.

Federal High Court sitting in Abakaliki, the state capital on Tuesday declared the controversial Ebonyi Cybercrimes Law No 12 of 2021 unconstitutional, null and void.

The Court ruling followed a suit by one Pascal Etu who had sued the State Governor, David Umahi, over the controversial law.

Ebonyi State Government had in September 2021 enacted the law in an equally controversial circumstances.

Apart from the House of Assembly members, no Journalist was present when the law was enacted. Also there was no proof of the law going through public hearing before being passed.

It was also quickly and secretly accented to by the state governor, David Umahi almost immediately.

The public only became aware of the existence of the law when

in October, a social critic, Godfrey Chikwere was arrested by the Police for allegedly flouting some sections of the law.

The Police were about to charge

him to court when he suddenly slumped and was rushed to the hospital.

Earlier this year, Mr Etu was arrested for allegedly flouting the law, as was the Spokesperson of the People's Democratic Party(PDP) in the State, Chika Nwoba.

Both were remanded in prison by the State Magistrate Court pending the determination of the allegations against them.

Mr Nwoba was later granted bail by the court following outcry and condemnations that greeted his arrest.

But Etu was not so lucky as he is still in prison custody till date with his matter suffering several adjournments.

While the case against Mr Etu was on at the State High Court, he instituted the matter against the state government and four others at the Federal High Court in Abakaliki challenging the constitutionality of the law.

In the suit FCAI/CS/6/2022, Mr Etu through his Lawyers prayed the court to declare that the Ebonyi State House of Assembly has no powers to make such laws.

He also argued that the law is unconstitutional, null and void as it runs contrary to the Cybercrimes Act passed by the National Assembly.

The respondents in the mater include Governor of Ebonyi state, Ebonyi State House of Assembly and the Attorney General of the Ebonyi state as first, second and

third respondents respectively. Others are Commissioner of Police Ebonyi State and Department of State Security Services as fourth and fifth defendants.

In his ruling, The Presiding Judge, Justice Fatun Riman granted all the prayers of the plaintiff.

The Judge while declaring the Ebonyi Cybercrimes Law 2021 unconstitutional, null and void also issued an order of injunction restraining the Ebonyi State government from continuing to enforce the law.

Justice Riman further held that the Ebonyi State House of Assembly had no constitutional powers to make such laws because the National Assembly had enacted the Cybercrimes Act in 2015 which is applicable in all the states of the federation

Ebonyi PDP petitions security chiefs over alleged plans to seal secretariat

Chairman, Inter Party Advisory Council (IPAC), Engr. Yabagi Sanni made this demand on behalf of the parties Tuesday in Abuja at a quarterly meeting between INEC and leaders of political parties held at the INEC headquarters.

At the meeting which had in attendance, Senator Abdullahi Adamu, national chairman of the All Progressives Congress (APC) and Dr. Iyorchia Ayu, national chairman of the Peoples Democratic Party (PDP) among other party leaders, Sani said that the demand for the adjustment of the timetable and schedule of activities for 2023 general elections, was a unanimous decision of the 18 political parties at its general assembly meeting.

He said "in summary, the General Assembly of IPAC, after an exhaustive examination of the INEC timetable and related issues, arrived at a unanimous decision to request for an extension of two months to the deadline of the time frame for the conduct of party primaries and resolution of conflicts arising from the primaries:

"By implication, the IPAC leadership is appealing to the INEC to extend the deadline for the conduct of party primaries and resolution of ensuing conflicts from the present INEC given date of June 3, 2022 to Aug. 4.

"Some of the issues considered by the IPAC General Assembly which necessitated the call for extension in the timeframe of the present INEC timetable and schedule of activities are based on certain circumstances and developments that have hampered timely and strict compliance by the political parties to the timetable."

He, however, advanced reasons for the

demand, stressing that there are certain constraints which INEC failed to put into consideration while drawing up its schedule of activities. Such includes but not limited to; fasting period by both Christians and Muslims as well as the Eld-el-fitr and Easter celebrations within the same period.

Others according to him include "the forthcoming gubernatorial elections in Ekiti and Osun states".

The parties said time allotted by INEC for the conduct of party primaries is too short in view of the efforts required by the political parties for effective and scrupulous screening and selection of their flag bearers.

The IPAC boss said the unprecedented large number of aspirants jostling to emerge as candidates of their various political parties in the coming general elections, had made the task of screening very cumbersome and demanding.

Sani added that political parties also had to be cautious and painstaking in the screening and selection procedures as a safeguard against creating rooms for disruptive incidents of litigation by aggrieved aspirants.

"In making the request for extension in the INEC stipulated timetable and schedule of activities for the 2023 general elections, we in the Inter-Party Advisory Council, are not unmindful of the provisions of the Constitution and the Electoral Act with respect to timelines in the electoral process.

We are however, of the considered view that our request will not, in any way, tantamount to an infringement or, a breach of any extant laws and provisions.

"This is because, the alterations that we are demanding, will not affect the statutory dates already fixed for the conduct of the 2023 general elections.

"We are praying for the slight changes in the timetable for the conduct of party primaries in full consciousness of our position as key stakeholders in the nation's democratic process and who, at the bottom of it all, constitute not only the greatest beneficiaries but, as the

platform of all the registered political parties, we are in fact, the fulcrum around which the entire system and processes revolve.

"We should therefore, be seen as a body of responsible and patriotic interest bloc with a very high sense of responsibility and commitment to the success of every crucial stage and aspects in the electoral chain."

Sani urged INEC to consider IPAC request as a decision that was in the best interest of the nation's democracy and specifically, the smooth and successful conduct of a rancour free, credible, transparent, free and fair elections in the year 2023.

INEC Chairman, Prof. Mahmood Yakubu, reiterated that the June 3 deadline for parties primaries is sacrosant.

Yakubu said that any extension in the timeline for one activity would affect other activities and put unnecessary pressure on political parties and the commission.

"This is also our first meeting since the Commission released the Timetable and Schedule of Activities for the 2023 General Election over two months ago on Saturday Feb. 26.

"Already, all 18 political parties have forwarded the schedules of their primaries to the Commission, and some have commenced the process of choosing their candidates by conducting Ward and Local Government congresses.

"The period earmarked for the conduct of primaries by political parties commenced on 4th April 2022 and will end 24 days from today i.e. June 3.

Twice in the last two weeks, the Commission had cause to remind political parties of the necessity for strict compliance with the timelines for party primaries.

"I hereby reiterate the position of the Commission that there will be no review of the timelines.

"There are so many inter-related activities that are associated with the timelines which must be carried out.

" Any review to extend the timeline for

one activity will affect other activities and put unnecessary pressure on political parties and the Commission," Yakubu said.

Yakubu added that such action would ultimately result in more complications than what the extension seeks to achieve.

"Therefore, the Commission will not review the timelines."

"Working together, we should ensure fidelity to the timelines in conducting transparent and democratic primaries for the purpose of electing candidates for the 1,491 constituencies for which elections will be held on Feb. 25 and March 11 2023.'

Yakubu disclosed that the INEC had prepared a calendar of party primaries for presidential, governorship, national and state assembly seats based on the proposals submitted by political parties as at Friday May 6, presented to party leaders at the meeting.

He also advised political parties as they conclude their primaries and prepare for the off-cycle and general elections, to ensure a transparent electioneering process devoid of acrimony and rancour.

"In doing so, fidelity to internal democracy is critical.

'Unfortunately, the number of litigations by aggrieved party members challenging the conduct of party primaries so far may exceed the 807 pre-election Court cases on the 2019 General Election in which the Commission was joined by litigants.

" In addition, as we all know the security situation in the country is challenging enough.

"Do not wittingly or unwittingly compound the situation by the disruptive behaviour of your members and supporters during party primaries and general elections.

Leaders of other parties at the meeting include those of the Action Alliance (AA), All Progressives Congress (APC), Action Peoples Party (APP), New Nigeria Peoples Party (NNPP), National Rescue Movement (NRM), Peoples Democratic Party (PDP) and the Social Democratic Party (PDP).

"We have received submissions and

Don't disrupt parties primaries, Senate pleads with NANS Promises to wade into FG, ASUU faceoff

The Senate on Tuesday moved to halt planned disruption of activities of political parties including scheduled primaries by promising to intervene in the crisis rocking the ivory towers.

The upper chamber therefore urged the National Association of Nigerian Students (NANS) to shelve the planned action but toe the part of consultation, not confrontation.

It promised to bring the Federal Government and the striking Academic Union of Universities, ASUU back to the negotiations table.

Senate President Ahmad Lawan gave the assurance on Tuesday at a meeting with executive members of NANS at the National Assembly.

Members of NANS met have visited to urge Lawan intervene in the prolonged crisis, else the students will have no option than to carry out the threat of not allowing any political party hold its convention in Abuja to elect candidates for 2023 general elections.

The meeting between NANS and the Senate President was facilitated by Bishop (Dr.) Sunday Ndukwo Onuoha to find solution to the prolonged ASUU strike.

Bishop Onuoha said 'ASUU embarked on an indefinite strike, as the second round of the eight-week warning strike ended. Since the first strike on February 14 this year, till the present day, other staff unions in the university system, like the unions of Senior Staff Association of Nigerian Universities, SSANU; National Association of Academic Technologists, NAAT, and the Non-Academic Staff Union of Education and Allied Institutions, NASU, have joined the train.

"The negligence in education sector is letting the lives of our young generation waste away, while they watch some of the political-elite do the dance of shame", adding "where are the children of the elite and the affluent right now? They have been whisked away abroad, to learn in better managed institutions, with money that can feed an entire village fat".

President of NANS, Comrade Asefon Sunday Adedayo told the Senate President, as the number three citizen, to use his good offices to impress on President Muhammadu Buhari to urgently resolve the strike embarked upon by ASUU to enable their members

go back to classes.

Adedayo said as leaders of Nigerian students, they have nothing to tell them to calm them any more, adding that they have decided to move from "consultation or dialogue to confrontation", by not allowing any political party to hold its convention in Abuja to elect candidates for the 2023 general elections.

In his response, Lawan recalled that it was the intervention of the Senate in the past and had sessions with ASUU and the FG that led to ASUU getting N20-30 billion as academic earned allowance.

"I want to be very frank and if anyone finds what I'm going to say not palatable, I'm sorry. The so-called 2009 agreement signed, for me it is the main cause of problem. That agreement shouldn't have been signed because there was no way government can provide that kind of resources that the 2009 agreement envisaged. It was not possible. With due respect for those who worked so hard, but eventually hoping to just get ASUU back to class just signed everything like that".

He said the 2009 was not practicable, adding that someone just wanted ASUU back to class.

According to him, "we are not happy that our students are at home. If we get our act right we ought export labour, not brain drain".

The Senate President paid special respect to Bishop Onuoha for his nationalistic stand, adding that "the Bishop deserves national honour".

Court admits more evidence against fake Army General

The trial of one Bolarinwa Abiodun, a self-professed Army General on a 13-count charge bordering on possession of forged documents and obtaining money by false pretence of N266,500,000 continues before Justice Oluwatoyin Taiwo of the Special Offences Court sitting in Ikeja, Lagos.

The court admitted more evidence against him through the fourth witness of the Economic and Financial Crimes Commission (EFCC).

The defendant, whose bail was on April 25, 2022 refused by the court as he was ruled to constitute a flight-risk, is being prosecuted by the Lagos Zonal Command of the EFCC on offences contrary to Section 1 (3) of the Advance Fee Fraud and other Related Offences Act 2006; Section 363 of the Criminal Law of Lagos State 2015 and Section 6 of the Advance Fee Fraud and other Related Offences Act No 14 of 2006, respectively.

He was first arraigned on April 11, 2022 and he pleaded "not guilty" to

all the charges. One of the counts reads: "Bolarinwa Oluwasegun Abiodun, between 15th June, 2020 and 31st December 2020 in Lagos, within the jurisdiction of this Honourable Court, with intent to defraud and whilst holding yourself out as a General in the Nigerian Army, obtained the sum of N111,400,000 from Kodef Clearing Resources Limited, under the pretence that the sum represented part by the President and Commander-in-Chief of the Armed Forces, as the CHIEF OF ARMY STAFF of the Nigerian Army, which pretence you knew to be false."

Another count reads: "Bolarinwa Oluwasegun Abiodun, sometime in May 2020 in Lagos within the jurisdiction of this Honourable Court, knowingly forged LETTER OF APPOINTMENT AS CHIEF OF ARMY STAFF dated 20th May 2020 and purported the said document to have emanated from the President of the Federal Republic of Nigeria, which document you know to be false."

Testifying as the fourth prosecution witness, Buhari Bello Kobi, an operative of the EFCC involved in the investigation, narrated how the EFCC had received a petition against the defendant who, in the guise of being an Army General, allegedly defrauded his victim of N266,500,000.

Led in evidence by the prosecuting counsel, Rotimi Oyedepo, he told the Court that the EFCC received the petition sometime in November 2021 and that the investigating team immediately swung into action by carrying out surveillance activities, which led to the arrest of the defendant on January 12, 2022.

He said, "Attached to the petition was a letter (purportedly) signed by President Muhammadu Buhari addressed to the defendant for the appointment, the Certificate of Confirmation as the incoming Chief of Army Staff as well as the invitation for inauguration as the COAS all sent to the petitioner via WhatsApp.

"We further gathered intelligence through surveillance. And on 12th January, 2022, the suspect was arrested at his residence at Alagbado, Lagos.

"In the course of the search, several items were recovered from his house, including six pump action guns, three cartridge bullets, a swagger stick, a military ID card with the passport photo of the defendant and his name as General Bolarinwa, several forged documents and several photographs of him in the military uniform."

According to him, four vehicles were also recovered from his house, including one Hilux, one Range Rover, one Land Cruiser and one other vehicle with OBJ1 as its number plate.

He also told the court that the investigating team wrote to relevant authorities, including the State House and the Defence Headquarters to ascertain the genuineness of the documents.

He added that letters of investigation activities were also written to First Bank of Nigeria Plc, where the account of the defendant was domiciled, as well as Zenith Bank and UBA, where the accounts of the victim were domiciled.

He thereafter confirmed Exhibit A, which was already before the Court as the petition, and identified the responses received from First Bank, UBA and Zenith Bank, which were already before the Court, as exhibits.

He also identified the letter of investigation activities written to the Chief of Defence, the Chief of Army Staff, the State House as well as their responses. When the prosecution sought to tender the documents in evidence against the defendant, there was no objection by the defence counsel, Kayode Lawal.

Defendant voluntarily gave statement in Malabu scam, EFCC official says

An investigator with the Economic and Financial Crimes Commission (EFCC), Ibrahim Ahmed, has said the 2nd defendant, Aliyu Abubakar, in the trial of former Attorney-General of the Federation (AGF), Mohammed Adoke, did not make statement to the agency under duress but voluntarily.

Abubakar, a businessman, had alleged that statements made in the course of his investigation by the EFCC, were made under duress, adding that he was also induced to implicate others. Following the development, the court to ordered a trial-within-trial.

Ahmed, who was the 1st prosecution witness (PW1) in the trial-within-trial of the money laundering charge preferred against the duo by the anti-graft agency, told Justice Inyang Ekwo on Monday that the allegation by Abubakar was untrue.

Also, while being led in evidence by counsel to the EFCC, Ofem Uket, the witness who is a CSP seconded to the anti-graft agency, also denied the allegation that Abubakar was induced to make the statements.

"There was no inducement my lord. The 2nd defendant (Abubakar) was not forced to make any statement and he was not detained. He did it voluntarily and was not threatened," Uket told the court.

During a cross examination by lawyer to Abubakar, Chief Wole Olanipekun, SAN, the witness said though he could not tell how long the interview with the 2nd defendant lasted, the timing was in the record made.

Ahmed said Abubakar made two statements out of the six the commission sought to tender in evidence, in his own handwriting.

He said the defendant also brought lawyers who he said he trusted to write some for him and he (Abubakar) attested to the statements.

The witness also acknowledged that two of the statements were written by one Bashir, a police officer seconded to the EFCC on Abubakar's behalf and that the defendant undertook that he gave him the go-ahead to do so.

Ahmed said Bashir took the recording during the investigation. Justice Ekwo adjourned the matter until tomorrow for the continuation of the trial-within-trial.

Witness to testify electronically in NIMASA ex-DG's alleged N754.8 million fraud

He said, "The prosecution is seeking an order granting leave to call the witness based in the United States of America to testify through electronic means; and for such other order, as this Honourable Court may deem fit, to make in the circumstance."

The counsel for the second defendant, E.D. Onyeke, had opposed the application arguing that "it will be prejudicial, as he is not situated within jurisdiction."

"We believe his evidence could be manipulated," Onyeke added, as he prayed the Court to dismiss the application.

However, delivering the ruling today, the Judge dismissed the opposition of the defence as lacking in merit, and granted the prayers of the prosecution. The case has been adjourned till June 30, 2022 for continuation of trial.

Election 2023: Agenda for the Nigerian electorate

ince the beginning of 2022 the Nigerian political environment has been charged with politicking and power-play towards the 2023 general elections. National conventions are being held, forms for expression of interest are being purchased and almost all political parties are warming up for their primaries. The stakes appear to be particularly high this time. Nigerians want to escape bad political circumstances and hope a leader will emerge to rescue the country from insecurity, impunity, lack of accountability and reckless tribal politics.

The Nigerian electorate, need a clear and unambiguous agenda in this entire scenario. As the body of citizens who have satisfied the constitutional provisions and are eligible to cast votes in each successive general elections in the country, the Nigerian electorate is critical to the Nigerian democratic experiment. Actions and inactions from it largely determine the political future of Nigeria especially after 2023.

Past electoral situations have not been impressive, especially in the areas of voters' registration and voting. Available statistics show that as of March 2019, the electorate population in Nigeria was estimated at 84,004,084, which represents 49.78 per cent of the 200,962,417 estimated population of the country. But in the last presidential election, only about 35 per cent of the eligible voters participated in the process. This means that a huge proportion of eligible citizens failed to either register to vote or vote. Instead, some opted to be used to perpetrate violence during campaigns, snatch ballot boxes, thumb-print ballot papers and write results which were either announced by returning officers or validated by the courts. In some other cases the electorate opted for ethnicity, religious sentiments, and financial inducements as motivations

As we approach the 2023 general elections, we specially call for a serious self-check on the part of the Nigerian electorate. They need to register and vote. Failure of eligible citizens to register or vote as represented in the 35 percent of 2019 is unacceptable. In fact, it is disheartening when compared to about 65 percent reported in other countries of West Africa. Where majority of the electorate fail to exercise their franchise, they avail the politicians the opportunity to manipulate the political process.

In the general sense there is need for the electorate to re-educate themselves on the meaning and power of their votes



As soon as the news broke out, I expected our financial crime watchdog to go to work and arrest all the officials involved in the scam at least for questioning. But the EFCC did not bestir. They slept like a lame, crippled mass of flesh, pretending not to know that Nigerians have been robbed and the exchequer

In what seems like an afterthought, the Federal Government, perhaps realizing that the press had uncovered their oozing, lucre dyspeptic underbelly, immediately issued a statement denying the information as misleading. The Federal Government did not deny spending N5.9 billion naira, no. Rather, they admitted that instead of 177 youths, the funds were spent on 16,629 youths. The truth is that 177 youths were trained, simple. The 16, 629 figure was an afterthought by the government. Indeed, it is criminal to expend such a mind-boggling amount of money on the training of 177 youths while our university teaching hospitals are a crying necropolis.

In the same vein, Nigeria's Attorney General and Minister of Justice Abubakar Malami, a public servant ostensibly earning salaries, recently in Kebbi State distributed thirty exotic cars to politicians. The gesture came some days after he declared his intentions to contest the 2023 governorship election in the state. The cars include fourteen Mercedes Benz (GLK 2022 model) valued at 40 million naira each, eight Prado SUVs 2021 model, valued at 45 million naira each, four Toyota Hilux 2021 model valued at 35 million naira each, and four Lexus LX 570 2021 model valued at 95 million naira each. Hapless and befuddled Nigerians read the invidious details of the Greek gift with chagrin and a sense of loss. It grates on the soul of a genuine citizen how a public officer will donate such expensive gifts to possibly influence delegates towards the APC governorship primaries in Kebbi State. If EFCC was alive to its responsibilities, Abubakar Malami would have been answering questions now explaining how and where he got so much money to indulge in that kind of reckless ostentation and vulgar display of wealth. But EFCC has looked away and Abubakar Malami is a free man, perhaps planning to donate more exotic cars and other material items towards

the State's party primaries soon. If there was no agency of government saddled with the responsibility to investigate and arrest financial criminals, Nigerians wouldn't have bothered much. But the certainty that there is an agency of government with the responsibility to watch, arrest, and investigate those who indulge in financial impropriety drives the pain deeper. The Nigerian Senate is populated by suspected criminals, those who have cases to answer

with big files at EFCC. Godswill Akpabio was accused of mismanaging N100 billion naira State funds by the EFCC. Today he is a serving minister of the Federal Republic of Nigeria. Theodore Orji was ac-cused of mismanaging N27 billion naira State funds by the EFCC. Today he is a serving Senator of the Federal Republic of Nigeria. Ibrahim Shakarau was accused of mismanaging N950 million naira of Goodluck Jonathan's campaign funds by the EFCC. Today he is a serving Senator of the Federal Republic of Nigeria. Ifeanyi Ubah was accused of N43 billion naira subsidy fraud by the EFCC. Today he is a strong member of the Nigerian Senate. Yet, there are many more.

It is this kind of existing double standard by the EFCC that has necessitated a call for their immediate scrapping. To look away while those accused of financial crimes in the country, especially government officials walk the streets while hounding petty thieves whose motives are driven by hunger is to demonstrate pathetic irresponsibility. Towards party primaries at all levels, politicians are barring their fangs, sharing billions amid hunger and deprivation in the country.

EFCC should either do their job or close shop and go home. Nigerians deserve more respect as they confront survival headlong. EFCC should speak up now or keep quiet forever.

uite very few of ASUU's past strikes won public sympathy like this current one has. Student bodies have reacted. Sectional leaders have passed comments. Parents, traditional rulers, politicians and religious leaders have all put in some words, and all seem to agree that this time the striking professors and their university system deserve some more equitable deals in the Nigerian rewards system. If this appears exaggerating, I can re-phrase that no stakeholder seems to consider the professors' current claims as frivolous; not even the Minister of Labour who recently declared that he too was unsatisfied with the conditions of service of the Union members. In spite of these, the striking lecturers had to extend the strike to another three months.

The seemingly unending imbroglio suggests that meetings



may never bring success to the struggles of Nigerian professors. My opinion of what can is the need for them to augment their current strategies with action. This is one of such times one cannot help relying on indigenous wisdom to resolve a global problem, so, to some two Yoruba sayings I went: 'Ebi n pa mi ko se e f'ife wi, ina n jo mi o se e kun yamunyanmun'; and ' Airin po nii j'omo ejo n'iya, t'oka ba saaju, ti sebe tele, ti monamona n boʻleyin, ko s'eni naa to le duro d'omo eranko'. Meaning? Don't worry you'll get it in the cause of the writing.

In this opinion I observe that ASUU's many meetings with the Federal Government cannot send the real message to the world. It's looking more like some joke, every day. It's like joke not because the striking lecturers do not have their facts, but because their dominant methods

of engagement, the sit at home strike, appears incompatible with, and inadequate for the character and nature of the current Nigerian government. I then propose that from professors to graduate fellows they need to wear their gowns and file to the streets of Nigeria in protest demonstrations. Of course, gowns are never violent, so, fear not. And if your fear is that hoodlums may hijack the show from the lecturers, then note that intellectuals have the capacity to manage crowds; after all, they teach and research for those professionally employed to do so. What to note is that unusual situations demand unusual approaches. Boardroom meetings do not appear potent enough to elicit response from the current Nigerian government. The foregoing sayings are my frameworks for declaring so.

A Beninois Visiting Research Fellow at the University of Lagos Institute of African and Diaspora Studies narrated the experience of his country's lecturers during a struggle similar to ASUU's. For 15 years they lived under inadequate salaries and dehumanizing working conditions. Like ASUU's, sit at home strike was their first strategy. The day they went further to engage in street protests across the country did not extend to third before the government bulged. Since the year 2014 in the economically humble country of Africa, a full professor has been earning 1.5m CFA monthly, and in same proportions it goes across the ladder. New reviews are in process.

Industrial action is a critical part of the social struggles that balance social relations in every social formation. It is some form of protest, and the very idea of protest is primarily aimed at striking the highest sentiments of the target of the protest. These sentiments are not universal; they depend largely on targets, political environments, plans, locations, times and other logistics surrounding them. The Nigerian government that is the target of the current ASUU protest does not exist on character but coercion, not on ambition (of returning for another term) but of exit plans to regroup for future political merchandise. In addition, the government holds little takes in terms of university education. Many ministers and governors and presidents hardly have kids in the public universities; maybe some distant relatives. Now they nurse the ambition of establishing private universities whose survival lies in the death of the public ones. Definitely, confronting this kind of group

with sit at home strikes is like stoning to bring down a wild elephant. It may take the cows coming home before the impacts are felt.

As ASUU's boardroom meetings with government deadlocks into another three months extension, its members at every part of the country need to move beyond the comforts of their homes. They need to take the struggle to the public and disturb the flow of daily governmental activities to save themselves from starvation and dehumanizing social conditions. Snakes suffer hazards because they don't walk in den. If the vipers lead, the cobras follow and the mambas crawl behind them no rational mortal wait can await the pit. The effort of a starving man crying out in whistle is a huge joke, and mumbling cannot be an option for a man inside a large inferno. Now you have translations to the proverbs, don't you? The take home is that ASUU's struggle needs to respond to the true character of Nigeria's Federal Government, and the characters are best understood from the lyrics of Fela's VIP, BONN, ASBP, STB and CBB to mention just a few. Please find out.

Health advocates caution Nigerians against high level of TFAs in foods

Public health advocates from the public and private sectors as well as civil society groups have, again, cautioned Nigerians against the consumption of foods containing high levels of industrially produced Trans Fatty Acids (TFAs).

They stated this at a training organised for journalists by the Corporate Accountability and Public Participation Africa (CAPPA) drawn from print, broadcast and online media in the five South East states of Abia, Anambra, Ebonyi, Enugu and Imo states on effective reporting of trans fats.

The two-day training organised in collaboration with the Network for Health Equity and Development (NHED) in Enugu was funded by the Global Health Advocacy Incubator (GHAI) and facilitated by local and international public health, media and communications experts including Country Director of GHAI, Joy Amafah, Executive Director of NHED, Dr. Jerome Mafeni and representative of the National Agency for Food, Drugs Administration and Control (NAFDAC), Dr. Eva Edwards, who shared insights on the status of NAFDAC regulations on trans fats.

The training module targeted building the capacity of Nigerian journalists to understand and exhaustively report on TFAs and its link with poor health for consumers, strengthening the relationship between Nigerian journalists, civil society advocating a trans fat-free Nigeria and regulatory agencies, particularly NAFDAC and sharing knowledge on local, national and global issues relating to TFAs and the oils and fats industry.

Enugu State Commissioner for Health, Prof. Ikechukwu Obi, who was special guest at the event, explained that the goal of the allied with the vision of the Enugu State Government for healthy citizens as espoused in its health sector reform law, which provided for a legal framework for citizens' participation in health sector and the setting of new standards for health research and information system management.

Obi noted that the high levels of trans fat in foods consumed by Nigerians, from the fast foods to re-used oils, meant the country was sitting on a keg of gun powder that might explode any time in form of cardiovascular diseases of all kinds.

He revealed that in 2021, the World Health Organisation (WHO) reported that cardiovascular diseases remained the leading cause of deaths globally and that in 2020, an estimated 17.9 million people died from cardiovascular diseases, representing 32 per cent of global deaths.

The commissioner also explained that 85 per cent of the deaths were due to heart attacks and stroke, adding that if public health advocates learnt anything in the fight against the COVID-19 pandemic, it was the realisation that working together, the challenges that threaten the collective well-being of the citizenry could be overcome.

FG to train young farmers abroad on livestock, crop production

Stories by J**OHNMARK UKOKO** gr National Agricultural Land Development Authority (NALDA) has concluded plans to sponsor 200 young farmers to Israel and Morocco for capacity building on crop production and animal husbandry to tackle hunger and enhance food security in Nigeria.

Executive Secretary of NALDA, Prince Paul Ikonne, who disclosed this in Abuja recently at an event to officially handover travel documents to the beneficiaries, said the programme was a continuation of the National Young Farmers Scheme (NYFS).

He explained that the pro-

gramme would improve the country's food production and exportation, noting that it was aimed at making agriculture more attractive to the youths.

He said the initiative was initiated in collaboration with the Ministry of Education, noting that the youths were drawn from the 36 states and the Federal Capital Territory (FCT), Abuja and would visit Israel and Morocco for six days to undergo intensive training on greenhouse farming and animal husbandry.

Ikonne further stated that the two countries were chosen because they have the expertise in agriculture and animal husbandry, adding that the Federal Government **K, CIOP PIOUUCLIOII** paid for their travel expenses and training as contained in NALDA's

budget. "These 200 youths will be engaged in learning proper crop production and greenhouse management and 100 youths will be engaged in animal husbandry, slaughtering, meat processing and

other aspects. "So, we are sending them to Israel and Morocco that we know have strong expertise on what we are doing to enhance their knowledge and expose them to modern crop production and animal husbandry. Upon their return, they will teach others what they have learnt," he stated.

Marketers attribute resurgence of fuel queues to N100b bridging debt

Independent Petroleum Marketers Association of Nigeria (IPMAN) has declared that some of its members have shut down operations following their indebtedness to commercial banks.

President of IPMAN, Chinedu Okoronkwo, said insufficient supply from marketers was building up queues at filling stations across the country, especially in Abuja.

Also speaking, Vice Chairman of the association, Abubakar Maigandi, disclosed members of IPMAN pay N1 million for 1,300 litres of diesel, while the government pay them N600,000 with shortfall of N400,000 and that the accumulated debt was challenging their businesses. They stressed that marketers buy diesel for N700 per litre and since there was no subsidy and government refused to pay them, it would be difficult to sustain the business.

Maigandi, who advocated an extension of intervention funds to resuscitate the diesel business or they will stop further supply, said the Federal Government has failed to refund 12 months products bridging claims, amounting to about N100 billion.

"We are still loading, but some marketers have shut down operations because they are highly indebted to the banks and could not continue to sustain their operations. Only few of our members are now operating and cannot satisfy current demand, he stated.

AMCON takes over assets of Aeroland Travels over N1.8b debt

Following the ruling of Justice D. E. Osiagor of the Federal High Court, Lagos Division, the Asset Management Corporation of Nigeria (AMCON) has taken over assets of Aeroland Travels Limited and its directors over indebtedness amounting to N1.8 billion.

The Trumpet recalls that Justice Osiagor delivered the judgment on February 7, 2022 and in compliance with the enforcement of the court order, AMCON moved to take the company's assets on Friday, May 6, 2022 as listed by the court through its Debt Recovery Agent, Robert Ohuoba & CO.

This was revealed in a statement issued by the corporation's Head of Corporate Communications, Jude Nwauzor recently and made available to The Trumpet newspapers in Lagos.

The property include those located plot 4 & 4B, Block 66 Magodo Scheme; Lagos State; plot 9, Block 44C, Adetoro Adelaja Street, Magodo, Lagos and other listed locations.

The court also ordered the freezing of the bank accounts and shares of the company's directors including Segun Adewale and Mrs. Victoria Adewale.

It equally granted AMCON the rights to seize any other landed property in any other location that might be found within the jurisdiction of the Federal High Court belonging to Aeroland Travels Limited or either of its directors.

Nwauzor confirmed that all the property listed in the court order have been taken over by AMCON with the assistance of court bailiffs and other law enforcement officials.

Following the development, AMCON had purchased the Non-Performing Loans (NPLs) of Aeroland Travels Limited from Polaris Bank, formally Skye Bank. ility of protecting the life and property of citizens.

DMO opens more FGN bonds for subscription

Debt Management Office (DMO) has announced the offer of two additional Federal Government of Nigeria (FGN) bonds for subscription.

The first offering is a two year savings bond, which will be due on May 18, 2022 at a 7.93 interest rate per cent per annum.

It fixed the opening date for the bonds on May 9, 2023, while the closing and settlement is May 18, just as it fixed the coupon payment dates for August 18, November 18 and December 18.

The bonds are offered at N1,000 per unit subject to a minimum subscription of N5,000 and multiple of N1,000 and thereafter, subject to a maximum subscription of N50 million.

The DMO explained that the interest payment would be made on a quarterly basis, while bullet repayment would be made on the maturity date, adding that the bonds qualify as securities in which trustees could invest under the Trustee Investment Act.

"They qualify as government securities within the meaning of Company Income Act (CITA) and personal Income Tax Act (PITA) for tax exemption for Pension Funds among other investors.

"They are listed on the Nigerian Stock Exchange and qualifies as liquid assets for liquidation asset and for liquidity ration calculation for banks," the DMO said, assuring that the bonds are backed by the full faith and credit of the Federal Government and charged upon the country's general assets.

Leveraging Lekki Deep Seaport for FG's regional trans-shipment hub

Over the years, Nigeria continues to lose revenue and investments due to multiple bottlenecks at the nation's ports exacerbated by diversion of cargoes to neighbouring countries. **ADAKU WALTER** writes that Federal Government's has been intensifying efforts to regain the losses and position the country as the maritime hub of West and Central Africa region.

Poor infrastructure, cumbersome clearing processes and other challenges have made Nigeria to lose trans-shipment and transit cargoes to neighbouring countries thereby jeopardising the country's chance of becoming a regional maritime hub.

Landlocked countries like Chad and the Republic of Niger, which, before now, were using the country's ports as transit points for their cargoes, have been diverting their shipments to Ghana, Togo, Republic of Benin, Cote d'Ivoire and Cameroon.

Reports indicate that most importers divert Nigeria-bound cargoes to the neighbouring countries just as investors shun the nation's ports and patronise other destinations, which costs Nigeria an estimated N130 billion yearly.

The challenges have restricted the country from reaching its heights in the maritime sector, which is one of the highest contributors to the economies of other countries.

The neighbouring countries capitalise on the shortcomings in Nigeria's maritime sector to assume trans-shipment hub status as they are rapidly developing into modern seaports with automated facilities and infrastructure as well as deeper draught that could accommodate larger vessels with Nigeria-bound cargoes.

While the ports in neighbouring countries could accommodate vessels with 16 metres draught, no Nigerian seaports is capable of accommodating such vessels due to shallow draught of as low as 13 meters.

It was learnt that the draught level of Togo is 15.5 metres, Republic of Benin has 15 metres, Ghana has close to 19 metres, while Cameroun has 16 metres.

Already, Togo has overtaken Nigeria to become the leading port in West Africa, as the United Nations (UN) report showed that Togo recorded 1,725, 520 twenty-foot equivalent (TUEs) of cargo throughput in 2020, while Nigeria recorded 1, 528, 520 TUEs, thereby losing over 196, 750 TUEs or 30 per cent of container traffic to the Lome Port.

Also, ports within the region have positioned themselves and are ready for participation in the African Continental Free Trade Area (AfCFTA) regime.

Meanwhile, stakeholders in the country's maritime sector have advised the Federal Government to design deep seaport and trans-shipment centre to accommodate large vessels and megaships of between 8,000 and 20, 000 TEUs currently being demanded regionally and globally, which they said, was the only solution to diversion of cargoes to neighbouring ports.

Also, the Nigerian Ports Authority (NPA) stated that with the country accounting for over 70 per cent of the cargoes imported to West and Central Africa, developing modern deep seaports would translate to huge potential for revenue earning for the nation along with the attendant socio-economic benefits.

Worried by the loss of the maritime

hub status and revenues due to the inadequacies of the country's seaports, the Federal Government and Lekki Port LFTZ Enterprise Limited signed a 45- year concession to develop a deep sea and multipurpose port in Lagos State.

With a draught level of 16.5 metres, Quay wall of 1,523 meters and turning circle of 600 meters, the Lekki port is projected to be one of the most modern deep seaports in West Africa, which will support the burgeoning commercial operations in Nigeria and reposition the country as the maritime hub of the region.

Minister of Transportation, Rotimi Amaechi, expressed confidence that the commencement of operations at the port would strengthen the country's maritime sector to meet the growing demands for goods transported by sea.

Also, Minister of Information, Lai Mohammed, during a recent tour of the port, said when completed, the port would make Nigeria to regain the maritime business it lost to ports in Togo, Cote d'Ivoire and Ghana.

He explained that it would also boost the country's quest to take advantage of the implementation of the African Continental Free Trade Agreement (AfCFTA), which he said, was capable of generating over \$201 billion in taxes, royalties and duties, as well as create no fewer than 169,972 jobs when the port commences full operations at the end of the year.

Mohammed pointed out that the aggregate economic impact of the port, put at \$361 billion in 45 years, will be over 200 times the cost of building the port, adding that the direct and induced business revenue impact of the port has been estimated at \$158 billion in addition to impact on the manufacturing, trade and commercial services sectors.

"No port in Nigeria currently has this. The equipment is why the port can do 18,000 TEUs, which is over four times the number that can currently be handled by the other ports," he said.

He explained that with regulatory agencies as the Nigerian Ports Authority (NPA), Nigeria Maritime Administration and Safety Agency (NIMASA), Nigeria Police Force (NPF), National Agency for Food, Drug Administration and Control (NAFDAC), Department of State Security (DSS), Nigeria Customs Service (NCS), Nigerian Immigration Service (NIS), Port Health Services (PHS), Nigerian Drug Law Enforcement Agency (NDLEA), the Federal Government's ease of doing business would be achieved at the port On the readiness of the Lekki port to help country attain its regional maritime hub agenda, Architect of the project, Matthew Oloyede, explained that with the automated infrastructure, the port will be capable of accommodating the largest and post-Panamax vessels.

"With power plant generation of 16 megawatts, we will have an efficient port where all operations are automated. We are competing with other neighbouring ports in terms of automation. Containers will pass through our scanners and not the usual physical examination process, which will reduce the clearing time.

Also, Managing Director of the Lekki Deep Sea Port, Du Ruogang, assured that it would change the economic landscape of Nigeria and West Africa with its largest terminal capacity, adding that the operators will have a more integrated terminal operating system, not only to drive the functionality of the port, but also its e-commerce.

Ruogang added that the competitive edge of the port remained its ability to accept larger vessels and discharge ships twice as fast, thereby reducing the overall port stay of vessels, as well as the costs for importers and exporters minimally, while ensuring savings for consumers.

'No candidate from Sokoto, Zamfara govt schools enrolled for WASSCE'

No public schools in Sokoto and Zamfara states will sit for the West African Senior School Examination (WASSCE) scheduled to hold from May 16 and June 23, 2022 because the government-owned ones did not present candidates. Head of National Office,

HNO, West African Examinations Council (WAEC), Mr. Patrick Areghan, disclosed this at a news conference in Lagos, to announce details of the body's preparations and readiness for the conduct of the examination in Nigeria.

Areghan however stated that

private schools in the states had registered their candidates for the examination, he also explained that "the reason why candidates from public schools were not registered remains unknown."

The WAEC chief also frowned at late registration of candidates, particularly by private schools, saying such act is totally unacceptable as it delays preparations for the examination.

He said over 1.6 million candidates from 20,221 schools have registered for the examination, out of which 800,055 representing 49.76 percent are males, while 800,724, estimating for 50.24 per cent, are females. would be examined in 76 subjects, made up of 197 papers while about 30,000 practicing senior teachers, nominated by various Ministries of Education, would be participating in the examination as supervisors.

"The revert to May/June period for the conduct of the examination should be celebrated. The significance of this is that the West African Examinations Council (WAEC) and the various member States, save Ghana, have now again found a common ground in respect of their academic calendars.

"Parents are hereby warned to desist from patronising these evil-doers who are hell-bent on frustrating the efforts of WAEC. They should not patronise them as that would only lead to the destruction of their children's destiny.

"Meanwhile, we shall, as usual, work hand-in-hand with the Nigeria Police to bring perpetrators to book. There will be no hiding place for them. Perpetrators will surely face the full wrath of the law."

He kicked off as an artist while he resided at Mushin, a quite popular and rugged part of Lagos at the time.

He's also featured with prominent stars like Dbanj, Femi Kuti, Duncan Mighty, Terry G, Olamide, and Dammy Krane, and

has shared stages with legendary performers not exempting his performance live with Wyclef Jean in South Africa. Durella began receiving awards in 2008 from MTV Base.

Durella was originally signed to TC Records in 2006 after its executives witnessed his performance at an event. Under this record, he released his first debut album "King of The Zanga" which includes tracks like- In the Zanga, SHAYO, Gunner's Anthem, Queen of My Zanga and Wizkolo Wiska and later on, he dropped his second album, Reconfigurated. With "Life in The Zanga", Durella emerged winner at a competition organised by Airtel (then, Zain)/MTV where he won 50,000 dollars.

He collaborated with various stars when he was visibly in the music scene. With the likes of his sound-identical, D'banj in "Ibadi E" Featuring Olamide, Durella and Kay Switch, "Nkiruka" featuring Duncan Mighty, "Buddy Hanging featuring Olamide", "My Life" featuring Terry G, "Gaga" Featuring Wizkid, Jahbless – "Joor Oh" Remix Featuring Ice Prince, Reminisce, Ruggedman & Eldee ,"Don't Go Funny" Featuring Timaya,


"2 Casket" by Quest Featuring Durella, HCode "Monster" (Remix) Featuring

You may remember Durella as the dude who is always on Dark shades. D'banj is a man of shades as well. One major difference between D'banj and Durella is their mode of presentation. Since his last major hit, Durella hasn't been on the limelight for several months. You may blame it on lavish spending as some of his fans accused him of or bad management from his former record label, Iconic Music or maybe he probably just ran out of songs which is almost impossible for a song writer.





Morocco to host CAF Champions League final Egypt's AI Ahly protests

onfederation of African Football (CAF) 'Morocco the host ' right to host the 2022 TotalEnergies Champions League final scheduled on May 30, 2022.

The continental football governing body received two bids from the Senegalese Football Association and Royal Morocco Football Association.

However, Morocco emerged as the favourite candidate to host the CAF Champions League grand finale after the Senegalese pulled out in the middle of the race.

Consequently, CAF decided to jettison the usual two-legged final for a one-legged clash to determine the winner.

In a statement, CAF said: "The previous CAF leadership decided on 17 July 2019 that the winner of the TotalEnergies CAF Champions League will be determined by a oneleg final, instead of the usual two-legged, home and away final.

"CAF received a bid from the Senegalese Football Federation and from the Royal Moroccan Football Federation to host the final of the CAF TotalEnergies Champions League 2022.

Senegalese "The Football Federation subsequently withdrew their bid. is therefore "CAF

pleased to award hosting of the the CAF TotalEnergies Champions League 2022

Final to Morocco. The date of the final is 30 May 2022. "There are currently discussions underway within CAF to revert to the old two-legged home and away final to determine the winner of the TotalEnergies CAF League, Champions rather than the one-leg final." Meanwhile, A1

Ahly have written to

CAF to appeal that a neutral ground should be selected to host the grand finale of this year's 2022 TotalEnergies CAF League Champions competition.

They advised that the continental football governing body should pick a venue outside the country of the four teams that made the semi-final spot.

Flying Eagles to grab semi-final ticket against Burkina's Etalons



After a comfortable 2-0 win and three maximum points secured against defending champions and reigning Africa's best, Ghana on Sunday, Nigeria's Flying Eagles are expected to keep things intense but firm against the Junior Etalons of Burkina Faso on Wednesday, to earn their semi-final ticket at the ongoing WAFU B U20 Championship in Niamev.

Both teams will take the pitch at 5pm at the Stade General Seyni Kountché,

the same venue where the Flying Eagles enacted a masterclass to send African champions Ghana tumbling on Sunday. Ibrahim Muhammad and former U17 star Ahmed Abdullahi scored the goals that downed the Black Satellites.

Coach Ladan Bosso still has the full complement of his squad and is unwilling to rest any of his regulars as he looks to make sure of

a place in the last four. "We must approach the match against Burkina Faso with even stronger determination and desire than we did for the Ghana match. A ticket to the semi-finals is key at the moment, and we can then start thinking of a ticket to the final and a place in the Africa Cup of Nations next

year." Only the

finalists at the WAFU B Championship in Niamey will be eligible for next year's Africa U20 Cup of Nations, already scheduled to take place in Egypt in February/March.

ex-coach Rohr N157m International Federation Association Football (FIFA) has partially granted a request of former Super Eagles coach Gernot Rohr against the Nigeria Football Federation (NFF) over a breach of contractual terms.

Nigeria to pay Eagles

Rohr was sacked by the NFF in December last year after a poor performance in the qualifiers to the 2022 TotalEnergies Africa Cup of Nations (AFCON) in Cameroon and was replaced by Augustine Eguavoen in the interim.

Angered by the turnout of circumstances, the German whose contract stipulated that he will be paid in full until December 2022 when the contract ends, dragged Nigeria's football governing body to FIFA alleging a claim of \$1.2m as compensation.

However, after reviewing the case brought by the German, who recently missed out on becoming the head coach of the Mali national team to Eric Chelle. the FIFA tribunal awarded the sum of \$377,879.46 to Rohr, admitting that his claim is "partially accepted insofar as it is admissible".

FIFA tribunal stressed that the NFF must ensure that they pay the money within a timeframe of 45 days or incur the wrath of the apex football governing body.

"Íf full payment (including all applicable interest) is not made within 45 days of notification of this decision, the respondent [the NFF] shall be imposed a restriction on receiving a percentage of development funding, up until the due amounts are paid," FIFA tribunal said.

NFF, However, not oblivious of the terms of the contract they signed with the German gaffer, will have to cough out an additional N156,933,339.74 to N62,718,294.52 FIFA slammed on the country over fans' destruction of Abiola National МКО Stadium during the world cup qualifiers with the Black Stars of Ghana.

like it was, we drew, they won. It makes it three points and the goal difference changed as well. Or you can see it like we were six points behind and they lost and we won," Klopp said in a bid to boost the morale of the Reds.

Pep Meanwhile, Guardiola has claimed that the whole country is supporting Liverpool to win the Premier League trophy after Manchester City hammered Newcastle United on Sunday.

The City gaffer in his statement to BeIN Sports, said, "Everyone in this country supports Liverpool, the media and everyone.

"Óf course because Liverpool has an incredible history in European competition. Not in the Premier League, because they have won one in 30 years, but it is not a problem at all."

However, Klopp shrugged off Guardiola's claims saying understands the he latter is under pressure after losing out on the UEFA Champions League.

He added that he also faced the same circumstance against Tottenham on Saturday that made him criticize Antonio Conte's tactics at Anfield.



Compared to review or relief, the Nigerian Speaker told his colleagues that in the case of the latter, the debts would still be outstanding, except that there would be some alterations, adjustments or even postponement of the repayment schedules.

"We want to reset our buttons to read from zero. That is the position, and I appeal that we all support this push", he stated

Gbajabiamila was contributing to discussions on the first plenary topic of the day, "Financing Africa's pandemic Response: Legislative Imperatives and Interventions," anchored by the Country Representative in Nigeria, World Health Organisation, Dr. Walter Kazadi Mulombo.

Nqakula. Participants at the session, backing Gbajabiamila's position, spoke on the need for parliaments to step up their oversight duties in tracking how the Executive

Some noted that in countries that secured debt

would look at several factors, including accounting for how the loans were utilised and the compliance of countries to agreements signed at the inception of the loan requests. Meanwhile as part of his

Meanwhile, as part of his recommendation for tackling or preparing for pandemics, Gbajabiamila suggested setting aside a percentage of the health budget for vaccine research and manufacturing by African nations.

He said this could also be legislated to make compliance mandatory.

The Nigerian speaker also recommended the establishment of an African Centre for Vaccine Research and Production.

He explained that the joint centre could be located anywhere on the continent, where all African countries could contribute to its development.

Marcos wins Phillipines presidency amid protests Say judge me by my actions, not family's past

Ferdinand Marcos Jnr has vowed to work for all Filipinos after his remarkable election victory, and he told the world to judge him by his presidency, not his family's past.

The son of the late Philippines dictator's victory would return his family to power 36 years after they were ousted by a popular revolution.

The Junior Marcos, better known as "Bongbong", has become the first candidate in recent history to win an outright majority in a Philippines presidential election, paving the way for a once unimaginable return to rule for the country's most notorious political dynasty. "Judge me not by my ancestors, but by my actions," Marcos told the world, according to a statement by his spokesperson Vic Padvinger

Rodriguez. Marcos fled into exile in Hawaii with his family during a 1986 "people power" uprising that ended his disgraced father's autocratic 20-year rule. He has served in congress and the senate since his return to the Philippines in 1991.

Marcos's victory in Monday's election now looks certain with 98 per cent of the eligible ballots counted in an unofficial tally showing he has 31 million votes, double that of nearest rival, Vice President Robredo. An official result is

expected around the end of

the month.

"This is a victory for all Filipinos, and for democracy," spokesman Rodriguez said.

"To those who voted for Bongbong, and those who did not, it is his promise to be a president for all Filipinos. To seek common ground across political divides, and to work together to unite the nation."

Though Marcos, 64, campaigned on a platform of unity, political analysts say his presidency is unlikely to facilitate that, with bitter feelings about his family's vast political influence and wealth.

About 400 people, mostly students, staged a protest against Marcos outside the election commission on Tuesday, citing election irregularities.

On Robredo, Mr. closest rival in the race and the country's current vice president, said that her team was looking into reports of voter fraud. But every opinion poll before the election had predicted that Mr. Marcos would win by a huge margin, and his lead by Tuesday was so overwhelming that reports of fraud and malfunctioning machines were unlikely to

sway the result.

Sara, the daughter of President Rodrigo Duterte and Mr. Marcos's running mate, had gathered 31.5 million votes by Tuesday, more than triple the votes of Senator Francis Pangilinan, who ran as vice president in support of Ms. Robredo.

A big win for Junior was securing Duterte's daughter as his vice presidential running mate. Sara Duterte-Carpio won more than three times the number of votes compared with her nearest rival and also likely broadened the Marcos appeal in many areas.

Manila city Mayor Francisco Domagoso, became the first presidential contender to accept defeat. Mr. Marcos and Ms.
