# Outrage trails slaying of girl by zealots in Sokoto

ational anger from Sultan and President-General of the Nigerian Supreme Council for Islamic Affairs (NSCIA), Alhaji Muhammad Sa'ad Abubakar III; Catholic Bishop of the Diocese of Sokoto, Matthew Kukah, and others has trailed the gruesome murder of a student of Shehu Shagari College of Education (SSCOE) in Sokoto State, by religious zealots over alleged blasphemy.

Yakubu Deborah who Samuel, was a 200-level Home Economics student, was mauled, killed and burnt on Thursday by a mob that accused her of blasphemy on social media against Prophet Muhammad. Videos showing how the student was stoned, beaten with sticks and subsequently set ablaze were circulated on social media.

Reacting to the unfortunate incident, the Sultan of Sokoto in a statement by the Sultanate Council, condemned the actions of the mob and called on security agencies to immediately bring the murderers to book.

"The Sultanate Council has learned with dismay the unfortunate happenings at the Shehu Shagari College of Education, (SSCOE) Sokoto that led to the loss of life of a female student of the Institution.

"The Sultanate Council condemned the incident in its totality and has urged the security agencies to bring perpetrators of the unjustifiable incident to justice

"The Sultanate Council has urged all to remain calm and ensure peaceful co-existence among all people of the state and nation," the statement said.

Father Kukah in a statement described the actions of the mob as criminal and tasked authorities at all levels to fish out the perpetrators and ensure justice is served on the matter.

In a statement titled 'Murder of Ms Deborah Yakubu," the revered cleric said the perpetrators no matter their motive must be punished.

Ĥe said: "We condemn

this incident in the strongest terms and call on the authorities to investigate this tragedy and ensure that all the culprits are brought to book.

"The only obligation that is owed her immediate family, her fellow students, and the school authorities is the assurance that those who are guilty of this inhuman act, no matter their motivation, are punished according to the extant laws of our land.

"This has nothing to do with religion. Christians have lived peacefully with their Muslim brothers here in Sokoto over the years.

"This matter must be treated as a criminal act and the law must take its cause," the statement said partly."

Governor of Sokoto, Aminu Waziri Tambuwal, announced the immediate closure of the institution while directing the Ministry of Education in the State and the Police to immediately investigate the cause of the incident.

This was contained in a statement signed by the State's Commissioner for Information, Alhaji Isah Bajini Galadanci.

The statement reads: "It has come to the notice of the Sokoto State Government, the unfortunate incident that took place at the Shehu Shagari College of Education (SSCOE), Sokoto, in which a student of the college lost her life.

"The government has ordered the immediate closure of the college.

"Already, the State Governor, Rt. Honourable Aminu Waziri Tambuwal has directed the Ministry of Higher Education, and relevant security agencies in the state to commence investigations into the remote and immediate causes of the incident and report back to the government."

However, the police in Sokoto said two suspects have been arrested in connection with the murder of the student.

A statement by Sanusi Abubakar, spokesman of the Sokoto Police Command, said operatives have been deployed to the area.

"At about 0900hrs, a distress call was received from Shehu Shagari College of Education, Sokoto, stating that students were rioting over one female student named Deborah Samuel, a level two student, who was accused

of making a social media post that blasphemed the holy prophet Muhammad (SAW).

"Students forcefully removed the victim from the security room where she was hidden by the school authorities, killed her, and burnt the building.

"The students banded together with miscreants and barricaded the Sokoto/ Jega road.

"Upon receiving the information, the DC Operations led a team of policemen and all other operational commanders in the state to the school where the road was cleared and the situation was brought under control.

"Two students were arrested in connection with the crime committed.

"The school has been closed down by the school authority, and policemen were deployed to give tight security coverage.

"The Commissioner of Police, Sokoto State Command, CP Kamaldeen Kola Okunlola fdc, mnim, is appealing to members of the public to go about their lawful activities and should not panic as the situation is under control.

"Meanwhile, the suspects in the viral video on Twitter were spotted and will be nailed soon."

Following the ugly incident, a Senior Advocate of Nigeria and human rights activist, Ebun-Olu Adegboruwa, has called for the relocation of the 2022 Annual Summit of the Nigerian Bar Association Section on Public Interest and Development Law (NBA-SPIDEL) scheduled to hold in Sokoto State from the 22nd to 26th of May, 2022.

According to learned silk, the murder of the female student is barbaric and lawyers must not be seen to converge on her grave.

He wrote: "I humbly urge NBA-SPIDEL not to hold any meeting or conference in the State where a Nigerian citizen has been brutally murdered and burnt to death.

"It is barbaric and lawyers should not be seen to be dancing on her grave in that State.

"We should make a statement to the government by cancelling the Conference and hold it in a neighbouring State in the North."

Meanwhile, Neo-Black Movement (NBM) of Africa has strongly condemned the "inhuman and unwarranted" slaying of Miss Deborah Yakubu Samuel.

NBM noted that the barbaric act has needlessly raised religious tension in the country. The lynching of Deborah is unacceptable; despite her alleged flaws, NBM stressed

It added: "NBM of Africa as a Pan- African organization driven by a passion for humanity is saddened and shocked over the gruesome act of religious intolerance at Shehu Shagari College intolerance at of Education in Sokoto State, Nigeria," according to a statement by the movement's spokesman, Mr. Oluwatosin Dixon. "NBM is a non-religious organization; a home to members from all religions. It has overtime stressed the need for African people and humanity in general to foster religious tolerance, accommodate disparities the among faiths and exhort religions to unity and full freedom of Africa as our home and humanity as our family

"NBM of Africa believes that Islam is a religion of peace and has over the years lauded the peaceful endeavours of wellmeaning Muslims. It is really saddening that some individuals will engage in such act under the guise of religion. "NBM of Africa believes that everyone is interrelated and as such we are brothers and sisters. We, therefore, need to grow our bond as a family and not destroy it.

NBM of Africa condoles with the families of the deceased and pray that she rests in peace. We also reiterate that Humanity is our watchword and we will relentless walk this path."

"We also implore the the law enforcement agents to bring the perpetrators of this devilish act to face the wrath of the law."

President Muhammadu Buhari on Friday finally reacted to the gruesome murder of Miss Deborah Samuel, a second year Home Economics student of the Shehu Shagari College of Education, Sokoto by fundamentalists on Thursday.

Though Buhari condemned the killing, he nonetheless urged religious and community leaders to call citizens' attention to the need to exercise the right to freedom of speech responsibly.

Buhari reacted through a series of tweets titled: State House Press Release: President Buhari reacts to Sokoto Killing linked to alleged blasphemy, says violence does not solve problems."

The statement which came through the official Federal Government Twitter handle, Presidency Nigeria @NGRPresident, "President reads: MBuhari strongly condemns the resort to selfhelp by the mob in sokoto, resulting in violence, destruction and killing of a second year student of Shehu Shagari College Education, Sokoto, of Deborah Samuel.

"President Buhari said the news of the killing of the young lady by fellow students was a matter of concern and demanded an impartial, extensive probe into all that happened before and during the incident.

"The President noted that Muslims all over the world demand respect for the Holy Prophets, incl Isah (Alaihissalaam, Jesus Christ) & Muhammad (SAW) but where transgressions occur, as alleged to be the case in this instance, the law does not allow anyone take matters into their hands.

"Moreover, religious leaders preach that it is not for the believer to judge the actions of another person. The constituted authority must be allowed to deal with such matters when they arise.

"No person has the right to take the law in his or her own hands in this country. Violence has and never will solve any problem," said the President.

Buhari also directed the Ministries of Information Culture, and Police that of Affairs and Communications and Digital Economy to work with GSM providers and Tech companies to help contain the spread of false and inflammatory information through social media.

"The President extended the nation's condolences to the family of the deceased student and wished all those injured a quick recovery. He commended the immediate response to the incident by the Sokoto State Government and urged religious and community leaders to call citizens' attention to the need to exercise the right to freedom of speech responsibly," the statement further read.

"President Buhari called for tempered comments by the media and calm among the general population while investigation is ongoing to find out the remote and immediate causes of the incident."

Bishop Korie said such Presidential aspirants that refused to condemn the action of the mob should not be entrusted with the affairs of the nation.

Chairman of the Southern branch of the Christian Association of Nigeria (CAN), and National Vice President, South-East Pentecostal Fellowship of (PFN), Bishop of Nigeria Maxwell Korie, has urged voters to shun presidential aspirants who have "cowardly" refused to make statements condemning the killing of Deborah Samuel.

### Crisis brews in Taraba State communities over plans to upgrade villages, create additional districts

To however avert the crisis, the people have called for the immediate deployment of more soldiers to some of the council's communities that are prone to the crisis.

They were led by a member of the Ichen Kurmi kingdom in Bissaula community, Fhatso T.N Tukura. The call, if urgently adhered to, they believed would go a long way to halt the outbreak of skirmishes in both Bissaula and Sunkuru communities.

The ongoing plans by the state government to upgrade villages to districts and create three additional districts in Ichen and Ndola Chiefdoms in the council was observed to have been the reason behind the ongoing tension in the area.

Several lives and properties, it would be recalled, were



recently destroyed in the council following an outbreak of clashes that occurred early this year.

Believing that the government can track down the "instigators of instability in the area" the need for the authority to call the council chairman, Ammamzalla John to order, they believed would as well assist in curtailing the situation.

The people who said they "recognized and applaud Governor Darius Dickson Ishaku, for his tireless efforts in ensuring permanent peace throughout the state, particularly in areas where restiveness has been reported" expressed sadness that despite the establishment of a Commission of Inquiry to determine the remote and immediate causes of the dispute, the chairman is going about igniting dust.

"The genuine extent to which the government has reached out to resolve and ensure lasting peace as a result of the regrettable conflict between the Ichen and Ndaka in Bissaula, including the establishment of a Commission of Inquiry to determine the remote and immediate causes of the dispute they said, " is welcome and appreciated."

Wondering why the council chairman, should go as far as sending a memo to the state government requesting the upgrading of fifteen (15) village areas to districts and the creation of three (3) additional districts in the Ichen and Ndola Chiefdoms, the need for the government to discard such request to avert upheavals, they said has become necessary.

The chairman's action, as stated by the community "is very upsetting to all wellintentioned people who want permanent peace in Bissaula town between the Ichen and Ndaka people."

While calling on the people to embrace peace in the "interest of reconciliation" outsiders who "care little or nothing about our shared existence in terms of language, interpersonal relationships, and interethnic marriages" as opined by them "should be viewed as common foes rather than friends."

### Police arrest three bandits, rescue 15 kidnapped victims

Niger State Command of the Nigeria Police Force (NPF) has arrested three suspected bandits and rescued 15 kidnapped victims at Agigi/Kpashimi forest via Lapai LGA of the State.

This was contained in a press statement by the Public Relations Officer of the State, DSP Wasiu Abiodun, on Friday. Adding that the suspects were arrested after being overpowered in a gun duel with the tactical team of the Police.

Abiodun gave the names of the suspects as Aliyu Mohammed Dauda aged 19yrs, Wada Usman Shehu aged 20yrs and Mohammed Shehu Abubakar aged 19yrs. He said, "Sequel to the ongoing onslaught against banditry and other criminality in the state, on 11/05/2022 at about 1330hrs, information was received that suspected armed bandits were sighted at Agigi/ Kpashimi forest via Lapai LGA.

"Police tactical team attached to Lapai Division with vigilante members were mobilized to the area where the bandits were engaged in a gun duel and overpowered by the tactical team, while some of the hoodlums escaped into the forest with bullet injuries.

"Consequently, three suspects among the bandits were arrested, and fifteen victims abducted by the hoodlums were rescued from the forest. The suspects arrested are: Aliyu Mohammed Dauda aged 19yrs, Wada Usman Shehu aged 20yrs, both 'm' of Maikunkele and Mohammed Shehu Abubakar aged 19yrs 'm' of Mayaki village, Lapai

"Two burnt motorcycles were equally recovered from their camp. However, the case is under investigation as an effort is ongoing to apprehend other members of the gang. Suspects will be arraigned in court after the investigation."

In another development, the police repelled an attempt by armed bandits to invade Maraban Dan-Daudu and Jiko villages through Gwada, Shiroro LGA.

The Police alongside vigilante members reportedly engaged the bandits in a gun duel for hours, thereby forcing them (bandits) to escape into the bushes with bullet wounds. "Similarly, on 12/05/2022 at about 0930hrs, armed bandits attempted to invade Maraban Dan-Daudu and Jiko villages via Gwada, Shiroro LGA.

"Joint security team deployed to the area, with vigilante members responded and engaged the bandits in gun duel which lasted for hours.

"As a result of this, the bandits were repelled as most of the hoodlums escaped into the forest with bullet injuries after they suffered some casualties.

'The Commissioner of Police, Niger State Command CP Monday Bala Kuryas, fsi commended the efforts of the tactical teams and urged them to sustain the momentum towards curtailing banditry in the state," Abiodun added.

### Councillor arrested for allegedly supplying arms to bandits in Kaduna

Kaduna State Police Command has arrested a serving councillor for allegedly being in possession of an AK-47 rifle in the Giwa Local Government Area of the state.

The suspect, Abdulrahman Adamu, who is a serving councillor in the Soba Local Government Area of Kaduna State, was arrested by the operatives of Operation Puff Adder II attached to the Kaduna Police Command during a routine patrol along Galadimawa Road.

According to a statement by the spokesman of the command, Mohammed Jalige, the police officers succeeded in intercepting the councillor, who was moving in a black Lifan motorcycle towards the Galadimawa community with a sack. The policemen at that

point became suspicious

of the sack being carried by the suspect and were prompted to search its content. It was in this process that they discovered an AK-47 rifle loaded with six rounds of 7.62 X 39mm live ammunition concealed inside the sack.

The police spokesman further revealed that the suspect was arrested and taken into custody alongside the exhibits while preliminary investigation reveals the identity of the suspect, Abdulrahman Adamu, as a serving member in the legislative council of Soba Local Government Area of Kaduna State representing Kinkiba ward.

The suspect equally confessed to having gotten the firearm from his accomplices, adding that he was to deliver same to bandits around Galadimawa village for their nefarious activities.

**CONTINUED FROM PAGE 2** As at the time of filing this report, former Senate President Anyim Pius Anyim is the only one of all the 2023 presidential aspirants that has publicly condemned the gruesome murder of the 200-level student of the Shehu Shagari College of Education.

In a statement he personally signed earlier in the day, Senator Anyim decried the killing of Miss Deborah Yakubu as cruel, illegal, callous and inhuman.

The former Secretary to the Government of the Federation (SGF) and frontline presidential aspirant on the platform of the Peoples Democratic Party (PDP) insisted that "there is no place in a modern Democracy such as Nigeria for jungle justice and killing of human beings illegally."

According to Anyim, "Miss Deborah Yakubu deserved to have been put through the full process of the law which has adequate punishment for all offences including the one she was accused of. We cannot afford now to add religious intolerance to the plethora of problems bedeviling our country."

Former Vice President Atiku Abubakar had earlier condemned the killing of the Christian female student and even commiserated with her family, only to delete the message on all his social media handles in what appears to be an attempt not to offend extremists.

Vice President Yemi Osinbajo, former Lagos Governor Bola State Tinubu, former Anambra State Governor Peter Obi. Rivers State Governor Nyesom Wike, Kogi State Governor Yahaya Bello and other presidential hopefuls have kept sealed lips despite the outrage that greeted the murder of the female student.

Bishop Korie, during a one-day Minister's Conference in Ebonyi, said such Presidential aspirants that refused to condemn the action of the mob should not be entrusted with the affairs of the nation.

Bishop Korie said: "We are keeping track of the responses of the Presidential candidates. If any of them is such a coward, that he refuses to make an appropriate statement about this, we now know that we should not entrust the affairs of the country into such a hand."

Bishop Korie added: "To the Federal Government, we are saying that we don't just want to hear statements of condemnations about what has happened, we want to hear statements of definite actions of the federal government to bring justice over this matter.

"All the people involved must be given the appropriate punishment according to the laws of the land. It is a case of wicked murder. It's not manslaughter.

"They moved against her with a deliberate intention to get her eliminated. So it is not a case of manslaughter," he said.

Bishop Korie said the Christian body would work against any move by either the Peoples Democratic Party (PDP) or the All Progressives Congress (APC) to field Moslem, Moslem candidate in the 2023 presidential election.

"As we prepare for election in 2023, Pentecostal the Fellowship of Nigeria, PFN, which is the umbrella Association for all Pentecostal and Charismatic Churches in Nigeria is making an emphatic statement that any political party that fields Moslem-Moslem candidates for the presidential election, we will work against their candidate succeeding.

"That is, by withholding our votes from them and in order to punish them for such plunder, we will make sure that all their candidates from the State House of Assembly upwards will lose our votes.

"If you dare it, our reactions begin from the State House of Assembly election.

"We are calling on all well-meaning Nigerians, including Moslems who have a sense of equity, justice and fairness to fall in line with us to ensure that this absurdity is not associated with any of the two major political parties in Nigeria, APC and PDP," the PFN leader added.

#### Ngige withdraws from presidential race

Minister of Labour and Employment, Sen Chris Ngige has withdrawn from the 2023 presidential election.

The political conundrum in the Niger Delta, nay Rivers State, is taking a different dimension ahead of 2023 general election. The riverine extraction in Rivers State populated by the Ijaw speaking people appears to be taking their agitation for power balancing in the power equation in the state to another level.

This time, the agitation is being amplified by the mainstream leaderships of Ijaw ethnic nationality, the Ijaw National Congress, (INC) and the Ijaw Youths Council, (IYC).

Some analysts say that since Wike assumed the mantle of leadership as the governor, the riverine Ijaws have not been very comfortable with the administration, even though they are eminently represented in the cabinet.

The deputy governor is from the riverine, so is the Secretary to Government, the State Accountant General and other commissioners and appointees.

In 2015, Wike contested against an Ijaw man, Dr Adol. Dakuku Peterside. In 2019, another Ijaw man squared up against him, Arch. Tonye Cole, even though he was eventually disqualified before the election following Supreme Court judgment.

But Awara of AAC who got the backing of All Progressives Congress (APC) supporters to confront Wike following Cole's disqualification is also an Ijaw man. He almost became an albatross to Wike.

These are all lost opportunities by the riverine people or Ijaws to taste power domiciled in Brick House, Rivers Government House. They are still fighting to realize this somewhat life aspiration.

This may explain why more than 70 percent of the governorship aspirants for the 2023 election in the state across all parties are from the riverine Ijaws. They appear to be battle-ready this time and the state chapter of APC (Amaechi faction) is dancing to the 'melodious makosa' of the riverine Ijaws by zoning its governorship ticket to that part of the state.

Wike and the leadership of PDP on the other hand are still holding the state in suspense. But the riverine Ijaws are agitating that right of first refusal should be accorded them in finally deciding where the pendulum should be headed. Even so, they do not completely trust Wike.

Among the Ijaw sons in PDP who took up the gauntlet and purchased the Expression of Interest and Nomination forms for the position of governor is Dr Farah Dagogo who represents Degema/Bonny Federal Constituency in the House of Representatives.

Along the line, however, Farah's exuberance clashed with Wike's overbearing attitude.

While the screening of aspirants for the state and national assembly elections were ongoing at the state headquarters of PDP along Aba Road in Port Harcourt, Dagogo apparently feeling that those in charge might not be doing the right thing, led some young men, the state government called hoodlums and cultists, to disrupt the exercise. The action drew the ire of Wike who bared his fangs and declared Dagogo wanted. He further directed the police authorities in the state to arrest Dagogo.

Dagogo was subsequently arrested by the police and charged to court on two counts charges of felony and cultism at a magistrate court.

He has remained in incarceration for more than two weeks, prompting a clamour for his release by mostly people from the riverine extraction and members of the vocal opposition

in the state.

The leadership of the Ijaw National Congress, (INC) had joined their voices to the clamour for Dagogo's unconditional release and issued a 48-hour ultimatum to Wike to effect the release of their 'son'. But it appeared they just touched the tail of a lion!

Wike waited for them till last Sunday at St. Paul's Anglican Church, Diobu in Port Harcourt, at the Thanksgiving service to mark the victory of Rivers State in the disputed 17 oil wells between the state and Imo State.

There Wike lashed at the leadership of INC for daring to give him a 48-hour ultimatum to release Dagogo. The governor's choice of words against the leaders of Ijaw nation was considered too caustic by some observers who condemned the governor's outbursts.

As would be expected, the two umbrella leadership bodies of the Ijaw nation, the IYC and the INC were very vociferous in their condemnation of Wike's vituperations against the leadership of INC. The governor was quoted to have used the expression; "Thunder fire you" while reacting to the ultimatum by INC to release Dagogo.

Rising in defence of the Ijaw course, the Ijaw Youth Council (IYC) in a statement said the derogatory use of "Thunder Fire You" by the Rivers Governor on the Ijaw people is "disturbing, inciting and denigrating" of the high office he occupies.

The National Spokesman of IYC who signed the statement, Comrade Ebilade Ekerefe, noted that such "tactless and disrespectful" comment by Governor Wike was the height of his prolonged disdain for the Ijaw nation as a whole and Rivers Ijaw people in particular since he became governor of the state.

"It is even more shocking that the Rivers Governor took his unrestrained verbiage to the hallowed pulpit of a church and desecrated the altar of God.

"The IYC restates that its only 'sin' that attracted Wike's ire was its demand alongside its parent organ, the Ijaw National Congress (INC), for the release of an Ijaw son, Hon. Farah Dagogo that was arrested and remanded in prison on the orders of the Rivers governor."

The IYC pointed out that "despite being the fourth largest ethnic nationality in Nigeria and the largest in the Niger Delta, the Ijaws have consistently promoted peaceful and harmonious relationships with other ethnic groups, including Wike's Ikwerre nationality in Rivers State.

"However, Wike should be reminded that

such unguarded and incendiary comments are capable of rupturing the existing good relationship with the Ikwerres, and his kinsmen are advised to call him to order.

"The IYC also reminds Governor Wike that power is transient and that by May 29, 2023, he will vacate the exalted governorship seat, which he has equally ridiculed, to become an ordinary citizen like others in Rivers State and Nigeria."

The statement further said that Wike had forgotten that by calling fire and thunder on the Ijaw nation, his benefactor and the revered leader, former President Goodluck Jonathan, is also an illustrious Ijaw son.

"This 'thunder' did not fire the former president when, despite all odds, he made him the choice of the Peoples Democratic Party in Rivers State against the wishes of other competent Ijaw aspirants in the state.

"Now, Jonathan as an Ijaw man is also under fire from Governor Wike. For him, all those that made him, including the people of Rivers State, are in his pocket and can be insulted at will.

"We, therefore, call on our people as a whole to see Governor Wike as an enemy of the Ijaw Nation. We urge Ijaws all over the world to speak against this tyrannical behaviour of Wike," IYC demanded.

The group called on all their Ijaw brothers that are delegates in the PDP not to cast their votes for Governor Wike during the presidential primaries.

"Suffice it to say that if a governor can cast aspersion on an entire ethnic nationality, what would become of him as president of the most populous black nation on the planet?" the youth body reasoned.

Shortly after the IYC reaction, the INC marshalled its own arsenal against Wike, announcing the withdrawal of their guaranteed support for Wike's presidential aspiration in 2023

The INC, in a statement issued by the member of its National Representative Council (NRC), Elder Christopher Abarowei, called on politicians who had declared support for Governor Wike's Presidential ambition to withdraw their support until he tenders an unreserved apology to the leadership of INC and IYC and the entire Ijaw nation.

According to Abarowei, the office of the Governor of a state and President is supposed to be occupied by persons who are considered by those who voted them into office in the first place as being among the best in terms of their ability to manage success.

He said "There is a popular saying that you know a person better when you give him power. Governor Nyesom Wike has disappointed those who helped him to be Governor as he has turned himself into a complete public nuisance with the way and manner he quickly insults people at the least provocation.

"This drift into uncivilized and uncouth adventure by a state Governor is in our opinion unacceptable, undeserving and out rightly condemnable. The recent outburst in a church of all places by Governor Wike against the Ijaw National Congress (INC) and the Ijaw Youth Council (IYC) is a clear case of a man whose mental state has to be interrogated.

"It is highly unacceptable for a man occupying the most exalted position of Governor of Rivers State to use derogatory words like 'THUNDER FIRE YOU' in a church that is supposed to be inhabited by decent people and respected workers in the Lord's vineyard. This is a clear indication that the Governor lacks the moral compass to manage a state not to talk of his delusional attempt to occupy the most exalted position in Nigeria."

Abarowei wondered how Wike will feel to ask for the votes of delegates of Ijaw extraction from Edo, Rivers and Delta States who according to him, Wike wants thunder to fire.

"Governor Wike should better still allow his aides to do what he is shamelessly doing now as the job of an attack dog does not in any way fit into the job description of a state Governor.

"We wonder how comfortable this Governor is with him having issues with almost everything around him except his over-bloated ego. There is a popular rule in boxing that requires a boxer with the longer reach and height to come down to the level of a shorter opponent to hit his target. In the process, the shorter man has an advantage to hit the face of the taller opponent with ease. Wike should be knowledgeable enough to know that using gutter languages will force weaker opponents to dive into the gutters with him.

Abarowei insisted that "No Governor of Ijaw extraction has ever insulted the Ikwerres the way Wike has thrown caution to the wind and insult Ijaws at random and we want him to come down from his high horse and build some moral decency and desist forthwith from insulting Ijaw people as his becoming a Governor today is a function of some Ijaw persons lifting his head, legs and hands. His fellow Ikwerre brother, Rotimi Amaechi, would have crushed him without the support of the Ijaws.

"It will be insulting to ask Wike to render an apology to the leadership of INC and IYC as we see moral bankruptcy written all over Wike but he should know his stay as Governor with all the advantages working for him has a term which is eight years at most which come to an end just a year away while the Ijaw Nation is termless.

It remains to be seen what would happen in the days ahead. Would Wike call the bluff of the Ijaws and stick to his gun? The governor has one respected Ijaw man who has been supporting his administration all the way, Chief Ferdinand Alabraba. Wike holds this man in great esteem, just as the man is highly respected among his people.

Would Alabraba wade into the anti-Wike sentiment spreading fast among his people and swing a ceasefire? Or has he also been caught off-guard by the Wike 'Thunder'? Analysts believe Alabraba is unlikely to abandon Wike at this "critical" time.

" I joined the race because of my concern for the people, especially my fellow youths who deserve a better future."

He, therefore, called upon the youths to

# How next Alaafin of Oyo will emerge

Hamidi Adeyemi, joined his ancestors on the 23rd of April 2022 at the age of 83 years.

It's customary for him to be mourned over a period of time. Within the period of mourning, the ruling house that will produce the next Alaafin, is expected to put finishing touches on preparations to present to the Oyo Mesi, the traditional kingmakers, the Alaafin designate, for consideration.

So fierce is this process, that before the demise of Adeyemi, the immediate past Alaafin of Oyo, there were numerous speculations, about how a successor to the throne of Alaafin of Oyo will emerge.

So much talk about the calibre of persons who will succeed Alaafin and the criteria for his selection.

The late Oba Adeyemi succeeded Alaafin Gbadegesin Ladigbolu in 1970, and after 52 years on the throne, civilisation has greatly influenced the tradition and culture of the ancient Oyo Kingdom.

There has been a change in the number of Oyo Mesi, the prominent palace chiefs, who are the kingmakers.

But despite these changes, the existing chieftaincy declaration still serves as a guide for the selection of Oyo kings.

#### TWO RULING HOUSES

The declaration states that there are two royal houses in Oyo - Alowolodu and Agunloye. The two families are to take turns ascending the throne.

The late Alaafin was from the Alowolodu royal family, so it is now the turn of the Agunloye family.

The Agunloye family is also known as 'Ladigbolu' or 'Gbadegesin' in some quarters

#### ANY DIFFERENCE BETWEEN LADIGBOLU AND GBADEGESIN?

After the demise of Oba Adeyemi, a debate began on which family will present the next king between Ladigbolu and Gbadegesin.

Clarifying the confusion over the names, Ayo Ladigbolu, a retired Archbishop of the Methodist Church and a prominent elder of the Ladigbolu family, said they are one family under Agunloye royal house.

He said: "The late Alaafin Gbadegesin was the son of Alaafin Ladigbolu. The full title was Oba Bello Gbadegesin Ladigbolu (11).

"His father was the first and the next from the family will be the Third."

HOW IS THE SUCCESSOR

#### **NOMINATED?**

Based on the chieftaincy declaration, the ruling house that is to produce the next king, in this case, the Agunloye ruling house, will nominate candidates at a meeting which will be summoned by the head of that family.

The candidate or candidates will then be presented to Baba Iyaji, a titled Prince of Oyo, who will subsequently submit the names to the Bashorun, head of the kingmakers known as Oyo Mesi.

The Bashorun will then summon a meeting of the kingmakers and present the list to them.

Explaining further, Ladigbolu said the candidate acceptable to the majority of the kingmakers will thereafter be proclaimed as the Alaafin designate.

### WHO ARE THE KINGMAKERS?

Ladigbolu said, apart from the Oyo state government declaration, which guides the selection of Alaafin of Oyo, the Oyo Mesi (kingmakers) will have the final say on this matter.

Although seven kingmakers

were once recognised, the numbers have dwindled with the nullification of one of the kingmakers.

"These seven kingmakers according to the declaration are, Bashorun, Ashipa, Agabaakin, Alapinni, Lagunna, Shamu and Akiniku," Ladigbolu stated.

"The title of Ashipa was the one that was nullified, and as such, it no longer exists. As we speak, only six kingmakers are remaining as members of the Oyo Mesi."

#### ONLY MALES MAY BE PROPOSED

According to Ladigbolu, women are exempted from being considered for the throne of Alaafin of Oyo.

"The chieftaincy of Oyo has an official declaration. It was made under section four, sub-section two of the Chiefs law cap 19 of the customary law regulating the selection of the Alaafin of Oyo chieftaincy.

"The person who may be proposed as a candidate shall be through the male line only."

NO SPECIFIC TIME-FRAME There is no specific time frame for the selection of the next king

of Oyo because it all depends on those who run the process, says Ladigbolu.

Although the family will be given 14 days to hold a meeting and submit a list to Baba Iyaji, if the list contains more than one name, the process will take a longer time.

"The kingmakers may have to interview the individuals presented before taking a decision. The selection of Oba Lamidi Adeyemi took a bit longer because of the political atmosphere then," he said. "There was a lot of tension

"There was a lot of tension and litigation so it was not a smooth process then.

"We pray that this time, there will not be a delay just as His Excellency, Governor Seyi Makinde, the governor of Oyo State, appealed to the kingmakers to be quick about the process."

#### TOO EARLY TO MEET

Does the Agunloye (Ladigbolu/ Gbadegesin) family already have preferred candidates for the kingmakers? Ladigbolu said it is too early to start considerations.

He said "It will be irresponsible to begin the process when the town is still mourning the passage of Alaafin Adeyemi. "I am from the Agunloye ruling family but it is too early to meet. This is a mourning period because we just lost a king. I have been busy since Alaafin died and it will continue till after the eighth day," said the retired cleric.

#### ALL COMERS AFFAIR

In selecting the next Alaafin, the law does not specify age, educational background, knowledge of the tradition and culture of Oyo or personal wealth as criteria.

All males of the Agunloye are qualified to come forward and signify their intention to become the next Alaafin.

### WILL THE NEXT KING USE LATE ALAAFIN'S PALACE?

According to Ladigbolu, the present palace was not the property of the late king. He said "it is the traditional seat of the Oyo royal throne and all kings reign from there, except when it is under renovation or reconstruction.

"Alaafin means the owner of the PALACE. Oranyan was the first owner of that palace. The Palace is where the King resides," he remarked.

# 'In wake of NDLEA's synergy with **military, drug cartels in trouble'** Navy boosts agency's operations with boats, other equipment

hairman/ Chief Executive Officer of the National Drug Law Enforcement Agency (NDLEA), Mohamed Brig-Gen Buba Marwa (Rtd) has said that the ongoing synergy between the anti-narcotic agency and other stakeholders especially the military means trouble for drug cartels and spells doom for their activities in the country.

Marwa stated this on Thursday while receiving two epenal boats and other operational equipment the Nigerian from Navy at the Western Naval Command headquarters, Apapa Lagos. He described the gesture as symbolic and the beginning of an era of stronger ties between both institutions.

"The Agency is determined to cripple the activities of drug cartels on every front. We do not doubt that the combination of naval and narcotics

strategies will spell doom for drug barons in the coming days. NDLEA will continue to partner with relevant stakeholders as we tighten the noose on drug criminals," he declared.

The NDLEA boss, who was represented by the Agencv's Director of Seaports Operations, DCGN Faboyede, Omolade further stated, "I am particularly pleased with the prompt response to my request for material that could help to strengthen the Marine Unit of NDLEA as part of a sweeping effort to protect Nigerian waters from the trafficking of illicit drug substances. The synergy between the Navy and NDLEA, as exemplified by ceremony, is a this testament that we are winning the drug war on the waterfront with the broad goal of preventing drug cartels from smuggling into narcotics our country through airports, land borders, and seaports.

"We have come to a point where security organisations can no longer afford to work in silos. Illicit drug trafficking, as a transnational organised crime, requires deployment of the intelligence and closeknit collaboration with key stakeholders like the Nigerian Navy and other security organisations. In our effort to stem the tide of narcotic drugs, we have gone the extra mile and that includes the pursuit of synergy with organisations in

the security sector.

"And so far, our efforts in one year showed that the strategy is effective. In 2021, we recorded the arrest of more than 12,300 suspected drug offenders, including seven drug barons with 1,400 drug traffickers jailed. We were able also to counsel and rehabilitate 8,000 drug users and in the same period, also, we mopped up over 3.4 million kilograms assorted drugs. of Interestingly, drugs and illicit proceeds

of drug crime worth N130 billion were successfully recovered.

"This year equally started on an excellent footing. We broke our first quarter operational record with the arrest of over 3,539 suspected traffickers drug (including rogue security personnel and a well-known billionaire baron) and the seizure of more than 65,916 kilograms of drugs."

While thanking the Chief of Defence Staff, Gen Lucky Irabor, and other service chiefs for

supporting the nation's drug war, Marwa expressed confidence that the partnership with the Nigerian Navy will produce more outstanding results in the country's fight against narcotic drugs and psychotropic substances.

He expressed appreciation to the Nigerian Navy led by Rear Admiral Awwal Zubairu Gambo, adding that "I would like to close with the words of Helen Keller: Alone we can do so little. Together we can do so much."

Earlier in his remarks, the CNS Vice Admiral Gambo, who was represented by the Ag. Flag Officer, Western Naval Command, Rear Admiral HUF Kaoje, said the support for NDLEA was to enhance its efforts to fight the drug scourge and boost its capability to curb illicit drug activities on the waterways.

The Naval chief expressed determination to continue to support the Agency as a major stakeholder in national development.

The furore which it generated must have alarmed the lady. A few days later, she claimed in a remorseful manner that the dog-sex claim was a stunt to gain followers. The debate which followed suggests that bestiality is a widespread practice these days. The viral video therefore is a slice of our now degenerated lives that is mirrored by the social media. It is a comment on the degeneration on our core values. It reflects failed socializations at family, school, and religious levels.

The question is what triggers bestiality? The answer could be found in mankind's penchant for the abnormal, especially by a small minority. On his way to Damascus to carry out more persecution, Jesus Christ met him; for this was said of Saul by Ananias, "Lord, I have heard from many about this man, how much evil he has done to the saints at Jerusalem..." (Acts 9:13). But the message of Jesus was that: "Go, for he [Saul/Paul] is a chosen instrument of mine to carry my name before the Gentiles and kings and the sons of Israel; for I will show him how much he must suffer for the sake of my name" (Acts 9:15-16). The pain that Christians undergo in

The pain that Christians undergo in this part of eternity is always a precursor to the eternal joy awaiting all believers. The Bible calls such believers *overcomers*. Precursor simply means "something that exists before something else, and is related to it or it influences its development." The righteous man is likened to a "tree planted by the water" (Psalm 1:3). The precursor of such a tree is different from that of other wild trees without planters that grow accidentally. The planter must have selected a seed, chosen the *place/land* to sow the seed; he would have *cared/nurtured* the seed. On its own, the seed must be a good seed with the full potential to grow; when planted; it is bound to undergo the biological processes of growth/reproduction; it will die, germinate, etc., until it will begin to bear its own fruit. This process is itself quite challenging and could be painful for both the tree and the planter. But the Bible calls the end product blessed! (Psalm 1:1)

Underlying every form of Joy, be it graduation, housewarming, business successes, etc. is some form of toil as its basis, foundation or precursor. Nothing comes out of nothing. No cross! No Crown!! And our Lord Jesus Christ tells us, "A woman; when she is in labour, has sorrow because her hour has come; but as soon as she has given birth to the child, she no longer remembers the anguish, for joy that a human being has been born into the world" (John 16:21). Here, we see that underlying the anguish of birth is joy.

The "pain" and "anguish" we are talking about is not the same as evil. Evil is outrightly bad; nothing good can be derived from evil. This pain refers to the labour, and the tireless efforts we put in

order to get the things we desire; in order to bring our desires into being. Indeed, the joy we expect to follow are efforts is enough driving force to make us put more effort. There is therefore power in human afflictions. Of late, an institution like the Nigerian Prison was rebranded as a "correctional facility". Be that as it may, prisons are not where people are kept to enjoy. They are places of isolation and punishment for crime with the hope that when freedom is restored the freed will live better and more fruitful lives.

Similarly, many people find the Christian life to be tortious and painful. A life of holiness is a life in which one would deny oneself some form of lifestyle. There are ways that are sinful and unrighteous. In 1 Corinthians 5:1-5, Paul tells the church that her ultimate goal is to *save the spirit of man*. "You are to deliver this man to Satan for the destruction of the flesh, that his spirit may be saved in the day of the Lord Jesus" (verse 5). The joy of all believers is that one day is the 'Day of the Lord Jesus.' What joy is the church of God seeking today? Ordinarily, the human earthly way is one of passion, and of the flesh. We want to

Ordinarily, the human earthly way is one of passion, and of the flesh. We want to pursue the money, wine and women of this world. Nobody enjoys an ascetic and hermetic lifestyle. We only need to walk down our streets in the early night – drinking joints. We only need to imagine what goes on in the various clubs, parties and social events. This is what some have called the Epicurean lifestyle.

But there is another way. It propels us to a more joyful relationship with Christ. There are two ways we can relate with Christ. One gives happiness. But this is worldly happiness. The other gives joy. This is eternal joy. Christ, Himself points this out to His disciples. [1] Earthly hap-piness with Jesus is the foundation of the eternal joy with Him. The disciples had this relationship while Christ was with them. As Christians, we are today enjoying it while in the church of God. It entails some pains and denials. It is the wilderness we must pass through to reach the promised land. In our relationship with Christ, we are called to love and holiness, and to partner with the Holy Spirit; as the precursor to eternal joy! (2) It is consequent upon our understanding of eternal joy that we may appreciate Jesus Christ's instruction to His disciples concerning the coming of the Holy Spirit; who will stand in His stead when He would no longer be with His own physically. In the Holy Spirit, His promise that He will be with believers at all times is fulfilled. "Most assuredly, I say to you that you will weep and lament, but the world will rejoice; and you will be sorrowful, but your sorry will be turned into joy" (John 16:20). Those who are not of Christ Jesus in this part of eternity may have their temporal moments of "rejoicing", but in Christ, while we may suffer, weep and lament, there will ultimately be permanent joy.

God in Christ Jesus is not oblivious of our sorrows and pains. But He assures us that we will trade our sorrows for joy. "Nevertheless I tell you the truth. It is to your advantage that I go away; for If I do not go away, the Helper will not come to you; but if I depart I will send Him to you" (John 16:7). May we find peace and joy among all who are truly the created, for there is only One Creator to Whom all lives belong. To Him be all power, praise, honour, glory and adoration.

# **2023:** Bakare throws hat into presidential race

The founder of Citadel Global Community Church (CGCC) popularly known as the Latter Rain Assembly in Lagos, Pastor Tunde Bakare is not at all a stranger to the country's rough and murky political terrain. In 2011, he was the vice-presidential

In 2011, he was the vice-presidential candidate to the then Retired General Muhammadu Buhari, who was the flag bearer of the Congress for Progressive Change, (CPC). At the end of that year's general election, General Buhari lost the presidential election to the ruling party, the Peoples Democratic Party, (PDP).

It would be recalled during former President Goodluck Jonathan's administration, Bakare who was the Convener of the Save Nigeria Group (SNG), gave Jonathan's administration a black eye in the poll that followed in 2015.

Surprisingly, as things became worst under the watch of Buhari, the man he was once his running mate could hardly speak or do anything to change the ugly situation in the country.

As expected, after his failed attempt with Buhari to secure the presidential ticket in 2011, Bakare returned to his church to shepherd his folks, who were enthusiastically waiting for him to return to the pulpit to water their souls.

Exactly 11 years after his first major attempt into partisan politics, Bakare has this time around, taken a full plunge into the murky waters of Nigeria politics. Will he swim ashore safely or sink? Are Nigerians ready for a man like him?

On Monday, May 9, 2022, Pastor Tunde Bakare in a speech entitled "A New Nigeria for Every Nigeria," gave an insight into the reasons why he wants to contest the country's highest office.

to contest the country's highest office. "Today, we converge on our nation's capital to collectively take a historic step towards the realisation of a possible Nigeria. When our founding patriots resolved to live as one nation under God, they had a dream of a Nigeria, whose diverse peoples would be knitted together though tribes and tongues may differ; a nation bound in freedom and peace, and a people united against the common enemies of poverty, corruption and insecurity; a Nigeria where the little boy in Abeokuta, where I was born and the Almajiri in Sokoto, where I lived as a child would find common ground in the quest for a future worth looking forward to; a Nigeria where the fisherman in Okpoama Kingdom in Bayelsa State, on whose creeks, I was once hosted like a brother, would find common purpose with the cattle owner in Kano, in whose city I have built enduring friendships; a Nigeria where the enterprising men and women of Onitsha, some with whom I have built businesses, would have the absolute liberty to build successful enterprises anywhere in the country; a Nigeria where the Christians of Jos and Southern Kaduna, several of whom I have sat with and prayed for in the search for justice and reconciliation, would live in peace and harmony with the Muslims in Jos and Northern Kaduna with whom I share a common Islamic history.

#### "The Realities of Nigerians

In the course of decades of diverse nation-building engagements with the Nigerian people across the nation, from representing individuals and businesses as a lawyer trained by Chief Gani Fawehinmi, GCON, SAN, and Chief Rotimi Williams, SAN, to building businesses across diverse sectors including manufacturing and aviation, from bearing the burdens of individuals and families and speaking truth to power as a Pastor, to improving healthcare delivery in communities and facilitating transformation in education outcomes, from leading reformatory civil society movements on the platform of the Save Nigeria Group (SNG) across the states of the federation and mediating in interethnic and communal clashes in some of Nigeria's conflict hotbeds, to campaigning as a vice-presidential candidate in the nooks and crannies of Nigeria, I have seen enough to realise that the Nigerian dream is not yet the reality of most Nigerians with whom I am forever conjoined far beyond the bond of geography.

"I can relate to the nine-year-old walking to and from the public tap every day to fetch sixty-four pails of water to make ends meet. I have been there, too. I stand here before you today mindful of the realities, but hopeful enough to offer myself as a bridge; a bridge connecting the dreams of our founding patriots to the highway of every Nigerian dream; the ones deferred and the ones you still wake up to each morning; a bridge between today's Nigeria and the one you know is possible. I stand here today to acknowledge that the realisation of my dreams was facilitated by Nigeria. I first saw the four walls of a classroom only because Nigeria footed the bill and asked me only to serve her with love, strength and faith in return. The bedrock for all I would become was laid by an inclusive free education policy that gave me a head start despite abject lack. Nigeria made many of the stories of my generation possible, so we cannot now in good conscience bequeath anything less than a New Nigeria in which every dream is possible.

"Twelve Years of Engaging the Government

The inadequacies of the Nigerian experience have kept propelling me to seek lasting solutions, and have led me from the grassroots to Aso Rock in my quest to be a reconciliatory bridge between what was, what is and what should be. With the utmost fidelity to truth and integrity, I have remained committed to engaging the government at the highest level. For President Goodluck Ebele Jonathan, not only did we mobilise Nigerians through the Save Nigeria Group (SNG) at a time of great confusion to ensure he became the substantive president of Nigeria, we also provided him with a framework to "Save and Transform Nigeria," worked with him on efforts to reengineer Nigeria's governance structure, and supported him through a difficult transition process in 2015.

## Aviation fuel crisis and survival of Nigeria's local airlines

Most sectors of the Nigerian economy have been grappling with various challenges in the last few years, leading to a situation where several firms and businesses either closed shops or relocated to other countries. Since the Russia and Ukraine war started in February, most sectors of the country's economy have been negatively affected. One of such sectors is the aviation sector. Recently, the Airline Operators of Nigeria (AON) announced its decision to suspend local flights due to the escalating price of aviation fuel (Jet A1) but shelved the move shortly afterwards. This followed the intervention of the House of Representatives, the Central Bank of Nigeria (CBN) and the Nigeria National Petroleum Corporation (NNPC) after the local airlines got what appeared like a lifeline. **JOHNMARK UKOKO**, in this analysis, probes if the lifeline for local airlines will provide the final solution to the challenges.

The Nigerian aviation sector and particularly the local airlines have had to grapple with various challenges, which had led to the bankruptcy of some local airlines and firms.

Some of the local airlines that once ruled the country's air space but have closed shops for various reasons are; Okada Air, ADC Airlines, Midwest Airline, Albarka Airline, Concord Airline and other local operators. Before the outbreak of the Russia and Ukraine war in February 2022 the surviving airlines were already contending with several challenges.

However, since the war, which has negatively affected the importation of petroleum products into the country and the increasing price of crude oil in the international market, the airline operators have been in disarray.

The current price of aviation fuel, otherwise called Jet A1 has constituted a major challenge to the local airline operators to the extent that on May 6, 2022, the airline operators addressed journalists and announced that from Monday, May 9, 2022, they will suspend their operations, due to the high cost of aviation fuel, which has risen to as much as N700 per litre.

Chairman and Chief Executive Officer of Air Peace, who doubles as Spokesman of AON, Allen Onyema, disclosed that prior to Russia's invasion of Ukraine, a litre of Jet A1 was sold for N190 per litre, but now sells for N700.

The AON disclosed that the local airlines concluded plans to suspend flights across the country, as it also advised the In the face of this challenge, the airlines travelling public, who intend to fly to make alternative arrangements to avoid being stranded at the country's airports.

"It is with great sense of responsibility and patriotism that the Airline Operators of Nigeria have continued to deploy and subsidise their services to the Nigerian flying public in the last four months despite the steady and astronomical hike in the price of Jet A1 and other operating costs.

"Over time, aviation fuel price has risen from N190 per litre to N700 currently. No airline in the world can absorb this kind

of sudden shock from such an astronomical rise over a short period. While aviation fuel is said to cost about 40 per cent of airlines operating cost globally, the present hike has shut up Nigeria's operating cost to about 95 per cent.

"In the face of this challenge, the airlines have engaged the Federal Government, the National Assembly, Nigerian National Petroleum Corporation (NNPC) and the oil marketers with a view to reducing the cost of Jet A1 without success," Onyema lamented.

But a few hours into the announcement, Ibom Air, Dana Airlines and Arik Airlines, among others, announced that they were not part of the AON's decision and would continue to operate despite the challenges.

Despite the division among members of the AON, Speaker of the House of Representatives, Femi Gbajabiamila, summoned the Governor of the Central Bank of Nigeria (CBN), Godwin Emefiele, Group Managing Director of NNPC, Mele Kyari and leadership of the AON to a meeting.

Gbajabiamila had announced the resolutions after about four hours of brainstorming that the House of Representatives' intervention culminated in a decision to mandate the CBN to provide aviation fuel at N480 in what seemed like a foreign exchange (Forex) subsidy, pending when the local airlines would

be granted licences to import the product.

'In the long-term, you can commence the process of applying for licences to import Jet A1. So that it will remove middlemen or whatever you know will be the landing cost to assist your business" he said.

Gbajabiamila said the House of Representatives and the Federal Government lamented the plight of the local airlines in the past few months, adding that the CBN had been asked to assist the troubled local airlines.

"The CBN Governor will provide six million litres of Jet A1 to the local airlines, as a matter of urgency. You will get an allocation in the next three months through the companies and marketers you have nominated

so that you would not say Jet A1 is now certain amount and it is no longer NNPC's fault. You have nominated the marketers that will sell the fuel to you," he stated.

He maintained that a longterm solution was for the local airline operators to commence the process of securing licences for the importation of aviation fuel to avoid suspicion over the landing cost of the product and other associated logistics issues.

Despite the House of Representatives' intervention to prevent the local airlines from suspending their operations, it is not yet time to rejoice, as one of the critical stakeholders to the survival of the troubled airline sector, the NNPC told the AON some home truth at the meeting.

Kyari told the meeting involving NNPC, CBN and AON at the behest of the Speaker of the House of Representatives that it was impossible to fix the price of aviation fuel because the petroleum sector has been deregulated and as such, Jet A1 will remain a deregulated product.

"You cannot hold onto any price and indeed what we have seen is N700 reference point. It depends on the market conditions. It can be higher than N700 depending on the market and as the market shifts. As we speak, it is closely related to the price of crude oil. Given the present circumstances, we cannot fix the price. We cannot ask that the product be sold at N500 or less. We cannot say it

must be below N600 or N700," Kyari stated.

Most airline operators and Nigerians may not like Kyari's position, but he made a valid point and at the end of the meeting, the NNPC and CBN agreed to provide six million litres of aviation fuel at N480 per litre for the next three months.

That means Jet A1 fuel will sell for N480 per liter between May and July, but the matters and questions arising are: What happened after July? What will happen if the price of crude oil rises further in the international market?

The intention of Forex being promised by the CBN to make available Jet A1 at N480 per litre in what Gbajabiamila described as 'subsidy' pending when local airlines will be granted licences to import the product may be genuine.

But it also throws up some challenges. Do local airline operators have the capacity to import aviation fuel? Do they have the logistics and expertise to import Jet A1 in a sustainable manner? No doubt, these are trying times for the country's aviation sector, as the Minister of Aviation, Hadi Sirika, admitted recently while pleading with the leadership of AON not to suspend their operations.

The airline operators had told the Nigerian flying public to prepare to pay as much as N120,000 for a one-hour flight. While the rich will not bother to pay N120,000 for an hour's flight, what about millions of Nigerians, who are less fortunate?

The roads and the railways are no longer safe for travel, which leaves Nigerians with only the safer option of travelling by air for those who can, due to insecurity.

Now that the Russia and Ukraine war has affected the local airline's business, will Gbajabiamila's intervention through the tripartite arrangement be the magic wand to rescue the local airlines and assure Nigerians of affordable flights?

As the challenges linger, Nigerians are asking: Why have successive administrations failed to fix the country's refineries in Warri, Port Harcourt and Kaduna over the years?



# Africa food crisis looms as Russia, Ukraine war continues Continent needs aid, expansion of social protection to prevent hunger

of ussia's invasion Ukraine has worsened the food security crisis in most African countries. Many countries in East, West, Middle and Southern Africa rely on Russia and Ukraine for a significant percentage of their wheat, fertilizer or vegetable oils imports, but the war disrupts global commodity markets and trade flows to Africa, increasing already high food prices in the region.

Even countries that import little from the two countries are indirectly impacted by higher world prices for key commodities. Governments and donors should ensure affordable food access in Africa by scaling up economic and emergency assistance and social protection efforts. Otherwise, millions of people across the African continent may experience severe hunger.

Senior Researcher on Poverty and Inequality with Human Rights Watch, Lena Simet, said: "Many countries in Africa were already in food crisis. Rising prices are compounding the plight of millions of people thrown into poverty by the COVID-19 pandemic, requiring urgent action by governments and the international community."

Under global and African human rights law everyone has the right to sufficient and adequate food. To protect this right, governments are obligated to enact policies and initiate programmes to ensure that everyone can afford safe and nutritious food. Social protection systems that implement the right to social security for all can be key instruments for realising the right to food.

Before the war, countries in East, West, Middle and Southern Africa, including Angola, Cameroon, Kenya and Nigeria, were already grappling with soaring food prices due to extreme climate and weather events, such as floods, landslides, droughts and the COVID-19 pandemic, which disrupted production efforts and global supply chains.

Since Russia's invasion, global food prices have reached new heights. The United Nations Food and Agricultural Organisation's (FAO) Food Price Index (FPI), a measure of the monthly change in international prices of a basket of food commodities, increased by 12.6 per cent from February to March. The March index is the highest it has been since the measure was created in the 1990s.

Russia and Ukraine are among the top five global exporters of barley, sunflowers and maize, and account for about a third of the world's wheat exports. Nigeria, the world's fourthlargest wheat importer, receives a fourth of its imports from Russia and Ukraine. Cameroon, Tanzania, Uganda and Sudan source over 40 percent of their wheat imports from Russia and Ukraine. The UN World Food

Programme (WFP) –buys half of the wheat it distributes around the world from Ukraine. With the war, supplies are squeezed and prices continue to rise, including fuel, increasing the cost of transporting food in and to the region.

Human Rights Watch research on the food situation in Cameroon, Kenya and Nigeria confirms that the rising food prices, exacerbated by the war severely affect people's livelihoods and food security in most African countries, especially where adequate social protection is lacking. The United Nations defines food insecurity as "a lack of consistent access to food, which diminishes dietary quality, disrupts normal eating patterns and can have negative consequences for nutrition, health and wellbeing." In situations of severe food insecurity, people have higher likelihood of running out of food and experiencing hunger, sometimes going days without eating.

In Cameroon, where more than half of the population experienced food insecurity before the war, the cost of imported food is driving local food inflation, with bread and other staple foods increasingly out of reach to those with low incomes. In Kenya, nearly seven of 10 people were food insecure before the war, but only one of 10 are covered by at least one form of social protection, and the cost of cooking oil increased by 6.5 percent between February and March alone. In Nigeria, where food insecurity affected nearly six of 10 before the war, year-to-year food inflation was 17.2 percent in March, with prices of bread, rice and yams rising even faster by over 30 percent.

The WFP warned that if the war lasted beyond April, acute hunger may increase by 17 percent globally, with the sharpest increases expected in countries in East, West and Southern Africa. They said the total number of people in these regions experiencing acute food insecurity may rise by 20.8 percent, affecting 174 million people.

Before the war, the cost of nutritious foods and high rates of poverty and inequality kept healthy diets out of reach for 66.2 per cent of people in the region, according to FAO estimates for 2020. Approximately 323.2 million people in Africa or 29.5 per cent of the population ran out of food or went without eating that year. In West Africa and Middle Africa, the share of food insecure populations is even higher at 68.3 percent and 70 per cent, respectively. The number of people affected by food insecurity continued to increase under the shadow of the COVID-19 pandemic.

Also, the World Bank data suggests that the Nigerian adult population suffering from moderate or severe food insecurity increased from 48.5 per cent in 2019 to 75.5 per cent in 2021. A Gallup World Poll before the war found that in Nigeria, 71 per cent of the population lacked money for food in 2020 and 69 per cent in Kenya. The poll also noted that the two countries imported approximately 31 per cent and 34 per cent of wheat from Russia and Ukraine and with disruptions occasioned by the war, the situation can only become worse, with the risk of people being pushed into destitution, starvation and premature mortality.

affects poor people, who spend more of their income on food even when consuming the lowest-cost options. The World Bank reported that in African cities food accounts for 60 per cent of total expenditures for the bottom 20 per cent of urban households and 35 per cent for the wealthiest, making it hard to absorb price hikes. People forced to spend more on basic staples have to adapt by purchasing lower quality food, eating less and reducing essential nonfood expenditures like health or education.

To prevent a hunger crisis, a rights-centered response is vital, Human Rights Watch said. Governments should act to protect everyone's rights to an adequate standard of living and in particular the right to food, by scaling up emergency food aid and expanding social protection systems. Investing in social protection might be a tall order for many African governments facing high debt levels and stretched fiscal positions after two years of the pandemic. A Global Fund for Social

A Global Fund for Social Protection should be set up to increase the level of support for low-income countries, helping them to establish and maintain social protection floors in the form of legal entitlements. Many social protection systems in African countries are at least in part financed and supported by the World Bank, which should ensure that support reaches everyone in need. International financial institutions like the International Monetary Fund (IMF) and the World Bank should refrain from pressuring countries to adopt fiscal consolidation measures that could further raise the cost of food or cut social spending.

cut social spending. Preventing a worsening food crisis requires international cooperation. Food exporting governments should carefully balance export restrictions to protect the right to food domestically while minimising to the extent possible impacts on food supply and prices for other countries. The World Trade Organisation (WTO) estimates that 40 per cent of the increase in global wheat prices during the 2011 food crisis resulted from hoarding. Importing govern-ments should work to ensure that nutritious food is affordable and accessible to everyone. In the long run, importing countries in Africa should boost local food production to increase food sovereignty and make food systems more sustainable. This requires support for climate change adaptation and resilience in the region.

"The war in Ukraine has led to more people across Africa going hungry. Governments should do everything in their power to mitigate the impact of rising food prices and avert a hunger crisis. Expanding social protection and ensuring the supply of affordable food is critical to protecting the right to food for everyone," Simet said.

### Workers commend Diri on welfare as deputy gov canvasses civil servants award

The group gave the commendation when its members visited the Deputy Governor, Lawrence Ewhrudjakpo, at the Government House, Yenagoa.

Chairman of the forum, Dr Stanley Sokari, commended the Diri administration for prioritising workers' welfare, noting that the state government had demonstrated a friendly disposition towards workers by ensuring prompt payment of salaries, implementation of yearly increments and promotion of professionalism.

"We appreciate the prosperous administration of Governor Diri and his deputy for their friendly disposition towards civil servants in the state. It is on record that Bayelsa State is one of the states in the country where yearly increments are implemented and where salaries are paid before the end of every month."

He, however, urged the state government to urgently address the impending knowledge gap in the service through capacity building and sponsorship of administrative officers to relevant

professional programmes. Sokari lamented that only

about 24 percent of administrative officers in the state were members of relevant professional organisations, such as the Chartered Institute of Personnel Management (CIPM) and the Nigeria Institute of Management (NIM) due to their inability to meet the required financial commitments.

He also appealed to the state government to consider members of the forum for appointments into higher political positions that border on administration in the service.

Ewhrudjakpo canvassed institutionalisation of yearly awards for civil servants in the state to motivate them for higher commitment, professionalism and enhanced productivity.

He noted that civil servants, especially the administrative officers, constituted the engine room of policy implementation, stressing that the introduction of best staff awards in different ministries and agencies, would bring about significant improvement in the civil service.

He said: "I am an apostle of positive reward, because once there is a mismatch between the excitement for performance and reward for work, the worker is likely to be demoralised and less productive.

"Because performance does not receive commensurate and proportionate reward, the reward must not necessarily be bread and butter, that is, in monetary terms. There are other factors of motivation.

"So, we can institute the annual civil service award cutting across all the ministries to ensure that every ministry produces first, second and third best staff members."

Ewhrudjakpo, who also advocated continuous capacity building of civil servants, assured that the state government would do everything possible to make the state's Public Service Training Institute functional to check capital flight and generate higher reven

# Distressed buildings to be demolished in Lagos

Lagos State Building Control Agency has disclosed that it has marked over 10 distressed structures in the state for demolition.

In a statement by the Head, Public Affairs, LASBCA, Adetayo Asagba, who said the buildings were marked for being structurally distressed and unsafe for habitation.

The development came on the heels of the demolition of a distressed building located at 47 Jebba Street, Ebute-Metta, Lagos State.

The General Manager, LASBCA, Gbolahan Oki, who spoke during the enforcement exercise, commended the efforts of the community leaders, youths, and residents of the areas for cooperating with the enforcement agents of the agency.

The other buildings marked for demolition before the end of the week by the agency are located at 37 Coates Street; 3, Ondo Street; 14 Ondo Street;

16 Church Street; 13, Ibadan Street; 3 Simpson Street; 35 Jebba Stree; 11 Jeba Street; and 19 Ibadan Street.

The LASBCA boss further explained that the exercise was a proactive step by the agency to prevent the loss of lives and property due to avoidable building collapses.

He said that the move had become imperative to rid the state of inhabitable structures, promote standards, and attain a liveable, organised, and sustainable built environment.

"We urge the people to recognise the urgency in this matter as we cannot afford to wait for another building to collapse; because every distressed building is a disaster in waiting," he said.

"Occupants of distressed buildings will keep asking for more time before they vacate but the truth is that we cannot afford to wait in the matter of life and death," he added.

Oki said the agency would no longer tolerate excuses by occupants of distressed buildings, who often cited emotional attachments as putative reasons for not being willing to vacate the distressed structures.

He called on owners/occupiers of distressed buildings within the state to vacate immediately, particularly during the rainy season which is associated with more cases of building collapse.

He urged Lagosians to emulate the cooperation of the youths and residents of Ebute-Metta who liaised with the government by reporting distressed buildings within the area to appropriate government agencies.

The General Secretary, Association of Real Estate Developers of Nigeria, Lagos State Chapter, Olumegbon Mutairu, commended the efforts of the state government in ridding the state of distressed buildings.

He promised the continued support of members of the association, especially by providing helpful information about the status of buildings across the state.

### AMCON takes possession of Aeroland Travels' assets over N1.8b debt

In its effort to recover outstanding debt, the Asset Management Corporation of Nigeria (AMCON), has taken possession of all assets belonging to Aeroland Travels and its directors over a N1.8 billion debt.

According to AMCON spokesperson Jude Nwauzor, this development was followed up by the order of Honourable Justice D.E. Osiagor of the Federal High Court, Lagos Division. That all the property as listed in the Court Order has to be taken over by AMCON with the assistance of Court Bailiffs among other officials of the law. AMCON purchased the Non-Performing Loan (NPL) of Aeroland Travels Limited from Polaris Bank (formerly Skye Bank) in 2018.

"It would be recalled that Justice Osiagor gave the ruling on February 7, 2022, and in compliance with the enforcement order of the court, AMCON put logistics together, and on Friday, May 6, 2022, took effective possession of the nine properties as listed by the court through its debt recovery agent – Robert Ohuoba & Co. "The properties include those situated at Plot 4 & 4B Block 66 Magodo Scheme, Lagos State; Plot 9, Block 44c, Adetoro Adelaja Street, Magodo Lagos; No. 4C Maye Ogundana Street, Magodo Lagos; No. 10 Oluyomi Oshinkoya Street, Magodo Residential Scheme, Lagos; Plot 8, Block 66, Residential Scheme, Sangisha, Lagos; No. 2A John Olugbo Street, Ikeja, Lagos; No. 2 Fadeyi Street, off Awolowo way, Ikeja, Lagos; No. 8 Surulere Alelor Street, Millenium, Gbagada; and No. 14 Jerry Iriabe Street, off Bashorun Okunsanya, off Admiralty Road, Lekki Penisula."

According to Nwauzor, the court also ordered the freezing of the bank accounts and shares of the company's directors, including Segun Adewale and Victoria Adewale.

It added that the court additionally granted AMCON rights to seize any other landed property in any other place that might be found within the jurisdiction of the Federal High Court belonging to Aeroland Travels Limited or either of its directors.

Until the coming of the order of the Court, all previous efforts by AMCON and its representatives to resolve the debt amicably with the obligor had proved abortive, which was why the Corporation resorted to the Court for justice.

# FG to reposition Delta port, dredge Escravos channel to boost vessel traffic, says NPA

In a bid to revive the port in Delta State, the Federal Government said it had awarded a contract for remedial dredging of Escravos channel.

The government said that the move would help to expand the channel and attract bigger vessels to the port in Delta State.

According to a statement by the Managing Director of Nigerian Ports Authority (NPA) Mohammed Bello-Koko, who stated this in Warri, Delta State, said the dredging of the channel would boost the cargo volume to both Warri and Calabar Ports.

According to him, the dredging, which was halfway done, would enable the port in Delta State to have a better draft, receive bigger vessels and record fewer incidences of vessels running aground when completed.

aground when completed. "We all know that the breakwaters collapsed about 10 years ago, and there has been high siltation resulting in the reduction of the draft from seven meters to three meters in some places."

Bello-Koko also said that the agency had started the mapping and charting of the Escravos channel, starting from the fairway buoy down to Koko Port, which had not been done for over a decade or more, has commenced.

"The essence is to enable us to be able to know the draft along the way and also ensure that the navigational aids are properly placed. This is because some decisions can only be taken after knowing that the channel has been properly mapped and surveyed," he said.

He said that the efforts showed that NPA was beginning to pay attention to the ports outside Lagos.

"We have a special interest in ensuring that Warri and other ports are more active. This is why we have been holding stakeholders' meetings and we are going to Port Harcourt for another one. This enables us to engage with the importers and exporters for them to know that these ports are available for use. We will deploy more marine equipment and ensure that the signals are also working to ensure safe navigation of vessels, "he added.

The NPA team visited the Olu of Warri Kingdom, Ogiame Atuwatse III, to seek support in reviving the Warri Port. The monarch said he was satisfied with the visit of the NPA management to the Warri Port as the first port of call after Bello-Koko's confirmation as the managing director.

He said the eastern ports needed to be opened up, adding that the recent efforts would yield positive results for the benefit of the importing community.

He, however, said that the NPA should always come to the royal family for support to achieve the goal of opening up Warri Port for business.

### PWDs lament unfair treatment at airports •Demand seamless access, facilities

Persons Living With Disabilities (PWDs) have demanded increased access at airport terminals in Nigeria, calling on airport and airline operators to make provisions for equipment, personnel and infrastructure that will guarantee a seamless travel experience for them.

PWDs made the call when the Coalition for Disability Organisations (CODO) held a sensitisation programme for the management of the Federal Airports Authority of Nigeria and other airport-related agencies in Lagos.

CODO had flagged off an advocacy project seeking to address discrimination faced by persons with disabilities at Nigerian airports.

A paper presentation was made during the event with the title, 'A Public Presentation of Research Findings on Access to Airports for Persons with Disabilities in Nigeria.'

The Convener of CODO/ Executive Director, Centre for Citizens with Disability, Mr David Anyaele stated that the PWDs travelling by air are often faced with a lack of amenities such as ramps for persons in wheelchairs, inaccessibility to restrooms at some airports, and in some cases denied the chance to fly.

According to him, the sensitisation programme was to draw the attention of stakeholders to the inability of the PWDs to access airports and services in the nation

On his part, the Director, Spinal Cord Injury Association in Nigeria, Mr Abdulwahab Matepo, said it is important to highlight the challenges of the PWDs with stakeholders such as the Federal Government, Federal Airport Authority of Nigeria (FAÂN), among others.

He emphasised that the goal of the event was to remove all barriers preventing the PWDs from accessing airport services like others who do not have their challenges.

Also, a professor of Sociology, Soyombo Omololu, who spoke at the event, said the PWDs were constantly lamenting the unfair and inhumane treatments they were being subjected to at airports; a situation, he said, had forced many of them to resort to other means of transport.

While responding, the Managing Director of FAAN, Capt Rabiu Yadudu, who was represented by the agency's International Terminal Manager, Mr Ayinla Gbolahan, assured stakeholders that the grievances raised by the PWDs would get to the appropriate authorities.

"I can assure you that this report will be taken back to the heads of FAAN, NCAA, and others. Plans are being made to put amenities in place for Persons with Disabilities," he said.

peration Plan Edo,' an exercise aimed at recertifying building plans and collecting data on socio-economic needs of communities in Benin City, the capital will be kicked off by the state government The Trumpet gathered.

Commissioner for Physical Planning, Urban and Regional Development, Isoken Omo, during a press briefing, said the exercise, which will commence in the Ugbor area of Benin City, is an expansion of the 'Operation Show Your Building Plan.'

She thanked those who have complied with 'Operation Show Your Building Plan' exercise, assuring that all applications have been fast-tracked and that over 400 approvals will be granted to those who have already gone through the process.

She noted that the state government through the programme will be able to collate the needs of communities which in turn will enable it to provide relevant services to Edo people. According to her, "The programme enables the government to know what services and infrastructure the people need. The 'Operation Plan Edo' will involve various ministries, such as Education, Roads and Bridges, Health, Power, among others".

She called on citizens to cooperate with officials of the ministries and provide necessary information to help plan the city and State in line with the 30-year master plan. Condemning attacks on its staff by residents, she warned: "Edo Štate Government frowns at the attack on Staff of Ministry of Planning, Urban and Regional Planning on duty.

Government is concerned about the ugly incident and has vowed to bring the perpetrators to book to serve as a deterrent to others." Meanwhile, Edo State Coordinator of Nigeria Erosion and Watershed Management Project (NEWMAP), Dr Tom Obaseki, has canvassed media collaboration in driving the conversation on flood control as the rains intensify.

Obaseki made the submission at a flood engagement workshop organised by the agency in Benin City, the Edo State capital. He stressed that beyond government action and infrastructural intervention, there was need for all stakeholders, particularly the media to continue to sensitize the people so they can take ownership of flood control efforts and change their attitude towards environmental protection.

According to him, "The media has a crucial role in spreading information in bridging the knowledge gap and enhancing public awareness. The media

chooses which issues to highlight to its viewers and how to frame them, influencing what people perceive to be a priority.

"When the public discussion about a particular topic is structured in such a way that it creates a sense of outrage and menace, people will put pressure on their leaders to put that issue at the top of the political agenda. "The manner in which the media presents information shapes audience perceptions. When communicating a message, the media transmits not just the content of the message, but also their interpretation of it."

Highlighting the state government's intervention in tackling erosion in the state, Obaseki said that the state government has built a total length of over 40 kilometers of secondary drains. "We have built a total length of over 40kms of secondary drains. This excludes over 400km constructed by other ministries and agencies; over 14kms primary stormwater culverts and drains and over 4km of earth stormwater channels.

This is more than what has been done by any other government in the history of the state. On his part, the Resident Engineer and ZUTARI Consultant, Mr Almeroux Loubser, said global warming has contributed to the excessive rains while advocating for use of green energy solutions to reduce burning of fossils.

Also, Edo State Primary Health Care Development Agency (ESPHCDA) has urged stakeholders to collaborate with the government across all levels to sustain awareness campaigns on regular hand washing to prevent diseases.

The Executive Secretary, ESPHCDA, Dr. (Mrs.) Otaniyenuwa Obarisiagbon made the submission in commemoration of the 2022 World Hand Hygiene Day in Benin City. She urged healthcare workers, parents and other stakeholders to adopt the culture of washing hands frequently in order to prevent diseases. She said, "Healthcare workers are to ensure proper handwashing with soap and water before contact with patients, before a sceptic procedure, after contact with ppatient'sbody fluids, and after leaving the patients surrounding in line with the World Health Organisation's 5 moments of hand hygiene.

"This will help protect the health worker as well as oothersfrom diarrheal diseases, Covid-19 and others. The use of liquid soap for hand washing is better than bar soap, especially in our health facilities." Obarisiagbon noted, "When the hands are visibly dirty, washing hands

with soap should be done rather than using alcohol-based hand sanitisers." She added, "Special attention should be paid to the fingertips, the thumbs, the inter digital spaces between our fingers, the back of our hands, and our wrists when washing our hands.

After hand washing, hands can be air dried or single-use hand towels should be used to dry our hands. The hand towels should be washed after use and not shared with others." "We must avoid touching the eyes, nose, and mouth with unwashed hands to avoid infecting ourselves." She urged, "Mothers of

children less than 5 years old must remember to wash their hands after changing their diaper and before preparing food for their children. "Let's remember to wash our hands before we eat, after using the convenience (restroom), and before and after contact with a sick person," the Executive Secretary added.

According to her, "the celebration helps to increase awareness on the importance of washing our hands regularly and ensure people of all levels work together to influence the culture of washing hands always. Washing of hands regularly is a simple and effective way to remove germs, avoid getting sick, and prevent the spread of germs to others."

#### CSOs welcome Buhari's assent to anti-graft bills, laud N'Assembly •President vows to end money laundering, others •Urge passage of Whistleblower Witness Protection Bills

nti-graft watchdog, Africa Network for Environment and Economic Justice (ANEEJ) and eight other Civil Society Organisations (CSOs) have welcomed the signing into law of three anti-corruption bills by President Muhammadu Buhari.

The Bills, which include the Proceeds of Crime (Recovery and Management) Bill, 2022, the Money Laundering (Prevention and Prohibition) Bill, 2022, and the Terrorism (Prevention and Prohibition) Bill, 2022, were signed into law by the President on Thursday at the State House, Abuja.

Abuja. ANEEJ and the eight CSOs, which are partners in imple-menting the "Enhancing Anti-corruption and Social Inclusive Reform Initiatives in Nigeria" project under the Strengthening Civic Advocacy and Local Engagement (SCALE) project of Palladium supported by USAID, described the development as a significant milestone in strengthening the war against money laundering, terrorism financing, and asset recovery.

Executive Director of ANÉEJ and leader of the group, Rev David Ugolor, while reacting to the development at Benin City on Friday, said the CSOs have been calling for the passage of POCA and charge the National Assembly to do the needful. He said, "The passage of the

Bills and their eventual assent by President Muhammadu Buhari yesterday¬ marks a significant milestone in strengthening the war against money laundering, terrorism financing, and asset recovery in the country. ANEEJ and its allies have been campaign-ing for the passage of POCA and other anti-corruption Bills for a long time coming." More so, he called on the

National Assembly to consider the passage of two other Bills, the Witness Protection Bill (2022), and the Whistleblower Protection Bill, (2022) before the end of the tenure of the present administration.

According to him, both bills are direly needed by citizens who are prepared to volunteer information to the Anti-corruption Agencies and the judiciary, adding that they would complement the effectiveness of the three Bills

signed by President Buhari. Ugolor, a member of the Board of the United Nations Convention Against Corruption (UNCAC) Coalition representing Sub-Saharan African CSOs also said the Money Laundering (Prevention and Prohibition) Act will help crackdown on Politically Exposed Persons (PEPs) and other perpetrators of Illicit Financial Flows (IFF).

"Even though our quest to have a separate asset recovery and management agency was not achieved in the Proceeds of Crime Act (POCA), ANEEJ and its allies are prepared to work with the Anti-Corruption Agencies (ACAs) to firm up assets management capabilities," Ugolor noted.

On his part, the Executive Director of 21st Century Community Empowerment for Youth and Women Initiative, Mallam Lukman Adefolahan, Nigeria has met some milestones required by International anti-corruption bodies.

He said, "We are happy that we are able to pull through with these three pieces of legislation and our focus will now shift to the enforcement of anti-corruption laws. By this development, Nigeria has met some milestones required by International Anti-corruption bodies, and it is now left for all stakeholders to go ahead with implementation."

Sixteen of the suspects were indicted by forensic analyses carried out on their devices and the incriminating documents recovered from them.

According to the EFCC, the remaining seven Oladipo Tunde Lawrence, Eludire Gbemileke Joseph, Gbenga Abiona Wale, Ojuwaye Emeka Oluwaseun, Babatunde Kolade Tunde, Abu Idris Olalekan and Boye Timilehin Emmanuel are under investigation.

Seven exotic cars, mobile phones, laptops, and several incriminating documents were recovered from the suspects.

I opted out of a College of Education to follow my dream by going to Ibadan then the hub of entertainment in Nigeria. I initially enrolled as a Secretary in training at Sight & Sound, Ibadan.

However, Tunji Oyelana, (Sura Di Tailor) who married my elder sister, Kikelomo, enrolled me in the University of Ibadan's Department of Music. But I switched to Theatre Arts. I starred in Village Headmaster, to Lola Fani-Kayode's Mirror In The Sun and a couple of stage productions including Femi Osofisan's Our Husband Has Gone Mad Again.

I was lucky to work with Adebayo Salami, and we shot Asewo To Re Mecca. Before the advent of the home video though, I also shot a celluloid movie titled Eri Okan with Adebayo Salami and the rest is history now.

Watching movies from pacesetters like you, we saw less cleavage on display, how do you feel when see actresses appearing almost nude in movies?

I don't get annoyed, the bottom line is this; nobody forces you to do anything. We need education and we need exposure. I'm a typical Nigerian woman, I love my Naija and our culture; there are some things we don't do, it's not in our culture. If we say we want to do it, we can do it in our house under our roof, not in public because you get no respect for doing that. Our producers and directors need to know that when you are acting as a prostitute, you don't need to remove your dress to become a prostitute. You don't need to be touched to act as a grade-A prostitute. I did Asewo to Re Mecca, the pacesetter, fantastic; myself and Toyin Adegbola. I played the number 1 Asewo and I introduced Toyin's character to it. We didn't remove anything and it was the talk of the town. When the producers know this, you will not see nakedness again. We should want people to respect us and respect this profession.

### You act with so much passion and conviction, what is your staying power?

First of all, I'm from a disciplined home. My late father was a retired school principal and my mom was a retired head teacher. We were taught that 'what is worth doing is worth doing well. This is what I'm ordained to do, this is what I love doing and when you're doing something you love, you need to put in all your effort and energy. You must be focused, know your onions and know what you want to do. That is why you see me working like this.

Is there any movie that is very dear to your heart?

I owe every one of them close to my heart. Toyin Tomato took me almost everywhere, it made me recognisable, and so I want to thank Wale Adenuga for giving me the opportunity.

Multitalented scriptwriter, producer and actor extraordinaire Sola Sobowale has remained relevant in the industry for nearly three decades now but her enigmatic strides returned her to the spotlight, a feat very hard to achieve in the sector that produces new stars nearly every passing quarter. Having featured in countless movies; Toyin Tomato as she is fondly called since her role in Wale Adenuga's Popular TV Series 'Oh Father!! Oh Daughter'. In this interview with **OMONIYI ALLI**, she spoke about the journey so far, the new name Laburu amongst

Your name has transited from Toyin Tomato to Eniola Salami and now Laburu, a character from King of Boys where you played the lead role; how does that make you feel?

You see in life, consistency is key because despite taking a long break for so many years in the movie industry, my comeback was huge and a big shout out to Mo Abudu and Kemi Adetiba for bringing me on board during the shoot of Wedding Party and the rest they say is history. These days people don't even call me Toyin Tomato anymore, only a few oldies do, but my role in King of Boys became a game-changer but the new role of Eniola Salami 'Laburu'. Anywhere I step foot, the scream is Mama King of boys and I am grateful that a lot of people connected with that character. The truth is that transitioning from Toyin Tomato to what I am now was huge and I am enjoying every bit of it.

#### What is your favourite part of working with Kemi Adetiba on the King of Boys project?

Working with Kemi isn't easy at all because she is someone who pays keen attention to details when on set; you may feel you are done with your role on set but Kemi has a way of speaking to you and you will end up talking about five shots for a particular scene. Kemi made me stronger, Kemi believed in me. I've been around for a while. You know you can do something, but you were never given the chance. I have never met Kemi Adetiba before; I came from the UK for an audition for Wedding Party. She auditioned me, and I got the role. After the Wedding Party, I got a call. She said I should come for dinner with her. When I got to Landmark, she looked at me and said we are going to work. Then she gave me the script. I said 'this is huge'. I asked 'what am I doing?' She said 'you are the king', I laughed and said 'you are joking'. She said 'no'. I said 'you are putting this responsibility on me, you are putting your life on the line for me, and you believe I can do it?' she said 'yes'. I said give me the baton and said let us run, and we have been running. We will not stop, we

#### are just starting."

*How much of Eniola Salami are you now?* "Some of the things I do in films are natural to me. I am a mother as seen in Wedding Party. As Eniola Salami, Sola Sobowale would not take no for an answer, Sola Sobowale would not want to be cheated, Sola Sobowale is principled, I call a spade a spade; Eniola is a killer, I am not a killer; Eniola is a liar am not a liar; Eniola is forceful, I am not. Sola Sobowale is a natural being.

Not many can leave Nollywood for a long time and then return as if they never left in the first place. What is your secret?

It's not my doing, it is God almighty's doing and I believe so much in him. I believe that this (acting) is what God ordained me to do and that is why I am still relevant. I am very sure that if I had towed a different career path I would have been forgotten by now so this is the path and this is what I have been led to do.

### So did you at any point in time miss the industry while you were away?

Yes, I did because every year I come home, produce a movie, and return to England. Now I have my time and now I only travel abroad on holidays. I am also glad that the Wedding Party came at the right time because if I didn't play that role I would be so envious of the person who played the role.

There are many sides to you as we see in movies, some portray you as being very hot, at other times very meek and you could also be lukewarm- who exactly are you in real-life situations?

You see, what you saw in Wedding Party mirrors what Sola Sobowale is in real life- I love my family passionately. I protect my family. With me what you see is what you get because I call a spade a spade. I don't mince my words because I'm a very down to earth person. I'm also a very free person; I play with people a lot, male and female alike. I love the people around me. I don't like to be around unhappy people and if I find myself there, I'd do my best to make them happy. I'm always smiling and you can tell that my therapy is on my face. If you brood and waste time thinking evil, soon virus will enter your system. I'm a very happy person.

Come to think of it, we see less of you in Yoruba movies as you feature quite often in English movies; does that mean the script isn't coming from that part of the industry?

You are right, I am not the regular face in Yoruba movies but I have acted in a few but the truth is when the Yoruba movie makers are ready, I am ready. Sola Sobowale loves Nigeria and I'm a typical African woman. I don't joke with my roots. I always even advise that when we want to produce a movie, don't just do straight English language, code-switch and co-mix appropriately. I like it when we input our culture into movies. Whether the movie maker is Hausa, Igbo or Yoruba, I'm ready to act any day. I don't have a shop where I sell, the only thing I do is to act and I'm ever ready.

## **EXCLUSIVE:** 'Drowned 13-year-old, beat security check to gain access into pool'

ne Nigeria Aquatics Federation (NAF) said that Matthew Godwin, the 13-year-old kid who drowned in its swimming pool on May 3, 2022, at the federation premises in Package B of the MKO Abiola National Stadium, passed under the barbed wire to beat security check.

In a telephone conversation with The Trumpet, the NAF Secretary-General, Sani Mohammed said Godwin alongside his brother, trekked from the IDP area in Durumi on that fateful day to the swimming pool where he met his untimely death.

According to Mohammed, there are three professional lifeguards and a coach whose duties are to ensure that those coming into the pool can either swim or are given tubes and floaters to keep them afloat while in the pool.

Godwin and the brother, having no money with them to pay to use the services of the pool, stole away through the barbed wire and found themselves in the pool.

Al Ahly drag CAF to international court Al Ahly has resolved to drag the Confederation of African Football (CAF) before the Court of Arbitration of Sports (CAS) over its decision to hold the final of this year's TotalEnergies CAF Champions League in Morocco.

The Egyptian club, in a statement, described the action of CAF as one that goes contrary to the rule of fair play adding that the resolve by CAF gives one of the teams an edge over the other.

Al Ahly already afoot in the final after demolishing the Algerian club, ES Sétif 4-0 in the first leg of the semi-final at Al-Salam Stadium in Cairo, had earlier sent a letter to CAF to consider using a neutral venue to host the grand finale

of CAF Champions League. However, despite the letter sent to the continental football governing body by the North African club, CAF went ahead to announce Morocco as the venue for the final after the Senegalese Football Association who were in the race to host it withdrew.

Moroccan club, Wydad AC is a finalist favourite which would probably see them slug it out with Egypt's Al Ahly in their home country, an occurrence the Red Devils will not allow to take place.

However, Al Ahly insisted that the club will pursue unrelentingly, its course until justice is served through a statement published on its official social media handles.

The statement read: "Al Ahly SC decided to present an appeal to CAS (Court Arbitration for Sport) of against the decision of the Confederation of African Football (CAF) of not holding the 2022 CAF Champions League final in a neutral

venue, aside from the venues of the four semi-finalists, in addition to other violations that do not meet the Olympic Charter, FIFA and CAF regulations.

The club has previously demanded CAF to play the game in a neutral venue and will appeal against CAF's decision, requesting CAS to resolve the situation before the competition's final.

announced "CAF in their statement, which was published yesterday on CAF's official platforms, the chosen venue to host the game and mentioned in the same statement that they are in discussions to revert to the old two-legged home and away final.

"Moreover, Al Ahly SC hopes that CAF will be keen not to disrupt justice and that they will provide CAS with all the required documents that will help in achieving justice.

"Al Ahly's decision to appeal to CAS came after CAF took the decision to hold the CAF Champions League final in the same venue for the second season in a row.

"This decision will give a home advantage to a certain team that will play at home in front of their fans in addition to violating other laws and regulations.

'CAF stated that their decision was based on the fact that there was only one bidder available to host the match without giving a proper explanation over the reasons behind the withdrawal of the other bid," the statement read.

Al Ahly travel to Algeria on Saturday, May 14, 2022, to tackle ES Setif in the second leg of the semi-final while Wydad AC host Angolan club, Petro de Luanda at Mohammed V Stadium on Friday.

CAF in a statement on its official website announced that it has awarded the right to Nigeria to host the finals with the home of Nigeria Premier League club, Akwa United pinpointed as the venue for the

"CAF will confirm the kick-off time in due course. "This is the first intercontinental major cup final to be hosted in International

Godswill Akpabio Stadium in Uyo. Uyo is the capital of Akwa Ibom State - the home of Nigeria's Premier League side Akwa United.

"Last year (2021), the TotalEnergies Confederation Cup was hosted in Cotonou, Benin where Morocco's Raja Club Athletic beat Algerian side, JS Kabylie 2-1," the statement read.

Four teams battling to qualify for the grand finale in Uyo, include DR Congo's TP Mazembe who narrowly secured a 1-0 victory over RS Berkane of Morocco, and Orlando Pirates that edged Libya's Al Ahli Tripoli to a 2-0 win in the first leg of the semi-finals.



## FIFA review Chile's petition against Ecuador

The world's football governing body (FIFA) said it has opened disciplinary proceedings against Ecuador over an allegation bordering on falsification that was brought before its panel by the Football Federation of Chile.

Chilean Football Federation reported Ecuador who secured automatic qualification to the 2022 Qatar World Cup after emerging fourth in the CONMEBOL tourney, for fielding an ineligible player.

According to the Chilean federation, one of Ecuador's defenders, Byron Castillo, who is

alleged to be a Colombian, falsified his age and nationality to play eight matches for Ecuador; an act that is a breach of FIFA's rule.

Chile in the petition asked FIFA to void all games Castilo featured in and award the points to the other teams.

FIFA, in granting Chile's plea, will offer them the leverage to leapfrog Peru and Colombia to the fourth position, a position that automatically gives them a qualifying ticket to Qatar.

Following, FIFA in a statement confirming the receipt of Chile's petition revealed it has invited the Ecuador football federation and their Peruvian counterpart regarding the issue.

The statement read: "As recently confirmed by FIFA, the Chilean Football Federation has filed a complaint with the FIFA Disciplinary Committee, in which it presents various allegations about the possible falsification of the documents that grant Ecuadorian nationality to the player Byron David Castillo Segura, as well as the possible noncompliance of a said footballer with the call criteria to participate with the national team of the Ecuadorian Football Federation (FEF) in eight qualifying matches, corresponding to the preliminary phase of the Qatar 2022 FIFA World Cup.

"In view of the foregoing, FIFA has decided to open disciplinary proceedings in relation to Byron David Castillo Segura's possible breach of the call criteria for the indicated matches. In this context, the FEF and the Peruvian Football Federation have been invited to present their positions before the FIFA Disciplinary Committee," the statement added.

### Kevin De Bruyne is beyond perfect, says Guardiola

According to Guardiola, Kevin De Bruyne has been very instrumental to the success of the club in the second half of the season, dismantling all obstacles to their surge for the trophy. "What can I say? The second part

of the league he has been beyond perfect," Guardiola said in Sky Sports' dock.

However with two games left for both teams having played 36 games of the 38 matches in the Premier League season, Manchester City need a minimum of a win and a draw, except Liverpool's two outcomes, go otherwise, to lift their fourth Premier League title in five years.
