hristian Association of Nigeria (CAN) has called on all adherents of the faith in the country to embark on a one day peaceful protest to ask for justice for Deborah Yakubu Samuel, a student of Shehu Shagari College of Education Sokoto who was gruesomely murdered by extremist Muslims. Mr. Joseph Daramola, CAN's General Secretary, in a letter dated 14th May, 2022, addressed to All Block Leaders, Zonal Chairmen, States and Local Coordinators, Denominational and Church leader's in the country, said the planned protest is scheduled to hold on Sunday, May 22, 2022 simultaneously across the country. He said the occasion

Conspiracy, dark horses theories beset APC ahead of primaries, 2023 elections

Conspiracy theories and talk of dark horses are assailing the ruling All Progressives Congress (APC) ahead of its primary poll to pick its presidential candidate for next year's general elections.

Before the commencement of selling of nomination forms. there was an almost clear indication that the presidential candidate of the APC will emerge from the southern part of the country.

The outcome of the party's national convention in which Abdullahi Senator Adamu, a northerner, emerged as National Chairman gave credence to the political calculation that ÂPC's presidential standard bearer must definitely come from the South.

In line with this thinking, aspiring gladiators from the South started signifying either intentions bv outright declaration or being projected by supporters.

Among the notable earlv signifiers were; Bola Ahmed Tinubu, Dave Umahi, Rochas Okorocha, Yahaya Bello and Ben Ayade while names of personalities like Chibuike Rotimi Amaechi, Chris Ngige and Emeka Nwakuiba, started flying as possible contenders.

of them Some pretended by initially denying their interest in the race but were later unveiled by groups or friends buying the N100 million nomination forms for them in what is now a norm in the polity.

As of the time of filing this story, about 27 voluntary or drafted aspirants are in the race for the APC presidential ticket, although some have reportedly withdrawn. Interestingly, they do not all come from different zones of the south alone as expected. Aspirants from the northern part of the country are now in the race.

As questions are being raised as to whether the

APC has lost its conscience over rotational politics, its national chairman, Abdullahi Adamu, sealed the hope of agitators for a southern presidential candidate for the 2023 poll when he declared that the party has not zoned its presidency.

Adamu's statement, no doubt, opened the floodgate of declarations and surprisingly, increase in number of northern aspirants interested in the race.

Some partv stakeholders in defence of the new development advanced reasons for the gate being be thrown open, saying it gives APC the latitude of selecting the best among those in the race.

This, however, raised a question as to whether APC leaders are tinkering with possibility of finding consensus candidate а ahead of its May 30th presidential primary election.

Should the party be considering consensus arrangement? This question has thrown up other concerns about who decides the 'anointed candidate' and by what

consideration? President Muhammadu Buhari had at any given opportunity assured the party of his intention to ensure that APC has a transparent primary. He said he has no preference among the aspirants while always urging them to up their of consulting game delegates that will vote at the primary.

But with a few latest entrants into the race, suspicion is ripe that there may be a 'dark horse' capable of disrupting the old order. The party is known for springing such surprises. Some have even spoken of "dark horses" being considered.

The APC disappointed bookmakers with the emergence of Adamu party consensus as chairmanship candidate because of the mileage achieved already by governor former of Nasarawa State, Tanko Al- Makura and Senator Sani Musa among other frontline contenders for the position. Buhari was



alleged to have had his way.

Should the party be looking towards Buhari's direction for the choice of APC candidate, then there are some aspirants being seen as 'anointed candidates.'

associated Names with Buhari and seen as dark horses include Ogbonnaya Onu, Amosun, Ibikunle Timipre Sylva, Godwin Emefiele, Ahmad Lawan, Goodluck Jonathan and Babagana Zulum who is yet to obtain nomination form.

Both Emeka Nwajuiba and Onu are said to be old associates of Buhari in the defunct Congress for Progressive Change (CPC) but the duo to some extent does not have wide acceptability in the southeast zone which makes it difficult to canvass Igbo presidency through them.

Amosun is believed to be closer to Buhari than most top notchers of APC in the South West. It was believed that he might be a better option to Tinubu should the presidential pendulum swing to the South West.

A dark horse from the South South is Sylva who is believed to be the president's henchman from the geopolitical zone. However, Buhari is said to be more comfortable with Chibuike Rotimi Amaechi who contributed immensely to the president's campaign both in 2015 and 2019 as director-general.

Two personalities from the North East that cannot be ignored are Senate President Lawan and political relationships

Borno Governor Zulum. It is obvious that APC is in search of a credible candidate whose acceptance cuts across and whose clout can withstand the popularity of a northern PDP

candidate, possibly Atiku Abubakar. A party source said there is consideration of a North/South joint ticket with Zulum as the arrowhead and possibly Amaechi or Sylva or Nwajuiba or Onu as running mate.

The theory on the consideration of а northern anointed candidate may be in tune with the idea of elder statesman, Tanko Yakasai, who claimed that some cabals in the presidency with negative missions have been sponsoring some aspirants from the southern part of the country to declare for the 2023 presidency.

He added that some of the aspirants who purchased have the presidential form were sponsored by the cabals.

"the Yakasai said north has always posited jokingly that they are "Cows" but the south is the "Grass" they eat". Is the assertion not true? Is the south not behaving like grass now? When they were to wrest power from Jonathan, the north was so united that Jonathan didn't survive their unity. Look at the south now, they want to wrest power from the north and their disunity is second to none. It's a pity!."

Lawan is believed to have built bridges of across geopolitical zones in his 23 years stay in the National Assembly: hence his being drafted into the race. Many senators and members of the House of Representatives have enlisted their support for Lawan's presidency, the should party eventually pick him.

The amendment by the Senate to section 84 (8) of the Electoral Act 2020 last week, it was learnt, might be part of the ploy by the APC to rally votes for the preferred candidate at the primaries.

The amendment was done to allow statutory delegates to participate in political parties' congresses and conventions.

The change in the electoral act would allow them, in addition to delegates elected by various political parties, to vote during congresses and conventions to elect candidates for various offices.

Statutory delegates include councillors, local government chairmen their and deputies. political party chairmen in all the 774 LGAs, state and federal lawmakers, governors and their deputies, president and vice president, political parties' National Working Committee members, state party chairmen and secretaries.

decision The to amend that part was reached on Tuesday by the lawmakers after the Deputy Senate President, Ovie Omo-Agege sponsored the move.

Speaking after the bill was passed, Lawan said the "unintended clause" had to be amended before the commencement of party primaries.

According to Lawan, the House of Representatives led by Rt. Hon. Femi Gbajabiamila will also sign the bill before transmitting it to President Muhammadu Buhari for assent.

Lawan added that the electoral act was amended to ensure that no one is denied his rights during political parties' activities.

The Electoral Act which was assented to by President Muhammadu Buhari in February

2022, prevents statutory delegates from taking part in party primaries.

APC aspirants strategize as Jonathan, Emefiele quit race

closure As at of duly returning of completed expression of interest and nomination forms of APC last Friday, 25 aspirants stood to be counted to be in the May 30 and 31 presidential primary race.

Names conspicuously missing on the form submission list are, former President Jonathan and CBN Governor Emefiele.

Forms were bought for the duo by different interested persons that wanted them to run, but while Jonathan denied knowledge of the identity of the cattle breeders and communities, nomadic Emefiele thanked rice farmers for their good intention.

While Jonathan left Nigerians in suspense till the end of forms submission as to his intention or otherwise, Emefiele's bid was never in doubt, having taken legal steps to forestall his disqualification by both APC and the Independent National Electoral Commission (INEC).

Jonathan's rumoured ambition petered away into thin air but Emefiele's aspiration slumped to heavy pressure from the opposition and other Nigerians leveraging on the provisions of the law on partisanship.

Before the new twist to the APC presidential race, some of the aspirants were apprehensive of the proposed drafting of Jonathan, thinking or believing that he was likely the 'anointed' candidate.

Rumours were spread of an unwritten pact between Buhari and Jonathan as the driving force while others hinged it on presumed scheming by the north to take a short cut back to power after a purported fouryear single term by the former PDP president.

Court halts sharing of derivation funds to oil states

Federal High Court sitting in Abuja has ordered the A c c o unt an t General of the Federation to immediately halt the distribution of more than One trillion naira due to oilproducing states pending the determination of the suit before it.

The court, presided over by Justice Ahmed Mohammad, in an interim injunction held that the distribution of the derivation funds without the indices of the Revenue, Mobilization, Allocation and Fiscal Commission (RMAFC) was injurious to the applicant which is Imo State government.

Imo State attorney general and commissioner for Justice, had in a suit No FHC/ABJ/CE/415/2022, against RMAFC and others challenged the distribution of the said funds without unambiguous indices by RMAFC as provided by in Nigeria's Constitution. In his submission before the court, counsel to lmo State Government, Chief Olusola Oke argued on the need to protect his client pending the determination of the suit.

After granting the exparte order, Justice Mohammed ordered the imo state to join other oil producing states as respondents to the suit.

He consequently adjoined the matter to June 15,2022 for hearing of the motion on notice.

Nigerian security architecture needs review, minister affirms

Minister of Defence, Major-Gen. Bashir Magashi (retd), has called for a review in the operations of the Nigerian security architecture to enable it defeat current challenges facing the country.

Magashi made the call at the 2022 Defence Retreat with the theme "Shaping the Armed Forces of Nigeria for Current and Future Security Challenges" held in Asaba, the Delta State capital.

The minister who was the special guest of honour at the event, said the review has become in view of the Federal Government's huge investment on military equipment, adding that there was still a lot to be done in spite of the successes recorded so far.

He also called for a review of the armed forces laws to ensure that they were in tandem with prevailing realities.

He said, "The Ministry of Defence will continue to provide administrative support and place premium on defence procurements.

"We look forward to deliberations that will produce implementable solutions to the myriads of security challenges facing the nation."

In his remarks, Delta State Governor, Senator Dr. Ifeanyi Okowa, called on the military authorities to prioritise the welfare of officers and men of the armed forces to motivate them in the fight against insurgency and other violent crimes in the country.

He said that the armed forces may possess sophisticated weapons but that without a motivated personnel, they would not achieve desired result. "As we try to evolve ways in

As we try to evolve ways in tackling multifaceted security challenges in our nation, another matter requiring priority attention is the welfare of our soldiers at the frontlines.

"It is my considered view that we can have all the sophisticated weaponry and excellent logistics but without motivated and satisfied personnel all our efforts will come to naught. "It is, therefore, imperative

that we place premium on their welfare so that they will discharge their duties with utmost pride and enthusiasm.

"In the same vein, honouring soldiers who die in the battlefront is the most powerful message we can send about serving our country sacrificially.

"It has the potential to ignite the fire of patriotism in our people and become an inspiration for many others to want to wear the uniform with pride and assurance," he said.

Penabdul, in his reaction to the incident said: "The role of the scholars and government in preventing bloodshed that might result from blasphemy against the Prophet (SAW) is a major task that must be taken seriously. In doing this, government at all levels and scholars must ensure anything or utterance that will lead to bloodshed is avoided at all times.

"We need government at all levels to criminalize blasphemy because of its apparent negative effect on our drive for peaceful coexistence.

"The incessant cases of mob actions across the country over blasphemy could be attributed to the slow nature of our justice system. So government needs to be deliberate in strengthening its justice system so that the masses can have confidence in it.

"The scholars on their part also need to look at a balanced approach on this issue, lest it escalates and lead to many unfortunate events such as the Deborah's case.

"On sensitive issues like blasphemy, I am of the opinion that government should recognize the voice of our scholars who are known to stand for the truth and are elderly. Their wisdom and experience will help a lot in taking a pragmatic step in this regard.

"When there is speed in justice delivery in matters like blasphemy and punishment meted out appropriately, it will reduce jungle justice and help bring about sanity in matters like this.

"People have over the years taken to jungle justice and this has led to more violence rather than solve the problem. This is the main reason why government needs to be deliberate about the issues that trigger mob actions."

Our Shaykh @DrMSaniR_ Lemo has made known his position on this issue. He stated what the government needs to do and the limit the scholars have in controlling mobs.

He said: "As religious representatives we must strive to take hold of our emotions in moments like this because once we lose our emotional balance we can mislead a lot of people. It is always better to be calm and calculating in our response.

"A sensitive issue as blasphemy against the

Prophet SAW is something v that government should take as seriously. Only government r has the instrument to prevent k these repeated cases of blasphemy and mob actions." k

Rev. Fr. George Barde of the Catholic Archdiocese of Jos, in his reaction to Deborah's death, said "The problem I have with Christians is that they use their own religion to judge another religion. This explains why they can never understand certain things that happen in this country.

"To be honest a typical Muslim knows that blasphemy carries the sentence of execution. The only issue here is who determines blasphemy? Just anyone?

"Islam as a religion is a comprehensive guide on how to do everything and what to believe in life. "It is very detailed about every life issues including dav how you copulate etc. When Yerima Bakura Ahmed Sani of Zamfara introduced Sharia mostly Christians shouted but most of his people saw no problem with it. Eventually most northern states have sharia law today. They like it because it is a direct and fast justice system. When again he decided to marry a young teenager from Egypt people shouted but her parents and his religion permits a minor to be married off

"Actually a family can kill their own child son or daughter who perhaps converts to another religion or marries a non-Muslim. It is called honour killing. It is rampant in Pakistan. "The Atheist Dadiata was

kidnapped for blasphemy and till date we don't know what has become of him.

"What happened to Deborah is very infuriating if you don't understand the religious sentiment of an average Muslim. The Qu'ran and hadith of course are his rule of life. No matter what you think and know once it says it then it can be done notwithstanding what you think or feel.

"So many Muslims might be embarrassed and ashamed at what has happened and keeps happening but they know that those people that committed that despicable and horrendous act of murder in the most inexplicable way in this modern world can justify their actions.

"It is difficult for some because they are a minority voice of reason in all of these. Whether it is to abduct and marry a Christian girl by force or demolish a church or revoke land ownership to Christians can be justified. Boko Haram feels more Muslim than all other Muslims and they can justify it.

"I don't blame anyone but those who have accepted responsibility of office in the name of all of us. We have seen this many times in this country. Tell me the outcome of the investigation."

Those who submitted forms included Osinbajo, Tinubu, Onu, Lawan, Akinwumi Adesina, Amaechi, Godswill Akpabio, Amosun, Okorocha,Tunde Bakare, Ayade, Umahi, Kayode Fayemi and Nwajiuba.

Others are Ken Nnamani, Yahaya Bello, Abubakar Badaru, Ahmad Yerima, Ajayi Borroffice, Uju Kennedy, Nicholas Felix Nwagbo, Dimeji Bankole, Sylva, Ikeobasi Mokelu and Tein Jack - Rich.

A close source in the party hinted that this new development buoyed the confidence the aspirants have in Buhari's pledge not to favour any aspirant but to join hand with party leadership in ensuring a transparent primary.

The source said the Tinubu's campaign which has not done much of consultations in the South South because of the rumoured interest of Aso Rock in either Jonathan or Emefiele, is now ready to traverse the states of the region namely, Bayelsa, Rivers, Edo, Delta, Cross River and Akwa Ibom in the next one week ahead of the primary.

Aside his South West base, Tinubu's campaign train has toured northern zones of West, Central and East.

With Jonathan and Emefiele out of the way, it is believed that most of Tinubu's allies in the South South can now boldly identify and campaign for him.

Likewise, one of the surprise entrants in the race, Lawan may now enjoy the full and open support of his admirers from the South South and other zones.

The Trumpet learnt that lists of ministerial, ambassadorial and board appointments as well as principal officers of a new 10th Senate have already been drawn by Lawan and his loyalists with the expectation that they will work towards his emergence first at the APC primary and later at the election proper. Former Governor of Abia State and current Senate Chief Whip, Orji Uzor Kalu, is an unrepentant campaigner for Lawan's presidency. He insisted power must be ceded to either the South East or North East, where Lawan comes from.

Kalu in a recent comment said "Lawan is from the North East and has similar sympathy with the South East that is yet to produce a president."

The Chief Whip also said nine APC presidential aspirants are set to step down for the Senate President ahead of the primary.

The Trumpet further learnt that Kalu is clandestinely paving the way for his emergence as Senate President in the next dispensation should Lawan win the presidential election.

However, an aide to a PDP senator from the South West said these are just political permutations as "none of these politicians knows their fate until after the primaries as some of them who bought forms for higher positions already have plan B to fall back on should they fail to realize their ambitions."

He said: "will you be surprised to later learn that a few of these presidential aspirants collected another form to run for other positions should their presidential ambitions fail?"

He specifically said both Lawan and Senate Deputy Leader Ajayi Borroffice collected senatorial forms to return to the Senate if they fail. Likewise, an

Likewise, an unconfirmed source said Governor Bello also obtained forms to contest the Kogi Central senatorial district election.

Niger Delta Affairs minister, Godswill Akpabio, also was said to have collected senatorial forms to return to regain the position he lost in 2019 following his defection from PDP to APC.

Also mentioned is Transportation minister Amaechi who was said to have bought and submitted a senatorial form.

The THE Impact Rankings is measured against the SDGs.



atholic Mass in Sokoto metropolis has been suspended until the curfew imposed by the state government is lifted.

The 24-hour curfew was imposed by the state government after protests rocked parts of Sokoto city over the detention of two persons linked to the awful killing of Deborah Samuel.

Hundreds of placard-carrying Muslim youths began a protest in Sokoto on Saturday demanding the release of the two suspects.

The suspension of mass by Catholic Diocese of Sokoto Bishop Mathew Kukah was contained in a statement signed by the Director, Social Communications, Rev. Fr. Christopher Omotosho.

Omotosho stated that Kukah's residence was not attacked though protesting hoodlums vandalised and torched two of the parishes.

The statement reads: "The Sokoto State Government has declared 24-hour curfew to help stem the ongoing protests embarked upon by Muslim youths in the state capital today.

"During the protest, groups of youths led by some adults in the background attacked the Holy Family Catholic Cathedral at Bello Way, destroying church glass windows, those of the Bishop Lawton Secretariat were also attacked and a community bus parked within the premises

vandalised. "St. Kevin's Catholic Church Gidan Dere, Eastern By-pass, was also attacked and partly burnt; windows of the new hospital complex under construction, in the same premises were shattered.

"They were promptly dispersed by a team of Mobile policemen before they could do further damage.

"The hoodlums also attacked the Bakhita Centre located along Aliyu Jodi Road and burnt down a bus within the premises."

Bishop Kukah has called for calm and applauded Governor Aminu Tambuwal for acting promptly by declaring the curfew.

He also commended the security forces for quickly rising to the occasion to prevent further damages to the church's facilities,

adding that no life was lost. "All Masses in the Sokoto metropolis have been suspended until the curfew is lifted," the statement added.

The Bishop appealed to Christians to remain law-abiding and pray for the return of normalcy in Šokoto.

NPA threatens to revoke port concession pacts of operators over facilities decay •World Bank, IFC, Afri-Exim I, others express interest to re-construct the affected port

Nigerian Ports Authority (NPA) has threatened to revoke the concession agreement of five terminal operators over purported collapse of infrastructures.

It said currently all affected terminal operators at the nation's seaports are under close watch to ensure they keep to all commitments and obligations as agreed under the Port Concession Agreement.

The Federal Government had in 2005-2006, entered into concession agreement for several bulk, breakbulk and container terminals, partly on a competitive basis (13 terminals) and partly through negotiation (12 terminals).

Addressing maritime reporters on Saturday, the Managing Director of NPA, Mohammed Bello-koko, disclosed that the affected terminal operators have been granted six-month grace to enable them meet up with the condition for renewal, before their concession agreement will be renewed permanently.

The NPA boss said the introduction of the Infrastructure Concession Regulatory Commission (ICRC) Act meant that renewal of concession agreement for terminal operators is no longer done the way it used to be done.

Tin-Can Island Port, we all know what is happening there. The port is practically collapsing. We need to focus our budget towards the rehabilitation of those quay walls at the Tin-Can port. We have taken a holistic review of decaying infrastructures at our ports and have decided that it is very important that we rehabilitate Tin-Can and Apapa

"What we have done is to start talking to lending agencies, even though we don't intend to lend. We are asking the terminal opera-

tors, you people have operated these port terminals for about 10 to 15 years; how much money are you going to invest in this port terminals? We are asking some of them that their leases have expired, how much will they be investing in the ports? "For us to renew these concession agreements that have expired, about five of them, we need to have categorical commitment from the affected terminal operators on the development of these port terminals. If the terminal operators cannot give us such commitment, then we either give the terminals to someone else or go and borrow money to rehabilitate those ports," he said.

According to Bello-Koko, if money is borrowed to rehabilitate those ports, then what the terminal operators are paying will have to change as the rates

will have to go up. He said of this is not done, these terminal operators will keep managing those places and the ports will keep collapsing.

He noted that because of the terminal operators financial interest, they don't want NPA terminals because that will mean stopping them from operating.

We have had interest from the World Bank, IFC, Afri-Exim Bank and others. Surprisingly, it was the World Bank that actually gave money to the NPA to construct part of Apapa port so many years ago. The World Bank has come again to tell us that if we need funding, they will give it to us," he stated.

Bello-koko while explaining the process of renewal of the port concession agreement, said the ICRC Act introduction meant that the process of renewal can no longer be done the way it used to be done.

"At the point of expiration of any concession agreement, the then Legal Agreement says that the terminal operators can apply for renewal and we will renew. It was after the concession agreement that the ICRC Act came onboard. The ICRC Act requires that there should be a new owner, a new bid and so on and so forth. So you can see there is conflict.


"Again, the Minister also said that the port terminals are in their worst state; asking what is the plan of the terminal operators to invest more. Also, the NPA asked the terminal operators about their development plans for the port terminals," he noted.

"The affected terminal operators have been given temporary extension of six months. If today, we revoke the current concession agreement and bring new people onboard, the new bidders will naturally pay the NPA far higher than what the current terminal operators are paying. We know this, but we are not yet saying that. What we are saying is that let us sit on the table and create a concession agreement that is fair. We need an agreement that holds the terminal operators responsible for their actions,* Bello-Koko added.

Fear of epidemic mounts as heaps of refuse litter P'Harcourt streets

esidents of Port Harcourt, Rivers State capital, are living in fear of out-break of an epidemic following heaps of refuse that litter the nooks and crannies of what was formerly known as 'Garden City.'

When *The Trumpet* visited some major markets within the state capital where foodstuff and other consumables are sold, heaps of refuse were seen competing for space with where the traders keep their wares.

At the Town market in Borikiri, Port Harcourt Local Government Area, a foodstuff dealer, Mr. Martins Nduaguba, told The Trumpet that despite the toll they pay to the authorities of Port Harcourt City Local Government, the council could not provide commensurate services to keep the environment clean for the daily activities in the market.

"My brother this is where you see us. What can we do? It is the duty of government to provide a good environment for businesses and for life. A place where people buy what they eat is not supposed to be left in this condition," he lamented. A lady who came to the market to buy some food stuff expressed disgust at the general poor sanitary condition in the market and the state as a whole. She lamented that since Governor Wike declared intention to contest the presidential election in 2023, governance "took a flight" in the state. The lady advised people who come to buy things like fresh meat, fish, tomatoes, vegetables and other consumables to ensure proper washing and cooking to escape contacting some "deadly" infections.

Other places visited like the Old Aba Road, Rumuomasi, Rumuokoro, Oil Mill Market, Slaughter, etc, the story is the same as the city of Port Harcourt once prided as the "Garden City" of Nigeria is fast becoming the opposite with serious health implications.


The general outrage the situation has provoked had attracted the attention of the opposition All Progressives Congress (APC) in the state. A chieftain of the party and former Publicity Secretary of the defunct New Peoples Democratic Party (nPDP), Chief Chukwuemeka Eze, in his usual blistering attacks on the Wike led administration, had urged

the governor to abandon his pursuit of presidential ticket of PDP and return to Port Harcourt to fix up things. Eze said Wike should "bundle himself back to Port Harcourt and concentrate on evacuating the humongous waste that now adorn major highways and streets in Port Harcourt, turning the once Garden City and pride of Nigeria to Garbage City.'

The ex-nPDP Spokesman feared that residents of Port Harcourt may be endangered species given the horrible environmental situation in the city which "in all honesty calls for a serious health emergency."

He said "the mountainous heap of dirts and pollutants have fouled the air and turned the once serene city into a garbage city" and called on Wike to channel the energy he uses in displaying "crass ignorance and flamboyant idiocy" to clear the wastes that line up on major roads and streets. Pastor for trial over alleged swindling of UK-based woman

An Enugu High Court has directed the police to arraign the General Overseer, City of Jesus International Ministry (COJIM), Pastor Christopher

Orji for alleged fraud. Hon. Justice Okey Anike, of the Agbani High Court, dismissed an application brought by the Pastor seeking to stop the police from investigating allegations against him by a United Kingdom based woman, Dr Anyaegbunam A. In the matter with Suit No: HAGB/ 50M/ 2021, the pastor sought the court to enforce his fundamental rights by stopping the police from investigating him on allegations brought to the police by the woman, who alleged that the applicant obtained several gifts and donation from her in the name of his church using misrepresentation of facts, fraud, deceit and undue influence. When the 5th respondent who is based overseas returned to Nigeria, she decided to visit the said man of God, where she received the shock of her life, as she realized that she has

been swindled in the name of God. It was maintained that the woman only realized that all the videos, and information she was being fed while abroad about the said church and its non-existent charity home, were all stage managed. Regrettably, when the said man of God realized that the bubble has burst, as the woman came into Nigeria for a burial, and actually came to visit him, he was so shocked that he refused to see her(the 5th respondent) – his benefactor who supposedly has 'donated' about N29,000,000:00 (Twenty nine million naira) both in cash transfer, and even a new Sienna Car to the supposed man of God, so as to help in charity work.

Realizing that the woman (5th respondent) left their makeshift shanty, in utter disappointment and very disgusted, the said applicant started using all sorts of gimmicks to reach the applicant including threat to her life. Subsequently, the woman made a demand to the man of God, and requested for the return of all her supposed donations including her computers, laptops and Sienna which were obtained by false pretense, deceit , fraud and misrepresentation of facts to her. This demand did not go down well with the said Pastor, who conspired with his cabals to report Dr. Anyaegbunam to Okija Shrine, and all sorts of threat and invitation where meted to her; including telling her that she will die in 15days time.

Consequently, she reported to the Nigerian Police Force who invited the said Pastor Christopher Orji and obtained his statement. Rather than resolving the issue, Pastor Christopher Orji went to High Court Agbani judicial Division, to institute Suit No: HAGB/ 50M/2021 praying the court to enforce his fundamental rights, by restraining police from investigating his matter, which he claims is a civil matter, and for police to be stopped from inviting him. The woman - victim - who is seeking to get her materials back from the Pastor then engaged the services of a fiery Enugu Lawyer, Chief O.A.U. Onyema, of Akpaagu Chambers.

A major fire outbreak that occured at the weekend has gutted a popular private school located at Eziala Úmuohiagu in Ngor Okpala LGA of Imo State; near Sam Mbakwe International Cargo Airport, destroying property worth over N18million.

The fire incident which began around 11pm that fateful night lasted for over 02hours and completely destroyed the block housing the library, computer unit and parts of the general hall of the Solid Foundation Schools.

When our correspondent visited the scene Sunday morning, the proprietress of the torched school, Lolo Ngozi Uju Madu was seen supervising some of her family members using water to put out the fire in areas where smoke was still noticed while clearing the debris.

Narrating her ordeal, the proprietress told The Trumpet that the inferno started late night and her attention was drawn to it by neighbours who ran to her home to alert her family of the unfortunate incident.

She disclosed that youths of Umuohiagu Community and other people who rushed to the scene in their numbers made frantic efforts to quench the raging flames for hours before they were able to put it under control adding that their time intervention saved the classrooms for all sections, administrative blocks and other nearby structures from being affected.

Lolo Uju Madu revealed that no fewer than 50 computer sets and accessories, laptops, tables, chairs, ceiling fans, assorted books, book shelves, countless electrical and electronics gaggets and the entire building was razed down from roof to foundation by the inferno.

Although she could not immediately ascertain the cause of the inferno, she stated that the midnight fire was strange as there was no electricity as at the time it started as to suspect electrical fault but thanked God immensely that no life was lost in the incident

"I don't want to suspect anything or anybody for this incident rather entrust everything into God's hands because He knows all and the best. It was a heavy loss I can't easily count now,' she said.

SERAP drags Buhari to court over N1.48 trillion refinery maintenance

Socio-Economic Rights and Accountability Project (SERAP) has filed a lawsuit against President Muhammadu Buhari "over his failure to probe allegations that over N1.48 trillion reportedly spent on maintaining the country's four refineries between 2015 and 2020 may have been stolen, mismanaged or diverted into private pockets."


The government reportedly spent N10.23 billion in June 2020 on three refineries that processed zero crude. Also in 2021, the government approved \$1.5 billion (about N600 billion) to repair the Port Harcourt refinery. Despite the huge spending, the refineries are still not working while fuel scarcity persists.

In the suit number FHC/L/CS/806/2022 filed last week at the Federal High Court, Lagos, SERAP is seeking "an order of mandamus to direct and compel President Buhari to investigate the spending on Nigeria's refineries, and alleged mismanagement of public funds budgeted for maintaining the refineries since 1999.

SERAP is also seeking "an order of mandamus to compel President Buhari to ensure the prosecution of anyone suspected to be responsible for the importation and distribution of dirty fuel into Nigeria, and to identify and ensure access to justice and effective remedies to affected victims."

According to the organisation, "It is in the public interest to ensure justice and accountability for alleged corruption and mismanagement in the oil sector, which has resulted in the importation and distribution of dirty fuel and protracted fuel scarcity in the country.

"Nigerian Constitution 1999 [as amended], and international standards impose clear obligations on the Buhari administration to take effective accountability measures to



weed out, expose and punish allegations of corruption in the oil sector, and to ensure effective remedies for victims.

"Ensuring justice and accountability in the spending of public funds on refineries would improve the availability of petrol and the enjoyment by Nigerians of their right to natural wealth and resources.

"Impunity for alleged corruption in the oil sector has contributed to the importation and distribution of bad fuel, violating the human rights of many users, including to a safe, clean, healthy and sustainable environment.

"The Buhari administration has legal obligations under Section 15(5) of the Nigerian Constitution to abolish all corrupt practices and abuse of power, and article 26 of the UN Convention against Corruption to ensure

effective prosecution of allegations of corruption. "Alleged corruption and mismanagement in the oil sector and the importation and distribution of dirty fuel have continued to deprive Nigerians of economic opportunities, subjecting them to cruel and degrading treatment."

SERAP is also seeking "an order of mandamus to direct and compel President Buhari to instruct appropriate anti-corruption agencies to jointly track and monitor the spending of public funds to rehabilitate, operate, and maintain Nigeria's refineries."

torney General of the Federation and Minister of Justice, Mr Abubakar Malami, SAN.

its lawyers, Kolawole Oluwadare and Ms Adelanke Aremo, reads in part: "Nigeria has made legally binding commitments under the UN Convention against Corruption to ensure accountability in the management of public resources. These commitments ought to be fully upheld and respected.

"Directing and compelling President Buhari to probe allegations of corruption and mismanagement of the money meant to repair the country's refineries would advance the rights of victims of corruption to restitution, compensation and guarantee of non-repetition.

"Combating the corruption epidemic in the oil sector would alleviate poverty, improve access of Nigerians to basic public goods and services, and enhance the ability of the government to meet its human rights and anti-corruption obligations.

"Despite the country's enormous oil wealth, ordinary Nigerians have derived very little benefit from their own natural wealth and resources, primarily because of widespread grand corruption, and the impunity of perpetrators.

"High-ranking public officials, including officers of the Nigerian National Petroleum Company Limited suspected of complicity in the allegations of corruption and mismanagement in the oil sector, and the importation and distribution of adulterated fuel have continued to enjoy impunity.

How Jang, others diverted **Plateau State's MSMEs** funds, by witness

A prosecution witness 13, PW13, in the trial of former Governor Jonah David Jang and a former cashier in the Office of the Secretary to the State Government (OSSG), Yusuf Pam, has told a High Court that the former allegedly diverted funds meant for the Micro, Small and Medium Enterprises (MSMEs) in Plateau.

The witness, Mr Musa Olashuko, an Assistant Director in charge of Development with the Central Bank of Nigeria (CBN), told Justice C.L Dabup that funds meant for artisans, small holder farmers, market women and entrepreneurs were diverted into the account of the Plateau State government and its agencies.

He said, "We made an enquiry on the regular flow of funds between the credited account communicated to us by the state government and the Plateau State Small and Medium Enterprises Development Agency (PLASMEDAN)'s account, and we noticed that funds were diverted to accounts related to the state government and its agencies and that no disbursement was made through the initial beneficiaries, i.e. the SME's (Artisans, traders, small holder farmers, entrepreneurs and market women.), where about 60% of the funds was supposed to go to."

Olashuko further revealed that when CBN noticed the inappropriateness of the deal, a recommendation was made that the Issuance of Irrevocable Payment Standing Order (ISPO) issued by the state government be taken over in order to recover the funds.

While cross-examining the witness, counsel for the first defendant, E.G Pajwok, a Senior Advocate of Nigeria, asked the witness whether, in the course of their investigation in Jos, they went to the PLASMEDAN office or contact any of the officials.

He responded that the CBN later found out that "PLASMEDAN was just a paper creation. No building, no officials. The creation was not supported with any structural or operational framework".

EFCC secures conviction of five fraudsters

Benin Zonal Command of the Economic and Financial Crimes Commission (EFCC) has secured the conviction of five internet fraudsters before Justice Efe Ikponmwonba of Edo State High Court, Benin City.

The convicts, according to a statement by the EFCC, include Amogie Julius, Omogbon Friday Harry, Osaze Okoro, Lucky Tegiri and Omokhua Destiny.

They were arraigned on one count charge each for fraudulent impersonation and obtaining by false pretence. They had sometimes between 2020 to 2022, impersonated foreign nationals with intent to defraud unsuspecting members of the public of their hard earned money.

The charge against Amiogie Julius reads: names dcluck75@gmail.com and company, of this Honourable Court did fraudulently personate the identity of Gloria Hernandez Ortiz, with intent to obtain money from her and thereby committed an offence contrary to Section 484 of the criminal Code Law Cap 48 Laws of Bendel State of Nigeria (as applicable in Edo state) 1976".

The charge against Lucky Tegiri reads: "that you Lucky Tegiri on or about 22nd February 2022 in Benin City, Edo State within the jurisdiction of this Honourable Court did with intent to defraud falsely represented yourself to be one Mark Linda by creating two fraudulent email accounts, with user

"that you, Amoigie Julius between 2020 to giveaway7610@gmail.com, by sending text 2022 at Wisdom Street, off Egba Road, messages to some unsuspecting Chinese ladies, Benin City, Edo State within the jurisdiction so as to obtain money, a representation which you knew is false and thereby committed an offence contrary to and punishable under Section 484 of the Criminal Code Law Cap 48 Laws of Bendel State of Nigeria (as applicable in Edo State) 1976."

All the defendants pleaded guilty to the charge preferred against them, thereby prompting the prosecution counsel, A.A. Ozigbu and KY Bello, to prayed the court to convict and sentence them accordingly.

Danger looms in Lagos as women, children sleep on railway tracks

A visit to the location showed some of the women and children just waking up and getting set for the day's business, while some were still sleeping on mattreses spread on the railway track.

Enquiries by our correspondent revealed that these mothers and their children go to bed on the rail tracks as late as 11pm when they are sure that the last Iddo to Ijoko train has passed.

Also, they wake up from 'bed' before 7am, just before the first Ijoko to Iddo train passes through Agege.

Speaking to our Correspondent, one of the mothers explained that it is very expensive to get an accomodation in Agege, giving the nature of their means of livelihood.

According to the nursing mother, who Rukayat said.


identified herself as Rukayat, "Getting an accomodation in Agege is very expensive, so we sleep on the railway track. Everybody has their own space, just enough to accommodate them with their children.

"We know the schedule of the trains (Lagos-Ibadan and Ijoko-Iddo), so we go to bed when the last train has already passed, and we wake up first thing in the morning just before the first train passes towards Ikeja.

"We survive through begging for alms and there is no way we can raise enough fund to get an accomodation here in Agege."

When asked where the father of the children sleep and work, Rukayat explained that he works in a factory along Oba-Akran in Ikeja and occasionally sleeps with them on the rail track.

"My husband works in a factory in Ikeja and occasionally comes here to sleep. Most times, he hangs out with friends and pass the night in market stalls or shops,"

The killing of Citizen Deborah, our own Malala

ast week the video of a body set ablaze by a mob went viral on Isocial media. It was preceded by the still picture of a lady dressed in red lying on the ground in a grotesque manner. Life was no longer in her. She had succumbed to savagery and jungle justice by overzealous morons jungle justice by overzealous morons who accused her, found her guilty and executed in a most barbarous manner reminiscent of the Stone Age. She died a most horrendous death in the hands of her class or school mates. She was stoned to death by students at a College of Education. The barbarous act was carried out by some teachers of tomorrow. What kind of educators would these teachers be in future? Do they recognize Nigeria? Do they realise that Nigeria is not an Islamic Republic, that is, supposing an Islamic Republic will tolerate such a murder? This is unacceptable. It is indicative of the deep division between world view of extremists in the north and

view of extremists in the north and the rest of the country. The ugly news has not been carried by cable network stations. If it happened in Afghanistan or the Middle East, her death would be on the airwaves. Fortunately, and appropriately, the Sultan of Sokoto, leader of Muslims in the country, has spoken against the murder. But he should not stop there. We expect him to personally get involved and ensure that the killer is paraded before the press as a common criminal. Except he does this, we would see the con-demnation as mere lip service. The demnation as mere lip service. The irrepressible Father Matthew Kukah has also condemned the murder and called on the government to fish out the perpetrators for the right punish-ment, stating that "the only obligation that is owed her immediate family, her fellow students and the school authorities is the assurance that those who are guilty of this inhuman act, no who are guilty of this inhuman act, no matter the provocation, are punished according to the laws of the land'. Writer Gimba Kakanda wrote on a Facebook post: the barbarism that transpired in Sokoto today has no basis in Islam, and it indicts us all. This culture prevails because past self-appointed punishers of blasphemers got away with their crimes. Whether in Islamic jurisprudence or our secular law, there's no place for jungle justice, no matter how any offended mob feels'. feels'

But the misguided zealots don't feel any remorse. Some posts which followed the gleeful announcement on social media are instructive. The killer whose photograph is prominently displayed on social media boasted: I killed her. I burnt her. You can see the matchbox I used in setting her ablaze'. One Muhammed Mode Gagi wrote,



ike a hurricane, the murder of Deborah Samuel Yakubu has swept all discourses out of the Nigerian social-political space. No one reads of the 100 million naira intention forms politicians are acquiring. ASUU's problems are put aside. Not even Putin's Russian destruction of cities in Ukraine is now before us. Many are perplexed that persons undergoing learning and education; young Nigerians of impressionable age could go this length of religious intolerance and atavism. This is a difficult thing for followers to know given the fact that the painter of the devil on the canvass before the followers are the leaders. They own the paint, brush and canvass. 'Ayu working for Atiku'

Criticism continue to dog last week's decision of the Peoples Democratic Party (PDP) to abandon zoning in picking its presidential candidate for the 2023 polls.

A member of the PDP in Edo State, Kassim Afegbua accused the leadership of the party of playing games with the zoning decision.

He said the party's National Working Committee (NWC) threw open the presidential ticket for pecuniary reasons.

In a statement titled "PDP and the Zoning Formula", Afegbua said the national chairman's first major assignment of following the dictates of the party constitution has ended up in abysmal failure.

"How do you jettison your constitutional provisions because you want to crookedly plot the ticket of the party for Alhaji Atiku Abubakar," he asked.

Afegbua categorically stated that "it is obvious that Dr. Ayu is pretentiously working for Alhaji Atiku Abubakar, and in the process trying to upturn the zoning arrangement.

"How can you abandon your constitutional provision as if it was an unnecessary provision, simply because you want Alhaji Atiku Abubakar to contest the election against the run of play?

"For jettisoning zoning, PDP will pay dearly for it some day. It may not be now, but certainly later. Give us the wrong candidate, and you all will see how Nigerians will return APC back to power. An injustice of this nature cannot endure the test of time."

He said, if by political accident, the party succeed in their plot to feature a Northern candidate, adding that Iyorchia Ayu should be prepared to resign his position immediately without further delay. "He cannot eat his cake and have it, or take the Southern part of the country for granted," he added.

He vowed that all those Southern PDP Governors who are part of the plot to foist a Northern candidate on the party will soon be exposed to all.

Speaking further, he said that "how do you reconcile the hypocrisy in asking the Central Bank of Nigeria Governor Godwin Emefele to resign because you feel he didn't respect the CBN Act, when you have also jettisoned the party's constitution; such double standard posturing.

"Nigeria democracy has a long way to go because people are never honest and altruistic. Due to corruption, some will even forget their names or where they come from."

The Trumpet recalls that at the 96th meeting of its National Executive Committee (NEC) Wednesday the party "noted the recommendation of the Zoning Committee that in the interest of justice and fair play, the Party should take decision on Zoning timeously so as to prevent complications to the process.

Emefiele can't continue as CBN governor, PDP insists

Peoples Democratic Party (PDP) has reiterated that Dr. Godwin Emefiele cannot continue as Governor of the Central Bank of Nigeria (CBN), demanding his immediate resignation.

The party's demand is hinged on a comment attributed to Emefiele that he is "having a lot of fun." PDP described as "reckless, irresponsible and unpardonable" actions which are in violation of the CBN

Act 2007 and the Public Service Rules. "This comment by Emefiele who also stated that Nigerians can go ahead and 'have heart attack' over the widespread anxiety in the country arising from his involvement in partisan politics, is provocative and enough to trigger a nation-wide restiveness, pitch Nigerians against the CBN, shut down the economy and destabilize the polity," said the party in a statement by its spokesman, Debo Ologunagba on Saturday.

The PDP asserted that despite Emefiele's alleged withdrawal from the Presidential race due to the pressure, he still cannot continue as CBN Governor having become partisan as a card-carrying member of the All Progressives Congress (APC).

The PDP said: "the CBN which keeps all sensitive materials for elections cannot be trusted with the custody of such materials with a biased Mr. Emefiele at the helm of affairs.

"It was despicable to watch Mr. Emefiele on Thursday May 12, 2022 at the Presidency, brazenly and derisively spit at the concerns of millions of Nigerians, the International Community and the Corporate World when he said of Nigerians, "let them have heart attack. It's good to have heart attack. I am having a lot of fun."

"Mr. Emefiele has crossed the red lines; he is provoking and daring Nigerians to do their worse especially in the face of huge allegations and revelations of massive looting, manipulations and doctoring of the books in the CBN under his watch as recently exposed in a leaked phone conversation and for which he ought to be behind bars.

"His unthinking and insensitive comment further establishes that he is not a fit and proper person to hold public office and continue the coordination of our national commonwealth as the CBN Governor, having exposed his lack of the required professionalism, code of conduct and regard for public concerns on issues that affect our economy and the electoral process.

"It also underpins the thoughtlessness and endemic corruption in the Buhari-led APC government and further shows the decadence in the CBN under Mr. Emefiele.

"The fact that President Muhammadu Buhari has failed to decisively rebuke and sack Mr. Emefiele only confirms that impunity is an official policy of the APC administration.

"Emefiele should know that Nigerians

will never have heart attack because of APC's impunity. Instead, they are now, more than ever before, ready and resolute to confront the situation and rescue our nation from the stranglehold of the APC.

"Now that he has been confirmed to be a card-carrying member of the APC, Mr. Emefiele must forthwith steer clear of the CBN as he cannot continue as the Governor. Anything short of that amounts to testing the will of the people and the PDP will not hesitate to call out our members and teeming supporters across the country to, within the ambit of the law, defend and protect the integrity of the CBN and our electoral process."

The party warned that Emefiele should be ready for investigation, prosecution and possible conviction for the atrocities allegedly superintended by him as the CBN Governor.



Ebonyi community tackles Umahi's aide over alleged fake endorsement

Ezzagu in Ishielu local government area of Ebonyi has tackled the Special Assistant to Governor David Umahi, Chief Emmanuel Igwe over his claim that stakeholders and Leaders of Thought from the community have endorsed some aspirants for the 2023 general election in the state.

Why I didn't sign APC withdrawal form - Andoaaka

Mr. Michael Kasse Aondoakaa, Senior Advocate of Nigeria, is a former Attorney-General of the Federation and Minister of Justice under the Peoples Democratic Party (PDP) administration between July 2007 and February 2010 before defecting to the ruling All Progressives Congress (APC) on which platform he seeks to contest the 2023 governorship election in Benue State. After returning his nomination forms, he tells journalists his mission in the race and why he did not sign the APC mandatory withdrawal form. Politics Editor, **TUNDE JOSHUA** brings excerpts.

What's your vision?

First of all to make Benue a very peaceful state with its neighbours. My dream is to make sure that all citizens living in Benue have equal rights, opportunities to do their activities. Those who are doing business, farming, and farming is not restricted to only crops farming, all forms of farming, they should do their business harmoniously. That is number one. Once we secure the state effectively and we also ensure that people live in peace with one another without saying this man is Hausa, this one is Igbo this one is Tiv, then we can make progress in the state. You know agriculture requires peace, if you don't have peace, you can't do it. Then, my first task is to have a peaceful Benue so that people will hear Benue as peace loving people, there will not be so much shouting. We will try to manage our crisis and minimize communal clashes amongst the people. Then, the next thing is to aggressively transform potentials we have in agriculture and try to make sure that we export agriculture. Our agricultural produce will be exported. We produce literally everything but because we have not been able to harness our potentials in terms of exporting agriculture. We have not been able to do that. So, if we achieve that, it will contribute to agricultural development of the nation. Our dream is to feed the country.

Your party included in the forms for each aspirant, a letter of withdrawal meant to be signed by all. As a lawyer, what does this letter portend and did you sign it and if not, why?.

Unfortunately, I did not sign and I sought clearance. The implication is a two way traffic. If you sign that agreement now and you win election and the opponent come to know that you signed the agreement, I can bet you, your elec-

tion will be invalidated. If you sign an agreement that you have withdrawn from the race, assuming you win the election, you participated in the general election, the opposition party will file an action that you did not partake in the election and when that form is subpoenaed and produced, it stands before the law that you have withdrawn from the election. So you can not be part of it. So, I think what the leadership of the party intended is to have that withdrawal in the case at the time of primaries people want to withdraw in compliance with the Electoral Act, they just fill in there and a Commissioner for Oaths will endorse it. It can not be intended that you withdraw before you participate, it looks absurd because if you win the election, the election will be invalid.

What will you do to improve the security situation in Benue State?

Benue is not the only one with insecurity. Insecurity is all over the country. The insecurity started during our time when I was in the office. Because of the collapse of the government in Libya, people moved

with small weapons down to South Sahara, down to our region. And most of them who were in the Libya Army were blacks. So, after Gaddafi was overthrown, the new government and you know that there was no strong government in Libya and there was kind of persecution and most of the soldiers ran with light weapons and they came in. The insecurity is an external aggression that is spreading within the country but it is something that after some years it will go. Because we had the great wild wild west in America that it was so frightening that people thought America will tear but what happened? It dissolved (and finished). We will overcome it and that is why I will not expect insecurity to be something a politician will use against others. There are many valid things to use. You don't talk security on the pages of newspaper and you also don't shout security. It is something that governors should join hands with the federal government to find a solution. It is a delicate issue. It is something that started during our time and we were not loud about it. We had cooperation from the governors that time. I was the Attorney General, we have issues and we were resolving them. I don't know why others make news out of it. Because if you say it is only Benue, it is not correct. You have happenings in Plateau, Katsina, Zamfara. The next set of governors in the north, which I hope to be part of, should come together and form a strong security buffer to protect our northern part of the country because the influx of these criminals is coming more to us. It is not something you will say I am APC, I am PDP, then you start looking for a tribe to blame. In Benue if you say Fulani are killing us what will Masari say in Kastina? They are Fulani but the attacks are more vicious. It is something that goes beyond accusations amongst ourselves and we should be able to solve the problem once and for all.

NCC alerts all to new ways hackers unlock, steal vehicles, android apps

It said that the fact that car remotes are categorized short range devices that make use of radio frequency (RF) to lock and unlock cars informed the need for the Commission to alert the general public on this danger, where hackers take advantage to unlock and start a compromised car.

According to the latest advisory released by the Computer Security Incident Response Team (CSIRT), the Cybersecurity Centre for the telecom sector established by the NCC, the vulnerability is a Man-in-the-Middle (MitM) attack or, more specifically, a replay attack, in which an attacker intercepts the RF signals normally sent from a remote key fob to the car, manipulates these signals, and re-sends them later to unlock the car at will.

The Commission said that with this latest type of cyber-attack, it is also possible to manipulate the captured commands and re-transmit them to achieve a different outcome altogether.

"Multiple researchers disclosed a vulnerability, which is said to be used by a nearby attacker to unlock some Honda and Acura car models and start their engines

wirelessly.

"The attack consists of a threat actor capturing the radio frequency (RF) signals sent from your key fob to the car and resending these signals to take control of your car's remote keyless entry system," the advisory stated emphatically.

However, the NCC-CSIRT, in the advisory, has offered some precautionary measures that could be adopted by car owners to prevent falling victim to the attack.

According to the cyber-alert unit of the Commission, "When affected, the only mitigation is to reset your key fob at the dealership. Besides, the affected car manufacturer may provide a security mechanism that generate fresh codes for each authentication request, this makes it difficult for an attacker to 'replay' the codes thereafter."

It said that vulnerable car users should store their key fobs in signal-blocking 'Faraday pouches' when not in use.

Importantly, the Commission said that car owners in the stated categories are advised to choose Passive Keyless Entry (PKE) as opposed to Remote Keyless Entry (RKE), which would make it harder for an attacker to read the signal due to the fact that criminals would need to be at close proximity to carry out their nefarious acts.

It explained that the PKE is an automotive security system that operates automatically when the user is in proximity to the vehicle, unlocking the door on approach or when the door handle is pulled, and also locking it when the user walks away or touches the car on exit.

The RKE system, according to the Commission, on the other hand, represents the standard solution for conveniently locking and unlocking a vehicle's doors and luggage compartment by remote control.

Additionally, in a related advisory, the NCC, based on another detection by CSIRT, informed the general public about the resurgence of Joker Trojan-Infected Android Apps on Google Play Store.

This arose due to the activities of criminals who intentionally download legitimate apps from the Play Store, modify them by embedding the Trojan malware and then uploading the app back to the Play Store with a new name.

It said that the malicious payload is only activated once the apps goes live on the Play Store, which enables the apps to scale through Google's strict evaluation process.

Once installed, these apps request for permissions that once granted, enable the apps to have access to critical functions such as text messages and notifications.

As a consequence, it explained further that a compromised device will subscribe unwitting users to premium services, billing them for services that do not exist. A device like this can also be used to commit Short Messaging Service (SMS) fraud while the owner is unaware.

"It can click on online ads automatically and even use SMS One Time password (OTPs) to secretly approve payments. Without checking bank statements, the user will be unaware that he or she has subscribed to an online service. Other actions, such as stealing text messages, contacts, and other device data, are also possible," the Commission said.

It warned that to avoid falling victim to the manipulation of hackers deploying Joker Trojan-Infected Android Apps, Android users must avoid downloading unnecessary apps or installing apps from unofficial sources.

The NCC also said it wishes to advise telecom consumers to ensure that apps installed from the Google Play Store are heavily scrutinized by reading reviews, assessing the developers, perusing the terms of use and only granting the necessary permissions.

Govt's Executive Order 5, tech innovation in Nigeria

Deepening knowledge-based economy that is innovation-driven and ensuring rapid movement of Nigeria towards becoming an industrialised nation are the two most important elements missing in the country's quest towards attaining economic buoyant status, according to some technology and economic experts. Without these two elements, they said, the country may find it difficult to climb the economic and technological ladder of development.

In 2018, when President Muhammadu Buhari signed the Executive Order 5, the Federal Government hinted that the executive order will take care of the two missing elements. But this has yet to happen, four years after.

In a proclamation entitled "Presidential Executive Order for Planning and Execution of Projects, Promotion of Nigerian Content in Contracts and Science, Engineering and Technology," President Muhammadu Buhari, pursuant to the authority vested in him by the constitution, signed on Friday, February 2, 2018 the Executive Order No. 5 ("EO5") by which all Ministries, Departments and Agencies ("MDAs") of government were directed to engage indigenous professionals in the planning, design and execution of national security projects and maximise in-country capacity in all contracts and transactions with science, engineering and technology components.

The thrust of the EO5 is the recognition of the vital role of science, technology and innovation in national economic development, particularly in the area of promoting Made in Nigeria Goods and Services ("MNGS"). Strategically, the main objectives of the EO5 are the harnessing of domestic talents and the development of indigenous capacity in science and engineering for the promotion of technological innovation needed to drive national competitiveness, productivity and economic activities which will invariably enhance the achievement of the nation's development goals across all sectors of the economy.

The EO5 makes certain specific directives which include the following: All procuring authorities shall give prefer-

ence to Nigerian companies and firms in the award of contracts, in line with the Public Procurement Act, 2007;

Where expertise is lacking, procuring entities shall give preference to foreign companies and firms with demonstrable and verifiable plan for indigenous capacity development, prior to the award of such contracts;

MDAs shall engage indigenous professionals in the planning, design and execution of national security projects and consideration shall only be given to a foreign professional, where it is certified by the appropriate authority that such expertise is not available in Nigeria;

Nigerian companies or firms duly registered in accordance with the laws of Nigeria, with current practising licence shall be lead in any consultancy services involving Joint Venture (JV) relationships and agreements, relating to Law, Engineering, ICT, Architecture, Procurement, Quantity Surveying, and etc.;

MDAs shall ensure that before the award of any contract, Nigerian counterpart staff are engaged from the conception stage to the end of the project and shall also adopt local technology that meet set standards to replace foreign ones;

The Ministry of Interior is prohibited from giving visas to foreign workers whose skills are readily available in Nigeria;

The Federal Government shall introduce Margin of Preference ("MoP") in National Competitive Bidding, in the evaluation of tenders, from indigenous suppliers of goods manufactured locally over foreign goods (MoP shall be 15% for both international competitive bidding for Goods and domestic contractors for national competitive bidding for Goods. For Works for domestic contractors, the MoP shall be 7.5%);

Foreign companies or firms shall not be engaged in contracts for Works, Goods, and Services in the country in violation of the standard international best practices as provided for under relevant statutes such as the Companies and Allied Matters Act (CAMA), Council for Regulation of Engineering (COREN) Act, Chartered Institute of Purchasing and Supply Management Act, Public Procurement Act, and the National Information Technology Development Agency (NITDA) Act as well as other relevant Nigerian laws and regulations on acquisition of technology and conduct of public procurement;

MDAs shall ensure that all professionals practising in the country are duly registered with the appropriate regulatory bodies in Nigeria, and shall ensure, in collaboration with the Head of the Civil Service of the Federation, that all foreign professional certificates are domesticated with the relevant professional bodies before being considered for any contract award or employment in Nigeria;

Agreements involving any Joint Venture and Public Private Partnership (PPP) between a foreign firm and a Nigerian firm, for technology acquisition or otherwise, shall be registered with the National Office for Technology Acquisition ("NOTAP") in accordance with the provisions of the NOTAP Act, before such contract are signed by the MDAs;

A Nigerian company or firm shall not be disqualified from an award of contract by any MDA on the basis of the year of incorporation except on the basis of qualification, competence and experience of the management in the execution of similar contracts;

NOTAP shall develop, maintain and regularly update a Data Base of Nigerians with expertise in science, engineering, technology and other

fields of expertise while the Ministry of Interior shall take into consideration the NOTAP Data Base together with other similar data from the Nigerian Academy of Engineering; Nigerian Content Development and Monitoring Board; Federal Ministry of Science and Technology and other relevant Ministries; in determining the availability of local skilled manpower in Science, Technology and Innovation (STI) for the grant of Expatriate Quota;

The secretariat is domiciled in the Federal Ministry of Science, Technology and Innovation (FMSTI), managed by the Strategy Implementation Task Office for Presidential Executive Order No. 5 (SITOPEO-5) and headed by a national coordinator.

The mandate of the secretariat includes overseeing a complaints/appeal board that will receive administrative complaints and appeals from communities, stakeholders, professional bodies, contractors, manufacturers around MDAs planning and execution of projects, promotion of Nigerian content in contracts and science, engineering and technology for remediation.



Zinox to take over Jumia

There are indications that Nigerian billionaire and Chairman of Zinox Group, Leo Stan Ekeh, might be planning a takeover bid for Jumia.

Ekeh, a former disc jockey, plans to use Zinox as the vehicle in ramping up shares in Jumia indirectly for a possible acquisition.

In 2001, the serial digital entrepreneur was not content with just distributing in Nigeria, systems that were manufactured in other countries, an idea that led him to the founding of Zinox computers. Zinox manufactures the first truly Nigerian-made Personal Computers, Laptops, Servers and UPSes.

Ekeh is credited with pioneering ecommerce in Africa with his now-defunct BuyRight Africa over 12 years ago, and he is replicating the same strategy that he deployed successfully in acquiring Yes Mobile, a cosmopolitan high-value retail outfit, Ashour Corporation, a foremost telecommunications services provider headquartered in Dubai, UAE and more recently, Konga to acquire Jumia.

Ekeh acquired Konga, another latter-day e-commerce pioneer, at a dying stage in 2018 and turned it around to the point of profitability in barely three years, becoming the first e-commerce brand to achieve this feat which industry experts have termed a miracle.

Sources claim Ekeh is supporting Konga's massive investment in technology,

logistics with a recent investment of over N4b and other infrastructure, including acquiring the single largest warehouse in Lagos, Port Harcourt, Abuja and Onitsha not too long ago, with the brand also attracting concrete interest from a horde of potential investors.

On the other hand, Jumia remains the largest ecommerce platform in Africa, despite its financial troubles.

Last year, the company reported a loss of \$227 million. This is one in a series of losses over the years. These losses, coupled with the declining share price, a drop in valuation to \$477 million and a further drop in net equity to \$413 million, raise insolvency concerns.

Jumia appears to be battling severe headwinds after its share price – which once traded at record highs of \$59.96 tumbling down and currently trading at Leo Stan Ekeh less than \$5 - prompting speculations of a loss of investor confidence and a surprise takeover by Sub-Saharan Africa's leading tech conglomerate, the Zinox Group.

In April 2019, Jumia had listed on the New York Stock Exchange (NYSE) with an eye-catching IPO which witnessed share prices opening at \$14.5 and rising as high as \$26. However, two weeks after, a damning report by Citron Research had accused Jumia of fraud, describing its stock as worthless. Specifically, the report had highlighted discrepancies in financials between investor presentations and SEC filings by Jumia, accusing its management of fraudulently inflating

Okra -- which was founded in 2019, by Fara Ashiru Jituboh and David Peterside, is described as a "one-stop-shop" platform that "empowers companies and developers to build products with seamless access to inclusive financial data and secure payments," according to its website.

The other five African Technology Pioneers are three Kenyan firms, Access Afya, Sendy and Pula Advisors.

Access Afya specialises in the provision of quality and affordable healthcare for the global mass market.

Using technology, the healthtech startup leverages available "patient data to facilitate efficient diagnostic, operational and follow-up care pathways."

Sendy, another Kenyan startup specialises in building Africa's ecommerce fulfilment infrastructure for consumer brands. In other words, the company

makes "trading in Africa easier and more beneficial to more people" according to information available on its website.

Pula Advisors doubles as an insurance and technology company, designing innovative insurance and other digital products farmers. The goal is to de-risk all agricultural investments and guarantee profit.

Others are Ampersand of Rwanda, a startup that has been described as the leading battery-swap energy network for light vehicles. Information available on its website says: "we offer East Africa's five million taxi motorcyclists a commercial electric motorcycle that is cheaper from day one, provides better overall user experience and requires minimal customer behaviour change."

Ejara, the Cameroonian startup specialises in helping Africans at home and in the diaspora to invest in different forms of investments including equities, cryptos and commodities, among others ..

Last year, eight African startups were named in the WEF 2021 Technology Pioneers list. The startups are: Cambridge Industries (Ethiopia), FlexFin Tx (Zimbabwe), Kuda (Nigeria), Moringa School (Kenya), mPharma (Ghana), Sokowatch (Kenya), 54Gene (Nigeria), and Gro Intelligence (Kenya).

According to WEF, the Technology Pioneers' list is an assemblage of leading "early-to growth-stage companies from around the world that are pioneering new technologies and innovations."

These startups are at the forefront of their industries, leading change and solving some of the world's most pressing problems, including climate change, food security, cybersecurity, among others.

Although Jumia denied any wrongdoing, the allegations from Andrew Left, founder of Citroen Research, resulted in a class-action lawsuit which Jumia recently settled out of court for \$5m.

However, the debacle appeared to have seen investor confidence in Jumia take a huge bashing, with the likes of Rocket Internet and MTN Group, among others, exiting. Several reports and articles in local and international media also detailed how the company which prided itself as the continent's first

order numbers while also labelling it unicorn fell from grace and how Jumia's misadventure had tainted the potential of African e-commerce.

Ekeh, a restless but very passionate e-Commerce enthusiast, is rumoured by sources to be keen on consolidating the e-Commerce brand with a presence in 15 African countries under Konga to actualize his great but very silent ambition to alter the destiny of Africans.

Zinox Group's Head of Corporate Communications, Gideon Ayogu, neither officially confirmed nor denied the speculation. He did, however, say that "nothing positive is impossible".







Refineries top Nigeria's forthcoming 109 oil and gas projects in 2023

new report released by Global Data has indicated that downstream projects will top upcoming oil and gas investment in Nigeria by 2026.

The report said that more than 100 oil and gas projects

will initiate operations in Nigeria in the coming four years accounting for over 24 per cent of the estimated total projects starting during that time.

According to Global Data, a data and analytics firm Africa Oil and Gas Projects Analytics and forecast by project type sector, countries development stage, capacitor and cost from 2022 to 2026, disclosed that of the 109 projects expected to commence operations in Nigeria, petrochemical will account for 14, upstream 26, midstream 31 and downstream refineries will have the highest amount with 38.

An oil and gas analyst with Global Data, Teja Poppula said:

"Nigeria is primarily investing in oil and gas production storage projects during the next five years."

He said these forthcoming projects would increase Nigeria's economy and help the country to change from an importer to an exporter of refined products, particularly to neighbouring countries.

The oil expert averred that amid the upcoming projects being started in Nigeria, Lagos is a crucial project with a total capacity of almost 650 thousand barrels daily expected to initiate in 2022, it will be the most significant individual refinery in the whole of Africa and it is presently in the stage of construction. Poppula further added that Midstream projects account for about 28 per cent of oil and gas processing projects compressing the majority of upcoming midstream projects with ANOU-Seplat, ANOH-SPDC and Brass, being the key projects with capacity of over 300 million cubic feet per day each.

The nation is also making major investment in natural gas processing pipelines as well as liquefied projects to decrease its dependence on oil, which presently drives the majority of revenue in the country.

He said that through this Nigeria will be accounting for 24 per cent of oil and gas projects by 2026 in Africa continent.

•Collaboration crucial for safety, says Jamoh

The Nigerian Maritime Administration and Safety Agency (NIMASA), the Nigerian Navy and the Inter-regional Coordination Centre (ICC) have advocated the need for continuous collaboration with regional and international stakeholders to ensure the sustainability of security in the Gulf of Guinea (GoG).

This was the thrust of presentations at the fifth plenary of the Gulf of Guinea Maritime Collaboration Forum, Shared Awareness and De-confliction meeting with the theme: Enduring And Sustainable Security.

Director General of NIMASA, Dr. Bashir Jamoh, who noted that collaboration and co-operation remain crucial in attaining enhanced security in the GoG in recent times, restated NIMASA's commitment to providing all logistics required for members of the SHADE Forum to thrive and maintain the momentum.

He said: "Two years ago, we connected virtually with our unhappy stakeholders, with challenges of piracy attaining its peak in the GoG between 2019 and 2020. But today, even the International Maritime Bureau (IMB), has affirmed that piracy is at a 28-year all-time low in the region.

region. "The SHADE must be nurtured to remain a force for good. As members we owe a collective duty to this forum to keep its dialogue robust and guard it from slipping into complacency as to become a toothless bulldog. It must be strengthened through cooperation, coordination, collaboration and communication. Security success can never be by solitary achievements.

"There must be cooperation between regional navies like we saw recently between Nigeria and Benin. We are all contributors to the success we are currently experiencing in the area of maritime security."

Secretary General of the International Maritime Organisation (IMO), Kitack Lim, who addressed the forum, congratulated Nigeria on the efforts at improving security in its territorial waters and the entire GoG domain, challenged members of the SHADE Forum to keep the momentum in sustaining the gains of the past one year. "Maintaining the momentum

"Maintaining the momentum of the gains made so far is the main challenge for the regional navies. To do so, we must address the root causes of piracy including the plight of coastal communities in order to reach sustainable solutions to piracy," he stressed.

Speaking at the forum, representative of the Chief of Naval Staff (CNS), Chief of planning, Navy Headquarters Abuja, Real Admiral Garba, noted that the successes recorded in the Gulf of Guinea was due to the collaboration, information and data sharing among the GoG countries. He stressed the need to

sustain the momentum through institutional capacity building for maritime governance.

"There is still room for greater

collaboration in the areas of Information sharing, increased presence of naval assets and strengthened legal frameworks among the GoG nations as well as international partners, which are all crucial in ensuring success of the Yaounde Architecture. The safety and security of shipping in the GoG is a vital enabler in the recovery process of global economy and trade disruptions due to COVID-19 pandemic," he said.

CRFFN, Tanko debunk purported inauguration of governing board by Amaechi

Chairman of the 100% Compliance Team of the National Association of Government Approved Freight Forwarders (NAGAFF), Alhaji Ibrahim Tanko, has debunked claims that the Minister of Transportation, Rotimi Chibuike Ameachi, has inaugurated the Governing Board of the Council for the Regulation of Freight Forwarding in Nigeria (CRFFN).

Tanko also stated that there was nothing like imposition of a Chairman on the board and that the selection of principal officers was done by consensus of all the elected and appointed members, who were present at the meeting.

the meeting. He told *The Trumpet* that contrary to reports that the board had been inaugurated, what took place was a meeting with the Minister of Transportation on the election of principal officers, including the Chairman.

"Tve just returned from Abuja. While there, I heard people saying that the Governing Board of the CRFFN has been inaugurated, but that is not true. They invited us to a meeting with the minister. To me, the purpose of the meeting was to elect the chairman and the vice chairman," he said. He informed that as they

He informed that as they settled down for the meeting, the minister walked in saying he had not more than one minute to spend with the members. He said the purpose of the gathering was to see if all could agree that "the status quo should remain" to which everybody chorused "yes."

He stated that as the minister was about leaving, one of them asked him about the formal inauguration of the board to which he answered that left to him, the body was as good as having been inaugurated.

At this juncture, he disclosed that a lawyer representing the ministry clarified that the forum was not for inauguration and that formal letters to communicate when the exercise would take place, would be written to them. He said thereafter, the minister left and that the Chairman, Alhaji Abubakar Tsanni, addressed the members, thanking them for their support and promised to work with them all the meeting ended after that.

According to him, what happened was that as we settled down for the meeting, the minister walked in and told us that he did not have more than one minute to spend with us, because of other engagements. He said the essence of convening the meeting was "to find out if we all can agree that the status quo should remain and by that he meant that if the chairman and the vice should continue and we all said yes.

"Nobody objected to his suggestion. If anybody had objected, we would have conducted the election there and then, but nobody did. I'm surprised to hear people saying he imposed the Chairman on us. Manufacturer sues NDLEA, demands N200m, apology over alleged N22b tramadol deal Managing Director of Mallinson the fact that there is a federal enshrined in section 35 of & Partners Limited, Mallinson High Court within 40 Kilometers 1999 Constitution as amen

& Partners Limited, Mallinson Afamefuna Ukatu, has sued the National Drug Law Enforcement Agency (NDLEA) at the Federal High Court, Lagos in an attempt to prevail on the NDLEA to release him unconditionally, or on terms the court may deem fit.

It would be recalled that NDLEA alleged that Ukatu imported two containers containing 1,284 cartons of Tramadol worth N22 billion in 2021 and also fingered him in a N3 billion shipment of Tramadol linked to the embattled senior police officer, Abba Kyari, who is being tried for sundry offences.

Besides insisting on his innocence, Ukatu also argued that the NDLEA not only failed to arraign him in court, despite the fact that there is a federal High Court within 40 Kilometers radius or where he was being held, but also failed to grant him administrative bail since his arrest on April 13, 2022.

Ukatu prayed the court to declare that his arrest by the NDLEA on April 13, 2022 at the Murtala Mohammed Airport terminal in Ikeja, Lagos, and his continued detention in the NDLEA office at NAHCO facility, was without reasonable cause or reasonable suspicion of a crime, which violates his fundamental rights.

He further prayed for an order of perpetual injunction restraining the NDLEA from re-arresting and further detaining him, contrary to his fundamental rights to liberty and freedom, as enshrined in section 35 of the 1999 Constitution as amended, among other legal provisions in the country.

The applicant made the prayers in his originating summons in a suit marked: FHC/L/CS/696/2020 before Justice Nicholas Oweibo, filled by his counsel, Victor Opara (SAN) of Victor Opara Chambers and in the alternative, prayed for an order admitting him to bail on liberal terms pending the conclusion of NDLEA's investigation or his arraignment.

He further sought an order directing the NDLEA to apologise to him publicly for the unlawful arrest and detention to be published in three national newspapers and an order directing the NDLEA to pay him N200 million damages for his unlawful arrest and detention.





Naira crashes as Emefiele's presidential quest suffers setback

The Naira saga across the foreign exchange (FX) nosedived just as presidential ambition of Governor of the Central Bank of Nigeria, Godwin Emefiele, seems to have suffered a major setback. At the investors and exporters

Naira was sold for N418.75 kobo. *The Trumpet* checks showed that the Naira has suffered serious loss amid the Monetary Policy's FX market intervention. The parallel market rate inches higher to N598 to one United States of America dollar, though it moderated to N59\$.

In 2019, the official exchange rate was N197 but low export receipts, high import bills and export receipts, high import bills and scarcity of dollar inflows bills and scarcity of dollar inflows have weakness the local currency which hit N420 per one United States dollar in the official window in March 2022.

National Executive Council (NEC) of ABCON said the move to save the Naira was agreed upon at its meeting in Lagos, where it unveiled strategies for save the local currency, bridge the exchange rate gaps and curb volatility in the Forex market.

The naira exchanges at N596 to the dollar at the parallel market and N415.83 to the dollar at the official market, thereby creating a gap of N180.17 per dollar.

ABCON President, Dr. Aminu Gwadabe, said there was urgent need to enhance dollar liquidity in the market and ensure stability of prices in the economy, saying the steps would save the local currency and economy from the impact of election spending that has kept inflation at double digits.

He disclosed that the deprecia-

tion of the naira against global currencies was due to pressure from rising dollar demand without sufficient liquidity to meet the demands from retail end users, manufacturers and other key players in the economy.

"The Naira has consistently come under serious pressure due to dollar scarcity, making it difficult for Forex end users, manufacturers and industry players to access dollar to meet their needs. ABCON under my leadership will continue to encourage our members to play the vital role of closing the exchange rate gaps in the market and reducing widening premium between the parallel market and the official window," he said.

Gwadabe listed several factors that continue to undermine the Naira stability and the local currency's value against other currencies called for the creation of BDCs Autonomous Foreign Exchange Trading Window (BAFEX) with determined maximum daily limit for legible BDCs to access dollars from banks, autonomous market and Diaspora Forex widow at prevailing market prices.

NDLEA seizes Italy, Dubai-bound drugs, 203,879 Tramadol tabs in Lagos, others Busts fake employments syndicate

peratives of the National Drug Law Enforcement Agency (NDLEA) have frustrated fresh bids by drug cartels to export Tramadol, Ecstasy MDMA and Cannabis to Milan, Italy and Dubai, United Arab Emirates through the Murtala Muhammed International Airport (MMIA), Ikeja Lagos.

Spokesperson of NDLEA, Femi Babafemi who disclosed this said the agency seized 203, 879 tablets of various pharmaceutical opioids and illicit substances in raids across Abia, Kaduna, Yobe and Kogi state.

He said: "At the Lagos airport, a female passenger, Odia Emiliana Efe was arrested on Monday 9th May why trying to board Royal Air Moroc flight from Lagos via Casablanca to Milan, Italy with 1000 tablets of Tramadol 200mg concealed in food items.

"Five days after, Friday 13th May, a freight agent Kareem Ibrahim was arrested at the SAHCO cargo shed of the airport for attempting to export food items in which were hidden blocks of cannabis weighing 6.65kg and 24grams of ecstasy drug, MDMA to Dubai in UAE. "In Abia, three trucks loaded with drugs coming from Lagos and Onitsha, Anambra were intercepted in Aba, Abia state. When properly searched in the presence of the owners on Wednesday 11th May, 67,100 tablets/capsules of Tramadol and 12,650 ampules of pentazocine, morphine and dopamine were recovered.

"On the same day, NDLEA operatives in Kaduna arrested a notorious drug dealer, Shehu Kabiru a.k.a Dan-Zaira, wanted by the Kastina Command of the Agency for jumping bail. Recovered from him include: 45,000 tablets of Diazepam weighing 41.5kg; 50,000 tablets of Exol, weighing 15.6kg; 1,500 tablets of Rohypnol weighing 700 grams and 300 bottles of codeine weighing 41.5kg.

"In Yobe state, no fewer than 7,029 tablets of Tramadol, D5, and Exol as well as 1.5kg cannabis were recovered from a drug dealer, Ibrahim Yakubu when his hideout was raided in Unguru town on Sunday 8th May, while in Rivers state, one Chekiri Richard Obomanu was arrested at Eleme area on Wednesday 11th May with 207.2kg cannabis.

"No less than 19,600 tablets of Tramadol coming from Onitsha, Anambra state to Abuja were intercepted and recovered along Okene/Abuja highway on Wednesday 11th May by NDLEA operatives in Kogi state."

Meanwhile, five members of a syndicate, which conducts fake recruitment into security agencies,

have been arrested in coordinated operations in Zamfara, Kebbi and Bauchi state, Babafemi further stated.

"Leader of the gang, Yakubu Sani was first arrested in Gusau, Zamfara state. His criminal gang issues fake NDLEA employment letters and identity cards to unsuspecting members of the public for the sum of N400,000 per person.

"A follow up operation in Zuru, Kebbi state led to the arrest of another gang member, Ibrahim Isah, while three others; Dahiru Musa Limanchi, Gambo Danladi and Umar Abubakar were nabbed in Bauchi state. Recovered from them include: a fake NDLEA ID card; NDLEA guarantor form; INEC offer of appointment letter; Nigerian Customs Special Replacement Form and appointment letter; Nigerian Correctional Service Replacement Form; Credentials of some Applicants; Receipts and passport photos; Five sim packs and one MTN SIM card," he states.

While commending officers and men of the MMIA, Abia, Kaduna, Yobe, Rivers and Kogi for the arrests and seizures, the Chairman/Chief Executive Officer of NDLEA, Brig Gen Mohamed Buba Marwa (Rtd) charged all men of he agency not to rest on their oars but continue to aspire to beat previous records.

He equally acknowledged the wellconducted operations in Zamfara, Kebbi and Bauchi that nailed five members of a criminal gang scamming innocent job seekers with fake employment letters.

Soludo meets Kanu, says IPOB members to maintain peace

He expressed sadness over what he described as "sacrilegious killings" of innocent persons, kidnappings and all forms of criminalities, including the brutal enforcement of the senseless "sit at home" perpetuated by sundry groups claiming to be acting for or on behalf of IPOB.

"He assured that if the opportunity arises, he will be glad to personally broadcast to his followers to maintain the peace. Together, we shall restore peace, security and prosperity in Anambra and the Southeast." Nigeria Ethnic Nationalities Youths Leaders Council (NENYLC) has called on President Muhammadu Buhari to declare a state of emergency In Sokoto due to religious riot and protests that followed the condemnation and arrest of suspects behind the

gruesome murder of Deborah Samuel. Some placard-carrying Muslim youths began a protest in Sokoto on Saturday morning and demanded the release of two suspects arrested in connection with the gruesome murder of Deborah, a 200-level Home Economics student of Shehu Shagari College of Education in Sokoto.

Some of the protesters besieged the palace of Muhammad Sa'ad Abubakar, the Sultan of Sokoto and the highest spiritual figure among Muslims in Nigeria, after he condemned the killing and demanded those involved face justice. Governor of the State, Aminu Tambuwal has already declared a 24-hour curfew.

Deborah was mauled and burnt to death on Thursday on the school premises for alleged blasphemy of Prophet Muhammad (SAW).

Group asks Buhari to declare state of emergency in Sokoto

NENYLC, a coalition of over 407 Ethnic groups, condemned the murder and called for justice, saying all the perpetrators should be brought to book accordingly.

In a statement signed by its president general, Comr Terry Obieh and Secretary, Aare Oladotun Hassan, the group called on Nigerians to shun religious and ethnic bigotry and embrace tolerance and harmony while asking the President to declare a state of emergency.

The statement reads, "As we all reflect and condemned the gruesome murder of Deborah in an institution of higher learning in Sokoto, over religious intolerance, very important to call Nigerians to shun all forms of religious and Ethnic bigotry, while maintaining peaceful coexistence, religious tolerance and harmony respectively.

"We condemn in strong terms this dastardly act, while calling on the authority to prosecute and melt out appropriate sanctions to everyone involved in the heinous crimes.

"It's worthy of note that Sokoto

State being the supreme custodian of Islamic religious practices in the northern part of the country is highly sensitive to ignite religious and consequential Ethnic wars and uncontrollable attritions, if the current hydraheaded spiral mass protests leading to burning of the Sokoto Arch Diocese Catholic Church headed by Rev. MNJTF kills terrorists in Lake Chad axis

Multinational Joint Task Force (MNJTF) has said it has killed about 300 Boko Haram/Islamic State West African Province (ISWAP) fighters in the Lake Chad axis.

This was disclosed by the Chief of Military Public Information, Lt.-Col. Kamarudeen Adegoke, in a statement issued on Saturday At Maiduguri. The terrorists were killed in 30 separate encounters. Adegoke in the statement said that the Force Commander, Gen Abdul Khalifa had made the revelation during an appraisal meeting with all Commanders of the MNJTF drawn from all sectors.

According to him, Khalifa said the meeting was designed to appraise the operations so far in preparation for the next decisive stage.

He said that an increasing dependence on Improvised Explosive Devices (IED) by the insurgents was noted and necessary counter measures were proffered. "About four IED making factories

"About four IED making factories were destroyed in the course of the operations so far," he said.

He praised the decisive role of the Air component of the MNJTF/ Operation Hadin Kai for the remarkable role it played in taking out several enemy camps, equipment and commanders.

The force commander said the latest being Abu Ibrahim, an ISWAP

leader (Khalifa) in the Lake Chad Tunbumas, who was a leader before in the Timbuktu General areas.

He said that the achievement was recorded due to the synergy and cooperation with Operation Hadin Kai. According to him, more than 52,000 terrorists comprising fighters, those conscripted by force, and their families have surrendered in the MNJTF and Op Hadin Kai areas of operational responsibility.

He called on the terrorists be they

Boko Haram faction or ISWAP to abandon the criminal organisation and surrender like thousands of their compatriots had done before it becomes too late.

"The entry of the Chadian contingent provides additional firepower in terms of armoured personnel Carriers, MRAPS and other combat enablers and urged the criminal Boko Haram Terrorists/ ISWAP be hunted and wiped out wherever they are," he said.

Inadequate footage to showcase 8 NPFL players, Nigerians react

vebrows have been raised over the inability the League of Management (LMC). Company organisers of the Nigeria Professional Football League (NPFL), and clubs to provide sufficient video clips to showcase the new eight Nigerian talents to the world, The Trumpet gathered.

This followed the invitation of eight NPFL players to be among the 30man Super Eagles squad ahead of friendlies with Mexico and Ecuador.

The new NPFL players invited are Victor Mbaoma (Enyimba), Ojo Olorunleke (Enyimba), Isah Ali (Remo Stars), Ibrahim Buhari (Plateau United), Chiamaka Madu (Rivers United), Babatunde Nosiru (Kwara United), Adewale Adeyinka (Akwa United) and Ishaq Rafiu (Rivers United).

According to concerned Nigerians who vented their anger through Twitter after the NFF released a list of the 30 on May 10, 2022, this was an avenue to showcase this crop of NPFL players to European scouts.

They pointed out that the LMC and NPFL clubs do not know the importance of highlights to showcase



these players' spectacular moments in NPFL matches which are key in promoting the country's Premier League.

They highlighted that the LMC and NPFL clubs have done poorly in this regard, stressing that the organizations were supposed to explore the usefulness of the social media TV platform, YouTube to upload highlights of NPFL stars to the world.

In a response to a tweet by Jibola Babs, he said, "This is what some of us are clamouring for. Reels/ clips of these guys. It will help people know them the more to help agents get them proper contracts in proper European leagues. The players need to invest a lot into their craft. YouTube is basically the world TV."

Comparing the NPFL, which he described as being poorly organised, to the English Premier League (EPL), Igebina A. Oghenaogie lamented that they hardly grant pre or post-match conferences.

"The league has to be properly organized. Interview of coaches in EPL alone is enough content. Does NPFL have pre and post-match conferences? This is really a big issue," he said.

However, Jibola Babs, also called for a total restructuring and rejigging of the system while he advised that a Conference format that includes four or eight top-flight clubs competing at the end of the league season should be adopted.

He said, "This is why I am clamoring for a rejig, restructure and reorganization [of the system].

"Lets have a conference format and play the top 4 or 8 at the end of the season. It saves cost, time, lives, and the players' careers by reducing incessant travel. This will help," he added.

Meanwhile, the match scheduled to take place in the United States on the 28 of May with Mexico at the AT&T Stadium in Dallas, State of Texas, and on the 2nd of June with Ecuador at the Red Bull Arena in Harrison, provides only 25 spaces for the players that made it into the 30-man provisional squad.

Heartland stuns Rivers United, Enyimba, Tornadoes record wins

A statement issued by the Egyptian club after the appeal to CAF was not granted, noted that they have decided to seek a redress, backed up by documents, from CAS and appealed to CAF not to disrupt the judgement.

CAF, defending its decision, noted that Royal Morocco Football Federation was given the right to host the 2022 CAF Champions League finals after their contender, the Senegalese Football Federation, withdrew its bid.

'No good sports facilities to help athletes excel'

President of Nigeria Athletics Federation (AFN), Tonobok Okowa, has lamented the lack of standard sporting facilities to support the development of athletes into world-class stars.

Okowa said this in the third edition of the All-Comers National Athletics Championship at MKO Abiola National Stadium, Abuja.

The AFN President appealed to governments at all levels to develop sporting facilities in their territories to serve as springboards to athletes' longtime dreams of excelling on the international stage.

stage. "The major challenge of the athletes in Nigeria is lack of facilities for their training ahead of any major competition," Okowa said in the closing ceremony of the two-day event held in Package A of the stadium.

According to Okowa, this

edition which is the third after the maiden edition was held in Samuel Ogbemudia Stadium, Edo State, in March, followed by a second in April in Yaba College of Technology Sports Complex, Lagos State, serves as an avenue to scout new talents ahead of African Senior Athletics Competition coming up by June in Mauritius. He said, "The objective

He said, "The objective of it all is to select the athletes to represent Nigeria at the forthcoming 22nd African Senior Athletics Championships in Mauritius.

"Many new athletes have now been discovered and picked. They have been making waves, competing with the older athletes, and coming out with a better time than the earlier one in the grassroots development programme.

"I am therefore happy that this development is making way for the numerous



younger ones who are getting pushed," the AFN President acknowledged.

Okowa commended the event which he highlighted, fast-tracks the development of athletics among the grassroots.

Furthermore, he praised the coaches and athletes for their commitments to the sports and assured them of improved welfare packages.

improved welfare packages. He said, "The federation is set to come up with welfare packages, both for the athletes and coaches, and the more they work the better they become."

The AFN, while disclosing that the objective of the event was achieved, conceded that the names of the new talents discovered will be released until Monday.

However, the 22nd African Senior Athletics Championships is scheduled to hold in Mauritius from June 8 to June 12.

NFF gets ministry's nod over S'Eagles coach

ose Poseiro has been appointed as the Head Coach of Super Eagles after the Federal Ministry of Youth and

Sports Development headed by Sunday Dare granted the approval of the nation's football governing body to engage the Portuguese coach.

Several world-class coaches were shortlisted for the Super Eagles' top job after the disappointing outing by the team, led by interim coach Augustine Eguavoen, in the 2021 African Cup of Nations in Cameroon.

Former Barcelona boss Valverde, former Ernesto PSV coach Philipe Cocu, and former PSG and France coach Laurent Blanc were all shortlisted alongside the Portuguese gaffer, but the NFF, after the screening, found Poseiro most eligible for the job.

the Sports However, Ministry unsatisfied with the selection process conducted by the NFF, after the latter forwarded the name

Iose Poseiro as the chosen candidate, told the nation's football governing body to do a thorough screening and also give a level playing ground to all the candidates.

Ministry The Sports reminded the NFF that the senior men's national team coach would be paid from the coffers of the federal government and as such, demanded that a proper job, devoid of sentiments, favouritism, and partiality, be done.

Snippets from an anonymous source revealed that the Sports Ministry would have preferred a local coach to take over the Super Eagles job, with Sunday Olise in the loop for consideration. This is a move totally in variance with the NFF's position to hire a foreign coach.

According to the NFF, Peseiro is expected to lead out the Super Eagles for the first time during the upcoming tour of the United States of America, during which the three-time African champions will slug it out with Mexico and Ecuador 'A' Teams in prestige friendlies.

China relinguishes Asian tournament hosting rights

China has relinquished its hosting rights for the Asian Cup 2023 tournament scheduled to take place in June 2023 over the recent rise of Covid-19 in the Asian country.

The Covid-19 scourge, the worst China have witnessed since the outbreak of the pandemic, has necessitated the Chinese Football Association (CFA) to relinquish its hosting rights having formally notified the Asian Football Confederation (AFC).

"The AFC acknowledges the exceptional circumstances caused by the Covid-19 pandemic, which led to the relinquishment (by China) of its hosting rights, the AFC said in a statement.

Although the AFC is yet to decide on succeeds China in hosting the tournament, the Asian football governing body said it will announce details about the tournament in due course.



Children, soldiers killed by suicide bomber

hree children and three soldiers have killed been in an attack on a military vehicle in Pakistan's restive northwestern region bordering Afghanistan. The mountainous frontier separating Pakistan and Afghanistan has long been a hive of militant activity, with fighters using the porous border to escape state security forces.

At the weekend, a suicide bomber detonated in a small market near Miran Shah in North Waziristan, just 26 kilometers (16 miles) southeast of Afghanistan.

Pakistan's army said three children aged between four and 11 years-old were killed in the "suicide blast" alongside three soldiers in the heavily militarized area.

"The bomber came by

foot and blew himself up when a vehicle of security forces passed by," a local government official said.

Pakistan prime minister Shehbaz Sharif said that "murderers of innocent children are enemies of humanity and Islam".

"We will not sit in peace until we hunt down these barbarians and those who patronize them," he added in a statement. The attack has not yet

been claimed by any militant groups. The Pakistani Taliban

-- Tehreek-e-Taliban Pakistan (TTP) has a long history of plotting strikes in the region. The group is

group responsible for some of the bloodiest chapters of recent Pakistani history. But after a brutal massacre of nearly schoolchildren 150 in Peshawar, a 2014 military offensive crushed the movement and drove its remaining members over the border into



Afghanistan. Since the Afghan Taliban returned power to in Kabul, Islamabad increasingly has complained that it is offering safe haven to militants staging

attacks on its side of the border. However, Saturday's

blast came in the midst of a ceasefire to facilitate peace talks. In a letter, TTP

leadership had warned fighters "not to violate

the decision taken by the central command."

Separately on Sunday, police said that two Sikh shopkeepers were shot dead by two gunmen riding a motorbike in the northwestern city of Peshawar, 30 kilometers (19 miles) from the Afghan border.

Local police chief Muhammad Ijaz Khan said that "both the men died on the spot and the gunmen escaped from the scene."

Stop carnage against Igbo now, Ohanaeze youths tell Tambuwal

Ohanaeze Ndigbo has expressed outrage over the reported attacks on Igbo people and businesses in Sokoto State.

Several reports in the media indicated that businesses of the Igbo in Sokoto were subject of attacks as protested Muslims against the arrest of two suspects involved in the killing of Miss Deborah Samuel, female student accused of blasphemy. The protesters were

said to have attacked and looted shops belonging to South-Easterners. In a statement, Ohanaeze Ndigbo Youth Council Worldwide said it was enraged that Ndigbo could become subject of attacks over an issue they knew nothing about. President-General of OYC, Mazi Okwu Nnabuike, said that it was provocative that such mayhem could be unleashed on the peace-loving Igbo residents. Okwu charged Sokoto State Governor Aminu Tambuwal to ensure that there would be no repeat of such 'mindless attacks.'

"We are enraged that Ndigbo are once more victims of an unprovoked attack in Sokoto State over an issue that has to do with a Christian student from Niger State. It is quite sad that Ndigbo have remained endangered species in Nigeria, justifying the quest for secession by separatist groups led by the Indigenous People of Biafra, IPOB.

"The news we are getting from Sokoto, which we have confirmed to be true, is totally unacceptable and we demand that there should be no repeat of such carnage. "Governor Aminu Tambuwal must see to it that Ndigbo and their properties are protected in Sokoto State. Any further attack on them will come with dire consequences. We also demand that those whose properties were looted must be compensated by the government.

"Ndigbo have suffered so much in this country and we are warning that enough is enough. If they repeat this aggression against our people, it would come with a commensurate reaction," Okwu added.
