## Nigerians want new era as party primaries begin, results trickle in

ith great expectations, Nigerians are demanding the country's political elite as the various parties hold primary polls ahead of the 2023 general elections.

The main opposition political grouping kicked off the primaries at the weekend.

As at midnight Friday, President Muhammadu Buhari failed to sign the latest amendment to Section 84 (8) of the Electoral Act 2022, which political parties and politicians fervently awaited.

This inaction of the President in a way eased the high tension in the polity as it dawned on the parties that they have to go into their various primary elections with only elected delegates as authentic voters.

The Peoples Democratic Party (PDP) kick-started its primaries on Sunday with elections in the states for State House of Assembly and House of Representatives seats.

The party adhered strictly to provisions of Section 84(8) of the 2022. Electoral Act, which allows only democratically elected delegates to vote at the indirect Primaries and National Convention of political parties.

National Organising Secretary of the party, Hon. Umar Bature r said of "those to Hon. specifically sa Saturday that "those qualified and eligible to vote as delegates in the Primaries forthcoming and National Convention of our great Party, the PDP are the three (3) AD-HOC Delegates Delegates per ward, elected at the

Congresses one (1) National Delegate per Local Government, elected at the Local Government Congresses.

ruling Progressives (APC) will Congress will hold its Governorship and House Representatives primaries on Thursday May 26, Senate and States Assembly on Friday, May 27 while the presidential primary is on Sunday Mav 29.

Section 84(8) recognizes only democratically elected delegates, stating, "A political party that adopts the system of indirect primaries for the choice of its candidate shall clearly outline in its constitution and rules the procedure for the democratic election of delegates to vote at the convention, congress or meeting.'

Upon realising their exclusion from the list of those privileged by the provision to members of the National Assembly came up with an amendment to the section to include 'statutory delegates'.

Working Committee members, state party chairmen and secretaries, be allowed as voters at primaries, congresses and conventions of all the political parties.

But, these set of people captured in the statutory delegates cadre have lost out as they are not eligible by law to vote.

Independent The Electoral National Commission **INEC** requires that list of delegates to participate congresses conventions of all the political parties must be submitted at least seven days earlier.

The Trumpet learnt that a majority of the parties, APC and PDP inclusive, met the seven days window by forwarding to INEC lists that contain names of elected delegates

This means than 5,000 delegates in both APC and PDP will determine the fate of the various aspirants at their respective primaries next weekend.

It means only national delegates elected government local congresses presidential determine standard bearers of the

parties while the five delegates elected from each ward for the state congresses will vote to elect governors, senators, House of Representatives and states' House of Assembly members for the APC. This means that APC will elect its presidential candidate with 2322 democratically candidate elected delegates

For PDP, it will be the three delegates elected from each ward. The PDP will elect its presidential flag bearer with 810 delegates based on one national delegate per local government area and one each per state to cover the physically challenged.

Failure by Buhari to sign the amendment, no doubt, is a big loss to members of the National Assembly who introduced the addition to settle scores with the executive arm of government, particularly state governors.

Some in both chambers of Senate and House of Representatives who have gubernatorial ambitions or wishing to return to parliament are now at the mercy of the governors.

lawmakers have been crying foul, petitioning their parties over what they termed lopsidedness in delegates list or total hijack of the list by their state governors.

Senate Minority Leader Abaribe Enyinnaya led a few aggrieved aspirants gubernatorial in Abia to the PDP secretariat last week to protest against what they called 'fake delegates list' submitted by the state party chairman who is being backed by Governor Ifeanyi Ugwuanyi. Also last week,

former National Publicity Secretary of the party, Chief Olisah Metuh led aggrieved members of the Anambra PDP to protest shoddy handling of the state delegates list.

There are lots unsettled issues states across the parties regarding delegates list.

Those captured as statutory delegates have started counting their losses as they will be losses as they automatically shut out of the largesse expected to be enjoyed from contestants at the convention.

Presently, there are unsettled rifts in some states across parties on how to constitute the delegate list.

On the part of the aspirants, a few of them with huge financial war chests are rejoicing that limiting the voting population to elected population to elected delegates will afford them chance to determine their strengths and limitations.

Political said big spenders like Atiku, Tinubu, Wike, Tambuwal and Udom may capture fair shares of the delegates.

## Communities seek govt's intervention over water crisis

### Say corporation sends bills without service

### Youths protest, say no supply no votes

s the water crisis in Lagos State continues to linger, residents of Osogbon Community Development Areas (CDAs) in Alapere, Kosofe Council. called on the state government to urgently intervene to save them from the constant typhoid fever, cholera and deaths occasioned by the acute water shortage in the communities.

They made the call at a meeting organised the Corporate Accountability Public Participation Africa (CAPPA) under the aegis of the Our Our Right Water, Coalition, to draw the government's attention to the plight of the residents, who lamented the health challenges they have been facing and the amount money they have been spending to get water neighbouring communities.

They also alleged that the Lagos State Water Corporation has been sending them bills amounting to N2,000 per household, even though the corporation has not been supplying them water for a long

time, adding that they had to stop paying the bills as they were not getting public water supply.

Addressing the meeting, Chief Olusola Akinsanya, explained that the plight of the communities was compounded by the difficult terrain of Kosofe area, which said, makes it impossible drill to boreholes or even dig wells. He lamented that those who had attempted to build boreholes and wells ended up wasting money, suchendeavours were met with huge disappointment.

"The water challenge has been very serious since 2016 and laying pipes through canals and the difficult terrain has been frustrating. We buy 20-litre keg of water from Hausa vendors at N2,000 each. We need water because water is life. The water from our boreholes and wells is polluted and not drinkable and could not be used for cooking. This has been our experience in the last 30 to 40 years," he

Speaking, Chairman of Osogbon CDA, Chief E. O. Fadeyi, lamented that due to the perennial water shortage in the area, their properties were not being rented,

as property seekers abandoned them when they learned about the water situation in the three community developens, with an estimated population of over three million.

Vice Chairman of Osogbon II CDA, Jaye-Johnson Otubaga, wondered why the Lagos State Water Corporation was sending bills to the communities without providing water, adding that no fewer than 8 households were being billed N2,000 monthly for water not supplied.

On his part, Pastor Isaac Oketola, said: "Politicians don't listen to us. When it is time for elections, they come to beg us in our churches and mosques to ask our members to vote for them. But this time it will not work unless they provide public water.

"I go to Somolu daily to buy water with my car and I spend at least N1,000, because our boreholes and well water are not good for drinking, cooking or even washing clothes," he said.

A women leader, who told The Trumpet that she and her husband had spent over N2 million to build boreholes for their hotel and residence, said the water from

the boreholes was messy, adding that each household in the communities spend an average of N3,000 daily.

"We have begged the state government on several occasions, but no response. We are pleading again with the Lagos State Government to come to our rescue. The situation has become very unbearable. They should please help us urgently," she added.

Some youths who carried placards with the inscription: "No Water, No Election," "Lagos State Government, Please Provide Us Water and Light," among others, vowed to mobilise the youths of the area against voting in the 2023 general elections.

They pleaded with the representative of Lagos East Senatorial District, Tokunbo Abiru, the Lagos State Government and the House of Assembly to urgently assist them and provide safe and affordable potable water to save the communities.

The water crisis is evident as The Trumpet sighted rustic water tanks of boreholes and Hausa water vendors crisscrossing the entire communities to supply water to households with a huge stick and two kegs of water on each side of their shoulders.

The CAPPA team led by Director of Programmes, Jakpor and Associate Director, Aderonke Ige, said their intervention was aimed at giving communities voice and to draw the attention of the Lagos State Government and representatives of the communities at levels to rise to their responsibilities help the Kosofe people to overcome the water

### Ex-convict held at airport for allegedly importing cocaine

#### •NDLEA uncovers 4.56kg crack in lawn mowers tyres •Seizes tons of Tramadol, Codeine

Operatives of the National Drug Law Enforcement Agency (NDLEA) have intercepted 24 parcels of cocaine allegedly imported into the country through Port Harcourt International Airport (PHIA) by a Brazilian returnee, Okechukwu Francis Amaechi.

A statement by the Spokesperson of NDLEA, Femi Babafemi, on Sunday said Amaechi, who has just finished serving his jail term for drug trafficking in the South American country, concealed the cocaine in 12 tyres of lawn mowers

"The 45-year-old ex-convict from Idemili South LGA, Anambra State was arrested at the Port Harcourt airport on Saturday 7th May upon his arrival from Brazil via Doha onboard Qatar Airline flight QR1433.

"Preliminary investigations revealed Okechukwu who was arrested and convicted in Brazil for drug offences completed serving his jail sentence in March 2022, after which he decided to return to Nigeria with three new lawn mowers where he concealed 24 parcels of cocaine weighing 4.56kg.

"Curiously, each parcel concealed in the tyres of the three lawn mowers, bears some unique inscriptions, which are believed to be means of identification of the owners of the drug.

"The two parcels in one of the tyres of the first lawn mower bear O LORD and HAVE MERCY. The parcels in one of the tyres of the second mower bears the inscription IN GOD and WE TRUST, while the third mower has IJIOMA and 186.6 inscribed on the two parcels hidden in one of its tvres," Babafemi started

He added that Amaechi claimed one of his church members gave him the lawn mowers to deliver to his brother in Port Harcourt.

The statement further said in other operations across Zamfara, Kogi, Rivers, Kaduna and Kano state, no fewer than 37, 876 tablets of pharmaceutical opioids especially Tramadol; 10,884 bottles of codeine and 825.016 kilograms of cannabis sativa were recovered during raids in the past week.

According to Babafemi, "In Zamfara state, a Mercedes Benz truck with reg. no. XB 986 AGB from Onitsha to Sokoto was intercepted in Tsafe area on Friday 20th May. Apart from the driver and his assistant that were arrested, three other persons: Alex Chukwuemeka, 37; Ignatius Mokwe Odikpo, 47 and Andrew Chijokwe, 47 who are owners of the drug exhibits were arrested in a follow up operation at a hotel in Gusau while waiting to receive the consignment for possible movement to Sokoto. Seized from them include: 9,900 bottles of codeine, 599.3kg cannabis and 15,889 tablets of other opioids.

"In Kogi state, a fake security agent, Richard Agada was arrested on Wednesday 18th May while conveying 10 bags of cannabis sativa weighing 116.8kg in a white Nissan van. Various quantities of opioids and cannabis were equally seized in two separate operations the previous Tuesday and Monday in other parts of the state with the arrest of a drug dealer, Ayuba Nda Isah, 32.

"Three suspects: Nornu Abanne; Yirakpoa Emmanuel and Dornu Gbarazia were arrested at Kaani community and Bori with 90kg cannabis and 1.5gram of Cocaine on Wednesday 18th May.

"In Kaduna, three suspects: Nura Salis, Bawa Musa and Charity Jacob were arrested on Tuesday 17th of May at Warri Street within the state capital with 4,900 tablets of Tramadol, 890 ampoules of Diazepam injection, 257 ampoules of pentazocine injection, 1,950 tablets of Nitrazepam and 830 tablets of Carbazapine.

"Equally, in Kano state, a drug dealer, Abubakar Abdullahi, 47, with 5,970 capsules and tablets of Tramadol was arrested, while Nasiru Musa and Musa Mohammed were also nabbed with 5,000 caps of the same drug on Tuesday 17th May."

While commending the officers and men of PHIA, Zamfara, Kogi, Rivers, Kaduna and Kano commands of the Agency for the arrests and Chairman/Chief seizures, Executive of NDLEA, Brig Gen Mohamed Buba Marwa (Rtd) said the war against drug abuse and trafficking is one that must be won.

He therefore charged all commands of the Agency to remain on the offensive against the cartels as they take advocacy messages to communities and schools.

### Reps probe terminal operators, NPA over non-remittance of multi-million revenue

The House of Representatives Committee on Public Accounts has begun investigation into terminal operators multi-million dollars debt owed the federal government and failure of the Nigeria Port Authority (NPA) to account for billions of naira supposed to be accruing to the national treasury.

The Committee being chaired by Rep. Wole Oke want the management of the NPA to explain why such a huge amount of money owed the Federal government by terminal operators has not been recovered and paid into the federal treasury.

The investigation is sequel to 12 audit queries from the office of the Auditor-General for the Federation on the financial statement of the NPA for the 2019 financial year.

Meanwhile, the NPA management had only responded to one of the 12 queries on the indebtedness of terminal operators to the government to the tune of \$852.094 million and N1.897 billion.

The NPA said the sum of N269.410 million of the N1.8 billion has been recovered while the balance of N1.6 billion invoices processed on the encumbered areas remain unpaid.

According to the NPA, "the sum of \$504.6 million is volume change on fix lease fee payment by APM Terminal, arising from clauses in the concession agreement out of the total sum of \$852 million.

The authority noted that bills raised on encumbered areas, which remained unpaid is \$19 million, adding: "The following has been paid-GMT-\$54,707,700.08, unpaid penalties-\$11,922,642.68 and unpaid VAT-\$28,693,707.07.

It said further that "\$92,533,518.72 has been recovered leaving unpaid lease and Throughout fee in the sum of \$139,970,637.71 (made up of \$113,982,486.82 and \$5,988,150.89) respectively.

Not satisfied with the explanation on the issue, the Committee directed the NPA management to come and reconcile their position with that of the Auditor-General for the Federation and provide evidence of remitting the recovered N269.51 million and \$92.534 million to the treasury.

The NPA is also to furnish the House with a contract agreement/ Service Level Agreement, the list of all terminal operators as well as a comprehensive schedule of lease fees, Throughput fees and GMT that makes up the total amount being owed to the government by the operators.

SERAP urged the INEC chairman to "urgently examine the books and records of financial transactions of political parties, and to make public the outcome of any such examination."

SERAP also urged him to "provide details of the guidelines, and steps that INEC is taking to prevent vote buying in the forthcoming elections in Ekiti and Osun states and 2023 general elections, and to prosecute vote buyers and other electoral offenders."

Recently, the ruling All Pro-

gressives Congress (APC) and the opposition Peoples Democratic Party (PDP) collected N100 million and N40 million for their presidential form respectively for the 2023 election.

In a letter dated 21 May, 2022 and signed by its deputy director Kolawole Oluwadare, SERAP said: "Nigerians have the right to know about the accounts and financial transactions of their political parties, especially the major parties with a strong possibility to assume government in the future.

"Transparency and accountability of political parties is important to achieve greater transparency in public life, curb the influence of money in politics, promote a level playing field, and remove the risks to the independence of political actors and would-be public office holders.

"It is both immoral and illegal to pay citizens to vote for a particular political party or candidate. Unpunished cases of vote buying and related electoral offences would continue to undermine good governance, the rule of law, moral values, as well as hinder citizens' participation in elections.

The letter added: "When a political candidate decides to buy the support of the people rather than contest fairly for their votes, there are possibilities that such candidate will show a disregard for democratic rules and a disposition to adopt illegal means becomes inevitable.

"Vote buying and related electoral offences encourage poor governance and weaken citizens' capacity to hold their elected officials accountable for their actions.

"SERAP urges you to urgently

take measures and to collaborate with appropriate anti-corruption agencies to ensure the effective prosecution of any outstanding cases of vote buying and related electoral offences allegedly committed in the context of the 2019 general elections.

"We would be grateful if the recommended measures are taken within 14 days of the receipt and/ or publication of this letter. If we have not heard from you by then, SERAP shall consider appropriate legal actions to compel INEC to comply with our request in the public interest.

"The lack of transparency and accountability in political finance is seriously undermining the legitimacy and credibility of the democratic and electoral processes, and invariably contributing to denying the citizens the right to effective participation in their own government.

"The failure of political parties to comply with transparency and accountability frameworks would undermine citizens' trust in their political parties and lack of trust will inevitably destroy confidence in the system and decrease citizens' interest and participation in the democratic process.

"Elections are only one part of the democratic process, and a fair and effective electoral system must be founded in an adequate democratic infrastructure and responsibility of political leaders.

"According to our information, several political parties have for many years failed to submit their annual financial statements to INEC. Many political parties have failed to submit election expenses reports, and to disclose material contributions received from individuals and corporate bodies to the Commission.

# Electoral Act: South-East PDP loses out

efusal of President Muhammadu Buhari to sign the amended Electoral Act has altered political permutations in the Peoples Democratic Party,

As it stands, without the President's signature, the act stipulates that only 811 people will be able to elect the Presidential candidate of the PDP as statutory delegates including the president, serving and former governors, and serving and former members of the National Assembly were excluded from voting at the national conventions. The 811 delegates would comprise of 774 national delegates (1 per LGA and 37 special delegates - people with disability from each of the 36 states and FCT).

The development has caused a total reshaping of permutations for the presidential candidates in the party with Senator Bukola Saraki, Governors Nyesom Wike and Aminu Tambuwal being boosted by the development. While Saraki has been boosted by the endorsement of the North-Central zone of the PDP, Wike even though without an endorsement from the South-South, is, however, without a serious contender from the region and would be gladdened by the fact that he has a fewer number of delegates within and outside the zone to reach out to.

Tambuwal would also be gladdened by the fact that the North-West zone is presenting the highest number of delegates to the convention given the region's superior number of local governments. Tambuwal's room for manoeuvre, is however, tempered by incursions made into the zone by Wike and Saraki. The North-West has 186 national delegates more than double the 95 coming from the South-East, a region that has three major presidential aspirants, Peter Obi, Anyim Pius Anyim and entrepreneur, Pharm. Sam Ohabunwa.

The development means strong consequences for the South-East as the limited number of the national delegates available from the zone is now being split

among themselves and others poaching from outside. While Atiku looks formidable on the national scene, being the immediate past presidential candidate of the party, he has to grapple with Governor Bala Mohammed of Bauchi for the North-East's

Atiku is also being challenged by the fact that no governor is openly associating with him besides his home governor, Ahmadu Fintri, who according to political insiders sees it as an obligation or rather compulsion to support the former Vice-President. While the stalemate on the Electoral Act is like a catastrophe for the South-East as it removes the region's advantages in statutory delegates, it also at the same time present's the region's diminished Local Government Areas, 95.

All attention is now turned to the South-West, which presents only Ayo Fayose. This presents a lot of opportunity for Saraki, Wike and Atiku who already have strong appendages in the region. Saraki has maternal origin in the region and campaign officials are very hopeful of the support of delegates from Ondo where the campaign is fighting off the influence of Atiku who has entered the state through his long-time associate, Eyitayo

The Wike campaign on its part is hopeful of mobilizing delegates through the only governor in the region, Seyi Makinde who is openly backing the Rivers State Governor. Ayodele Fayose who even though an aspirant is also believed to be working for Wike. The development has turned the South-West into the most

contested zone.

### How UK court seized £2m cash linked to Nigeria's ex-Gen Useni

Accuses him of creating accounts to conceal proceeds of corruption
 Monies are gifts from friends, relatives, he claims

Royal Court in Jersey Island, United Kingdom has reportedly seized about £2 million belonging to Lt Gen Jeremiah Useni (rtd), a former Minister of the Federal Capital Territory during the Gen Sani Abacha-led military administration.

The said sum, described by a Jersey Island publication, Bailiwick Express, as "dirty money transferred into local bank accounts by a Nigerian General and politician said to be corrupt dictator Sani Abacha's right-hand man," was allegedly transferred by Useni into four Standard Chartered Bank accounts on the Island.

Useni, the second most senior officer under the rule of General Abacha between 1993 and 1998, was said to have first opened an account in Jersey in 1986 in the name of 'Mr Tim Shani', who he later admitted did not exist and presented himself as the true account

"Over the next 15 years, money totalling £1.9m was transferred into four accounts held by 'Mr Shani' with Standard Chartered Bank," the publication stated.

It added, "In 2001, the bank wrote to Gen Useni - believing him to be 'Mr Shani' – informing him that changes to anti-money laundering legislation in Jersey had resulted in stricter regulations, including the need to have a certified copy of his passport.

"In response, six months later, 'Mr Shani' requested that the entire balance in his existing accounts be transferred to a Nigerian bank, in which it transpires that Gen. Useni was a shareholder.

"This request was rejected, and in February 2003, the bank was refused permission to operate the accounts by the police's Joint Financial Crimes Unit.

"There followed several attempts by Gen Useni's lawyer to unfreeze the accounts and, in 2007, Gen Useni finally identified himself as the true owner of the accounts.

"Giving his occupation as 'Lieutenant-General', he informed Standard Chartered that the main source of his wealth was derived from the profits of his multiple businesses, which included transportation, hotel hospitality, petrol stations, personal savings and property investment.

"He said the reason for opening a Jersey-based account was for 'security' as it was 'necessary to hold a proportion of wealth outside of Nigeria'.

"However, the bank asked Gen Useni to explain the source of the money and why he had transferred it to the accounts, as well as 'supporting documentation to back up the provenance of the funds' and a full explanation as to why the account was originally opened up under a different name.'

Bailiwick Express said although in correspondence the following year Gen Üseni said he dealt in property investment where he sold some and put some in rent and owned a shopping centre, two petrol stations and a domestic gas station, a farm and a rice mill, he provided no information about his income in the 1980s and 1990s.

The publication stated, "He (Useni) added that he had not set up the original account in a false name, rather he had used a 'coded password name' as advised by the person who had set it up on his behalf.

"However, he did not explain why he had used 'Tim Shani', with Jersey's Attorney General concluding that he did so to further distance himself from the ownership of assets that had a likely criminal origin.

"In a judgment handed down this

morning setting out its decision to order the transfer of the £2m into the island's Criminal Offences Confiscation Fund', the Royal Court said, 'The Attorney General believes that the Shani accounts were created to hold, hide and conceal bribes or other proceeds of corruption received by Useni during the period he held office.

"The payments into the Shani accounts were more likely than not for the purposes or on account of exercising political influence over the award of lucrative contracts to foreign and Nigerian companies for the supply of industrial or commercial services in Nigeria.

If this conduct had occurred in Jersey, it would have constituted the customary law offence of misconduct in a public office."

The report added that through a

Jersey-based lawyer, Gen Useni fought but failed to prevent the seizure.

He was also said to have explained the source of the funds in a written affidavit as follows: "In accordance with a culture of gift-giving in Nigeria, which is still accepted practice in Nigeria, government officials from time to time receive cash gifts from friends and well-wishers during festive seasons.

"These acts are similar to gifts being provided by Members of Parliament in England or corporate gifts being provided to directors/employees.

"The culture needs to be looked at in the context of when I was a government official, and at that material time, save there being a culture of gift-giving, there was no official code of conduct governing the issue.

"This could also be said to be true for the western governments, from what I know, so Nigeria should not be chastised or criticised for this."

Explaining the use of the name of a fictitious person to set up the original account, Useni reportedly said, "The primary reason for this again was nothing sinister, but for my protection. As you will understand from reviewing Nigeria's history, it has had several coups, and we are now in our fifth republic.

"The governmental regimes are unstable, and if rulers came into the office who are not friendly to my political persuasion, my wealth and safety could be on the line."

He reportedly added that the money constituted savings for his retirement and there had not been a code of conduct in place in Nigeria at the time obliging him to declare it.

However, the Royal Court was not convinced by his explanations.

It said, "Essentially, (Gen Useni's) case is that the source of the substantial sums paid into the bank accounts is cash gifts from friends, relatives and wellwishers on festive and other ceremonial occasions in accordance with Nigerian custom, but in the view of the Court, it is simply not credible that friends, relatives and well-wishers would make gifts to (Gen Useni), as a public official, of such magnitude to allow him not only to accumulate millions in these bank accounts, but to acquire the very substantial assets he said he owned in Nigeria.

"It is an explanation that verges on the absurd."

It also found that there had been a code of conduct for public officials in place in Nigeria well before substantial amounts were paid into the Jersey accounts.

It concluded, "The affidavits of [Gen Useni] have not satisfied the Court that the property held in the bank accounts is not tainted property and on the application of the Attorney General, we will make a Forfeiture Order in relation to that property."

The Court reportedly ordered that £45,000 be taken out of the amount seized to pay Standard Chartered Bank's legal costs.

In 2020, Jersey returned more than £230m of money to Nigeria which had been laundered through the United States and the island by Gen. Abacha.

### EFCC releases former speaker, Etteh over alleged N130m fraud

Economic and Financial Crime Commission(EFCC) has announced the release of a former Speaker of the House of Representatives, Patricia Etteh, after fulfilling her bail conditions in an alleged N130 million fraud saga.

According to the Commission on Saturday in a statement by its spokesperson, Wilson Uwujaren, the former speaker was released on Friday, adding that she will be reporting periodically for further

"Former Speaker of the House of Representatives, Mrs Patricia Olubunmi Etteh, detained by the Economic and Financial Crimes Commission, EFCC on suspicious and shady financial involvement with Phil Jin Projects Limited, has been released by the Commission.

"She was released on Friday, May 20, 2022, upon fulfilling bail conditions offered her by investigators working on her matter. She is to report periodically to assist further investigations," the state-

Etteh, who was Speaker between June 6, 2007, and October 30, 2007, was arrested in Abuja on Tuesday by operatives of the

Special Duty Unit of the anti-graft agency, sources familiar with the matter said.

The former lawmaker is currently being interrogated for allegedly receiving a suspicious N130 million payment from a contractor that the Niger Delta Development Commission (NDDC) awarded a solar-powered electrification project in Akwa Ibom State.

The said contract was awarded to a certain Phin Jin Project Limited in 2011 for N240 million. It is unclear if the company is registered with Nigeria's Corporate Affairs Commission. A search of its name on the CAC online directory did not show

Investigators said weeks after the contractor was paid the mobilisation fee for the project, N130 million was transferred to Etteh, who is neither a director nor a shareholder of the company on record.

"The payment of that huge amount to her is suspicious," one source said.

"She is claiming that the contractor repaid debt due to her but that is doubtful. So her claims are being scrutinised.

"They even overpaid for the contract. Instead of N240 million, they paid N287 million. These are knotty issues she and the contractor need to explain and that is why she is being interrogated by operatives," the source added.

"It is uncertain that the contract was delivered. Its exact status has not been determined but we feel that no magic would have made the contract to be delivered or executed to specification after Etteh was given that huge amount from the contract sum," another source said.

### School remains shut after pupil, 5, drowns during swimming lesson, police step in

anagement of Redeemers Nursery Primary School in Ogba, Lagos state, has suspended activities after Chidera Eze, its five year-old pupil, reportedly drowned during a swimming session, even as the Lagos State Police Command have started investigating the incident.

The late Chidera Eze was said to have drowned during a swimming lesson

organised by the school at the Ivory Health Club in the Ikeja axis of the state.

The deceased and his colleagues were said to have been playing close to the pool during the training when he suddenly slipped into it.

When The Trumpet visited the school on Friday, no student was seen within the premises, while suspicion enveloped the atmosphere.

Some security men at the school gate told The Trumpet that all school activities had been suspended since the incident happened.

Anthony, the pupil's father, had earlier alleged that the school's officials neglected his son, resulting in his death.

'All these happened and none of the teachers, caregivers and lifeguards took notice of what was happening," he had said.

'My son was under the water for over 30 minutes and we were all shouting

as we watched the video. Another pupil also fell into the water, but her colleagues raised the alarm and they pulled her out and while this was going on, nobody noticed my son was inside the water."

At the time of this report, the school was yet to react to the matter.

Police authorities at Area G, Ogba, Lagos Command told The Trumpet that they were investigating the incident.





#### Again, four-storey building collapses in Lagos, four feared dead


(alive) and taken to nearest hospitals for further treatment.

"However, four adult males were recovered (dead), bagged and handed over to officials of the State Environmental Health Monitoring Unit, SEHMU, to be processed further after being deposited at the mortuary.

"Remains of the selfcollapsed four floor building was then taken down to ground zero by the Agency with the use of it's heavy duty equipment-the Excavator, thereby eliminating any further threat to lives and all other proximal properties.

"Other primary responders present includes the LASAMBUS, LASG Fire Sevice, LABCA, SEHMU, Federal Fire Service, NEMA, Red Cross, LNSC and NPF," the release read.

### 2023: Catholic church suspends priest for joining guber race



The Catholic Diocese of Gboko in Benue State has suspended a priest, Rev Fr Hyacinth Alia, for joining the governorship race in the state.

Alia had picked up the N50m governorship form of the All Progressives Congress and had been cleared by the ruling party to participate alongside 11 successful aspirants in the party's primary.

But the Bishop, Catholic Diocese of Gboko, William Avenya, in a letter dated May 20, 2022, announced the suspension of Alia from public ministry "after series of admonitions" to him.

Avenya noted in a letter that "the Mother Church does not allow her clerics to get involved in partisan politics on their own"

The letter partly read, "I write to communicate to you the suspension of my priest,

"The Mother Church does not allow her clerics to get involved in partisan politics on their own.

"You are aware that my son, your brother and your priest has purchased the party forms to contest for the Office of the Governor of Benue State under the All Progressives' Congress, which is totally against our vocation.

"Therefore, to respond to the spiritual and pastoral needs of the Church in the Catholic Diocese of Gboko, I have suspended him from the exercise of sacred ministry.

"This canonical suspension takes effect from the moment it is communicated to him and lasts until he ceases from contumacy."

- The Meeting deliberated extensively on the State of Nation, particularly the worsening insecurity; the 2023 General Elections; and recent troubling developments in the polity.
- Arising therefrom, the Forum: Firmly reiterates its stance on the Principle of Zoning and Power Rotation between the North and the South, as the basis on which the Nigerian Federation has, since Independence, been premised.
- States, unequivocally, that the Zoning and Rotation of the Presidency of Nigeria are fundamental to the future existence of the Country.

While equally urging other well-meaning northern leaders, who believe in the oneness of Nigeria, to support this cause, because therein lies the unity and progress of Nigeria.

On the worsening state of insecurity and rampaging violence across the country, Forum warns that Nigeria is plummeting into a state of total disorder and lawlessness, with attacks on innocent people resulting in kidnapping, loss of lives and destruction of properties happening in different parts of the country almost daily.

Sadly, the Federal Government and its Security Agencies are not doing enough to arrest the situation, whereby people can no longer travel safely either by road, rail or even by air to Kaduna State in particular.

It is not only frightening but unimaginable that despite the heavy presence of military commands and installations in the State there could be such security challenges.

The Meeting cautions that these bellicosities and deliberate programs to exterminate the indigenous populations of the Middle Belt are, by implication, acts of aggression against the rest of Nigeria, and would not be tolerated any further.

- Deplores the inhuman plight of the 1,700 indigenous people of Southern Kaduna driven out of their homes and have now become Internally Displaced Persons (IDPs) for over five years as well as several other Internally Displaced Persons in different parts of the country, left to live in conditions that impinge on their human rights as citizens of this Country. Hence, calls on the Federal Government to, without delay, facilitate the return and reintegration of these Nigerians into their Communities.
- The Meeting resolved to resist, through all legitimate means, the barefaced attempts by religious fundamentalists to impose on the rest of us, a Nigeria of "one country, different laws".
- The Meeting reaffirmed the commitment of the people of Southern Nigeria and the Middle Belt to the RESTRUCTURING of the Country, in tandem with the Principles of True Federalism, as was established by the Founding Fathers of Nigeria.

# **APC and PDP set to dump power rotation?**

There are indications that Nigeria's two leading political parties APC and PDP may dump power rotation in the 2023 general elections. Both parties have thrown their presidential slots open to politicians from all the regions in the country, a move that has reinforced the notion that both parties are steeped in caprice. Many Nigerians are shocked at this development given that there has been an unspoken, even if unwritten understanding that power should be rotated between the South and North to ease tensions.

President Muhammadu Buhari has been in power for seven years and barring any developments, he will be in power for eight years. During his tenure, it is believed that he has favoured the North in what seems like a primitive rehearsal of nepotistic predilections.

Given that Nigeria seems to be at a crossroads with all the arising ethnic tensions and distrusts in the polity, zoning, which will see power rotate to the South, is the best option for the country. There are fears in the South that the North has monopolized power to the marginalization of the South. In the spirit of equity and fair play, power rotation in Nigeria is not only desirable but necessary to assuage general feelings of alienation across the South. Before this period, it was believed that the South-East deserved to produce the next president of the country, a move which will give the region a sense of belonging and perhaps, stop all the agitations for a separate country. The decision by the two leading political parties to do away with zoning will further fan the embers of agitation in the South-East and promote further blood-letting and criminal

Nigeria must work out an arrangement that would ensure peace and assuage bruised feelings across the country. Advanced democracies in the world have evolved through a workable and practical political | arrangement and understanding of power arrangement that is convenient for all their regions. In Nigeria, the quota system was worked out as a mechanism to achieve balance in schools' admission and recruitment into various security outfits in the country. The greatest beneficiary of the quota system is the North. Although the quota system has continued to stifle merit and excellence, it is somewhat enshrined in Nigeria's Constitution. Despite the entrenchment of the quota system in Nigeria, there are still abysmal gaps in education excellence and growth in terms of career development.

The political class should not deliberately cause an implosion in the country through acts of omission and commission. The unwritten rotation should be respected. Following MKO Abiola's death, Nigerians agreed that the South-West deserved to be assuaged. Therefore, power was zoned to the region which saw the emergence of Chief Olusegun Obasanjo as President in 1999. It is fair to say that Obasanjo's emergence saved Nigeria from tipping over the abyss of imminent civil unrest that could have snowballed into a war.

The desirability of power rotation in a heterogeneous federation like Nigeria cannot be over-emphasized. It will amount to the highest level of insensitivity if a Northerner emerges as a presidential flag bearer of any of the leading political parties in 2023. In the current dispensation, Nigeria needs a president from the South, especially the South-East. Any person of good intentions would agree that since the end of the civil war, the South-East has not been properly integrated into the Nigerian polity given its size and contributions to the growth of the country. That sort of bias against the region has fuelled agitations for a separate country called Biafra. It will be in the interest of the whole country that the two political parties, APC and PDP adopt power rotation that will see them zone their presidential slots to the South-East.

It will be foolhardy for the Nigerian political class to pretend that power rotation is not necessary now. To continue to exclude or deny any ethnic group the opportunity to hold power at the centre is to advance the narrative that One Nigeria is a mirage. Nobody in Nigeria is more Nigerian than the next person. The political class must steer the country away from the precarious precipice on which it delicately hangs. To pretend that all is well while some sections of the country are summarily imploding is to demonstrate an insensitive behaviour which is at cross-purposes with democratic culture.





# Osinbajo: Dishonest thesis

Tread with deep interest an article published by my predecessor in the Senate as the representative of Osun Central Senatorial District, Senator Professor Sola Adeyeye. I believe the description of him at the foot of the article as "the Senator for Osun Central in the National Assembly" is clearly erroneous as since June 2019, I have been representing Osun Central Senatorial District in the Senate Chamber of the National Assembly. Nonetheless, I find it curious that a news organ will not know that the Spokesperson of the Senate is the Senator representing Osun Central Senatorial District. The Theory of Establishment as the only route to the Presidency appears to be the typification of

Nigerian democracy by the writer. Senator Adeyeye asserted and I think rather firmly that "if the establishment does not want you, you can never win the presidency". I am at a loss to see the factual and empirical basis for this assertion in view of the recent political history of Nigeria that saw President Buhari dislodging an incumbent President and a political party that has controlled the Presidency for about 16 years before the 2015 electoral loss.

Which establishment want President Buhari and the APC in 2015. My sense in reading the article is that people are outrightly discounted in our democratic enterprise, what matters from his theory is the predisposition of what he termed the "establishment". Okay, why this attitude and why over the issue in question? Senator Basiru and I are at this moment on two different sides of the political divide within our party, the All Progressives Congress (APC). Ordinarily, as my successor in the Senate, I should have no reason to engage with him in an adversarial manner in public space. However, where it concerns Nigeria and our patriotism, where it concerns nothing personal, there are no sacred spaces to speak the truth.

penned by a personality I have so much respect for: "Yes, Tinubu has the structure, he has amassed the money and is already throwing it around left, right and centre, but the truth is that many are just fleecing him at the moment. Osinbajo did not give me money and cannot give me money. He has given me what I want and it is exactly what I want for my children and for all Nigerians. Let me elaborate.

I read Chidi Amuta's column in the Sunday ThisDay of the 15th of May, 2022. He had an article there titled "Overcrowding the Presidential Doorway." Like most informed commentators, he is scandalized by the number of unserious people clogging the space in supposed contest for the presidency on the platforms of the political parties. He took the liberty to mention that only "seven from the multitude of presidential aspirants have any business aspiring to lead anything beyond a local government or town union" and he went further to describe them.

Here is how he put it:

Rotimi Amaechi stands tall in the APC pack as one man with an unusual courage and boldness to fix frightening problems. He has fixed things we can see and feel in his Rivers state and all around Nigeria. There is Yemi Osinbajo, exemplary Vice President, an unusual combination of morality, ideas and practical solutions. I hardly know about the rest of the crowded choir."

I mean, read that again and pay close attention to how he described each person. Is there any description or testimonial that is better than what he said about Osinbajo? Is there anyone better for Nigeria now than a person with "an unusual combination of

morality, ideas and practical solutions"? Amuta gave each their due, but he found in Osinbaio an encapsulation of what he found in others and more.

This is a man who has been Vice President for seven years. If in seven years, power did not make him lose his idealism, ethics and can-do spirit, what will the next four years be with Nigeria under his watch? Yes, this Nigeria drugged up in political miasma needs a man like him and I am proud to stand with him! The possibilities his candidacy portends are exactly the tonic my creaking bones need to get on the road for him. I didn't need to be preached to or converted. I know him. If helping deliver Osinbajo as the leader of our country is the last thing I do here on earth, I will die a very fulfilled man. In politics and in my private life, I don't do duplicity. In Osinbajo, I find a leader I can identify with, a leader I can trust.

Senator Basiru claims that the central thesis of my piece "is that Professor Yemi Osinbajo is the preferred aspirant of President Muhammadu Buhari." He read what I wrote and heard what he wanted to hear. But what he heard is not what I wrote. I made a case for why the Vice President should be Buhari's preference, not that he is. If a person with a doctorate degree is unable to make this elementary distinction, the best I can do is to adapt the words of Iesus on the cross - "Father, forgive him, for he knows not what he is saying."

None of us, at least not me, knows Buhari's preference, even though he has indicated he has one. I'm sure Senator Basiru wishes his principal is Buhari's preferred choice. So what is wrong with my being forthright about my own wishes in that regard?

He also has a problem with the following comment I made, which he interpreted as pursuant to my thesis:

"In his piece, Reno missed two fundamental truths about Nigerian politics. The first is that if the establishment does not want you, you can never win the presidency. The second is religion as a factor in Nigerian political outcomes is overrated, especially at the national level. Yes, the establishment uses it when convenient, but, when it matters, realpolitik always trumps religion.

"Nigeria is not a land of political revolution. We have been caught in the web of the 'Class' of 1966' like since forever and they are still in charge. They determine who is president, irrespective of parties. Buhari, for good or ill, has reshaped the establishment platform to be more pro-North. He may have done it deliberately or it may just be something that has developed naturally under his watch. Whichever is the case, it is today our reality.

"Of course, the popular wisdom is that religious sentiments determine the outcomes of national political contests, especially for the presidency – at the party and general election levels. But the historical facts do not support this. What history tells us is that any candidate of any religious background can be sold successfully nationally by the establishment once they determine he or she is the one they want there."

He contended that no establishment wanted President Buhari and the APC in 2015 and then said he sees my comment as "a clear attempt to use a banal assertion to becloud the spirited efforts of the coalition that ripened to the APC and the struggle of our leaders like President Buhari, Chief Bisi Akande, Asiwaju Bola Ahmed Tinubu, Chief Ogbonnaya Onu among others that ensure the presidency for the APC against all odds."

Obviously, he is avoiding the basic truth of my thesis and attempting to replace it with his own invented "recent political history"

despite hearing me talk clearly about the 'Class of 1966'. Or, is it that he does not know that all the presidents we've had since the advent of the Fourth Republic are fully sanctioned by the 'Class of 1966' before the vote that brought them formally to Aso Rock? In 1999, did they not determine, after their bungling of June 12, that Olusegun Obasanjo, one of their own, should get it? When Muhammadu Buhari looked to succeed Obasanjo, did they not freeze him out because they believed at the time that he still had resentments over the Ibrahim Babangida coup that toppled him? Okay, we might say Umaru Yar'Adua was an Obasanjo project, but he was also the establishment's project to reward one of their own, the late Shehu Yar'Adua. The original coming of Goodluck Jonathan was fortuitous, but he was adopted because he was still part of the Obasanjo project. When they fell out with him, did they not bring back the now contrite Buhari to replace him?

So, why go on a wild goose chase with his "recent political history" when the facts support my basic thesis that if the establishment does not want you, you can never win the presidency? When his principal went to see Babangida in Minna in January this year, did he just go there to secure Babangida's sole vote in his quest for the presidency? Of course, the political parties will naturally organize and make their choices and partake in elections, but our history tells us that the powers that be make these choices for the topmost national political position before the ordinary voter. It is what it is and we need not lie to Nigerians because they know.

Plan International, a non-governmental organization (NGO), has called for more girls' participation in Information and Communication Technology (ICT) careers to foster a more dynamic technology sector and enhance innovation and productivity.

Country Director, Plan International, Mr Charles Usie, made the call in Abuja at the weekend, at an event to commemorate the 2022 Girls in ICT Day.

The News Agency of Nigeria reports that the event featured a debate and quiz competition among schools in the Federal Capital Territory (FCT).

The topic of the discussion is tagged "Is Technology a Critical Component of the Education of Students today"?

The selected schools in the debate and quiz competition include Light of Day School, Kubwa, Capville School, Government Secondary School (GSS)

Dutse, GSS Garki, GSS Wuse Zone 3 and Maitama Model School. Usie, represented by the Communication Advisor of the organisation, Mr Yunus Abdulhamid, said that the competition would spur conversation among girls in ICT.

"Girls in ICT debate competition for a young adolescent is to help spur conversation of girls in ICT. " Data indicates fewer females in ICT and science generally. Also, as you progress, more girls drop out from related courses. "In today's world, more women are found in all human endeavours like the pilots, engineers, architects, medical doctors, bankers and many more.

"For us, as a country to advance in what we do, we need more participation of girls in ICT in our world today," he said. Usie also said that 50 per cent of the country's population were female, hence the need for the government to pay critical attention to the girl child in the area of technology. "We can hardly survive in today's world without technology. In Nigeria, 50 per cent of our population is female and

involving them in ICT will help to advance the country's development. "Any society who looks down on this group of people will definitely fail. So, we are saying that females must imbibe technology to really grow our

"At Plan International, we focus on the adolescent girls. This does not mean the boys are not important, they are because, in our programmes for girls, we also carry the boys along," he said.

The Project Coordinator, Plan International, Mrs Mary Mbukpa, called for monitoring of devices used by children from home. Mbukpa called on the government to provide digitalised library and put in place a system where the girls don't have to go to other sites that would not be significant to their learning. She also encouraged parents to ensure that they guide their children in the use of digital platforms "We have had debate and quiz competitions towards showing the good about ICT, so it is important for young girls to begin to access ICT and also bearing in mind that they need to be safe online.

"Looking at our society, the boys have access to different ICT platforms but we are very conservative in the way we build up our young girls. "We need to try to control a lot of things they do but we are looking at how girls can use the ICT to better their education," she said.

One of the students, Jamie David, an SS1 student of GSS, Wuse Zone 3, said there was a need for girls to be given the opportunity to be able to have access to ICT.

David said this would be one of the ways to tackle gender inequality in our society. "We have to evolve as the world is evolving. Technology has helped us in many ways; it all depends on the choice of technology.

Parents should look more into what the children do and not buy a gadget for children who are not mature to use it," she said.

Mr John Osigbemhe, a Science Teacher in GSS Garki said that girls around the world were becoming more interested in ICT, hence the need to encourage Nigerian girls to utilise the power of

Osigbemhe added that stakeholders should help the children by putting in place restrictions on the use of technology and control by parents. He said that there was a limit to what the school could do to curtail the gadget being used for all manners of social vices in society.

NAN reports that Capville School cliched the first position, GSS Wuse Zone 3 came second while GSS Garki and GSS Dutse came third in the debate category.

Also, Maitama Model School clinched top, Light of Day School came second and GSS Dutse came third in the quiz competition.

NAN reports that Plan International in partnership with Tech Her for Women in Technology, an NGO, would offer six months online programme for

# Federal Govt approves incentives for startups

The delegation included the Director-General of NITDA, the Executive Vice Chairman of the Nigerian Communications Commission (NCC), the Post

Master General and the Managing Director of Galaxy Backbone Plc.

The visit provided a useful platform for open and interactive discussions on the ecosystem's pertinent challenges and interventions required from the government to enable the ecosystem achieve its full potential.

The forum was attended by 143 ICT and Startup Companies. The delegation also paid a visit to 3 selected tech startups, namely: Flutterwave (currently valued at US\$3 billion), Treepz (with a current funding of US\$3.1 million) and Reliance Health (with US\$48.3 million in funding).

The Nigeria Startup Bill (NSB) was earlier approved by the Federal Executive Council and forwarded to the National Assembly and the process is about 90% complete. The approval of the incentives at the Council will consolidate the gains recorded for far in the NSB process. The implementation of the National Digital Economy Policy and Strategy (NDEPS) emphasises the importance of the innovation and startup ecosystem to the development of an indigenous digital economy. The Ministry will continue to position Nigeria to develop this ecosystem in order to transform Nigeria into a country with a sustainable and thriving digital economy.

# CBN's policies and need to save naira from free fall

In the 1970s and early 1980s, the naira exchanged for one United States of America dollar. It was highly sought after globally due to its value. But Nigeria's romance with the International Monetary Fund (IMF) and the World Bank, particularly during the military era and the penchant for obtaining loans from foreign financial institutions, empowered the IMF and World Bank to force successive administrations to devalue the country's currency to an all time low. Last week, the naira exchanged for N600 to \$1. JOHNMARK UKOKO writes on the need to save the local currency.

The naira was more like a beautiful bride in the 1970s to the early 1980s, as the currency was highly sought after by Nigerians and foreigners alike. But today, even wealthy Nigerians hardly want to deal with the lo-cal currency because of the low value it currently commands. The currency, which traded for N1 to \$1, now exchanges for about N600 to the dollar and much lower with the Pound Sterling

In spite of various measures put in place by the Central Bank of Nigeria (CBN) to shore up the value of the currency, it has consistently continued to nosedive.

Nigerians like the blame game, as the currency, which exchanged for less than N200 to the dollar, when the President Muhammadu Buhari administration took over power seven years ago now see the naira exchanging for about N600 to the dollar at the parallel

About two years ago, the CBN blamed the free fall of the naira on activities of the country's Bureau De Changes (BDCs). As a result, the apex bank's big hammer fell on the BDCs, leading to their being banned from accessing the dollar at the foreign exchange (forex) market.

But the ban on BDCs from accessing forex at the official window did not shore up the value of the naira.

Shortly afterwards, the CBN blamed AbokiFX for the continued fall of the naira. Governor of the bank, Godwin Emefiele told the world that the daily publication of the black market rate on the AbokiFX site was responsible for

the misfortune of the currency.
It then swiftly barred the site and went ahead to announce that the management of the AbokiFX would be sanctioned for their role in the free fall of the naira, following which owners of AbokiFX shut down the site, but the fate of naira worsened.

The CBN also blamed some manufacturers and importers for the situation of the currency, saying it had granted forex to some manufacturers and importers, which it said, was partly responsible for the worsening value of the local currency.

To further drive home its point, the apex bank prohibited 42 products from sourcing forex from the official window, following which the Manufacturers Association of Nigeria (MAN) and the Lagos Chamber of Commerce and Industry (LCCI) pleaded with the Federal Government and CBN to reconsider the ban, but they did not succeed. Yet, the naira continued to fall.

Even as crude oil now sells for over \$100 per barrel at the international market due to the Russia and Ukraine war, the naira has consistently continued to crash, just as the country's foreign reserve

has continued to dip.

A black market operator, who told The Trumpet that black market operators buy the dollar for between N570 and N580 depending on the quantity, but sell at between N595 and N600, attributed the eroding value of the naira to increasing demand for foreign currencies and low inflow of foreign exchange into the country.

Investigations by *The Trumpet* showed that between April 15, 2022 and May 17, 2022, the country's external reserves dropped by over \$700 million.

Economists also affirmed that although the CBN has blamed the decline of country's external reserves to the activities of politicians, who are bent on mopping up the dollars in circulation and expressed concern that while the price of crude oil has risen to over \$100 per barrel, there was no reason for the country's external reserves to fall.

Speaking to The Trumpet, they argued that although the CBN has consistently said that the parallel market was not the true reflection of the value of naira, Nigerians should take that submission with a pinch of salt.

Some watchers of the political and economic developments in the country, led by Ondo State Governor, Öluwarotimi Akeredolu, have attributed the recent crash of the local currency to Emefiele's presidential ambition.

Akeredolu had insisted that Emefiele goofed to have contemplated contesting the presidency, when his tenure at the CBN had not ended; maintaining that he (Emefiele) sent the wrong signals to the local and foreign investors with his foray into politics.

He said the apex bank governor's body language had put severe pressure on the naira, adding that Emefiele's action was unprecedented in the country's central banking history.

Responding to the developments, a former Deputy Governor of the CBN, Prof. Kingsley Moghalu, took a swipe at Emefiele for his actions, adding that he ought to have ended his tenure at the apex bank before aspiring for political

He said Emefiele was wrong to have attempted to vie for the country's presidency, as governor of the CBN, saying his action had further put pressure on the value of the naira against foreign

Curiously, the Association of Bureau De Change of Nigeria (ABCON), which the Emefieleled CBN earlier blamed for the continued slide of the naira, informed Nigerians that it had found a solution to the poor value of the local currency.

ABCON President, Dr. Aminu Gwadabe, said the association had developed a roadmap campaign plan needed to save the naira from further decline and enhance exchange rate stability.

Gwadabe revealed that the move to save the naira was agreed upon by the association after its meeting recently in Lagos, where he said, ABCON unveiled strategies to save the local currency, bridge the exchange rate gaps, curb volatility gaps and check volatility in the forex market.

He stressed that there was the urgent need to enhance dollar liquidity in the market of prices in the economy, saying the steps would save the local currency and the economy from the impact of election spending that had kept inflation at double digits for a

The ABCON further disclosed that the depreciation of the naira against global currencies was due to pressure from rising dollar demand without sufficient liquidity to meet the demands from retail end users, manufacturers and other key players in the economy.

The naira has consistently come under serious pressure due to scarcity of the dollar, making it difficult for forex end users, manufacturers and industry players to access the dollars to meet their needs.

"ABCON under my leadership will continue to encourage its members to play the vital role of closing the exchange rate gaps in the market and reducing premium between the parallel market and the official widow," he said.

Gwadabe canvassed an enhancement of existing BDCs automation portfolio to file transaction returns on the portals of CBN, ABCON, the Nigeria Inter Banks Settlement System (NIBSS) and other related organisations for effective regulatory monitoring and supervision.

"The CBN's reluctance to open new windows through which foreign exchange can be attracted to the economy remains a key factor in the naira's continued fall. The non-inclusion of BDCs among channels through which Diaspora remittances to Nigeria under the apex bank's guidance and regulation has reduced the volume of dollars inflow into the economy," he lamented.

On his part, President of MAN, Mansur Ahmed, who addressed journalists recently, said members of the association were increasingly finding it difficult to access forex to import the needed raw materials and machinery for production.

Ahmed said the apex bank had consistently promised them that the commercial banks would meet all their foreign exchange requirements, but so far, they hardly get up to 20 per cent of their forex needs.

Arguing that scarcity of foreign exchange has been the major challenge of the manufacturers in the past three years, he urged the Federal Government and the CBN to walk the talk by providing forex for the manufacturers to enable them keep their production going as expected.

He identified epileptic power supply in the past few months

as a major headache the local manufacturers were currently contending with.

Also, an economist, Dr. Muda Yusuf, blamed the free fall of the naira on CBN's policy summersaults, saying its multiple foreign exchange policies was responsible for the failure of most people who have dollars do not bring them into the country.

While speaking with members of Finance Correspondents Association of Nigeria (FICAN) recently in Lagos, Yusuf said most Nigerians and foreigners have plenty of dollars but were reluctant to bring them into the country because of the CBN's fixed exchange rate regime.

He advocated liberalisation of the exchange rate, as one of the ways to shore up the value of the naira, stressing that the currency had been on the free fall because there was scarcity of dollars in the country.

"I blame CBN policies for the free fall of the naira. It is wrong for CBN to tell those who have foreign currencies how much they should sell. Let people bring in their foreign currencies and sell at whatever price, by so doing, there will be increased inflow of forey rather increased inflow of forex rather than dollars that come from only the sale of crude oil.

"If CBN can allow local and foreigners who have foreign currency to bring them in and sell at whatever price they like, within a short time there will be enough forex in the country and the naira will appreciate in a way it has not done for a long time," he added.

Nigerians wonder why despite the promises of the current administration, it banned several products from accessing forex at the official window, while the naira that exchanged for less than N200 in 2015 now exchanges for about N600 to the dollar.

While Nigerians are being told that there is scarcity of dollars in the country, government officials, their supporters and CBN senior executives swim in foreign

As analysts contend that with the forthcoming 2023 general elections, huge spending by politicians will put severe pressure on the nation's currency, Nigerians ask: Is this how the naira will continue to fall until it hits N1,000 to the dollar? Who will stop the naira from the free fall?

It will be interesting to experience how Nigerians, who have been negatively impacted by the insensitivity of successive governments and CBN's policies, will cope with the anticipated harder times ahead.

The Nigeria equity market closed on a positive note as investors piled on MTN Nigeria stocks following the announcement by the telecommunication giant that its technology startup firm, Momo PSP has commenced operations.

All Share Index (ASI) increased by 1.05 per cent to close at 53,257.49 points compared with the 52.721.34 points it closed with the previous day, while market capitalisation of equities listed on the NGX increased to N28.721 trillion from N28.423 trillion as of last Wednesday.

The total volume traded closed with the exchange of 274.557 million units valued at N8.45 billion and traded 5,184 billion

However, the market breadth closed negative with 21 gainers, as against 29 losers, while the NGX 30 index increased by 1.13 per cent to close at 2.065.52 points, as against 2.042.63 points the previous day.

Market turnover closed with a traded volume of 120.62 million units, just as MTN and Stanbic IBTC were the key gainers, while Fidelity Bank and Ecobank Plc were the key losers.

The Central Bank of Nigeria (CBN) has said that paper currency will soon be out of circulation, urging market men and women to sign onto the e-Naira.

Controller of the Delta State Branch of CBN, Godwin Okafor, stated this at the Ugbogonogo Market during the bank's market sensitisation programme on the e-Naira in Asaba at the weekend.

He urged traders to key into the Central Bank's e-Naira policy, adding: "We are in the market to sensitise the people on the use of e-Naira. It is backed by the CBN, unlike Bitcoin, which has no legal backing," he said.

Consultant to CBN on e-Naira, Dr. Aminu Bizi, said Delta State was chosen as the second state to sensitise market women on the e-Naira after Lagos State.

"Government alone cannot do everything and that is why the CIBN is partnering with the government. The schools we visited are government or state owned schools. I believe the Ministry of Education can also do similar thing to support institutions of learning.

Chairman of Lagos branch of CIBN, Peter Ashade described the ceremony as a significant milestone in the history of the institute.

Ashade, who is also the Group Chief Executive Officer, United Capital Plc, noted that the journey to realising the vision with the support of the national secretariat had given the institute a lot of hope as the edifice would be commissioned in due time.

He noted that the location was strategic and that completing the property would give the institute better visibility.

"We have done a lot. We are building a point of reference where a lot more can be done. One of the floors will be used for computer-based test (CBT). We are trying to position ourselves to mirror what is happening at the national level in terms of visibility and sustaining the capacity building of the institute. Before the COVID-19 pandemic, we had bricks and we now have virtual learning.

Responding, Chairman of the Building Committee, Kola Abdul, said the building, which would be completed in reasonable time, would advance the institute's cause as a professional body.

### Buhari names Jummai Tutuwa DG of FIIRO

President Muhammadu Buhari has approved the appointment of Mrs. Jummai Tutuwa, as substantive Director-General of the Federal Institute of Industrial Research, Oshodi (FIIRO) effective May 10, 2022.

A statement issued by the Ministry of Science, Technology and Innovation, affirmed that Tutuwa takes over from the Acting Director General, Agnes Asagbra, who was appointed in February 2020.

According to the statement, Tutuwa was the Director in Charge of Biotechnology Centre at the National Biotechnology Development Agency (NABDA) in Jalingo, Taraba State.

The development came two

years after Asagbra took over as the Acting DG of FIIRO following the dismissal of Chime Igwe, who was accused of involvement in a certificate scandal.

Minister of Science, Technology and Innovation, Dr. Ogbonnaya Onu, had appointed Igwe as the Acting DG in 2019 when the position was vacant after the retirement of the former Director-General, Prof. Gloria Elemo.

The institute had been enmeshed in controversy over Igwe purported PhD, which he claimed to have obtained from the Universite D'Abomey Calavi, Benin Republic, but he could not present a certificate to back his Igwe reportedly failed to present his PhD certificate 17 years after submitting a letter of attestation form the university and was alleged to have used the attestation letter to secure promotions up to the directorate level at the institute.

He is currently facing trial at the Special Offences Court in Ikeja, Lagos by the Independent Corrupt Practices and other Related Offences Commission (ICPC) over the alleged certificate

FIIRO was created with a mandate to assist the industrialisation of the country and its economy through the use of local raw materials and upgrading indigenous production technology.



Recall that the lawmaker was kidnapped on May 15th to an unknown destination. He was later decapitated by his abductors and his head hung at Chisco park in Amichi community at Idemili North Local Government Area of the State.

Reacting to the ugly incident, Prof Soludo expressed shock and deep sadness over the murder of the lawmaker, who represented his constituency.

In a statement, the Governor

consoled his kinsmen of Isuofia, noting that it is probably the same criminal gang that attacked him and killed three policemen at Isuofia two years ago that is once again on the prowl.

"But they can never cow down Isuofia and Anambra state," he added.

Soludo, who offered a N10 million reward for information to track the killers, vowed that the perpetrators, as well as all criminals operating in Anambra, must be decisively brought to book.

"Anambra will soon be a hell for these criminals," he assured, giving the assurance of the government's resolve and renewed determination with the security agencies to go all out against the criminals and ensure they are brought to justice.

While urging Ndi Anambra to brace up for the all-out war against the criminals, he said "Anambra will win against the forces of darkness."

Similarly, the State's Commissioner of Police, CP Echeng Echeng in a statement issued on Saturday by the Public Relations Officer, DSP Ikenga Tochukwu, described the act as barbaric and cowardly while assuring that the perpetrators will be brought to book.

"The Commissioner of Police Anambra State Command CP Echeng Echeng has today 21/5/2022 (Saturday) describe the murder of Hon Okechuwu Okoye as barbaric and cowardly.

"Recall on 15/5/2022, the Command Operatives had earlier embarked on a rescue operation following the incident of his abduction on the same date at about 5:30 pm along Aguluzigbo Umiona, Aguata LGA.

While the operation is still ongoing, today 21/5/2022 at about 4 pm, a headless body was seen and later recovered by Police along Nnobi, Ideani road. Further information and confirmation, identify the corpse as Hon Okechuwu Okoye. The corpse has been deposited in a morgue.

"The CP while commiserating with the family and friends assures that the perpetrators of this dastardly act shall be brought to book," the statement said.

Meanwhile, Governor David Umahi of Ebonyi State has accused some politicians in the Southeast of benefiting from the growing insecurity in the region.

# AfDB okays \$1.5b food fund for 20m farmers

frican Development Bank (AfDB) has approved a \$ 1.5 billion emergency food production facility for 20 million farmers on the continent to avert a looming crisis caused by Russia's invasion of Ukraine.

AfDB disclosed this at the weekend, saying the fund was meant to assist Africa in overcoming the shortage of about 30 million metric tons of food due to the disruption of global food supplies caused by the conflict in Europe, especially for wheat, maize and soybeans imported from Russia and Ukraine.

The bank explained that the facility was designed to boost the local production of cereals and oil grains, as the most effective and efficient way of building resilience across Africa's food systems, adding: "African farmers urgently need high quality seeds and inputs before the planting season begins in May to immediately boost supplies."

President of AfDB, Dr. Akinwunmi Adesina, said: "Food aid cannot feed Africans. Africa doesn't need bowls in hand. Africa needs seeds in the ground, machinery and harvesters to harvest locally produced food. Africa will feed itself with pride, for there is no dignity in begging for food."

The African emergency food production facility had benefited from stakeholder consultations, including those with fertiliser producers and separately with African Union agriculture and finance ministers this month.

The price of wheat has soared in Africa by over 45 per cent since the Russia and Ukraine war began. Fertiliser prices have also increased by as much as 300 per cent and the continent faces shortage of two million metric tons of fertiliser. Most African

countries have already witnessed increases in the prices of bread and other food items.

"If the deficit is not addressed, food production in Africa will decline by at least 20 per cent and the continent could lose over \$11 billion in its food production value. The AfDB's \$1.5 billion strategy will lead to the production of 11 million tons of soybeans.

"The bank will provide

fertilisers to small holder farmers across Africa in the next four farming seasons with its influence with major fertiliser manufacturers, loan guarantees and other financial instruments," he stressed.

# Ukraine must decide its own future, says Poland's president

Poland's President Andrzej Duda has told lawmakers in Kyiv that only Ukraine has the right to decide its future.

The Polish president is the first foreign leader to give a speech in person to the Ukrainian parliament since Russia's February 24 invasion.

Kyiv has ruled out any peace deal that would involve ceding territory and has dismissed calls for a ceasefire that would involve Russian forces remaining in territory they have occupied, saying this would simply give Moscow time to rebuild its forces.

"Worrying voices have appeared, saying that Ukraine should give in to Putin's demands," Andrzej Duda said. "Only Ukraine has the right to decide about its future, nothing about you without you," he added, to a standing ovation in the chamber.

He said that the international community must demand that Russia completely withdraw from Ukrainian territory.

"If Ukraine is sacrificed for economic reasons or political ambitions, even a centimetre of its territory it will be a huge blow not only for the Ukrainian nation, but for the entire Western world," Duda said.

Poland's relations with Russia have long been fraught, since the Russian invasion Warsaw has positioned itself as one of Kyiv's loyal allies.

Poland is a strong advocate of tough sanctions against Russia and has been vocal in its support of Ukraine becoming a member of the European Union.

"I will not rest until Ukraine becomes a member of the European Union," the president said on Sunday.

## Four members of same family killed in tourist plane crash

It would be recalled that Union Bank's total assets rose by 19 per cent to N2.6 trillion in 2021, while Titan Trust total assets hit N136 billion in 2020.

In 2021, Titan Trust signed the agreement with Atlas Mara, Union Global Partners Limited and other shareholders to acquire 89.39 per cent of Union Bank's shares, subject to regulatory approval and other financial conditions.

"It is looking to obtain regulatory approval this month after which it will close the transaction," Amray said.
