Showdown in Delta guber primary, others, LP-led option emerges to fight APC, PDP

is a battle of 'godson' versus 'godfather' in Asaba as Governor Ifeanyi Okowa and Chief James Onanefe Ibori go head-to-head at the Delta State in what is seen as a do-or-die gubernatorial primary election of the Peoples Democratic Party (PDP).

The party and the rival All Progressives (APC) holding governorship primaries nationwide on Wednesday and Thursday.

PDP has held state and federal assembly primaries which APC is getting ready to hold throughout the weekend with its presidential one that stretches to next week.

Asaba, Okowa believed to be supporting House of Assembly speaker Rt. Hon. Sheriff Oborevwori as against Ibori's former finance commissioner David Edevbie in what observers and many others see as the battle for the political lives of the ex-governor and the incumbent. Heavy financial inducement of the delegates by both sides is being alleged.

former Okowa Justice commissioner Peter Mrakpor and Deacon Chris Iyovwaye among others while Chief Kenneth Gbagi and Donald Comrade Awolowo Egbo have dropped out and may be heading to other political parties to actualise their ambitions.

Meanwhile, the opposition base against the ruling APC ahead of next year's election been widened beyond the PDP as a third force or coalition alternative comprising about six registered political parties, labour groups and civil society organisations emerged.

The coalition has adopted the Labour Party (LP) as the arrow head of the third option.

"Operatives of the Economic and Financial Commission (EFCC),today May 24, 2022, arrived at the Maitama, Abuja home of a former Governor of Imo state, Senator Rochas Okorocha, to effect his arrest.

"EFCC had on January

24, 2022, filed a 17-count criminal charge bordering diversion of public funds and properties to the tune of N2.9 billion against Okorocha.

Ex-governor risks missing APC presidential screening

The case was assigned to Honourable Justice Inyang Ekwo of the Federal High Court, Abuja but attempts to arraign Senator Okorocha, were twice stalled owing to the absence of the exgovernor who evaded service of processes.

"At the last adjourned date, March 28th, 2022, Justice before adjourning Ekwo until May 30th, 2022, had warned that it was 'the last adjournment I shall grant in this matter.'

"In the circumstances. the commission is left with no option than to effect the arrest of Senator Okorocha and bring him to trial," EFCC said.

Meanwhile, the embattled senator earlier former pleaded with operatives of the Commission who invaded and barricaded his home to allow him to go for the screening of presidential aspirants of the All Progressives Congress (APC) holding Tuesday.

Okorocha is one of the 24 presidential aspirants being screened by the APC.

The Senator told newsmen that he was under siege after EFCC operatives on Tuesday barricaded his house.

He described the situation as an ugly development that does not portray the EFCC in good light. alleged He that the

Commission's invasion was a ploy to stop him from attending the APC presidential screening. Contrary to the claim of

the EFCC, he also claimed that no formal invitation was extended to him before the raid.

According to "Frankly speaking, I find myself in a situation of what call hostage. Policemen and EFCC operatives are currently in my compound to possibly whisk me away and my gate is blocked.

"All I am asking is to be allowed to go for my screening because I am a presidential aspirant and our election comes up on Sunday. If I am not allowed to go for this screening, I might miss it.

"I am not an unknown person in the country. I have an address and people know me in the country. All that it takes for the EFCC is to send me an invitation and I will gladly oblige."

Also, his lawyer, Ola Olanipekun (SAN), described the attempt by the EFCC to arrest the Senator

without a search warrant as a violation of his fundamental human rights.

According to him, got a distress call that the Rochas family is under siege as the lead counsel who is handling all the matters that are in Court concerning this

"I got here and I met a detachment of EFCC officers and security men and they are led by investigation officers who are familiar to us the legal team in this matter.

"My simple request is, what is going on here and the answer is that the Director Operations wants to have a meeting with His Excellency former Governor and Distinguished Senator Rochas Okorocha.

"Before now, there are issues on the ground. There are extant Court Orders restraining arrest. There are Court Orders made by the Federal High Court in Ábuja restraining interrogation on this matter

"So, what I have sought to do is to ask whether there are letters for an invitation? There are none. Whether there are warrants for the arrest? There is none.

"Are there court processes to be served? There are none. In fact, the processes are served by Court officials, who are the bailiff of the Court.

"I then asked what is really going on? I've also requested that the invitee should be given time to report either later this week or early next or any other time other than the day of the screening of presidential aspirants on the platform of APC which the Distinguished Senator is a most prominent person who is to be screened for the presidency of Nigeria.

'Today is the day of screening and an invitation by any security agency not preceded by a letter of invitation or notice before now, to us is very prejudicial. That is why we requested that a day be fixed so that the senator can voluntarily go and keep an appointment with whoever it is that is inviting him again that has been turned down.

"As I speak to you now the siege continues but reasoning must be made to prevail. What normally happens in such a circumstance like this in a country governed by law and the Constitution is that a citizen has fundamental human rights to freedom even when you are being investigated for any alleged offence.

Ĭ dare say it is a breach of the fundamental human rights of citizen Rochas Okorocha and it has to stop."

APC chieftain cautions Biafran agitators

A chieftain of the ruling All Progressives Congress(APC), in Imo State, Chief Alan B. Onyemaechi, has warned agitators who claim to be supporting the detained leader of the Indigenous People of Biafra (IPOB), Mazi Nnamdi Kanu, to shun violence.

He said violent agitation would jeopardize their aspirations and

complicate their leader's treason case.

Onyemaechi who spoke to the press in Owerri pointed out that persons hiding under the cover of the IPOB to unleash mayhem in the South-East had continued were only do so to complicate the treason trial of the detained Nnamdi Kanu and mess up the entire agitations of the Ndígbo for fairness, equity and justice in the Nigerian project.

He noted that since the civil war that ended in January 1970 the Igbos cannot be said to be doing badly in the Nigeria nation but declared that "the issue is that when it comes to making appointments, those in-charge of such appointments become apprehensive of giving Ndigbo their fair share in order not to surrender power to them or to re-launch them into their premiere positions because of the war."

He expressed that, Orlu has become a theatre of violence with lives and properties belonging to APC members being destroyed daily insisting, "it is not out of place to accuse political opponents of Governor Hope Uzodinma of being responsible for this.

BMO dismisses PDP's alleged APC's tenure elongation plot

Buhari Media Organisation (BMO) has said that Claims by the Peoples Democratic Party (PDP) of a ploy to extend President Muhammadu Buhari's tenure is a diversionary tactic in the aftermath of the crisis that trailed the opposition political grouping's primaries last weekend.

According to BMO, it is irresponsible of the opposition party to concoct a plot out of the President's delay in signing a further amendment to the Electoral Act 2022 at a time its primary election was marred by irregularities.

In a statement signed by its Chairman Niyi Akinsiju and Secretary Cassidy Madueke, the group said it was shocking that barely 24 hours after PDP through its National Organising Secretary Umar Bature released guidelines for its primaries, "the party spokesman Debo Ologunagba threw caution to the wind with a spurious claim of a tenure elongation plot over the recently passed amendment to the Electoral Act that the President has yet to give his assent to.

"For us, there is no explanation for this volte-face other than the harvest of crisis and drama that trailed the PDP primaries across the country.

"From the kidnap of delegates in Osun State and the death of a PDP member in Bayelsa to factional elections in Delta State, there are clear signs that PDP has not learnt from its past mistakes and this is what the party leadership wants to divert attention from, with its lame claim on the delayed Presidential assent.

"Our advice is for the party that has been boasting about 'rescuing Nigeria' to first rescue itself from its time-tested violent ways and learn to play decent politics.

"This advisory also extends to the need to act in a responsible manner instead of seeking to stoke crisis with unfounded claims".

BMO wondered why any individual or group could hold the Presidency responsible for what the National Assembly has since described as an unintended error.

'Killing of pregnant woman, kids terrorism, not ethnic cleansing'

Human Rights Writers Association of Nigeria (HURIWA) has condemned the reported massacre by gunmen in Anambra State of a pregnant woman, the unborn baby and her four kids. It described it as a most gruesome and despicable crude terrorism of the 21st century which must be attended to swiftly with every might that the Anambra and federal governments can muster.

In a media statement, HURIWA through the National coordinator Comrade Emmanuel Onwubiko, called on governors of the South East region to as a matter of extreme urgency, take transparent steps to stamp out this emerging terrorism which is capable of instigate civil strife across ethnicities.

IThe group said: "We urge

Igbo governors to act swiftly because the killing of these innocent souls is beginning to take ethnic dimension especially after the Ebonyi State governor Dave Umahi appeared on television to mention the unknown gunmen as being Igbos even without providing any shreds of forensic evidence.

"HURIWA is appealing that there should be a security meeting between South East governors and governors of Northern region so steps are taken urgently to make it very clear that no sane person is supporting act of terrorism."

HURIWA condemned the mass murders on Sunday in Anambra State, following the killing of seven persons in various locations in the state. Out of the number, four were siblings. Their mother was also among the dead.

The attack took place at Isulo in Orumba North council. The other two persons were killed at Abatete in Idemili North council.

"HURIWA recalled that the gunmen invaded the areas, opened fire on the victims and left showing that there is no ethnic colouration but pure act of terrorism which must be stamped out by first and foremost bringing the perpetrators to face the stiffest penalties.

"HURIWA is once more asking the Governor of Anambra State to urge his brother governors of the South East to work out regional strategies for stamping out this emerging terrorism which has nothing to do with any sort of political agitation but these are acts of terrorism.

Edo, USA partner on agric, others

Edo State and the United States, are exploring areas of investment to sustain the gains recorded by the Obaseki-led government in agriculture, economy, healthcare and education, among others.

Governor Godwin Obaseki disclosed this when he received the United States Ambassador to Nigeria, Mary Leonard, who was on a courtesy visit at Government House, Benin City.

The governor said his government is sustaining efforts at engendering sustainable growth and development and ensuring economic prosperity for Edo people. He said, "for us, it is all about our economy. We have been able to grow our economy to align with its potential. We are addressing a whole lot of issues, particularly security and healthcare to sort out the economy.

"We are working to fire our economy to the extent that we utilize the economy to the benefit

of our people, and one key driver for us is agriculture; food. The number one pressing issue in Nigeria today is food availability. We are going to make sure we focus on food production and economic growth. We are engaging with our young people and trying to position them to take advantage of the opportunities in culture and technology globally. In order to be competitive economically, the key asset you need are your people; the key driver they need is education. They have to be educated. We are emphasizing education, particularly basic education," he added.

Reaffirming his government's commitment to ending the menace of human trafficking and illegal migration in Edo, Obaseki further noted, "We realized that it is that lack of hope and poor education that fuels irregular migration, and we have tried as much as we can to curtail that menace of irregular

migration by creating hope for them; nobody wants to leave home if the home is comfortable."

Highlighting the success recorded by his administration in the health sector, the governor said the state partnered with the Association of Nigeria Physicians in the Americas (ANPA) to provide free medical outreach to Edo people.

to Edo people.

He said, "A couple of weeks ago, we received 67 medical practitioners in our state and they worked with our personnel on ground to improve quality healthcare delivery to our people. For us, with healthcare, it's about the foundation. If we have the basic health footprint right, as well as the training of community healthcare heads, then it will not be too challenging dealing with diseases such as malaria and distributing vaccines."

On culture, Obaseki added, "For us as government, our goal is to position Edo for the subcontinent. We are working

with the European Government in the areas of storage and preservation facilities and the Nigeria Government, to strengthen the national museum monuments' facilities. We are looking forward to working with the Royal Palace in building a royal collection and the whole idea is to build the Edo Museum of West Africa Art (EMOWAA) where you will have a lot to see when you come in."

Earlier in her speech, the United States Ambassador to Nigeria, Mary Leonard, saluted the government for its anti-trafficking laws, noting that they have helped in curbing irregular migration among young people in the state.

While reassuring the support of the United States, she further hailed the Obaseki-led government for its various programmes to positively engage Edo youths. Leonard further revealed that museums in the United States of America are intensifying efforts to repatriate Benin artifacts in their possession.

The event included celebrating the diverse abilities of persons with disabilities through song ministration, dance, testimonies among others. On the occasion, 17 visually impaired persons received white canes from the church, free gift packs for all participants among other foods and drinks.

Mr. Jake Epelle, Chief Executive Officer and founder, Albino Association of Nigeria and a special guest, relieved his plight as a person living with Albinism. Among the negative ordeals are isolation, neglect, self-education, abuses, domestic accidents, hurtful jests from school mates and society. He encouraged the audience to read more about Albinism and special persons and to relate with the first as humans beings created by God instead of discrimination.

Epelle disclosed that he would retire in a few years and groom persons to con-

tinue with the foundation's legacy and businesses to concentrate on his pastoral service.

Pastor Dapo Fesayo, Head of Protocol, observed that most persons are so engrossed with life challenges, families, finance and oftentimes forget about people with disabilities around them and outside the church.

He thanked God for putting the Disability inclusion drive into Pastor Akabueze's mind and for his spearheading the laudable initiative.

He added: "God made us bright and beautiful; so we should love everyone regardless of colour, size, background or tribe.

Blind, a radio OAP, urged government at all levels to support persons with disabilities and not only pay lip service, "Specially, the Federal and Niger Delta States governments to build schools, infrastructures for them," he urged.

According to him, as an indigene of the Niger Delta regions, blessed with the oil, he regrets that there are neither special schools for the blind and deaf nor even vocational training for people with disabilities." Sadly, most people with disabilities are languishing and unproductive in those

regions," he stated.

Kelly the Blind disclosed that he has been leading the cause of people with disabilities through his radio programme for over seven years with stiff opposition from various quarters. He emphasized that there are millions of special persons in Nigeria but despite the Disability Bills, these are not well catered for.

Mr Adebayo Muritala David, Creative Director, African Craft Shop Nigeria and a visually impaired man, charged the government to do more by giving scholarships to children of people with disabilities and empowering others with vocational skills according to their interests.

He disclosed that he is based in Osogbo, Osun State and he has been training clusters of persons with disabilities in his community but not sustainable due to lack of funds.

He recalled his bitter experience from family and society for being blind and as a Christian from a Muslim background. But God stood for him and his family and so he will never denounce his Christian faith, he added.

Joint military operation set to take place in Anambra, Imo

A Joint Task Force (JTF), consisting of soldiers and police, is set to conduct offensive operations in Anambra and Imo states, following the killing and destruction of property by unknown gunmen. The Trumpet gathered that aerial and land assaults will focus on Anambra South and Orlu Senatorial District in neighboring Imo State.

Meanwhile, the community vigilance groups in Anambra's 176 communities are to be disbanded by the state government following allegations of compromising the security operations. Also, a new community vigilante outfit is being formed by the state government towards defeating the gunmen.

As at the time of filing this report, no fewer than 57 suspects have been arrested in connection with the killings in Anambra, with over 18 criminals killed by government forces.

The Commissioner of Police, Anambra State Police Command, Echeng Echeng, who addressed a press conference in Awka, frowned upon the reluctance of residents to volunteer information on the activities of criminals in their areas.

He insisted that there was nothing 'unknown' about the gunmen terrorising the state to warrant

the 'unknown gunmen' tag. Echeng said: "We are putting together a new community vigilante outfit because the group we have now has compromised the security operations in the state."

"The current one would be disbanded because people do not come up with relevantf information about the activities of these criminals and you know that security is a joint thingn and it is not for security officers alone.

"This thing you call 'unknown gunmen' is wrong because we know them and they are in

those communities and they are living with the natives. They are not spirits, they are human beings and we have made a lot of arrests and a great number of them were killed in the course of engaging them.

"They only have shrines where they force the natives to take oaths of secrecy and silencen and all these things are basically psychological angles to cow them."

Paternity crisis as herbalist claims impregnating woman

Sikiru Olaleye and Lamide Afolabi are currently in a war of words over the paternity of a male child delivered by the former's wife, Sadiat. She, until delivery, had been patronising Afolabi, a herbalist, for fertility concoction, having been in marriage without fruit of the womb. The herbalist is now claiming he slept with the woman for her to conceive, while taking the concoction.

Sources said Mr. Olaleye was not only shell shocked that his wife and the native doctor cheated on him, he is most distraught that the native doctor is claiming paternity of his boy, claiming that he was the one who impregnated his wife.

The 42 year-old native of Igbehin, also in Owode-Obafemi Local Government Area, said, "I had never seen anything like this before except in a movie. It happened that my wife, Shadiat and I had a disagreement and she left for her hometown in Iwo, Osun State, with our son. I visited her hometown and tried in vain to persuade her parents to reconcile us. I even gave Shadiat's parents N12,000 for her transportation back to my house, but she refused.

"So, I gave up on the possibility of her returning to my home and took solace in the belief that when the time is ripe, my son would come back to me since I had tried my best to make her return home. It was a shock when some people in our neighbourhood started mocking me that my son belongs to a herbalist in the nearby village called Malaka. His name is Lamidi Ifaloba, a herbalist whom my wife patronised and he actually made some fertility concoctions for my wife when she could not get pregnant for about six years.

"I was shocked and devastated and I could not pull myself together for a long time, especially when I learnt that a lot of people in the community already knew about the matter. I learnt that Ifaloba claimed to have named the boy Iunior and even boasted that the matter would unsettle the community. My wife and I did not have any quarrel on the day she left my house. I only returned from work and found that she had left with all her belongings. Even our neighbors did not know when she moved all her belongings out of our apartment."

He noted that his wife could not have accused him

of being impotent or use that as an excuse to engage in extra-marital affairs with Ifaloba which resulted in the controversial pregnancy and child adding, "I have had three children from my previous marriage to another woman and my first child currently attends Abeokuta Grammar School.

"I am no longer interested in taking back my wife, but I want to have custody of my son, hence, I am crying out to the public to dissuade Ifaloba from taking what truly belongs to me after his escapades with my wife. He cannot take my wife and also take my son."

But reacting, the herbalist explained that he was lured to bed by Olaleye's wife on a day her husband chased her out of their apartment during a quarrel and she rushed to his house around 1.00 am. He said: "Actually, his wife ran to my house in the night and accused her husband of beating her over a disagreement. The weather was actually cold that night and I asked her to stay till next morning, while I was busy fixing some things. But she told me that she suspected her husband's sperm was not fertile enough to get her pregnant.

The Trumpet gathered that the victims' families were contacted by the abductors to demand a sum of N10 million before they could release them, but the family could not afford the sum.

However, it was gathered that the victims were released on Monday to reunite with their family after a ransom -N1 million - initially rejected was paid to the abductors.

Confirming the incident, the Police Public Relations Officer(PPRO) of the state, SP Funmilayo Odunlami, said the victims were already with their family members.

Another incumbent senator loses return bid

Senator Nicholas Tofowomo, representing Ondo South in the National Assembly, has lost his bid to contest as candidate under the umbrella of the Peoples Democratic Party (PDP) in the forthcoming 2023 general elections.

Senator Tofowomo, who served as the Commissioner for Transport during the administration of former Governor of Ondo State, Dr Olusegun Mimiko, succeeded Yele Omoguwa and assumed office in June 2019 as well.

Speaking with newsmen after the election, the winners lauded the delegates and leadership of the party for a free and fair election. They urged other contestants to see their emergence as a victory for all of them, adding that the task ahead was huge.

Undergraduate strangled to death by lover

▼ do State police command d has arrested a 27-year-old d man, John Aipoh, for reportedly murdering his 24-yearold lover, Precious Ikpikhumi, after she ended their four-year relationship.

Precious, a final year student at the University of Benin Teaching Hospital's Institute of Health Technology, was declared missing by her family on May 1 after she went to church and did not

The police, after a detailed investigation arrested John who confessed to have ambushed Precious while she was on her way to church on May 1, took her to an uncompleted building where he murdered her, and then moved to an unknown destination.

It was uncovered that Precious and John have been at loggerheads over some issues. It got so bad that Precious even sent a voice note to a friend of hers in which she expressed fears that John might kill her for calling off their relationship.

In the voice note Precious said;

"What I want to let you know is that it is not those two boys that are making me to do all these things. It has been long I have been telling John. John said I cannot tell him that I am tired of the relationship as he was the one who approached me and he is the one who can decide when it will end. I told him even if you force me to date you, hope you know you cannot force me to marry you. It is better we have a broken relationship now than a broken marriage.

"I can't please. I cannot die. If it happens that truly he harms

me or kills because I refused to continue dating him, I know it shall never be well with him. My blood will always cry over

"I have made up my mind. If is that I will die in this relationship, a fly that fails to hear word is one that follows the corpse into the grave. Since I don't listen anything John does to me I will

Precious is said to have gone into hiding after calling off their relationship but was unfortunately found by John.

On May 1st, 2022, John dragged

her to an uncompleted building and killed her by using her scarf to strangle her. He then escaped to an unknown destination.

Following his arrest, he took the police to the uncompleted building where he dumped Precious's lifeless body.

When interrogated, John, who was found with the phones of the deceased, said he killed Precious in anger after she called off their four year relationship.

Precious's body has been deposited in the morgue while the suspect is now in police custody and will be charged to court.

FG to spend N999m daily on feeding 10m pupils

Approximately 10 million pupils will be fed by the Federal Government with N999 million daily under the National Home Grown School Feeding Programme (NHGSFP) across the country.

Hajiya Aishatu Digil, the Team Lead of NHGSFP, disclosed this at a stakeholders meeting in Abuja on disbursement modalities for the review of cost of feeding in the programme.

She said Hajiya Sadiya Umar Farouq, the Minister of Humanitarian Affairs, Disaster Management and Social Development got approval for spending N100 per person daily on the

feeding programme.
She said 9,990,862 pupils from primary one to three in the programme would now be fed with N100 daily for 20 days in a month, which would amount to N999,086,200 million daily.

"Prior to this, we were feeding school children with N70 per child, per meal. This was since 2016 but the President has approved N100 upward review. "We have all stakeholders like

the World Food Programme, National Bureau of Statistics, National Orientation Agency (NOA), Global Alliance for Improved Nutrition (GAIN), Ministries of Agriculture, Education and others to deliberate on the modalities of disbursements.

'We are here basically to look at how best we can realise the benefits of the programme based on the new approved cost to improve the standard and quality of the meal and menu for the

The breakdown of the N100 is as follows; N70 is for the cost of all food items except egg, N14 for cost of egg to be implemented through the state structures in partnership with Poultry Association of Nigeria. "We are planning of having 'Egg Wednesday', where each child in the programme will be

giving one egg every Wednesday. "N10 stipends for cooks, N5 and N6 for micronutrient fortification, payable to cooks and one naira for quality assurance,

payable to supervisors, which is optional," she said. Digil said the programme would ensure the elimination of poor implementation practices, adding that the ministry was looking out for reforms.

"After this meeting, we will collate inputs from stakeholders and present to the minister so that we will implement the reviewed feeding cost in the next feeding circle, which starts this month," she said.

Dr Umar Bindir, the National Resource Person of the National Social Investment Programme said that the programme was not the responsibility of the Federal Government alone.

The Programme Manager of NHGSFP Malam Musa Abubakar in Sokoto State said pupils and their parents were happy with the initial N70 per meal per child.

"However, with the upward review of N100, all of them will smile as this will also boost the rate of school enrolment."

Mr Chika Ebogha, the Chief Programme Officer at NOA said

the N100 per meal per child was a good improvement.

Ebogha called on Digil to step up in the area of compliance in states that have challenges, adding that NOA was willing to assist on monitoring and evaluation of the programme

Mr Kingsley Anikwe from the Federal Ministry of Agriculture and Rural Development suggested that formation of school gardens should be encouraged in schools to handle the production of agricultural produce.

Mš Irowa Irabor, the Project Manager, Enhancing Access to Safer Nutritious Diet Project (GAIN) said the organisation would provide technical and capacity development to the programme.

Irabor said GAIN would be interested in the "Egg Wednesday Campaign", adding that the organisation could support in creating visibility in the implementation in states.

Mr Onallo Akpa, the Director-General, Poultry Association of Nigeria called for effective collaboration with the association to actualise the "Egg Wednesday" initiative.

However, some stakeholders suggested that state governments should actively involve others, saying that cooking of meals should be done within the school vicinity and that farmers should also be evaluated.

ASUU denies rejecting new FUTA Vice-Chancellor

Academic Staff Union of Universities, (ASUU) of the Federal University of Technology (FUTA), Akure has dissociated itself from some concerned members kicking against the appointment of the institution's new vice chancellor

There were reports on Thursday that the union rejected the appointment of Adenike Temidayo Oladiji.

A statement issued in Akure by ASUU's Chairperson, Prof. Oluyinka Awopetu and Secretary, Dr. E. Rasaki, described the alleged rejection of the new VC as misleading. The leadership of the union dissociated itself from the reports, saying it never rejected the appointment of the new VC.

"These publications, largely titled 'FUTA VC: ASUU kicks, says appointment fraught with fraud, lacks transparency, never hensive strike, which in part does originated from ASUU-FUTA secretariat.

"The said publication was signed, according to the reports, by two professors who are not members of the executive of ASUU FUTA branch. The two have no rights, neither were they authorised, nor have the capacity to speak for and on behalf of ASŪU FUTA branch.

"All communications from the branch are duly released by the branch chairperson and secretary only.

"Similarly, in other publications, we learnt of a purported position of FUTA Senate.

"As it is, the nation is aware of the ongoing total and comprenot allow any meeting to hold. It was thus an embarrassment that our members were purported to have held a Senate meeting.

"To the best of our knowledge and all facts on ground, no Senate meeting was held in our university to pursue this position.

"ASUU FUTA, by this statement, is calling on members of the union and the public to disregard the statement in its entity as this is not the position of ASUU-FUTA. ASUU is a union of intellectuals and will not result to any act that can mislead the public," the statement stated.

Ekiti varsity resumes despite ASUU strike

Amid the ongoing strike by the Academic Staff Union of Universities (ASUU), the management of Ekiti State University (EKSU), Ado-Ekiti has announced the resumption of academic activities from Tuesday, May 24, 2022.

Bode Olofinmuagun, Director of Information and Corporate Affairs, who issued a statement to that effect said the management of the institution took the decision to resume at a meeting on Monday.

Olofinmuagun disclosed that the management discussed the impact of the ongoing strike by all the four staff unions.

According to him, the administration was concerned about the pains experienced by students and parents.

He explained that one academic session of admission (2021/2022) is still open, and the second semester of 2020/2021 is still open.

The statement read, " The management of Ekiti State University, Ado Ekiti (EKSU), at its meeting held today, 23rd May, 2022, discussed the impact of the ongoing national strike embarked upon by all the four staff unions as it affects the university vis a vis academic and other activities.

"The management noted the pains being experienced by students and parents as a result of the on-going protracted industrial action.

" The management noted further that one academic session (2021/2022) of admission is still outstanding, while the second semester of the 2020/2021 academic session is yet to be concluded. Moreover, the admission process for the 2022/2023 academic session will commence soonest.

"Consequently, in the interest of the students, parents, guardians and indeed the society at large as well as the survival of the university, management decided to reopen the institution for normal academic activities with effect from Tuesday, 24th May, 2022."

ASUU had on February 14 declared a one-month warning strike to protest the nonimplementation of its demands by the federal government.

On March 14, the union extended the industrial action by eight weeks, citing the government's failure to fully address its demands.

The union thereafter extended the strike by another 12 weeks.

However, The Trumpet learnt that information about the venue of the Chief Orbih's parallel primaries got to a top official of the state government who allegedly mobilised some gunwielding miscreants to the place with the

Those who have won delegate elections in Nigeria over the last two decades fall into the following categories:

1. Those backed by an incumbent government at national or state

2. In the absence of a incumbent FG; those who are supported by a majority of "Super Stakeholders". These include sitting state governors, former governors & leaders in states where no sitting governors exist.

3. Aspirants who are able to dispense stupendous financial

In the absence of an incumbent FG, a very rich aspirant can prevail against scenario 2 above.

Delegate elections are devoid of conscience, rational thinking, patriotism or the principle of right

From my many years of experience, 70 to 80% of delegates vote along with the dictates of their leaders. It has nothing to do most often with their personal convictions.

WHY IS THIS SO?

It is so because at the end of the convention everyone returns to his state. If at the convention you refused to toe the line, most assuredly you are likely to pay for it and certainly you will not be a delegate in the next election ...and so will many perks and privileges elude you in your state.

This is not restricted to ordinary delegates alone. Even if you were a former minister or senator or whatever, once you fail to align with party directives, be ready for sanctions from the powers that be within the party in your state.

INFLUENCE OF MONEY

This is a very interesting and intricate matter. *Money in some may be the ultimat factor. And in other situations where group or regional interest is crucial and compelling, it may be of little consequence.

"But without money or with an offer considerably much lower than the leading contender financially, the poorer aspirant irrespective of pedigree, competence or suitability, may have no chance of winning at all.

Mischievously, and quite treacherously, the new trend is that each state delegation collects monies from all the aspirants and thereafter do one of to things.

1. They still vote for the aspirant they had decided on from home based on several considerations.

2. Divide their votes pro rata in accordance to how the aspirants have faired financially.

In the last PDP convention in Port Harcourt in 2019, most delegates went home with between \$8000

This year, the figures are bound to be higher. The big spenders are prepared to go as far as \$10,000

As I write this piece, a delegate election to elect the state assembly member for my local government is underway Informat me from the venue is that one of the two contestant is offering N200,000 per delegate while the other has offered N150,000.

We have 10 wards and 3 delegates per ward. That is, each aspirant will today dispense N6m for this delegate election!!!

Of the many reactions, two stuck with me. One was from a younger colleague and a close friend who currently edits one of Nigeria's biggest newspapers.

He said, "on this your appointment, I don't know whether to tell you congratulations or ask what the heck you think you are doing."
I chuckled. I knew what he wanted

to say, but I asked him what he meant

anyway.
"I am just here wondering why you a former presidential spokesman and former News Agency of Nigeria MD, would accept to run a state governorship campaign media", he said.

The second reaction that stuck was that of a senior colleague. A very well known retired TV executive of Delta State origin.

"Congratulations", he said. Before I could say thank you, he fired off rapidly, "I am happy you are doing this, but are you not backing the wrong horse? APC? Delta State? You know Delta is a PDP State, so what do you think you are doing?", and so on and so forth.

My response to both men forms the

basis of what I'm going to say here.
To my bright young friend, I explained that Délta Štaté is in a desperate situation. And where we are in our State, there's no longer any big or small man. There are no former presidential spokesmen or former NAN managing directors. It is just we the people against they the government.


I told him that since the beginning of the 13 per cent derivation from crude oil receipts, Delta has earned close to N20 trillion. In simple maths, that's N20,000 billion. I challenged him to ask his reporters in Warri and Asaba to capture the State in one word. "Deplorable", he said; "I know Delta very well. I have been there many times."

The fact is that the situation is worse than deplorable. In Delta, poverty walks on four legs, in unpaved streets of filth and mud. There are only very few parts of our cities that you can come upon and say 'I want to live here.' Criminality seems to be deliberately condoned, maybe even encouraged in the State. Almost everywhere else, outside the capital, Asaba, seems besieged.

There are police and military checkpoints every few yards on almost every major road. But in between these checkpoints are black spots of horrendous criminality, and tales of woe and helplessness.

In private circles, there's conversation that suggests that criminality is condoned as a sublime weapon to scare

well-to-do indigenes from coming home. This way, thugs, goons and their sponsors in power won't have to answer too many questions to the elite and

others about how the State is being governed, and misgoverned.

Only recently, journalists in Warri who cover the two southernmost senatorial districts, Central and South, decided to stop reporting the activities of the state government. Their reason: the government has been totally unfair to the people of the area. The journalists, under the aegis of the Nigerian Union of Journalists (NUJ), in a statement, accused the government of not being in touch with the needs and challenges of the people. They said the government was distant and unable to give any coherent account of their activities in these very large parts of the State.

If the situation in Delta was caused by just corruption, it would have been a straightforward issue. But when you add incompetence, greed and man's sheer inhumanity to man into the mix, you will find that compassion, natural intelligence, a sense of balance and a record of performance, are perhaps all we need to reshape the narrative.

And in all these, Senator Ovie Omo-Agege stands head and shoulders above the entire field of governorship hopefuls in Delta today.

The quite unhelpful argument about Delta being a Peoples Democratic Party (PDP) State is naturally a non-starter. In the contest for the hearts and minds of Deltans, we are first individuals before we are party men. Then I ask, show me one politician of note and clout in Delta that isn't the product of the PDP. Those of us who left did so in protest of the wickedness that governance has become in the State.

With the weakest infrastructure possible, a sea of unemployed and sometimes unemployable young people, and governments that have since stopped pretending to offer anyone hope, Delta is today a bubbling cauldron of pain and anguish.

The resultant anger is expressed in inter-ethnic violence, street fights, armed robbery and prostitution, as each group engages with red-eyed vigour to grab the scraps from the tables in Asaba.

But the All Progressives Congress (APC) has a different plan. And it's not about a party playing sanctimonious and being holier than thou. It is instead about a party that is a protest movement against the evil that currently stalks our home State. A national party that, warts and all, represents in Delta a powerful counterpoint to a band of very bad people. Persons denuded of conscience, and whose legacy is not on the streets of Delta, but in offshore bank accounts and acreages.

There's a common joke about Delta that surfaces often on Facebook and elsewhere. Young, angry Deltans would copy pictures of six lane highways and gleaming infrastructure from elsewhere and caption these "my xyz village in Delta State". Beyond the sardonic laughter that these posts cause is a story of total disillusionment and frustration over what is and what could have, and really should be.

Someone recently asked me, what is he going to do differently? This was the precise question I asked him when he requested me to execute this crucial aspect of the campaign.

This is what he told me.

"I will re-engineer governance in Delta. I would create wealth and employment by building industrial hubs and open them to manufacturers at rock bottom, but reasonably competitive leases.

I will invest our wealth in Independent Power Plants to power factories, streets and homes.

I will drive ICT and make my state the new Nigerian Silicon Valley.

My plan is to BUILD A NEW DELTA, so I will embark on an immediate infrastructure revolution as part of my industrial strategy

The ultimate goal will be to create the best infrastructure possible without incurring untold, untenable and prohibitive costs.

Today's Delta, he maintained, is a reminder that as a people we must reflect on our journey and assess where we are as against where we ought to be. As part of this reflection, we have come up with a developmental blueprint within our manifesto that encapsulates nearly all aspects of our existence as a people.
His words: "Our strategy is captured

as Employment and Empowerment,

Development, Good Governance and Enduring Peace and Security. In the short form, we call it the EDGE to BAND (Build a New Delta), and it is our governance strategy from micro to small and medium enterprises, women and youth empowerment, skills acquisition, social safety nets, pension policies, infrastructure, agriculture, deliberate and forward looking industrialisation, sports, entertainment and the entire works.

"Take infrastructure, for instance, I plan to immediately embark on a large scale investment in industrial estates, schools, hospitals, good road networks, top class but affordable transportation systems, housing, potable water, power infrastructure, ICT, and more as part of the strategy to put industrial development back on track."

In my brainstorming session with Omo-Agege before I accepted the job, and in others thereafter, I have come to observe his passion for people and development. And he backs it with concrete evidence. As a senator and later, deputy Senate president, without any executive power, he successfully brought in a slew of projects to Delta

These include the Federal Polytechnic at Orogun, the elite Nigerian Defence Space School, a Federal University of Agriculture and Technology, and a campus of the Nigerian Law School, the latter two of which have been approved by the Senate.

He also embarked on an ambitious power programme with the aim of solving electricity distribution challenges: Bringing in brand new transformers and replacing obsolete ones in many areas state-wide. He also single-handedly embarked on the mass provision of solar street lighting across all towns and villages of Delta Central.

While a senator, Omo-Agege carried out mass renovations and furnishing of select schools across the state; he constructed water schemes, dragged in additional funding for several stalled and struggling federal infrastructure projects, and on and on.

There's so much more he has done that to chronicle all here will appear as a hagiography of sorts. But to my mind, Omo-Agege, has a proven record of service. And in such a short time (he's been less than three years as deputy Senate president).

His far reaching plans to lift Delta back to its feet ring true, and are punctuated with clear do-ables and concrete milestones. As for willpower, he made it clear to me, as he has to others, that he is not afraid of breaking eggs to make an omelette. Anyone who knows him well knows that he's a fairly tough guy.
"I am not going to pussyfoot over

issues. I will be decisive and do what needs to be done when it needs to be done, in the interest of our State and people", he says.

Buhari, Bawa berate judiciary on anti-corruption war

resident of the federation, Muhammadu Buhari, and Executive Chairman of the Economic and Financial Crimes Commission, (EFCC), Abdulrasheed Bawa, have said the loss of cases in the courts on technical grounds cast a slur on the integrity of the judiciary and questions its commitment to the fight against graft.

The duo spoke at a three-day capacity building workshop, themed, "Judicial Dynamism: A Key Factor in the Fight Against Economicand Financial Crimes."

The event, which was organised for judicial officers, corruption investigators, and prosecutors, had Senate President Ahmad Ibrahim Lawan, House of Representatives Speaker Femi Gbajabiamila, as well as President of the Court of Appeal, Justice Monica Dongban-Mensem, and other top government officials in attendance.

Buhari, represented by Secretary to the Government of the Federation (SGF), Boss Mustapha, said cases lost on technical grounds questioned the commitment of the judiciary in the

fight against corruption.
"Every corruption case lost on technical ground raises questions about judicial commitment to the fight against corruption. Perpetrators of corruption, economic, and financial crimes should not be allowed to escape the justice they deserve on grounds of technicalities and conservatism.

"The judiciary should not see itself or act as mere spectators or bystanders whilst criminals exploit mere technicalities to escape with our commonwealth, get bolder, and embolden others to continue in the unwholesome act of

corruption," he said.

Buhari, therefore, charged judicial officers to, "consciously aim to plug loopholes being exploited in our laws by critical elements in our midst."

Earlier in his opening remark, Bawa expressed concerns about corruption cases lost to technicalities at various levels of court in the country, stressing that such development may serve as a disincentive to the fight against economic and financial crimes.

He said corruption cases lost on technical grounds had a way of boosting the confidence of corrupt elements and negatively affected the cherished image of the judiciary.

Bawa said, "As a commission, we do not expect every judicial decision to go our way, but there are instances the EFCC and many Nigerians have been left at a loss about certain judicial decisions, where defendants who obviously have stolen our commonwealth and those who have aided and abetted them have been allowed to go home to enjoy their proceeds of crime on technical grounds.



"This has the tendency of affecting negatively the cherished image of and confidence in the Nigerian judiciary both locally and internationally.

"In the commission, we hold the view that corruption is a plague that does not select its victims. Those stealing and abusing our common patrimony do not wish us well.

"Judges are as much victims of corruption as the ordinary man on the streets. It is therefore in our collective interest that the gains of the fight against corruption are not reversed. This is also why we must aggregate fresh opinions and forge deliberate winning tactics and strategies to stem its ugly tide.

Reviewing the impact of the EFCC in the fight against economic and financial crimes, in its 19 years of existence, the EFCC boss stressed that the commission had carved a niche for itself with numerous milestones to its name.

"However, in the little over a year that I have had the privilege to superintend, the commission secured an unprecedented record of 2,220 convictions. It is the highest ever in the history of the commission and as I address you this morning, we have already secured 1,222 convictions, thus far, this year," he said.

While commending the judiciary for its role in making the conviction record possible, the EFCC Chairman advocated for an enhanced welfare package for Judges and Justices. He also harped on collaboration between the legislative arm of government and the judiciary in drafting and enacting laws.

Meanwhile, Attorney General of the Federation and Minister of Justice, Abubakar Malami (SAN), in his goodwill message, commended the EFCC and the National Judicial Institute for collaborating over the years in building capacity for judicial officers, stressing that technological advancement and globalization made it imperative for law enforcement agencies and the judiciary to be up to date with emerging trends.

"We are aware that technological advancements and globalization have brought about an increase in digital activities and transactions.

Economic and financial crimes have moved to the digital world and cybercrime has become the focal domain of

"There is a need, therefore, to bring our judiciary and the law enforcement agencies up to date with emerging digital trends," he added.

Also, at the event, the Chief Justice of Nigeria, Justice Tanko Muhammad, assured that the workshop would identify factors that served as impediments to the effectiveness of the EFCC and the judiciary as veritable tools for the prevention and successful prosecution of financial crime cases in Nigeria.

ICPC, NDLEA to synergize for better drug law enforcement

National Drug Law Enforcement Agency (NDLEA) has proposed to partner with the Independent Corrupt Practices and Other Related Offences Commission (ICPC) to rid the nation of illicit drugs.

NDLEA Commandant of Kano State Division, Abubakar Idris Ahmed, made the proposal during a courtesy visit to the ICPC Kano State office, stressing that he needed to work in partnership and in synergy with ICPC to defeat drug-related criminality.

According to him, "No single agency can defeat criminality alone in Nigeria, but the value and performance of the NDLEA, combined with that of ICPC would be greater than only the effort of NDLEA fighting the menace of illicit



drugs in Nigeria.

"Behind every crime, the motivating factor is money. This is where the two agencies should collaborate. It is critical that we establish a relationship so that we can achieve greater success in drug law enforcement. The majority of crimes committed in the country today are committed while under the influence of drugs."

On his part, the ICPC Resident Anti-Corruption Commissioner (RACC) of Kano State, Ibrahim Garba posited that there was a relationship between illicit funds and illicit drugs trafficking, thus the need for NDLEA and ICPC to move quickly to check illicit financial flows and drug trafficking in Nigeria.

Garba expressed his delight with the request for synergy and added that the Commission had always welcomed inter-agency collaboration with other law enforcement agencies in its crusade against corruption because it recognized that the war on corruption and crime could only be won through a collaborative approach.

The highlight of the event was the recognition of the ICPC RACC as an Ambassador for the War Against Drug Abuse (WADA) by the NDLEA Commandant Kano, on behalf of the Chairman of the NDLEA, Brigadier General Mohamed Buba Marwa (Rtd).

'Improvement on money laundering investigation, prosecution imperative'

Provost of the Anti-Corruption Academy of Nigeria (ACAN), the research and training arm of ICPC, Professor Olatunde Babawale, has

reiterated the importance of effective investigation and prosecution in money laundering cases.

He stated this while giving a welcome address at a workshop on Anti-Money Laundering and Counter-Terrorism Financing at the ICPC headquarters recently.

According to him, the workshop was a follow-up to an unfavorable mutual evaluation carried out by the Inter-Governmental Action Group against Money Laundering in West Africa (GIABA) 2019 which rated Nigeria low in the investigation and prosecution of money laundering.

Professor Babawale opined that financing of terrorism and money laundering are crimes with economic effects which only differ in the sense that money laundering often comes from an illegal source, whereas terrorism finance has to do with 'who' the money goes to and 'what' illegal group or activity it supports.

He likewise referred to the UNODC's report which estimated that about 2-5% of global GDP (\$800 billion to \$2 trillion) is being laundered around the world annually.

He lauded the ICPC for doing a lot in building and continuously applying modern strategies to aid its enforcement mandate as stated in section 6a of the Corrupt Practices and Other Related Offences Act 2000.

"The primary reason for establishing the Academy is to facilitate the effective implementation of ICPC's mandate, cardinal among which is enforcement, and to equip ICPC officers with the necessary skills and knowledge that will enable them to perform at the required level," he said.

He, however, added that the evernanging nature of terrorism and money laundering requires the Commission to do more. "It is to this effect that the academy is expected to provide a system of training and re-training that will continually produce sound anti-corruption policies, operational efficiency, and good management culture,"

The provost stated that the content of the workshop was carefully put together to ensure maximum learning by participants and also equip them with enhanced skills of investigation and prosecution with a view to laying the foundations for a sustainable assault on corruption.

Corruption in Passport Offices

he Nigerian Immigration Service (NIS) needs to address the corruption that has taken over its Passport Offices across the country. An article was recently published in a daily newspaper detailing the nature and depth of deep-rooted corruption among NIS officials in the Lagos and Ovo Passport Offices. The problem is, however, not peculiar to these two states alone. Corrupt officials extort Nigerians applying for passports, making them pay sometimes up to double the legitimate fee of N27,000 for a 32-page passport.

The registration is supposed to be done online, but applicants who follow this due process and submit their print-out to the Passport Office almost certainly face a delay of weeks, if not months. One is spared only if the palms of certain officials are "greased" with cash. People who are willing to pay could get their passports in as short a time as 24 hours depending on how much they are willing to give as bribe. For this reason, many applicants, are forced to defer or even cancel their travel plans. Some may lose out on a job opportunity that requires one to present an international travelling passport.

Nigerian students who have gotten admissions into universities abroad are forced to defer or cancel their registration since they require a passport to apply for a travel visa. Every Nigerian has a right to own a Passport and it is not fair that corrupt NIS officials are making it difficult for honest Nigerians to acquire one. The Comptroller-General of NIS and Comptrollers of passport offices need to sit up and deal with the corruption among their officers.

Touts have taken over the passport application and acquisition process, working together with corrupt officials for selfish gain. This needs to be addressed. The practice

of charging 45,000 for 32-page, and 90,000 for 64-page passports respectively must be stopped. These corrupt officials are well known because they carry out their "business" openly. They abandon their posts in the interests of going about "fast-tracking" their "client's" applications. They work together with so-called business centres located near the passport offices where applicants are directed to pay to have their application done online. The online application process itself has been compromised in such a way that the applicant is forced to seek the help of these touts or officials, who in turn charge hapless applicants for their services. These services sometimes include arranging for fake birth certificates, state of origin certificates



and other required documents for applicants who do not have them. In such a case, even wanted criminals could be assisted to acquire a passport that would help them get a visa to flee the country.

The NIS therefore needs to put its house in order. The narrative out there is that top officials in the NIS are seriously compromised by giving a tacit approval to corrupt practices. The sites and channels that applicants can use to get assistance should be upgraded and run smoothly to make the passport application process easier. Corrupt officials should be arrested and punished to serve as a deterrent to others. More outlets should be opened to clear the bottlenecks that currently characterise the whole process. Officers of the NIS need to be sensitized that corruption among them is a dent in the image of Nigeria.

Immigration officers are the point of first contact with foreigners at the port of entry; so, integrity and credibility become extremely important to ensure that the dealings of NIS officials with foreigners is honest and professional. These same NIS officials are in the habit of soliciting for funds from travelers. It is unethical, unpatriotic, and disgraceful to the image of the country.

The passport offices must rid themselves of touts and expel any person from their premises who is not there to apply for a passport. As it stands right now, the NIS has a very poor image among Nigerians because people believe that without paying a bribe to NIS officials one will not get a passport on time. The NIS must therefore curb corruption among its ranks and treat all passport applicants equally. Professionalism is being eroded from the NIS; Nigerians have lost confidence in the integrity of NIS officials. The Trumpet therefore calls on the Minister of Interior to take a decisive action to correct the ills in the system.

FG boosts livestock subsector with veterinary equipment

Lagos approves eight e-hailing operators, cautions residents against using Rida, In-Drivers, others

The Lagos State Government has warned residents to be careful of unlicensed e-hailing operators as they pose security threats to safety of life and property.

This followed as the state government said only eight registered operators of the several e-hailing services were recognised in the state namely: Lagos Ride, Uber, Bolt, Let Me Run, Global Taxi, Zoom Run, Treepz (Plenty Waka) and Shuttlers.

The state government, however, disowned Rida, In-Drivers and others operating in the state.

Commissioner for Transportation, Dr. Frederic Oladeinde, disclosed this in a statement, saying the state government has observed high level of non-compliance by some unlicensed operators, who violate the guidelines put in place to regulate their

Expressing the state government's displeasure over the refusal of the App owners and partners (drivers) to comply with the law guiding their operation in the wake of criminal activities in the state, the transport commissioner further revealed the use of unauthorised operators by driver partners and commuting

Maintaining that the state government has held several meetings geared towards compliance with the regulations guiding e-hailing operations within the metropolis, Oladeinde urged residents to ensure that they patronise only the licensed operators, as most of the unauthorised operators do not have traceable operational base within the state in case of emergency or safety concerns.

Highlighting the importance of safety of life and property in the state, he stressed that only eight of the several e-hailing operators were registered and recognised by the state

According to him, Lagos Ride, Uber, Bolt, Let Me Run, Global Taxi, Zoom Run, Treepz (Plenty Waka) and Shuttlers remain the legitimate e-hailing operators recognised and licensed to operate by the state government, while Indrivers, Rida and others were not licensed.

He appealed to anyone transacting business with them to be cautious, while assuring that the state government would soon begin to clamp down on the violators.

Oladeinde, who also enjoined residents of the state to collaborate by reporting any e-hailing operators different from the ones listed above to the Ministry of Transportation, maintained that the state government will not relent in its efforts to make Lagos safer for residents.

Terrorists threaten to kill train passengers

Terrorists who abducted the passengers of the Abuja-Kaduna train have threatened to start killing their captives if the Federal Government refused to release their children allegedly kept in a Yola detention facility.

Recall that on March 23, some terrorists attacked the Kaduna-bound train, killing eight passengers and abducting several others.

Speaking with Tukur Mamu, the spokesman of Sheikh Ahmad Gumi, via atelephone conversation, the leader of the terrorists, Abu Barra claimed that the abduction was a retaliation for the arrest and detention of their children by the security agencies.

Barra said, "Our children numbering about 8 between the ages of one to seven years are currently being held at an orphanage in Jimeta, Adamawa State under the supervision of the Nigerian Army.

'The names of our children are Abdulrahman, Bilkisu, Usman, Ibrahim and Juwairiyyah. They were forcefully taken from our wives in Nasarawa and taken to the orphanage in Yola.

"For any continued discussion on the release of these passengers and a safe resumption of the train service, our children must be released

"Only then we will release some of the abducted victims, especially the women while other passengers will be released on a prisoner exchange with some of our arrested comrades by the government."

He threatened that if within seven days the government does not respond to their demands, they will stop feeding the victims and will start slaughtering them one after the other.

The terrorists leader further added that if the government does not respond after that, then Nigerians should forget to use the Abuja-Kaduna rail line as well as the Kaduna-Abuja

According to him, "If the government decided not to respond, so be it.

We are warning Nigerians, especially those that are patronizing the train, that if this matter is not resolved peacefully, the day they decided to attack us or do anything funny, passengers or commuters should forget to use the train or follow the Abuja-Kaduna road because we will be consistent and they can't stop us. We believe that you will deliver this message

"Therefore, we rely on you and urged you to convey this important message to everyone."

Barra further claimed that the Federal Government suspended the resumption of the train service because of their threats.

He said, "The government suspended the resumption of the train service indefinitely because of our threats and we repeat, if our conditions are not met, the resumption of the train service is to the detriment of the government and the passengers.

"We don't need money. We have a good reason for doing what we did, until our demands are met none of the victims will come out alive even if it means we all die with them. They are well taken care of as you can see from the pictures, we sent to you via WhatsApp but we assure you that this will not continue.

"We choose you (Tukur Mamu) to convey this important message to the government, the families of the victims and Nigerians in general because we believe you won't alter our message and we have seen you severally with Sheikh Gumi in the forest, therefore, we recognized the fearlessness in you."

Maritime stakeholders reject 29% women representation in workforce

The maritime community has rejected the high level of gender bias in the sector following the newly published 2021 International Maritime Organisation's (IMO) Women International Shipping and Trading Association (WISTA) in its maritime survey report.

The report, which was

The report, which was launched during a virtual symposium to mark the first IMO International Day for Women in Maritime, reviews the proportion and distribution of women employees in the maritime sector among IMO member states and the global industry.

According to the report, which highlighted variation among individual sub-sectors, women account for only 29 per cent of the overall workforce in the global industry and 20 per cent of the workforce of national maritime authorities in IMO community.

According to data gathered from member states, search and rescue teams in national maritime authorities account for significantly fewer women employees with only 10 per cent, compared to female diplomats with 33 per cent and training staff members at 30 per cent.

Industry data showed that women seafarers constitute only two per cent of the crewing workforce and are predominantly found in the cruise sector, while in companies that own ships, they are 34 per cent of the workforce and women in maritime associations make up 16 per cent.

Also, in the towage, salvage, dredging industry, women accounted for 10 per cent, the bunkering industry recorded 10 per cent, while women employed in the surveyed offshore sector accounted for a paltry four per cent.

In marine insurance, women

made up 51 per cent of the workforce, while crewing agencies and crew training segments had 55 per cent. Of the companies that had boards, the overall share of female members was 28 per cent.

Secretary-General of IMO, Kitack Lim, in his welcome address at the symposium, said while women were working in all facets of the maritime sector globally to support the transition to a decarbonised, digitised and sustainable future for the industry, gender imbalance in the sector remained high.

He frowned on the result of the global survey, which he said, exposed the gender gap in the sector, maintaining that diversity benefits the entire sector, hence, the need to commit to recognising, facilitating and supporting the contributions of women as key stakeholders to help address the challenges of decarbonisation for a green future.

Speaking on the survey, President of WISTA International, Mrs. Despina Theodosiou, said the report pointed out the low representation of women in the maritime industry as it exposes some sectors where there are almost no women presence and others with modest level of parity.

She said the survey underscored the low number of women at sea despite the ongoing seafarers shortage and how shipping companies have a reasonably high level of women in senior management and board positions, while workboat, bunkering, offshore and dredging companies barely reach double percentage figures across their workforce.

"We want to push for this collection of industry data to fuel those who are in positions to create the change to do so. This data will hopefully give people across different industries, but interlocked sectors, sub-sectors, and geographical locations, the

inspiration to focus their efforts on creating greater gender diversity," she said.

Speaking at the panel session, the Former Secretary-General, Abuja Memorandum of Understanding (MoU) for West and Central Africa, Mfon Usoro, said women have not been accorded due recognition in the work place.

She said the world needed to embrace a culture of gender diversity and inclusiveness, especially as governments have committed to it by signing the Sustainable Development Goals (SDGs) five and IMO gender resolution.

Usoro, who is also the President of Chartered Institute of Logistics and Transport (CILT) Nigeria, said the IMO should ensure governments of member states and their agencies show commitment to their national policies.

She urged IMO to take a cue from the Central Bank of Nigeria (CBN) policy on 40 per cent women representation on boards of all banks, which has opened opportunities for more women in the country's banking sector.

The CILT president also urged the IMO to require governments of member states to submit reports on the status of implementation of the resolution of gender policies and practices as part of their scorecards.

Executive Vice President, Operations and Assets, CMA-CGM, Mrs. Christine Cabau-

Woehrel, pointed out the need to provide the right training to attract more women into the maritime industry.

While lamenting the low number of female seafarers, Cabau-Woehrel advocated more enhanced conditions at sea, such as crew changes and compatibility to attract more women for efficiency and best practices.

FG to rehabilitate narrow gauge rail lines to connect West Africa

Manager of Papua New Guinea Maritime Administration, Ms. Dinah Inape-Omenefa, highlighted the importance of mentorship and coaching programmes to encourage women into maritime and support them in the sector.

She said while working in the sector was more extensive and technical, there was the need to improve safety and better working conditions for women, as well as build technical competence in them.

Also, Permanent Representative of Saudi Arabia in IMO, Essam Al Ammari, said more needed to be done on visibility as an important part of the process, as women were underrepresented in the sector.

He warned that while women face challenges in the sector, governments needed to invest in implementing policies for women education to remove gender barriers and ensure their visibility in the shipping industry.

On his part, Executive Vice-President, Maritime Policy and Government Affairs, MSC Group, Bud Darr, said the maritime sector needed more talents and skill sets recognition to facilitate its development.

He said bringing women onboard the sector offers an array of skills, especially in the achievement of de-carbonisation, which required a diverse work force for better decision making.

ANLCA seeks FG's intervention to reduce levy on imported vehicles

The Association of Nigerian Licensed Customs Agents (ANLCA) has urged the Federal Government to reduce the levy on used cars payable in the relaunched Vehicle Identification Number (VIN) from 15 to five per cent to make them more affordable.

Public Relations Officer of the Tin Can Island Port Chapter of ANLCA, Onome Monije, who explained that with the new policy, imported vehicles might remain unaffordable to many Nigerians, called on the government to review the levy downwards.

Monije, who is also Chief Executive Officer of Onas 100 Resources Nigeria Limited, said freight agents were ready to abide by the new regime as long as it intends to facilitate trade and increase the efficiency of revenue generation.

According to her, the VIN

valuation was a welcome development for importation of vehicles into the country, noting that freight agents had engaged their importers and car dealers on the importance of the new valuation.

"The VIN valuation, for us, is not as if there is an increase in charges or tariff, some prices are intact, but the only concern we are looking at is the aspect of import levies. For VIN, we have no issue but the levy, because it is not about us the agents or the Nigeria Customs Service, but for the government to look into the levy by reducing it to five per cent instead of 15 per cent.

"Some cars are stuck in the port because of the levies. It is not that we are crying more than the bereaved, but this is our country and we need to look at the holistic approach on the levies and see how best to reduce it," she added.

Permanent Secretary of the Ministry of Transportation, Dr. Magdalene Ajani, has said the Federal Government is striving to rehabilitate the existing narrow gauge rail lines to standard gauge lines with a view to connect Nigerian cities with West Africa.

Ajani stated this at the ninth Nigeria Annual Transport Lecture titled: Nigeria Transportation For Development, Sectional Achievement, Prospects And Challenges, held in Abuja.

She said the Federal Government remained resolute and undeterred in its vision to revolutionise the transport sector into a world class system, noting that the development of Deep Sea Ports and automation of the country's ports operations would facilitate the ease of doing business at the ports.

She also disclosed that to strengthen this position, the ministry has ongoing public-private engagement in the development. Nations results showed that in road accidents according to advocate to ad

of a world class transport system within the properties of the National Inland Waterways Authority (NIWA) in Lagos State and encourage other states to key into the initiative.

Ajani further stated that the current administration recognises the importance of the transportation sector to the industrialisation and diversification of the Nigerian economy.

She said the government was doing everything possible to ensure infrastructural development to drive the sector even as the ministry was challenged by insufficient funding, minimal private sector participation and duplication of functions that tend to cause inter-agency conflicts.

In her presentation, a former Director of Road Transport and Mass Transit Administration, Federal Ministry of Transportation, Anthonia Ekpa, decried neglect for the road sector by the Federal Government as against huge sums of money earmarked for other modes of transport.

She said prioritising the road sector was cheaper and would have more coverage on roads constructed and buses bought contrary to money spent to build just an airport runway or rail track.

She revealed that the United

Nations records in 2018-2019 showed that people died mostly in road accidents and enjoined all to advocate better development of the road sector.

How my growing up influenced my charity foundation- Dennis Aikoriogie

Imo and Ábia. We believe we could do more with the right sponsors and partners; we are currently restructuring the board of the foundation.

GoRead is an emerging company I co-founded with a friend to introduce an innovation to private and public schools, that makes learning easy, educational materials accessible and affordable. Global Hobnob Nigeria

Limited is the production and exporting arm of Global Hobnob LLC New York, where we ship food and cash crops overseas.

You've worked in different capacities, across sectors. How did these work experiences impact your life?

I have worked in the banking, insurance, public and private sectors.


Every sector comes with its own unique experience and these experiences have shaped and impacted me greatly.

As a businessman with vast experience, how would you rate the economic growth of Nigeria?

Post-independence, Nigeria has not experienced much economic growth, I believe we have the potential to compete in the business world, we have not had the right policies to put us in the right footing, issues like access to capital, ease of doing business, lack of industrialization for which epileptic electricity could be the contributing factor, we keep on exporting products with no value addition and makes Nigeria products less competitive on the global stage.

Tell us some of the activities in your foundation?

Scholarship and tuition assistance programme, we have helped indigent students pay their tuition and have given scholarships to see them through school, recently, we also distributed free notebooks, pens and other materials to Ancilla orphanage school in Imo State.

Widow programme, from time to time we have reach out to widows in the community, we have provided food items and cash donations to support their families.

Youths and women empowermentwe intend to equip youths and women with the right kind of entrepreneurial skills and financial literacy to survive in modern business world and upon completion of such training we set up them up in the skilled area they have just acquired knowledge, we also intend to leverage on fintech.

Water access, sanitation, and hygiene, we are working on providing clean and portable water to rural communities and educate them on sanitation and hygiene.

These are short and medium term or operational goals, the long term or strategic goal is having an orphanage, in the orphanage we are going to build school and hospital to provide services freely to the community.

If you could have an audience with the President of Nigeria, what would you tell him to do differently?

I would advise him to ensure that there is stable electricity in the country because it plays a catalytic role in small and medium enterprises, which are the drivers of any economy. To ensure a credible electoral system is in place, strengthen and liberalize democratic participation and try as much as possible to demonetize the political process, simply put. To build strong institutions.

Lastly, my word to him will be to ensure the security of lives and property appointing capable people in position of authority.

You are a man of many parts; how do you unwind and still have time for family duties?

I try as much as possible to spend time with my family despite the busy schedule. Occasionally, we go out to events church, parties and see movies together. I plan to spend more quality time with my family, going on vacation, sights seeing etc. We are currently working building the foundation to financial freedom to enable us ample time for family and leisure.



onso Madueke defeated Henry Atseve 0-2 to 7-6(10) win the men's singles in the 44th edition of the CBN National Tennis Competition to claim the coveted prize.

Madueke, four seeded in the tournament, having fallen in the first set to top seed Atseye, recovered to displace his opponent in the second set who later conceded defeat in the third set after sustaining an injury.

Atseye had qualified for the grand finale of the men's singles after beating the defending champion of DavNotch Open, Wilson Igbinovia, 4-6, 7-6(6), 6-4 in the semi-finals.

The 18-year-old Igbinovia was on course to lift his second championship title in two weeks before being hampered in the last two sets despite winning the first in the semifinal against Atseye.

On the other semi-final tussle, Madueke strolled past unseeded Friday Gabriel with ease in the championship to record 6-0 6-0 flawless victory.

"It was not an easy match, but I knew that as long as I kept on fighting, I was going to scale through," Madueke told the media after Atseye conceded

"We both had to play two consecutive matches today and even though my opponent's semi-final game was quite tougher than mine, I knew that \boldsymbol{I} couldn't rest on my oars.

"I had to keep pushing and stay focused. Thank God I had the victory at last," he added.

Meanwhile, in the male singles wheelchair event. Alexander Adewale defeated Yusuf Wasiu in the 44th edition of the CBN Senior National Tennis Open Championship held at the Moshood Abiola National Stadium, Abuja.

The event scheduled from May 13 to May 21, saw the defending champion, Adewale beat second-seed Wasiu 6-2 7-6 7-5 to clinch the title.

Speaking to the media, the excited Adewale, who won the male wheelchair singles event, thank the organisers, CBN and Nigeria Tennis Federation (NTF), for putting up such a wonderful event that keeps athletes in shape.

He further appealed to the federation to organise more tournaments which will galvanise Nigerian tennis players' performances on the international stage.



"I won the last year edition and I have won more than four championships consecutively," Adewale told News Agency of

Nigeria. "My opponent today has always been my rival in any competition.

"Î thank the Nigeria Tennis Federation (NTF) and Central Bank of Nigeria (CBN) for organising this championship," he added.

Adewale continued: "We want the Federation to organise more national championships. We really need their support so that we can participate in major international competitions.

"This is the road to take for us to feature at the Paralympics. We all have the same challenge as wheelchair tennis players, and that is that we want to participate in international championships," he appealed.

Meanwhile, in the women's category, top-seed Kafayat Omisore defeated number fourseed Oluwakemi Oluwasegun into two straight sets 6-1 6-2 to win the championship.

Omisore, despite emerging victorious, admitted that her opponent had put up a worthy challenge but was able to see her off with her fountain of experience garnered in the sport over time.

"It was a tough work, but I thank God I ended well. My opponent also played well, but I defeated her based on experience," Omisore said postmatch.

"I did not relent and I continued to work hard to achieve my target. I will go back home and continue to train for any competition ahead," she added.

The 44th edition of the CBN Senior National Tennis Open Championship was contested by 32 players comprising 16 males and 16 females.

"We've obviously got far more children coming to the games, far more women coming to the games, and all of a sudden in these last few weeks and months, we've got these idiots not just running on the pitch but attacking players. What the hell are you doing?

"Running on the pitch is obviously delirious because City have won the league,

so I get that, but attacking opposition players on the pitch - where has this come from? Why is it happening? I've got no idea. It's absolutely ridiculous," He added.

Neville's former teammate, Roy Keane, has called the fans 'scumbags' for encroaching into the pitch to celebrate City's victory.

He stressed that a fan who could have resulted in punching a player would have the effrontery to stab a player.

"It's disgraceful. It really is and I tell you what - a player or a manager is going to be seriously injured," Keane said. "If you're mad enough to

come on and punch a player, then you're mad enough to come on and do something silly like stab a player. Something crazy will happen. People have come back from Covid and forgotten how to behave themselves.

Obi spoke in London shortly after a meeting of selected persons from Commonwealth countries with the Prime Minister of Britain, Boris Johnson, at the latter's 10 Downing Street office.

He disclosed that

the meeting basically deliberated on trade and investment among C o m m o n w e a l t h countries.

Obi also said it touched passionately on how the United Kingdom and other C o m m o n w e a l t h countries would encourage investment on the continent and the African Free Trade Agreement should be made to function actively so that the countries would reap positive benefits from it.

Obi lamented that trade among African countries was very low and called on African leaders to look inwards and concentrate more on the economic problems facing the continent that often result to political problems.

frontline The presidential aspirant asserted that when a continent gets her right, economy would pull a lot of people out of poverty, therefore reducing tension and insecurity usually associated with poverty.

Obi, who also took the opportunity to meet the UK Minister for Africa, Vicky Ford, disclosed that he discussed issues affecting Africa, especially Nigeria. with her

"We discussed about democracy and political stability, trade and investment, education, especially the out-of-school issue, as well as security matters with her," he said.

Obi while lamenting on the state of the country, he said what was happening now was a challenge to statesmanship and called on everybody that has the capacity to help to come forward and do so.

Youths protest over killing of youth leader

Angry youths of Ikot Andem Village in Ukanafun Local Government Area of Akwa Ibom State have protested against the killing of one Ufot Joe. The youth president of the community was killed by suspected cultists along the village road on Monday The Trumpet gathered.

A witness, Akaniyene Inyang, said the incident occurred on the lonely village road linking Ekparakwa axis of the community about 7.00 pm after the Peoples Democratic Party (PDP) Senatorial District primaries. It was gathered that the victim was waylaid and shot dead by the hoodlums while riding his new motorcycle back home.

"The late Joe was riding on his motorcycle from his village, Ikot Andem, and was ambushed by suspected cultists. who opened fire on him and fled with his motorcycle, leaving him dead in the pool of his blood."

Continuing, he said it was too late for him to be rescued as neighbours arrived

following alarm raised by passersby, who discovered that the victim has lost much blood from the gunshot wounds. He disclosed that the motorcycle snatched from the deceased was an empowerment gift to him by a politician representing the area in the House of Representatives, Mr. Unyime Idem.

One of the youths' leaders, who spoke on condition of anonymity, explained that "the matter had been reported to the Police for immediate investigation with a view to apprehending the suspects."

Meanwhile, the Police Public Relations Officer (PPRO) in AKwa Ibom SP Odiko Mcdon when contacted on phone said the command has not received the report but promised to investigate when there is official report on the incident.

"I am in a meeting," he said, promising to revert, when fully briefed on the incident from the Divisional Police Officer (DPO) incharge of the area.

Groups protest against Shell

A coalition of civil society organisations has protested against the activities of multinational oil company, Shell Petroleum Development Company (SPDC) in the Niger Delta area.

The coalition, led by the Africa Network Environmental Economic Justice (ANEEJ), headed Reverend David Ugolor, staged the protest at Lagos Corporate Headquarters of Shell carrying placards with different inscriptions such as We Demand A Just Energy Transaction and We Say No To Carbon Emissions, among others.

The group lamented the level of pollution, poverty and agony the activities of Shell's and other oil giants had subjected Nigerians to, especially in the host communities and demanded an immediate end to what they described as the perennial inhuman activities of the International Oil Companies (IOCs) in the Niger Delta.

"We call on the

Church ch of other England and financiers of Shell to withdraw financial their and moral support, having known that Shell had not respected the global agreement, neither had the company aligned its strategy with the Paris Climate Agreement and Glasgow 2021 commitment for net-zero.

"We are calling on the Church of England and other financiers of Shell to completely withdraw their moral and financial support to Shell, a major fossil fuel extracting company, whose operations in Nigeria's Niger Delta have contributed to carbon emissions, e n v i r o n m e n t a l degradation, destruction of livelihoods and other human rights violations.

"Last year, ANEEJ brought together West African Non-Governmental Organisations (NGOs) in a letter to the Archbishop Canterbury, Reverend Justin Welby, asking the Church of England Pension Board, and by extension, other investors to desist from lending its moral and financial authority to Shell and voting for Shell's climate and climate energy plan, but the letter was ignored.

"Few days after
Shell's last Annual
General Meeting (AGM),

the company faced two challenges major major — its energy transitions at rategy from official First, institutions. First, International Agency (IEA) concluded new oil and gas fields should be approved for development after 2021, if the world is to reach its agreed net-zero emissions target of 2050," the coalition stated.

Shortly afterwards, a Dutch Court ruled that Shell must cut its carbon emissions by 45 per cent by 2030 with immediate effect. The judgment found that the Church of England applauded Shell for the same policies.

"Shell is causing a danger to peoples' right to life. Shell bosses are not accountable," the group said.
