# Battle of titans as presidential primaries enter business end, PDP kick-starts exercise

t is a weekend of anxiety, tension and pressure as the race for the 2023 presidential election will properly kick off today with the 811 national delegates of the Peoples Democratic Party (PDP) gathering at MKO Abiola National Stadium, Abuja to elect one of its 15 aspirants as the standard bearer.

The ruling All Progressives Congress (APC) has shifted its presidential primary election to June 6-7 until PDP picks its torchbearer.

made Attempt was at narrowing down the PDP contest by northern aspirants to produce consensus candidate а among Saraki, Tambuwal, Bala Mohammed and Mohammed Hayatu -Deen but the parley broke down and the gladiators decided to run solo.

The party also disappointed members from the south east at the peak of agitation for southern presidency when it's zoning committee led by Benue State governor, Samuel Ortom decided decided not to zone the presidential ticket.

Throwing it open made the aspirants to jettison parley talks and go all out on individual strength to test their popularity.

But along the line, it became obvious that some of the aspirants are not just in the race. Findings revealed that former Ekiti State governor, Ayodele Fayose, media mogul, Dele Momodu are being sponsored by one of the leading aspirant while South East contenders like, Nwachukwu Anakwenze, Sam Ohuambuwa were passive in their campaign while the former governor of Anambra State, Peter Obi surprisingly quit the race and dumped the party.

Aspirants like Hayatu -Deen is much more feasible on the social and electronics media while nothing was heard about almost seven of the aspirants after purchasing the nomination forms.

Among the array of aspirants, the pendulum of success tilted towards three major contenders. According to opinion polls and power inter- play in the party, the leading aspirants are; former Vice President, Atiku Abubakar, Rivers State governor, Nyesom Wike, former Senate President, Bukola Saraki and Sokoto State governor, Aminu Tambuwal. Atiku Abubakar, the

Atiku Abubakar, the party's candidate in 2019 is no doubt still a contender to beat by every standard because of his influence, alliance with stakeholders across geopolitical zone and financial muscle.

Atiku has some top notchers in the party working for his aspiration and pushing for his emergence. In the northern parts of the country, he stands a better chance of winning delegates from the North East and North Central. Taraba State governor Darius Ishaku and his godfather, Theophilus Danjuma are behind him while the Bauchi governor, Mohammed may Bala step down for Atiku at the convention ground. Rumour even had it that Bala will go back to pursue his second governorship term.

His chances of dominance in the north central may be punctured by the influence of Saraki who is likely to have the votes of Kwara delegates. But, the former governor of Kogi State is rallying Kogi delegate vote for Atiku.

The North West will be a battle field for Atiku, Tambuwal and to an extent, Saraki. The zone no doubt has the highest number of delegates.

Tambuwal is likely to have a larger bite of the bites from Sokoto, Zamfara, Jigawa and Katsina while Atiku will clinch Kaduna where he has the backing of former governor, Ahmed Markafi and Kano.

Wike who took the race by surprise is running at an unprecedented speed. He approached the campaign with all vigour and seriousness and he is among the front runners in today's contest.

With the help of the Oyo State governor, Seyi Makinde and former Ekiti governor, Fayose, Wike has made an inroad into the South West and may split the votes of the zone with Atiku. Both Wike and Atiku have polarized the Ogun State chapter of PDP, which resulted in the state producing two governorship candidates from parallel congresses.

In the South South, Wike is going to split votes with Akwa Ibom governor, Emmanuel Udom. Wike has foothold in Rivers and Edo while Emmanuel has

his grip on Akwa Ibom and Cross River while Governor Ifeanyi Okowa may deliver Delta delegates to Atiku.

The South West also will be a straight battle between Wike and Atiku. Governors Okezie Ikpeazu and Ifeanyi Ugwuanyi are allies of Atiku while Wike made an inroad in Ebonyi, Anambra and Enugu by raising faction simply to gainer parts of the delegates votes. While Wike may have

While Wike may have weaker links in the north, Tambuwal may pick strain of votes in the southern parts of the country counting on his parliamentary alliance with former lawmakers in the House of Representatives.

Analysts are of the opinion that Wike might be banking on his financial war chest to rake delegates in zones where he is not too strong. He is believed to have more financial muscle than Atiku who is being circumspect in spending, probably conserving monetary energy till voting day.

Meanwhile, the political atmosphere is still hazy with the ruling APC as there is more confusion on the direction the party is going to take.

Amid this uncertainty, more confusion was thrown into APC political calculus as yesterday, a court cleared former President Goodluck Jonathan as eligible to contest the 2023 presidency.

This reawakened anticipated push for a Jonathan's consensus candidacy. The party has not made any pronouncement in this regard while the former president had in the past denied running.

Findings revealed that top echelon of APC leadership deliberately delayed screening of aspirants to await the ruling of the Federal High Court, Yenagoa on Friday.

It is expected that decisive position either towards consensus or otherwise may be taken as soon as President Muhammadu Buhari return to the country today.

Precedent from the last national convention of the party indicates that Buhari calls the shot in APC and may have a say in breaking the ice.

The fallout from a scenario of Buhari endorsing Jonathan, is better imagined as aggrieved stakeholders may face the president in the eyes.

The Trumpet gathered that the 3,222 national delegates are not likely to take things lowly should the party go ahead with a consensus option as they will missed out of the expected monetary windfall.

Whatever happened in the next 24 hours will determine the chances of APC retaining power in 2023.

Peter Obi joins Labour Party to contest presidential election

Former governor of Anambra State and erstwhile presidential aspirant on the platform of the Peoples Democratic Party (PDP), Peter Obi, has formally joined the Labour Party (LP) to contest the 2023 presidential election.

A close source confirmed that Obi registered as a member of the party on Friday in his ward in Anambra State. He is expected to contest the party's presidential primary election next Tuesday. The Trumpet had on Wednesday reported that Obi was planning to dump the PDP for Labour Party.

"The results of various primaries of the party conducted so far have shown who most of these delegates are loyal to," the source had said.

"So, he (Obi) is under pressure to leave the PDP for the moneybags, we are currently looking to find another party to accept him."

Obi had resigned his membership of the PDP two days before its presidential primary. He said his resignation was because of the recent developments in the opposition party. In a letter dated May 24, 2022, and addressed to the national chairman of the PDP, Iyorchia Ayu, Obi said he had already informed the chairman of the PDP chapter in his Agulu Ward 2, in Anambra State.

"I am writing to intimate you of my resignation from the PDP, which was conveyed to the chairman of Agulu Ward 2, Anaocha LGA, effective Friday, May 20, 2022. Consequently, I am by this letter informing you of my withdrawal from the PDP Presidential Primary.

Also, a Federal High Court sitting in Yenagoa, Bayelsa State, has declared that former President Goodluck Jonathan is eligible to contest the 2023 election.

The presiding judge, Justice Isa Dashen, made the declaration in the judgement which lasted for over two hours on Friday. Justice Dashen held that Jonathan was elected into the office of the President of the Federal Republic of Nigeria once in 2011 as he only completed the term of Late President Umaru Musa Yar'adua in 2010 "not on the basis of any election but by constitutional appointment."

further declared He "spurious, as baseless and unsubstantiated," the plaintiffs claims that Jonathan has been elected as president on two previous elections. He also ruled that Jonathan's right to contest for the office of president again cannot be denied by any retroactive law.

origination Ĭn an summons filed by some members of tĥe All Progressives Congress, APC, led by Andy Solomon and Idibiye Abraham, the plaintiffs had sought an order of the court stating that Jonathan is not affected by the fourth alteration to the constitution barring Vice-Presidents, who succeed their principals, from serving more than one full term.

CONTINUED FROM PAGE 2 Commission, INEC, were listed defendants. as his reaction to In the judgement, counsel Jonathan, Eric Omare, said: 'Some members of the All Progressives Congress, APC, led by Andy Solomon approached the federal high court to seek for two declarations. Essentially, his case was that by virtue of Section 137 subsections1(b), Jonathan having taken the oath of office as president on two occasions is disqualified from contesting the

presidential election. "Secondly, he also contended that by virtue of Section 137 subsection which was brought 3 the Constitution by into the fourth alterations to the Constitution in 2018. Jonathan having completed the term of late President Umaru Musa Yar'adua and having served one term is no longer qualified to contest. "We joined the issues with

them and today in a well considered judgment that lasted for over two hours, the court agreed with us that one, Jonathan had not contested for the President of the Federal Republic of Nigeria on two occasions that he only completed the term of late President Yar'adua on the basis of constitutional requirements. 'Secondly, the court

also held that the fourth alteration which also introduced Sections 137, subsection 3, does not apply disqualify Jonathan. So, in summary the court agreed with us and held that Jonathan is qualified to contest the 2023 presidential election.

Reacting to the judgement, counsel to the plaintiffs, Sigha Egbuwabi, said: "We are the plaintiffs' counsel in this challenging the eligibility of the first defendant, Dr. Goodluck Ebele Ionathan. we canvassed our position before the court that he is no longer eligible by the Section introduction of subsection (1b) and 137 subsection 3 because he has taken the oath for the office of the president twice.

"Because he has taken the oath to the office of the President twice and by introduction of subsections 3 which is the law as it is now, it is our position that under that law he is going to be screened for the election coming 2023 which primaries will commence

very soon. "What we have canvassed is that he is no longer eligible. Ordinarily, we know that former President Jonathan is a good person, a person who has ruled this country with integrity and dignity. We do not have any

challenge having him back again, however, we also do not want a situation where he will come to transgress the law.

"For so much integrity he has acquired, he worked hard to acquire all these and he will not be allowed to slip into an error that will make him transgress. The law will not equally speak well of him. That was the reason why our clients who were the plaintiffs instituted this matter.

"The court has though ruled otherwise but we are eager to have a copy of the judgement. We will come together and look at it critically but I always assuage everybody that we will go to the court of appeal to test it.

It is not as if we are eager to deny him contesting the presidential election but what we are maintaining is that he cannot be allowed to transgress the law that is what we are maintaining and by provisions of that Subsection 3 though it commence in 2018, what we are maintaining is that he is no longer eligible. The law now as it is, we are talking of the law as it is, not the law as its ought to be, not the law, not the law as it was but the law as it is."

Security strengthened in Abuja

PDP is finished for plotting anti igbo agenda, says HURIWA

# Omo-Agege, Sheriff await Ogboru in all- Urhobo Delta guber battle Joel-Onowakpo Thomas, Emergor hail DSP's emergence

With the emergence of Deputy Senate President Ovie Omo-Agege and House of Assembly Speaker, Rt. Hon. Sheriff Oborewori, as standard bearers of All Progressives Congress (APC) and Peoples' Democratic Party (PDP) respectively, the stage is set for another titanic governorship battle with veteran old warhorse, Chief Great Ovedje Ogboru, in Delta State

Ogboru is being speculated to join the contest on the platform of All Progressives Grand Alliance (APGA) in what promises to be an

all-Urhobo affair. Until the emergence of APC as the main opposition politi-cal party in Delta, Ogboru had always been the major arrowhead of the fight against PDP in the state. He has contested all the governorship elections in the state since 2003, flying different parties' flags including the APC's in

2019. Oborevwori picked the PDP governorship ticket with ease, beating others including Deputy Governor Kingsley Burutu Otuaro.

At the election held, on Thursday, 25th May 2022, at the Steven Keshi Stadium, Asaba, Sheriff polled 590 votes of the 821 valid delegates ballots cast, leaving his closest rival David Edevbie in a distant second with 113 votes. Serving Senator representing Delta South

Senatorial District, Senator James Manager came third

with 83 votes. Omo-Agege, Senator emerged as the APC torchbearer after he was returned unopposed at the party's governorship governorship primaries held at Federal College of Education, Technical, Asaba, after polling 1190 votes. A total of 1350 delegates were expected to take part in the election. However, only 1235 were accredited, with 1191 casting their votes. One of the

votes was voided leaving the total number of valid votes at 1190.

Omo-Agege in an interview shortly after his declaration, welcomed the candidate of the PDP into the contest, saying: "I don't care about who has emerged in the opposition. He is much welcomed into the arena. There is no structure outside Deltans and what Deltans want.'

He said the 2023 election is about the liberation of Deltans, stressing that the APC was in a hurry to get to work and deliver the people from long years of suffering under the PDP.

He added: "We are very confident because we have taken our time to go on the best recruitment drive to pick the very best that will deliver the best in addition to our grassroots commanders who will lead this charge to uproot the failed PDP administration in Delta State."

For the first time since 2007, all the major political parties in the state will be fielding candidates from not just the central senatorial district but also the same ethnic nationality (Urhobo) for the governorship contest: Ovie Omo-Agege, Orogun, Ughelli North Local Government Area, (APC); Oborewori, Osubi, Okpe Local Government Area (PDP) and Ogboru,

Abraka, Ethiope East Local Government Area (APGA). With the likely third force

still officially being awaited, the stage is now set for who eventually becomes the next governor of the state.

Reacting to the emergence of Omo-Agege, APC's frontline consensus aspirant for Delta South Senatorial District, Hon. Joel Onowakpo Thomas, expressed optimism that the party was now poised for victory at all levels in the 2023 general elections.

Thomas is set to clinch the Delta South senatorial election ticket in Warr on Saturday.

Also speaking, a leader of the APC in Delta, Olorogun O'tega Emerhor, said for the first time the party was prepared to win elections in the state.

# FG to introduce e-procurement in contract documentation

### By ISAAC JOB, Uyo

The federal government has said that it will begin the process of electronic documentation and packaging of contract procedures to make public procurement more transparent in line with international standards and best practices.

Addressing participants at a Two Day Retreat for Federal Permanent Secretaries held in Uyo, Akwa Ibom State capital, on Friday, the Director-General, Bureau of Public Procurement (BPP), Mallam Mamman Ahmadu, disclosed that the e-procurement system is being developed by the Bureau in partnership with the World Bank and 10 Ministries, Departments and Agencies selected as Pilot Procuring Entities before the full roll-out of the e-system. Ahmadu said the theme of the



retreat is "Strengthening Public Procurement for Optimal Effectiveness" adding that the benefits of e-procurement are tremendous.

He emphasized that one of the objectives of the retreat is to improve procurement implementation in Nigeria and ensure effective execution of the annual budget.

"It is rewarding to note that tremendous improvements have been recorded in public procurement process over the years.

"However, there is need to do more to maximize the gains already recorded and to close gaps on the lapses."

In her remarks, Dr Folasade Yemi-Esan, Head of Service of the Federation, urged the permanent secretaries to demonstrate commitment toward addressing the capacity gaps of all officers involved in procurement cycles.

"This can be done by ensuring frequent training, retraining, tooling/ retooling and performance assessment. In line with international best practices and the peculiarities of procurement processes, we must embrace the emplacement of e-procurement practices and private sector participation.

Akwa Ibom State Governor, Udom Emmanuel, said the state government is prepared for the reforms of procurement services through the enactment of public procurement laws by the State House of Assembly.

Governor Emmanuel, who was represented by the Deputy Governor, Mr Moses Ekpo, stated that the state government has domesticated the regulated procurement culture in the affairs of the state.

'Before the enactment of the Procurement Act, corruption in procurement according to reports accounted for large fractions of government's total budget."

wo aggrieved governorship aspirants of the All Progressives Congress(APC) in Akwa Ibom State, Senator Ita Enang and Mr Augustine Utuk, have protested and rejected the emergence of Obong Akan Udofia, as the winner of the party's governorship primaries held in Uyo on Friday The Trumpet gathered.

Addressing a press conference in Uvo on Friday shortly after the APC gubernatorial primaries, Senator Ita Enang, the immediate past Senior Special Assistant (SSA) to President Muhammadu Buhari, on Niger Delta Affairs, who led other aspirants in the protest, noted that the outcome of the exercise was not in line with the provisions of the Electoral Act, 2022.

Ita Enang disclosed that Akan Udofia is not a member of APC in his ward and claimed that the exercise was heavily stage-managed to have a

predetermined outcome in favour of the purported winner.

According to him, all the aggrieved aspirants have written a petition to the National Executive Council (NEC) of the APC, to avert the crises which, he observed, could lead to the party not having a governorship candidate as was the case in Zamfara and Rivers State in 2019.

He said the purported winner of the APC governorship primaries in Akwa Ibom was on the ballot paper of PDP governorship<sup>1</sup> primaries conducted at Godswill Akpabio International Stadium a few days ago and wondered how he sauntered into the venue of the APC primaries and later emerged the winner. Ita Enang insisted that such irregularities and

# FG slams 23-count charge on Osinachi's husband

The Attorney-General of the Federation has filed 23-count charges against Peter Nwachukwu, the husband of late gospel artist, Osinachi, who died in April after she was allegedly assaulted by her spouse.

He was charged under sections 104 and 379 of the Administration of Criminal Justice Act, 2015 and culpable homicide contrary to section 221 of the Penal Code which is punishable with death.

The case with charge number, CR/199/2022, was

filed at the High Court of the Federal Capital Territory, Abuja, on May 20, 2022, by the Head, Sexual and Gender-Based Violence, Department of Public Prosecutions of the Federation, Ministry of Justice, Mrs Yewande Gbola-Awopetun.

The prosecutor accused the defendant of forcefully ejecting the deceased from the family home, contrary to the VAP Act, adding that he also attempted culpable homicide by pushing Osinachi out of a moving vehicle.

The Federal Government further alleged that the defendant deprived the deceased of her liberty by restraining her movement and locking her up in the house.

Nwachukwu was equally accused of emotional, verbal and psychological abuse contrary to section 14(1) of the VAP Act, 2015.

The defendant was said to have denied Osinachi access to her money for medication and household necessities and forced her into begging and borrowing. The charge further alleges that Osinachi's husband forcefully isolated and separated her from her family by preventing the deceased's mother and siblings from visiting her matrimonial home.

Nwachukwu was similarly accused of cruelly beating the children and recording their cries and playing it on his phone, noting that he threatened the children and prevented them from reporting the acts of domestic violence against their mother to his pastor, Dr Paul Enenche or any other person.

One of the counts reads, "That you Peter Nwachukwu, 56, male, on the 8th of April, 2022 at Aco Estate, opposite police station, Lugbe, Abuja, FCT, within the jurisdiction of this honourable court, did commit an offence to

She said that the defendant, who was a driver for the complainant, Habanera Limited, stole a Prado 2019 model, with registration number SMK 708 FU valued at N36 million belonging to the complainant.

"The defendant dropped off a staff of the company at the office and was supposed to fill up the tank at a fuel station, however, he absconded with the car," the prosecutor told the court. According to her, the offences contravene sections 411 and 287 (7) of the Criminal Laws of Lagos State, 2015

(Revised). Section 287 (7) prescribes a seven-year jail term upon conviction for stealing from one's employer, while 411 stipulates two years imprisonment for conspiracy.

The Chief Magistrate, Mrs Adeola Adedayo, admitted the defendant to bail in the sum of N100,000 with two sureties

in like sum.

She held that the sureties must submit copies of their National Identification Number (NIN) and Lagos State Residents Registration Agency (LASRRA) card.

She ordered that sureties must be residents within the court's jurisdiction and be gainfully employed with evidence of three years of tax payment to the Lagos State Government.

Adedayo adjourned the case until June 29, for mention.

# Police begin orderly room trial of four policemen who extorted man of 350 euros

Four policemen who extorted the sum of 350 Euros from a man, which he was taking to a hospital in Lagos, to pay for his father's medical bills have been given an orderly room trial by the authorities of the Lagos State Police Command.

The sister of the man, whose name on her Twitter handle is @Marisalex\_22, had given details of how her brother, who was going to a hospital, was stopped by the policemen and the money he was taking to the hospital to pay their father's medical bills was taken from him.

After her tweets, which got the attention of the authorities of the State Police Command, the Command, through its Public Relations Officer, Benjamin Hundeyin, invited the man and his sister to the state police command.

The man was able to identify the policemen, who were said to have admitted to collecting the money and were made to return the 350 Euros, which was handed back to the man.

The lady also announced on her Twitter handle that the Lagos Police PRO facilitated the recovery of the money, while nothing was done to the policemen.

This action of the Lagos State Police PRO did not go down well with the Force Public Relations Officer, Muyiwa Adejobi, a Chief Superintendent of Police (CSP), who wrote on his Twitter handle asking the Lagos Police PRO to take more disciplinary action against the policemen.

## Politicians mop up dollars for party primaries, APC presidential candidate, Nwajuiba laments

As presidential primaries of political parties take place, particularly in the ruling APC and major opposition PDP, a presidential aspirant on the platform of the All Progressive Congress, (APC), Chukwuemeka Nwajiuba in this interview decries the negative influence of monetary inducement in picking candidates as against other considerations and concludes that this was responsible for the scarcity of dollars and exorbitant exchange rate to naira. The former Minister of State for Education bares his mind on other national issues and how he intends to govern the country if given the opportunity. Politics Editor, **TUNDE JOSHUA** brings **excerpts**.

Why do you want to be President of Nigeria?

I think part of why I am running is because I was trying to bring some sense of social order to our polity. Let's not run away with the belief that our country has collapsed. That, it is no longer a country of laws or a country of rules and there is no more moral, there's no more order. In other words, everything works because this is at the heart of what it is that you see on display.

#### Agitation for restructuring has reached its peak, if you become President, will you restructure the country?

What is it that I would restructure? The borders of Nigeria are known and are defined, and accepted internationally in the world. Restructuring obviously can't be talking about landmarks, the issue is governance. Is it the question of landmarks or the resources? Since 1999 this Nigerian Constitution has been restructured. I ask, is there something a state does with its citizens other than service and tax? That is how citizens and the state relate. Is there anything you would like to do in Nigeria that the law says you cannot do? It's not. If you want to build a refinery there is a process, you just need to apply. Remember, we were three regions by 1966, and war was fought over this matter. When the military took over, they said we don't want the situation, it is better everybody creates states, they are no longer ethical. Nigeria had to create states to unbundle the structure as a way to stop a civil war again. To a large extent, they have succeeded. So, something must be right with the new structure. What do you want to restructure? Is there any limitation to what a state governor can do? Nigerian governors are the most independent governors in the world. If anybody knows the income that they generate in the states that they transfer to Abuja, they should say so. Nobody has ever compelled any state to generate one income and send. It is for the states to try and generate as much as they can. So, why keep saying let's revert to the thing that killed us; I said it's good to know a book, but read it.

## What is your view on consensus candidate?

I already said it is not possible to win an election without the consent of everybody. So why will I say I can only win if I am the most powerful. You can only win by consensus. So whatever consensus my party agrees with for a better Nigeria will be okay. If they don't give me, whoever they give, they just decide that this is what we have to offer. That is my understanding of what we're doing.

Your party inserted a withdrawal letter in the nomination forms of every aspirant, in your view, is it

legal or ethical to withdraw ahead of an exercise?

Yes, in every situation, you make provisions. The Supreme Court has held repeatedly that political parties are not parastatals of government. They are voluntary associations, the only thing the Supreme Court has held repeatedly is been consistency, that the party is supreme in its decision on internal matters. The only condition is that the parties must obey their guidelines and regulations. So, that is the only limitation I see. You come to an association and they say for you to contest on our platform before we agree that we and you can work together, you need to give us the confidence that looks as if we don't like you to do this, you will not take us to court, will you give us that assurance before we can start. Check other parties, they don't have this. That's exactly how I look at this. It may not be moral or ethical, it is actually what you believe that you want to do. Political parties make their own rules and if this is what they said they want to do you may be guided on how to engage it.

*Can you tell us about your economic plan?* 

All economies are socially based. You have to know the sociological content of an area to be able to decide what to sell to them and what they can produce. There is no point continuing the way we are, and expecting that we will survive. Just hearing that dollars will be shared; just knowing that there is a convention coming in the past few weeks, dollar has jumped by 12%. We are now at N607 to a dollar because every Tom, Dick, and Harry who has access to any allocation, whether local government allocation or contract is changing it to the dollar to head up to the convention because we thought there will be 7800 delegates. So all the big men with big money bought up all the dollars. You also have the need factor, if you explain to the poor people that they are the ones causing this problem they will say no. What caused inflation in the market; who will pay but they don't understand. When I was running for governor in Imo in 2003, I published a pamphlet. For every economic plan, you can just expand but it will remain the same. If vou produce or at least don't produce, the only force on your production is determined by outside forces. When I said Nigeria is an oil occurring country

instead of an oil-producing country, there is a difference. Nobody knew there was oil here until outsiders came to do everything. That is Nigeria's condition. So, until a nation re-engages its paradigm it will be difficult for her to grow and I think we should have a different way of working.

Do you think politics is being monetized today as insinuated by many?

I must agree with you that we have a monetized politics but I can assure you that we have a Buhari elected, who didn't have money. I am only presenting myself for you to choose. I am not saying I can fly. I am not sponsored by the oil industry. So the only people who can sponsor me are Nigerians. 3150 people made contributions and we bought these forms. So, I know that if Nigerians are willing, once my party selects me, APC will be speaking to 90% of the demographics of Nigeria, speaking to the 70% who are below 50 and who believe it's possible to vote for somebody who is 55 who is hope for them. Right now Nigerians are sure that this is where they can get the most efficacious drugs and this is what I am providing. I know that is what I am up to and that is what APC will be offering Nigerians if they take me as their candidate. They will be speaking to elders who believe that they have gotten somebody who will do the work for them. Almost all my supporters are above my age. I have members of the House of Representatives from 1992 who endorsed me even before they contributed money. Some paid N1000, and someone from Nasarawa gave me 150 tubers of yams to sell from his farm. People are investing, thinking that there may be a new Nigeria. It is not about monetization or not, it's about Nigerians committing to a future where they want to go.

#### What is your position on the move by South East presidential aspirants towards having a consensus candidate from the zone?

The South East does not want to arrive at a consensus. The South-East wants to work with Nigerians. We are very disappointed, we thought about 10 to 20 people from the south-east will buy these forms so that we can make a case. When you are making a case, you can make it one way, let all of us come out; men, and women and say yes we believe in Nigeria. We have only seven aspirants and that is very small but I am sure out of this seven, we have those in their seventies, we have those in their sixties, we have those in their fifties. We have every type you need. Nigeria must have the full breadth of Igbo diversity. Any type you need Igbo people has it. So what we said was that anyone you choose we are going to back him or her.

# Lagos APC aspirant, Olawale condemns denial to participate in governorship primary

### •Says State Exco intimidated by his popularity among Lagosians •Faults non-release of screening exercise result

One of the aspirants screened by the All Progressives Congress (APC) for the Lagos State governorship contest, Olawale Wasiu has condemned what he described as unjust denial from participating in the governorship primary election conducted on Thursday.

He faulted the process that led to the emergence of delegates to the governorship primary which he said was undemocratic as the delegate congresses held in the 245 wards of Lagos was a "sham".

Olawale insinuated that the 'powers that be systematically schemed him out of the race because of his soaring popularity among Lagosians.

The aggrieved aspirants in a statement on Thursday after the primary said the exercise is one-sided and does not reflect the total interest of the entire APC members in Lagos State.

The statement read "a purported "Governorship Primary Election" of the All Progressives Congress (APC) Lagos State is being held at the Mobolaji Johnson Stadium. Onikan. According to the organizers of the event, the eligible "Delegates" to vote at the "Governorship Primary Election" are those handpicked by just one of the APC factions in Lagos State through a sham Delegates Congress purportedly held in the 245 Wards of Lagos State on the 18th and 19th of May 2022.

"The one-sided Congress which excluded all the other aspiring delegates that bought the APC Delegates Nomination Forms was conducted in gross violation of the APC Electoral Guidelines. APC Constitution and the Electoral Act.

"The Lagos State APC State Exco, headed by one Pastor Cornelius Ojelabi is complicit in the exercise or this blatant

rape of democracy in APC Lagos. "We also note that the Screening Committee which was inaugurated by the APC National Headquarters to screen all governorship aspirants in Lagos State. has refused to publish the results of the screening exercise as at the time of this press release.

"The approved Election Guidelines of the APC mandates the Screening Committee to release its results within 24 hours of concluding the screening exercise, so as to allow participating aspirants to appeal the outcome of the screening at the APC Screening Appeals Committee.

"I cannot understand why the Screening Committee chose not to contact the aspirants screened by them either by phone call, text message, written letter, or any other means of communication. considering their decision to withhold the results of the screening.

"This is a serious breach of aspirants' fundamental rights to fair hearing. as enshrined in the Nigerian Constitution.

The resultant effects of that misadventure still live with the party till date.

"The extent to which these same individuals have succeeded in their desperate scheming will become apparent when the Screening Committee eventually decides to "release" the results of the screening (which is already 12 days in arrears).

Optimistic that the will of the people will not be subverted, Olawale implored his teeming supporters to remain calm and law-abiding, despite the provocations.

Speaking on his next line of action, the aspirant said "we will continue to seek redress from the internal dispute resolution mechanisms or the party. Without foreclosing the enforcement of our rights to seek justice in the court of law.'

# Agbado stands still in honour of Oba Elect, who died before official coronation

The news of the death of His Royal Highness, High Chief Anthony Adetunji Olukayode Akinrinade, Olu of Agbado Elect in March 2022, was like a tornado which struck the entire community and its environs. It was difficult to believe as people gathered in small groups talking to themselves in low and hushed voices.

On Saturday, 14th May 2022, the reality of the passage of the Olu of Agbado Elect became real to most members of the communities. It was therefore not surprising when market women abandoned their wares in the ever-busy Agbado market to join the children, who had already lined up the streets as early as 7.30 a.m. to have a glimpse of the casket bearing the remains of the late Olu, whose corpse was being conveyed to the African Church, St. Paul's Parish, Agbado, situated along the Agbado Railway Station Road.

Also waiting for the remains of His Royal Highness were the Church officiating priests made up of the Curate, Rev. E.T. Adenuga, Vicar/ Archdeaconry Chairman, The Ven. M.A. Aaron and Bishop of Ifako Diocese of the Church, The Right Rev. I. A Falana.

At exactly 9.30 am on citing the vehicle bearing the corpse of the late Olu, the whole area erupted in one big grief, as women and children wailed uncontrollably. Strangers and residents of the community made up of Igbo, Nupe, Efik, Takpa, and large Hausa indigenes, who now speak the Yoruba dialect fluently. One after the other without any form of prompting, they testified to the goodness of the late Olu of Agbo Elect. Everyone has one good thing or another to say about him. So many agreed that he was a detribalized man because of his long service in the Nigerian Police Force. Others said he was also a great emancipator of the masses.

The enormous goodwill, encomium, and grief expressed by both natives and strangers over his death made Palace Watch dig a little deeper into the possible legacy of the late Olu of Agbado Elect.

Ifo Local Government is a local government area of Ogun State with its administrative headquarters in Ifo town.

The Council area is made up of several towns and villages, which include Akute, Agbado, Ifo, Ojoolu, Abeloju, Jagunna, Lerin, and Pakoto.

The unique and interesting thing about Agbado is that it is a commercial and the epicentre of the new railway line that connects the South West to other parts of the country.

Olori Faith Akinrinade, his wife, in her tribute said "Kabiyesi Anthony Akinrinade, although we can't see you anymore, we know that you are near, smiling down watching us. You are forever in our hearts until we meet again on resurrection morning, continue to rest in peace."

When President Muhammadu Buhari's administration invoked the 2017 policy to revive rail transportation to link some parts of the country through a railway network, most communities sited along the old rail network corridor in the country were not too pleased with the plan. Even though the plan will enable more people to embrace rail transportation, which will further engender rapid development of these areas.

In the South West region, towns and villages like Agbado, Itoki, Abule, Ijoko, Ogba Ayo and Sango all in Ogun State never really welcomed the idea.

Some residents were seen complaining about the destruction of their houses along the rail corridors while others complained about the problem of being relocated to new areas of the state, which they were not happy about.

Immediately the Chinese contractors mobilized to the site, miscreants in these areas popularly known as 'Area Boys' whose parents and relatives were not too happy with the project, deliberately made it very difficult for the contractors to perform.

A close Palace source said, as the dig-dong between the Chinese contractors and the Area boys in Agbado continued unabated, His Highness, High Chief Anthony Adetunji Olukayode Akinrinade, who had not yet been made the Olu of Agbado elect, as one of the elites in the town, stepped into the matter and used his influence as a retired Senior Police Officer, to make sure the foreign contractors were provided with adequate police security for them to continue with their work.

Another reason why the late Olu elect was so loved and cherished by all according to Baale of Paara Community, is that "The late Kabiyesi *Cont'd on page 10*

was installed Baale of Agbado Station on the 27th of December, 1996 by the Late Oba Oyebade Lipede, the immediate past Alake of Egbaland. Immediately after his installation as Baale, he facilitated a Police post in the Ayinla area of Agbado, The police post was later upgraded to Agbado Divisional Headquarters. The late Olu of Agbado Elect again assisted through the help of the Alake and Paramount Ruler of Egbaland in the upgrading of the railway project to a full-fledged Agbado Train Station.

The residents, who initially gave the Chinese contractors problems, complained that so many people have left Agbado and relocated to all the adjoining places. Some of them have gone bankrupt as there were no longer buyers for their wares. They said they used to make about #20 to #25,000.00 in their various businesses a day in October 2013, but when the rail project began; some of them could no longer make up to #15,000.00 a week.

The residents were further incensed that, the regime of the former Governor of Ogun State, Ibinkunle Amosun, demolished buildings along Sango-Ijoko-Agbado-Akute-Alagbole Road to pave way for a 32-kilometre highway project that was designed to open up the boundaries of Ogun/ Lagos State economic opportunities.

Just less than a year after the commencement of the project, the Chinese contractors made a considerable effort in the reconstruction of terminals at Agbado and Sango. The icing on the cake came, when the Federal Government announced that it has made more progress with the establishment of a partnership with a railway wagon assembly, which is now being built at Kasumu, Ifo area of Ogun State.

The bustling nature of present-day Agbado and the economic transformation of the entire areas and communities along that corridor are now beginning to excite the people, who live in these areas, especially Agbado which has been in existence for well over 60 years now.

According to Oluwakemi Agboola, "It is now very easy for us as market women to go into the inter lands in Abeokuta and Ifo, to buy and transport goods to Agbado, where we sell such goods and make quick returns. Furthermore, most of the few houses left in the areas have been remodelled and are now attracting better prices as rents.

If not for the way the late Olu of Agbado Elect stood his ground, when we were causing unnecessary trouble then, we would have missed

this particular opportunity to develop Agbado town, which we are now beginning to enjoy. This is among other reasons why we will not forget him in a hurry.

Mr Akinrinade Akintoye Olusola, one of the sons of the late Olu elect, in his tribute said, "Despite the hurdles and hotshots fired at you when you were doing well to our communities, the fearless persons that you were and your continued prayers kept you going. Now that you are gone, our people and communities have begun to appreciate your good deeds."

Princess Yetunde Osoba in her tribute wrote, "I never imagined that I would be writing this so soon, you have fought a good fight, you have finished your race and I know you kept the faith. Your favourite saying whenever you saw me was, 'I am running my race.' If tears could build a stairway and memory lane, I would walk right up to heaven and bring you back to finish the running race you started, especially in the Agbado community."

The late Akinrinade was born in Agbado Railway Station into the families of Akinrinade – Somoye paternally and Adetokun – Adekanbi maternally of Egba land. His father was from Akodu compound of Egba Alake section. His grandfather was the Jaguno Ijaiye Obirinti (War Chief) during the Ijaiye war with Ibadan and Oyo in the olden days. His grandfather was part of the Exodus movement of the Egbas from homestead to present Abeokuta during the reign of Alaafin Atiba of Oyo.

His father. Late Chief Gilbert Ige Akinpelu Akinrinade, was the Baba Ijo of St. Paul's Anglican Church till his death in 2005. He was among the first governing board members of the Agbado District Comprehensive High School. He was the Chairman of the St. Paul's Anglican Church Primary School. It was the late Oba elect father, who brought the Agbado Community Bank and was the bank's first Chairman.

The father to the late Olu of Agbado elect, began his career as a pioneer Clerk, in the Agbado Post Office. He was the first Dispenser of the Agbado Dispensary now known as the Agbado Health Center. He was traditionally the Agbado Town Secretary for many years and was later installed as the Osi Balogun of Agbado station in 1978. He was thereafter promoted to the position of Otun Baale of Agbado Station until his death in the year 2005.

The late Olu Elect began his education in St. Paul's Anglican Church School, Agbado, and later moved to St. Augustine R.M. School, Itesi, Abeokuta. He finally completed his primary school education at Ansaru-Deen Primary School, Oke-Ado, Ibadan, where he lived with his senior Aunty, Late Mrs Alugbin.

He later proceeded to Gaskiya College, Sabo, Yaba and later joined the Nigerian Police Force. While in the service of the Nigerian Police Force, he enrolled in private studies with the School of Career and International Correspondence. He attended so many in-service courses such as Criminal Prevention and Criminal Jurisprudence.

While still in service, he served and held various positions as the Nigerian Police Administrative Officer, Divisional Police Officer, DPO, Officer in Charge of Pay and other Charges, the Falomo office of the Nigerian Police Force, Obalende. He served in the Nigerian Police Mobile Unit and later in his career became the Officer in Charge of Command, CID, Ebute Meta before his voluntary retirement.

During the Nigerian Civil War, he served under the 3rd Marine Commando when Chief Olusegun Obasanjo was the GOC of that Division. General Alani Akinrinade, who was then a Lt-Col, was the Divisional Staff Officer while the late Military Head of State, late General Sani Abacha, was then the C.O, 17 Brigade of the Nigerian Army.

The late Oba Elect retired from the Nigerian Police as a C.S.P.

# **Train Attack:** Pakistani man seeks FG help to recover son from terrorists

Pakistani father of one of the victims of the Abuja-Kaduna attack train has appealed to the Federal Government to safely recover his son from the captivity of the terrorists.

According to a publication on The News International, a Pakistan-based newspaper, on Friday, the father came to know about the abduction of his son, Dr Abuzar Afzal through social media when the terrorists released video statements of kidnapped persons recently.

"Afzal, who is a resident of Multan Zakariyia town, was serving a Nigerian company as General Manager. He has done his PhD in Microbiology Faisalabad the from

"Afzal said in his video message that he was abducted on March 28, along with 62 others.

"He said he was in a difficult situation. Afzal has also worked as a sub-inspector with the Anti-Narcotics Force. He resigned from ANF in 2020 and went abroad.

"Talking to The News, his father Muhammad Afzal Sheikh said his son went to Nigeria in 2020 after he received a job offer.

"He said they repeatedly tried to contact the Pakistan Embassy in Nigeria and requested the Foreign Ministry for help. A call came from the Foreign Ministry on Wednesday. The FO assured the safe recovery of Afzal who has a wife and two children. He appealed to Prime Minister Shehbaz Sharif and Foreign Minister

### Arms control: NCCSALW, NSCDC agree to collaborate By PAUL MICHAEL, As Audi pledges support in retrieval of illegal weapons Defence Editor, Abuja

The National Centre for Control of Small Arms and Light Weapons (NCCSALW) has called for closer collaboration with Nigeria Security and Civil Defence Corps (NSCDC) to mop-up illegal arms in Nigeria.

National Coordinator of NCCSALW, Maj Gen Abba Dikko (Rtd), made the call during a courtesy call on the Commandant-General of NSCDC, Dr Ahmed Audi, at the NSCDC headquarters in Abuja on Wednesday.

Gen Dikko said that CCSALW had been NCCSALW working assiduously to deliver on its mandate. Adding that the Centre is willing to work with the NSCDC and other security agencies to ensure that the illegal arms in possession of

unauthorised people were recovered. He commended Dr Audi

for his leadership, innovation and direction, particularly in the area of protection of critical infrastructure and national assets across the country.

Gen Dikko called for partnership with NSCDC in the areas of intelligence data collection sharing, and mainstreaming control of arms in the NSCDC's hierarchy and work environment.

He stressed that leveraging the existing capacities of NSCDC and otĥer security agencies will go a long way in strengthening coordination and building the capacity stakeholders relevant

on their responsibilities under the small arms and light weapons management paradigm.

While responding, the NSCDC boss lauded the establishment of the Centre, noting that it was in the interest of peace and security as well as crime prevention and control.

He pledged the support of NSCDC to the retrieval of illegal weapons in the country, attributing the current security challenges facing the Nation to the proliferation of illegal arms in the hands of unauthorized persons.

Dr Audi thanked the coordinator and his team for their efforts toward achieving the centre's mandate

He expressed delight with the opportunity to support NCCSALW in the discharge of its duties of mopping illicit arms in the country.

CG expressed The NSCDC's readiness to give full support to the Centre, saying that the fight against illicit arms in the polity was a must and could only be won through collaboration with relevant stakeholders.

"There is a need for all security agencies to come together to fashion out new strategies to address this menace. We have to stop the smuggling of weapons and clean up the system by mopping up the ones already in circulation.

"For us in the NSCDC, we are ready to key into the programmes of the National Center for the Control of Small Arms and Light Weapons because we are partners in progress," he

said. applauded He the contribution of the Centre to National Security and assured of a more robust relationship with the center.

Dr Audi emphasized that it was in recognition of the center's mandate and credibility that the Corps handed over the cache of arms recovered from a criminal hideout in Imo State.

Zulum confirms 32 killed, 6 injured by terrorists in Borno By PAUL MICHAEL,

He further stated that six other youths were injured, while others escaped unhurt in the border communities with Cameroon.

"Governor Babagana Umara Zulum is very disturbed by the unfortunate killing of fellow citizens at the weekend.

"Pending a full report, the Governor was briefed by the Majority Leader of Borno State House of Assembly, Mohammed Dige, who represents Kala-Balge where the victims hailed from," he lamented.


He noted that the youths were not farmers, but enterprising young men engaged in gathering metals 'Kayan popularly called Ajaokuta' which are sold as raw materials for steel production.

Continuing, he said that the victims were said to have gone to a deserted Mudu village in Dikwa LGA, 45 kilometers from Rann, the council headquarters in search of raw materials of steel.

According to him, soldiers alongside the Chairman of Kala-Balge LGA, on Tuesday, recovered 14 bodies of victims who were apparently tied and shot at close range.

Nigeria currently hangs on a dangerous precipice and your decisions at the primaries can go a long way to decide if the country will tip over the abyss or not.

Party primary election is not an opportunity for self-enrichment. Ironically, the delegates must know that the good candidates do not always have money to share. Those who share money are political predators, wolves in sheep clothing that must have made money by compromising social structures. Party delegates who collect money to vote in the primaries are thieves, simple. There is no better way to say it. They are invidiously assaulting their conscience and the future of the country. A process that thrives on stealing will automatically produce thieves; this is the moral burden the delegates must bear.

By the time the party primaries are over, different candidates would have emerged for different positions. Then, a head count will be made and Nigerians will know whether the delegates stole the future of the country or demonstrated a responsible attitude at the primaries. Also, politicians who imagine and are convinced that they can compromise the process by inducing party delegates with huge sums of money should remember the divine and inevitable day of reckoning. It is never far away. The 2023 election is symbolic in many ways but more directly, its outcome will signify the revival or collapse of Nigeria. Party delegates at party primaries have the onerous responsibility to kick start a renewal process of the Nigeria entity.

# Ascended, after being crucified, dead, buried, and risen!

esus Christ was crucified. He died. He was buried. He rose again. The fact of His rising from the dead signified that christ is indeed alive. But he needed to show that He was living. He demonstrated this to His disciples. "To them He presented Himself alive after His passion by many proofs, appearing to them during forty days, and speaking of the Kingdom of God" (Acts 1:3). He used the intervening forty days (that followed the resurrection of Jesus Christ) to prove that He has indeed arisen and had a body. He appeared to two men who were on their way to Emmaus. One of them was named Cleopas. "They said to Him, 'Concerning Jesus of Nazareth, who was a prophet mighty in deed and word before God and all the people and how our chief priests and rulers delivered him up to be condemned to death and crucified him. But we had hoped that he was the one to redeem Israel. Yes, and besides all this, it is now the third day since this happened. Moreover, some women in our company amazed us. They were at the tomb early in the morning and did not find his body; and they came back saying that they had even seen a vision of angels, who said that he was alive. Some of those who were with us went to the tomb and found it just as the women had said, but him they did not see' " (Luke 24:19-24).

After His resurrection, Jesus Christ lived 'among' His disciples for forty days – as mentioned earlier - before He ascended to heaven. Hence forty days after the resurrection is generally celebrated as Ascension Day by the Church. "Then he led them out as far as Bethany, and lifting up his hands he blessed them, he parted from them and was carried into heaven. And they returned to Jerusalem with great joy and were continually in the temple blessing God" (Luke 24:50-53). Ascension brought joy to the disciples. It reinvigorated the act of worship from the disciple knowing full well that Jesus is alive.

A major significance of the ascension of Christ to believers is that it confirms his divinity and ever-presence among His people. He was seen alive and taken away in the very presence of His disciples. "And while they were gazing into heaven as he went, behold two men stood by them in white robes, and said, "Men of Galilee, why do you stand looking into heaven? This Jesus, who you was taken up from you into heaven, will come in the same way as you saw him go into heaven" (Acts 1:9-11).

The reality of the ascension of Christ was not accidental. It was prophesized by the prophets of the Old Testament and by Jesus Christ Himself. "The Lord said to my Lord, Sit at My right hand" (Psalm 110:1). "In my father's house are many mansions; if it were not so, I would have told you. I go to prepare a place for you" (John 14:2). If Jesus had not ascended there would not have been anyone to sit by God to propitiate for human sins (Matthew 26:64; Hebrew 1:3, 12:2; 1 Peter 3:22).

Hebrew 1:3, 12:2; 1 Peter 3:22). The ascension elevated Jesus to a tower from which He could fight on our behalf and subdue the enemies of the Church; making our enemies His footstool (Psalm 110:1). Hence, we – soldiers of the Cross and faith - can become rulers and be strengthened for the fight against the world and all that does not represent the will of God (Acts 9:22; Psalm 29:11). And in Hebrew 11:32-34, "For time would fail me to tell of Gideon, Barak, Samson, of David and Samuel and the prophets – who through faith conquered kingdoms, enforced justice, received promises, stopped the mouths of lions, quenched raging fire, escaped the edge of the sword, won strength out of weakness, became mighty in war, put foreign armies to flight."

The ascension enthroned Christ at the right hand of God. Consequently, all

authority is given to Him by God. His authority is of absolute sovereignty. He shares it with no other power on earth below, and in heaven above. Apostle Paul puts it thus: "Therefore God has exalted Him and bestowed on Him the name which is above every name, that at the name of Jesus every knee should bow, in heaven and on earth, and every tongue confess that Jesus Christ is Lord, to the glory of God the Father" (Philippian 2:9-11). The ascension of Christ Jesus makes it

The ascension of Christ Jesus makes it possible for Him to elevate all believers to become priests forever in the order of His own dispensation. "You are a priest forever according to the order of Melchizedek" (Psalm 110:4b). "But you are a chosen race, a royal priesthood, a holy nation, God's own people, that you may declare the wonderful deeds of him who called you out of darkness into His marvelous light" (1 Peter 2:9). God has always desired that all believers should be called His own people. Prophet Jeremiah affirms this Divine desire in a most loving expression, "The Lord has appeared him afar. I have loved you with an everlasting love; therefore I have continued my faithfulness to you" (Jeremiah 31:3).

The ascension becomes meaningful in a believer's life only when they accept its reality, its mystery, and the fact that He died, was resurrected on the third day, and ascended into heaven; sitting at the right hand of God the Father. The writer of Hebrew thus called Jesus Christ the Forerunner. "This hope we have as an anchor of the soul, both sure and steadfast, and which enters the Presence behind the veil, where the Forerunner has entered for us, even Jesus, having become the High Priest forever according to the order of Melchizedek" (Hebrew 6:19-20). We must therefore anchor our faith and hope - that the ascension secures for believers - on Jesus. "Therefore lift up your drooping hands, strengthen your weak knees, and make a straight path for your feet, so that what is lame may not be put out of joint but rather healed" (Hebrew 12:12). And in verse 25, our task as believers is: "See that vou do not refuse Him who is speaking. For they did not escape when they refused Him who warned them on earth, much less shall we escape if we reject Him who warns from heaven.'

"Now, may the God of peace who brought again from the dead our Lord Jesus, the Great Shepherd of the sheep, by the blood of the eternal covenant, equip you with everything good that you may do His will, working in you that which is pleasing in His sight through Jesus Christ; to whom be glory forever and ever. Amen. Shalom!!

# 'We should not honour men above God' – Pastor Mokuolu

•Exposes dirty side of General Overseers of Nigerian churches

A careful look at the Prophet in Psalms 75 to 83 will enable one to picture the signs and instruments as they served in the ministry of prophesying.

In the ministry of prophesying. Old Testament prophecy, among other things, was a declaration of God's message to the people, which sometimes includes a message about future events. Prophets, who were uniquely empowered by the Spirit of God, were considered the mouthpiece of God. They spoke from their first-hand experience and knowledge of God.

What did prophesying sound like? Sometimes it was a ringing declaration of God's word for that moment. Other times it pronounced spiritual truth with authority or warned of impending judgment or reassured people of God's deliverance. Often delivered in a poetic or figurative language, Old Testament prophecy usually focuses on God's character and power. Sometimes Isaiah or Ezekiel seemed rather eccentric as they act out an object lesson to underscore their message from God.

Just like Prophet Nathan did to King David, he has come out to warn Church Pastors, Prophets, and Church leaders especially Church General Overseers in Nigeria, to be mindful of what they do and preach, otherwise, they will incur the wrath of God.

Mokuolu declared boldly that Nigerian Church leaders are preaching covetousness instead of salvation, faith, and holiness. He added that their general lifestyle in the past 40 to 50 years has not also helped Nigeria's development. Mokuolu noted that many G.Os are only desperate for money, which has contributed in very large measure to the present decadence in the country.

He said, "Dear General Overseer of Churches in Nigeria, I bring you greetings in the name of the Lord, and I speak the following words with utmost respect; I have great respect for you all.

"It has been in the news recently, that some of you have started lamenting about the spate of violence in Nigeria. It is nice to know that you are concerned and are speaking out. You are condemning the government and you are asking questions. But the surprising thing is that we are actually surprised that you church leaders are equally surprised about these ugly developments. We are surprised that you are lamenting too.

"Now we are asking ourselves, what exactly did you people do, as Church leaders when all these ugly things were developing? And what do you people actually expect now? Do you people expect to see anything different in the country from the kind of messages Church leaders have been preaching in the country in the past 40 years? What kind of Christians do you people expect that these types of messages will produce? Another question is what kind of society did you people expect your messages to help produce?

'How do you expect Nigeria to be a righteous nation with the kind of messages most of you have been preaching in the past 40 to 50 years? The crux of your messages all these years is centered on materialism. All you've been preaching is nothing but messages that centered on how people are going to eat, spend and have money. You the Church leaders failed to raise righteous people for this society. You also failed to raise Godly people for Nigeria. You did not discipline people and you did not preach the gospel of our Lord Jesus Christ.

"Why are you then surprised? You never mobilized your followers to witness, and preach to the people who have become bandits today. Rather you keep mobilizing them to give, and to help you build magnificent buildings, which you people call Churches. These buildings in all honesty don't mean anything or serve the purpose of the body of Christ. They really do nothing to the true believer. It is these same buildings you spend so much money to maintain.

"We are therefore wondering why some of you are surprised at the level of evil in Nigeria. If there is a group of people that have failed Nigeria, it is the Church. And within the Church, the greatest culprits are the General Overseers, the Pastors, and the preachers, who have refused to raise righteous people. But rather are after their own pockets, after what they will get, they are also after fame and name.

and name. "When you preach to a group of people, saying If you are the firstborn of your family, you need to give some special offerings, how can Nigeria develop if these are the type of messages you are preaching? Again, you get up to preach saying they are going to eat and they will be filled. And if the Christian population in the country is to increase astronomically, how will they eat? How are we going to eat as Christians, if there is no mechanized farming? Is the food you preach that the Christian population is going to eat, going to drop from heaven?

"Who will be the people that are going to practice this mechanized farming if the needs ever arose? Do you expect members of other religions to farm and feed the Nigerian Christians? Sadly, Nigerian Church leaders keep putting people's faith in things that are not real. Why? Church leaders want their folks to keep expecting some divine miracles; will God just throw money at Christians from heaven without work? Church leaders daily give the impression through their preaching that hard work is no longer needed for the faithful to grow, all they need to do is to keep giving offerings and they will be rich

work is no longer needed for the faithful to grow, all they need to do is to keep giving offerings and they will be rich. "Now, if you must know, the Church leaders are part of the people who created all the problems we are currently experiencing in the country. Why are some of you complaining that it is difficult to travel from one part of the country to another? Your past and present actions are part of the reason(s), my Lord General Overseer! These problems are now steering us on the face. It is because as Church leaders, you have not been preaching the truth. You know and see the decadence around you. If the Church is this corrupt, and if around you, we have this high level of corruption, what do you expect from the larger society? Jesus said, we are the light of the world, and we are the salt of the earth. Two kinds of relationships we must have with other people are being the light and salt to them.

"Some of you as Church leaders neither raised people that reflect light nor salt among your followers. Permit me to ask, where is the salt among your folks in today's society? Where are the testimonies? When a General Overseer is preaching against women wearing trousers and suits instead of looking at more important issues. These irrelevant issues are what our G.Os have been preaching for decades, and they expect the society to develop and grow or for things to begin to work well in the country. How can this happen Mr G.O.?

"As Church leaders, you have continually let out the real issue of unrighteousness in your preaching. As a Church, we are now focusing on clothing, and you are expecting the society to turn right. Whenever our Church leaders travel either within or outside the country and once they arrive at their destinations, we begin to see their pictures all over the internet alerting us of their private jets.

"People also see you daily travelling in a convoy of exotic cars. These are the pictures you are painting to the young people in our society. These young men and women also want to be where some of you are today. They also want to have what you have. Unfortunately, the Nigerian economy does not support that mad craving for money and material wealth. In the process of looking like some of you G.Os, our Pastors and Church leaders, so many youths have resulted in stealing, kidnapping, robbery, and banditry.

"Many people who attend your programmes annually are into adultery, fornications, and ungodliness. You never get to do altar calls for these types of men and women. All you say during the crusades is 'those who want to rise this year should come forward'. Every December you as Church leaders keep using sweet words to deceive your faithful. You keep saying 'This is your year of upliftment! This is your year to rise and shine!!' You continue this is your year of this and that. You have been saying these things for well over 40 years now. "People are gufforing and things are gufting

"People are suffering and things are getting worse in society. In countries where people

don't believe in God, they are advancing far more than we do. You hold all kinds of night vigils, as Church leaders, you do not care about the safety of your folks; they have to travel several miles to attend your programmes. In these programmes, you keep promising them that you can solve all of their problems. Now as Church leaders, you are again urging your followers to go into active politics. Did you ever train, prepare or raise the Church members you are presently asking to go into active politics to do so? Did you raise any of your followers to stand as Daniel in our various offices across the land? Can you tell or show us the difference between a Christian and an unbeliever in some of our offices in Nigeria today? Why should any of you, as Church leaders, be surprised that there is a lot of evil today in this country called Nigeria?

"It is nice to know that Church leaders have now begun to realize that all the promises they have been making to their congregations are not visible. Why? Because the economy does not even support their empty promises to their folks. I know as a Pastor, you'll be quick to say that we are dependent on heaven's economy. You know, within your heart of heart, that people will continue to suffer because our economy is not good. No matter what you pray and prophesy. If we continue to pray and refuse to fix our hospitals and put adequate equipment in these hospitals that are supposed to help people to diagnose simple ailments, and tell them what is wrong with their health, people will continue to suffer and die.

"As Church leaders, instead of doing just this, you prefer to build big Church auditoriums; Church structures worth billions of naira just to gather people on Sundays. These same people will die at home because they have no diagnostic centers to go to when they are sick. No MRI scans. No X-ray and whatever. Simple ailment, people who are supposed to be members of your Churches and congregations are dying. God gave us this knowledge, and we have become so selfish and so self-centered. Church leaders now oppressed people even with their wealth. This is the wealth that came from the offering of some people.

"Let me tell you something Mr G.O. in Acts, the Bible says, they laid all that they had in the Apostles' feet. The Apostles in question did not lay claim to that money as their personal money. They took this money and distributed it, and the bible says, there was none that lacked among them. But what you do today as Church leaders, you take all the money and begin to boast to us, that you are the richest Pastor in the world. You begin to boast to us that you have so much wealth. You prefer to oppress people with your wealth than to express the love of Jesus to them, in sharing it with everybody.

"Your chairs in the Church altar are separate, they have big cushions, while every other person can sit on a plastic chair in the Church assembly or auditorium during service. These are the kind of examples you are setting. If politicians are doing all these things, you should not blame them because these are the examples we see in you, sir.

"Mr G.O. Sir, where is the Christ that you have been preaching? Your gospel is largely becoming ineffective. Now you are begging people to respect you. For example, did the late Nelson Mandela beg anybody to respect him? NO! He was respected, because of the great sacrifices Madiba made. He is even respected so much after his passage. He is respected even in death. If an unbeliever is so much respected and venerated, how much more are the supposed servants of God?

"But instead, what you are now doing Mr G.O. is to threaten us that if we dare correct you that God will just spank us. We must not correct you, and we must not say anything against you, because you have raised so many young people now that have become sycophants."

"These sycophants now call you people father! father!! These groups of people have now become a clique. They have now become a cult. These people believe they can't succeed in the Ministry except they bow to you. Some of them even believe that you carry some special anointing, that they must tap into before and until you go. Sir, Ephesians Chapter 4 verse 7, says that 'God has given to every one of us the grace to succeed in life according to our measure of faith.' We all have what we need to fulfil our ministries. Whether Apostles, Teachers, or Prophets. Jesus will give every man and woman what he or she needs sir. Note what you carry is for the body of Christ. What you carry is to raise the children of God to become like Christ. What everybody needs to do in the Ministry, Jesus will deposit in them.

"But you have confused people, that they now literally worship you. Many of you have surrounded yourself with sycophants who can never tell you the truth. Some of you have Universities, you have institutions. What students and teachers do in these schools is terrible. It is worse than what is happening in some federal institutions across the country.

"Some of your schools are dying, but now, you are blaming the government. Are we not supposed to be light and the salt of the earth? Where are the people that you have raised as Minister of God? You gather people from year to year, all that you do, or tell them, is about money and material success. How then, do you not expect that we are going to end up like this? Everybody is desperately looking for money. Everybody!!! When politicians come to you, you bless them. When people attend your programme what you preach to them is how to make more wealth. How to be wealthy. You tell them that the wealth you have now is still small. There is still a place God is taking them to. What do they want to do? A man has four cars. You are telling him that isn't enough. Mr G.O. sir, how many cars do you want such a person to drive in life to be comfortable? Why are you teaching us covetousness?

"Why can't some of our Churches' G.Os. Speak the truth? Some of them have truly disappointed our Lord Jesus Christ. This is not the gospel Jesus commissioned you and committed you to preach. Most of these G.Os have turned the Church and Ministries into family affairs. Some of them, their children, oppressed people they talk to and have the audacity to be abusing Pastors. "And the so-called G.O sits there watching,

"And the so-called G.O sits there watching, thinking the society will grow. Some of them, their children talk to believers, the people our Lord Jesus Christ died for as if they are beggars. As if these Pastors are nobody. You sit down there as a G.O. watching like Ella, as your children are desecrating the altar of God. Many of you are planning how you will quietly hand over your Ministries to your children.

"The Church of God has now become a family business. Because it is now all about money and wealth. And then you are wondering why Nigeria is bad? Why will it not be bad? If you as a G.O. of a Church or Ministry is all concerned about money, what do you expect from the kidnapper?

"What do you expect from the hoodlums and the armed robbers? If you must know it all about money today. The lady that is prostituting her body, she is doing so, because she wants money. They are looking for money. Many of you G.Os are stealing from the people. You are preaching and they are dropping money. And sir, you think that is the call of God. Do you think this is the same gospel that Apostle Paul preached? Do you think this is the same gospel Peter preached? That he told somebody, that may you perish with your money. For you think, you can buy the gift of God with money.

# Power generation continues to decline as investments rise

In most parts of the world, the more investments in terms of funding and equipment the government provides for power generation and distribution, the better services the citizens enjoy, but the reverse is the case in Nigeria. Since the democratic dispensation began in 1999, successive administrations have invested huge amounts of money in the country's power sector. **JOHNMARK UKOKO** writes that despite the huge funding and investments in the sector, perpetual darkness has remained the lot of Nigerians and businesses in the country.

Since 1999 when democratic governance began till date, successive administrations have, as a matter of policy, invested huge resources in foreign and local currencies in the country's power sector.

From former presidents Olusegun Obasanjo and Goodluck Jonathan to the President Muhammadu Buhari administration, the governments have, as a matter of deliberate policy, engaged eggheads to man the country's power sector.

At the inception of his government, Obasanjo appointed the late Bola Ige to provide Nigerians with stable power supply and on assuming office, Ige assured Nigerians that he would turn stones into bread in the power sector, but when he was killed, the power situation deteriorated from bad to worse.

When Jonathan assumed power, he appointed Prof. Barth Nnaji to tackle the power challenges, but as of when he was removed from office, there was no noticeable improvement in the country's power sector.

Nnaji even left the power situation worse than he met it, as his time as Minister of Power witnessed scandal due to his interest in private business in the power sector, especially in his home state of Abia.

On his part, President Buhari, who came to power on a change mantra, appointed former Lagos State Governor, Babatunde Raji Fashola, as Minister of Power. At his appointment, Nigerians who have seen his performance as Lagos State governor hoped that as Minister of Works, Housing and Power, the days of darkness were over.

They had hoped that with Fashola at the helm of affairs in the power sector, generation and distribution would improve significantly, but as the years went by, Fashola's reign in the sector proved another mirage, as power generation and distribution remained around 5,000 megawatts.

At the commencement of Buhari's second term, he moved Fashola from the Ministry of Power and appointed Muhammed Saleh, again, with the hope of reviving the sector.

Most Nigerians thought electricity supply would improve with an electrical engineer in place of Fashola, a lawyer as Minister of Power, but barely a year and six months after Fashola's successor in the ministry, the country's electricity situation has been challenged by the constant collapse of the national grid and power outages.

In the last six months or thereabouts, Saleh had been explaining to Nigerians why the country had constantly remained in total darkness.

The national grid that had over 6,000 megawatts a few years ago has now plunged to about 3,526 megawatts as of last week with most parts of the country experiencing unprecedented outages.

The Nigeria Electricity System Operators (NESCO) has negatively impacted the transmission and distribution of electricity to consumers, including households and businesses across the country.

However, the Transmission Company of Nigeria (TCN) explained that the Federal Government was making an effort to deliver two units of 330kv power transmission substations in Katsina and Kano states.

Managing Director of TCN, Sule Abdulaziz, disclosed that the company would deliver two units of 330 KVA power transmission substations in Katsina and Kano along with the transmission lines in the next two years to boost power supply in the country.

A statement issued by General Manager, Public Affairs of TCN, Ndidi Mbah, said on completion, the Katsina substation will improve the transmission of bulk power supply to Daura, Dutsima, Kankara and other parts of the North.


No doubt, the Buhari administration in its seven years had awarded several power contracts running into billions of dollars and trillions of naira, but improvement in the power sector has been at best negligible.

President Buhari's administration has awarded a lot of power projects across the country aimed at guaranteeing the country a stable power supply but to no avail

On assumption of office, ministers of power keep assuring Nigerians that they know the challenges of the power situation and that they have what it takes to remedy the situation.

But at the end of their tenures, they often leave the power supply worse than they met it, even after supervising the award of huge contracts and projects to boost the sector.

Former Minister of Solid Mineral Resources, Kayode Fayemi, recently said he knew the challenges of the power sector and possessed the magic wand to tackle them.

Fayemi, who is the Governor of Ekiti State and a presidential aspirant on the platform of the All Progressives Congress (APC), stated this while addressing Niger State delegates, assuring that if elected president, the country's power challenges will be a thing of the past.

"I need your votes to continue the good legacies of President Buhari's administration on several fronts. This government has done well in the economy, security and infrastructure development. The only area where there are still some challenges is power supply.

"If I emerge as the next president of the country, the challenges currently being witnessed in the power sector will be a thing of the past," he said.

While the politicians are doing what they know how

best to do in making promises, businesses in the country are closing down due to the failure of the power sector.

Most businesses that have not shut down operations now run skeletal services as a result of erratic power supply and rising cost of diesel.

Only recently, President of the Manufacturers Association of Nigeria (MAN), Mansur Ahmed, told The Trumpet that members of the association were grappling with serious challenges of epileptic power supply.

Most Nigerians, who commented on the situation, lamented that successive administrations have failed the country in the area of power supply, wondering why 62 years after independence and huge funds invested in the power sector, the country still gropes in utter darkness. They expressed sadness that it appears the more money the government spends on power, the worse it gets.

A public affairs analyst, Sam Nwajoba, berated the engineers in the ministry of power for the high level of corruption and compromise with foreign and local contractors to exploit the country.

Nwajoba alleged that the engineers and some senior civil servants were not being sincere with Nigerians and as such the more projects awarded and commissioned in the power sector, the more epileptic electricity supply Nigerians experience. "The Federal Government is

"The Federal Government is not sincere in its avowed commitment to delivering stable power supply to Nigerians. We are told that for every budget, about one power project or the other will be commissioned or about to be awarded. But despite that, the power generation has remained between 5,000 megawatts and 7,000 megawatts for years until recently when it crashed to below 4,000 megawatts.

"Politicians, top civil servants and engineers in the ministry of power are feeding fats from the various power projects while the country's business sectors and the economy at large suffer.

"As long the government fails to make tough decisions and take concrete actions against senior civil servants and engineers in the Ministry of Power, Nigerians will continue to be told one story after another, while power supply remains erratic," he said.

As the power situation worsens, Nigerians ask why has it become nearly impossible for successive administrations to deliver stable power supply in the country?

## Agriculture remains highest employer of labour in Africa, says Elumelu

In a statement made available to *The Trumpet, the* ILC said the inaugural sitting will be held fully virtually, while the various committees will begin their work on May 30, 2022, just as plenary sittings will be held between June 6 and June 11, 2022.

# Problems bedevilling Nigeria's Real Estate sector

't is no longer news that Nigeria has overtaken other African countries as the country with the most Real Estate investments.

This feat was achieved thanks to a growing population of over 200 million people. Despite this feat, Nigeria, like most African countries, is bedevilled by numerous economic and political woes that have hurt the country's real estate sector making it difficult for the sector to thrive better.

The coronavirus pandemic increased drastically the risk in the capital market. The volatile nature of the equity capital market in this post-pandemic era is one of the reasons why there is a drastic drop in returns in Nigeria. Because the real estate sector is a component of this financial system, most protective investors will reconsider investing in real estate. Additionally, the raising capital for lands, fees, and construction costs have made things more difficult for estate agents.

One major effect of this problem is the impact on the Nigerian economy by limiting the flow of cash in the real estate sector, thereby having a very negative effect on the country's Gross Domestic Product.

The ongoing rise in the price of most Nigerian homes is posing a significant challenge to the country's real estate sector. Most Nigerian cities are overpriced, which discourages potential investors. Rivers, Lagos, and Abuja are the most affected cities, all of which are important commercial hubs.

Furthermore, the exorbitant price tag has widened the social divide between different income earners. In short, there are some areas where a middle-income earner, let alone a low-income earner, cannot afford to rent a home.

Taking Lagos State as an example, certain housing units are occupied by the wealthy and cannot be afforded by low-income earners. When this happens, combined with the country's rising economic woes, people tend to flock to less expensive areas, putting a damper on hopes of a possible drop in rent costs.

Environmental, Social and Governance (ESG), a set standard that is used to evaluate the environmental and climate effects of housing units is a major factor in the Nigeria Real Estate sector. Most apartments are characterised by pollution, the prevalence of waste in public areas, lack of trash bins for proper waste disposal, and more. This is not just mostly prevalent in big cities such as Lagos, Abuja, Port-Harcourt and Kano but is also common

in some local communities.

More so, according to the Global Housing Standard, real estate professionals should be concerned about greenhouse gas emissions. Some real estate practitioners in Nigeria disregard this standard, resulting in widespread environmental and climate change in most areas of the country.

Statistics show that Nigeria's ESG indexes grew by approximately an additional 40% in 2020. This is said to have been primarily influenced by matrices determined by how Nigerians handled waste and how conducive their environment was. Another important factor that contributed to the exponential increase was the high proportion of healthy residents compared to the low rate of medical cases caused by environmental factors.

Furthermore, the depreciation rate of the Naira is a major source of concern for the real estate sector and other sectors of the Nigerian economy. The failure of the government to subsidize the cost of building materials after so many failed promises adds insult to injury,

forcing contractors and building engineers to purchase this expensive construction equipment at exorbitant prices across the country.

Notwithstanding, though not taken seriously by the government, housing experts have made several recommendations for the country to become self-sufficient in the manufacturing of building materials. These recommendations have yet to bear fruit, but in the meantime, Real Estate investors in Nigeria will most likely be purchasing construction materials at exorbitant prices, aided by rising naira depreciation for who knows how long.

The increase in rural-urban migration occasioned by the inability of the government to create jobs in the rural communities is a major factor. The large influx of renters from rural areas to urban areas has had a significant impact on property regulation in the country. As a result of this unchecked migration, the prices of home rent have increased drastically over the years. In places like Abuja, the price of a 1 bedroom apartment which was around N300,000 to

N350,000 in the semi-urban areas of the city is now at an all-time high of N450,000 to N500,000

Even though rent prices in rural areas are relatively low, people flock to urban areas in search of white-collar jobs and greener pastures due to a lack of investment opportunities in other sectors of the economy, especially agriculture. As a result, most real estate managers and agents capitalize on this flow by raising house rents.

Similarly, Estate laws are generally not properly implemented in Nigeria, which has resulted in many cases where investors have been deprived of the land they legally purchased. This problem is very common in Abuja and Lagos. It is primarily orchestrated by a group of land grabbers commonly known as omo-onile in Lagos. These well-known property scammers have a penchant for dubbing investors with the settlement fee tag. They are also commonly found on construction sites where building projects are in progress, where they either violently or deceitfully extort.

In Lagos State for instance, despite the city's law, which



# **Court orders final forfeiture of Lagos port containers to EFCC**

The Special Offences Court sitting in Ikeja presided over by Justice Mojisola Dada on Thursday, May 26, 2022, asked the Economic and Financial Crimes Commission (EFCC) to take custody of some properties that belongs to one Obinna Anthony Okonkwo at the Apapa ports in Lagos.

It was recalled that Justice Mojisola had earlier ordered the interim forfeiture of the properties, after an ex-parte

The properties are container with no: TCLU A576813 located at 7, Okotie-Eboh Street, Lagos; a container with no: TGHU 8404304 located at 7, Okotie-Eboh Street, Lagos; and a container with no: GESU 600 located at a warehouse on 191, Muyibi Street, Olodi, Apapa, Lagos.

Counsel for the EFCC, S.O. Daji, at the sitting on Thursday while requesting the final forfeiture of the items, informed the court that the EFCC had complied with the

application filed by the EFCC. directive of the court, including publishing the interim forfeiture order in a national newspaper.

He tendered exhibits to prove his case saying "My lord, after the publication, till now, no one has come forward to lay claim to the items."

Furthermore, Daji told the court that investigation revealed that the owners used fake documents to import the items into the country and that the containers were acquired with proceeds of unlawful activities.

guarantees offenders 21 years in prison, land grabbers continue to thrive in certain areas of the State. There have been numerous cases where people's land has been forcibly taken and buildings demolished, rendering the property protection law ineffective. One such case happened recently in Abuja where the house of a prominent Magazine publisher and aspiring politician in Nigeria, Prince Kpokpogri was demolished.

This problem that has remained largely unchecked appears to be deterring a significant number of real estate investors from investing in Nigerian property.

Buildings collapsing in various parts of the country indicate that the construction materials used by some contractors are subpar. In short, some of these building contractors in Nigeria lack the necessary educational credentials and professional experience.

This persistent problem appears to have become a source of concern for the majority of Nigerians, and if allowed to persist, it may succeed in tarnishing the image of the country's real estate sector taking it backwards. Presently, some buildings in certain industrial areas of the country do not meet construction standards, which is largely due to the incompetence of the responsible building contractors, a lapse on the part of regulatory agencies.

Finally, the importance of real estate to the economy of Nigeria cannot be overemphasized. It is undoubtedly a major economic driver and has generated wealth for the country. Despite the fact that it is the largest Real Estate market in Africa, it has faced these critical challenges over the years without the government making significant efforts to tackle them.

No country grows to its full potential without a healthy Real Estate sector. It is time the government makes deliberate efforts to tackle these problems for the betterment of the country.

"We urge your lordship to grant our application, which is brought pursuant to Section 17 Advance Fee Fraud and Other Fraud Related Offences Act 2006,' he said.

arketers of oil have called for investment in new tankers to replace existing ones

Executive Secretary of the Major Oil Marketers Association of Nigeria (MOMAN) Clement Isong, on Tuesday, called for investments in new trucks.

He said, "Many of the trucks that are on our roads are about 40 years old. Those trucks should not be on the road because they are prone to accidents."

He made this known during an oil and gas summit in Lagos where he delivered a lecture on 'Opportunity areas and challenges of investments in the Petroleum Products Marketing & Bunkering sector'.

According to him, "those trucks should not be on the road because they are prone to

accidents." The old trucks were no longer road-worthy and were the causes of tanker accidents, adding that lack of funds to purchase new ones were some of the fallouts of low investments in the downstream sector.

However, he said, with the passage and implementation of the Petroleum Industry Act (PIA), marketers were hopeful that investors would be encouraged to invest in new trucks as part of the way forward for the downstream sector.

"Those are investments that haven't been made in Nigeria for very many years because the business was not generating enough money. But by the time the PIA is implemented, then we will have better quality trucks – trucks that will not continue to cause accidents like those we currently see on the road," he said. According to Isong, the same situation of asset depreciation applied to product storage tanks. He noted that most of the tanks were about 50-60 years old, calling on the government to ensure that it drove investments into the sector to guarantee safety of the depots.

"Although most of the tanks at the private depots are also old, those at the NNPC depots are even older.

"The 30, 000 filling stations in the country are also very old. Most of them are about 50-60 years old. Most of the stations need to be pulled down and rebuilt. Filling stations are supposed to be rebuilt every 10 to 15 years. The underground tanks also need to be changed because they are rusty and cause products to seep into the water being consumed," he said, adding that new technologies needed to be deployed to improve the safety of lives and properties in the sector.

He called on the government to put in place self-regulation that would pull investments into the downstream sector, and in turn improve safety performance in the sector.

"When I say safety, I mean the entire health, safety, environment and quality of the depots across the country. And I'm not just talking about the private depots alone. So, there is so much investment that needs to be made to upgrade the filling stations in the country. But sometimes, the sector probably will need the regulator to accompany us to make sure that we do the things that we must do," he said.



USAID Trade Hub partners with ShEquity to support women entrepreneurs

ShEquity Partners, an investment firm that promotes African women in entrepreneurship, has revealed that it will invest in and support more than 100 potential women-owned and led businesses in Africa.

"If Africa is to reach its full economic potential, smart investment for African women entrepreneurs needs to be dramatically increased." Koelbl said.

Additionally, as part of the USAID Trade Hub project, ShEquity will provide business development services and technical support to 120 womenowned or led businesses in the target markets and also select 12 high-growth, high-impact businesses that will each receive at least \$50,000 in venture capital funding.

"Williams was recognized for his role in the legal quest for environmental justice. He worked with the four fisherfolks from the three communities in the Niger Delta that held Royal Dutch Shell accountable for the oil spills and environmental damage to Oruma, Goi and Ikot Ada Udo communities.

"He was also on the legal team that litigated the action over gas flaring in the Iwherekan Community in the case of Jonah Gbemre versus Shell in 2005," he said.

Executive Director of CAPPA, Akinbode Oluwafemi, said: "The award of the Goldman Environmental Prize to Chima Williams serves as encouragement to individuals, groups, and communities even beyond the Niger Delta that are fighting environmental injustices. The environmental justice community hails this announcement.

"The recognition of Williams is a testament of his doggedness in the quest to hold corporations like Shell accountable for environmental recklessness that they think they can get away with."

A statement issued by the Goldman Environmental Foundation listed other winners to include Niwat Roykaew from Thailand; Marjan Minnessma of The Netherlands; Juliet Vincent, Australia; Nalleli Cobo, United States and Alex Luciatante and Alexandra Narvaez, Ecuador.

The Goldman prize was inaugurated in 1989 and awarded yearly to environmental justice activists from each of the world's six continental regions and had produced 213 winners, who had been so far honoured, including 95 women from 93 nations to date.

A Federal High Court sitting in Abuja on Friday denied the bail application of a former governor of Imo State and presidential aspirant of the All Progressives Congress (APC), Sen Rochas Okorocha.

Okorocha was arrested on Tuesday 24th May 2022, in a commando-style by operatives of the Economic and Financial Crimes Commission (EFCC) after laying siege on the ex-governor's Maitama home for several hours in a bid to produce him in court over allegations of fraud.

Okorocha, who represents Imo West Senatorial district at the red chamber, had filed an ex-parte application seeking release

on bail pending the determination of the suit he filed against the Federal Government. It was gathered that the former governor premised his application on his presidential

ambition under the APC. A statement by the Spokesperson of EFCC, Wilson Uwujaren, on Friday, said Justice Ekwo refused the bail application. He added that the Commission has filed a 17-count criminal charge against Okorocha with arraignment adjourned until May 30, 2022

He said, "The attempt by a former governor of Imo State, Senator Rochas Okorocha to force his release by the EFCC on Friday, 27 May 2022 failed as Justice Inyang Ekwo of the Federal High court, Abuja refused his

ex parte application asking to be released on bail pending the determination of a suit he filed against the Federal Government.

"Mr Okorocha who was arrested by the EFCC on Tuesday, May 24, 2022, premised his application on the grounds that his presidential ambition under the platform of the All Progressives Congress could be imperilled unless granted bail.

"But Justice Ekwo declined to compel the EFCC to release him on bail but ordered the applicant to put the Federal Government on notice to justify his continued detention.

"The EFCC has filed a 17-count criminal charge against Okorocha before the same judge, with arraignment adjourned until May 30, 2022."

At the sitting, counsel for the EFCC, S.O. Daji, who brought the motion for final forfeiture of the items, told the court that the EFCC had complied with the directive of

#### Anti-graft War: POCA to address architectural gaps, ICPC boss says

The Chairman of the Independent Corrupt Practices and Other Related Offences Commission (ICPC), Professor Bolaji Owasanoye (SAN) has stated that the recently passed Proceeds of Crime (Recovery and Management) Act (POCA) would help address the architectural gaps in the fight against corruption in the country.

Professor Owasanoye made this known during a one-day capacity building training for officers of the Commission on the POCA and Money Laundering (Prevention and Prohibition) Acts 2022 held at the Commission's headquarters.

The ICPC Chairman explained that the training was organised to keep the staff of the Commission abreast with two of the newly passed bills signed into law by President Muhammadu Buhari about two weeks ago.

According to him, corruption and other related offences such as money laundering and illicit financial flows undermine the stability of not only Nigeria but other countries, adding that in the quest to fight the menace of corruption, countries now engage in self-assessment, which considers several indices and reveals many things including vulnerabilities.

He further noted that since corruption is sophisticated, many countries have designed various mechanisms for dealing with unexplained wealth.

He said, "One of the examples that we have found that worked in other countries is civil recovery or civil forfeiture. Because corruption is a crime, the global standard was that you must prove beyond a reasonable doubt; whoever is alleging must prove beyond reasonable doubt and this can be very challenging, especially when you are dealing with intangible assets and timid capital.

"For the first time in Nigeria, we have the reversal of the burden of proof."

The Chairman implored all participants, particularly prosecutors, to take advantage of the innovations of the two new legislations as they carry out their work in fighting corruption in the country.

Four papers were presented on the topics, 'Introduction to the Proceeds of Crime (Recovery and Management) Act 2022 - Legal Procedures', 'Introduction to Proceeds of Crime (Recovery and Management) Act 2022 - Administrative Issues under the Act', 'Innovations Under the Introduction to Money Laundering (Prevention and Prohibition) Act 2022', and 'Quick Wins under the Introduction to Money Laundering (Prevention and Prohibition) Act 2022'.

The presenters were Yetunde Mosunmola, Olakunle Akinsola, John Paul Okwor, and Paul Okoko, all officers of the Commission.

Tendering exhibits to prove the same, he said, "My lord, after the publication, till now, no one has come forward to lay claim to the items."

He further told the court that investigation revealed that the owners used fake documents to import the items into the country.

"We urge your lordship to grant our application, which is brought pursuant to Section 17 Advance Fee Fraud and Other Fraud Related Offences Act 2006," he said.

Thereafter, Justice Dada granted the prayers and also ordered the final forfeiture of the items.

The items were also ordered to be sold and the proceeds remitted to the Consolidated Revenue Fund Account of the Federal Government.

### Court jails two internet fraudsters in Benin, one in Port Harcourt

The Benin Zonal Command of the Economic and Financial Crimes Commission (EFCC) on Thursday, May 26, 2022, secured the conviction of two internet fraudsters, Aigbe Joseph and Adefulire Abiodun before Justice Efe Ikponmwonba of Edo State High Court, Benin City.

Joseph and Abiodun were arraigned on one count each - fraudulently representing themselves in order to defraud unsuspecting victims.

The charge against Aigbe Joseph reads, "That you, Aigbe Joseph sometime between 2019 and 21st February 2022 in Benin City, Edo State within the jurisdiction of this Honourable Court did with intent to defraud represent yourself to be Jeannette Provencal, a lady based in the United States of America, thereby committed an offence contrary to and punishable under Section 484 of the Criminal code Law Cap 48 Laws of Bendel State of Nigeria (as applicable in Edo state) 1976".

The defendants pleaded guilty to the charges when they were arraigned prompting the prosecution counsel, A.A. Ozigbu asked the court to convict and sentence them accordingly.

However, counsel to the defendants, A.S. Adeshina and A.S. Akinfolarin pleaded with the court to temper justice with mercy as the defendants have become remorseful for

In a similar development, Justice A .T. Mohammed of the Federal High Court sitting in Port Harcourt, Rivers State, has convicted and sentenced Abiye Dokubo to two years imprisonment for impersonation.

A statement by the Spokesperson of EFCC, Wilson Uwujaren, on Thursday said Dokubo was convicted on May 19, 2022, on a one-count charge bordering on impersonation, upon his arraignment by the Port Harcourt Zonal Command of the EFCC.

The count-charge read, "That you Abiye Dokubo on or about the 10th of November, 2021 at Eagle Island, Port Harcourt within the jurisdiction of this Honorable Court fraudulently impersonated yourself to be one Nina Lambert via your Telegram account with the intent to gain advantage for vourself and thereby committed an offence contrary to Section 22 (2) (b) (1) of Cyber Crimes (Prohibition, Prevention, etc.) Act 2015 and punishable under Section 22 (2) of the same Act".

He pleaded guilty to the charge when it was read to him.

Following his plea, prosecution counsel, J .N. Dogonyaro prayed the court to convict and sentence the defendant accordingly.

Justice Mohammed convicted and sentenced the defendant to two years imprisonment, with an option of a fine of One Hundred Thousand Naira (N100, 000) payable into the Consolidated Revenue Fund Account of the Federal Republic of Nigeria.

In this interview with **OMONIYI ALLI**, the Ogun born actress opened up on her sojourn into acting, her opinion about the movie industry, and attraction to the opposite sex amongst others.

Acting for you, how did it all start? You know, when I left my paid employment work, I started acting gradually, and even before I left the job I always go on part-time stuff. I started with Laff patterns and everyday people. So when I left my paid job, it was very easy for me because I started it as a career. Coming into the industry is like coming into familiar terrain, because I know I have the talent for acting in me. So that is how I started gradually and to God be the glory I started growing in the industry from soap opera now I have done home videos. At a time, I was the assistant coordinator for the Actors Guild's of Nigeria (AGN) in Ogun State, and then later I joined the Association of Nigeria Theatre Arts Practitioners (ANTP). I started with Oga Bello, and then with Jide Kosoko, you know I started studying under so many people. After studying under these people I came out with my own film which is "Eewon Lafin-Itan Kokoro ede" shortly then it was taken to Italy, it was a big one, I was happy for that. I have done other jobs and equally lost counts on those I have featured in and the rest we say is history.

*How has the journey been so far?* The journey has been up and down. Not quite rough, and I would not say it has been so smooth, but gradually if you are ready to grow in it, you have to trick it gradually which is what I did, and which I am still doing, am still working on it, am still working gradually and taking it easy. But the journey so far has been wonderful and great; at least I have a good story to tell about it and am enjoying it and I thank God.

## As an actress what makes you unique?

I think God make me special, everything about me starts from God. Because every day I asked God for wisdom, knowledge and understanding, with that you can stand with any other person, so I think God created in me that uniqueness, and I also try to be unique in my own little way, to try to create things better than what I see. So creating what is better than the best of course will stand you out.

As someone who has been in the industry for a long time, what is your opinion generally about the Nigerian movie industry?



The Nigerian industry movie now I can say is growing very fast and can compete to some extent with other movie making countries of the world. Apart from the piracy issue that we are all faced with, which is affecting us terribly, I can say we are growing fast. You see that these days our people are producing good movies because gone are the days when we produce low standard film and it will be accepted by the people, even the cinemas will not take it. So at the moment, filmmakers are beginning to be creative with their storylines and entire production outlook so that they can fit

into any market. For me at the moment, I won't feature in a movie that cannot leave the shores of Nigeria to other parts of the world.

#### It is often time believed that sex for role is very much rampant in the industry, especially for females who want to become superstars overnight; how true is this?

Well, let me just put it as 50-50. From my own experience in the industry, I have never been asked out by any producer or director, or even co- artiste. Though, my co-artiste may just admire us. I have never been told specifically that because of this role I have to go out with you, and I don t think anybody has reported it to me, even though I know that once in a while it happens. But you see as you lay your bed so you lie on it. When you are focused and you know what you want to do in the industry you have come to the industry for a purpose, if you know the purpose of your coming to the industry and why you are there, nobody will say look if I don t sleep with you, you won't be a superstar. The truth is if you are good in your act; producers would be the ones chasing you for appearance in their movies. I know a lot of actresses that if they come for an audition you would not just let them go because they are good. You really have to ask yourself, are you really an actress? Because some

people just see the industry and feel that haa! Money is there oo, I am a beautiful girl, I want to be there, no! It doesn't work like that. While others who know they don't have the acting qualities; they force their self and by so doing they are inviting trouble at the end of the day the producer will want to sleep because they know that at the end of the day you are still useless and the scene you feel you have featured in won't make the final cut of the movie.

#### Any regrets so far?

No regret. Every day I am happy being an actress. In fact, do you know every day I thank God that I am in this industry? Because I couldn't have done anything better. This is an industry that has taken me to Paris, Italy, and London to mention but few.



he Nigeria senior men's football team have officially, on Thursday, opened its camp ahead of the international friendly matches with eleven times CONCACAF champions Mexico and 2007 gold medalist in the Pan American Games, Ecuador, in the United States.

Super Eagles head coach and his crew are already with the Nigerian team in the United States to play Mexico this Sunday, May 29, 2022, at the AT&T Stadium in Arlington, Texas.

The Nigeria national team whose brilliant start in the 2021 AFCON in Cameroon was marred with an abrupt exit from the continental tourney and a successive exit from the 2022 FIFA World Cup in Qatar after its archrival, Ghana, edged them out on goal aggregate, looks to reignite their footballing campaign ahead of the 2023 AFCON in



Cote d'Ivoire.

Nigerians are eager to see the fortunes of the team turnaround and surpass the 1994 team under the tutelage of Dutch tactician and most successful Super Eagles head coach, Clemens Westerhof.

Although the Nigerians are sceptical over what Jose Peseiro could achieve with the team, the Portuguese seek to win the fourth AFCON title for the Super Eagles using the friendly matches to put the team in shape ahead of the biennial continental competition.

Eventually, the Super Eagles, already in Dallas including Jose Peseiro, players and backroom staff, start their first training session on Thursday 6:00pm (Dallas, Texas time). Following the Mexico fixture, the Super Eagles will on June 3 tackle Ecuador in Red Bull Arena, New Jersey.
