arely days to the commencement presidential primary elections across parties, uncertainty has pervaded the polity's turf regarding which part of the country should present candidates that will fly the political groupings' flags in the in the 2023 presidential election.

There is tension as a result of comments by political and non- political actors over zoning of Nigeria's presidency particularly by the two leading parties, the ruling All Progressives Congress (APC) and the opposition Peoples Democratic Party (PDP).

In the past two months, the PDP has been worst hit by criticism on its failure make a categorical statement on where it is zoning its presidential ticket. The party succumbed to pressure by inaugurating a zoning committee led by Benue State governor, Samuel State governor, Samuel Ortom to guide it on how to handle the delicate and sensitive issue.

At the completion of its assignment, Ortom tĥat announced members committee unanimously agreed a decision which will be tabled before the NWC for implementation subject to ratification by the National Committee Executive (NEC). The open ended statement, however gave room for speculation that the PDP has thrown it's presidential ticket open.

Though Ortom frantically defended the committée's position of not being categorical about an open ticket, the party was left vulnerable

The issue of zoning has remained volatile as it has created a sharp division among PDP members aspiring to pick the party's presidential ticket. One after the other, Northern aspirants either denied knowledge zoning arrangement in the party or gave reasons why it should not be the yardstick selecting the PDP candidate.

Sokoto State governor, Tambuwal and Aminu former Senate President, Saraki made frantic efforts at different fora in the course of their consultations to convince stakeholders that the party should consider competence above zoning because of the peculiarity of the 2023 polls.

Tambuwal pleaded that PDP should adopt any other consideration outside zening outside zoning to ensure it wins the Presidency and then come to a round table to zone political offices.

governor, Bauchi Mohammed Bala specifically cautioned the party leadership that should the PDP miss the chance of clinching 2023 presidency, all stakeholders will remain in opposition while some may be forced to jump ship to the APC.

Former Vice President Atiku Abubakar who in the past has been an advocate of zoning turned round to query itsfeasibility as a yardstick.

Atiku said "Where the president comes from has never been the problem of Nigeria neither will it be the solution. There is no such thing as the president from Southern Nigeria or

president from Northern Nigeria. There is only one president for Nigeria, and by Nigeria."

Dr. Hayatudeen Mohammed even said he was not aware of any referendum for the Nigerian people to vote on zoning. He said "zoning is a matter of convenience for certain leaders and for parties to discuss and agree among themselves, it is not an imposition that everyone is bound to abide

by."
Senate Chief Whip Orji Uzor Kalu and Rivers State Governor, Nyesom Wike, accused northern presidential aspirants violating the party's principle of zoning and rotation of power by contesting. Wike blamed them for not honouring the gentleman's agreement subsisting in the PDP.

"The provision of our constitution is clear under Section 7, Sub-section 3C,l. It says there should be rotation of party offices elective founding fathers of the party know the complexity, they know the diversity of this country and they made sure that for equity, fairness and justice, this should be done," Wike said.

However, in line with previous resolutions of the PDP Governors Forum that power must go to the south in 2023, aspirants from the area demanded from the party a southern presidential ticket.

Peter Obi, Pius Anyim, am Ohuambuwa, Sam Nwachukwu Anakwenze all agreed that one of the Igbo aspirants must clinch the party's ticket.

With the understanding the ticket has been thrown open, 17 presidential aspirants paid N40 million each to obtain

On the other hand, the outcome of the March 26 national convention of the APC portends that the presidential ticket will go to the south since, Senator Abdullahi Adamu, northerner emerged as national chairman.

majority of contenders who declared interest and those that have obtained nomination forms so far are from the southern part of the country. This, it is believed, may win sympathy votes for the APC in the southern part of the country.

CSOs decry IPAC chairman's alleged stand on NDLEA drug test

ational Civil Society Coalition, a body of over thirty (30) Civil Society Organisations (CSOs) have demanded the suspension of the Chairman of Inter-Party Advisory Council (IPAC), Amb Ogar Osim, for allegedly rejecting the proposal for screening of all aspirants by the National Drug Law Enforcement Agency (NDLEA).

The IPAC chairman was said to have described the proposal by NDLEA as an awkward proposal.

Responding in a press statement signed by the convener, Martins Igwe, on Tuesday after an emergency meeting of the body held on Monday, the CSOs said that the IPAC chairman should be suspended within 14 days or come out to debunk his statement. The statement says, "On behalf of

National Civil Society Coalition for peace and security we call on the IPAC members to immediately suspend its chairman for rejecting the effort of the NDLEA to compliment the effort of our electoral body to bring peace and security in electoral process through test of the political aspirants for 2023 election testing of aspirant is not only timely but appropriate to guarantee peace during elections and certified candidates whose mental health in capable of the challenges ahead.

"In Nigeria, we are witness to a state legislator after election he left his position for no reason. A federal legislator has also been caught beating a woman in a shop. Is Jonathan qualified to run in 2023?

INTRODUCTION

Nigeria is a country of one major news item per day. The issue in the polity currently generating national ruckus, hoopla and bedlam is the presumed intention of Dr Goodluck Jonathan to run for the 2023 presidency. It does not matter that he has never confirmed to anyone, the rumour of his planned defection from his opposition PDP party under which he was once elected President, to the ruling APC party. They are prepared, as ever, to shave his hair in his absence.

I have carefully read the arguments of those who believe that Dr Goodluck Jonathan is disqualified from contesting the 2023 presidential election, because according to them, he had already done two terms and will thus be ineligible to contest for a third term. They cite the Fourth Alteration (No 16) Act, which was signed into an Act by President Muhammadu Buhari on the 11th of June, 2018. The section they are relying on is section 137(3) of the said Fourth Alteration to the 1999 Constitution, which provides that "a person who was sworn in to complete the term for which another person was elected as president shall not be elected to such office for more than a single term".

THE ANTAGONISTS ARE DEAD WRONG IN THEIR LEGAL POSTULA-

The truth of the matter is that the antagonists of Jonathan running in 2022, in their strange line of argument, are mainly relying on the above section 137(3). They have probably not adverted their minds to sections 141 of the Electoral Act, 2010, as amended, and section 285(13) of the same Fourth Alteration to the 1999 Constitution, as amended, which they are relying on. More revealing is that these antagonists are probably not aware of an extant and subsisting Court of Appeal decision where Jonathan was frontallly confronted and challenged before the 2015 presidential election, on the same ground of being ineligible to contest the said 2015 election, having allegedly been elected for two previous terms of office. The section 137(3) being relied upon by the antagonists was signed into law in 2018, three years after Jonathan had left office. Can he be caught in its web retrospectively? We shall see that anon.

The case in question is CYRIACUS NJOKU V GOODLUCK EBELE JONATHAN (2015) LPELR-244496 (CA). In that case, the Court of Appeal, Abuja Division, held that President Goodluck Jonathan had only taken the oath of office once and therefore upheld his eligibility to contest the then Nigeria's presidential election

slated for March 28, 2015.

The intermediate court held that the oath of office President Goodluck Jonathan took in 2010 was merely to complete the "unexpired tenure" of late President Umar Yar'Adua, who died while in office as President.

The appeal had been brought before the court by one Cyriacus Njoku, who was challenging the ruling of the High Court of Federal Capital Territory, Abuja, which on March 1, 2013, had dismissed the suit he filed to stop President Jonathan from contesting the 2015 polls.

In a lead judgement delivered by Justice Abubakar Yahaya, the full panel of the court unanimously held that President Jonathan had only spent one term in office as President, going by the provisions of the 1999 Constitution.

President Jonathan had been empowered as acting President on February 9, 2010, following a motion for operation of the "doctrine of necessity" by the Senate, owing to the protracted stay of late President Umaru Yar' Adua in Saudi Arabia on medical grounds.

When President Yar' Adua eventually died on May 5, 2010, Goodluck Jonathan was sworn in as president to serve the unexpired residue of office of Yar' Adua. Jonathan was later elected President in 2011 for the first time, on his own merit.

Mr. Njoku had contended that Jonathan had already sworn to the oath of office and allegiance twice and therefore, should be disqualified from contesting the 2015 election, as any victory he secured would amount to being sworn in thrice.

However, the court ruled that the oath that Jonathan took in 2010 was merely to complete the unexpired tenure of late Yar'Adua; adding that by virtue of Section 135 (2)(b) of the 1999 Constitution, Jonathan only took his first oath in May, 2011. The Court of Appeal further held that disqualification is through election, not oath taking.

The intermediate court's judgement read in part:

"In this appeal, it is not controverted by the appellant that the first oath taken by the first defendant (Jonathan) was the oath he took as the Vice President and not as President... But he took the oath in May 2010 to complete unexpired tenure of late Umaru Musa Yar' Adua. Section 37(1)(b) disqualifies a person from contesting for president if he had been elected twice. Disqualification is through election and not oath taking. Election is a process of choosing a person to occupy a position by voting. When election is given its literal meaning, it connotes when a voting is employed to choose a person for political office. This did not take place when Jonathan stepped into the shoes of his Principal who went to the great beyond. To say these things were done is to import words not used by the constitution. Section 146(1) of the constitution cannot be deemed an election for a VP to step into the office of a President.

Read Also: Mixed reactions as 'Goodluck Jonathan 2023 poster'

Election involves conducting primaries by party, nomination, election and announcement of results. All these processes were not done. If a VP succeeds a President that dies, that cannot be challenged. It is a mode of stepping into the vacant office provided for by the constitution. When a President dies, the Vice President automatically becomes President as provided for by S130 (1)(2) of the 1999 constitution... It was not election that produced the first respondent in May 2010, the oath he took then was not an oath of elected President as provided for by Section 180 of the constitution.

The process of election was followed in 2011. The oath of office taken in 2011 was the first oath taking by the first respondent as an elected President having fulfilled all the process of election.... Again, the succession

of a Vice-President to the office of a President who died, in accordance with Section 146(1) of the 1999 Constitution, cannot be "deemed an election", especially for the purpose of taking away a right that has been vested. As stated earlier, an election under the 1999 Constitution involves primaries, nominations, voting and declaration of results.

That is the mode prescribed in electing a President, and once it is so prescribed, it must be followed, and no other method can be employed. All these processes can be challenged in a Court of law and if successful, the election would be annulled. But if a Vice-President succeeds a President who died, that cannot be challenged because it is a Constitutional provision, and the succession cannot be annulled.

It is a mode of assumption to the office of the demised President, an 'appointment' by the Constitution, as it were, as no letter of appointment is necessary from anybody. The Vice-President automatically becomes the President, by virtue of his being the Vice-President. An example can be found in Section 130(1) and (2) of the 1999 Constitution." Per ABUBAKAR DATTI YAHAYA, JCA (Pp 40 – 41 Paras E – D)

The Court of Appeal further upheld the decision of the lower court which had dismissed Mr. Njoku's suit for lack of locus standi. It noted that "it is fundamental that where a party lacks locus, the court cannot assume jurisdiction....We agree with the lower court that the appellant has no locus to sue".

On the question of the cause of action, the court held that the case of the appellant was "speculative and imaginary as none of the reliefs he sought accrued to him any benefit".

Indeed, the Court of Appeal had awarded the sum of N50,000 each as cost to the defendant, President Jonathan.

RETROSPECTIVITY OF LEGISLA-TION

Aside Jonathan being completely cleansed of the virus of ineligibility to contest the 2023 presidential election by the Court of Appeal decision in Njoku's case, as Naaman the leper was, after dipping himself in the River Jordan seven times, Jonathan is also aided by the golden canon of interpretation to the effect that an enactment does not operate retrospectively or retroactively to take away from citizens enured rights.

We may now ask the question: What is the effect of Buhari signing into law section 137(3) of the Fourth Alteration to the 1999 Constitution in 2018? The answer is found in section 2 of the Interpretation Act which provides that:

t has been confirmed that former President Goodluck Jonathan has Ldecided to join the All Progressive Congress for the purpose of contesting the 2023 presidential election. However, the former President is disqualified from contesting the election by virtue of 137 (3) of the Constitution of the Federal Republic of Nigeria, 1999 as amended which provides as follows:


"A person who was sworn in to complete the term for which another person was elected as President shall not be elected to such office for more than a single term."

Some people have said that the amendment is not retrospective and therefore cannot apply to Dr. Jonathan. Assuming without conceding that the amendment is not retrospective it is submitted that under the current Constitution a President or Governor cannot spend more that 2 terms of 8 years. In other words, the Constitution will not allow anyone to be in office for more than a cumulative period of 8 years. In Marwa v. Nyako (2012) 6 NWLR (Pt.1296) 199 at 387 the Supreme Court stated that Section 180 (1) and (2)(a) of of 8 years.

the 1999 Constitution of the Federal Republic of Nigeria has prescribed a single term of 4 years and if a second term, another period of 4 years and not a day longer.

In the case of Gov. Ladoja v INEC (2008)40 WRN 1 the Supreme Court rejected the prayer of Governor Ladoja for 11 months' extension to cover the period he was kept out of office through illegal impeachment. The Supreme Court rejected the prayer on the ground that a Governor is entitled to spend a maximum period of 8 years or less and not more than 8 years.

It is not in dispute that Dr. Jonathan became the President of Nigeria in 2010 following the sudden death of President Umoru Yaradua. He later contested and won the 2011 presidential election. Having spent 5 years in office as President, Dr. Jonathan is disqualified from contesting the 2023 presidential election. The reason is that if he wins the election he will spend an additional term of 4 years. It means that he would spend a cumulative period of 9 years as President of Nigeria in utter breach of Section 137 of the Constitution which provides for a maximum two terms

"1. An Act is passed when the President assents to the Bill for the Act, whether or not the Act then comes into force;

2. Where no other provision is made as to the time when a particular enactment is to come into force, it shall, subject to the following subsection, came into force -

a. In the case of an enactment contained in an Act of the National Assembly, on the day when the Act

b.In any other case, on the day when the enactment is made".

It is therefore clear that section 137(3) of the Fourth Alteration to the Constitution took effect from 11th June, 2018, when President Muhammadu Buhari assented to it. Section 137(3) is subject to section 318(4) of the 1999 Constitution which provides that, "the Interpretation Act shall apply for the purposes of

interpreting (its) provisions".
Section 137(3) is one piece of legislation that can be termed retrospective or retroactive legislation.

On retrospectivity of legislation, the apex court, coram Justice Kekere-Ekun, J.S.C, held in the case of SPDC V. ANARO & ORS (2015) LPELR-24750(SC) at (Pp. 64 paras. B), thus:

"There is a general presumption against retrospective legislation. It is presumed that the legislature does not intend injustice or absurdity. Courts therefore lean against giving certain statutes retrospective operation. Generally, statutes are construed as operating only in cases or on facts, which come into existence after the statutes were passed unless a retrospective effect is clearly intended. It was held inter alia, in: Ojokolobo Vs Alamu (1987) 3 NWLR (Pt.61) 377 @ 402 F-H that it is a fundamental rule of Nigerian law that no statute shall be construed to have a retrospective operation unless such a construction appears very clearly in the terms of the Act or Law; or arises by necessary and distinct implication. See also: Udoh Vs O.H.M.B. (1993) 7 NWLR (Pt.304) 39 @ 149 F - G; Adegbenro Vs Akintola (1963) All NLR 305 @ 308." Similarly, in ALEWA V. SOKOTO

STATE INEC (2007) LPELR-8388(CA) (PP. 32 PARAS. A), the Court of Appeal, per Ariwoola JCA (as he then was), held thus:

"It is however settled law that, unless the law makers expressly state otherwise, a statute operates prospectively but not retrospectively. It is a cardinal principle of English Law that no statute shall be construed to have retrospective operation unless such a construction appears very clearly in the terms of the Act, or arises by necessary and distinct implications. The position is the same in this Country. İn Olaniyi vs. Aroyehun (1991) 5 NWLR (pt 194) 652, the Supreme Court held that:- "A construction like other statutes operates prospectively and not retrospectively, unless it is expressly provided to be otherwise. Such legislation affects only rights which came into existence after it has been passed." See also; Chief C. Odumegwu Ojukwu vs. Chief Olusegun Öbasanjo & Ors. (2004) 7 SCM 53 at 93, Afolabi & Ors. v. Governor of Oyo State (1985) 2 NWLR (pt 9) 734, Ojokolobo vs. Aremu (supra).

Hear my Lord Kekere-Ekun JCA, (as he then was) in ALEWA V. SOKOTO STATE INEC (2007) LPELR-8388(CA) (PP. 21-22 PARAS. D):

"There is a presumption that the legislature does not intend what is unjust. Thus, although under our legal system, the Legislature is competent to make retrospective laws, the Courts generally lean against giving a statute retrospective effect unless the terms of the statute so state in clear and unequivocal language. In Afolabi v. Governor of Oyo State (1985) 2 NWLR (9) 734 at 752 E, Aniagolu, JSC stated thus, "The Courts have always leaned against giving statutes a retrospective effect and usually regard them as applying to facts or matters which came into existence after the statutes were passed, unless it is clearly shown that a retrospective effect was intended by the Legislature." Underlining supplied. See alsoAdesanoye v. Adewole (supra) at 147 B-C & D-E; West v. Gwyne (1911) 2 CH 1; A.G. Federation v. A.N.P.P. (2003) 15 NWLR (844) 600 at 648 G -H; Sa'ad v. Nyame (2004) All FWLR (201)1678."

His Lordship Muhammad, J.S.C, in EGUNJOBI V. FRN (2012) LPELR-15537(SC), (PP. 34-35 PARAS. F),

"...It is trite law that the Courts frown at retrospective and retroactive legislations. Ojokolobo v. Alamu (1987) 3 NWLR (Pt.61) 377 at 34 406; Afolabi v. Governor of Oyo State (1985) 2 NWLR (Pt 9) 734. Although under Nigeria Law, there is a presumption against retrospectivity, where a retrospective operation is clearly spelt out, that legislation must not be declared incompetent; Adegbenro v. Akintola (1963) 2 SCNLR 216; Adeshina v. Lemonu (1965) 1 All NLR 233; The Swiss Air Transport Co. Ltd v. African Continental Bank Ltd (1971) 1 All NLR 37; Attorney General East Central State v. Ugwuh (1975) 5 SC 13...

Indeed, section 4(9) of the Constitution denies the NASS "in relation to any criminal offence", the power to "make any law which shall have retrospective effect". Though this section are if all a deals with priminal tion specifically deals with criminal offences, judicial decisions clearly show that it operates with equal force to civil matters.

Thus, the court held in the case of the ATTORNEY GENERAL OF THE FEDERATION V. ALL NIGERIAN PEOPLES PARTY (ANPP) & 2 ORS. (2003) 15 NWLR (Pt. 844) 600 @ pages 648-649, paras. E-B, that:

"A statute is deemed to be retrospective where it takes away any vested right acquired under existing laws or creates a new obligation or imposes a new duty or attaches a new disability in respect of transactions or considerations already past... Based on the presumption that a legislature does not intend what is unjust, the courts have always leaned against giving statutes a retrospective effect and usually regard them as applying to facts or matters which came into existence after the statutes were passed unless it is clearly shown that a retrospective effect was intended by the legislature. In the instant case the constitution came into being on 29th May, 1999 and all rights, liabilities and privileges as contemplated by the circumstance of the arose as of that day. Consequently, its provisions can only be read prospectively."

From Legislative Chambers to Government House: Lawmakers eyeing Governorship Seats

The Peoples Democratic Party (PDP) had last week screened 201 governorship aspirants while the All Progressives Congress (APC) and other political parties are still selling nomination forms and waiting for aspirants to be screened. Most of the aspirants are serving legislators in either of the two chambers of the National Assembly. Politics Editor, TUNDE JOSHUA examine intrigues in states where lawmakers are eyeing Governorship seats.

s politicians step up their games in preparation for the 2023 governorship election in states of the federation except in few states which have off-season elections, there have been alignment and re-alignment of positions across parties in search of gubernatorial candidates.

Some serving governors are obviously not having stiff opposition to their second term ambitions as they have control of their party structures. These include Ahmadu Fintiri of Adamawa, Abdullahi Sule of Nasarawa, Babagana Zulum of Borno, Babajide Sanwo-Olu of Lagos, Seyi Makinde of Oyo, Dapo Abiodun of Ogun, Gboyega Oyetola of Osun, and Abdulfatir Abdulrazaq of Kwara.

In what has become a norm in Nigerian polity, majority of the two term governors are jostling for seats in the Senate, thereby negotiating new positions for serving senators they want to replace. Governors of Taraba, Delta, Yobe, Plateau, Niger, Kaduna, Kano, Katsina, Kebbi, Jigawa, Benue, Enugu and Abia are believed to be nursing senatorial ambitions.

While a few other second term governors rather go for the most exalted office of the president. They are Nyesom Wike of Rivers, Emmanuel Udom of Akwa-Ibom, Dave Umahi of Ebonyi, Aminu Tambuwal of Sokoto, Bala Mohammed of Bauchi and lately, Ben Ayade of Cross River.

There is a believe that a few of these presidential aspirants might have secretly purchased senatorial nomination forms as back up but findings at the PDP headquarters proved this wrong as a staff in the office of the National Organising Secretary told The Trumpet that "such forms cannot be sold secretly now. How would they stand for two screening exercise. Are you telling me they will be screened as senatorial aspirants and then go to the presidential screening committee to be screened?"

When he was confronted with possibility of such happening in the past, he simply said "as far as records in the NOS office is concerned, there is no presidential aspirant that bought senatorial nomination forms".

Senators that have indicated interest in the governorship seats in their respective states include the chairman, Senate Committee on Appropriation, Barau Jibrin who is a leading contender for Kano State governorship ticket on the platform of APC. He has to contend with another ranking lawmaker, Alhassan Ado-Doguwa, the current Majority Leader of the House of Representatives, who is also eyeing Kano governorship seat.

Also in the Kano Guber race is Hon. Sha'aban Sharada representing Kano Municipal Constituency who an APC stalwart and a strong member of the Ibrahim Shekarau faction of the party in the state.

Senate Minority Leader, Enyinnaya Abaribe who has served as deputy governor of Abia State in the past is

gunning for the number one position in the state in 2023. He is believed to have gotten the blessing of Governor Okezie Ikpeazu who himself wants to come to the Senate.

However, Abaribe is battling opposition to his ambition on zoning issues. Abaribe come from the same senatorial district with the governor.

Another lawmaker, Honourable Benjamin Kalu, member representing Bende Federal Constituency of Abia State in the House of Representatives is also in the Abia governorship race.

Immediate past Deputy Senate President, Ike Ekweremadu wants to be the governor of Enugu State on the platform of the PDP.

Like Abaribe, Senator Ekweremadu, who is from Enugu West senatorial district has his gubernatorial ambition

being objected to by PDP stakeholders in the state on the ground that the Enugu State governorship ticket has been zoned out of Enugu West

He, however have insisted to forge ahead with his ambition while discarding the claimed zoning arrangement.

In Taraba State, former Senate Minority Whip, Emmanuel Bwacha who recently defected from the PDP to the APC is in the race. Though, he claimed that he was forced out of the PDP by alleged crisis in the party but it was obvious he defected to APC in search of governorship ticket when it dawned on him that Governor Darius Ishaku was not going to back him.

Senator Bassey Akpan, wants to be the next governor of Akwa Ibom State and has been screened by the PDP. He has Pastor Umo, the anointed candidate of

Governor Emmanuel Udom to contend with for the PDP ticket.

Two federal lawmakers, a senator and an House member are in the race to succeed Rt. Hon. Aminu Tambuwal as governor of Sokoto State in 2023.

Senator Ibrahim Gobir representing Sokoto East senatorial district is of the APC and Honourable Balarabe Salame,

member representing Illela/ Gwadabawa Federal Constituency of Sokoto State, are in the race.

Equally in Ebonyi State, two federal lawmakers are in the race. Chairman, Senate Committee on Youths and Sports, Senator Obinna Ogba representing Ebonyi Central and Honourable Anayo Edwin, member representing Ezza North/Ishielu Federal Constituency are willing to take over from Governor Dave Umahi.

Both want to explore the opportunity created by Umahi's defection from the PDP to APC.

Senator Ahmad Babba Kaita, representing Katsina North has never hidden his governorship aspiration in Katsina State but not on same page with the state governor, Aminu Masari and by extension, leadership of Katsina APC.

This might have informed his recent defection to the PDP to realize his governorship ambition.

In Oyo State, the two APC senator, Teslim Folarin representing Oyo Central and Abdulfatai Buhari representing Oyo North are said to be interested in the governorship race.

Folarin, who lost the APC ticket in 2019 to Bayo Adelabu seem to be the leading contender this time around. But he has his colleague, Buhari to contend with. Buhari has also took a shot at the party's ticket in the past.

In Adamawa State, Hon. Abdulrazak Namdas, member representing Jada/ Ganye/MayoBelwa/Toungo Federal Constituency is ready to test the waters with the incumbent governor, Ahmadu Fintiri. Both Namdas and the governor are political allies of former Vice President, Atiku Abubakar.

The aspiration of Senator Elias Abbo is yet to be confirmed as the youngest senator is said to be consulting.

Honourable Onofiok Luke, representing Etinan/ Nsit Ibom/ Nsit Ubium Federal Constituency who the current chairman of the House Committee on Federal Judiciary wants to run on the ticket of PDP, for the Akwa Ibom State

Another House member gunning for Akwa Ibom Government House is Hon Enyong Okon, representing Uyo/ Uruan/NsitAtai/Asutan/Ibesikpo Federal Constituency of Akwa Ibom;

A fourth term lawmaker in the House of Representatives, Hon. Herman Hembe, is in the race to has succeed Governor Samuel Ortom in Benue State, while

Honourable Farah Dagogo, member representing Degema/Bonny Federal Constituency in Rivers State is also eyeing the Rivers State governorship seat.

PDP disowns man who poses as Delta State Chairman to defraud aspirants

"The general public and particularly PDP aspirants are, by this notice, advised that the caller who is making the calls with telephone number 07035036524 is not the State Chairman of our party and the criminal caller is neither connected to him nor operating on his behalf.

'This statement, therefore, dissociates Olorogun, Barr. Kingsley Esiso, the Delta State PDP Chairman from the activities of this impersonator completely and urges the general public, especially our aspirants, to henceforth disregard any form of interaction with any caller with the number 07035036524 and warns that anyone who deals with this caller, will be doing so at their own peril," he said.

He urged the general public to be wary of such calls, urging the public to 'report any further calls from the said number to the nearest security agency'.

EFCC grills AGF's aides over alleged sales of Presidential pardon

Some senior officials of the Ministry of Justice and aides of the Attorney General of the Federation (AGF) have been quizzed by the Economic and Financial Crimes Commission (EFCC) over suspicion of corruption in the compilation of the presidential pardon

President Muhammadu Buhari controversially pardoned former governors, Joshua Dariye and Jolly Nyame, who are serving jail terms for corruption, after getting the nod of the Council of State on April 15, 2022.

The council is made up of the president, vice-president, former heads of state, former chief justices, senate president, speaker, governors and the attorney-general of the federation (AGF).

Based on the recommendation of the presidential prerogative of mercy committee, Buhari submitted names of 162 persons to the council for advice on state pardon.

There has been widespread criticism of the pardon and the full list of those pardoned is still being kept under wraps, although many convicted coup plotters made it.

Some sources at the ministry of justice said that several aides of Abubakar Malami, the Attorney General of the Federation (AGF), who were responsible for the processing of the list are currently being investigated by the anti-graft agency.

One of the sources said, "Of particular surprise is the inclusion of Atuche on the list that was submitted to the Council of State.

"There are several names that raised suspicion and the EFCC had to be called in to investigate what went down."

Atuche was, in June 2021, convicted of N25.7 billion fraud and sentenced to 12 years imprisonment to run concurrently for six years.

When the name was presented to the council, it was rejected, supposedly because he had just been convicted and was yet to serve one full year.

Dariye and Nyame were both jailed in 2018.

They are yet to be released from the prison weeks after the pardon,

reportedly because of bureaucratic bottlenecks.

"Mrs Leticia Ayoola-Daniels, director of the administration of criminal justice and reforms department under the justice ministry, is also being quizzed by the EFCC," another source said.

Those invited have been subjected

to lie detector tests "and many of them are failing".

Some of those quizzed attributed their failure to pass the test to "high blood pressure".

There is yet no scientific proof linking blood pressure to effectiveness of lie detector test.

Alaafin Oba Lamidi Adeyemi 111 (1938-2022)

2022, Nigerians and the rest of the world woke up to the sad news that Alaafin of Oyo, Oba Lamidi Olayiwola Adeyemi 111, danced into the night of his long royal life by joining his ancestors while receiving treatment at the Afe Babalola University Teaching Hospital, Ado Ekiti. He was the third from the Alowolodu Ruling House, the other being Agunloye of the two ruling houses recognised by Oyo tradition and the law of the Federal Republic of Nigeria. Always richly bedecked in traditional Yoruba attire, surrounded by most of his beautiful and adorable 'Ayabas' (wives), Oba Lamidi held the traditions and moral values of his people in a most colourful manner. Indeed his sartorial elegance equally matched by his Ayabas' was a cultural beauty to behold at public events and any time he travelled from the shores of Nigeria.

Apart from being the most historically prominent of all Yoruba monarchs, reasons abound why Oba Adeyemi's memory and legacy will remain etched in the sands of time. As the foremost iconic aesthete of Oyo kingdom, he lived, practised and advocated the beauty of cultural nuances in all interactions. From the political angle he was one of the nationalistic royal fathers whose voice was respected and honoured in Nigeria's political circles. Although he strongly upheld the idea of Yoruba nation and state policing, he never called for splitting the federation. For about eight years Oba Lamidi privately paid vigilante groups to guard farms and villages from Oke-Ogun down to Oyo town. This was part of the metamorphosis of Amotekun as acknowledged by the Oyo State Government which made him the Grand Patron. He believed in community policing as the most effective means of local security. The Amotekun experiment has proved that local policing can co-exist with the national security systems. Unlike many of his peers,

n Saturday 23rd of April, | Adeyemi placed ethics and virtue over money | before his death. With his personal wealth in giving chieftaincy titles of the land to deserving citizens. He was Chancellor to Uthman Dan Fodio University, Sokoto for three chequered tenures. When the grand monarch passed on, he was serving as the Chancellor of the University of Maiduguri.

On the social sphere, Oba Adeyemi was a unifying factor between the royal families, embracing all members of the royal household irrespective of being Alowolodu or Agunloye. He made peace with other kings thereby downplaying battles of supremacy. His marriage to non-Yoruba in his expansive polygamous harem shows his appreciation of cultural diversity. Adeyemi was widely reported to play fatherly and husband roles to all his wives who he established well



he settled a very long list of known and unknown people's educational bills till he died. He patronized local medical services as evident in where he passed on. Furthermore, Adeyemi was passionate about religious harmony, making the palace a confluence where all religions merged for the progress of the kingdom. Traditionalists, Christians and Muslims all co-existed in worship in the various shrines in his palace.

The late monarch's major frustration was that Nigeria has never had the kind of leadership that thought more about the people; a leadership that is able to understand the complexity of the nation. While alive he often recalled that in 1914 when the amalgamation document was signed by his predecessor Alaafin Siyanbola Ladigbolu, the king lamented that what the British colonialists were trying to do was bringing predators and preys together and seriously warned against the consequences. But he then thought that if the leaders and managers of affairs were prudent enough, they might be able to manage the contraption. Alaafin wanted the Yoruba to play their leadership roles as exemplars and Omoluwabi as a model to others.

Oba Adeyemi was 83 years old and the longest reigning Alaafin ever, having ruled for more than 51 years. In general, he will be missed for his candour, his great intellect, his retentive memory, his ability to represent the true Yoruba person in the way he dressed, the way he danced, the way he moved, his courage, his versatility, his generosity, his love for family, and his love for youngsters' education. We sincerely condole with the people of Oyo and Nigerians over the loss of this great nationalist. While we say 'adieu' to the great king, we wish the Oyomesi the very best in selecting the next Alaafin.

Oba Adeyemi has since been interred according to Muslim rites and the tradition of Oyo, leaving the Oyomesi in control of the monarchy until another king is crowned.

t is disturbing that some top politicians, Lobvious selfish reasons, are trying to jettison the much- desired rotation of the Presidency between the north and the south. Since the advent of democracy in 1999, it has been an acceptable political tradition. Though it is not expressly written in our constitution, it has become a convention, just like the unwritten British constitution. At the end of his tour of duty, the position again went back to the north. And the current incumbent President Muhammadu Buhari, took over.

This beautiful narrative is what the two major political parties, APC and PDP, are trying to change in 2023. The problem actually

emanated from the latter, the main opposition party. . It set up a committee, headed by the governor of Benue State, Samuel Ortom, to work out its zoning formula. After allocating all the key offices, it dubiously left out that of the president. To be fair to the APC , they kept their promise . All their presidential aspirants were from the south. All that is about to change because of the dishonorable and divisive role that PDP

is playing. It is pertinent to sound a note of warning that retaining the Presidency in the north will have catastrophic consequences for this country. The leader of Afenifere, the umbrella sociocultural group of the Yoruba, Pa Ayo Adebajo, said that the return of the Presidency to the north in 2023 may lead to the disintegration of the country. A similar view was also expressed by Chief E.K Clark who is the leader of the Pan- Niger Delta Forum , PANDEF. He said: " it will be calamitous if the major political parties should zone their presidential tickets to the north ". The Ohanaeze and Middle Belt Forum, the sociocultural and political umbrella groups of the Igbos

. have also seriously opposed the position of the Northern Elders Forum, NEF, that the race for the 2023 presidency should be thrown open for the north to participate.

Interestingly , the four Southwest, zones-- the South-South Southeast, and North Central-- have vowed to work against any party that fields a northern presidential candidate.

The unity of Nigeria has never been so threatened as it is now. That is the more reason the politicians must be careful in taking decisions that would further weaken our bonds of unity. There have been strident complaints over the years in the South and the Middle Belt about the Hausa/Fulani domination of the country. It has even degenerated to an abysmal level that Nnamdi Kanu, an Igbo activist, and Sunday Igboho, a Yoruba irredentist, have, respectively, spearheading the agitation for the secession of their ethnic groups from Nigeria.

That the fate of Nigeria, as a united entity, is hanging precariously on the balance, should be of serious concern to us all.

We should not forget that the National Intelligence Council of the United States predicted on March 5, 2005, that Nigeria would breakup in 2015. President Obasanjo took it very seriously. He therefore, sent the document and Middle Belt respectively to the Senate to study and

to serve as a guide in its operations. Although John Campbell , a former US ambassador to Nigeria, who was a part of the prediction later exonerated his country, we should only thank God for our resilience. That Nigeria survived 2015 is not enough reason to totally discountenance the factors threatening our unity

Only recently, another release by the United States Council on Foreign Relations and Harvard Kennedy School painted a very gloomy picture of Nigeria. It said that Nigeria is now a failed state. The organization said that their conclusion was not based on emotion ,but on " a body of political theories developed at the turn of the century and elaborated upon, case by case, ever since ".

In the paper signed by its Senior Research Fellow and former ambassador to Nigeria, John Campbell and Robert Rotberg, a founding Director of the Harvard Kennedy School and President Emeritus of Word Peace Foundation, it was stated that "Nigeria has long teetered on the precipice of failure. But now, it is unable to keep its citizens safe and secure. Nigeria has become a fully failed state of critical geographical concern".

These are very wrong signals that all discernable and patriotic Nigerians should be worried about. It is very disheartening that most Nigerian politicians are only interested in what they can loot from our common patrimony. They are not bothered about the survival of the ecountry as a united entity.

The 2023 presidential election will serve as the litmus test. The rotation of the office of the president between the north and the south must be held sacrosanct. It should not be unduly politicized. If we do, we will unwittingly give credence to the doomsday predictions of the breaking up of Nigeria.

Buhari assures families of train attack victims' safe return

■ Tasks military, NRC on rescue mission coordination

resident Muhammadu Buhari has stated that the terrorists who attacked the Abuja-Kaduna train on March , 2022, are using their captives as shields from military bombardments.

The President made the claims on Monday when he hosted some FCT residents at State House on Sallah homage, adding that the terrorists do not care if their hostages are killed during rescue mission. Noting that the situation requires wisdom, caution and patience.

A statement by the Special Adviser to the President on Media and Publicity, Femi Adesina, further indicated that Buhari assured families that efforts are ongoing to ensure the return of all captives alive and unhurt while ordering the management of Nigeria Railway Corporation (NRC) to create situation room for the coordination of hostages safe return.

According to the statement, the President said bandits and terrorists, unlike professional soldiers, don't respect the rules of engagement and could resort to harming hostages when attacked.

Buhari said, "As we celebrate this occasion with joy amidst friends and family members, we are fully conscious of the fact that many families in our country are in a state of fear and anxiety on account of the many captives held by terrorists against their will, including those taken away after the tragic bombing of the Abuia - Kaduna train.

"I have directed security agencies to ensure quick and safe recovery of all victims of kidnapping. I urge the railway management to immediately set up a situation room for the coordination of the rescue mission and for a minute by minute engagement with the families of the captives.

"This should ease their pain and anxiety as we push the military to finding a safe return to their families. My aim is to see all those in captivity safely rescued.

"Let me assure Nigerians that the bandits are just pushing their luck, but this is only for a while before they are finally crushed. They are using civilians as human shields, thereby making it difficult to confront them directly," he said.

"They don't care about killing their hostages if they come under attack. It's a delicate situation that requires wisdom, caution and also patience. Any rescue operation that results in the death of any hostage cannot be deemed a success.

"The government doesn't want this kind of tragic outcome. It's a complex

situation that demands proper handling. The primary objective of any rescue operation is to free the hostages safely, unharmed and alive.

"Let me make it clear, however, that defeating the terrorists and bandits requires more than weapons; we also need human intelligence which is necessary to frustrate terrorist plans. The people and community leaders should help our security officials with information about the activities or movements of criminal groups."

Buhari urged Nigerians to create a hostile environment for criminals hiding in communities.

He added, "By protecting criminals from exposure, you are endangering your own security and the security of your own community. No criminal can thrive in an environment where he faces the risks of exposure by the people.

"This administration has allocated huge resources to improve the capacity of our security forces by timely giving them adequate equipment and improving the welfare of personnel to boost their morale.

"Abuja has witnessed remarkable improvements in terms of security. In the past terrorists had made it almost impossible to conduct our normal lives. Road barricades had overrun the capital city and people had to pray in

fear because of the anxiety of terrorist attacks. No place in FCT was beyond the terrorist. Not the United Nations building, nor the Police Headquarters.

"But today, the situation is no longer so. We have significantly weakened and crippled the capabilities of the Boko Haram terrorists so much that they no longer have the ability to seize, and occupy any Nigerian territory without being repelled by our gallant troops

"Of course, we can't say that the terrorists are one hundred percent destroyed, but we have destroyed their ability to seize our territory. This improvement in terms of significantly weakening the enemy is necessary for finally defeating them. The rate at which the terrorists are

giving up their weapons and surrendering to our troops is a significant and welcome development."

The President commended the FCT Minister, Mohammed Musa Bello for diligently ensuring the capital city stays safe and attractive, while thanking the FCT residents for visiting the Presidential Villa.

"It's my pleasure to welcome you all to the presidential villa. As is the tradition, people pay homage to the President as part of the events to mark the Sallah celebration.

"I value these kinds of visits because they afford me the opportunity to interact directly with the people or their representatives. I commend the FCT residents for living in peace and harmony for years since the capital officially came into being," the President said.

Battle against terrorists nearing end, President affirms

President Muhammadu

saying that normalcy is
gradually returning to the
northeastern part of the
country.

The President said this while giving a security appraisal in a message he sent to Muslims to mark Eid, stating that as the Holy month of Ramadan reaches its end, so the end to terrorism approaches.

According to a statement by his Senior Special Assistant on Media and Publicity, Garba Shehu, the challenges of banditry and kidnapping are being tackled differently in the North-western and North Central states. Buhari said, "After a period of fasting and reflection, this year, we have cause to welcome the occasion in hope. The battle waged against terrorists who falsely masquerade under the name of Islam is approaching its conclusion."

"The fight has been long and hard. Final victory is within sight. Boko Haram and its offshoots' final embers are now fading.

"Last month, the leader of ISWAP was killed in an airstrike. Since the New Year, thousands of fighters have surrendered to enter rehabilitation programmes. The territories they used to occupy are now seeing the return of those who were forced to flee their barbarity. Normality is finally beginning to return to the Northeast. It is a long process. Yet it is one we are, together, now embarking

"With the designation of bandit groups as terrorists, the challenges of banditry and kidnapping are being tackled differently in the Northwestern and North Central states where the latest military acquisitions and the Armed Forces are being fanned out across the region to thwart acts of terror.

"The administration is equally getting impressive reports of the special operations to curb crude oil theft and illegal oil bunkering in the South-South, with millions of illegally refined products being impounded and illegal refineries destroyed.

"While we are making progress cleaning the environment, some evil people are busy causing more pollution and destruction.

"In response to the disturbing rise in criminal attacks targeting law

enforcement and public facilities in the South East, concerted military operations to rid the region of Indigenous People of Biafra (IPOB) and Eastern Security Network (ESN) elements have, in recent weeks, led to the overrunning of IPOB/ESN bases, the seizure of weapons and the arrest of a large number of suspects."

The President approved the establishment of a Naval Base in Oguta, Imo State.

"The reinvigoration of the war against drug abuse and illicit drug trafficking is also showing positive results as shown by the arrest of over 12,300 offenders including seven drug barons; the conviction of 1,400, counseling and rehabilitation of about 8,000 drug users.

"The seizure of over 3.4 million kilograms of drugs and cash worth over N130 billion, all in 2021 has been

recorded while the first Quarter of this year has seen the arrest of no fewer than 3,536 offenders including security personnel and a well-known billionaire drug baron. The seizure of more than 65,000 tons of assorted drugs in this period sets a record for the nation."

It is with a view to giving impetus to the concerned agency that President Buhari granted approvals for the promotion of more than 3,500 officers, the procurement of operational equipment, training for personnel and buildings for residential barracks.

The President also directed increased coordination and cooperation among security agencies, saying that an end has been brought to a silo approach among the agencies, assuring that there will be no shortage of funds to provide security for the citizens.

Politics of Delta State N150b loan and its implications

espite attempts by the Delta State Government to explain its decision to obtain a N150 billion loan just about a year to the expiration of its tenure, which was approved by Speaker of the state House of Assembly, Hon. Sheriff Oborevwori, as requested by Governor Ifeanyi Okowa recently, tempers are high that the state government must have some ulterior motives for obtaining the facility.

The state government gave reasons for requesting the loan, which Okowa sent to the House of Assembly, as the lawmakers allayed fears that the money was being sought to prosecute the 2023 elections, but opposition elements are not convinced that the loan will be deployed to the projects the state government claimed it was meant for, insisting that the loan was meant to prosecute the 2023 governorship poll.

2023 governorship poll.
Chairman of Okowa's College of
Commissioners and Commissioner
for Finance, Fidelis Tilije and Commissioner for Information, Charles
Aniagwu, outlined the motives
for the loan, which they said, will
be granted by Zenith Bank Plc.

They explained that the Okowa administration was encouraged to seek approval for the loan against the backdrop of expected statutory accruals from the Federation Account as part of the 13 per cent derivation fund from oil producing states of the country.

Tilije said following agreement with the Federal Government on the refund for years of wrongful deduction of funds belonging to benefitting oil producing states, Delta is due for two tranches of N257.6 billion and over N130 billion in the next five or six years.

Therefore, to avert the likely depreciation of the value of the expected funds from the Federal Government in the light of the steadily rising rate of inflation, the state government decided for the N150 billion loan to enable it to further lighten the huge debt burden inherited by the Okowa administration.

He explained that the N270.6 billion ought to have been received long before now, but because the Federal Government could not pay the total money in bulk, the oil producing states reached an agreement for some part of the funds to be paid within three years, while the other part should be paid in five years.

paid in five years.

He said: "Having reduced the debt profile of the state from N151 billion to N72 billion, it is important that we have so many other contracts that we have awarded within the period of time and because it is a close out of a particular tenure, it became very important that we ensure those legacy projects, including the new state secretariat building are completely paid for before we leave office.

"Apart from the fact that we are paying old contractors, we are also ensuring that even the new contracts that we awarded, which we refer to as legacy projects, are also completed on time. The

governor is also very mindful of the fact that pensioners are suffering. When we came into office in 2015, the total pensions past dues was N35 billion and we have been trying to reduce that outstanding dues. The state government approved N300 million monthly to be paid as past outstanding and just recently it was increased to N500 million monthly.

"To further reduce the past pension obligations from the facility, we will be spending N20 billion for state pensions outstanding of past dues and N10 billion to the Bureau of Local Governments as grant to enable it to also reduce outstanding payments to pensioners at the local level."

Tilije also explained that the bridging loan would be used to offset debts owed many contractors with certificates for various completed projects, especially the legacy projects of the Okowa administration, including the State Secretariat Complex, Asaba, Orere River Bridge, the Ode-Itsekiri Bridge, the Coker Junction Asaba Flyover and interchange, Bridge across River Ethiope at Obiaruku, Owa-Alero drainage channels and projects being executed in the three new universities.

Also captured is the completion of the Asaba-Ughelli dual-carriage way from Ogwashi-Uku, Kwale, Isoko to Ughelli from Asaba. About N50 billion of the loan would also be deployed to the payment of entitlements of pensioners as well as further assist the Bureau of Local Government.

He further stated that part of the loan would also be used to fund the Warri/Effurun drainage project, explaining that the facility was of soft nature because it was being offered on the strength of the accumulated derivation fund wrongfully withheld from the state and other benefitting states.

Deputy President of the Senate, Ovie Omo-Agege and the state chapter of the All Progressives Congress (APC) also criticized the move. They expressed concern that the loan was not tied to any specific development project thoughtfully conceived and executed in the best interest of Delta people. Responding to the development, Executive Assistant to the Deputy President of the Senate, Aruviere Martin Egharhevwa in a statement said: "Responsible public finance management demands clarity on the funding of budgets. This is a key consideration in awarding contracts for infrastructure and general developmental projects. Given Delta's distinct comparative financial advantage compared to many states of the Federation on account of its huge monthly oil derivation funds, Delta people deserve to know the compelling justification to hastily borrow a whooping N150 billion under the pretext of paying for contracts that the Okowa administration regularly claims it duly awarded, with funding guarantees. Strikingly, the so-called projects are all unknown to the public.

"Further, why is the Okowa administration borrowing hastily against anticipated petroleum subsidy payment and refund with indeterminate crystalisation time? Are they not wetting the

ground for the next administration to contend with huge debts unnecessarily? Knowing that the repayment funds may not even crystalise till may be 2027/2028, why is the regime doing this? As suggested by some commentators, is the N150 billion a 2023 'election war chest'? If true, we can only advise a rethink because it will fail with serious consequences.

He said after about seven years of neglecting the all settling of pension commitments to retirees in the state, Okowa now suddenly wishes to pay them from the loan, because they are entitled to their pensions, they deserve to and must be paid their pensions anyhow.

"However, the state government's choice to pay them from an unusual source and close to the 2023 general elections is not lost on discerning minds, including our seniors. Whatever the intentions are, they will be clinically shut down at the right time.

"While we recognise that borrowing is sometimes necessary in public finance management, especially in relation to mega infrastructure development, we also believe such borrowing must be responsible, and not recklessly propelled by corruption and primitive private interests. It should not be all about sinking many generations into intractable debts in the hope of achieving impossible electoral postulations," he added.

He alleged that the N150 billion loan approved by the House of Assembly was an escalation of a corrupt pattern of reckless borrowing by the Okowa administration to fund mystery projects or what Delta people now generally refer to as 'audio' or invisible projects.

"We strongly advise and warn them to think twice about this socalled loan. It looks too corrupt in appearance and character to be ignored. It will create too many problems for them. A word is enough for the wise," he said.

Also, the state chapter of APC disagreed with Okowa for obtaining the N150 billion loan barely a year to the end of his tenure.

In spite of attempts to explain the motives of the loan, the APC lampooned the state government for obtaining what it called "yet another humongous loan," saying: "Okowa wants to spend what will accrue to Delta in the next five years within the last one year of his mistake of a 'one chance' administration!"

A statement signed by the party's state Publicity Secretary, E. V. Onojeghuo, and made available to journalists in Asaba, said the N150 billion, a facility to be managed by Zenith Bank aimed at securing the loan.

at securing the loan.

This, of course, was against the "expected inflow from the Federation Account from petroleum subsidy payments made without recourse to the 13 per cent derivation due to oil producing states from January 1999 to November 30, 2021.

"Okowa went further to present a most unlawful excuse for obtaining the facility to the legislature, claiming that the state's ability to deliver the legacy projects of his administration is limited by the fact that the expected total refund will not be received into the state's account in one lump sum, but will be refunded over a period of five years on a quarterly basis with effect from April, 2022 to January, 2027," the statement reads.

But those who spoke in favour of the state government's move argued that Omo-Agege and his APC ilk have no basis to criticise the Okowa administration for its decision to go for the loan, maintaining that it was for the overall interest and development of the state.

A Lagos-based public affairs analyst, Barrister Okotiebo Omoviro, argued that the APC-led administration at the federal level had borrowed trillions of naira to fund railway and other phantom projects that have yielded little or no result in the past seven years of the President Muhammadu Buhari administration.

"Therefore, if the Okowa administration decided to borrow N150 billion to further develop infrastructure and drive development with a view to delivering more dividends of democracy in Delta before he leaves office next year, so be it. The onus only falls on the people of Delta State to monitor the projects being outlined and hold the Okowa

NCDMB creates \$40m fund for women in oil and gas sector

The Nigerian Content Development and Management Board (NCDMB) has created a \$40 million fund specifically to enable more female participation in the Nigerian oil and gas sector.

Executive Secretary of the board, Simbi Kesiye Wabote, stated this at the board's Annual General Meeting (AGM) of the Oil and Gas Trainers Association of Nigeria (OGTAN) in Abuja.

Speaking on the theme: Diversity And Inclusiveness In Human Capital Development For The Energy Sector, Wabote noted that unavailability of funds remained one of the key challenges that often hinder the participation of women in the oil and gas sector activities.

He said the board had addressed

the issue through the Nigerian Content Intervention Fund (NCIF), adding: "To provide a fair chance for women in the oil and gas industry, the board is partnering with Nigeria Export and Import Bank (NEXIM) to establish a \$20 million fund that matched with an additional \$20 million fund by NEXIM bank, making the total pool of funds available to women in oil and gas to be \$40 million."

He explained that his board and its partners have introduced and implemented several initiatives that promote diversity in the oil and gas industry. Some of those gender focused intervention were being implemented in partnership with the Bank of Industry (BOI), while others were facilitated by the Nigerian Export-Import Bank.

Wabote said another step taken

c by his board to drive diversity in the oil and gas activities was the setting up of the Diversity Sector Group in the Nigerian Content Consultative Forum (NCCF), adding that the board has also organised events targeted at women and community activities to promote inclusiveness.

"NCDMB efforts to lead the women folk into the mainstream of the Nigerian oil and gas industry was recognised at the fifth Nigerian International Energy Summit this year when the agency was awarded the best gender support company in the energy sector," he said.

He assured the audience that the NCDMB would continue to encourage female members of staff to occupy key positions in preparation for higher leadership roles and continue to promote human capacity development across various spheres of the energy sector, including skills development and entrepreneurship programmes to ensure development in secondary and tertiary institutions to prepare the youths for the future.

He affirmed that NCDMB's Human Capacity development model was not gender-based and that it was inclusive and provides equal opportunities for all applicants and beneficiaries.

On youth development, Wabote said the NCDMB has initiated the 60-20-20 training model in which 60 per cent of the training resources provided for young Nigerians with specialised skills to secure employment, while the women get 20 per cent and the remaining 20 per cent are reserved for other interested applicants.

Over 20 PFAs meet PenCom's N5 billion recapitalisation deadline

No fewer than 20 Pension Fund Administrators (PFAs) have met the National Pension Commission's (PenCom) deadline to increase their minimum regulation capital and shareholders fund from N1 billion to N5 billion as of April 27, 2022.

The Trumpet recalled that 2021, PenCom approved recapitalisation for PFAs, with a 12 month transition from April

In a statement issued by the commission, it declared that the recapitalisation was expedient, as the value of pension fund assets under their management and custody had grown exponentially.

"The assets had grown by 244 per cent from N3 trillion in 2012 when the previous recapitalisation was done to N12.29 trillion as of December 31, 2020. The sustained growth in assets implies greater fiduciary responsibilities that require more operational capacity by the PFAs," it stated.

There was also an urgent need to boost the PFAs capacity to manage the increasing number of registered contributors and value of pension fund assets in their custody.

PenCom explained that 10 PFAs had met the new regulatory capital requirement of N5 billion as of December 31, 2021 while the others intensified efforts to meet the April 27, 2022 deadline.

The commission stated that the exercise resulted in some mergers and acquisitions, which led to the reduction of the number of PFAs from 22 to 20.

The commission approved the acquisition of AIICO Pension Managers Limited and the merger between Tangerine Pension Limited and APT Pension Funds Managers

It also approved change of name of the merged entities to Tangerine APT Pension Limited. In addition, the commission approved Norvenberger's acquisition of IEI-Anchor Pension Managers Limited after acquiring majority

shareholding.
"With the conclusion of the recapitalisation, particularly Retirement Savings Account (RSA) holders should expect increased effectiveness and efficiency, as well as improved service delivery from PFAs," it added.

Access Holdings Plc profit hits N57b in Q1 2022

Access Holdings Plc has released its financial results, which reveals that the top tier lender recorded a profit of N57.40 billion in the first quarter (Q1) of 2022 translating to a 9.23 per cent increase year-on- year.

The group also reported earnings per share of N1.63 or 9.46 per cent growth from the N1.49 billion earning in Q1 of 2022.

Access Bank Plc has grown its Q1 of 2022 profits by 16 per cent in four years since hitting N22 billion in Q1 of 2018 and the profit reaching N57.40 billion.

The result also showed that in Q1 of 2022, net interest income declined by 7.03 per cent from N93.96 billion to N87.36 billion within the period.

Access Holdings profit performance is on the back of margin growth, as income from interest foreign exchange gains, fees and commissions income appreciated vear-on-vear.

The financial institution earned

N 170.32 billion from its lending business as interest income grew by 27.27 per cent from N126.07 billion, while the group's e-business income raked in N20.13 billion representing 12.36 per cent from N17.92 billion in 2021.

This suggests that the bank has improved its use of e-banking channels in the delivery of financial services to its customers, even as credit related fees and commissions stood at N21.15 billion during the period.

In addition, the group grew its deposit from customers by 7.9 per cent to N7.49 trillion, while its total assets have increased to N12.08 trillion and net assets rose by 4.77 per cent to N1.08 trillion.

Access Holdings Plc last traded at N9.85 per share and its market capitalisation as of Wednesday, April 28, 2022 year-to-date performance showed that the company's share price appreciated by 5.91 per cent.

MAN tasks FG on implementation of AfCFTA

The Manufacturers Association of Nigeria (MAN) has urged the Federal Government to urgently commence the implementation of the African Continental Free Trade Area (AfCFTA) to support its industrialisation agenda and for robust competitiveness.

President of MAN, Mansur Ahmed, made the appeal recently at the Business Luncheon of the Apapa Branch Council of MAN in Lagos with the theme: Improving Nigeria's Manufacturers' Competitiveness Within The Context Of AfCFTA's Implementation.

Ahmed, who was represented by the Chairman of Ikeja branch, Robert Ugboaja, said the call became necessaryt because the country was not competitive enough to fully maximise and harness the benefits of the AfCFTA.

He said the country's manufacturing sector was beset with several changes, such as lack of infrastructure, erratic power supply, deplorable road networks and high cost of funds, among

He lamented that countries like South Africa, Egypt and Morocco have more infrastructure, such as broadband, gas and electricity unlike what obtains in Nigeria.

"Almost all manufacturers have to provide their own electricity, they have to provide their own generating sets, buy very expressive diesel to power their generators. A company in Nigeria will have to provide its own water and still have to pay government for generating the

water," he lamented.

Ahmed stated that the country

needed to look beyond the ease of doing business and seriously tackle the challenges of interest rate and exchange rate.

Speaking, Chairman of Apapa branch of MAN, Frank Oyebu, charged the Lagos State Government to collaborate with the Federal Government to ensure the success of the AfCFTA implementation.

Oyebu added that AfCFTA's design reflected an explicit commencement to creating a framework for deeper socio-economic integration that would enable trade, investments and greater mobility of people.

He urged manufacturers to embrace innovations, review their processes and strategise to enhance their production mode and compete favourably in their

Also, on his part, Taraba State Coordinator of the NDE, Illiya Yakubu Ilelah, said the directorate will not hesitate to sanction absentee participants.

Citing the huge amount the Federal Government has been spending on job creation, he urged the participants who are not ready to take the training serious, to, as a matter of urgency, withdraw as several qualified applicants were waiting for an opportunity for the training.

A talented Nigerian musician, Adekunle Gold, in one of his popular songs titled: Work, encouraged people to work hard. This is in harmony with what God's Word, the Bible, recommends at Ecclesiastes chapter 9, verse 10, where it says: "Whatever your hand finds to do, do with all your might..."

Work - whether paid or unpaid, is good for our health and well-being. It contributes to our happiness, helps us to build confidence and self-esteem, and can reward us financially. Work is an essential tool through which individuals can achieve their goals, flourish, and live happy, meaningful lives.

Unemployment and poverty are two of the major problems currently plaguing Nigeria's economy and its society. Nevertheless, despite the high rate of unemployment and poverty, the situation is not necessarily hopeless. People can still find some meaningful work to engage in, even though it may be small. And, as another talented Nigerian musician, Sonnie Smyth, sang in his music video entitled: 'NO WAHALA': No wahala, e go better, after today, I go see tomorrow o! (You can download and watch this music video by Sonnie Smyth and directed by Achor Yusuf on YouTube).

If you are unemployed, or cannot find a job in your area of particular interest, it is wise to consider looking for a job in other areas, even if the job is considered 'menial' by the standards of some people. Do not allow false pride to let you look down on a job-as beneath your dignity. Any legitimate service that can benefit others, and that people are willing to pay for, can be considered as an alternative job

opportunity when jobs are scarce.

People differ in terms of many characteristics such as intelligence, talents, academic levels, etc. Therefore depending on human potential and the specific working environment, work can be equally beneficial to the person or demeaning. For example, prostitution, gambling and drug dealing constitute work, as you get a kind of remuneration for the service you provide. But the money you get out of these kinds of work becomes useless, as it neither contributes to human flourishing, nor is the basis of a meaningful life. Work should be the key to human survival and flourishing, and not to degradation of the individual and his moral values

On the other hand, no matter how honest, working from dawn to sunset does not make your life flourish either. "All work and no play makes Jack a dull boy," goes the popular saying. Workaholics, the people whose only purpose in life is work, deprive themselves of the enjoyment of engaging in other activities. Productive work is not an end-in-itself, but a means of flourishing. If one pursues productive work to the exclusion of everything else in one's life, so that it becomes one's only purpose in life, this will undermine one's flourishing. On the other hand, those who keep their life balanced are likely to enjoy their work even more.

So, whether our work is mostly mental, physical or somewhere in between, we should recognise that there is dignity in labour! Hard work helps us to care for our material needs. Moreover, it contributes to our self-esteem, after all, hard work is just that-hard. Dana Air apologises to passengers for cancellation of Port Harcourt-Lagos flight

Dana Airline has apologised to its customers over the inconveniences the cancellation of its Port Harcourt-Lagos flight on May 2, 2022 caused them, saying it was due to safety precautions.

According to the airline, its aircraft with registration number 5N JOY operating flight 9J 344 was set to take off when the pilot noticed an anomaly, which he queried with the Air Traffic Control (ATC) before returning the flight in line with its safety operating procedures.

It said the impact on the brakes due the aborted takeoff affected the aircraft tyres, which sparked off while the aircraft was taxing to re-park at the airport.

Communications Manager of the airline, Kingsley Ezenwa, in a statement, disclosed that all 50 passengers onboard the aircraft disembarked safely, adding that the maintenance team immediately grounded the aircraft pending the conclusion of investigations.

"We sincerely apologise to all the passengers onboard the aircraft for the inconveniences caused due to the l cancellation of the flight. At Dana Air, the safety of our passengers and crew will remain a top priority in all aspects of our operations and we will continue to operate in accordance with the civil aviation regulations and global best practices," the statement added.



NUATE protests against planned airports concessioning, catering by foreign airlines

The National Union of Air Transport Employees (NUATE) has protested against ongoing discussions to concession airports in the country, saying they do not understand government's response to the demands of aviation unions on labour-related issues and several lapses

in prevoius concession programmes.

National President of NUATE, Ben Nnabue, in his May Day message, said the union was also presently battling the vexed issue of catering by some foreign airlines.

He said the union is in consultations with the Nigerian Civil Aviation Authority (NCAA) over the matter on why the workers delayed action on it in the last one month, adding that the union remains committed to ending the unwholesome act in the interest of local firms that provie in-flight catering services.

Nnabue said the COVID-19 pandemic, the Russia-Ukraine war, increase in price of aviation fuel, travelers' negative reaction to recent hike in air fares and other adversities have been excruciating for airline and had delayed the exit of the aviation industry from recession.

He said big local airlines continue

to defy the law on free association and membership of unions, noting that the Minister of Labour and Employment, Dr. Chris Ngige, had not fulfilled his pledge to intervene in the matter.

Nnabue said the air transporters had been left with their own devices to ensure that all aviation workers, particularly in Air Peace, Azman Air and Dana Air, among others, were free from slavish labour this year.

"We urge the Minister of Aviation, Hadi Sirika, to urgently review his Aviation Roadmap. We are of the view that the projects under the roadmap require significant adjustments to harmonize them with current realities in the world of aviation and our national interest," he said.

He also pointed out the issue of Minimum Wage Consequential Adjustment and Conditions of Service for the aviation agencies, noting that the union was firmly behind the workers decision not to accept further by government agencies on the issues.

"We express our frustration at the delay of the Bureau of Public Enterprises (BP) in resolving the negotiated redundancy benefits of former employees of SAHCO, a matter pending since 2009. We assure the affected ex-workers that the unions have gone far and cannot retreat on the matter at this point. We are at the verge of a final solution, failing which we shall take decisive actions towards seeking justice for the victims," he added.

He further urged the Federal Government to urgently address the shortcomings of the newly commissioned international terminal at Murtala Mohammed International Airport (MMIA) so as to put the terminal to maximum use.

He warned that it will be a major disservice of this administration should the terminal turn out to be a white

Was acting your childhood dream?

I will not say I have always wanted to be an actor, but I have always loved be on television as a broadcaster. But somehow, acting found me and here I am today.

When did it dawn on you that you would make a living off acting?

When I shoot my first movie, after the heat, I disappeared. I told them I could not cope with it and I did not want to act anymore. They called me for a second job, telling me that I would be allowed to leave after that. Afterwards, they still lured me to do the third one. Somehow, they wanted me.

I ran away because I felt I could not deal with the pressure and drama. But, after sometime, I realised that it could be the right place for me. Now, I do not need anyone to tell me that it is meant for me. If I decide to leave Nollywood today, it is because I want to.

Is it a necessity to feature in any movie you produce?

I must not feature, but why would I produce a movie and I am not in it? Remember other people pay me to be in their movies. I feel it is what I love to do and being part of it add value to the movie.

What's the secret of your staying power?

The industry is very competitive. What I have tried to do is to be myself. When you be yourself, it stands you out from any other person. If you are trying to be some other person, it is not you. I try to be me and I believe it is slow and steady. So, I would rather be here and steady than being forgotten so soon. I take things one after the other.

As the same time too, I try to be relevant in the industry because it is the only way nobody forgets you.

How did your background contribute to what you do today?

First of all, I come from a very strict home. Normally, my parents will not allowed any of their children to do what I do today. I actually shot my first movie without telling my parents. People who knew me back home still do not believe I am an actress.

But being an actress has not changed me or give my parents reasons to regret allowing me to go into it. It has shaped me more and I do not forget where I am coming from. I am doing this for a reason and propose and

I do not forget that. I do not forget where I am coming from and it helps me a lot.

Was there any time you wished you were not famous?

Yes, I have felt that many times. I always feel like quitting, especially when they write things about me that are untrue. I think I actually quit, but after a while I said to myself that why should I?

get burnt and undone.

How do you want to be remembered?


Sometimes, your beauty is your pain but you have to make good use of it and look at the advantages of being beautiful. That I am pretty is not by mistake; God made me this way.





Former Manchester United defender and football pundit, Roy Keane says Cristiano Ronaldo has proven beyond being a "short-term fix" and deserves to remain with the club a little longer.

Keane, after the United match against Brentford where Ronaldo scored his 18th Premier League goal of the season, marveled that at 37, the Portuguese forward has put in brilliant performances for the club.

Though the soccer pundit opines that United need new players to pose competition in the squad, lamenting that it is wrong for the leading goal scorer of the club to be of that age, he, however, objected to the view of letting Ronaldo leave.

Keane stressed that it is absurd to consider keeping the Manchester United talisman out of the squad adding that such logic is unfathomable.

In a TV programme, Monday Night Football, Keane said, "Ronaldo's signing was a short-term fix, for the fans, for the share price. But he has still scored the goals.

"I just think with the goals that he has got, his performances, warrants staying at the club. But Manchester United have to get players around him, they have to get other strikers in,

there has to be competition for places.

"If the leading goalscorer, the man you are depending on, is 37 years of age then that is certainly not good but I would certainly be holding onto Ronaldo.

"There might be a conversation that needs to be had about the way you are going to play or that you are not going to be playing week in and week out. But why would you get rid of a player who scores that many goals? I don't see the logic in it," Keane, the former United captain, added.

Keane took over the captain's armband at Manchester United after Eric Cantona's abrupt retirement, and held to it for eight years until his retirement in 2005,

He added that the problem bedeviling the Red Devils is way above Ronaldo.

Fulham clinch Championship title, make Premier League return

Fulham have won the 2021-22 Championship season to return to the Premier League after thrashing Luton Town 7-0 at Craven Cottage on Monday.

Fulham against Nottingham Forest were unable to lift the trophy after they lost by a lone goal at Craven Cottage but put up a surprising performance against sixplaced Luton to finally ice their season's blistering campaign.

The Cottagers opened the feast of goals through captain Thomas Cairney in 29 minutes and doubled the lead 10 minutes from defender Kenny Tete.

Serbia's Aleksandar Mitrović scored a brace in the second half with Fábio Carvalho, Bobby Decordova-Reid, and Jean Seri firing the furnace that consumed The Hatters.

Consequently, Mitrovic on Monday, May 2, 2022, equalled the record of Portsmouth hero Guy Whittingham's 42 championship goals in a season and surpassed it having scored two consecutive goals to take his tally to 43 for the

Reacting to the performance of Mitrovic in the romp, Fulham manager Marco Silva praised the record-breaking striker and affirmed that the accolade bestowed on him is well deserved.

"What a fantastic way to finish with a 7-0 with Mitrovic scoring the last goal and breaking the record is amazing," Silva told Sky Sports in a postmatch interview.

"He deserves it. He played a fantastic game as well, he's a very good professional, a good lad. He enjoyed the moment, we all enjoy being with him and I just want him to keep working hard," he added.

Fulham, returning to the Premier League after a successful 2021-22 campaign, makes it 28 times the London-based football club has featured in the English topflight league.

Torino style restricts Aina's match time

Super Eagle Ola Aina has been starved of regular playing time in his Italian club, Torino, after being subjected to fighting for his position in the starting lineup.

The Nigerian international and versatile defender who plays as a wing-back or right-back has either come from in as a substitute or substituted in most matches.

While some Nigerian media think that the Super Eagle must have been subjected to this treatment following his appearance in the Nigeria senior men's team to play against Ghana, The Trumpet report otherwise.

Aina's club Torino adopted a 3-4-2-1 system of football which projects three central defenders after the goalkeeper, two wing-backs, and two central midfielders four players, two midfielders thereafter, and the central striker.

On the array of four, comprising two wing-backs, Torino rotate the position, right and left wings, among three players, Ola Aina, Ivorian Wilfred Singo, and Kosovan Mergin Vojvoda.

Aina, 25, after the World Cup qualifiers against Ghana on March 29, returned to Italy and was listed as an unused substitute against Serie A side Salernitana, Joel Obi's club, on the 2nd of April.

Following the away match against Salernitana in Stadio Arechi, Aina came in as a second-half substitute against AC Milan on April 10th at the Olimpico di

Torino head coach, Ivan Juris, drafted the Super Eagle in the starting lineup against Lazio at the Stadio Olimpico after Milan's encounter that ended barren.

Surprisingly, the Super Eagle played the entire 90 minutes against Atalanta which ended 4-4 after being benched against Spezia and in the recent 3-1 win against Empoli.

The player, who joined Torino from Chelsea after a successful loan spell in Stadio di Torino where he made 30 appearances and scored his debut goal against Udinese on February 2, 2019, completed a permanent switch worth £9m to II Toro on 11 June 2019.

Aina's major challenge lies with Juris, who deniably, prefers to use Singo and Vojvoda more regularly in Torino's starting lineups. The Super Eagle has featured 21 times for Torino this season in all competitions.



Why FIFA sanctioned Nigeria, others

he world football governing body has slammed Nigeria with sanctions over the country's inability to control its fans after they failed to secure the qualifying ticket to FIFA World Cup hosted by Qatar.

The Super Eagles played a goalless draw against the Black Stars of Ghana in Kumasi during the first leg of the double-legged tie but failed to capitalize on the overwhelming home support to edge out their West Africa rivals.

Following the result of the match that ended in a one-all draw, the disappointed Nigerian supporters trooped into the pitch and caused disgraceful damage to the MKO Abiola National Stadium facilities which prompted people to scamper for safety.

However, the International Federation of Association Football (FIFA) delegated its Disciplinary Committee to review all the incidents that took place during the qualifiers for the Qatar 2022 FIFA World Cup.

FIFA on its official site reiterated that it is committed



to "zero-tolerance stance against discrimination and violence in football, a number of member associations have been punished due to the abusive behaviour by their respective supporters."

Accordingly, the world football governing body fined Nigeria \$150,000 and also banned the Super Eagles to play a one-match without any spectators to cheer them up to victory.

Other countries also sanctioned in Africa according to their degree of crime, include Algeria, fined \$3000 for

throwing objects and lighting fireworks in a match with Cameroon and DR Congo, fined \$5000 for throwing objects in a Qatar 2022 first leg qualifying match with Morocco.

Consecutively, DR Congo after incurring the wrath of FIFA in the first leg tie with Morocco, were fined \$120,000 and have been contained to play one match without a spectator after their fans threw objects and invaded the field of play.

FIFA added that the Congolese failed to maintain

law and order in the stadium and also failed to organise the match properly.

Morocco and Egypt got a piece of FIFA's disciplinary actions to ensure sanity in the game of football. Morocco were fined \$30,000 for lighting fireworks, throwing of objects and

blocking of stairways while Egypt were fined \$6000 for team misconduct.

Senegal national team were handed a \$175,000 fine and have been constrained to play one match without their fans in the stadium.

Declan Rice: from unwanted kid to England star

West Ham midfielder Declan Rice has developed to become one of the most impressive players in England in recent times, attracting interest from European top clubs.

Rice's development in football from Chelsea's academy to becoming a key player in West Ham and England's Three Lions, is a story with certain unhappy epistles.

The 23 years old West Ham player left Chelsea at the age of 14 to join the East London club but was faced with challenges that were beyond his control.

As a kid, he had an uneven growth, smaller in stature than his usual age which made West Ham rethink considering him for a role.

However, Rice at the eventual moment until Hammers could ponder on his status as a player in the club, overcame the defect, sprouting in growth to stamp his importance to the club and country's successes.

Rice was a formidable figure in England's team during the EURO 2020 final, playing all seven matches in a superb form and continued in this clime in the 2021-2022 campaign season for West Ham.

"I was really small when I was a kid. Not too small, but smaller than most," Rice told Sky Sports as West Ham hosted Arsenal at London Stadium.

about getting rid of me, I was in the middle of a growth spurt. I could play, but I just looked so gangly and unorthodox - it didn't look right.

"I knew if they gave me the time, I had the ability and I could still play. It was just my running technique - I looked long in the legs and everything was off.

"Once they gave me that time and that space to grow into my body, everything else came through," said Rice. "My personality as a kid, I always wanted to be a captain, I always cared about the game and wanted to learn. As I got older, that started to show through.

"When you're younger, ability is one thing, but you have to want it the most. I feel like that gets you further. I hear so many ex-pros say it, that they come across players where they were better than them but they didn't want it enough.

"For me, I came across so many players who were better than me, but they didn't have the mentality, the head, the heart to want it enough and keep pushing themselves. Luckily enough, in the end, I had both," he added.

The England international being sought by Chelsea and top English clubs to help solve their midfield challenges ahead of next season's campaign, has featured 33 times in the 2021-22 Premier League season for the Hammers, scoring 1 goal and providing four assists.

"Always in my heart. Thank you mimi," Pogba passionately Tweeted.


'Nkekiah adds a different dimension to Arsenal's attack'

Israel demands apology from Moscow after Lavrov says Hitler had jewish roots

rael has denounced Russian Foreign Minister Sergei Lavrov suggesting that Nazi leader Adolf Hitler had Jewish roots, and that Jews are among the worst anti-Semites. Israel has demanded an apology from Moscow.

Israel's Foreign Ministry said it summoned the Russian ambassador for "a tough talk" over the comments, which Lavrov made on Sunday in an interview with Italian television.

Since Russia's invasion of Ukraine on February 24, Israel has sought to keep a delicate balance between the two sides, but remarks by the Russian foreign minister to an Italian channel sparked anger in Israel.

Minister Yair Lapid said Lavrov had made "an unforgivable, scandalous statement."

marked Israel Holocaust Remembrance Day last week, with sirens blaring out across the country to commemorate the millions of Jews killed by the Nazis during the Second World War.

The comments Russia's foreign minister came as he reaffirmed Moscow's stance that his country's invasion of Ukraine is aimed at freeing the country from

Dani Dayan, director f the Yad Vashem, of the Yad Vashem, the World Holocaust Vashem, Remembrance Center in Israel, also criticised Lavrov's statement. calling them "unfounded, delusional and dangerous remarks which deserve to be condemned.'

In a speech to the Israeli oarliament in March, the Ukrainian President called on Israel to "make a choice" by supporting Ukraine against Russia, and asked the Jewish state to provide them with weapons.

Israel has however provided helmets and bulletproof vests Ukrainian rescue workers, but has not supplied the country with weapons.

Pope wants to meet Putin in Moscow over Ukraine war

Pope Francis has said that he asked for a meeting in Moscow with Russian President Vladimir Putin towards ending the war in Ukraine but had not received a reply.

The 85-year-old Pontiff also told Italy's Corriere Della Sera newspaper that Patriarch Kirill of the Orthodox Church, who has given the war his full-throated backing, "cannot Putin's altar boy."

He also disclosed that he had sent a message to Putin around 20 days into



conflict saving "that I was willing to go to Moscow."

Francis, who made

unprecedented visit to the Russian embassy when the war started, said in the interview that about three weeks into the conflict, he asked the Vatican's top diplomat to send a message to

The message was "that I was willing to go to Moscow. Certainly, it was necessary for the Kremlin leader to allow an opening. We have not yet received a response and we are

still insisting". He added, "I fear that Putin cannot, and does not, want to have this meeting at this time. But how can you not stop so much brutality?"

Before the interview, the Pope had not specifically mentioned Russia or Putin publicly since the start of the conflict on Feb. 24. But he has left little doubt which side he has criticized, using terms such as unjustified aggression, invasion and lamenting atrocities against civilians.

When asked about a trip to the Ukrainian capital Kyiv, the head of the Roman Catholic Church said he would not be travelling to Ukraine anytime soon.

"I'm not going to Kyiv for now. I feel I shouldn't go. I have to go to Moscow first, I have to meet Putin first," he said.
