

EFCC, Wike, Amaechi, Rivers guber candidate, others in ding dong war

overnor Nvesom Wike has directed General and Commissioner for Justice, Prof. Zacchaeus Adangor, to commence "diligent prosecution" alleged illegal financial dealings of former Rivers Governor Chibuike Rotimi Amaechi, Mr. Tonye Cole, Sahara Energy and others over the sale of state assets.

But a nong o v e r n m e n t a l organization (NGO) is urging Wike to come to equity with clean hands.

The governor who gave the directive shortly after swearing in the Attorney General and two other commissioners insisted that Rivers people must know how the sum of 50 million dollars "disappeared" from the treasury of the state government during Amaechi's tenure.

Wike said: "Attorney General, you're at a critical period where people want to know what the State is going to do with the Judiciary Panel of Inquiry after the Supreme Court iudgement on Luckily, you came at the right time when have preferred criminal charges against the former governor (Amaechi), Sahara Energy, Tonye Cole and the rest of them."

Wike said there was no proof of business where the cash was deployed: "So, you are coming at the right time to take over the matter and to make sure it is prosecuted diligently. I don't want to hear excuses. Let the people what happened to our money. The world will see how \$50 million Dollar from our account was moved to a company without show there was a whether business."

Commissioner Justice, to write strongly-worded protest letter the Economic and Crimes Financial Commission (EFCC) "harassment" of the state's Peoples Democratic Party (PDP) governorship candidate, Siminalaye

This, Wike said, is predicated on the fact that, recently, EFCC officers attempted to harass and intimidate Fubara, who before his emergence as the PDP governorship candidate, had served as the Accountant General of Rivers State.

Wike said EFCC needed to know that the era of impunity and flagrant disobedience to the rule of law is gone and his administration will not accept such behaviour.

He maintained that the attempt to harass the PDP candidate will not be accepted as the state government will not hesitate to charge the EFCC for contempt.

Wike explained that before now, the Rivers government had obtained a subsisting court judgment against the EFCC that it cannot investigate the state's finances or its officers. According to him, there is also another judgment against EFCC by Fubara to enforce his fundamental rights, which has not been set aside.

"Rivers State government had judgment against EFCC since 2007. The court said you (EFCC) has no business in the financial transactions of the (Rivers) State. EFCC has been struggling to set aside that judgement until now. They have not even appealed it."

Wike warned that nobody will accept the use of EFCC at such political period to intimidate persons in order to achieve their "skewed" goals: "We are in a political

period. People should not think that they will use EFCC to intimidate or manipulate him (Fubara). Nobody will accept that. So you (Attorney General) have to attach the judgment of the candidate against EFCC and send the right signal to them that we are not people that can be cowed."

The two other commissioners sworn in were, Hon. Isaac Kamalu as Commissioner of Finance, Budget and Economic Planning and Dr. George-Kelly, Dakorinama Alabo as Commissioner for Works and Special Projects.

They were among the commissioners who had resigned to contest in the governorship primaries of the PDP.


"The news making the rounds that Fubara, on Tuesday night escaped an attempt by officials of the EFCC to arrest him" has been described by HURIWA as "disgusting and shameful."

The prominent advocacy group reminded the politician that "under the constitutional Norm, he is innocent and therefore should respect a properly constituted law enforcement agency and surrender himself for questioning."

HURIWA said it was a bad precedence that the politician is setting if he continues to evade arrest of the EFCC which is a body set up by law of the Federal Republic of Nigeria just as their task is supported by the constitutional provision in Section 15(5) which states that eradication of corruption and combating abuse of office is the duty of government.

quoting HURIWA news media said the drama unfolded the Port Harcourt International Airport as the plane ferrying Fubara and other PDP chieftains who had accompanied him to Abuja to receive his Certificate of Return touched down at the airport just as the Rights group said it is inexplicable why the top Rivers politician is evading the invitation of the Economic and Financial Crimes Commission when he would be accorded all his basic and fundamental human rights as a citizen since the anti-graft agency can't afford to be lawless and unethical in its activities of waging a war against corruption.

HURIWA also stated that unlike the previous acting Chairman of the EFCC in which someone allegedly died in EFCC detention. the new dispensation is not associated with draconian detention for facilities now. Rights group encourages the Rivers



HURIWA condemned the reported physical confrontation against the operatives of the EFCC going by the news report that as the operatives move to effect the arrest of the Rivers PDP governorship candidate for questioning over allegations of graft related offences, some vouths believed to be his supporters allegedly resisted the officials and attacked them. Though details of the alleged attack were still sketchy as of the time of filing the report by the media but sources said some of the EFCC operatives sustained injuries.

HURIWA recalled that the EFCC had declared Fubara, the immediate past Accountant General of Rivers state, and three other top state government officials wanted over alleged N117 billion fraud.

After the drama at the airport, Fubara won the state governorship PDP on May 25 primary proceeded to the state party secretariat addressed party supporters and stakeholders.



Murderers of Fasoranti's daughter to die by hanging

Ondo State High Court has sentenced three death by hanging for killing 58-year-old Funke Olakunri, daughter of the leader of Afenifere, the pansocio-political Yoruba organization, Pa Reuben Fasoranti.

The convicts, Adamu Muhammed Adamu, Usman Shehu and Lawal Mazaje, were similarly accused of assassinating a hunter in the forest. However, the court discharged the fourth suspect, Auwalu Abubakar, arraigned for aiding and abetting.

In his verdict, Justice Williams

Olamide convicted the three suspects to death on charges bothering on conspiracy to kill, kidnapping, murder, and armed robbery. The commiserated the victim's family and advised the government to find a lasting solution to the thriving insecurity in the

On July 12, 2019, the 58-year-old Olakurin, who was heading to Akure, Ondo State, from Lagos, was attacked and shot by the armed herdsmen on the Benin-Sagamu Expressway.

After months, the killers were arrested on April 6, 2020, following tracking and investigation by men of the Special Anti-Robbery Squad of the Nigeria Police Force.

PDP NWC to assist Atiku in finding acceptable running mate

The leadership of the Peoples Democratic Party, particularly, the National Working (NWC) Committee are going to be deeply involved in finding an acceptable running mate for its presidential candidate. Abubakar.

The party chairman, Dr Iyorchia Ayu and the presidential candidate met with governors of the party on Wednesday evening at the PDP Presidential Campaign Office, Legacy House, Abuia.

The meeting was the first major convergence of the governors with the party leadership after the May 29 conclusion of its special national convention in which Atiku emerged.

Ayu said the meeting continues this weekend until the party "someone with large acceptability" that will go into the 2023 presidential contest with Atiku Abubakar.

The national chairman said "the issue of finding a running mate is as important as that of electing the candidate and our party is not leaving no stone unturned.

"There are a lot of consideration that goes into this process and we have to critically look into each consideration.

"The main focus of the PDP is to rescue power from the ruling APC that has bastardized governance traumatized Nigerians. And to achieve our aim, we need to choose right and choosing right entails wide consultation.

"But I want to assure our teeming members and Nigerian at large that our choice will reflect their aspirations".

In a very brief address after the meeting, the chairman of PDP Governors' Forum and governor of Sokoto State, Aminu Tambuwal said the meeting dissected outcome of the presidential primary.

When asked if the meeting discussed the issue of vice presidential candidate, he accepted that it was one issue on the front burner.

Tambuwal said, "it is part of the consultation, it's ongoing and governors are also being consulted on that."

There has been anxiety on who will be Atiku's running mate, a decision which could not be left to the candidate alone to

Top on the list of possible vice presidential candidate are; Governor Ifeanyi Okowa of Delta, Nyeson Wike of Rivers, and Ifeanyi Ugwuanyi of Enugu.

The name of the former governor of Imo State, Ĕmeka Ihedioha came up immediately after the convention but it was learnt that the name was dropped for being a feeble consideration. The name of the former Governor of Delta State, Dr Emmanule Eweta Uduaghan is also top on

Another twist to the contest is the mentioning of the name of the former Finance minister, Dr Ngozi Okonjo Iweala.

But, this is doubtful as there is little possibility that Iweala may leave international appointment at the World Trade Center (WTO) for the vice president job.

The governors are likely to meet again on Friday to fine tune the nomination of one of them as Atiku's running mate.

Tambuwal further said stakeholders at the meeting expressed satisfaction with the conduct of the convention and commended the leadership and members for the success.

"The national chairman along with the candidate came to thank the governors for their roles at the convention.

"We talked about cooperation and collaboration in prosecuting successful electioneering campaign that will result in victories for the PDP at various elections from the state house of assembly, national election, governorship and the presidential election come February

" It is more of a consultative meeting on matters concerning the way forward."

Israeli PM makes surprise visit to UAE

Israeli Prime Naftali Minister Bennett has made a surprise visit to the United Arab Emirates

A statement from Bennett's office said the Israeli leader will meet UAE President Sheikh Mohamed bin Zayed Al Nahyan and that the two will discuss "various regional issues," with Iran likely to top the agenda.

Bennett also met Foreign Minister Sheikh Abdullah bin Zayed Al Nahyan.

Bennett's visit on Thursday was his second public trip to Abu Dhabi since Israel and the UAE formally normalised ties in 2020 after years of quiet cooperation.

Sheikh Mohammed succeeded his late Sheikh half-brother Khalifa bin Zayed Al Nahvan last month.

"Today, together, we will take to the special bond that has been woven between our countries to the next level for the growth and security of both our peoples,"

Bennett said before his departure.

In 2020, the UAE and Bahrain became the first Gulf states to sign an agreement to establish diplomatic relations with Israel.

It was primarily directed against Shiite Iran, which the UAE saw as an arch-enemy, though economic interests also played a role.

Only two Arab states, Egypt and Iordan. maintained diplomatic relations with Israel.

In a video statement recorded before departing,

commended countries at an International Energy Atomic Agency meeting in Vienna on Wednesday who voted censure Iran over its transparency about nuclear activities at three undeclared sites in the country.

"We see here a firm stance by the countries of the world regarding distinction the good and between evil, as they clearly state that Iran is concealing things. We will not let up on this issue," he said before boarding a plane to

The statement directed the Chairmen of Igbo-Eze North and Igbo-Eze South LGAs as well as Forest Guard Neighbourhood Watch Officers of the affected two council areas to ensure strict compliance with the Executive Order.

Akpabio, Umahi win APC senatorial ticket

The immediate past Minister of Niger Delta Affairs and presidential aspirant, Senator Godswill Akpabio, and Governor David Umahi of Ebonyi State have emerged as the Senatorial flag bearers for Akwa Ibom North West and Ebonyi South Senatorial district on the platform of All Progressives Congress(APC) for the 2023 general elections respectively.

At the Senatorial primary held Thursday night in Ikot Ekpene Local Council in Akwa Ibom State, the Returning Officer, Bunmi Moleye, announced that out of the 512 accredited delegates, Akpabio polled 478 votes while DIG Ekpo Udom (Rtd) and Sir Joseph Akpan scored 3 and 1 votes respectively. A similar exercise was held on May 28, which saw DIG Ekpo Udom (Rtd) as the party's candidate but was later nullified following petitions of alleged security infractions.

The state chairman of the party, Sir Stephen Ntukekpo, who addressed the people before the nomination, said the National Working Committee of the party mandated him as the chairman to conduct a rerun of the election yesterday adding that he duly informed the aspirants concerned of the exercise. He said, " almost a week ago, a similar exercise was conducted here and as a state chairman, I received a letter from the National Working Committee, indicating with strong words that there are some sufficient and profound infractions in the Akwa Ibom North West Senatorial district.

They mandated us to conduct the rerun exercise today, on that note permit me to introduce the committee members carefully selected by the National Working Committee. The five-man committee is led by Sir Sylvester Okonkwo as the chairman. We have about three aspirants in this exercise and they have been informed about the exercise of today and they are: Joseph Akpan, DIĞ Ekpo Udom, Obongemem Ekperikpe Ekpo, Godswill Obot Akpabio."

One of the aspirants,

Akpabio,

Ekperikpe Ekpo, however withdrew his aspirations and drummed support for Godswill Akpabio even as he urged his delegates to vote Akpabio whom he described as his father. Today, my father(Akpabio) has joined the race. I plead with all my delegates to identify with him as I return all the delegates to vote for Senator Godswill Akpabio. With that, I have withdrawn my aspiration to the Senatorial seat," he

Meanwhile, DIG Ekpo Udom(rtd) as well as Ŝir Joseph Akpan boycotted the primary and have not yet made public the reasons for their action.

Senator Akpabio while making a remark after his victory said, "I thank all the delegates across the Senatorial District for finding me worthy

to represent you in the Nigerian Senate. I was the only senator ever to do the kind of empowerment I did from market to water projects, electrification, even road construction, I did all as a senator, and I promise to do more. I pray that you all shall live long to enjoy the fruits of your labour.'

It was gathered that Observers from INEC and representatives of NWC as well as the Chairman, APC Primaries Appeal Committee, Sunday Ewoleye, were present at the primary rerun. But stakeholders in the Senatorial District have kicked against the emergence of Akpabio in the 2023 senatorial elections.

A youth leader, Mr Udoma Idiong, said it is the turn of former "Abak five" comprising five local government areas in the senatorial district to take their turn for the senate seat. He said Akpabio must wait for their turn for equity and justice to other local government areas in the senatorial district.

Similarly, Umahi contested the presidential primary of the APC but lost to Bola Tinubu at the party's convention in Abuja.

Umahi's younger brother, Chief Austin Umahi, had emerged as the winner of the election two weeks ago.

The party cancelled the senatorial primary election for Ebonyi South and rescheduled it for Thursday night.

The rescheduled Ebonyi South APC Senatorial primary election was held at Afikpo North Local Government Council, with Governor Umahi clinching the party's ticket.

Wike re-appoints ex-Chief of Staff, three excommissioners

Lesson teacher bags life jail for impregnating 14 year-old pupil

domestic Violence and Sexual Offences Court sitting in Ikeja has sentenced a `lesson teacher,' Joseph Ibanga, to life imprisonment for defiling and impregnating a 14 year-old girl.

While delivering judgment, Justice Abiola Soladoye, said the prosecution proved the charge defilement beyond reasonable doubt against the lesson teacher.

"The survivor was a minor and her consent is immaterial. The evidence before the court showed that the defendant had sex with her in her home and his own matrimonial home. She subsequently became pregnant and had a babv.

"The medical report corroborated the evidence of the victim. The defendant is responsible for the act and there is evidence before the court to prove same. The survivor identified the defendant as her lesson teacher and the person

who had forced sexual intercourse with her.

"The defendant is very ungrateful and wicked. He ravished the student with impunity and taught her nonsense. He has brought ridicule to the teaching profession and this punishment will serve as a lesson to him.

"The defendant is hereby found guilty as charged, based on the avalanche of evidence against him, and he is sentenced to life imprisonment."

The judge ordered that

the name of the convict be entered into the register of sexual offenders of Lagos State. The prosecution presented three witnesses at the trial, while the defendant has no witness, he gave his sole defence.

According to prosecution team, Mr Olusola Soneye, Olufunke Adegoke and Ms Abimbola Abolade, the defendant committed the offence between January and March 2019 at No.12, Iresi Street, Orile-Agege, in Lagos.

They submitted that the defendant was a lesson teacher, who taught the survivor at home, because she was not in school for a long time, due to slow learning. They said that the defendant had sex with her in her home, where she lived with her aunt, and whenever he came to teach her and subsequently became pregnant and had a baby, contrary to section 137 of the Criminal Law of Lagos State, 2015, which stipulates life imprisonment for offenders.


"The suspect was arrested at about 2300hrs on Friday, June 4, 2022, after he took to his heels upon sighting policemen on routine patrol.

UNIABUJA sacks two professors over sex-for-marks

The University of Abuja, UNAB, has dismissed two lectures over allegations of sex for marks.

Vice-Chancellor of the University of Abuja, Prof. Abdul-Rasheed Na-Allah, who made the revelation did not disclose the names of those affected but said the lecturers were dismissed as part of tough measures to discourage such ugly incidents in the institution.

Na'Allah told the News Agency of Nigeria (NAN) in New York that the university had introduced a policy on sex abuse on

campus, which had been published.

Na-Allah, who was on a two-day visit to the U.S. to meet with the University of Abuja Alumni Association, USA chapter, to solicit support for the institution, said, female students needed to be protected."

According to him, the institution is committed to high moral standards and will not tolerate any act of misconduct perpetrated by its staff against students.

"I have dismissed two professors since I became the Vice-Chancellor. It tells you how we are serious about the issue of sexual harassment.

"We are collaborating with some Non-Governmental Organisations (NGOs), to make sure that it is not only us that are addressing this issue, but we have a strong partner-

"We cannot allow the lives of our students to be destroyed because most of the abuses destroy the lives of their victims."

The V.C said: "it was sad to see some lecturers, who are supposed to be protecting the female students, becoming one of their problems. This is a problem of universities in Nigeria, not only the University of Abuja alone.

Nollywood star seeks custody of son, step-daughter as marriage collapses

These are not the best of times for Nollywood superstar, Kalu Ikeagwu. The marriage of this star, who has featured dozens of films has fallen apart and he is currently doing everything possible to secure custody of his son and the step-daughter he is accused of enticing for

Kalu Ikeagwu informed a High Court, sitting in Ikeja, how his wife, Ijeoma, deserted their matrimonial home and prevented him from gaining access to their two children.

Consequently, Ikeagwu in a suit marked LD/8939HD/2021, is seeking a dissolution of his six-year-old marriage to Ijeoma and full custody of his three years-old son and 10 years-old step-daughter.

Under cross-examination by the respondent's counsel, Mrs S.I. Amedu Ikeagwu revealed that his wife packed out of his matrimonial home and sent him a mail that she was on her way to her father's house in Enugu. He told the court that he was shocked when he found her at the Murtala

Mohammed International Airport with the children a few days later.

"I got back home from a trip on August 4, 2021, to find out that my wife had left our matrimonial home with the children to an undisclosed location. I tried to contact her when I got to the house and found it empty. I sent her an email on that same day and she replied that she had gone to her father's house in Enugu.

"She told me she was at her father's place in Enugu and four days later, I saw her at the airport in Lagos, heading to God knows where. In the mail she sent, she said she was in Enugu. Ikeagwu also debunked the claim that he sent his wife and kids out of the house and failed to provide materially for them.

"I did not send her out of the house. Someone has to tell me why it takes four days to get to Enugu from Lagos. If you say 'you are on your way' it means it is a continuous sentence. It was a stated fact that she was on her way," he said.

The Nollywood star further told the court that his wife denied him sex and also poured water on him while he was asleep and that he was not aware that his wife lost a pregnancy due to a Sexually Transmitted Infection, STI, while they were together.

"After the birth of our son, she refused to have sex with me. I was not aware she lost another pregnancy due to an infection, as I did not give her any infection. Till date, I have not seen any report attached to a document that she lost a baby through STD. Though I did not ask her why she lost the baby," he said.

Ikeagwu said he stopped sending money to the children for upkeep and maintenance because his wife denied him access to his stepdaughter. He added that this was after she accused him of attempting to sleep with the child and she failed to acknowledge the money he sent to her.

"The last time I sent money to them was in November 2021. I stopped sending money because my wife denied me as a father to my step-daughter and she also accused me of wanting to sleep with her," the actor said.

On why he was seeking custody of his step-daughter, whom he had earlier sought for revocation of guardianship, the actor said he had information that his wife wanted to relocate from Nigeria with the children.

"I want custody of the two children. The reason I sought for revocation was because my wife had turned my step-daughter against me and at that point, I got a hint that she wanted to fly the children abroad. I have never been married to any woman before I got married to my wife. I married her after she had her daughter.

"I earlier said the issue of revocation was because I felt she wanted to use me. My Lord, look at the precedence of how I have treated the girl from the very beginning. I am an actor by profession and I travel to locations within and outside Nigeria where I can spend five days to one month.

"At the moment it may be difficult but I am thinking about the future when I remarry and get a stable wife," Ikeagwu said. Justice Christopher Balogun had earlier ordered the children to play with their father in court and ordered the respondent to present the receipts of the tuition fees of the children in court.

Balogun said: "According to the Child's Right Act, you cannot deny the children the best education even if you're quarrelling with your wife. If I should as a judgment grant you a divorce, and if your wife is in Enugu and you stay in Lagos, why should I give the custody of a 10 year-old girl to you while her mother

"The Supreme Court ruled that it is not the wealth of a father that the children of that age need, they need the care and attention of their biological mother. The only reason the girl-child should not be in the custody of the mother is if the mother is mentally derailed or the issue of infidelity is involved.

"Assuming the girl starts her monthly period, you as a father do not know what to do. You will be scared of the blood. A female girl is delicate. Your own case is worse because an accusation has been levelled against you," he said. The judge adjourned the case until June 23 for continuation of hearing.



"We should all be reminded that Sunday 6th June 2022, made it exactly a year when an invading gang of killer herdsmen killed at least over 20 people in Igangan, Ibarapa North Local Government Area of Oyo State. In that particular incident, several houses, which included the Palace of the Asigangan and a popular petroleum station were burnt in the attacks at midnight when people were in their beds sleeping in their respective homes."

Ooni Ogunwusi, who is the co-Chairman of the National Council of Traditional Rulers of Nigeria (NCTRN), explained that there have been reports that some criminals are currently working to invade and wreak havoc on the entire Yoruba land, such as the one that just happened in Owo town in Ondo State.

He continued, "When calamities like this befall us without a single trace, the interpretation is that the intelligence unit of our country's security architecture is probably faulty or completely missing. In situations like this, head or tail, it is the innocent people who go about their daily lives that suffer in the process. This is why we must be careful. He regretted, that "Well-organized"

sophisticated media propaganda has been unleashed globally on Islam and its practitioners and Islam has suddenly become the black-sheep of religion worldwide. Most people with discerning minds, still know, that the true essence of the word Islam preaches and teaches peace.

"We find in the Glorious Qur'an verses prohibiting, warning and discouraging Muslims from killing innocent souls. But somehow, those verses are not trending in the media landscape because nobody wants to hear good news about Islam once it has been painted to be evil.

Allah says in Qur'an Chapter 5:32: "If

Allah says in Qur'an Chapter 5:32: "If anyone killed a person, not in retaliation of murder, or (and) spread mischief in the land – it's as if, such a person has killed all mankind, and if anyone save a life, it would be as if he saved the life of all mankind."

"What does retaliation of murder means? Retaliation of murder as in the case of a soul for a soul and not mob action against innocent souls. A case of apostasy, a case of Zina, a case of highway robbery or their likes.

"In one verse, the Muslims have been warned from any thought of killing an innocent soul and at the same time introduced to the nobility of saving a life in the most encouraging way. When we save one life as Muslims, we have saved the entire humanity. The reward for such actions is usually immense.

"I want the thread to be short, otherwise, we have many verses and Hadith of the Prophet, peace be upon him, on the dangers of bloodshed and the greatness of refraining from that." He added.



plate no MKA - 469 YJ carrying Onions and Potatoes coming from Zaria enroute Ore, had a stopover at Ondo town and was attacked by men of the underworld around 0110 hrs. In the cause of this attempt, the robbers shot the driver, while the motor-boy escaped with bullet injury, a motorcyclist alongside the pillion and a passerby were also hit by stray bullets.

"It is however disheartening that these peddlers, who are out to achieve no good, did not confirm the story before spreading this falsehood as the victims involved in this failed robbery are from Yoruba, Igbo and Northern extraction.

"While presenting the cheques to the next of kins in the presence of family members, the Commission of Police appreciates the Inspector General of Police for such laudable initiative to provide succour to the families of the deceased personnel and encouraged the beneficiaries to effectively manage and judiciously use the resources for better welfare of the families.

Kaduna govt confirmed 32 locals killed by terrorists Kaduna Govt denies reports of aerial attack by terrorists Says NAF helicopter deployed to engage bandits

About 32 people have been reportedly killed by terrorists popularly referred to as bandits during an attack in some villages in Kaduna State on Sunday.

The State's Commissioner, Ministry of Internal Security and Home Affairs, Samuel Aruwan, confirmed this while giving a security update on Thursday and added that the government mourns the gruesome killing and burning of houses in the attacked locations.

Aruwan named the villages attacked by the bandits as Dogon Noma, Ungwan Sarki, and Ungwan Maikori in Kajuru Local Government Area of the State. Adding that security agencies and traditional leaders the locations have been updating the government on the development since the incident on Sunday.

According to the reports, the bandits stormed the area in large numbers on metargulas.

large numbers on motorcycles and proceeded to raze several houses, as they attacked and killed locals.

Aruwan identified those killed at Dogon Noma Ahmadu Musa, Audu Dandaura, Akilu Laya, David Wasika, Hajatu Buhari, Nashon Buhari, Iliya Yaki, Javan Mairabo, Jackson Adamu, Nasco Victor, Dutse

Gwamna, Joshua Amadi, Gona Isah, Douglas Yakubu, Phineas Joel, Tanimu Umaru, Abody Iliya, Wanzami Halidu, and Iliya,

Dogo Aweh.
Others include Sunday
Shittu, Rejoice Audu, Jedidiah Ayawa, Jinkai Pius, Rebecca Ayafa, Ishaya John, Audu Danladi, Jibo Sule, Yakubu Garba, and Williams Danbaba.

The Ungwan Sarki village, Maikasa Kufana, and Augustine Bahago were confirmed killed Mamiya Maikori was killed at Úngwan Maikori

Meanwhile, the Kaduna State government has debunked a report published in some dailies suggesting that the victims of the attack were killed

by terrorists using a helicopter. According to Aruwan, "The Kaduna State Government wishes to make a clarification based on reports received since Sunday. The bandits attacked the first two locations and killed 31 citizens. They then headed into Ungwan Maikori, where they killed one person and burnt some houses.

"An Air Force helicopter (under Operation Whirl Punch) dispatched to the area, had earlier scanned the first two locations and sighted burnt houses and proportion on fire houses and properties on fire.

"The helicopter intercepted the bandits at the last location Maikori) (Ungwan engaged them as they retreated, before the arrival of ground troops to the general area."

He further disclosed that It

was the arrival of the air asset that deterred the bandits from further attacks on the citizens in the village after the bandits had already killed one local

and burnt several houses.
"The story that a helicopter provided air support to the bandits against the locals, is therefore an untrue account.

"The Government of Kaduna State having gone through all the facts finds it

regrettable that a section of media would circulate an unverified report, insensitive to its implications on national security, law, and order.

"Evewitnesses peddled report of a helicopter aiding bandits in the killing of innocent citizens are invited to present their accounts to Government-backed by incontrovertible facts." added.

Aruwan said the military, police, and other security agencies working in the general area deserve commendation and motivation, rather than demoralizing allegations.
"In the last 72 hours,

security forces have conducted vigorous operations in the same general area, and are on the trail of a wounded notable terrorist

'Similarly, kidnapped victims, including an expatriate kidnapped at a mining site, were rescued after a fierce engagement with bandits," he said.

He said Governor of the State, Nasir El-Rufa'i, on receiving reports of the attack, expressed deep sadness and prayed for the repose of the victims' souls. The Governor also conveyed his heartfelt condolences to the families of

Terrorists invade Borno community, kill 25

About 25 scavengers also known as 'Yan Ajakuta', in Dikwa LGA of Borno State have been reportedly killed by members of the terrorist group, Islamic State West Africa Province (ISWAP).

The victims were said to have been shot by terrorists who rode on six motorcycles at Mukdala village, located about 10 kilometres north of Dikwa town on Wednesday.

A member of a Civilian Joint Task Force in the State, Takno

Ibrahim, said the victims were shot multiple times. He added that some of the victims escaped with bullet wounds and were taken to the General Hospital in Dikwa town by officers of the military and task force.

An evewitness, who spoke on the condition of anonymity, said he was on the farm when he heard the sounds of motorcycles from a distance. The witness said he quickly hid in the bush before he started hearing sounds of gunshots from a distance.

"It was later that I discovered that they killed a lot of people," he said.

The development comes days after 32 people were reportedly killed in an attack on four communities in Kajuru LGA of Kaduna state.

Kaduna The government confirmed the killing of the locals on Thursday in a security update by the State's Commissioner of Ministry of Internal Security and Home Affairs, Samuel Aruwan.

The Legislature in Nigeria since 1999

wing to the historical fact that the legislative arm of government in Nigeria has always suffered a hiccup each time military mis-adventurers sacked any government, this vital organ in democracy has remained diffident and subservient to the whims and caprices of the Executive branch. Sadly, since 1999, the Executive branch as represented by the President and State governors, has seen itself as senior and the most powerful of the three arms of government. This is antithetical to the letter and spirit of democracy. Nowhere is this subservience and dithering found as in the Houses of Assembly in the country.

In December 2021, the Delta State House of Assembly (DSHA) approved a loan request by Governor Ifeanyi Okowa for an N20 billion facility from Fidelity Bank Plc. The Speaker of the DSHA, Rt. Hon. Sheriff Oborevwori, read the letter of the governor to the legislators requesting for a loan to finance the state government's five percent equity in the UTM offshore Limited Floating Liquefied Natural Gas (FLNG) Project.

With less than 13 months in office, and only 5 months after the approval of 20 billion was granted, DSHA has approved a "bridging finance facility" of a N150 billion loan for the government that has barely one year to the end of its tenure. Its purpose, government explained, is to settle the arrears of 'unpaid certificates earned by contractors with respect to the completion of some critical ongoing legacy projects awarded by past and present administrations in the state. Part of the loan would be used to pay outstanding pension commitments to the State and Local Government Areas, amounting to N20 billion and N10 billion respectively.

What happened in Delta State is common in all the legislative houses in the country. The National Assembly is equally guilty. The legislature under the Executive system of government is a major arm of the three arms or organs of government. It is not a junior partner. It is one of the defining features of democracy. Being the law-making body, it serves as the guard and guide of the Executive arm.

The principle of representation is mostly reflected in the legislature since every constituency is represented

in the various legislative houses. The power of the legislature is enamoured by its ability to issue or withdraw funds to the Executive arm through appropriation bills. It could query, rightly impeach, or out rightly sack the executive from office. In the absence of a strong opposition party, the legislature is expected to be the critical arm of governance. It is therefore sad that the legislature in our democracy has reduced themselves to mere rubber stamps of the Executive arm.

Various reasons have been averred for this timid and robotic attitude of legislators. Some of them are contractors to the government, full-time politicians whose survival depends on fat hand-outs from the Executive, a hangover of the long years of military dictatorship that never had a legislature as well as naivety of those parading themselves as legislators.

What we have today is a far cry from democracy. It is executive dictatorship!

Committees of the National Assembly with oversight functions failed to detect huge fraud in the national treasury. Why the silence of this arm of government in the face of open thieving? In saner climes, the National Assembly would have summoned the relevant government agencies to give explanations. Insecurity in Nigeria, the prevalence of unknown gunmen, bandits, terrorists, kidnap cases, the collapse of our public health and education sectors, mass unemployment, collapsed industries, a failed economy, and food crisis are enough matters for a conscientious National Assembly.

We strongly believe that the Nigerian legislature has failed in the assignment entrusted to her by the people. They are merely self-seeking egoistic people. For a few, the legislative houses are nothing but protective bunkers where politicians hide from being probed as former governors, ministers, drug barons, etc. A nation's national assembly is a place for seriousminded persons who are highly knowledgeable in state affairs. We have not been so blessed with such an assembly of people here in Nigeria. Hence the call for a unicameral assembly at the national or at the extreme a return to a much cheaper system of governance at the State and or National levels that the Parliamentary system offers.

It must be pointed out that history will not exonerate the legislature from the sorry state of the country. Members of the National Assembly and State Houses of Assembly should brace up and begin to make laws that would guarantee the purpose of government. Nigerians expect a government that promotes the common good, protect lives and property, secure the economy as well as promotes justice and fairness across its citizenry.

The time has come for Nigerians to organize and mobilize themselves through non-Governmental organizations, trade unions, and the civil society to activate the processes of recall as entrenched in the Constitution to put so-called 'representatives' on their toes. The level of political participation must be stepped up by citizens. There cannot be effective democracy without informed public opinion and political participation by all. Currently, Nigeria cannot afford a docile and timid legislative assembly.







Welcome father, son and holy spirit

Since the early days of the church, the doctrine of the Trinity has never been without contentious argumentations. The early Church excommunicated heretics and burnt books on account of this doctrine. The doctrine of Trinity can be explained in an analogy from geometrical model. What we see in an object isthree angles. But we call it a triangle. Equally, wherever and whenever we encounter the divine in word, thought and deed, we encounter Him manifest Himself as FATHER, SON and HOLY SPIRIT. This is called TRINITY, or simply TRIUNE God.

God walked with Adam in the Garden of Eden. But Adam fell because he was unholy and disobedient. God therefore separated Himself from man. However, because of His Divine love, God sent His son whom He gave total power to restore man to Himself, the Godhead (John 3: 16). Whereas the Scripture is replete with the "visibility" of God the Father, and Jesus Christ His incarnate Son, the Holy Spirit, the third person in the Godhead is hidden. Indeed, theologians often call it the "shy partner". At creation, and to redemption and ultimately to the time of rapture the eternality of the Trinity is acknowledged by the Church. This is called the 'Eternal

By 'eternal' we mean that which transcends time and space. An eternal being is not bound by time. It is not subject to space. In the Bible, eternality is often expressed in terms such as 'for ever and ever,' 'as it was in beginning ...,' 'world without end,' 'the same, yesterday, today and forever.' Paul expressed it thus: "Blessed be the God and Father of our Lord Jesus Christ who has blessed us in Christ with every spiritual blessing in the heavenly places, even as he chose us in him before the foundation of the world. In love, he predestined us for adoption as sons through Jesus Christ (Ephesians 1:3-5). And in verse 13 Paul writes further, "In him you also, when you heard the word of truth, the gospel of your salvation and believed in him, were sealed with the promised Holy

Spirit."
The living Church of God is what it is today because it is powered by the Divine, holy and eternal triune God. The theologian and scholar, Daniel N. Schowalter, stated that because the Trinity is such an important part of later Christian doctrine, it is striking that the term does not appear in the New Testament. [But] while the New Testament writers say a great deal about God, Jesus, and the Spirit, of each, no New Testament writer expands on the relationship among the three in the details that later Christians do. The earliest New Testament evidence for the tripartite formulae comes in 2 Corinthians 13:13, where Paul wishes that "the grace of the Lord Jesus, the love of God, and the communion of the Holy Spirit" be with the people of Corinth. This 'prayer' of Apostle Paul – called the Grace - is the most popular and common Christian prayer and benediction. Each time we proclaim it we are as well acknowledging the completeness and eternality of the Triune Godhead.

The biblical basis of Trinity can be inferred in the following ways. (i) At creation there was Trinity: "And the earth was without form, and void, and darkness was upon the face of the deep. And the spirit of God moved upon the face of the waters (Genesis 1:2); God says, "... Let us make man in our image, after our likeness..." (Genesis. 1: 26). Also, "Come, let us go down and there confound their language, that they may not understand one another speech" (Gen. 11: 7). So even in creation, the fact of God having other Beings with Him can be confirmed Biblically. The sure way is to know who they – the other Beings - are in the Scriptures. Clearly, the appearance of the Holy Spirit and Jesus Christ Himself are the ways God has interfaced His creation. Hence, Trinity is established. David, as a Prophet and Patriarch of old, even before the incarnation of Jesus, called Jesus Christ LORD (Psalm 110:1).(ii) At man's fall God released His Holy Spirit to keep His select, for the prophecy came not in old time by the will of man; but holy men of God speaks,

as they were moved by the Holy Ghost (2 Peter 1: 21); (iii) God made the incarnation of Jesus Christ possible by the power of the Holy Spirit: "And the angel answered and said unto her the Holy Ghost shall come upon thee, and the power of the Highest shall over shadow thee... (Luke 1:35); and (iv) God manifested His approval of Jesus at Baptism through the incoming upon Jesus by His Spirit (John 1:32); and Jesus Christ was empowered by God for His ministry with/in the power of the Spirit (Luke 4:14). God made Jesus to endure the cross (Heb. 9: 14) and resurrect by the power of the Holy Spirit (1 Pet. 3:18). "For Christ also hath suffered for sins, the just for the unjust, that He might bring it to God; being put to death in flesh, but quickened by the Spirit."

Today, Christ Jesus has poured upon His Church the Holy Spirit that is still actively doing the work of the Father and Son in the Church of God. So, Jesus Christ still speaks to us, "And I pray the Father, and He shall give you another Comforter, that He may abide with you forever; even the Spirit of truth" (John 14:16, 17). Christ did not give his Church a dated or one stance Holy Spirit. The Spirit is given eternally to the Church for ever."And when He is come, He will reprove the world of sin; and of righteousness, and of judgement"

What lessons can we take away? Do we see the unity, harmony and cooperation among the Persons of the Divine Godhead? Don't we humans have the attitude of "I can do it alone"? God worked the work of redemption and salvation with His Son and the Holy Spirit. He gave them power to function. The Apostles' question: "Did you receive the Holy Spirit when you believed" (Acts 19: 2)can be reinterpreted, as "where you connected to God's power through Jesus Christ when you believed? Hence in Acts 10:44, "When Peter was still speaking, the Holy Spirit fall upon all who heard the word. The circumcised believers who had come with Peter were astounded that the gift of the Holy Spirit had been poured out even on the Gentiles, for they heard them speaking

in tongues and extolling God."

As Jude (19-20) notes, "It is these who cause division, worldly people, devoid of the Spirit, but you, building yourselves up on your most holy faith and praying in the Holy Spirit, keep yourselves in the love of God, waiting for the mercy of our Lord Jesus Christ that leads to eternal life."As we commence the last and longest season in the Church's calendar, I pray with you in this wonderful words of the Collect for Trinity. "Almighty and eternal God, You have revealed yourself as Father, Son and Holy Spirit, and live and reign in the perfect unity of love. Hold us firm in this faith, that we may know You in all Your ways and evermore rejoice in Your eternal glory, who are Three Persons in One God, now and for ever." Amen

Olabayo is not a stranger to controversies. "I had wished it was possible for the whole country to observe a week-long prayer in unity, Muslim, Christians and Pagans alike to jointly pray for God's mercy over our people and land."

It was after this opening statement and without much ado, we delved into this no-holds-barred interview.

Trumpet: Primate, what could be the reason for this gloomy and deep-seated grief you are expressing?

Primate: I am extremely sad, because all these people, who call themselves politicians with no exception whatsoever, don't know about the heavy wrath of God that awaits them. If you tell them, and they get to know, some of them will immediately shake it off as a huge joke. But sadly, if some of them get to know the great tribulations that await

them, some of them might drop their political ambition and look for something else to do.

Nigeria has bled enough, due to the recklessness and inhuman activities of most of our political leaders. God is about to punish them now and their collaborators. Sadly, they will be made to pay with so much pain, with some members of their immediate and extended families. God's punishment is coming now, because of all the crimes they have been committing against the people and the land. None of them will be exempted.

The two dominant parties, the Peoples Democratic Party, (PDP), and the All Progressive Congress, (APC) alongside other political parties in the country that are pretending to have concluded their party's primaries. As they now get ready to run for the office of the President, the highest office in the land, they will all be disappointed. There will not be elections at the end of the day as the political tension would be so tense, that it will not be conducive to conduct a free and fair general election in the country. Also, there will be massive political related assassinations and so many other evils across the land.

Then, that will be the beginning of the catastrophic consequences that await our politicians, during and before the conclusion of this political process. Mark my words, there are going to be massive political assassinations across the nooks and cronies of this country called Nigeria. There is going to be massive bloodshed, like never before in the recent political history of this country.

God has said, in the ashes of all these deaths and political dramas, he will, eventually, raise a good leader that will take Nigeria to the promised land. But before the emergence of this leader, there will be suffering, famine and hunger in the land. People need to be very careful before they incur the wrath of God. As soon as Muhammadu Buhari took over power from ex-president Goodluck Jonathan, I made it very clear to whosoever cares to listen, saying that "President Buhari was going to create more problems for Nigeria, during and after his tenure as Nigeria's President. And this is exactly what has happened.

I stopped talking because corruption had pervaded all the facets of Nigerian society. Never a time did I ever say that Muhammadu Buhari was the Messiah Nigeria was waiting for? Never! If I had mentioned what God showed to me then, people would say that I needed money from the APC government. That was why I tried to rattle the President and his government. Your guess would have been as good as mine. And the government gadflies would have again been let loose on me. Unlike in the past, I am now old and fray, I can no longer run abroad as I did during the military regime of General Abacha.

At some points, it became very clear that he was going to deliberately divide the already troubled and fragmented country, Nigeria, along ethnic and religious lines. But my close associates will attest to these claims, several times, I told them, "It will take the grace of God for Nigeria to survive as one united and indivisible country after President Buhari's APC government misrule. The deep shit we are in today is clear for every Nigerian to see both young and old.

The blood of all the innocent lives that have been cut down at their prime are now crying out for vengeance and justice. The way things will turn, later on, will be unimaginable. The EndSars riots will be a child's play. There will be a massive uprising that will shake the country to its foundation. People who served in governments, who aided and abetted in all these evils, who now think they will be able to escape with their loots, will invariably suffer for their sins. Without anyone going near them, they will begin to die mysteriously with some members of their immediate families.

God wants to show them that he is truly God, not man. So many of these people will be brought back by the masses to face judgment

Some of them in government today, who now have the means to relocate to other lands with members of their immediate families, should begin to do so immediately. They don't need to wait until the expiration of their tenure in government. They will soon realize that they do not have more time in their hands.

But one thing is certain wherever they go in this world, they will never know peace because of the injuries they have deliberately inflicted on this country and its people due to selfishness.

Go and mark my words today. The atrocities of the Islamic fundamentalists across the country will further intensify as soon as President Buhari vacates office on May 29, 2023, as they will try to take over Nigeria, and declare it an Islamic State. They are determined at fragmenting the country. We, therefore, need to pray very well, for us to still have a country called Nigeria.

The recent Massacre at the St Francis Catholic Church in Owo town will be a child's play, compared to so many similar incidents that will happen across Nigeria in the foreseeable future. It will be so intense that the Nigerian Security system and agencies will be overwhelmed and look helpless. But God will intervene at the end of the day. Most of the people presently parading themselves as Nigerian leaders will end up in prisons. And they will be made to pay heavily for the havoc they committed against the land and the reckless manner they raped our country and its resources.

For all these heartless evils against the land, the spirit of the people that have been killed over the years will begin to fight, very soon, you'll begin to see very important people across the land dying without knowing how or what killed them.

If you must know, I never for once thought in life that I would live up to my present age of 76 years. But God in his mercy is preserving me because he wants me to witness the surgical operations he is about to carry out across the length and breadth of this country Nigeria. I, therefore, owe it a duty to speak out, whether people in government like it or not.

Let me repeat, between now and December this year, people should learn to stockpile foodstuffs in their homes because the kind of famine that will soon fall on this country will be intense, and parents will begin to sell their children unashamedly.

Let me sound this note of warning, the Lagos state government needs to be more serious about its internal security.

Trumpet: How do we stop extremism among the Christians and Islamic followers?

Primate: Extremism is flourishing because Nigeria never had a good leader. It became more intense during this dispensation just because of the body language of our present President.

As all these ugly incidents happen, Nigeria will continue to manage to remain one country. But after some years if the people bent on destroying this country continue unchecked, Nigeria will eventually break up. And become severed countries, just like the old Soviet Union.

But for now, let us continue to pray, and hope that people with the fear of God, take over the affairs of this country, and be firm in their decision making processes. Only then will we see a New Nigeria.





NLC president canvases universal protection for workers

The Nigeria Labour Congress (NLC) has canvassed for a universal protection cover that would address the challenges of COVID-19 pandemic and other future occurrences that require such an intervention.

President of the NLC, Ayuba Wabba, said this while speaking

with newsmen on the sideline of the ongoing 110th session of the International Labour Conference (ILC) in Geneva, Switzerland.

"We are working assiduously on the issue of universal social protection, one of the issues that have come up very clearly with the COVID-19 pandemic is the fact that we do not have any means of social protection.

"Unlike other climes, everybody benefits from social protection whether you are in small or medium-scale enterprises or unemployed. They have a database and they use the database to transfer money directly into the account of everybody. A fraction of the taxes being paid is actually paid as a social security cover

for workers to actually address issues of COVID-19 pandemic," he said.

Wabba also noted that when the COVID-19 pandemic started there was threat of mass sack in which the NLC reached an agreement with employers of labour, adding that Nigerians were the first among unions and employers in Africa to actually have an accord so that they should also protect the sustainability of the production lines.

The agreement was signed to say that we would not support any company or any establishment that would just use the COVID-19 scourge excuse to sack workers just like we had with Access Bank that want to actually sack workers en masse," he said.

He explained that the agreement was still subsisting and thank labour had kept watch to ensure that the agreement would be respected by all employees, stressing: "I can say that Nigerian employers are organised labour are on the same page, as the challenge of COVID-19 pandemic should not be used to sack workers en masse," he stressed.

On occupational safety, Wabba said most workers were affected as there are no provisions for them to receive social protection

"This time around, labour centres around the world including the working class have put on the table to make occupational health and safety fundamental human right. It is the first instrument that the 110th session has already passed and it will be adopted during plenary.

"Part of the instruments to drive that particular decision is convention 155 and convention 187 of the International Labour Organisation (ILO), which are fundamental conventions of the occupation health and safety. I think with that we would be able to go back home to domesticate these two important conventions,"

Maritime agencies commit to national single window

•We're on the verge of concluding automation processes, NIMASA DG

¬ederal Government Agencies under the auspices of the Federal Ministry of Transportation (FMOT) have reached an agreement to digitalise their internal processes, while also maintaining focus on actualising the National Single Window regime in the nation's transportation sector.

This agreement was reached at the fourth Heads of Maritime Agencies meeting in Lagos.

Addressing the press after the meeting, the Registrar of Council for the Regulation of Freight Forwarding in Nigeria (CRFFN), Sam Nwakohu, disclosed that full automation of the internal processes of the various Agencies represented, is a pre-requisite to achieving the much anticipated National Single Window regime in the sector.

Nwakohu, who was the Chairman of the meeting, said the Chief Executive Officers (CEOs) of the various agencies have agreed on timelines

to achieve full automation of internal processes. "We have agreed that all agencies under the Ministry of Transportation should, as a matter of priority, attain full automation. This process will be well coordinated and we also gave ourselves timelines to achieve this," he said.

On his part, the Director

General of the Nigerian Maritime Administration and Safety Agency (NIMASA), Dr Bashir Jamoh, said NIMASA's automation processes have reached over 80 per cent completion and assured that NIMASA's commitment to automation will reduce human interface while plugging revenue leakages in the system.

"In line with the Federal Government's Executive Order on Ease of Doing Business, we are committed to full automation to attain reduction of human interface in majority of our transactions with our stakeholders and this is in our bid to ensure transparency and professionalism, which the sector requires to grow. The goal is to align with the National Single Window initiative when all the internal processes of the various Agencies have been concluded,"

Commenting on the high freight rate occasioned by the War Risk Insurance placed on Nigerian bound vessels Jamoh stated that the Agency would focus on creating the awareness, while also canvassing the International Community for a review. This move is in relation to the removal of Nigeria from the global piracy list.

'It may interest you to know that by the end of this quarter, which is the end of June, we would have recorded another milestone as we are yet to record a single attack or incident of maritime insecurity on our waters. Therefore, we will keep advocating for the total removal of War Risk Insurance by the international community, so that Nigerians can benefit from that," Jamoh stated.

It would be recalled that the maiden edition of the meeting was in 2020, with the aim of enhancing the synergy and cooperation of agencies under the supervision of the FMOT, which is intended for a more effective and efficient maritime sector.

The meeting was attended by Managing Director of the Nigerian Ports Authority (NPA), Mohammed Bello Koko; Executive Secretary, Nigerian Shippers' Council (NSC), Emmanuel Jime and Managing Director of the National Inland Waterways Authority (NIWA), George Moghalu.

Others are Managing Director, Nigerian Railway Corporation (NŘC), Fidet Okhiria; Rector, Maritime Academy of Nigeria (MAN) Oron, Emmanuel Duja Effedua and Director General, Nigerian Institute of Transport Technology (NITT), Zaria, Bayero Salih-Farah Zaria.

STANMEG Communications noted that using rigorous research tools will bridge the huge gap in the financial services system with the exclusion of some members of other social strata.

Since 2005, the Nigerian financial services sector has witnessed increasing activities by the government and regulatory authorities aimed at deliberately promoting policies geared towards expanding financial inclusion.

The Central Bank of Nigeria (CBN) has been championing the encouragement and supporting products specifically targeted at the low income and financially excluded, while the government has focused more on interventionist financing arrangements, as well as building institutions and frameworks that promote financial inclusion.

"Financial exclusion has significant outcomes for the real sector as lack of access to credit can be a disincentive to entrepreneurship, investment and economic growth. It also has assumed greater level of importance in recent times due to its perceived importance as a major driver of economic growth.

iving access to the l of millions of people who are presently excluded from financial services will provide the possibilities for the creation of a large depository of savings, investable funds, investment and therefore global wealth generation," the statement added.

The organisers of the conference pointed out that access to financial services that are well suited for low-income earners would promote enormous capital accumulation, creation of credit and boom in investments.

Expert tasks government agencies to support oil palm research

Managing Director of Presco Plc, Felix Nwabuko, has urged government agencies to support oil palm research to boost export and economic development.

Also speaking, the Commissioner for Agriculture and Food Security, Stephen Idehenre, said the Edo State government was working hard to boost oil palm production in the state.

Idehenre said the state government was collaborating with Presco and other stakeholders to produce quality seedlings for Nigeria and the international markets.

On his part, President of the Nigeria Agricultural Business Group (NABG), Emmanuel Ijewere, described oil palm as "the future of Nigeria and Africa's economy."

In his presentation, representative of Siat Group, Rein Dan, who spoke on the outcome of the research conducted with partners of the group, said the development would boost growth and sustain profitability.

He said Siat Group started a 20-year collaboration with CLRAD, PALME and other organisations to the project implemented at Presco to pioneer the establishment of trials covering some 500 hectares

"This project, developed in Africa and one of the largest of its kind in the world, engages over 120 full time workers to monitor the growth, production and oil extraction rate. Results indicate that oil yield in Nigeria has reached over five times more than the global average.

These efforts by ensuring perpetual and regional adaptation, not only provide the Siat Group with guaranties regarding materials used. It also safeguards the sustainable growth of the African Oil palm industry in general, primarily by increasing yield and thus reducing the need for land conversion or deforestation,"

Manufacturer decries worsening power supply in Nigeria By JOHNMARK UKOKO to month, the reverse is the case, adding: "I am tired of complaining power supply and the high cost of power supply and the high cost

Managing Director of Liberty Industries Limited, Kamal Abuh, has lamented the lingering power outages in the country, saying that he does not understand why despite President Muhammadu Buhari's financial interventions in the sector in the last seven years, power supply has not improved.

Abuh, who spoke with The Trumpet in a telephone interview, disclosed that due to the worsening public power supply, the cost of running his small factory continues to rise every month.

He lamented that instead of power to increase from month

about the erratic power supply in the country. The more investments the government makes in the sector, the worse power supply becomes.

"The cost of powering my small factory has continued to rise month by month. A few years ago, the Manufacturers Association of Nigeria (MAN) commissioned a research to find out how much its members used to power their

The result said that manufacturers spent an average of 30 per cent of their cost of production on power generation. Currently, power generation gulp as much as 50 per power supply and the high cost of diesel and gas, has astronomically shut up the cost of my production. I know I am speaking the views of most other manufacturers.'

He berated the power generating and distribution companies, stressing that they kept on giving one excuse or the other on why power supply keeps degenerating without showing

efforts to change the situation. Abuh said the past three weeks have been quite challenging due to the poor power supply, adding his firms can't be buying diesel at about N500 per litre, adding that the government has not done well in the area of power supply.



Tenancy Agreement in Nigeria

A Tenancy Agreement is a contract between a Landlord and the Tenant which sets out the rights and obligations of both the Landlord and the Tenant when renting property in Nigeria.

A Tenancy Agreement is not compulsory, and the fact that a tenancy agreement does not exist in a tenancy relationship does not mean that the Landlord and Tenant have no rights in the tenancy. Both Landlord and Tenant have something called implied rights in all Tenancy relationships whether or not a Tenancy Agreement exists. However, a Tenancy Agreement is important because it provides further protection for both the Landlord and Tenant, and it expands on the implied rights.

If you are a Landlord about to rent out your property, or if you are Tenant about to rent a property, it is advisable that you insist that there is a Tenancy Agreement.

Who Originates it?

In Nigeria, the Tenancy Agreement is in most cases created by the Landlord or their lawyer. As the Landlord is the owner of the property, they set the terms on which they want to rent their property and present this to the Tenant. Nigeria Property Centre has developed a service for Landlords where they can create their own Tenancy Agreement with the use of the NPC Document Service.

Tenant's rights

As the Tenancy Agreement is a contract between two parties the Landlord and the Tenant, the Tenant has the right to review the terms of the Tenancy Agreement to determine whether or not the Agreement protects his/her interests. Most Tenancy Agreements are straightforward and easy to understand; however, it is advisable where possible to get a lawyer to review the terms and advise on how they affect the Tenant's current and future rights.

Content of a good Tenancy Agreement

As a Landlord or a Tenant, you need to ensure that your Tenancy Agreement includes the following terms and information at a minimum:

The names and addresses of

the Landlord and the Tenant The address of the property
The start date and end date

. How much the rent will be Other applicable amounts including – legal fees, agency fees, security deposits, service charges, fees etc as applicable

The obligations of both the Landlord and the Tenant

. An outline of bills the Tenant is responsible for

The above list is not exhaustive and in fact, there are more terms that are frequently included in well-drafted Tenancy Agreements. Before renting a property, it is important that a well-drafted Tenancy Agreement is signed by both parties as it is the most important document in the tenancy relationship.

The Commissioner urged members of the estate to rise against perpetrators of such unfavourable acts, who sacrifice the common good of the area for their parochial pecuniary interests and carry on in a way that is inimical to the wellbeing of residents and sustainability of the scheme.

According to him, measures put in place by the government to control development in the estate and elsewhere in the state include the imposition of penal fees to discourage illegal and non-conforming developments, regular monitoring and enforcement as well as outright removal of the contravention where possible.

On the Onikosi land tussle, he assured that the solution was just an inch away as the committee set up to resolve the matter was making progress, which might result in the creation of a new scheme to accommodate the Onikosi Village excision and prevent the emergence of a slum around Magodo Scheme II.

The Special Adviser, E-GIS, Dr Olajide Babatunde, asked the residents association to foster regular stakeholders engagements and come to terms with the myriad problems facing the scheme.

On her part, the Permanent Secretary, Ministry of Physical Planning and Urban Development, Abiola Kosegbe, urged members of the estate to support the enforcement drive and other initiatives of the Ministry.

The Chairman of, Magodo Residents Association, Bajo Osinubi, sought the assistance of the ministry to restore the scheme to its original plan and also wade in for an amicable solution to the ongoing land tussle in the area.

FG's housing projects expensive

Housing prices introduced by the Federal Government under the one-bedroom flats between N1.5 million and N4.5 million in Abuja National Housing Programme (NHP), have been causing outrage across the country as private developers have picked

shortfalls in the housing scheme. They believe that the programme is not affordable, justifiable as it is beyond the low-income earners who are the original target of the scheme and may breed corruption among civil servants. They said the government should concentrate on making policy than engaging in housing construction.

The Minister of Works and Housing, Babatunde Fashola had unveiled a portal for the housing scheme recently and urged Nigerians to apply for allocation of available 5,000 plus housing units, ranging from one, two to three-bedroom bungalows and blocks of flats in any location of their choice across 34 states and the Federal Capital Territory.

The stakeholders insinuated that prices may undermine the genuine intentions of private developers and may give rise to an increase in housing prices, as some developers are selling

and major cities. The buildings come with variations in prices as a result of the cost of building and topography.

The one-bedroom house type costs between N7, 222,404 and N9, 268,751. A two-bedroom bungalow sells for N9, 148,378 and N12, 398,460, while that of a three-bedroom ranges between N13,241,074 and 16,491,155.

The Chairman, Board of Trustees, Real Estate Developers Association of Nigeria (REDAN), Oluseyi Lufadeju, told newsmen that the pricing is not reasonable and justifiable. "If you want to build for the low-income, it's not workable. It is not the type of houses the low and mediumincome earners are looking for,"

Continuing he said, "they're looking for houses between N2.5 million and N3 million. That's why people are saying, the government has no business to build houses. It is the responsibility of private developers. Government should provide land and infrastructure as in all housing developments; infrastructure is 30 per cent of

the cost of construction." He said the government should continue to provide enabling environment in terms of low-cost financing and use of local building materials as well as facilitate the private sector because they rely on research and their research efforts have been bringing solutions. For the Professor of Estate Management, University of Lagos, Timothy Nubi, the houses are not affordable.

He said that he is not surprised by the turn of events, as the government believes that there cannot be affordable homes if the prices of cement and iron rods are high.

Nubi, who is also a member of REDAN, urged the Muhammadu Buhari administration to study the blueprint of the late Lateef Jakande that enabled him to provide low-income houses in the country.

He lamented that what is supposed to be for low-income earners are now out of their reach. "It is better for the government not to go into housing and come up with such ridiculous prices," he said.

Nubi said that it is the wealthy that will buy up the houses as no civil servant or lecturer can afford such houses. He added: "They're telling the civil servants to go and steal, which will fuel

corruption in the society."
The REDAN Vice President, and Chairman, South-West zone, Debo Adejana, said with the Federal Mortgage Bank of Nigeria (FMBN)'s National Hous-ing Fund (NHF) loan scheme more middle-income earners in the formal sector should be able to secure these properties if they can find any that meets their needs.

"For the low-income earners, I am sorry to say that I cannot see how they will be able to afford any of the properties, except there is a highly subsidised or social housing component to the offering which I have not heard of.

On the impact of the prices on real estate, Adejana said: "Private developers do not need the government hosting prices to move their prices. Prices have already moved and keep moving based on the performance of building material prices.

A situation where most construction inputs have more than doubled in price in the last year does not need government housing prices before private developers adjust their prices. It is simply market dynamics of demand and supply at play." Clarifying the decision to adopt online sale of forms, Fashola said, "It is just to make the system more accountable and people seeing credibility if they win, and if they are not successful they will equally know that the system has at least given them a fair chance."

He explained that the government did not just set out to build houses, adding that the project has served many purposes, the first of which was to test what sort of houses Nigerians would like to live in so as to make policies to guide its agencies and parastatals, as well as other stakeholders, to build what could

be acceptable in the markets. "We are the policy head of those parastatals like the Federal Housing Authority (FHA), the Federal Mortgage Bank of Nigeria (FMBN) and so on.

We are saying that the NHP had not succeeded in the past and some of the houses built then still remain empty. So, we conducted a national survey across the zones just to find out what is acceptable," the Minister said.

The findings, he said, were that while in the Northern part of the country there was a preference for bungalows and a large expanse of land which encouraged building horizontally, in the Southern part, there seemed to be acceptable for blocks of flats and lack of space which made building vertically necessary.

According to the minister, the scheme is a pilot or demonstration scheme meant, among others, to galvanise private sector participation.

He continued thus; "We applied for land from the states and we set out to do a demonstration or a pilot programme because we then wanted to validate what we saw and build a pilot scheme.' He added, "It was also a way to implement our Economic Recovery and Growth Plan (ERGP) because at the time we conceived this programme, the country was in recession", expressing delight that it has fulfilled that objective because over 1,000 contractors were engaged on the building sites; "businesses owned by Nigerians and Nigerian contractors.'

Dangote Cement, SON push for standard in block making

n an attempt to curb the menace of building col-Llapse across the country, the Standard Organisation of Nigeria (SON) has called on block makers and artisans have been enjoined to adhere strictly to quality production and shun acts that could compromise standards in the sector.

The Assistant State Director

SON, Lillian Gua, gave the charge in Port Harcourt, Rivers State, during a sensitisation workshop organised by Dangote Cement Plc, in collaboration with the regulatory organisation for the block makers and other artisans from Bayelsa and Rivers States.

According to Gua, block makers occupy a strategic position in the building industry, hence,

the need to make quality their watchword.

Gua said there is a need for the building artisans to know the right mixtures in the production of blocks to achieve the expected

While citing Dangote Cement as an example of a certified product, whose quality has been tested and found to be accurate, she enjoined participants to acquaint themselves with the steps and processes involved in getting a product certified so that they would not be deceived into buying fake products.

She disclosed that every certified product is issued a certificate of standard as proof of having gone through the quality test conducted by the SON.

Gua lauded Dangote Cement for organising the workshop, adding that such a forum will keep the manufacturers abreast of developments, especially, as it affects the quality and standard of products.

Technical Director, The Dangote Cement Plc, Mr Adeiza Aniki, said the workshop was designed to update and refresh block makers, and artisans on the standard and quality of blocks.

He explained that Dangote Cement sees the participants as a critical force in the cement value chain and has, therefore, made the workshop a periodic exercise to get feedback from the market and help in meeting the demands of customers at all times.

Aniki urged participants to contribute to the efforts at mitigating the collapse of structures in the country. According to him, one of the ways they can do that is through adherence to quality and exposing bad eggs in the business.

"Check for excess amounts of dust in cement, which is called a float test. To do this, put a small quantity of cement in a bucket of water. If the cement floats on the water for some time before it sinks, the cement is of good quality. If the cement sinks immediately it touches the water, the cement is bad quality cement," he said.

The technical director added: "Rub the cement between the fingers and if it gives a smooth feeling, the cement is of good quality; but if it feels gritty or rough, it means other substances have been added. This is a sign of bad quality cement."

N544m Fraud: I was framed – Babachir Lawal

Tormer Secretary to the Government of the Federation (SGF), Babachir Lawal, has said he was framed in an alleged N544 million corruption scandal against him.

Lawal spoke on Thursday during an interview with Channels Television.

Recall that in December 2016, a senate ad hoc committee on "mounting humanitarian crisis in the north-east" indicted the former SGF of fraud in a contract awarded for the clearing of "invasive plant species" in Yobe state, through the Presidential Initiative on North East (PINE)

PINE, which was under Lawal, was at the time unable to account for N2.5 billion allocated for poverty alleviation for IDPs. The Senate ad hoc committee accused the former SGF of using N544 million to cut grasses.

Subsequently, the Economic and Financial Crimes Commission (EFCC) arraigned Lawal and others over alleged fraud.

President Muhammadu Buhari in October 2017 sacked Lawal and according to the presidency, the decision was in line with the recommendation of the probe panel.

When asked during the interview on Thursday if he felt the allegation affected his public image, Lawal said the scandal has "enlarged" his profile.

He said, "On the contrary, it has enlarged my profile. The thing is in court and I have pleaded not guilty and I believe I'm not guilty. A lot of Nigerians, everywhere I go, know it was a set-up. It was very clear.

"I know some people set me up. I won't tell you. I know and they know that I know some of them have confessed."


Asked if it is right for someone who is in government to influence a contract to a company in which he is a beneficiary, the company before his appointment into public office.

"I was a member of the board for 16 companies at that time (2015). I was managing director for one. I wrote letters of resignation to those companies.

"I instructed my lawyers to disengage me from the Corporate Affairs Commission, documented, written, and even the fee paid for.

"We had the board resolution sent to the banks delisting me as a signatory to all the accounts. All these are documented for everyone to see.

"In politics, nobody was interested in all these things. What happened, therefore, was that the company of which I was a managing director, unknown to me, got a contract as a consultant to supervise a project which was called grass cutting. It wasn't grass cutting."

Alleged N3b Fraud: Court acquits Ochuko Momoh, five others

Justice Taiwo Taiwo of a Federal High Court sitting in Abuja has discharged and acquitted Ochuko Momoh, the wife of a former Managing Director of Pipelines and Products Marketing Company, Haruna Momoh, of a case of alleged fraud.

Ochuko and five others have been standing trial for an alleged N3 billion fraud by the Independent Corrupt Practices and Other Related Offences Commission (ICPC).

However, in a judgment delivered on Thursday, Justice Taiwo acquitted Ochuko and the other five accused on money laundering related charges.

Justice Taiwo, who held that the prosecution failed to discharge the burden of proving its case against the defendants beyond all reasonable doubt, also ordered the discharge of an earlier interim forfeiture order made against Ochuko Momoh and her two firms - Blaid Construction and Blaid Farms.

The Judge noted that the case of the prosecutors was based on mere speculation and conjecture.

The ICPC had brought Ochuko Momoh alongside Blessing Azuka-Agozi, Stanbic IBTC Bank Plc, Energopol Nigeria Limited, Blaid Construction Limited, and Blaid Farms Limited before a Federal High Court in Abuja to be tried on a 22-count charge.

The ICPC, in the charge, marked: FHC/ ABJ/CR/278/2019, accused Ochuko of laundering funds estimated at N3 billion through her companies - Blaid Construction and Blaid Farms.

Azuka Agozi was alleged to have reneged on her promise to provide ICPC's investigators with documents relating to the contracts Energopol Nigeria Limited allegedly executed for the PPMC, for which it was allegedly paid huge sums.

The ICPC accused Stanbic IBTC of failing to report suspicious transactions in the accounts of Blaid Construction and Blaid Farms to the relevant authorities as required by law.

In May 2019, a Federal High Court, Abuja, presided over by Justice Binta Nyako, faulted the decision of ICPC to freeze Blaid Construction Limited and its director, Mrs Ochuko Momoh's bank accounts.

Interpol, ICPC, others sign MoU on Database access

As Owasanoye vows to profile PEPs, money laundering suspects

The International Criminal Police Organisation (Interpol) has signed a Memorandum of Understanding with Nigeria's anti-graft agencies, the Independent Corrupt Practices and Other Related Offences Commission (ICPC), Economic and Financial Crimes Commission (EFCC), and other security agencies to grant them access to the global database of the organisation. The Chairman of the ICPC, Prof Bolaii Owasanove, who made this known at the end of a meeting by Heads of Nigerian Law Enforcement Agencies with top officials of Interpol in Lyon, France, said the Commission will utilise the database in profiling Politically Exposed Persons (PEPs), money laundering, and illicit financial flows suspects.

It was gathered that the Nigerian delegation to Interpol was made up of top officials of the National Central Bureau Abuja (NCBA), Nigeria Police Force, Nigerian Navy, Nigerian Immigration Service (NIS), Economic and Financial Crimes Commission (EFCC), Nigerian Financial Intelligence Unit (NFIU), National Drug Law Enforcement Agency (NDLEA), National Agency for the Prohibition of Trafficking in Person (NAPTIP) and the ICPC.

The high point of the meeting between the Nigerian delegation and Interpol was the signing of the Memorandum of Understanding (MoU) between the International Police and ICPC, NFIU, NAPTIP, NDLEA, and EFCC, which granted the law enforcement agencies access to the organisation's databases.

At the meeting, the ICPC boss discussed how the anti-corruption agency and the country could take advantage of the Interpol database in profiling suspects.

"The Commission will develop the habit of issuing notices, especially on high profile suspects. Such notices will be seen globally on PEPs in particular," Prof Owasanove said.

The ICPC Chairman also disclosed that the Commission would join the Global Focal Point Network coordinated by Interpol as part of measures to tighten the noose around corrupt and criminal persons.

Interpol is expected to support the law enforcement agencies in Nigeria through the strengthening of information sharing, utilisation of the organisation's database of global suspects, and prevention of incursion and influx of migrant terrorist fighters into

The Interpol briefed the Nigerian delegation on Operation Gemini, a special project focusing on trans-border organised crime involving migration, human trafficking, drug trafficking corruption, and financial crimes.

The International Police also held special sessions with the delegation which were devoted to international and regional cooperation in law enforcement, operational methods of Interpol and strategies for data and informational sharing, Interpol policing capabilities, role of the National Central Bureau (NCB) in Nigeria, and Nigeria Border Management strategies, integration of Nigeria Law Enforcement Databases with Interpol NCB.

Under the MoU signed with Interpol, the Nigerian law enforcement agencies will have unrestricted access to global criminal databases. It is expected that this fresh collaboration will boost the capacity of law enforcement agencies in Nigeria to fulfil their mandates.

EFCC trains officers on crypto currency, forensic auditing

anything to hide. So I guess that is the reason some people stay away from me. And that is the way I want to live my life; scandal-free, and neat. But for actors that live on scandals, I believe it is because they are still young. By the time they get it right, they will know that it does not pay.

So why did you leave acting for the corporate world?

No, I never left. I go to the office during the day and then go for movie shoots at night. And I did well on the job; I never used my employer's office time for acting. I would shoot movies on weekends, when on holiday and during my annual leave. Apart from the talent, you need to be disciplined as an actor.

Having gone into the business world and sat in the boardroom as a director, I can tell you this for sure.

Don't you consider yourself lucky as you are one of the very few active veterans; while we only get to see others when they are in dire need of assistance from the general public?

To be honest I can only say am grateful for life and family; to this end, in this acting job have gotten married on this job, I have children, I live in my house, I have my car and all of that. I'm saying this with all due respect and not because I am trying to bring people down. Now, actors from my set got trained just for the job alone and unfortunately, most directors just use you and dump you. I realized this early enough and that enabled me to see the future ahead fast. That made me go into the corporate world, I diversified earlier in my career and I have very good results to show for this.

Are you saying that actors need to foresee the future early?

Yes, you have to think. This job is not as spectacular as other jobs. If you get paid N2 million today as an actor, unfortunately, some people will squander the money the next day. Veteran, and in fact, every actor must learn to save and set some money aside for the future. Yes, you can buy those choice cars you fancy but don't forget to take care of your children and your family. I have tried to do all of these responsible things and I'm still on this job. Not all actors are irresponsible and yes acting is a serious job.

As a thespian, what do you look out for in a script?

There are good and bad scripts, and I am well trained, remember I said that. And I recognize a good script; which must have a beginning, middle and an end. It must be well defined and must have a very challenging role for me. When all those are there, it will be acceptable to me. This comes with my training and should apply to all actors.


The philanthropist who is passionate about change added, "every other investment is subject to economic indices but relentless support and empowerment of children transcend generations. So parents should keep investing regardless

In the second innings, Female Yellow Green made light work of the run chase by scoring the required total in 10.5 overs, losing just 2 wickets.

Nigeria finished with 56 runs for the loss of 2 wickets in 10.2 overs with debutant Rukayat Abdulrazaq named player of the match.

Buchanan also won eighth domestic trophies with Lyon comprising three Coupe



de France and five French topflight division league trophies.

Chelsea's statement reads in part: "Prior to moving to France, Buchanan spent four years playing college football in the States with West Virginia Mountaineers where she made 98 appearances and established herself as one of the top players in the NCAA.

"Buchanan also brings a

wealth of experience having started her international career at just 14 years old when recruited into the Canadian youth programme in 2010.

"Her first silverware came in the form of a silver medal at the 2012 CONCACAF Women's Under-17 Championship in Guatemala and she then went on to win the Young Player award at the 2015 FIFA Women's World Cup.

"The centre-back made her senior debut for her country in 2013 against China, becoming one of the youngest international players at the time.

"Since then, she has gone on to make 118 appearances and receive a host of individual honours, being named Canadian Player of the Year three times, nominated for the prestigious FIFA Ballon d'Or and featuring in the FIFPro Women's World XI. Last year, Buchanan also took home gold at the 2020 Olympics," the

statement said.

After signing the contract with the Blues, Buchanan on her part added that she comes to add value to Chelsea's squad and help the team win more trophies while soaring among world greats.

"I am coming to Chelsea with the same ambition I always had, win trophies and become the best in the world. The club has everything in order for us to compete in every competition and it's time to bring a Champions League trophy to London.

"I'm hoping to bring my experience to the team and continue on the successful pathway that the club has been on for the past seasons. I can't wait to join my new teammates and the coaching staff on this journey," Buchanan added

Chelsea noted that Buchanan in the summer will join up with the squad before heading to the States for the WICC tour in August.

CL final: Paris police apologise to tear-gassed fans

Paris police have tendered an unreserved apology to fans that were teargassed when trying to enter Stade de France to watch the UEFA Champions League final between Real Madrid and Liverpool on May 28, 2022.

Didier Lallement, who is the Paris police chief, regretted issuing such an order that caused chaos and ridiculed the image of the country.

According to Lallement on Thursday at the Senate, the decision became the last resort under such hectic circumstances.

"It is obviously a failure. It was a failure because people were pushed around and attacked. It was a failure because the image of the country was undermined," he said.

To assert his claim, the Police chief stressed that about 40,000 fans had no ticket which is the only authorised means for anyone to be allowed into the arena to watch the prestige final.

He added that some of the fans smartly came with fake tickets to beat security checks to gain entrance into the stadium but were rightly spotted.

Although, Lallement was unable to substantiate his claim according to reports by the British media.

Lallement said, "The figure has no scientific virtue but it came from feedback from police and public transport officials.

"Maybe I was wrong, but it was constructed from all the information harvested.

"Whether there are 30,000 or 40,000 people, it doesn't change anything. What matters is that there were people, in large numbers, likely to disrupt the proper organization of the filtering. But that we count them precisely to within 5000, it doesn't change much," he added.

The report revealed that Lallement's apology comes after officials of Liverpool are set to meet with the Chairman Review of the UEFA Champions League final to satisfy themselves that the process is unbiased.



Mané to Bayern, Liverpool turn to Nunez

Liverpool summer target and Uruguay international, Darwin Nunez, wants to move to the Merseyside club which will bring his spell at the Portuguese topflight club, Benfica, to an end.

With a convincing performance for Benfica that saw the sensational forward score 34 times in all competitions, Liverpool, whose player Sadio Mane is on the brink of switching to Bayern Munich, would ratify a deal for the Uruguayan.

Although reports revealed that the Reds are yet to bid for the player, they are on the watch not to contend with any club for the signature of Nunez.

While it has been alleged that United Boss, Erik ten Hag, practically rejigging the club squad, could swoop for the player to galvanise the Red Devils, Nunez, who scored against Liverpool in both legs of the UEFA Champions League quarter-finals, is valued at €100m by Benfica.

Liverpool are shopping for possible replacements for Sadio Mane and Mohamed Salah, who have refused to agree to extend their contract despite having one year left to run in their present contracts.

Reds' boss Jurgen Klopp would not want a situation where the club will be starved of necessary firepower to process next season's campaign in uncertainty and would look to welcome Nunez to Anfield.

Bayern Munich have tendered a second bid for Sadio Mane who said his decision is based on what the Senegalese want for him.

According to a transfer gossip by British media, Mane, 30, has one year left on his contract and joked that majority of people in Senegal want him to leave Anfield.

Meanwhile, Eurosport last month reported that Ten Hag was interested to bring the player to Old Trafford and has a line £80million to snap the player away from Liverpool's radar.

According to the report, United boss has two targets and two priority signings. He wants to sign defender Jurrien Timber from Ajax for around £35 million, and will also pursue a bid for 22-year-old Uruguayan striker Darwin Nunez, who will cost £80m from Benfica.



Salah named PFA Player of the Year

Liverpool forward and Egyptian prodigy Mohamed Salah has been named the 2022 PFA Players' Player of the Year, beating fellow contender and Manchester City Kevin De Bruyne to clinch it.

Salah wins it for the second time having carted home the 2018's edition.

The 29-year-old, who also won the FWA Footballer of the Year award, has only one season left in Liverpool until he agrees to sign a new one.

Salah finished the 2021-22 season remarkably, emerging as the league's joint-top goalscorer with Tottenham Son Heung-Min.

The Liverpool ace forward, who plays from the right flank also beat Cristiano Ronaldo, Harry Kane and team-mates Virgil van Dijk and Sadio Mane to win the honour.

The former Roma player voted part of the 2022 PFA Premier

League team of the year, joined Liverpool five years ago and has established himself as a key figure for Jurgen Klopp's side.

Although, Tottenham's Son Heung-Min shared the Golden Boot with the Egyptian, the South Korean did not make the shortlist or the best XI of English Premier League team for 2021-22 season.

For the record, Salah scored 23 goals in the EPL and clocked 14 assists during the 2021/22 season, comprising a hat-trick and assist at Old Trafford as Liverpool plummeted rivals Manchester United 5-0

Liverpool forward led the season's campaign for a club quadruple that resulted in an FA Cup and Carabao Cup double having lost the African Cup of Nations (AFCON) final against Senegal in Cameroon.

"It's a great honour to win a trophy, individual or collective and this one is big so, very happy



and very proud of that," said Salah.

"This one is a really good one to win, especially because it's voted by players. It shows you that you've worked really hard and you get what you worked for.

"Thave my room with trophies in a cabinet and I made sure that I had another space for one more. I always keep space and just try to imagine that the trophies are going to come.

"When you get older, you feel like you're more stable and you know exactly what you want from football so I'm just trying to really chill and help the team.

"That's why I think I also won the playmaker because it's like you're more aware of the game, so you just try to make the people next to you better and try to make yourself better as well," he added.

PFA members vote for the winners of each award, choosing the players they feel have put in the best performances all year. Salah is now one of only nine players in history to have won two PFA Players' Player trophies, joining Mark Hughes, Alan Shearer, Thierry Henry, Gareth Bale, Cristiano Ronaldo, Lucy Bronze, Kevin De Bruyne and Fran Kirby; according to a report by Sky Sports.

ngel Di Maria's proposed move to Juventus must have taken a new twist after the Argentine's agent Jorge Mendes was spotted to have arrived in Spain to discuss the player's future with Barcelona.

The 34 years old having scored 93 goals and 119 assists in 295 appearances in the last seven years, has captured the attention of several high profile clubs in Europe,



including Barcelona.

Barcelona, seeking to return to dominance of Spain and Europe have also made Raphilha a priority target but Leeds United's price tag could restrict them from launching the offensive for the Brazilian international

Osimhen, who won the U17 World Cup, disclosed in an interview with NFF TV, where he explained that the goal against Chelsea is his most cherished goal because his friends wanted him to score against Chelsea regardless of the result.

"My most cherished goal is the one I scored against Chelsea.

"A lot of my friends who were Chelsea fans sent me messages before the game saying they did not care if Chelsea beat us Lille or not, they just wanted me to score.

"They really wanted me to actualize my dream, and that was one of the best moments in my career."

Osimhen scored in the 2-1 win by Nigeria against the Leone Stars of Sierra Leone on Thursday at the Moshood Abiola National Stadium, Abuja.

Ten Hag could succeed after Woodward's exit'

Netherlands boss Louis Van Gaal said Manchester United manager Erik ten Hag could succeed in Old Trafford following the change of leadership with Richard Arnold stepping in to replace Ed Woodward.

Van Gaal had in the build-up to Manchester United's interest for former Ajax boss, advised that he should turn down the offer from the Red Devils who he posited were more of a commercial club than a football club.

However, Erik ten Hag still accepted the offer and Van Gaal who managed the United squad for two seasons, 2014-2016, added that the exit of Woodward, vice-chairman of Manchester United, could be the difference for the former Ajax boss.

"There is now a new leadership," Van Gaal told Sky Sports ahead of Netherlands clash with Wales at the Cardiff City Stadium.

"It was Woodward and now it is Richard Arnold and that can make the difference. So we have to wait and see.

"He [Ten Hag] has a lot of confidence. So who am I to say something about that," he added.

Furthermore, Holland's boss charged Ajax defender Jurrien Timber to step up his game if he is to feature for the Dutch national team at the FIFA World Cup in Qatar.

Timber, who steps in to replace Virgil Van Dijk after the Liverpool defender was given a break after undergoing a hectic season at Liverpool, is strongly needed by Ten Hag at Manchester United.

Van Gaal, who won the FA Cup for Manchester United in 2016 before his sack, stressed that the 20-year-old centre-back must play in the first team to be guaranteed a place to represent the country in Optar

"I think a player of his quality can play in the Premier League. That is not a problem," Van Gaal admitted.

"If he has to make this big step

now, that's the question.

"(If he does not play) then he is not so wise, I think. He has to play," he added.

Meanwhile, former Ajax midfielder Marciano Vink has said that Timber's move to Manchester United would mean a lot for the Red Devils keen on rebuilding a solid first team ahead of next season.

Vink added that the versatile defender, who won Ajax's young player of the year award this season, would form a perfect defensive pair with Harry Maguire in United's defence.

"Maybe he can play alongside Harry Maguire, this guy is ice cold," Vink told ESPN FC.

"What this guy has shown in the Champions League against Haaland, what he has shown in the national team already at this age, he doesn't blink.

"This guy is so comfortable on the ball, he anticipates like the best and a defender needs to anticipate,



you can be a strong defender, tall but if you don't know how to anticipate where the ball is going or attacker then you're not a good attacker but this guy anticipates like the best.

"For me, it's somebody who could play in the Premier League but also could help Man United from the back football-wise," he exemplified.

'I snubbed Real Madrid's advances to join Barcelona'

Ferran Torres has said he rejected the advances of Spanish football giant Real Madrid on several occasions to finally join Xavi Hernandez in Barcelona.

The former Manchester City forward, who moved to Camp Nou in this year's winter transfer window, is overwhelmed by the proposed move by Barcelona for Bayern Munich topnine, Robert Lewandowski.

Ferran, satisfied with the club's activities to bolster the squad ahead of next season's campaign, admitted Lewandowski will be a great addition to the squad.

"The fact that Robert Lewandowski is motivated to come to Barcelona is a source of pride. I hope he reaches an agreement and can come", Ferran Torres said to Cadena COPE's El Partidazo.

"Joining Barcelona is already a huge thing, but to be called by Xavi Hernandez, with what a great player he has been, was decisive.

"He told me his ideas, his desire and I did everything I could to come to Barcelona," Ferran revealed Xavi's influence lured him to Catalans.

However, Ferran admitted his season has been hampered by injury after leaving Etihad Stadium for Camp Nou

"It has been a difficult year because I had to leave [Manchester City], I had a serious injury and I arrived at Barcelona with a lot of hope," Ferran said
