Obi, Tinubu under fire over interim running mates, Atiku gets kudos

residential candidates of the All Progressives (APC) Congress and Labour Party (LP), Asiwaju Bola Tinubu and Mr. Peter Obi, have been lambasted by some Nigerians for naming interim running mates.

The critics said Tinubu's and Obi's delays in choosing substantive running mates indicated unpreparedness to govern unlike Peoples Democratic Party's (PDP's) Alhaji Atiku Abubakar who has named Delta State Governor, Dr. Ifeanyi Okowa, as his substantive vice presidential candidate.

But some other political analysts as well as the camps of Obi and Tinubu disagreed. A political activist and governorship former

candidate in Comrade Igbini Odafe Emmanuel, said that neither APC nor the LP erred in submitting names of persons as 'placeholders' for their vice presidential slots.

He also said all names submitted so far to the Independent National Electoral Commission (INEC) as candidates for the 2023 elections are 'placeholders'.

Igbini, an engineer and former oil industry unionist, who was the Governorship Candidate of Peoples Redemption Party (PRP), Delta State in 2007 and 2011, made this assertion in a statement, in an apparent reaction to a claim by INEC that there is no constitutional provisions for a 'placeholder.'

In the statement, Igbini said "as a political activist and a former three-time governorship candidate, I am compelled to react to the recent claim by Independent

National Electoral Commission (INEC) through its National Commissioner Barr. Festus Okoye, that there exist no place in Nigerian Constitution and Legal Framework for what is now

described as 'placeholders' in Nigeria electoral process specifically as it concerns submission, change or substitution of names of candidates for general by elections registered

political parties.

"This claim by INEC is fundamental falsehood deliberately made by it to mislead Nigerian voters and to cast aspersion on some political parties like APC and Labour Party which publicly disclosed that the names they submitted to INEC as their Vice Presidential Candidates were meant only to beat the June 17, 2022 date set by INEC but which they may change or substitute within the window provided by the sections 31 and 33 of the Electoral Act 2021, as amended to do so.

'Contrary to INEC's claim, I wish to state unequivocally that actions taken by APC and LP are constitutional and in line with sections 29, 31 and 33 of the Electoral Act 2021, as amended. The use of the word, "Placeholder" is merely misinterpreted by INEC. "Placeholder" simply means that it is not

substantive but temporarily standing in for something or someone else. The word is used in solving Algebraic Expression and Equations in Mathematics.

also inform "Let me Nigerians that this idea of changing or substituting candidates for general elections have been in our electoral laws of 2006, 2010 and now 2021, as amended."

He affirmed that changing or substituting candidates for elections is not limited to only Vice Presidential candidates as we now seem to focus on.

In fact, all names so far submitted by political parties to INEC as Presidential, Vice Presidential, Senatorial, House of Representatives and House of Assembly Candidates are placeholders' and can be changed or substituted before the 90 days to date of election, after which, no change or substitution is allowed except case of death of a candidate.

"For avoidance of doubt, I here reproduce verbatim, sections 29, 31 and 33 of the Electoral Act 2021 as amended:

"Section 29(1) states that: "Every political party shall not later than 180 days before the date appointed for a general election under the provisions of this Act, submit to the Commission in the prescribed forms the list of the candidates the party proposes to sponsor at the elections who must have emerged from a valid primaries conducted by the political party.

"(2) the List or Information submitted by each candidate shall be accompanied by an Affidavit sworn to by each candidate at the Federal High Court, High Court of a State, or Federal Capital Territory High Court indicating that he or she has fulfilled all the constitutional requirements for election into that office

'Section 31 states that: "A candidate may withdraw his or her candidature by notice in writing signed by him and delivered personally by the candidate to the political party that nominated him for the election and the political party shall convey such withdraw to the Commission not later than 90 days to the election.

"Section 33 states that: "A political party shall not be allowed to change or candidate substitute its whose name has been submitted under section 29 of this Act, except in the case of death or withdrawal by the candidate: provided that in the case of such withdrawal or death of a candidate, the political party affected shall, within 14 days of the occurrence of the event, hold a fresh primary election to produce and submit a fresh CONTINUED ON PAGE 4

state and the government commitment to ensure adequate security and protection of lives and property of the citizenry in the state, particularly this rainy during government has season, resolved to take further measures to deal with escalating the recent attacks, kidnapping and the criminal levies being enforced on our innocent communities.

"This act of terrorism has been a source of worry and concern to the people and government of the state. Therefore, in order to deal decisively with the situation in our respective communities, government has no option than to take the following measures:

"A. Government has henceforth. directed individuals to prepare and obtain guns to defend themselves against the bandits, as government has directed the state commissioner of police to issue license to all those who qualify and are wishing to obtain such guns to defend themselves. Government is ready to facilitate people, especially our farmers to secure basic weapons for defending themselves. Government has already concluded arrangement to distribute 500 forms to each of the 19 Emirates in the state for those willing to obtain guns to defend themselves.

"B. People must apply

of Police, license to own guns and such other basic weapons to be used in defending themselves.

C. A secretariat or centre will be established for the collection of intelligence on the activities of informants.

" D. people are strictly and advised warned to make sure that any information or intelligence about an informant must be true and nothing but the truth, as all information on such informants must carry correct data on the suspects, including their pictures, correct names, address, occupation and witness to testify the genuity of the information given, as government is taking punitive measures against any one found as informant. Any person who give wrong information against anybody, will be served the same punishment with an informant and will be treated as such.

"E. Government has requested the state House of Assembly to pass, as matter of urgency, the informants bill before it, to enable government take the drastic measures on informants as contained in the bill.

F. Government has ordered for the recruitment 200 additional of Community Protection Guards in each of the 19 emirates of the state, making it 500 per emirate, to increase their manpower

and capacity to deal with the bandits.

To further ensure the efficiency and effectiveness of these measures, as well the proper implementation of these measures, government has also decided as follows:

Henceforth, all filling stations on the affected areas are hereby closed with immediate effect. Anybody found riding motorbike within the areas is considered as bandits and security agencies are thereby directed to shoot such persons at sight. Security agencies are by this announcement directed to ensure strict compliance.

"Anybody found violating this order should be dealt with according to the rule of law. Government would not condone any act where innocent people are being killed.

Government is also using this medium to thank all those who honoured and respect the peace dialogue in what ever form. In the same vein, those who refused to honour and respect the peace dialogue are here by warned to allow peace within our respective communities.

"Government is hereby directing the military, police, civil defence and other security agencies to mobilise their operatives and take fight to the enclaves of the criminals with immediate effect."

Meanwhile, Governor Bala Mohammed at the weekend tasked security agencies to evolve proactive security strategy to protect rural communities against the activities of bandits and kidnappers in Bauchi State.

The governor gave the charge during a condolence visit to Sabon Gari Narabi community in Toro Local Government Area of the state where a five-year-old girl, Khadija Abdullahi was allegedly kidnapped and murdered by her neighbour.

He urged the Commissioner of Police in the state, Mr Umar Sanda to reshuffle Divisional Police Officers (DPOs) across the 20 local government areas for more effective response to issues of banditry and kidnapping.

Mohammed, who lauded the police and other security operatives for their dedication to duties, stressed the need for concerted effort in deployment of more personnel to areas considered to be the hideout of criminals.

He said the government was concerned about the safety of the citizens by providing all the needed support to secure towns and villages.

"We are here to also commiserate with the people of Toro over incessant activities of bandits where about eight incidents happened in Narabi community. It is becoming unacceptable.

"The person who perpetrated this mayhem has been arrested and he is facing the law. We are going to follow the case with keen interest.

community leaders "Our should be more vigilant because compromises are everywhere. We have people coming into Toro and Alkaleri because of the size of the LGAs and the terrains.

'We are going to make sure we put our eyes and legs on the ground. We are going to listen and our contacts are with you, so please, collaborate with us.

Also at the weekend, a vigilance group commander, Mallam Danladi Dobbo, and two others were killed in Kpade community in Lapai Local Government Area of Niger State in a renewed onslaught by gunmen.

Several villagers were also injured in the attack, while the gunmen who stormed a farm in the community abducted an unspecified number of locals.

Sources close to the community said the incident occurred on Friday around 3:30pm when the people were busy in their farms.

A tractor belonging to the farmers was set ablaze by the rampaging gunmen who came in large numbers.

According to a source, gunmen ambushed the vigilance commander and his men who had gone into the forest to rescue the abducted victims; they killed him and two others.

The bodies of those killed were vet to be recovered by the villagers, who appealed to the state government to deploy security agents to the area to help recover them.

The recent attack was coming barely three weeks after gunmen killed a Divisional Crime Officer (DCO) of Lapai division, and a vigilante in a similar circumstance, though there was no official statement from the state police command to that effect.

It was reliably gathered that three different helicopters were in the last one month seen hovering over Kpada community, which shares border with FCT and Kogi State before the attack on Friday.

Attempt to reach the Police Public Relations Officer of the state command, DSP Wasiu Abiodun was not successful as of the time of filing in the report as his mobile phone was switched off.

However, the Commissioner for Internal Security in the state, Mr. Emmanuel Umar, confirmed the attack, but appealed to the affected community to remain calm, as the government had mobilised security agents to the area to recover the bodies of the victims and rescue those abducted.

22 youngsters die in nightclub

Tragedy hit South Africa at the weekend when no fewer than 22 people were found dead at a nightclub under mysterious circumstances in a township of the southern city of East London.

Eastern Cape police spokesperson[•]Brigadier Tembinkosi Kinana on Sunday said police were alerted by members of the public to the incident at

Scenery Park. circumstances "The under which they died are under investigation," Kinana said, adding it was too early to determine

the cause of death of the young adults aged between 18 and 20 years.

The bodies will be transported to state mortuaries where relatives are expected to help identify the victims, said Siyanda Manana, a spokesperson for the Eastern Cape provincial health department. "We are going to im-

mediately be embarking on autopsies so we can know the probable cause of death," he said. "We are talking 22 bodies right now."

South Africa's President Cyril Ramaphosa has expressed his condolences to the families of the 22 people who died at a tavern in East London.

Ramaphosa said the victims were teenagers.

"While the President awaits more information on the incident, his thoughts are with the families who have lost children as well as families who are awaiting confirmation of how their children may have been affected," a statement from the presidency said.

Many people gathered at the scene frying to find loved ones. National police minister Bheki Cel traveled to the scene in Scenery Park, where he told a large crowd: "The call is on the parents to see that their kids are kept well, the call is on the community to say we can't allow our kids to die.'

Makinde approves more recruitments for Amotekun Corps

Lagos University Teaching Hospital (LUTH) and the Nigeria Centre for Disease Control (NCDC) have pledged to strengthen institutional collaboration in fighting infectious diseases after successfully managing COVID-19.

Part of the collaboration is the building of a 40-bed isolation centre at LUTH jointly financed by the NCDC and the World Bank, the Chief Medical Director of LUTH, Prof Chris Bode said while welcoming the Director General of NCDC, Dr Ifedayo Adetifa to the hospital at the weekend.

He said since Adetifa came on board as the D-G of NCDC, he had brought his vast skills on vaccine impact and monitoring to bear while also expanding the frontiers of managing not only the COVID-19 pandemic but also other emergent diseases as Ebola and Monkeypox ..

Bode said Adetifa. who had his residency training at LUTH, was returning to a familiar turf as he expressed confidence that the visit would provide an opportunity to further cement the cooperation between LUTH and NCDC.

He recalled the "wonderful working relationship and collaboration with LUTH", especially since the onset of the COVID-19 pandemic outbreak.

NCDC, LUTH partner against infectious diseases

"Many institutions closed up and shut down in the raging days of the pandemic. We cannot blame them, the fear was high as apocalyptic predictions were made for African landscape.

"We in LUTH, however, stepped up to the plate and did our own heavy lifting in contribution to the national efforts to contain the disease," he said. The CMD disclosed

that LUTH's department of community medicine was closely involved in contact tracing and was part of the policy making at the emergency operation centre.

He said its clinicians admitted and treated over 1000 cases, most with multiple co-morbidities requiring multi-disciplinary management.

He said psychiatrists at the hospital established the emotional and psychosocial support group that was later adopted by Lagos State to render invaluable psychosocial support for patients and relations of COVID-19.

Bode said that LUTH trained other hospitals and care givers from many states on management of COVID-19 isolation centres while acknowledging top class collaborative research efforts with the NCDC on the pandemic.

• overnor Seyi Makinde has approved Jthe recruitment of additional 500 men for the Western Nigeria Security Network (WNSN), codenamed Amotekun, in Oyo State as part of his administration's efforts to enhance security of lives and properties.

He stated this at a monthly security meeting with local government Chairmen, Vice Chairmen, heads of security agencies, traditional rulers and stakeholders at House of Chiefs, Secretariat, in Ibadan at the weekend.

Engineer Makinde told the gathering that the security issue is a collective responsibility therefore all hands must be on deck in order to curtail insecurity facing the country, in which Oyo State was not exempted.

"Security is everyone's business and if we all play our parts well, we will have a safer and more secured environment, although security of lives and properties is paramount responsibility of government, but government cannot do it alone except with cooperation of the entire citizenry and as we can see from the report gotten all over the country, Oyo State is relatively peaceful, this was not achieved by the effort of government alone but with the efforts of the stakeholders, most all especially the security commanders.

"This meeting is aimed at getting the situation report from various quarters on security as well as to dialogue on what to do as stakeholders and fine tune necessary steps, this will help government to put necessary machinery in place for people in the state to sleep with their two eyes closed and as the operation of the Amotekun corps is concerned, we have perfected the process of employing 500 more hands to enhance their performance and further deepen the security architecture of our State."

HURIWA decries killing of Christian clerics

group, Writers Civil advocacy Human Rights Association of Nigeria, (HURIWA) has said that Nigeria would have been boiling should Imams be kidnapped or murdered the way the marauders are terrorising and annihilating Christian leaders in the country.

HUŘIWA's National Coordinator, Comrade Emmanuel Onwubiko, in a statement, categorically stressed that "President Muhammadu Buhari, the service chiefs and all the heads of security agencies who are Muslims would have swung into action" and taken more decisive actions "should kidnappers start feasting on Imams."

The group emphasised that "the spate of kidnapping and gruesome killing of Christian leaders and their followers was pure persecution." It asked why Imams have not fallen victim to abductions and killings if the problem is a general one and not targeted at Christians as seen in the last few years."

At the weekend, terrorists murdered another Christian cleric, 50-year-old Catholic priest, Rev Fr. Vitus Borogo, in Kaduna State, at Prison Farm, Kujama, along Kaduna-Kachia Road.

This followed the abduction and killing of Reverend Father Joseph Bako of St. John Catholic Church, Kudenda in Chikun Local Government Area of Kaduna State recently..

"About 20 Christian clerics have either been kidnapped or killed just in 2022 and there has not been one report of the kidnap or the killing of an Imam. This is not in any way inciting the kidnap of Imams but the unending attacks on Christian clerics is suspicious, that clandestine forces are after Christian

Ondo orders compulsory installation of CCTV in public, private institutions

n Executive Order for compulsory **L**installation of close circuit television (CCTV) devices in all public and private institutions in Ondo State has been signed by Governor Rotimi Akeredolu.

This order came weeks after the attack on worshippers at St Francis Catholic Church, Owo area of Ondo killing not less than 40 people and many others sustaining injuries.

A statement at the weekend by the Chief Press Secretary to the Gov-ernor, Richard Olatunde, said it was a measure to prevent insecurity due to the increased rate of insecurity in the country and the need to protect the lives and property in all public and private institutions throughout

the state.

He stressed that the executive order shall be enforced at all religious places of worship financial institutions (of all kinds), event centres, supermarkets, educational institutions (schools), hotels or motels, guest houses, inns, restaurants, clinics and health centres, eateries, recreation or vehicular parks and other places regularly used by the public.

"This becomes imperative in the light of the increased spate of insecurity in the country and the need to ensure security of lives and properties in all public and private institutions and centres throughout the state," the statement said.

"The executive order shall be enforced at all religious places of worship, financial institutions (of all kinds), event centres, supermarkets, educational

He said the order is pursuant to Section 176 (2) of the Constitution of the Federal Republic of

Nigeria, which vests such power in the governors, as the chief executives of their states.

According to him, the rder expects, "That order the owners, occupiers, managers and operators of public/private institutions within Ondo State shall mandatorily install, use and maintain CCTV devices and other secret cameras to monitor and keep surveillance on the daily activities in their premises and especially monitor the ingress and egress of people/vehicles at the said places, venues and centres.

"That the installed CCTV devices apart from capturing all activities at the public/ private institutions must also have data storage hardware and data stored therein should be made available to security agencies whenever it is required. public/private "That

institutions shall employ and maintain well-trained security personnel who shall man the entry and exit points to their various facilities/premises.

"That where necessary, the owners and occupiers of public/private institutions shall erect a well fortified perimeter fence with a security post at the entry

and exit points. "That this Executive Order shall be enforced by all security agencies particularly the Nigeria Police, Nigeria Security and Civil Defence Corps (NSCDC), Ondo State Security Network Agency (Amotekun) and the De-partment of State Security Services (DSS).

"That violators of this Executive Order shall be prosecuted in accordance with Section 203 of the Criminal Code (Cap. 37) Laws of Ondo State of Nigeria."

Nigeria relying on improved security to boost OPEC's oil output, says Sylva

Minister of State for Petroleum Resources, Chief Timipre Sylva, at the weekend, declared that after meeting with oil companies, he expects to see some improvement of security in the sector to enable Africa's top producer to meet its Organisation of Oil Exporting Countries (OPEC) production quota by the end of August 2022.

It would be recalled that Nigeria loses millions of barrel of crude oil yearly to theft and vandalism, which underscores how insecurity causes financial losses for the country.

Sylva said President Muhammadu Buhari had pledged to ensure that oil theft was nipped in the bud and had set up dedicated courts to combat the problem, saying: "This year the Federal Government projected 1.8 million

barrels per day, in the first quarter, but blamed the shortfall on attacks on oil infrastructure and crude oil theft.

"For us in Nigeria, we are at a low point and we are not able to meet our OPEC quota. We have given ourselves just about a month to ensure that we can. We believe that by August we would see some improvement in security.

"At this moment, I think prices are firm enough, I don't think there will be any surprises in August. We believe that the market is well supplied. And of course some people consider price to be on the high side and expected us to pump more, but currently, there is little capacity that can be brought to the market."

The minister also disclosed that Nigeria had started the construction of 614 kilometers (382) miles pipeline, which will reach furope through Algeria, adding that Algeria, Nigeria and Niger held talks on the revival of the project to pipe gas to Europe to diversify its gas sources.

Nigeria was embarking on the construction of its portion of the gas pipeline. The revival comes at strategic time as the European Union (EU) seeks to wean itself of Russian gas following its invasion of Ukraine and is seeking alternative sources," he added.

Diri also cautioned politicians against influencing the youths



My 100 days in office hellish, says Soludo

•Vows to end IPOB sit-at-home order

Governor Charles Soludo of Anambra State says his last 100 days in office have been 'bumpy' and challenging due to the rising 'insecurity and red treasury' that he inherited from his predecessor, Mr Willie Obiano.

Soludo, who disclosed this at the weekend during a ceremony to mark his 100 days in office, vowed to end the Monday sit-at-home order declared by outlawed Indigenous People of Biafra (IPOB).

"To be sure, the last 100 days have been bumpy and challenging as expected, with insecurity and a red treasury being the most portent, as clearly identified in our inaugural address," he said. "Thus, with declining revenue

in the context of insecurity and a mountain of debt including over N20 billion in arrears of gratuity to pensioners since 2018 vis-à-vis the sky-high expectations from you, some fundamental disruptive changes are inevitable."

The governor, however, asked people who were pitying him for the situation to withdraw their pity, explaining that he "consciously applied for this job, and there will be no excuses.

"The Monday sit-at-home order by IPOB, which has wrecked the Anambra economy and disrupt the people's social life, will soon be history," the governor said. "Our children will have their full week of studies and our

businesses will be in full charge again. We have declared zero tolerance for touting which has endeared the government to transport owners, operators and stakeholders. More programmes and projects will be unveiled in due course, particularly to retrain and empower the former touts." He said the major part of the 100 days have been devoted to making key appointments into the government and fighting insecurity in the state. The governor said his administration would work hard towards implementing his manifesto, which he said, centres on five driving pillars of security, law and order, economic transformation agenda; social agenda; governance, rule of law and value system, noting that he has begun work in those areas.

"We have maintained the policy of the past administration on 'Community Choose Your Project' in which communities receive grants from the state government to execute a project or projects of priority to the community.

"Our administration has launched a new phase and increased the grant from N20 million to N25 million per community. We have also launched a policy that no retiree from the state civil service will be owed gratuity under our administration and have paid retirees from March to date. We have also begun, albeit gradually, to pay gratuity to pensioners who retired since 2018 and there is hope and joy in the land. We have also approved the same policy for local governments," the governor said.

Prof. Soludo said his administration has successfully screened over 40,000 candidates who applied for teaching jobs in the primary and secondary schools in the state. He said additional 6,000 candidates would soon be screened for recruitment in the state. The governor said, in the face of dwindling state resources, his administration would begin to collect taxes from Anambra residents and indigenes of the state in the diaspora, assuring that such taxes must be put to good use.

He added: "More programmes and projects will be unveiled in due course, particularly to retrain and empower the former touts."


Ohanaeze youths write UK Embassy on Ekweremadu, warn blackmailers

Ohanaeze Ndigbo Youth Council Worldwide (OYC) has again waded into the raging controversy over the detention of former Deputy Senate President, Ike Ekweremadu and his wife, Beatrice.

The youth wing of the apex Igbo socio-cultural organization had earlier urged caution and an end to the social media trial of the Senator. The group has now written an open letter to the UK Embassy, begging that at least the Senator's wife be freed to enable her attend to their ailing daughter, Sonia.

In the appeal letter, the Ohanaeze youths said it was now clear that the Ekweremadus did not involve themselves in any untoward deal but had followed an established process to save the life of their daughter. The letter of appeal was signed by Ohanaeze Youths President-General, Mazi Okwu Nnabuike and the Secretary-General, Comrade Obinna Achionye.

The letter read in part: "Following more emerging revelations

in the case involving the former Deputy Senate President, Senator Ike Ekweremadu and his wife, both true son and daughter of Igbo land, we find it expedient to make this open appeal to the UK Embassy in Nigeria.

"Contrary to earlier reports which flooded the media, it has become clear that the couple had no bad intention in mind. Having seen that they had no other intention rather than to save the life of their daughter, as nobody will sit by and watch their child die without making efforts, we deemed it necessary to make this appeal. We plead with the United Kingdom, through its Embassy here in Nigeria, to look into the implication of detaining the husband and the wife. We appeal for the release of one of them so the person can take care of the sick child who needs medical help urgently.

They alleged that fifth columnists have created pseudo accounts with the name of the alleged victim of organ harvesting, David Nwamini.

OYC said, "we observed that within the last 48 hours, no less than five fake Facebook accounts have been created with the profile of the alleged victim.

"This is no doubt the work of blackmailers as they have gone ahead to be making posts with the said unverified accounts. The posts contain spurious claims and allegations which are clearly the handiwork of political enemies, all aimed at bringing the Senator down. It is a matter of time and the identity of those behind this shall be unveiled if they fail to desist from their evil antics.

"They had earlier claimed that the boy in question is 15 years, but current revelations have proved otherwise. This is why we call for a thorough investigation. We urge the general public to discountenance those posts as the truth will surely prevail and Ekweremadu and his wife will come out of these allegations with their reputation unscathed."

Meanwhile, hope of survival may have risen for the daughter of the former Deputy Senate President, as a Nigerian lady, Martha Uche, has offered to donate her kidney to save Sonia's life.

While mixed reactions have continued to trail the report of the arrest, detention and arraignment of the two prominent Nigerians, Ike Ekweremadu and his wife, Beatrice, by the London Metropolitan Police over alleged conspiracy to transport a 15 year old boy Ukpo Nwamini David to the UK in order to harvest his organs for their child.

Ekweremadu and his wife facilitated David's entry into the UK to transplant his kidney into their daughter who is suffering from kidney failure. The couple were charged with alleged conspiracy to harvest the organs of a child in the United Kingdom.

However, Martha has offered to donate her kidney to save the daughter of Ekweremadu. In a video interview that went viral on social media, Martha said she needs to save the life of Sonia.

"I want to do that because I need to help the girl. She is dying. They have already showed me in my dream that I should help the girl. I've already seen her long time ago. Even this morning I still had the same dream so I need to do it fast," Uche added.

When asked if she has any demands to help the daughter of the former Deputy Senate President, Martha said she has no demands for now, but she only needs to save the girl's life which is more important.

EEDC, MOJEC partner to extend MAP metering to Enugu residents doorsteps

Enugu Electricity Distribution Company (EEDC) and MOJEC International Limited have started to extend mobile Meter Asset Provider (MAP) metering programme to doorsteps of Enugu residents. The mobile MAP metering programme ensures meters are installed same day once a reimbursable payment is made after customer's provision of means of identification and electricity bill.

Flagging off the programme on Sunday in Jubilee Estate, Enugu, the Managing Director of EEDC, Mr Praveen Chorghade, said that MAP is a metering intervention initiative introduced by the Nigerian Electricity Regulatory Commission (NERC). Chorghade said that the MAP metering allows meter manufacturers and meter vendors to meter customers while they pay for the meters.

According to him, it is however designed in a way that customers will be reimbursed with the cost of the meter through energy credit, over a 36-installment period.

"The need to close the existing metering gap in our network has necessitated our partnering MOJEC International Limited in our quest to ramp up our metering efforts and move away from the estimated billing and direct connection.

"The introduction of this Mobile MAP Metering is a clear innovative improvement on the usual MAP meter process which takes up to 10 working days to meter a customer and cut down the process to an 'Instant Meter Programme', to enable EEDC to serve the customers with 'meter at your door step'. We have therefore selected two locations in Enugu for the pilot of this Mobile MÅP Metering exercise, and we intend to extend the same to other locations within our coverage area, as a conscious way of migrating more of our customers from the

estimated billing to the metered platform.

"Today, we are at the Jubilee Estate to meter our customers residing at Upper Chime Avenue, New Haven and Premier Layout, and it will last till June 29. Similarly, from June 30 to July 2, we shall be at the Trade Fair Complex Gate to meter customers of GRA Onitsha Road Feeder and Golf Estate.

"All that the customers need to do to initiate the metering process is to simply present a copy of their bill and a valid means of identification, pay for the meter and once payment is confirmed, the meters will be installed for them the same day. The singlephase meter goes for N63, 061.27; while the Three-phase meter is N117, 910.69. These prices are all-inclusive of VAT," he said.

Speaking, the Group Managing Director of MOJEC International Ltd, Ms Chantelle Abdul, said that the company produces three million meters annually and was ready to close the metering gap in the South-East.

Abdul said: "We are committed technically and financially to make this happen through the innovative Mobile MAP Metering programme that have started in Enugu and will be spreading in the entire South-East.

"EEDC remains a leading DisCo in provision of meters to its customers in the country and we commend the board and management of EEDC for being committed in ensuring Nigerians especially people of South-East are metered."

Chairman of Electricity Committee of Jubilee Estate, Chief Dubem Okoye, thanked EEDC and MOJEC for making access to prepaid meters stress-free, protocol-free and time for residents of the estate and its environs.

Falana canvasses association to defend Judiciary

Rights lawyer, Femi Falana (SAN), has implored judges to form a national association of judicial officers to protect the interest of the judiciary.

He said establishment such association would in line with section 40 of the Constitution of the Federal Republic of Nigeria, 1999 (as amended).

Falana, a former President of the West African Bar Association (WABA), explained that floating such association is imperative to prevent the executive arm from compromising and sabotaging the judiciary.

He made the recommendation following a letter recently written by 14 Justices of the Supreme Court to the Chief Justice of Nigeria (CJN), Justice Tanko Muhammad, about their poor condition of services despite an annual allocation of N110 billion.

According to Falana, the executive "cannot stand a judiciary that is independent to the extent of ruling against the subversion of the rule of law, constitutional breaches, human rights abuse and official impunity."

Consequently, he added that judges "are deliberately poorly paid to compel them to depend wholly on the executive organ of the state. Even though the Constitution provides for financial autonomy for the judiciary, the executive arm has sabotaged it."

In spite of the independence of the judiciary, according to the senior lawyer, the salaries and allowances of judges are withheld while houses and cars are supplied to judges by state governors.

On these grounds, Falana said: "Notwithstanding that judges are conservative,

it is high time that Nigerian judges form an association to defend and protect the interests of the judiciary.

"This demand is justified by section 40 of the Constitution which guarantees the fundamental right to freedom of association."

He drew the attention of the judges to similar bodies across the world, citing the Commonwealth Magistrates and Judges Association, Judicial Officers Association of South Africa, South African Chief Justice Forum, International Association of Judges and National Associations of European Administrative Judges, among others.

Falana also cited similar bodies already functioning in the federation to include the National Association of Women Judges and the Magistrates' Association of Nigeria.

The learned silk further emphasised the need to set up the Nigerian Judicial Officers Association "to defend the interests of judges and promote judicial independence, human rights and rule of law in the country."

He noted that the letter signed by the 14 Justices of the Supreme Court had confirmed that judges had been suffering in silence, and called for a holistic review of the conditions of service of judges in the country.

He added that the federal and state governments should be compelled "to actualise the financial autonomy for the judiciary in line with the relevant provisions of the Constitution of the Federal Republic of Nigeria, 1999."

Falana, however, pointed out that it had been difficult to join the struggle for the improvement of the working conditions of judges on the ground that the budget of the Supreme Court "is shrouded in secrecy."

He said the details of the expenditure of the N110 billion budgeted for the judiciary are not set out contrary to the provision of section 81 of the Constitution, making it difficult to demand an increase in the budget of the judiciary.

On the part of judges, Falana asked the judiciary "to stop giving undue attention to political cases to the detriment of other more pressing matters relating to the liberty of citizens.

"How can election cases or pre-election matters be more important than the cases of citizens who are languishing in prison custody? Judges should ensure that equal time is allotted to all cases," he emphasised.

ICPC urges public servants to be dedicated

Independent Corrupt Practices and Other Related Offences Commission (ICPC) has charged public servants to be dedicated in the discharge of their duties.

Representative of the ICPC Acting Resident Anti-Corruption Commissioner of Katsina State, Sani Tukur Tarauni, gave the charge at a sensitisation programme organised for 105 officers of the Katsina State Safety and Road Traffic Authority (KASSAROTA).

The one-day enlightenment event with the theme "War Against Corruption: The ICPC Perspective", was aimed at

sensitising the officers on the need to shun corruption and imbibe the spirit of honesty and integrity in discharging their official duties.

Turauni urged the officers to be mindful of the fact that KASSAROTA is a new establishment and an integrity organisation which demands that its officials must display a high level of transparency while on the field.

He further reiterated that the Commission's approach to the fight against corruption has led to the realisation that the only way to stem the tide of the hydra headed monster is through collective responsibility and public involvement.

In his response, the Director-General of KASSAROTA, Alhaji Danlami Yar'adua, noted that the Authority was established by the state government for traffic intervention in order to sanitize the roads by ensuring road users do the right thing in Katsina State.

Yar'adua appreciated the efforts of ICPC in educating the public towards reducing the level of corruption particularly in Katsina State and the nation at large.

He added that the current initiative and sensitisation of Ministries, Departments and Agencies (MDAs) by the Commission would go a long way in checkmating corruption and other related offences in our communities for a purposeful development.

EFCC tasks anti-graft agencies on implementation of NACS

We would like to thank those of you who offered tips and tried to assist with the investigation. Our thoughts go out to the Otobo Family during this difficult time." Until his death, he was a Non-



The current PVC revolution: fact or fiction

n terms of Permanent Voter's Card (PVC) registration, there seems to be a revolution going on in the country. Registration centres are swarmed daily by thousands of youths who want to possess that document which will give them access to voting in 2023. Nigeria has never witnessed this level of awareness before. On social media, different skits have been created by artistes to promote voter registration. What is the cause of this upsurge? Will this translate into a radical increase in the number of voters next year?

Hitherto, most Nigerians had seemed indifferent or showed apathy towards the political process in the country. Nigerians seem to believe that our political system is not transparent given that it keeps recycling the same people every four years. There is also the widespread belief that the votes of the electorate do not count due to rigging, manipulation, and ballot box snatching around the country during elections.

Three odd years ago, Muhammadu Buhari won the election with a paltry 15.2 million votes, a far cry from the 73 million registered voters. Of the total number of people registered to vote, 35.6% voted during the last election. In a country of over 200 million people and 120 million people of voting age, 15.2 million does not represent a healthy percentage of Nigerians. In various states, governors emerged with as low as 200,000 votes out of a possible 2 to 4 million registered voters. This does not speak well for Nigeria's political participation.

In the current dispensation, there is a general desire and clamour by millions of people especially the youths to obtain the PVC required to vote in next year's election. The upsurge in the desire to obtain the PVC started with the emergence of the Labour Party candidate Mr Peter Obi. Before his emergence, many youths virtually shunned activities leading to the 2023 general elections. This is because they were confronted with the same old politicians and | to the 2023 general elections. It remains political parties who, as far as the youths are concerned, cannot be exonerated from the socio-economic anguish and malaise in the country. The emergence of Peter Obi of the Labour Party has led to an upsurge among youths to acquire the PVC.

INEC offices around the country are besieged and inundated by thousands of youths across the ethnic divide wishing to collect their PVC. Currently, according to INEC, there are more than 85 million registered voters in Nigeria. This has never happened in the history of the country. Now, INEC is under pressure to extend the deadline for millions of potential voters to obtain their PVCs. It is a fact therefore that Nigerians are responding positively

to be seen if these facts will translate into something tangible in 2023.

Prior to the 2014 general elections, Nigerians were disenchanted with the PDP administration at the centre. They were united in their resolve to change the leadership in Aso Rock. On Father's Day

The whole world said June Sunday the 19th was Father's Day, and different emojis flew into my social media space from biological and non-biological wards, from students I taught twenty, thirty years ago, from social media 'offsprings. Thanks for all that you have been to me', one wrote. There was sour grape too. One father observed: which one is this again, bringing me more expenses? It's Father's Day I will still be the one to take them out, just as I did on Mother's Day and Children's Day! Hahahaha!

I didn't grow up with the tradition of observing Father's or Mother's Day. Father was father, papa really. And Mother was mama, you know. Duty. Social responsibility. Provision of everything. Meeting all our needs from a modest civil servant's income. It was a given. It was part of me, of us. The man in the house called the shots in a firm way, but also ensured that we were comfortable within his means. What he could not afford now, he promised to get us later. And he did. Somehow, we knew our limits. We never asked for the moon. From deed and action, Papa taught us how to be a father, a dad, a friend. Friend? That came later, that is, after A 'Levels success and he bought me a beer at 18! I was dizzy after a glass. But a beer from Papa would not harm me, the same man who never spared the rod if I as much broke any of the rules of engagement like going to play football without permission! But all of this prepared me for fatherhood! To be a father by example...

I was 27 when I became a father. And a dad. That early morning in the hospital when I bore my tall thin baby girl in my arms, I stared at her for hours, wondering abut the beauty of a human being that had come out of my loins, my very first, (beginning of my

strength', the bible says) how the experience would change my life, how I would always have to reckon with three persons thenceforth, how I would have to ensure that she was fed regularly no matter how expensive baby formula was and how I would care for her no matter the circumstances. I had always wanted a girl, having come from an immediate family of seven boys and two girls, one five years older and the other six years younger, and the other six years younger, and how that deprived me of a close relationship with a girl at home. Odd, isn't it? But that was it.

I also peered into the future, what I would do, what I wouldn't do, what direction I would give, religious, philosophical, spiritual, moral, and perhaps political. Sound education was a given. To pay fees for her through school without seeking support from my wife a given. But I did not foresee the world which she came into later as things began to tumble, as salaries were delayed, or withheld when ASUU was on strike, when our Take Home Pay could Not Take us Home, when inflation hit the roof, when the purchasing power of the naira took a terrible nose dive, or when herdsmen came into the narrative, when I ordered her to return home to Nigeria from the UK after an MSc to be able to meet a spouse and marry, how I changed my mind and asked my children to live anywhere in the world after my abductors threatened to kidnap my kids so I would be released from their custody to look for ransom money to free myself!

That was not part of my vision! Fatherhood was trying. Stressful sometimes. Did you worry about school fees sometimes? About what they would wear? About taking them to and bring them back from school, supervising homework, organizing private coaching,

preparing them for entrance into secondary school and later JAMB examinations? And they passed the examinations. There was happiness. Sense of achievement. Accomplishment. So, fatherhood was joyful too. How could, how should a father from a conservative home handle 'tabooed sexuality subjects' with a child of the modern age? It was a tough question! Push some to the mother? Allow her to discover some?

So, it was that as I journeyed through the walls of education as a teacher, I encountered many students who made me a father, boys and girls who said daddy was absent in their lives, they didn't know what it was like to have a father, how to bring a child into the world was not everything, how to provide material things was not fatherhood, how being an aggressive male in the house destroyed anything about fatherhood. And in a Creative Writing class, I asked my students to describe their relationship with their father and one of them broke down inconsolably as others wrote, and how she said the only thing about her father she knew was his photograph because he died when she was two or three. Or was it before she was born? I don't remember now. But there were no dry eyes in the class of twenty-five that day when her experience of a no-dad hit the class, especially those who had taken presence of fatherhood for granted.

There were others too who said once a second wife came into the picture, they 'lost' their father to the charms of Mrs. New Wife! How he didn't bother anymore about the details of their lives. Children of 'Baby mamas', who grew up with dad never visiting the child's school. Love child with no open love for the child. What about the one who grew up in Yorubaland with a Yoruba mother, and who

thought his dad was Yoruba, who spoke Yoruba, who was told that his father died when he was a baby, how he once attended a party with his mom and a cousin to his mom cornered and told him his father was from Imo State, and he was alive somewhere in Port Harcourt and before she could complete the story, his mother burst in on them and almost had a fight with the woman, how she warned him never to go to that woman in his life. Pained, as a final year student, what would he say was his home state when he went into politics, what would he tell his children, why did his mother blank out his father, why the bitterness? Questions. Questions! Questions!

Fatherhood and Father's Day. Much later all the other kids came, and I learnt how to deal with each of them individually, separately, and together. They all came in their different ways, character, brilliance, attitude, food choices, choice of academic career, even marriage choices. So, as I was fathering kids, having eat-outs, having family dinner to encourage bonding, I was also a student of parenting too, learning things Papa never taught me, mak-ing mistakes even while correcting them, learning lessons which no book or teacher or guardian taught me. Leant that it was better to allow them blossom while you guided them into self-discovery and if



they trusted you enough, everyday will be FATHER'S DAY in their lives, they would remember you positively and reciprocate proper fatherhood with good 'childrenhood! And of course, we soon moved to another level- that of a grandfather, welcoming a second generation of my own brood, male and female, a blessing which money cannot buy! Lessons learnt while grooming their parents may no longer be applicable while relating with your children's children. It's a new world, where a five-year old could put me through the intricacies of an android phone! Marveling about it all is part of the pride of being a father and a grandfather.

So, let everyday be a day for fathers, for mothers, and for the children. So, when your son writes: T've never really been a fan of Father's and Mother's Day because for me I believe my parent's are special and I thank God for having you every day. I thank God because I was blessed to be able to grow up, stroll to the sitting room and have someone sitting there who I could ask any questions and from whom I could get wise answers', one feels fulfilled. And let the spirit of love, parental, sibling, filial, govern the world. Perhaps if we had that consciousness, there would be less tension in the world!

Then Russia invaded Ukraine on February 24, 2022, it **V V** was officially reported there were about 8000 Nigerians in the war-troubled state. Most of this number was students. Many Nigerian students were undertaking courses that are in the medical, engineering and technical or pure sciences. Recently, and sadly, Medical and Dental Council of Nigeria (MDCN) issued a policy statement that "medical and dental degree certificates issued by medical schools from Ukraine from 2022 will NOT be honoured" by the body. It went on to justify her rejection of the certificates from Ukraine that "for the avoidance of doubt, Council categorically states that online medical training done in any part of the world is short of acceptable standard and is not recognised by the MDCN."

When the war commenced in Ukraine, the authorities made



commendable efforts to repatriate stranded citizens from Ukraine. It was done at the wake of racial discrimination against Africans by the authorities in Ukraine. As at March 2022, the fifth batch of 123 evacuees were airlifted from Ukraine to Nigeria. Each evacuee got a free SIM card and \$100 for transport. President Muhammadu Buhari approved \$8.5 million to bring back 5000 citizens from Ukraine. The import of our analysis is to establish a fact that the authorities are aware that we have among us victims of war. These persons ought to be further supported and properly settled in Nigeria.

No one would encourage a professional body to lower her standard for those aspiring to get enlisted in the profession. However, it is a thing of worry that our government could spend scare resources to secure the safety of citizens from Ukraine and turn its face the other way.

Securing the certificates of returnee students from Ukraine

The current plight being experienced by Nigeria citizens from Ukraine is similar to throwing them under

is similar to throwing them under the bus when it mattered most. Consequently, one intends to make a plea for the students and youth returned to Nigeria. They constitute the most desperate population of Nigerians. One can only imagine theirpsychological and mental state. They will be trauma-tised in the face of theirparents who may be confused on the next step may be confused on the next step they could take. It is the duty of government to rescue these Nigerians from their state of forlornness. The Minister of Education should act fast to save us any foreseen disaster and waste of humans and other resources this neglect may amount to. During the Nigerian Civil War, manystudents caught in the web of the war were distributed to other Nigerian Universities to enable them complete their programmes. One should appeal that a similar programme can be put in place for the returnees. If this plea is well-received, efforts

should be made to ascertain the number of evacuated students from Ukraine, the courses they were studying and the Universities government could possible place them. I believe that most of the affected parents will welcome such a programme even at their personal cost. This is a purely humanitarian gesture borne out the ethics of social responsibility on the part of government. There are many ways to achieving this.

Our Universities may be directed to collaborate with relevant professional bodies, secure and scrutinise the students' transcripts and place them at the most appropriate levels of studies to enable them continue and complete their course of study.

Education is primarily a social responsibility of government. In other words, we argue that it is the duty of government to ensure that citizens are given good education. The students who travelled out of Nigeria to further their life-desire should not be treated as some common criminals. They had a noble and praiseworthy desire. Their being in Nigeria today was due to no fault of their own. Even the Universities they were attending are aware of their plights. This may have informed why the Universities in Ukraine went the extra mile to offer them further online training that has now fallen short of the requirement of various professional bodies in Nigeria. Given this, we must rise up to mitigate their plight and save them from falling into some other dangerous desperation.

One also expects the parents/ guardians as well as the returnee students to be more organised and united in their plight. They ought to have collectively met with the Minister of Education in order to discuss their situation and resolve the entire impasse their educational processes have suffered. The war in Ukraine may not be the last of wars that would displace our

citizens. Other natural disasters such as earthquakes and flood may happen elsewhere in future with dire consequences on Nigerians. We should therefore take the Ukraine case as a learning curve for us as a people. Bringing evacuees back safely to Nigeria is a commendable thing to do. But it is necessary that they are well-settled. Settling these youth implies protecting some them from becoming criminal and drug addicts. It implies protecting them from unwonted social and peer influences. It amounts to freeing them from depression and mental health challenges

The parents of these student returnees are watching their resources and future wasting. They may be confused and desperate people. It is duty of government to make citizens happy and be comforted. We should be moved to extend societal kindness to these Nigerians who may be thinking they have "wasted" their resources on their wards. Collectively, we can make our society a better place. Since the Nigerian Medical and Dental Council is the first corporate body to cast aspersion on the educative process of the Ukraine returnees, one is calling on this body to go the extra length towards making Ukraine's 2022 certificates authentic and worthwhile.

Can aspirant who participated in primary election of a party defect to another and seek nomination therefrom?

INTRODUCTION

The last one month has been a beehive of activities for all the registered political parties in Nigeria ahead of the 2023 general elections. Following the conclusion of nomination of candidates by the ruling APC, the opposition PDP, and the emerging 'third force', there have been insinuations from political discourses suggesting that the new Electoral Act 2022 prohibits the practice of shopping for another party platform by aspirants who failed, for one reason or the other, to clinch party ticket in a previous attempt in their first choice of party. In fact, in the last few days, I have been inundated by genuine requests from friends and associates for my legal opinion on this subject. Again, there is palpable apprehension amongst politicians who participated but failed to secure party tickets in their various parties to try their luck in another party; the same foreboding is the reason some aspirants like Senators Ekweremadu and Abaribe decided at the dying minutes of the primaries of PDP to withdraw from the contest and thereby not be seen as having participated at all in the first instance. What follows hereunder is my considered view on the subject, having studied the Electoral Act, the Constitution and relevant case law(s) on the topic.

THE ELECTORAL ACT 2022.

The new Electoral Act 2022 became operative on 2nd March 2022, effectively repealing the Electoral Act No.6, 2010. From my personal study of the new Electoral Act, the only aspect that touches on the subject of nomination of candidates of political parties is Section 35 thereof (formerly Section 37 in the repealed Act). It provides: *"35. Where a candidate knowingly allows himself to be nominated by more than one political party or in more than one constituency, his nomination shall be void"*

Some analysts have erroneously argued that the above cited provision of the Electoral Act has effectively stopped any aspirant who has participated in the primaries of party A from defecting to party B to seek nomination. In support of this line of argument, they rely on the decision of the Supreme Court in *UGWUMBA UCHE NWOSU V. ACTION PEOPLES PARTY & 3 OTHERS (2020) 16 NWLR PART 1749, p.28*

Permit me to take us through the facts of this case as doing so will enable a holistic grasp and appreciation of the matter as well as the ratio decidendi (the reason for the decision).

UCHE NWOSU (Son-in-law of former Governor of Imo State, Owelle Rochas Okorocha) contested and won the primaries conducted by the APC on 6/10/2018; and his name was forwarded to INEC (4th Respondent in appeal) as governorship candidate of the APC in the general elections slated for 9/3/2019. Uche Nwosu (the Appellant) also contested and won the governorship primaries conducted by another political party, the Action Alliance, and on 2/11/2018, he was issued with a 'certificate of return and confirmation as the duly elected governorship candidate' of AA. In February 2019, ACTION PEOPLES PARTY, MR UCHE NNADI AND THE PEOPLES DEMOCRATIC PARTY (1st - 3rd Respondents, respectively) sued UCHE NWOSU and therein challenged his nomination by the two political parties at the Federal High Court, Abuja, seeking, among other reliefs, a declaration of court that the nomination of Uche Nwosu as

the governorship candidate of the AA was invalid, null and void having been made at the pendency of similar nomination of the APC for the same position.

The Supreme Court interpreted Section 37 of the Electoral Act 2010 (now Section 35 of the Electoral Act 2022) and held that the conduct of the Appellant (Uche Nwosu) in knowingly presenting himself for nomination in another political party, the Action Alliance during the pendency of nomination by the APC, was illegal. In the lead judgment read by AUGIE, J.S.C, the Court declared as an illegality the subsequent nomination by the Action Alliance as its gubernatorial candidate. In the words of JUSTICE AUGIE, the court held, "By allowing himself to be nominated by two political parties, the Appellant, not only did an act that is not authorized by law, which is illegal, the Electoral Act clearly says in its section 37 that such a nomination 'shall be void". It's instructive to note that the decision of the court (constituted by 5 learned justices) was unanimous as none of the justices in the panel that heard the appeal dissented. It needs to be added also that the decision was an affirmation of the concurrent findings of the two lower courts in the judicial rung, that is, the Federal High Court, Abuja and the Court of Appeal had decided the matter against the Appellant before it proceeded to the apex court. In his concurring judgment, EJEMBI EKO, J.S.C deprecated the conduct of the Appellant in the following words:

"The purpose of the section 37 of the Electoral Act is to forestall a situation where the rich and powerful will impose on the nation the culture, or the dictatorship, of single party "democracy". That is, the prohibition of a situation where the high and the mighty will impose himself on all the political parties by buying up the candidature by whatever means, howbeit nefarious, in order that he would be the Abacha style sole candidate "on whom the cap fits". And that would be prelude to fascism. The court will not aid any party in the direction of the Golgotha for crucifixion of the nation's multi-party democracy. Such madness will be nipped at the bud".

He further held:

"An individual who 'knowingly allows himself to be nominated by more than one political party' commits an illegality under section 37 of the Electoral Act".

CONCLUSION

The extant revised Electoral Act 2022 makes no provision prohibiting a person who has previously participated in the primary election process of one political party but failed to secure its nomination for one reason or the other from cross-carpeting to another party platform to seek nomination. Neither is the judicial authority discussed in the foregoing premises supportive of such perceived prohibition. Indeed, a person who, aspiring for a public office, participated in the primary election of one political party but failed to get nomination of that party, can move to another political party to seek that other party's nomination. What the law forbids is double or multiple nomination, and not double or multiple participation. I will conclude this opinion by submitting further that it will be tantamount to a gross violation of, and great disservice to all known canons of statutory interpretation for anyone to ascribe a strangely narrow meaning to the clear provision of section 35 or any other part of the Electoral Act 2022.

pet project unveiled in his presidential bid, 'Nigeria By Shareholding' through sponsoring a bill as soon as he is sworn into office when elected. The bill is to ensure that all Nigerians including Isoko people benefit directly from the income earned by the country through a Nigeria Company Plc.

The income earned from the company will serve as a guarantee for every Nigerian willing to access funds for self development, educahe explained.

Malami ill-advised Buhari on Electoral Act, says Senate spokesman

•Says S'Court verdict vindicates N'Assembly • Adeyemi hails apex judgement

Lawmakers have hailed Friday's judgement by the Supreme Court dismissing the suit initiated by the Attorney General of the Federation and Minister of Justice, Abubakar Malami on behalf of President Muhammadu Buhari. However, they accused Malami of wrongly advising the President on the case.

spokesperson/chairman, Senate Committee on Media and Publicity, Senator Ajibola Basiru, described the judgement dismissing the suit brought against section 84(12) of the Electoral act 2022 as a vindication of the National Assembly.

Buhari and the Attorney-General of the Federation and Malami had filed a suit at the Supreme Court, seeking an interpretation of the controversial clause in the Electoral Amendment Act 2022.

In the suit filed on April 29, the plaintiffs listed the National Assembly as the sole defendant.

Section 84 (12) has been a subject of intense litigation and political debate in Nigeria since President Buhari signed the amended Electoral Act 2022 into law in February this year.

Shortly after signing it into law, Buhari had urged the parliament to delete the controversial clause in the Electoral Act, but the National Assembly declined the president's request.

According to Section 84 (12) of the legislation, "No political appointee at any level shall be a voting delegate or be voted for at the convention or congress of any political party for the purpose of the nomination of candidates for any election."

The suit came weeks after the Federal High Court in Umuahia, Abia State, struck out Section 84 (12) on the ground that it was in conflict with some sections of the Nigerian constitution.

The Supreme Court on Friday expunged the case on the grounds that it lacked the jurisdiction to entertain the suit and is an abuse of court process.

Basiru had blamed the Attorney general for always giving the President legal advise that cannot stand the test of judgement.

"The judgement of the Supreme Court just validate some of our opinions that the President is not receiving very sound legal advise from the office of the attorney general.

"Like he was also misled over the issue of grazing roots in the past, the same thing, having assented to a bill, the same President cannot go ahead to seek to delete an aspect of the bill.

"So we hope the President will be alive to getting second opinion on legal matters so that the Federal Government would not be embarrassed on plain legal matters that are very elementary.

When asked on the position of the National Assembly over the judgement he said, it shows that the judgement did not consider the constitutionality or otherwise of section 84(12) and so the court declined to invalidate the law that means that the law still stands as at today.

"Section 84(12) still stand as part of the extant laws of the country and that any political party that does not comply with the provision does so at his own peril. "I also know that for instance notwithstanding the case filed by the Attorney General even the President complied with the law by asking his appointees to resign and they resign and those of them that resigned were not even reappointed.

"So in terms of the implementation of the law the President and the political parties implemented the law so one would not know what was the interest of the Attorney General litigating the provision that had been complied with by even his President and the political party.

In the same vein, the senator representing Kogi West, Smart Adeyemi applauded the apex court for throwing out the suit.

Adeyemi at the weekend in a telephone chat said the judgement has affirmed the doctrine of the seperation of powers.

President Muhammadu Buhari and

Adeyemi said, "everyone now knows the limit of his powers, that is what the supreme Court has just done. To tell the executive that this is the limit of their own powers so they should not delve in to the powers of the legislature just like the judiciary must be respected. "So this is a far reaching judgements. It would allow every arm of Government to know the limit of its powers so that you don't infringe on another person's constitutional responsibility as it is entrenched in the constitution the powers of each arm of Government

"I think this will guide the executive now and forever in the way and manner people use their position.

"The clause was meant to safeguard and ensure that nobody will have any advantage over others in a democratic setting that is just what we wanted to achieve by that clause and I think this judgement has affirmed our position and it shows we have done the right thing.

"I was one of those who actually contributed to the debate on that section at the committee level and at the floor of the senate. I have been filling the development with keen interest.

"The section was inserted based on people taking advantage of their position as members of the executive to contest election. Those were what informed our position and I think it is better that way.

"We thank the judiciary for doing what is right for the country.

"It is not for the executive to make laws, it is for legislators to make laws, that is why they were elected in the first place where we have 360 house of Representatives and 109 senators can we all be wrong. It is very clear for me I am delighted with the judgement by the supreme Court."

> Visits to two small former Soviet states in central Asia will be made by President Vladimir Putin this week in what would be the Russian leader's first known trip abroad since ordering the invasion of Ukraine.

Pavel Zarubin, the Kremlin correspondent of the Rossiya 1 state television station, said Putin would visit Tajikistan and Turkmenistan. He will also meet Indonesian President Joko Widodo for talks in Moscow.

In Dushanbe, Putin will meet Tajik President Imomali Rakhmon, a close Russian ally and the longest-serving ruler of a former Soviet state. In Ashgabat, he will attend a summit of Caspian nations including the leaders of Azerbaijan, Kazakhstan, Iran, and Turkmenistan, Zarubin said.

Putin's last known trip outside Russia was a visit to the Beijing in early February, where he and Chinese President Xi Jinping unveiled a "no limits" friendship treaty hours before both attended the opening ceremony of the Olympic Winter Games.

Russia's February 24th invasion has killed thousands of people and displaced millions more. He said the main aim of the invasion was to defend "our" people in the largely Russian-speaking Donbas region of eastern Ukraine.

eason for the Federal Government sack of Acting Accountant-General of the Federation (AGF), Anamekwe Nwabuoku, and immediately inviting eligible candidates to apply for the position of the substantive one has emerged. Findings by The Trumpet indicate that Nwabuoku, who was appointed through a letter

dated May 20, 2022 and signed by the Permanent Secretary in the Federal Ministry of Finance, Budget and National Planning, Aliyu Ahmed, was removed 28

days after his appointment. Consequently, the Federal Government redeployed him to the Federal Civil Service Commission (FCSC) as Director of Finance without giving any official reasons.

It was also learnt that the processes to fill the vacant seat of a substantive AGF commenced through a circular with referenced number: HCSF/PS/CMO/193/03 and titled: Commencement of the process of appointment of a substantive Accountant-General of the Federation" by the Head of the Civil Service of the Federation, Folasade Yemi-Esan, who requested eligible applicants to submit their applications on or

before July 6, 2022. The call for qualified applicants to fill the position became

Linkage Assurance shareholders applaud growth despite tough operating environment

Shareholders of Linkage Assurance Plc have applauded the company's performance, which saw it grow its Gross Premium Written (GPW) by 34 per cent in the 2021 financial vear in spite of the challenging business environment.

A cross section of the shareholders including Bisi Bakare, who spoke at Linkage Assurance Plc's 28th Annual General Meeting (AGM) in Lagos, said the operating environment had become increasingly competitive and commended board and management for making deeper inroads into oil and gas, aviation and agriculture businesses, among others.

In addition to #EndSARS, other two major claims occurred in 2021 for which provision of N1.5 billion and N750 million has already been paid.

While assuring the shareholders of better performance in the current year given its first quarter and second quarter performance, he said: "We will continue to refine our strategy in line with the political, economic, sociological and technological changes in the industry.

"We will also continue to develop innovative products, alternative channels of distributions and strategic initiatives that will enable us to achieve our corporate goals and objectives. With a medium-to-long term perspective, we believe that we will benefit from growth in these initiatives, Fumudoh stated.

While responding to share-holders' questions, Managing Director and Chief Executive Officer of Linkage Assurance Plc, Daniel Braie, pledged commitment to meeting its claims obligation despite the challenging business environment.

Informing that the company paid out whopping N3.99 billion claims in 2021 financial year, against N2.41 billion in 2020, Braie said its reinsurance capacity was strong to continue to

To improve our business process and services, we will commence the first phase of our digital transformation plan during the year, the CEO assured. necessary after the immediate past AGF, Idris Ahmed, was arrested by the Economic and Financial Crimes Commission (EFCC) over an alleged N80 billion fraud.

Idris was subsequently suspended by the Minister for Finance Zainab Ahmed and appointed Nwabuoku in acting capacity.

In the circular dated June 21, 2022, Yemi-Esan noted that President Muhammadu Buhari approved the process, adding that the role was open to all directors and accountants in the service, who are not due for retirement before the end of 2024.

"Following the President's approval, the Office of the Head of Service of the Federation is commencing the process of appointing a substantive Accountant-General of the Federation from eligible directors and accountants in the pool of accountant general of the federation.

"Consequently, all accountants in the mainstream federal civil service in the pool of accountant general of the federation, who have attained the position of substantive directors from grade level 17 on or before January 1, 2020 and are not retiring from the service earlier than December 31 2024, are eligible to participate in the exercise. Officers undergoing disciplinary proceedings are, however, excluded from the exercise," the

circular added. It further directed permanent secretaries to forward the list of eligible directors on SGL17, confidential and personal files of all eligible directors, five copies of curriculum vitae of each of the eligible directors and a brief on each of them in the attached format to be produced in Microsoft Word and in five hard copies) and soft copies.

Bread producers threaten strike over bakery materials' price hike

Bread producers and caterers, at the weekend, threatened to withdraw their services across the country due to the unprecedented increase in the price of bakery materials and Federal Government's purported neglect of the matter.

In a communiqué issued by the national leadership of the Association of Master Bakers and Caterers of Nigeria (AMBCN), the group stated that the cost of flour, sugar and other materials used in bakery business had increased beyond the reach of most bakers.

The communiqué, which was issued after the National Executive Council (NEC) meeting of the association in Abuja, and made available to The Trumpet on Friday, the bakers stated that they would down tools from July 13, 2022, if the situation persisted. They also revealed that ef-

forts to get the government's intervention in the matter had been unsuccessful, as there had been no positive response from the concerned ministries, departments and agencies of government.

The communiqué, signed by the association's executives, led by its National President, Mansur Umar, stated that the council reviewed the "neglect of the Federal Government in addressing the challenges facing our sector as captured in our letters acknowledged by the Federal Ministry of Industry, Trade and Investment, Federal Ministry of Finance, Central Bank of Nigeria and unproductive intervention of the Secretary to the Government of the Federation.

"Increase in prices of bakery materials especially flour and sugar having reached unprec-edented levels, for example, flour is now between N25,000 and N27,500, so also other ingredients.

The National Wheat Cultivation Committee already constituted is yet to be inaugurated after over one vear. NAFDAC, SON, NESREA have turned the bakers into money making machines by charging our members outrageous levies even at this very challenging moment.

NCS, SON disagree over influx of substandard goods at ports

Standards Organisation of Nigeria (SON) and the Nigeria Custom Service (NCS) have disagreed over the influx of substandard and fake goods and products that have flooded the country's markets through the ports.

Recently, Director General of SON, Mallam Farouk Salim, who spoke during the destruction of some wholesome products at Amuwo Odofin in Lagos, blamed the influx of the products on the fact that officials of the agency were not at the nation's various ports.

He indicted the NCS for not carrying his officials along in its various cargoes' inspection.

While supervising the destruction of cable wires, stuffed tyres and gas cylinders worth billions of naira, Farouk said his officers are not given unfettered access to the port to partake in joint cargo examinations by the custom.

But in a swift response to Salim's allegation at the weekend, Public Relations Officer (PRO) of the Customs, Timi Bomadi, disagreed with the SON, saying

the statement ascribed to the SON Director General was not true.

Bomadi stated that there are existing open channels of officials of SON and Customs Area Commands should the need arises for clarification or interventions, adding that NCS's usually partake in examination of goods.

We want to state that the SON's allegations are untrue. The Nigeria Custom Service is fully cognisant that strategic cooperation among security and regulatory agencies is at the heart of national security and will willingly work in tandem with other security and regulatory agencies including the SON, to achieve national goals.

"Under the Nigeria Integrated Customs Information System (NICIS 11), SON and other regulatory agencies of government are linked directly and frequent make inputs in reference to their operations.

"At no time did the NCS refuse to oblige them with any request. Indeed the Nigeria Custom Service even without intervention from SON on its own directs suspicious items bordering on brand and intellectual property rights infringements to them,' he said.

Speaking further, he explained that the SON has access to NCS systems and that its officials are informed and fully participate in examination of goods and accessing the Customs website.

"Therefore, the statement ascribed to the Director-General of SON creates a totally false negative light. It is questionable, raises serious concern and calls for scrutiny by discerning members of the public. It is also self-condemning.

"SON has access to our systems, the officers are informed and fully participate in examinations and even go as far as

collect product samples where necessary during examinations for their investigations. Even the field inspection process chart on the SON official website shows the involvement of SON at the ports and boarders during examinations.

Bomodi stressed that if after issuing certificates, participating in examinations, taking samples for further investigations and authorising releases to the NCS, substandard goods find their way into the open market, the SON boss should look inwards.

"While success is said to breed opposition, the success of the NĈS is not achieved by tarnishing the image of other agencies, just to look good or score cheap points," he added.

While Fielding questions from journalists on why fake products are all over the country, Farouk said: "We are not always invited for joint inspection, it is rare and in-between, but I guarantee you that if our officers get opportunity to inspect these products, the moment they look at it from their experience, they would be able to detect substandard goods.

'Don't forget that our colleagues in the Customs service are only trained to charge duty payment, they have no idea what substandard goods look like. But our officers are trained on how to check these products and determine if they are substandard.

"We do not have unfettered access like the constitution said we should, the law 2015 Act says we must be allowed to be at the port, it is not a favour that we should be waiting on someone to call us into the port.

'As Nigerians, we are part of the government by law, unless the law is changed by the National Assembly and signed by the President, the law says that the SON must be present at the port and not at the discretion of other agencies," he stated.

Naira volatility persists, inflation rises despite raise of MPR, says ABCON

Continuing volatility of the naira, in spite of foreign exchange interven-tion by the Central Bank of Nigeria (CBN) is being compounded by the rising inflation, interest rate and slow economic growth, which pose great consequences for the low and middle income earners in the country if urgent steps are not taken to remedy the situation.

President of the Association of Bureau De Change Operators of Nigeria (ABCON), Alhaji Aminu Gwadabe, who stated this at the weekend in Lagos, maintained that the unfolding scenario raises the risk of stagflation with potentially harmful consequences for the poor in the economy.

He added that already, the global growth is expected to slump from 5.7 per cent in 2021, which is significantly lower than the 4.1 per cent predicted by the International Monetary Fund (IMF) in January 2022.

Gwadabe stressed that to keep the country's economy going and strong in the face of these challenges, there was the need for improved local production and diversification of the economy from over-dependence on oil and gas.

He said the naira exchanged for N614 to one United States of America dollar at the parallel market during the weekend, adding that dollar bids continues to rise as inflation rose to 11-month high, maintaining that these occurrences were eroding the purchasing power of most households in the country.

"The biggest driver of inflation is the stubborn rise in food inflation. The average price level of the food basket rose by 1.13 per cent to 19.54 per in April 2022. This can be reversed by increased support for agriculture and government policies that support the sector," he stated.

The ABCON boss said Nigeria's huge population and the Diaspora market, which attracts an average of \$20 billion yearly into the country, could be explored to deepen dollar inflows to the country's economy maintaining that the dollar receipt points through over 5,000 Bureaux De Change Operators have the potential of deepening dollar inflows and

significantly improve the economy. He said globally BDCs remain one of the channels through which the Diaspora remittance funds come

into countries.

Gwadabe, who pointed out

that BDCs remain at the center of economic development and have the capacity for the development of the Nigerian economy and deepening the foreign exchange (Forex) market, expressed the belief that the success of BDCs will be boosted by access to multiple streams of forex earnings to deepen the market, keep the naira stable and boost BDCs operations.

"Making BDCs one of the major channels through which \$20 billion Diaspora remittances enter the economy yearly will give dept to the forex market and boost BDCs operations in the country. Nigerian BDCs operators have also identified with the immense opportunities presented by Diaspora remittances and want to play greater role in attracting more foreign capital inflows into the economy.

He stressed that remittances are known to help poorer recipients meet basic needs, fund cash and noncash investments, adding: "Finance education fosters new businesses, service debts and essentially, drive economic growth."

Speaking further, the ABCON boss said although the CBN recently showed greater commitment to curb inflation by raising the Monetary Policy Rate (MPR) by 150 basis points to 13 per cent per annum, strengthening the economic through local production would reverse negative trends in the economy.

He stated that as inflation rate remain higher than interest rates, retaining interest rates on investment would drop and foreign capital inflows would falter, leading to sluggish economic growth.

Gwadabe noted that other advance economies, including that of the United States of America, was also fighting inflation with its interest rate hike.

The United States of America Federal Reserve Bank had maintained its monetary policy tightening stance, raising interest rates by 75 basis points to 1.75 per cent in order to rein in inflation. This is the third rate hike this year and the biggest increase since 1994.

"The rise in United States interest rate will cut capital inflows into Nigeria and other developing markets. United States is the largest source of capital imports into Nigeria in first quarter of 2022 accounting for 5.21 per cent of total capital inflows," he stated.

In a statement the Chancellor, Catholic Archdiocese of Kaduna. Reverend Father Christian Okewu Emmanuel, disclosed the gunmen raided the farm at Kujama along Kaduna-Kachia road and hacked the priest to death.

"It is with a heavy heart, but with total submission to the will of God that we announce the death of Rev. Fr. Vitus Borogo, which sad event took place today, at Prison Farm, Kujama, along Kaduna-Kachia road, after a raid on the farm by Terrorists.

"Until his death, late Fr Vitus aged 50 years was the chaplain of the Catholic community of the Kaduna

State Polytechnic, and the Chairman chancellor added. of the Nigerian Catholic Diocesan Priests Association (NCDPA), Kaduna Chapter.


Gruesome attacks by gunmen continue unabated in Kaduna State despite the presence of military barracks and other security formations.

In a statement by the State's Police Public Relations Officer, DSP Bright Edafe, the CP expressed sadness over the crisis which has most times led to the abduction of farmers.

Advising the settler community to look inward and identify the moles among them, he urged the herders, farmers and all stakeholders to cooperate and fish out the bad eggs to pay for for their evil in the interest of peace.

Edafe stated, "On Friday, 24/6/2022, the Delta State Commissioner of Police, CP Ari Muhammed Ali, in company of the Assistant Commissioner of Police Operations ACP Sa'ad Ibrahim and the DPO Obiaruku had a brainstorming meeting with Stakeholders in Obiaruku to discuss the recent crisis between the Indigenes of the community and the Hausa community. The crisis incited by herders and farmers conflict is a worrisome trend and requires urgent attention.

"The CP in his remarks expressed his sadness over the development regarding the farmers/herders crisis, particularly as it sometimes climax to the extent of kidnapping farmers and others alike. NPF, INTERPOL synergy leads to recovery of three stolen vehicles in Niger Republic

Synergy between Nigeria Police Force (NPF) and International Criminal Police Organization (INTERPOL) has led to the recovery of three vehicles that were stolen from Nigeria in Niger Republic.

Inspector-General of Police, Usman Alkali Baba disclosed this in a press statement by Force Public Relations Officer, CSP Olumuyiwa

Adejobi, at the weekend. According to the statement, the achievement was recorded following credible intelligence and physical support from operatives of INTERPOL, which led to the trailing of a trans-border car theft syndicate and the eventual recovery of their loot.

The statement reads, "The Inspector-General of Police, IGP Usman Alkali Baba, mni, NPM, fdc, has commended the cooperation and synergy between the One Hundred and Ninety-Four (194) member countries of the International Criminal Police Organization (INTERPOL) which has facilitated worldwide police cooperation for enhanced crime control.

"The IGP equally commended operatives of the Force Criminal Investigation Department (FCID), INTERPOL Section, for leveraging the platform made available through INTERPOL to curb trans-border crimes especially crimes that cascade into other neighbouring African countries.

"The IGP made this remark upon the successful recovery of three vehicles stolen from Nigeria in the Niger Republic. The achievement was recorded following credible intelligence and physical support from operatives of INTERPOL Niamev which led to the trailing of a trans-border car theft syndicate and the eventual recovery of their loot.

"The investigation which lasted for several days led to the recovery of a Toyota Camry with Chassis

No: 4T1BE46K47U673141, Mercedes Benz 2012 550GL with Chassis No. 4JGBF8GE8CA762560 and a Hyundai vehicle with Chassis No:

KMHDH41EBDU54686.' The statement further added that investigation into the matter is still ongoing with a bid to arrest all persons complicit in the case.

While commending the unrelenting efforts of Police Operatives, the IGP commended the INTERPOL Niamey for their cooperation and the important roles played in the recovery of the stolen vehicles.

According to the IGP, the multilateral relationship is vital to nip crimes and criminality in the bud. He urged members of the public to report cases of stolen vehicles so that prompt and necessary action can be taken towards recovering them either within or outside Nigeria.

He called on the owners of the recovered vehicles to approach the Nigeria Police Force Criminal Investigations Department, INTERPOL Section, at the Force Headquarters, Abuja, for the recovery and claims of their vehicles, with valid proofs of ownership and proper means of identification.

The statement continued: "The IOC administration will finalise on an exceptional basis alternative models for the organisation of these boxing competitions, working closely with the Paris 2024 Organising Committee and athletes



NDLEA arrests man with cocaine, kingpins

peratives National the Drug Law Enforcement Agencies (NDLEA) have arrested a Brazilian returnee, Benson Uche Igwedum, who allegedly concealed cocaine in his private part.

A statement on Sunday NDLEA's Director of Media and Advocacy, Femi Babafemi, said the suspect was arrested at the arrival hall of Murtala Muhammed International Airport, Ikeja Lagos on 20th June.

According to him, Igwedum had swallowed about 50 wraps of cocaine before departing for Nigeria but excreted 48 pellets in Addis Ababa where he handed them over to another

person. He said, "Igwedum was nabbed at the Lagos airport on Monday 20th June upon his arrival on Ethiopian Airlines from Sao Paulo, Brazil via Addis Ababa. Preliminary investigations reveal the suspect had swallowed 50 wraps of cocaine before departing Brazil and excreted pellets in Addis Ababa 48 where he handed them over to

another person. "He however claimed he was unable to excrete the remaining two wraps at the hotel room in Addis Ababa before boarding his flight but later excreted them in the aircraft restroom during the flight from Ethiopia to Lagos.

According to Babafemi, "After three weeks of painstaking investigation and tracking, operatives of the MMIA command of NDLEA on Saturday night, 25th June arrested a drug kingpin, Onyekachi Chukwuma MacDonald, behind attempts to export 40 parcels of Methamphetamine popularly called Mkpuru Mmiri locally to London, United Kingdom through the NAHCO export shed of the Lagos airport.

"Onyekachi was arrested at Manacola estate, Alakuko area of Lagos at the weekend, three weeks after his Mkpuru Mmiri consignment weighing 2.05kilograms was intercepted at the airport and his freight agent, Peter Christopher Anikan arrested on 7th June.

"During his interview, the suspect said hes from Ahiazu, Mbaise Local Government Area of Imo state and had lived in Dubai, UAE for 10 years before returning to Nigeria in 2019. He stated that after his return to Nigeria he opened a phone accessories shop in Sango Otta, Ogun state but the business collapsed. He then started sending cigarettes to London and decided to conceal the illicit drug in the consignment after advice by a friend."

In another development, the agency seized another consignment of 2kg Mkpuru Mmiri at a courier house in Owerri, Imo state.

"The cargo seized on ednesday 22nd, June Wednesday June had ankara and lace fabrics in which two cylindrical cellophanes containing the drug heading to Hong Kong were concealed.

"Also at the Lagos airport, NDLEA NDLEA operatives on Friday 24th June intercepted 500,000 tablets of Tramadol 225mg packed in 10 cartons and labelled Tramaking imported from Karachi, Pakistan on Emirates Airline. The consignment weighing 407.60kg was seized during a joint examination with Customs and NAFDAC officials.

Kebbi Area Command of the Nigeria Customs Service (NCS) has handed over Donkey Skin worth N48,130,642 to Nigeria Agricultural the Quarantine Services (NAQS).

Area Comptroller of the Command, Comptroller Joseph Attah during the handing over ceremony at the weekend, said the interception was made by the Command's Rapid Response Team around Bahindi – Dogon Rimi Waterside in Bagudo Local Government Area of the state.

According to him, a total of 2,820 Donkey Skins, which were concealed in about 94 jumbo sacks with each containing 30 pieces each, were recovered by the Service.

He added that exportation of Donkey Skins is prohibited by

Law, so the attempt to smuggle them outside the country contravenes Section 63(b) of CEMA CAP C. 45, Laws of the Federation of Nigeria, 2004 (as amended).

His words: "The items were evacuated from the location and brought to our Headquarters in Birnin Kebbi. Physical examination revealed ninety-four (94) jumbo sacks, each containing thirty pieces making a total of two thousand eight hundred and twenty (2,820) donkey skins. The item is valued at N48,130,642.00.

Tariff - (2022-2026) exportation of which is prohibited. The intent to smuggle it out of the country, therefore, contravenes Section 63(b) of CEMA CAP C.

"Donkey skins fall under Schedule 6 of Common External 45, Laws of the Federation of

Nigeria, 2004 (as amended)." While condemning the slaughtering of the 2,820 donkeys, eventually extinction of the livestock, he

recalled Nigeria's signatory to a multilateral Convention on International Trade on Endangered Species of Flora and Fauna (CITES) which makes a trade on donkey skins illegal. The items were converted

to seizure and in line with the directive of the Comptroller General of Customs, Col. Hameed Ibrahim Ali (Rtd), the ninety-four (94) jumbo sacks of the donkey skins are being handed over to Nigeria Agricultural Quarantine Service, Kebbi State in the spirit of interagency collaboration," he added.

NCS, SON trade words over importation, proliferation of substandard goods

Nigeria Customs Service (NCS) and Standard Organisation of Nigeria (SON) are engrossed in a war of words over importation and proliferation of substandard goods.

Director-General/Chief Executive of SON, Mallam Farouk Salim, had on Thursday flayed Customs over the smuggling of fake and substandard goods out of the nation's seaports. He spoke while destroying fake goods intercepted by the organization in some parts of the country.

Salim accused the Service of being responsible for revenue losses, as well as the preponderance of fake and substandard products in the country.

He faulted Customs for excluding officials of SON from joint examinations of imported goods at the seaports and borders, saying the exclusion is a major reason for the proliferation of substandard and fake products.

Responding on behalf of the Comptroller-General of Customs, the Public Relations Officer, Timi Bomodi, in a statement at the weekend described the position of SON as mere fiction while accusing the organization of incompetence.

has always directed suspicious items bordering on brand and intellectual property rights infringements to SON even intellectual property without any intervention from them. He stressed that the Service has not received or turned down any request from SON on joint

Bomodi stated that NCS

examination of goods at the borders. He affirmed that the services of Customs are accessible to SON. Bomodi said, "We want to

state that the allegations are untrue. The Nigeria Customs Service is fully cognizant that strategic cooperation among security and regulatory agencies lies at the heart of national security willfully works in tandem with other security and regulatory agencies including SON to achieve national goals.

"Under the Nigeria Integrated Customs Information System (NICIS II), SON and other regulatory agencies of government are linked directly and frequently make inputs in reference to items of significance to their operations. At no time has NCS refused to oblige them with any request. Indeed the Nigeria Customs Service even without intervention from SON on its own directs suspicious

items bordering on brand and intellectual property infringements to them. rights

"The attached redacted documents buttress the fact that SON has access to our systems, are informed and fully participates in examinations and even go as far as collect product samples were necessary during examinations for their investigations. Even the field inspection process chart on the SON official website shows the involvement of SON at the ports and borders during examinations.

"There exist open channels of communication between officials of SON and NCS Area Commands should the need arise for clarifications or interventions."

He remarked that the statement of the SON's DG is an attempt to portray NCS in bad light and cautioned that government agencies should work in synergy in the interest of the nation.

He added: "Therefore this statement ascribed to the DG creates a totally false narrative and is viewed as an attempt to portray the NCS in a negative light. It is questionable, raises serious concerns and calls for scrutiny by discerning members of the public.
