Buhari, Tinubu, other APC chiefs' mind games heighten ahead of primaries

uhari fired the first salvo when he enjoined APC governors to allow him to choose like his successor they do. This demand ruffled feathers in some quarters, including presidential aspirants who are pushing for the primary election instead of consensus candidacy. Reactions followed immediately.

Tension in the APC has reached a crescendo and uneasy calm is pervading the entire Buhari House edifice, the party's national secretariat, over uncertainty over where the presidential ticket pendulum swings.

Millions of the party faithful were thrown off balance by Buhari's plea that APC governors should allow him to nominate his successor from the 23 screened aspirants. Many were more confused than they were before the 'unfriendly' Villa meeting.

President The blackmailed the governors and subsequently sowed a seed of discord among them as to whether they should give an express permission to his request or requested reciprocal respect by the president.

The division obvious some as governors seeking reelection are ready to do the president's bidding while a few others putting up resistance are cautious of being hunted by their past deeds in government by avoiding the 'Ókorocha's treatment'.

Buhari's insistence also is causing rift in the party's hierarchy as two National Vice Chairmen (North West and South West) have bee challenging not only seeming autocratic posture of APC national Abdullahi chairman, Adamu but by extension the undemocratic decision of Buhari to foist a candidate on the party.

More than four days after concluding the screening, the John screening, the Oyegun-Odigieled panel on Friday released the result of the exercise, creating more tension and confusion by just saying 13 aspirants wwre cleared . Despite this, there is tension over nonmentioning of the 10

Tinubu himself obviously gave in to emotion on Thursday in Ogun State when he lamented like someone who knew he ',has lost the battle'.

His outburst on how he crowned Buhari in 2014 as well as Ogun State Governor Dapo Abiodun sounded defeatist and he seems to be poised for the worse, after all an adage says "he who is down needs fear no fall again".

majority А of Tinubu's supporters do not entertain any fear of endorsement from Buhari but asked that the party leadership should allow cleared aspirants to test their



popularity among the delegates.

Tunde Hammed Aresa, Deputy Coordinator, Osun States'Chapter BATIC MOVEMENT of Nig, one of the numerous Bola Tinubu support groups said President Buhari if Buhari is a democrat, he should come out and work for his anointed but allow aspirants to battle it out at the primary.

He said: "all we have asked the President and anyone preaching consensus to do is to come to the Convention and beat Tinubu, if you can.

Court restrains bank, others from paying former deputy governor

High Court sitting in Owerri, the Imo Capital, presided over by Justice М. E. Nwagboso, has issued an order restraining five commercial banks in the country from debiting the state funds in order to pay former Deputy Governor Eze Madumere, pending the determination of a suit before the court.

The state government in its application stated that the state's fund domiciled with the affected commercial banks are for the salaries. pensions and gratuities of Imo workers and

retirees respectively. Iustice Nwagboso, stated that the order followed an exparte motion filed by the Attorney-General of Imo State against the affected institutions and individuals which includes Zenith, Access, UBA, Union and First Bank.

Madumere, upon which a garnishee order was used to seal Zenith Bank, the subsequent appeal has vitiated the earlier order. He therefore advised all parties in the case to adhere to due judicial process and refrain from self help while the matter lasts.

According to the Minister, about 760 million people lack access to electricity worldwide, with 3 out of 4 of them living in sub-Saharan Africa. ing power worldwide. "Nigeria has already made a strong commit-ment to embracing energy transition, pledging to significantly reduce its greenhouse gas emissions under the Paris Agreement on Climate Change. This is in addition to the commitment Nigeria made through His Excellency President Muhammadu Buhari, at COP 26 in 2021 to attain carbon net-zero by 2060.

"Nigeria needs affordable, reliable and sustainable energy resources to eradicate the prevalent energy poverty in the shortest time possible, and propel economic growth. The only viable option currently on the table is natural gas, considering our vast proven gas endowments, put at 209 tcf, with 600 tcf potential reserves. We cannot ignore this resource, especially when energy poverty is viciously starring at us,' he said.

He called on African countries to stand together to weather the climate change storm, while avoiding losing all recent gains in the quest to pull the continent's vast population out of energy poverty, and economic poverty.

Lagos postpones basic education examination

The examination, otherwise known as the "Junior WAEC" which is for the JSS3 students in both the public and private secondary schools in the state was earlier scheduled for between Wednesday, June 1 and June 8 will now take place from Wednesday, June 8 to Wednesday, June 15, 2022.

A statement signed by the Director, Lagos State Examinations Board, Mr. Supo Gbadegesin, said the postponement was due to the inability of some registered Approved Private Junior Secondary Schools to upload the bio-data of their candidates for the printing of their Optical Mark Readers (OMR) Sheets.

Gbadegesin added that Tuesday, 31st May, the exam dates again.

He pointed out that it was necessary to shift the dates of the examinations to accommodate other schools that were yet to upload the data of their candidates into the Board's database so that the students would not be denied the opportunity to write the examinations.

agos crushes over 2,000 impounded motorcycles

lowing the total ban d on Motorcycle operations across six Local government areas of Lagos, the state government on Friday, crushed no fewer than 2,228 impounded motorcycles for failing to comply with provisions of the traffic law.

The over 2,000 motorcycles were among those impounded by the Lagos State Taskforce and other enforcement agencies saddled by the government with the responsibility of ensuring compliance with the traffic law across the state. 259 Meanwhile, over

motorcycles were impounded within 48 hours after the total ban across six local governments, and 18 suspected riders, as well as passengers, were apprehended during the enforcement exercise.

As gathered, the state government has concluded plans to prosecute both passengers and riders by arraigning them before the Lagos mobile court for violating the state laws. The Chairman of the

Lagos State Taskforce, Shola Jejeloye, disclosed that the state government will not relent in its efforts at ridding the metropolis of disobedient Okada riders.

Jejeloye explained that the over 2000 motorcycles being crushed were in continuation of the exercise and that it was often done as stipulated by the law and served as a deterrent to others still plying restricted routes across the state.

The Chairman stressed that the agency would further intensify its effort in ensuring that all impounded motorcycles were crushed after following due process of Traffic Laws, as enshrined in Lagos State Transport Sector Reform Law of 2018.

According to him, the law said that no two persons shall ride, drive or propel a motorcycle or a tricycle on a major highway within the state, and any person in

contravention of this provision commits an offence and will be prosecuted.

Jejeloye added that the agency's efforts have been doubled since June 1, when the ban took effect. "Although the compliance rate is very high and encouraging, okada operators are not to be trusted. Their style of operation is synonymous with gorilla warfare- when we retreat, they advance, and when we advance, they retreat, but enforcement of the ban has come to stay.

"We will ensure not a single offender operating his okada on the Highways will be spared. We will keep watch and continue patrolling

the affected parts of the State to ensure they do not get back on our toads."

The chairman stated that in the past, he had made a series of appeals verbally and through the mass media on the dangers of Okada operations in the state, but

the perpetrators remained hell-bent on carrying on with their dare-devil style of riding against traffic, speeding recklessly, damaging vehicles of other road users; and endangering their lives, passengers, pedestrians and other road users.



Waste management: Oyo govt terminates PSPs' appointment, sets June 10 as renewal deadline

The Oyo State Government has terminated the appointment of waste collectors, setting June 10, 2022, as deadline for re-application of renewal of contract.

Revealing the new devel-

opment in a meeting held with the Waste Collectors (Private Sector Participants) and Stakeholders, the Honourable Commissioner for the Ministry of Environment and Water Resources, Mr Abiodun Oni, reiterated that the new initiative was conceived to



actualise the vision of keeping Oyo State clean, while also harnessing other opportunities that are inherent in proper waste management system. "We are tired of using the

same approach without getting results," he said. The Commissioner further narrated instances where the

State had heaps of refuse in open spaces, thereby, causing embarrassment and posing threats to the health of residents in the State.

He further assured residents that the State Government was taking holistic measures to ensure that the State experiences a turn-around in the

environmental sector.

He also announced that the State Governor, Engr Seyi Makinde, has approved the appointment of a new Waste Management Consultant, Mottainai Recycling Africa, who will see to the day to day running of the disposal mechanism in the State.

Speaking further on this development, the Permanent Secretary for the Ministry, Mrs Modupe Adeleye, revealed that the action taken on the re-application of the PSP operators was intended to move the State forward and ensure a cleaner and healthier environment.

She enjoined all the stakeholders to work with the State Government in actualising this agenda.

In another development, the State Government has again embarked on enforcement to caution traders towards improving sanitation within the environment and also checkmating traffic congestion.

Hon. Oni, while calling on the traders to remain law abiding and be peaceful when carrying out their legitimate businesses also stated that this present administration is poised at maintaining and sustaining the State ecosystem

towards ensuring a clean and green environment that would be attracting investors to thrive in the State

Similarly, the Oyo State Government has sealed a filling station for violating the Environmental laws and failure to carry out the state's weekly sanitation exercise.

The filling station located at Gate in Ibadan was also accused of accommodating a filthy drainage lane which environmental officers alleged exposed residents to health hazards and could also pose an environmental threat to people's health if not timely addressed.

Aggrieved Nigerian man Obinna, 41, shoots wife, kills mother-in-law, commits suicide in US By BENJAMIN OMOIKE

A 41-year-old Nigerian, Obinna Igbokwe, on Wednesday night in Texas, United States, shot his wife, Tangela Igbokwe, killed her mother and fled to North Texas with their three-month-old son, Mansa, before finally killing himself.

Igbokwe lived in Spring, Montgomery County of Dallas, Texas.

According to the U.S. police, Obinna Igbokwe and his wife argued over the custody of the couple's three-month-old son Mansa.

The argument, according to the police, led to the shooting. Igbokwe shot his wife and her mother point blank, in the head.

The wife, who survived the shooting is, however, said to be in critical condition in the hospital.

But her mother, Linda Larkins, who was also shot in the head was pronounced dead at the scene.

Police authorities said

the suspect's 14-year-old son might have witnessed the shootings and went next door to get help.

Obinna Igbokwe reportedly took their son and fled in a 2008 white Honda Accord.

The Montgomery County Sheriff's Office deputies thereafter raised an AMBER Alert, which was, however, discontinued after the suspect shot and killed himself.

The shooting happened in the 30120 block of Aldine Westfield Road around 7.30 p.m.

According to the Corsicana Police Department, Igbokwe dropped off the child in a car seat at a hotel and said he would be right back, but never returned.

Since he did not return, police said they were contacted and learned the man left in a white passenger car.

At about 1.05 a.m., Ennis Police Department officers said they located the white Honda Igbokwe was driving and attempted to stop the vehicle.

After a short pursuit, the Honda stopped in a parking lot, where officers observed and heard a single gunshot come from the interior of the Honda.

Law enforcement officers began life-saving measures and summoned medical personnel, but due to the severity of the injury, authorities said Igbokwe succumbed to his wounds at a Dallas hospital at about 5.20 a.m.

Authorities said Mansa is safe and unharmed and has been reunited with his family.

"Our hearts are with the family affected by this tragic and horrific crime and we are working with the victims to ensure they receive support and assistance," a Facebook post from MCSO said.

This investigation is being completed across multiple jurisdictions and involves the Corsicana Police Department, Ennis Police Department, Ellis County Sheriff's Office, and the Montgomery County Sheriff's Office.

Good governance and effective representation are what I seek to offer them.

If given the mandate, what are the people of Delta South Senatorial District expecting from you?

You know the position of the legislator is not like the executive position. It is basically for making laws to provide a better benchmark and framework for the executive arm of government.

executive arm of government. So I must look at the Niger Delta and the Delta South Senatorial District. What are the pressing issues that will make it a better place for all of us? Do we have Ministries that are supposed to do certain things that they are not doing? Then, I will take them up and ensure they do what they ought to do. Is there a gap in the law that is supposed to provide the basic framework to ensure the government performs? We will now begin to push for those laws along with my colleagues in the National Assembly to ensure that those laws are provided.

Our environment, as you know, is very peculiar, partly water, swamp and land. All these things make us unique with vast cultural diversities. I have to ensure my senatorial district has the best representation. In the area of primary healthcare, you see people complaining of liver problems, kidney problems, and all sorts of illnesses which did not start on their own. It started from minor symptoms that you can go to the primary healthcare centre and they can be treated. But because of the deficiencies in the Primary Health Center, it aggravated to that level. Then, in the riverine areas, what do we need to do to make life much better for the people? Do we have the needed roads? Do we have the needed infrastructure that ought to be in those places? These are the things I will look at to make sure that at best we provide them for our people.

Like I said earlier, I have seen someone with an open mind, who has been able to do so many things in Delta Central Senatorial District, the Deputy Senate President Senator Ovie Omo-Agege. What he has been able to do alone in Delta Central is something some Governors cannot do for 8 years. That is what I expect the people of Delta natorial I Maritime University Okerenkoko, it has not even taken off, is something that is supposed to benefit our people. The seaport in Warri, is it functioning? It is something that brings about economic change to the District. What is preventing it from functioning? Even though the Federal Government said vessels can go to those places. What has happened to the refinery in our area? What kind of leverage is it providing for our youths? The Niger-Delta Development Commission (NDDC), what is it providing for our people? Our roads are bad. These are things being a legislator gives you an overview to see. And you begin to attract them to your place.

All along in your political journey, you have been operating from the executive position right from when you were the Local Government Council Chairman, Chairman Delta State Board of Internal Revenue and States Coordinator, Federal Inland Revenue Service. Now you are crossing to the legislative arm, How will you convince the electorates that you are going to serve them well?

When I joined the Delta State Board of Internal Revenue in 2009, I was a tax practitioner. When a tax practitioner becomes a tax administrator, he is an excellent person to be a legislator. For that position, for example, if you are a lawyer and they now made you a judge, you will discover that there is nothing a lawyer will tell you as a judge that you have not done before. My experience as a tax practitioner will become handy as a tax administrator. Now, to be more specific to your question. You need to be abreast with executive duties to know the lapses rendering this organ of government from functioning effectively. The truth is that most executives operate within the perimeter of the law. And when you operate within the perimeter of the law, you observe that there are hindrances provided by the law that enable them not to perform to an optimal level. That is why they continue to review the laws to accommodate these gaps that are there

accommodate those gaps that are there. Having been in the executive position, starting from the position of the Chairman of Isoko South Local Government Council, Delta State, Chairman, Board of Internal Revenue, States Coordinator, Federal Inland enue Service, I know in the law that needs to be provided to make the executive perform at the optimal level. My focus mainly will be on primary healthcare because the diseases that kill our people are not the diseases that take the rich out of the country. It is small, small ailments which standard primary healthcare can take care of. If we can provide the benchmark and framework for taking care of these things in a structured pattern and strengthen the primary healthcare system in Delta South Senatorial District, with the laws that are there in proper perspective, the prevalence of High Blood Pressure, Diabetics and stroke will be limited. Also, having held executive positions, I am more experienced to know what my people need, and the laws that need to be provided for the executive to perform optimally.

What is your take on the issue of resource control and restructuring?

The issue of resource control and restructuring has been there for a while now. This present administration did their best as much as possible to move resource control from where it was to a new dimension. The hindrances that prevented this present administration of President Muhammadu Buhari are still the same people who are preaching and calling for resource control. Resource control is allowing people to be in charge of their resources. But if you want to be in charge of your resources it also behoves you to provide the benchmark on how the resources will be managed. If you are pressuring the Federal Government for resource control and you at the State do not want the Local Government to have control over their resources, then you are paying lip service to it. As the issue of the local government autonomy, judiciary, national assembly, and state assembly are processes of resource control.

If you ask me what my position on resource control is, I support it 100 percent because it will create competitiveness among States. I am also aware that States in the federation have enormous resources that can support their existence, just that we are not willing to tap into them. I said something during my primary election that I will liaise with my colleagues in both Chambers of the National Assembly to strengthen the States to be more sustainable. So that in their own way they can provide some basic things that can eliminate poverty, because if we are unable to tackle poverty we are going nowhere in this country.

Looking at your Senatorial District since 1999 till date, it has been occupied by PDP. How do your party, APC, plan to wrestle power from them?

If you look at it from that perspective, for someone who has been in a position for so many years, there is the inability to push that person away. Let me remind you what happened in 2015, PDP that has been in power was removed by APC. There is still a gap, people are dissatisfied, there are gaps, people feel cheated, people feel they are not getting their fair share and the clamour for change is greater now than ever.

People want to experiment with something new, this desire for change and greater participation in governance in the Senatorial District is one of the things that will create the catalyst for change and I believe the time has come and the people are well prepared for that change. I am talking to people in the Senatorial District and the major thing they are looking at is, can he provide our needs? I am going to provide them with effective representation and my antecedent corroborates that. I and my antecedent conobolates that a am one person if they allow being in that position, everybody in the Senatorial District will get their fair share. And I believe they are ready. The people I have talked to are ready for that change. I am happy that I am not contesting against an incumbent. The truth is that without trying to undermine my opponent, PDP will not be a match for me. Why do I say so in this election, we are not looking at political party. We are going to be looking at individuals and their antecedents.

The National Assembly that we are going to is not a place for just anybody. If you send somebody that does not have the ability and the connection to deliver on the expectation of the people, then we have lost it entirely. For me, without trying to pride myself on the way of blowing my own trumpet, I have been in government, private sector and public sector and I was very successful. I am the right candidate for the position.

right candidate for the position. The Delta South Senatorial District comprises four ethnic groups, do you have a good reach to the people? I think it is a little bit premature for me to begin to the people the prediction

I think it is a little bit premature for me to begin to talk about how deeply the politics of Ijaws, Itsekiris and the Urhobos. It is too early for me. Politics is all about strategies and you must keep certain things to yourself. What I want to say is that I have served on the executive board that covers the whole state, and I have made my mark. I covered from Delta North to Delta Central and Delta South, I dominated it. Not only that, in the Federal Inland Revenue Service, I dominated six States; Rivers, Edo, Delta, Akwa-ibom, Bayelsa and Cross River States. So, in terms of reach, and relationships built over the years, I want to say that I am firmly rooted and I have no doubt that these relationships will pay off.

Looking at the past election, do you think this new electoral law offers some hope? The new electoral law? Yes! BVAS offers

The new electoral law? Yes! BVAS offers some hope, the second thing is that in this election everybody is fighting for his head, there is no sitting governor who is going to say he is returning, and the commissioners are not thinking about whether they are going to retain their positions because it is going to be the end of the tenure. This race is very open, some of the things that occurred the last time and they got away with in 2019, they can't get away with it this time around. I think I want to rest it at that.

PDP is known for buying votes. How do your party intend to curb vote-buying during the general election?

When there is poverty, people will begin to sell their conscience for a pot of porridge. It is difficult to prevent people from taking the money if they are offered. But what I want to say is that the environment that will occur in the 2023 election will be different from 2019, simply because they are bringing BVAS. Secondly, if you see people buying votes you have the right to report them according to the law. We only need to become more vigilant, we also need to educate our people.

Despite insecurity, INEC to continue voters registration, releases election guidelines

The Independent National Electoral Commission (INEC), on Friday promised to continue voters registration which was suspended on the account of insecurity in troubled areas of the country.

Chairman of the Commission, Prof. Mahmood Yakubu gave this assurance at a special meeting of the Inter-Agency Consultative Committee on Election Security (ICCES) to review security arrangements for the Ekiti Governorship Election held at INEC headquarters, Abuja.

This is as the Commission released regulations and guidelines for the 2023 general election.

The National Security Adviser (NSA), Maj. Gen Babagana Monguno (rtd) and Co-Chair of ICCES, Heads of various security agencies and National Commissioners were at the meeting.

Also at the meeting were the Resident Electoral Commissioner for Ekiti State, Dr Adeniran Rahmon Tella, the state Commissioner of Police, Moronkeji Adesina, Secretary to the Commission and Senior officials of the Commission

Though INEC set June 30 deadline for suspension of the Continuous Voters Registration (CVR), the commission is reconsidering its stand because of the continued surge of

Nigerians in listed areas to get registered before the deadline.

The INEC chairman said "Nigerians may recall that the ongoing CVR started a year ago. For the first time, the Commission introduced online pre-registration as well as physical registration at designated centres.

"As the deadline for the suspension of the CVR i.e. 30th June 2022 approaches, long queues are building up, especially in some states in the South East, Lagos, Kano and the Federal Capital Territory (FCT). The Commission had anticipated the last-minute surge and therefore established additional centres and deployed more machines to register citizens.

"Unfortunately, the security situation in many parts of the country has not allowed full deployment as planned. In some states of the Federation, INEC registration officers were attacked resulting not only in the unfortunate destruction of buildings and loss of equipment but even worse, the death of a staff. This has forced the closure of some of the registration centres.

"However, in view of the surge, additional machines will be deployed to some of the most congested areas to ease the surge. Similarly, the Resident Electoral Commissioners (RECs) have been directed to liaise with the security agencies and stakeholders on the possibility of

reopening some of the centres earlier closed because of insecurity, but in doing so, they must always bear in mind the safety of registrants and registration officials.

" Furthermore, the RECs are directed to do more to provide information, increase awareness of the processes and more promptly respond to genuine complaints by citizens.

He said the Commission appreciated the support of partners and critical stakeholders in mobilising citizens to register while looking forward to such partnership to encourage registered voters to collect their PVCs and for increased voter turnout on election day.

Yakubu said with the coming into force of the Electoral Act 2022, it has become necessary to review the Commission's Regulations and Guidelines to govern the conduct of elections, adding that the Constitution of the Federal Republic of Nigeria 1999 (as amended), the Electoral Act 2022 and the Regulations and Guidelines constitute the electoral legal framework.

He said "on several occasions, the Commission has assured Nigerians that we are finalizing the Regulations and Guidelines for the elections. I am glad to announce that the document is ready and will be presented to Nigerians shortly. The soft copy will be uploaded to our website with the link shared on our social media platforms.

"With the release of the Regulations and Guidelines today, and the publication of the Strategic Plan (SP) 2022-2026 and Election Project Plan 2023 earlier, the Commission has virtually concluded the planning processes for the 2023 General Election nine months ahead of the election.

"In the next couple of weeks, the training manual will also be presented to Nigerians. Going forward, the Commission will focus on election administration: logistics, training, voter education, technology, sensitization against vote-buying, inclusivity measures and, above all, security. ICCES will continue to play a critical role and the Commission appreciates the support of all security agencies."

With only 15 days to the Ekiti governorship election, the Commission said all the major activities that are supposed to be carried out at this stage have been successfully undertaken.

" I led a team of INEC National Commissioners to Ekiti State early this week to assess the Commission's preparations for the elections. We visited our offices in several Local Government Areas, held meetings with our staff, had an audience with the Council of Obas to solicit the support of their Royal Majesties for peaceful elections and met with the security agencies.

2023: Coalition for Peter Obi warns INEC against disenfranchising millions of Nigerians

Coalition for Peter Obi (CPO) made up of 17 support groups for the Labour Party's presidential candidate has warned the Independent National Electoral Commission (INEC) against disenfranchising millions of Nigerians ahead of the 2023 general elections.

CPO also called on the electoral body to extend the deadline for the collection of Permanent Voters Card (PVC).

The 17 groups have embarked on massive voter education campaign, supporting citizens to register and collect their PVC, online and at various INEC offices.

The Coalition stated that reports from around the country show that INEC lacks the capacity to register the millions of Nigerians,

especially youths, arguing that there have been complaints that Nigerians spend hours waiting to be captured.

The Coalition in a statement signed by its Chairman, Mr Marcel Ngogbehei, encouraged its members to embark on voter education, providing clear information on PVC registration and supporting the logistics to distribute millions of Permanent Voters Card (PVC) that are currently in INEC custody. The Chairman listed the various groups involved in the Voters Sensitisation Exercise and asks the general public to volunteer or support with money and logistics, adding that this is a collective task.

Mr Ngogbehei lamented the lackadaisical attitude of some INEC staff in various states, but also praised the dedication of staff in many locations, and further stated.

"CPO estimates that one INEC machine can

only register 1 person in 10mins, an average of 900 persons per month. Therefore, a Local Government Area with 2 INEC machines can only register 1800 persons per month if operating at 100% capacity, but with the present capacity, INEC needs 4 years of continuous voters' registration exercise to capture the millions of eligible Nigerians.

"INEC is hereby advised to expand its logistics operations, establish mobile registration centres, strategically move registration centres to highly populated areas like markets, partner with market leaders to encourage PVC collection, send text messages to voters on their PVC collections, allow people to book online for PVC collections and consider senior citizens in their 80s or 90s that have mobility

"INEC should start now to consider their

stakeholders and implement strategies that will provide better customer value unless they intend to disenfranchise millions of Nigerians who are eager to exercise their civic rights in the general elections.

"The Electoral body should do everything possible to cater for thousands that are currently stranded trying to register in the various locations or in the alternative, expand its logistics and extend the deadline by 6 months.

"Nigerians must be allowed to freely express their civic rights at this critical time of our nation's history.

"As a Coalition for Peter Obi's presidential ambition, we have embarked on voter education, PVC registration and support logistics to distribute the PVC across the length and breadth of this country and calls on the public to support the various groups"

Unneasy calm is now enveloping the ancient kingdom of Warri, nine months after the coronation of Prince Utieyinoritsola Emiko as the 21st Olu of Warri Kingdom and Ogiame Atuwatse III, as a result of the intrigues that characterized his selection process and eventual installation on Saturday, August 21st 2021.

A very reliable source close to the Olu of Warri Palace, who pleaded anonymity because of the possible consequences, alerted Trumpet Newspaper, about the alleged invitation by the Economic and Finance Crime Commission (EFCC) to the Olu of Warri, Ogiame Atuwatse III. Sadly, he said, "This is the first time in the history of Warri Kingdom that a sitting Olu of Warri, is being invited by an anti-graft agency to come and answer questions involving fraud.

He explained that Ogiame Atuwatse III was allegedly called by EFCC to state what he knew about a purported diversion of huge sums of money from the bank accounts of late Captain Idahosa Wells Okunbor, who died on August 8, 2021, in a London hospital, and who happens to be the late father In-Law to the Olu of Warri.

He further alleged that part of the missing money was what the Olu of Warri used to finance his coronation on Saturday, 21st August 2021, maintaining that, Ogiame Atuwatse III, has indeed appeared before an EFCC panel over this allegation twice in Abuja, thus creating apprehension among the inner circle of the Olu of Warri kitchen cabinet in the palace.

The source continued, "The widow and second wife of the late billionaire businessman, Mrs Nosa Okunbor, after the burial of Captain Okunbor, was the person that discovered that one of her late husband's bank accounts have been tampered with and large sums of money fraudulently withdrawn from the bank account, thus causing her lawyer to do a petition to EFCC prompting the agency to investigate the matter."

He stressed that the Olu of Warri Palace is presently doing everything within its powers, to make sure that this information is not made public.

Trumpet Newspaper immediately contacted Chief Mene Brown, a High Chief in the Warri palace, who is a close confidant of the Olu of Warri, Ogiame Atuwatse III for comments. Chief Brown in his response said,

"The allegation is false, wicked and reckless, stressing that "As a Chief in the Olu of Warri Palace, I do not have the authority to comment on issues like this, which have no direct bearing with His Royal Majesty, Ogiame Atuwatse III and the Warri Kingdom.

The matter in question only concerns the immediate family of the Olu of Warri's Olori Ogiame Atuwatse III. Stressing, "The best I can say, is that the Olu of Warri and the Palace of Warri Kingdom is not involved nor connected with the happenings in the

The best I can say, is that the Olu of Warri and the Palace of Warri Kingdom is not involved nor connected with the happenings in the late Captain Okunbor's immediate family or Business Empire late Captain Okunbor's immediate family or Business Empire.

He continued, "As far as I know, it is a business colleague of the late business Mogul, Dr Olatunde Ayeni, whom the late Captain Okunbor bought out of a particular business concern, they both had an interest in before his death, is the person that is alleged to be making trouble writing all manner of petitions to the EFCC after the death of his supposed friend, even though, the late Captain Okunbor left some other businesses he had interest in for Dr Ayeni to continue to manage on his own.

The Warri High Chief said, "I am however aware that EFCC has waded into Dr Ayeni's petitions and found nothing to substantiate. In all this, HRM Ogiame Atuwase III and the Warri Palace have nothing to do with all these allegations."

Our source, however, still maintained that Chief Brown, who is the one leading the cover-up game and should not be taken seriously, since he is known as the man Friday to the present Olu of Warri, Ogiame Atuwatse III, who wants everything done to cover up the mess. He went further to paint a gloomy picture of the current situation in the Warri Palace, which he says is very depressing despite the front they are all putting up. He stressed that although Ogiame Atuwatse III and some of his chiefs as Brown, the Palace Secretary Ikomi and Johnson, are desperately trying to cover up the ugly happenings in the Warri Palace, very soon the whole thing will be exposed. He said Ogiame Atuwatse III is presently jittery that is why he has now renewed his efforts for reconciliation, thus contacting all the persons they thought they had earlier conquered. That is why Ogiame Atuwatse III, is doing everything possible to reach out to his estranged Uncle, Prince Bernard Emiko and his cousin, Prince Oyowoli, the eldest son of the 20th Olu of Warri, Ogiame Ikonwoli I, who was cheated out of the throne. Both Princes he stressed are still maintaining their distances from the Ogiame and the Warri Palace. Prince Bernard Emiko, he said, has continually blocked and refused to pick up calls from Ogiame Atuwatse III.

He stressed that Chief Ayiri Emami, who was allegedly disrobed as Ologbotsere of Warri Kingdom is now being pressured at the instance of the

Olu of Warri, Ogiame Atuwatse III, by his very close friends to withdraw his cases in courts with about the selection and installation of Prince Tsola Emiko as the 21st Olu of Warri. He explained further that Ogiame Atuwatse III is very worried, and presently not too sure about the outcome of the court cases filed by Chief Ayiri Emami in his capacity as the Ologbotsere of Warri Kingdom and as the then Chairman Warri Council of Chiefs. He said, if this matter is allowed to go through all the gamut of the court processes, Ogiame Atuwatse III might lose his throne.

Our source said the Ogiame's worry is based principally on the fact that he knows that the 1979 Chieftaincy Edicts of the defunct Bendel State, which expressly stipulates the procedure and processes to be followed before an Olu of Warri can be enthroned was out rightly violated, during his selection and eventual installation as the 21st Olu of Warri kingdom. And now that the pomp and pageantry that follows the Olu of Warri coronation is over, reality has now begun to set in that the court decisions no matter how long it takes, may not favour him. Hence Ogiame Atuwatse III is presently making an effort to reach out to all the aggrieved persons in this matter.

Trumpet Newspaper source, further stressed, that on the 22nd of May, 2022, Chief Ayiri Emami, the allegedly suspended Ologbotsere of Warri Kingdom close friends, for the very first time since after the coronation of Prince Tsola Emiko as the 21st Olu of Warri, in a deliberate effort to broker peace between the two of them, arranged a meeting in Lagos in the late Captain Okunbor expensive house in Banana Island, where Chief Emami and Ogiame Atuwatse III met for the very first time in months. And before the arrival of Ogiame Atuwatse III in the meeting venue, Chief Emami told whosoever cared to listen, that he will not accord Prince Tsola Emiko the respect of a seating Olu of Warri. True to his promise, Chief Emami never did. Even though Ogiame Atuwatse III was very polite and civil to him during the brief perperiodey met and spoke. Ogiame Atuwatse III was said to have asked after the well-being and family members of Chief Emami.

Despite this, Chief Emami never accords the Olu of Warri the respect of his throne. And when, it became clear to all people present at the peace meeting, that Chief Emami was not ready to go back on his words, the peace meeting was abruptly called off and rescheduled for another day.

In the first peace meeting, Prince Yemi Emiko, who is alleged to have skewed everything in favour of Prince Tsola Emiko to become the 21st Olu of Warri, was not present.

In the rescheduled peace meeting that took place on the 23rd of May, 2022, Prince Yemi Emiko was present, when the close associates of Chief Emami were trying to pressure him into withdrawing his cases in courts concerning the Olu of Warri. People at that meeting were shocked and speechless when Prince Yemi Emiko, who is now aggrieved, told Chief Emami never to attempt to withdraw any of his cases in courts. Saying "Your cases and Prince Oyowoli are the only options left for us, to checkmate the present Olu of Warri, Ogiame Atuwatse III, who is apparently getting out of control since he ascended the throne."

Our source explained further, that "the Palace of the Olu of Warri that cost the Itsekiri people a lot of money to build, is gradually decaying and falling apart due to lack of use and maintenance. The roofs in the Palace are presently leaking, especially now that we are in the rainy season. The Warri Palace, unlike when Ogiame Ikonwoli was still alive and resident in the palace, was very well kept, as all the facilities in the palace were well maintained then.

"But now, most of the rooms in the Palace are locked as Ogiame Atuwatse III is not living in the palace and he is not likely in the foreseeable future to move into the palace, he stressed. As his late father, the 19th Olu of Warri, Ogiame Atuwatse II, has so many personal houses and properties all over Warri Kingdom.

"The present Olu of Warri, he added has this personal forbear for the Olu of Warri Palace built

by the Itsekiri people, because his mother, Iya Oba Gladys and him, still harbour this erroneous belief whether true or false, that it was when his father moved into the Warri Palace that he strangely came down with the illness that eventually resulted in his demise."

I am however aware that EFCC has waded into Dr Ayeni's petitions and found nothing to substantiate. In all this, HRM Ogiame Atuwase III and the Warri Palace have nothing to do with all these allegations

The source concluded that the drama in the Olu of Warri palace has intensified in all fronts, as highly respected Chief and member of the Ginuwa I Ruling House, Akoma Dudu-Dimeyin, who at the inception of the crisis that led to the installation of the present Olu of Warri, said the Ginuwa I Ruling House has no such powers to purportedly suspend Chief Ayiri Emami as the Ologbotsere of Warri Kingdom. He was immediately coaxed into appearing before Ogiame Atuwatse III for the revalidation of his Chieftaincy title some time back. As if that was not enough humiliation, he is again presented with some documents to sign which he refused. Chief Akoma's refusal to sign any document has not only unsettled some members of the Olu of Warri palace but has also heightened the tension and anxiety among the Ogiame Atuwatse III inner kitchen cabinet members and some Chiefs, who are members of the Olu of Warri Council of Chiefs.

Troops neutralise 14 terrorists, arrest 15 others

the roops of Nigerian military conjunction in with the Civilian Joint Task Force operating in Borno State, have killed no fewer than 14 terrorists and arrested 15 others.

This was disclosed by the Director of Defence Media Operations, Major General Benard Onyeuko, during a press briefing on the operations of the Armed Forces of Nigeria, Police and other security agencies at Defence Headquarters, Abuja.

During the briefing, which covers operations of the Forces from 19 May - 2 June 2022, Onyeuko stated that troops of Operation Hadin Kai repelled attacks by terrorists at Firm Base Arege in Abadam Local Government Area of Borno State.

He added that during the attacks, troops responded with superior firepower and inflicted heavy casualties on the terrorists while others fled in disarray.

"Troops also neutralized 14 terrorists and arrested 15. Accordingly, all arrested terrorists, rescued families and recovered items have been handed over to the appropriate authorities for further action," he started.

According to him, "troops recovered 10 AK 47 rifles, 5 AK 56 rifles, 2 FN rifles, 227 rounds of 7.62mm ammunition, 7 AK 47 magazines, 1 PKM gun. 1 AA gun, 164 rounds of



Lieutenant General Yahava AA ammunition, 111 Shilka

ammunition, 1 gun truck, 1 shilka barrel, 2 Dane guns, 2 Improvised Explosive Device, 1 car engine, 4 trollies and one water pump machine. Troops also rescued 100 terrorist family members which included 33 women.

Onyeuko also said that the troops on fighting patrol along Ashigashiya, Kodele, Apagaluwa in the and Gwoza Local Government Area of Borno State had earlier encountered terrorist herders who engaged troops in a fierce gun battle. Adding that the terrorists fled due to troops' superior fire power while troops recovered 40

sheep during exploitation. The Major General also said troops of Operation Hadarin Daji sustained aggressive and clearance operations to deny terrorist and other criminal

elements further freedom of action.

He said following credible information about terrorists heading towards Dampo village in Bakura Local Government Area of Zamfara State, troops mobilized and laid in wait at the bandit crossing point on 22 May 2022.

He said this led to a gun battle between the bandits and troops, making the bandits flee in disarray due to the superior firepower of the troops.

According to him, 292 cattle and 1 camel were recovered following the bombardment. Also, on 21 May 2022,

following credible intelligence report, troops arrested a notorious foreigner Jabe Buba a terrorist informant at Garuwa village in Tambuwa Local Government Area of

Sokoto State. Pictures and video of him posting rifles in the forest were found in his phone and cash of One Hundred and Thirty Thousand Naira (N130,000.00) was recovered from him," he added.

Onyeuko added: "Troops recovered 9 AK 47 rifles, 100 rounds of 7.62mm ammunition, 458 rustled cattle and 20 motorcycles. Troops also rescued 152 neutralized civilians, 18 bandits and apprehended 25 bandits. Accordingly, all arrested, rescued civilians and recovered items have been handed over to the appropriate authorities for further action.

More so, the troops of peration Whirl Stroke Operation reportedly conducted several operations within the period under review.

The Media Director stated further: "On 24 May, troops responded to a distress call on kidnapping incident along Zakibia-Ugba Road. Own troops made contact with the criminals. After a gun battle, the leader of the group, one Mr Odada and 2 other members of the kidnappers who were all dressed in uniforms militarv were neutralized.

"The victim, one Mr Chimaobi Omemma, a businessman was rescued. Items recovered include 1 AK 47 rifle, 3 fully loaded magazines (90 rounds of 7.62mm special), 1 Toyota Corolla vehicle and an ATM card bearing Felix Terzenqwe. All recovered items are still in

custody.

He further stated that on 29 May 2022, a distress call was received of a group of bandits terrorizing locals at Bowa in Doma Local Government Area of Nassarawa State.

"After a hot pursuit, one Mr Adamu Akure was captured at Ijiwo junction in Rukubu. Items recovered include 1 locally made pistol and several cartridges amongst others. The arrested criminal is presently under interrogation. Also, a notorious gun runner, Mr Morris Ayitu was arrested after a raid at his residence in Abirisi in Guma Local Government Area. Also arrested are his wife and an accomplice, Mr Julius Aseni," he added.

Also, troops of Operation Octopus Grid, a subsidiary of Operation Delta Safe, operating in the creeks of the Niger Delta, discovered and destroyed 40 illegal refineries, 165 metal storage tanks, 72 ovens, 23 dug out pits, and 5 wooden boats.

recovered "Also, are One Hundred and Seven Thousand Four Hundred (107,400) litres of crude oil, Four Hundred and Fifty-Six Thousand Four Hundred and Fifty (456,450) litres of AGO, Six Thousand Two Hundred and Fifty (6,250) litres of PMS, 6 trucks, 3 outbound engines, and 1 AK 47 rifles. Troops also apprehended 21 criminal elements. All recovered items and apprehended criminals were handed over to the appropriate authorities for further action," Gen Onyeuko concluded.

Explosive device blows up planters

Two suspected members of the proscribed Indigenous People of Biafra (IPOB) have reportedly sustained fatal injuries after being blown up by an Improvised Explosive Device (IED) planted by IPOB and its armed wing, Eastern Security Network (ESN).

А statement bv Brigadier General Onyema Nwachukwu, Director Army Public Relations, said the incident occurred along Eke Ututu - Orlu Road in Orsu Local Government Area of Imo state on 1 June 2022

According to him, IPOB members have planted IEDs along troops' patrol routes on several occasions but the efforts have failed to bring harm to the troops.

"Ăn Improvised Explosive Device (IED) planted by members of the Indigenous People of Biafra (IPOB) and its armed wing, Eastern Security Network (ESN) has exploded, causing severe injuries to two members of the outlawed group. The incident occurred along Eke Ututu - Orlu Road in Orsu Local Government Area of Imo state on 1 June 2022.

"The dissidents, inadvertently stepped on the IED which they had earlier planted along several routes in Orlu, Orsu Local Government Area, while they were attempting to evade troops' onslaught against terrorists in the area.

"The outlawed group have severally planted IEDs along troops' patrol routes in failed effort to bring harm to the troops.

"We urge all peace-loving people of the South East to please inform troops of possible areas where explosives these have been buried for proper evacuation and disposal," he said.



Police to launch short code for free emergency calls, says IGP Pledges adequate security for free, fair 2023 polls Launches POSSAP

Inspector-General (IGP) Usman Alkali Baba has said that the Nigeria Police Force (NPF) shall soon launch a short code for free emergency calls and sharing of vital information between it and the public

IGP Baba disclosed this on Thursday while addressing Police Commanders at the Strategic Police Managers and the official launch of the Police Specialized Services Automation Project (POSSAP) held at the Force Headquarters, Abuja.

According to the IGP, the police have "secured the approval of the National Communications Commission (NCC) for the allocation of a national Police Short Code for free emergency calls and information sharing between the Police and citizens. The acquisition of the short Code which is '933', is a landmark initiative by the Force leadership to bridge the age-long emergency

communication gap between the Police and members of the public."

He added that the short code shall be formally launched soon by the police and shall be accessible by the public.

The Police Chief also stated that the aim of the meeting was to review the internal and re-evaluate security policing strategies in line with evolving new approaches. He assured that appropriate security measures are in place to ensure free, fair and credible polls in 2023.

He said, "We have similarly, strengthened 'Operation Restore Peace', the Special strengthened Anti-Secessionist Operation in the South East with the deployment of more special operational Units and assets of the Force.

"In order to enhance the attainment of our internal security mandate, I am also elated to confirm that we have secured the approval of the National Communications

Commission (NCC) for the allocation of a national Police Short Code for free emergency calls and information sharing between the Police and citizens. The acquisition of the short Code which is '933', is a landmark initiative by the Force leadership to bridge the age-long emergency communication gap between the Police and members of the public. The code will soon be formally launched.

"Furthermore, as part of our police modernization vision, the Force has established an Unmanned Aerial Vehicles (UAVs) Unit within the Department of Operations (Airwing Section) of the Force.

"To aid the take-off of the new Unit, we have procured five (5) Drones and Officers to man the Unit have also been exposed to specialized training in South Africa and certified as Drones Operations

specialists. We are currently leveraging

on the expertise of the NPF-UAV Unit to support special police operations, particularly, for surveillance operations along the Abuja-Kaduna Highway and railway corridor. They were also optimally utilized in the recent Nigeria Police special anti-banditry operation in Sokoto with huge success

"In order to address the welfare concerns of the Force, the Police Insurance Section is being re-positioned for better operational efficiency. In furtherance of this, I have approved the establishment and incorporation of the Nigeria Police Insurance Company (NPIC) to effectively manage the Police insurance policies, and maximize the welfare interests of police personnel who are constantly being exposed to occupational hazards

"Consequent to operational these and administrative initiatives, I am

glad to note that the Nigeria Police's service deliverv and operational efficiency have significantly improved. This is evidenced by the fact that between January 2022 to date, the Nigeria Police have arrested a total of three hundred and twenty-eight (328) Terrorists/Bandits; three hundred and twenty-five (325) Armed Robbery Suspects; three hundred and thirty-nine (339) Kidnapping Offenders and two hundred and fortyseven (247) suspected cultists. "Also, within this period,

we have safely rescued three hundred and seven (307)kidnapped victims and recovered five hundred and ten (510) firearms of various descriptions, and eight thousand, nine hundred and six (8,906) ammunition of various descriptions and calibre including rocket-propelled grenades and and other Improvised Explosive Devices.

Tragic killings across the country

igeria is on the edge of a dangerous precipice occasioned by a surge in tragic and wanton killings in the land. Killing of innocent persons across the country has become the norm rather than the exception. The most recent is that of a pregnant mother Hariri Jubril and her four little children in Anambra State. Two weeks before, Deborah Yakubu was set ablaze by some of her College of Education classmates in Sokoto. These incidents left the nation in shock. 'Shock' is the wrong word. We are no longer "shocked" at the news of killings. We are merely "troubled" or "disturbed" or, worse, "nonchalant". Sadly, we quickly recover from these emotions and carry on with our lives. This may seem trivial. It is not. It is a big tragedy – we are losing our basic humanity or humaneness. And the federal government appears overwhelmed!

How did we descend into such barbarity? How human are we when we shrug our shoulders at the news of a girl being burnt alive by her own classmates? How human are we when we sleep normally at night after seeing a video of a woman and her fiancé having their heads chopped off while still alive? How human are we if we can continue to enjoy our meal after seeing the corpses of a woman and her four little children slain in the street for the crime of being different? How do gloss over the deaths of scores of people in a Boko Haram attack? Is Mr. President able to sleep with so much blood being shed in the land under his watch?

The deaths of fellow Nigerians, our own brothers, and sisters, have become nothing but numbers – 30 people killed here, 12 people killed there. We have lost our humanity, and we are out of touch with what it means to be human. The English poet Matthew Arnold (1822-1888) believed that there was a beast in every one of us that needed to be tamed if society were to attain civilisation. Unfortunately,

the beast in all of us is threatening to take over the souls of Nigerians. The mark of this beast is not 666. It is lack of empathy, sympathy, fellow feeling, and goodwill. Its mark is a totally anaesthetised attitude towards horror and terror. This beast looks upon the death of a fellow human being with indifference. It makes the appropriate "noises" such as "oh no!", "how unfortunate" and, for perhaps a few days, "justice must be served!". Its "duty" done, the beast goes on as usual. This is what we have become. Beasts. This is the tragedy of Nigeria. The killers themselves are unusual – they are the greater beasts. They maim and deface or burn the corpses - an indication that the anger levels are too high.

It is not only the Nigerian citizen who



has become anaesthetised to tragedy. It is the Nigerian system in its entirety. Nigeria has become a failed state. When systems of government fail, the citizens rebel. It leads to anomie, anarchy, and general lawlessness. Our politicians carry on with their campaigns as though Nigerians are not dying daily. In fact they use these deaths to promote themselves, promising to end it all if they are elected. In the meantime they have surrounded themselves with police and armed personnel while ordinary Nigerians sleep with only one eye closed.

The government must rise to its obligations and address the dehumanization of Nigerians and the endless killings. The government should seriously consider allow the establishment of State Police. The federal security forces are overwhelmed and often are not familiar with the terrain to which they are posted. State police would be at home on their turf since they are from the same area. They will be far more efficient at identifying criminals and perpetrators of violence. They would also have the added advantage of familiarity – local people will feel freer with them and would be more forthcoming with information.

The government should call on religious and community leaders to emphasize the sanctity of human life and the importance of peace, unity, brotherhood, and good neighbourliness. The government should involve traditional and religious leaders in forming vigilante groups that would be responsible for fishing out criminals and handing them over to the authorities.

Finally, the judiciary needs to get serious. It must show that it is impartial and will not allow any crime to go unpunished. Extra-judicial killings happen as a consequence of a failed judiciary. In Nigeria justice is given only to the highest bidder. The judiciary needs to restore the faith of Nigerians in the system. The current situation where everybody is a law unto himself has got to end. Nigeria deserves better.

Holy spirit, the father's promise poured upon believers

The study of the Holy Spirit is called pneumatology in theology. Pneuma-tology is derived from Greek. The Holy Spirit is not only a New Testament (NT) occurrence. He manifested in varied forms in the Bible. In the Old Testament (OT), as well as in the NT, it appeared in seven ways. As a dove (Genesis 8:8-12), fire (Exodus 3:2; Isaiah 6:1-13), oil (Exodus 30:17-33; Songs of Solomon 6:1-13), water (Exodus 40:1-33; Psalm 78:1-20), breath (Genesis 2:1-7; Ezekiel 37:-14), wind (Job 37:1-24; Isaiah 40:1-17; Jeremiáh 49:28-39), and rain (Hosea 6:1-11; 1 King 8:22-36; 1 King 18:41-46). He is often called the

silent or shy partner in the Trinity. The Holy Spirit was promised to be poured upon men and women by God through the prophets of old. "Let Israel hope in the Lord; for with the Lord there is mercy, and with Him is plenteous redemption. And He shall redeem Israel from all his iniquities" (Psalm 130:7-8). Nevertheless, believers are asked to 'wait' till the time the Holy Spirit will be poured upon them. "I wait for the Lord, my soul doth wait, and in His word do I hope. My soul waited for the Lord more than they that watch for the morning; I say, more than they that watch for the morning" (Psalm 130:5-8).

This promise was succinctly prophesized by Joel, "And it shall come to pass af-terward, 'that I will pour out my Spirit upon all flesh, and your daughter shall prophesy your old men shall dream dreams, your young men shall see visions" (Joel 2:28). This prophecy was fulfilled on the day of Pentecost (Acts 2); and will be further fulfilled during the tribulation (Acts 2:16-21) and during the Millennium (Isaiah 32:15; 44:3; Ezekiel 36:26-27; 39:29; Zechariah 12:10).

Jesus Christ himself promised his

disciples the Holy Spirit. Unlike all the prophets of old, it was only upon Jesus Christ that the Holy Spirit was poured out or poured upon in full measure, or in fullness (Isaiah 11:1-2; 42:1; 61:1; Matthew 3:16; 12:18; John 3:34). Therefore, all believers who desire the Holy Spirit and its power are entitled to receive it 'unto full measure' as manifested on the day of Pentecost. In the early Church, the acts of the Apostles were due to the empowerment and enablement given to them by the Holy Spirit's power, All this happened at Pentecost; the day the Church was established by Christ Jesus. Pentecost (Greek, Pentecostos means fiftieth) was held on the fiftieth day after the Passover Sabbath. Whit Sunday is the corresponding Christian Festival. Á similar occurrence, the 'rushing of a mighty wind' and the appearance 'unto them tongues parting asunder, like as fire; and it sat on each of them' (Acts 2:2-3), also took place in 1 King 19:11-12.

The Holy Spirit is the power of the Church and the Christian faith. He made 'mission' possible. It was the drive that made the Apostles to witness for Jesus Christ boldly, especially the fact of His life and ministry (i.e. the Gospel) cum His Resurrection. In spite of opposition by the Sadducees and High Priests, in the face of martyrdom, the Apostles remained resolute in discharging the Great Commission entrusted them by Jesus Christ. "But when they did not find them, they dragged Jason and some brethren to the rulers of the city, crying out, "These who have turned the world upside down have come here too" (Acts 17:6). It made it possible to proclaim the universality of the Gospel and establish the 'Catholic and Apostolic Church.' With the Holy Spirit believers can "turn the world upside down" (Acts 17:6) for Jesus Christ.

Importantly, the Holy Spirit made it possible for the Apostles to witness to the growing of the Church and Christianity exponentially. Accordingly, Rev F. Marshall, outlined the results of growth brought about by the Holy Spirit for the Church thus: (i) There were added unto them in that day about three thousand souls" (Acts 2:4); (ii) "And the Lord added to them day by day those that were being saved" (Acts 2:47); (iii) Many of them that heard the word believed; the number of the men came to be above five thousand" (Act 4:4); (iv) "And believers were increasingly added to the Lord, multitudes both of men and women" (Act 5:14); (v) "When the number of the disciples was multiplying ..." (Acts 6:1); (vi) "And the number of the disciples multiplied in Jerusalem exceedingly; a great company of the priests was obedient to the faith" (Acts 6:7).

Consequently, the Holy Spirit brings about an 'increase', 'adding', and 'multiplying'

of disciples and converts in the Church. Believers must therefore 'wait' to receive the 'pouring upon' or baptism of the Holy Spirit. Therefore, take assurance of Jesus Christ's promise to all believers, "Nevertheless, I tell you the truth, it is to your advantage that I go away, for if I go, I will send him to you ... when the Spirit of truth comes, he will guide you into all the truth; for he will not speak of his own authority, but whatever he hears he will speak" (John 16:7-15). Again, Jesus assures that: "And behold, I send the Promise of My Father upon you, but stay (i.e. wait) in the city until you are clothed with power from on high" (Luke 24:49). This promise was fulfilled and recorded in Acts 2:1ff, "When the day of Pentecost had come, they were all together in one place ... And they were all filled with the Holy Spirit and began to speak in other tongues as the Spirit gave them utterance."

The Holy Spirit is still with us. It is still for all who are ready to 'wait' and receive Him. He is the power of all believers and the church of God. John Maxwell rightly notes, "Leaders can never empower anyone else until they are first supernaturally empowered themselves. The term 'filled with the Holy Spirit' is used five times in Acts (2:4; 4:8, 31; 9:17; 13:9). Whenever someone is filled with the Holy Spirit, something happens. Empowered leaders express God's power, then others." Christians are empowered when they receive the promised Holy Spirit through Christ Jesus. Be blessed and Shalom!

Apostle Paul judged the activities of the various Churches that were set up then among the Gentiles and wrote to them based on his judgement according to the Word of God.

Every judgement Apostle Paul delivered on the various Churches was based on the Word of God and not his personal opinions.

Our Lord and Saviour Jesus Christ even clarified His statement in Matthew 7:1 in John 7:24 when He said: "Judge not according to the appearance but judge righteous judgement. Jesus Christ encouraged us to judge one another in love and according to the righteous judgement of the Word of God. Therefore, anybody hiding under the canopy of Matthew 7:1 to say that a brethren cannot point to the wrongdoings of another brethren to help them recover in righteousness is wrong because Jesus Christ said we can pass righteous judgments.

God wants us to be our brother's keeper hence it is not wrong to watch over the shoulder of your fellow humans to bring them back to the right path of righteousness if they have strayed.

God said in the scriptures that "at the hand of every man's brother will I require the life of man"- Genesis 9:5. Therefore, if you don't tell your friends, neighbours and others you meet every day about their wrongs either directly or diplomatically, if they perish in sin, God will hold you partly responsible for their blood. That is why we need to join in spreading the gospel because if you don't join in spreading it and people within your reach are not made to understand the true meaning of the gospel of Christ and perished in their sins, God will partly hold you responsible and you will be punished for it.

If you truly love your neighbour or other humans the way you love yourself as commanded by Christ, why are you not spreading the gospel either directly or even through sharing the word of God online?

Nigeria gets 5th Cardinal appointment of Roman Catholic Church

Cardinal in Latin, Sanctae Romanae Ecclesiae cardinalis, literally "cardinal of the Holy Roman Church", is a Senior Member of the clergy of the Catholic Church, immediately behind the Pope in the order of hierarchy. Collectively, the members constitute the College of Cardinals and are appointed for life.

Their most solem responsibility is to elect a new Pope in a conclave, always from among themselves (with a few historical exceptions), when the Holy See is vacant. During the period between a Pope's death or resignation and the election of his successor, the day-to-day governance of the Holy See is in the hands of the College of Cardinals.

The right to participate in a conclave is limited to cardinals, who have not reached the age of 80 years by the day the vacancy occurs. In addition, cardinals collectively participate in papal consistories (which generally take place annually), in which matters of importance to the Church are considered and new cardinals may be created. Cardinals of working age are also appointed to roles overseeing dicasteries of the Roman Curia, the central administration of the Catholic Church.

With the revision of the Code of Canon Law promulgated in 1917 by Pope Benedict XV, only those who are already Priests or Bishops may be appointed cardinals. Since the time of Pope John XXIII, a Priest who is appointed a cardinal must be consecrated a Bishop, unless he obtains a dispensation.

On Sunday, 29th May 2022, the 59 years Old Catholic Bishop of Ekwulobia, Anambra state, Peter Okpaleke, was appointed a Catholic Cardinal. His appointment was announced by the head of the Catholic Church Worldwide, Pope Francis.

Bishop Okpaleke was one of the 21 new Cardinals from around the world announced by the Pope on that Sunday. With this appointment, Bishop Okpaleke is now the fifth Cardinal from Nigeria to be so appointed by the Catholic Church.

Nigeria has since independence produced five Cardinals in the Catholic Church. The first Catholic Cardinal from Nigeria was Dominic Ignatius Ekandem, who died in 1995 at the age of 78 years. He was followed by Francis Anizoba Arinze, who will soon be 90 years on November 1, 2022. He is an expert on Christian/Muslim dialogue, having spent most of his professional life in Rome, and is now retired.

Anthony Olubunmi Okogie is the third Cardinal from Nigeria and the second alive. He will be 86 years on June 16, 2022. He is retired and was the Archbishop of Lagos Archdiocese for 39 years.

On Óctober 24, 2012, Pope Benedict XVI appointed the then Archbishop of Abuja Archdiocese, John Onaiyekan, who is now 78 years old and five others as Cardinals.

Archbishop Onaiyekan was before Bishop Okapleke was appointed a

Cardinal, the youngest of the Nigerian Catholic Cardinals. He is known for his peace and reconciliation work across the increasingly bitter Christian/Muslim divide.

The unique thing about Bishop Okpaleke's appointment is that he is still young and falls within the age of a working Cardinal. Working Cardinals not only participate actively in a conclave they can be appointed as a Pope if there is a vacancy in the Holy See today. Pope Francis after the announcement of the new appointments at Regina Coeli on Sunday, May 29, 2022, said, "On Saturday, 27th August, I will hold a Consistory for the creation of new Cardinals. Let us pray that they will help me in my mission as Bishop of Rome for the good of all God's people."

The College of Cardinals currently consists of 208 Cardinals out of whom 117 are electors and 91 non-electors. But with the new additions, the number will grow to 299 Cardinals, of whom 131 will be electors.

Of the 21 newly appointed Cardinals, eight are from Europe, six from North America, and four from Central and Latin America.

Cardinal Peter Ebere Okpaleke, who was born on March 1, 1963, is from

Amesi, Aguata Local Government Area of Anambra State, Nigeria.

He had his primary school education at Amesi, and in 1983, he entered the Bigard Memorial Major Seminary in Ikot-Ekpene and Enugu, where he studied philosophy and theology from 1983 to 1992.

He thereafter went to study Canon Law in Rome at the Pontifical University of the Holy Cross.

He was ordained a priest of the Diocese of Awka on August 22, 1990. On the 7th of December, 2012, Pope Benedict XVI appointed Okpaleke Bishop of Ahiara, Nigeria. He was consecrated as a Bishop on May 21, 2013, but there was opposition to his appointment on the basis that he was not from the Mbaise ethnic group. As expected, the Pope insisted that he remains the Bishop and the church will not tolerate such ethnic bigotry.

Tribalism in the Catholic Church

The division amongst the Igbos is so deep that it is now affecting even religion, specifically the Catholic Church, known as the Holy Roman Catholic Church.

In the Catholic Church, the powers to appoint a Bishop are exercised by

Once the Pope exercises this power, it is not subject to any form of debate or negotiation. Once the Pope has spoken, the decision is final. This is the premise of the statement attributed to St. Augustine - Roma locuta est, causa finita est (Rome has spoken, and the case is closed).

To put it in context, the Catholic Church thrives on the principle of 'sensus ecclesiae' which connotes universality. In line with 'sensus ecclesiae', there were times when we had Nigeria's Priests and Bishops who were Irish because the Catholic Church is one and universal. Recall the days of the missionaries in Nigeria and you will realize that those Oyibo Priests were not serving in their local governments or state of origin. Nor in their villages of birth.

Now, pause for a moment and ask why an Igbo Catholic Priest was appointed by the Pope to become a Bishop in an Igbo Catholic Diocese in 2012 and the entire Diocese rejected his appointment and refused to allow him to take canonical possession of a Diocese validly entrusted to his pastoral care by the Supreme Pontiff.

Surprisingly, the reason was that the then Bishop Okpaleke is from Awka Diocese in Anambra State and not from Ahiara Diocese in Imo State.

The rejection was bold, daring and not even pretentious; it was so scathing and embarrassing that his Episcopal ordination was held outside the Diocese he had been appointed to lead. Despite his ordination, he was refused entry into the Diocese and never took charge of Ahiara Diocese even for one day. The Ahiara Diocese made a loud statement and they were clear - they would rather stay without a Bishop rather than have a Priest that is not from Ahiara Presbyterium. They didn't mince words about it and remained defiant.

After a while and in a bid to calm the tension and for peace to reign, Bishop Peter Ebere Okpaleke had to resign his appointment as the Bishop of Ahiara Diocese in February 2018, an office he never really assumed. One can imagine how he survived those difficult moments of his life. He would have relied greatly on the Holy Spirit as epitomized in his episcopal motto - 'Veni Sancte Spiritus' (Come Holy Spirit!).

Regardless, he remained a Bishop, albeit, a Bishop without a Diocese. To reiterate, Bishop Okpaleke was without a Diocese because even as an Igbo man, the Igbo Diocese he was appointed to oversee rejected him because he was not from that particular part of Igbo land. It is also important to emphasize that there is no provision in the Canon law that stipulates that only Priests from a particular Diocese must serve as Bishop of that Diocese.

In March 2020, a new Diocese had to be created in Anambra (Ekwulobia Diocese) and he was appointed as the first Bishop of the newly created Diocese. His Episcopal installation took place on April 29, 2020, and he has been serving in that capacity before his new appointment as Cardinal.

recent report of the Nigeria Inter-Bank Settlement System (NIBSS) has indicated that between January and April 2022, about N117.33 trillion payments were processed through various electronic channels.

This is N35.79 trillion higher than the N81.54 trillion processed in the corresponding period of 2021. Nigeria recorded N27.22 trillion in electronic payments in January 2022, N27.76 trillion in February, N32.52 trillion in March and N29.84 trillion in April 2022, amounting to N117.33^{trillion.}

Hence, reducing transaction charges will likely increase electronic payments and, in turn, reduce exposure to risks such as robbery associated with carrying bulk cash and lowers the frequency of printing new currency notes to replace damaged ones.

ECOWAS commits to common stance on AfCFTA position, policy protocol

Economic Community of West African States (ECOWAS) has expressed commitment to a common regional position on the African Continental Free Trade Area (AfCFTA) on competition policy among member states.

The ECOWAS Commission, ECOWAS Regional Competition Authority (ERCA) organised the first virtual regional meeting on the AfCFTA draft protocol on the competition policy with ECOWAS member states on Friday, May 27, 2022 to adopt common positions, consistent with regional and national competition framework in West Africa.

A statement issued by the APO Group and made available to The

Trumpet on behalf of ECOWAS, revealed that opening remarks were made by Executive Director of ERCA, Dr. Simeon Koffi, Acting Director of Trade, ECOWAS Commission, Kolawole Sofola and an official of Ghana's Ministry of Trade and Industry, Michael Opoku, who chaired the meeting.

As part of the second phase of negotiations on the AfCFTA, a draft protocol on competition policy was proposed by the AfCFA Secretariat. The meeting considered offers from ERCA and four competitions with experts from the ECOWAS Region and members of ERCA's consultative competition committee.

Following deliberations at the meeting, they adopted the amendments, which will form the basis for regional position on key provisions of the draft protocol to be presented at the upcoming fifth meeting of the committee on the competition policy, which will end on June 7, 2022 in Accra, Ghana.

The protocol on the competition policy, being an integral part of the agreement of the AfCFTA, would contribute to the attainment of AfCFTA's objectives, leading to industrial and agricultural development and enhanced competitiveness.

After a meeting in April 2021, it was agreed that addressing the divergent positions of the parties required prior coordination of positions within the regional entities, such as the Regional Economic Communities (RECs).

Service, Hajiya Salamatu Abubakar, who commended the ITF for the collaboration with the state government to develop the capacities of the civil servants, assured the civil servants that her office would ensure the sustainability of the partnership to enable the civil servants to compete globally.

Earlier in his welcome address, Permanent Secretary, Human Resources Development, Niger State Head of Service, Mallam Isah Ibrahim, said the MoU was aimed at developing the capacities of the state workforce across all cadres.

Ajayi-Kadir, therefore, charged

the apex bank to reconsider its stance regarding the fiscal and monetary policy measures and reforms that have negatively

impacted the manufacturing sector.

He said in response to the domestic economic conditions in the first quarter (Q1) of 2022 and other challenges, especially those associated with the prevailing international financial and economic environment, the Monetary Policy Committee (MPC) recently reviewed its previous decisions by deepening the MPC.

He disclosed that the MPC reviewed its previous decisions by increasing the Monetary Policy Rate (MPR) to 13.5 per cent from 11.5 per cent, which was fixed since September 2020. He argued that although

the rationale for increasing the MPR stems from the need to curb the rising rate of inflation that recently peaked at 16.8 per cent, the CBN should ensure relative stability and sustain economic growth in the face of uncertainties in the global economy.

'The implication of CBN's actions for the economy and manufacturing sector will lead to another level of increase in interest rates on loan-able funds,

which will enhance the intensity of the crowding effect on private sector businesses, as firms have lesser access to funds in the credit market.

"It will spur an upward review of existing lending rates dependent on obligations of manufacturing concerns, which will increase costs. It will intensify demand crunch emanating from the heavily eroded disposable income of Nigerians, as well as constrained access of households and individuals

to cheap funds."

Ajayi-Kadir added that the CBN action will exacerbate the intensity of idle capital assets, worsen the already declining profit margin of private busi-nesses and heighten the mortality rate of small businesses.

'It will also further reduce capacity utilisation, increase unemployment, crime and insecurity, as banks' capacity to support production and economic growth has been constrained. This will restrict the pace of full recovery of the real sector, make manufacturing performance remain lackluster and lead to learner contribution to the Gross Domestic Product (GDP)," he added.

He stressed that the increase in MPR has widened the journey further away from the preferred single-digit interest rate regime is not friendly considering the myriad of binding constraints as already limiting the performance of the sector.

He added that MAN was concerned about the ripple effects of CBN's decision and its implications for the manufacturing sector, which is finding it difficult to survive.

Experts warn farmers against wrong use of agrochemicals

Some agriculture experts have called for increased awareness and advocacy against the wrong use of agrochemicals.

The experts, who made the call in Lagos, said the misuse of agrochemicals by local farm-ers have resulted in negative implications on the environment and human health.

Principal extension specialist at the National Agricultural Extension and Research Liaison Services (NAERLS), Dr. Fadlullar Issa, said it was expedient to raise the awareness level of the farmers on the dangers of inappropriate use of agrochemicals.

'To sensitise farmers against wrong use of agrochemicals, we must embark on a sustained awareness campaign. This is necessary because we have a dearth of extension service agents in Nigeria. "The sensitisation is necessary

and should be the sole job of extension service workers. In some states, the ratio of one extension officer to farmers is one to 6,000. Essentially, they cannot cover that number, hence the need for the media to join in the advocacy campaign against wrong application of agrochemicals.

He also expressed concern that the misuse of agrochemicals was a major challenge in the Nigerian agricultural sector and that there were consequences for not adopting the recommended practice of the substances.

"When we overuse or underuse agrochemicals in crop cultivation, it has negative implications on human health. The misuse of agrochemicals also has consequences on the environment. This has been scientifically proven to cause skin irritation, eye problems, breathing difficulty and even death.

"Some people have gotten some permanent ailments because of this agrochemical misuse in

crop cultivation," he added. On his part, Dr. Tunde Babalola, an agriculture expert, who said sensitisation of the farmers should not be left in the hands of government alone, restated the need to intensify the campaign against the misapplication of agrochemicals through private and government partnership.

The government has an ongoing programme, which is extension services to educate local farmers on appropriate application of agrochemicals in crop farming. Agricultural extension needs to intensify its reach to farmers to curb the inappropriate use of agrochemicals. Our local farmers need more orientation on the negative implication of agrochemicals abuse on human health and the environment.

"The government needs to find extension services more for local farmers to be kept abreast of the dangers of agrochemical abuse. As such, a media approach to reach the farmers should also be embarked upon to prevent misuse of fertilisers and herbicides," he stressed.

Babalola also pointed out that media advocacy on the dangers of the wrong use of the agrochemicals should be prioritised, maintaining that just as there were media campaigns and advocacy against poliomyelitis, HIV/AIDS and the COVID-19 pandemic, there should be serious awareness and campaign against wrong use of agrochemicals.

"Some of the advocacy programmes are most times sponsored by non-governmental agencies, individuals and stakeholders and so, such should be replicated in the fight against misuse of agrochemicals.

"These can be spread faster than what the government is doing to sensitise the farmers through its extension services. We can also advocate responsible use of fertilisers and other agrochemicals for young farmers through social media advocacy,' he stated.

'Investment in FGN securities profitable, risk-free'

ebt Management Office (DMO) says it is advisable for Nigerians to invest in the various federal government securities, as they are profitable and risk free.

Director-General of DMO, Patience Oniha, said this virtually, saying apart from raising funds to finance government projects, the various Federal Government of Nigeria's (FGN) securities also offered attractive investment opportunities for Nigerians.

Oniha maintained that the Federal Government issues the bonds through the DMO and make periodic interest payments to the investors, while the principal is paid at the end of each tenor.

She also explained that the Federal Government has various investment platforms like the FGN Bond, FGN savings Bond, Treasury Bills, the Green Bond, the Sobering SUKUK and Eurobond, among others.

"One function of the FGN securities is to raise capital to finance budget deficits and also to raise funds to execute critical infrastructure projects. They are backed by full faith and credit of the Federal Government of Nigeria and default risk-free," she stressed.

She further stated that the FGN securities also contribute to the development of the domestic capital market, adding that they serve as benchmark for other private institutions to issue their securities.

"They enhance the savings and investment opportunities of the populace thereby promoting financial inclusion. They also attract foreign investors into the domestic financial market to refinance maturing domestic debts and diversify sources of funding for the Federal Government.

Strong indications emerged increased the stake to 93.4 per cent, even as it failed to mention this fact in a statement it issued during the week.

A document sighted by The Trumpet further revealed that a name change could follow and "with the completion of the transaction, TGI Group, parent company of TTB, will now becomes the majority shareholder and core investor in Union Bank.'

However, the ownership transfer excluded Union Bank UK, a subsidiary of Union Bank of Nigeria, which also has been sold, with the proceeds of divestment to all the shareholders as of March 4, 2022.

It was also learnt that in the spirit of the change of ownership, most members of Union Bank's board and some top executives have exited the bank.

Be more professional, Women estate surveyors urged

omen estate surveyors have been asked to be wary of professional misconduct, technicalities of establishing partnerships and develop expertise in proposal writing. This is in a bid to become more relevant in the profession.

The call was made at a lecture series and interactive sessions entitled, 'Beneath the Glamour, Operating a Successful Practice' organised by the Women Wing of the Nigerian Institution of Estate Surveyors and Valuers (NIESV), Lagos branch.

The forum brought together women practitioners across the state including the chairman of Lagos branch of the institution, Mrs Olabisi Demola-Alade and a past president of NIESV, Mr Bolarinwa Patunola-Ajayi.

In her presentation on estate surveyors and valuers and professional ethics, the Partner, Mark Odu & Company, Bridget Oranye, said women practitioners must be observant of the general ethics that cover the way they should act while conducting the business of estate surveying and valuation.

She stressed the need for women to imbibe the virtue of honesty and devotion to the institution in professional practice.

"You are expected to be honest, trustworthy, loyal, respectful, adhere to the law of the land, avoid harm to others and be accountable. All these are embedded in our code of conduct from the registration board of the institution," she said.

Oranye, who is also the NIESV National Women Coordinator, charged practitioners to familiarise themselves with the Act, which sets up the institution, the green book and the constitution to avert professional pitfalls.

The Partner, Estate Links/ Gbenga Olaniyan & Associates, Mrs Adejumoke Akure, who spoke on the technicalities of partnership, explained that it was important for practitioners going into partnership to define the reason for it and ensure complementary of strengths rather than excluding men in the business partnership.

Akure said there was need for Strengths, Weaknesses, Opportunities and Threats (SWOT) analysis, which is a strategic planning and management technique to help identify threats related to business

competition or project planning. A lecturer in the Department of Estate Management and Valuation, Lagos State

University of Science and Technology, lkorodu, Mrs Olubunmi Adeowo, stated that there are things that are

very essential, especially for solicited briefs when writing briefs on property management and valuation.

Speaking on acceptable briefs and proposals, she noted that some of these are the open statement, description of the objective of the valuation report, the targeted audience and budgeting for the particular job, ability to adapt as well as description of the success rate.

The coordinator, NIESV women wing, Lagos branch, Mrs Olufowobi Olawunmi, said: "There is a need to organise more programmes that will enlighten female surveyors so that they can excel in the profession."

Olufowobi disclosed plans to bring more women estate practitioners into the association to train and educate them.

She stated that every practitioner that studied estate management can excel and supersede the performance of her male counterpart.

On her part, the Director of Estate, Lagos State Ministry of Housing, Mrs Olayinka Patunola-Ajayi, who moderated the sessions observed that for most successful women in the business, what the society sees is the glamour and not the roughness that they must have experienced.

The Ikoyi 21-Storey Building Collapse, what has changed?

In the Lagos State real estate market, Ikoyi quickly comes to mind as the apex of Nigerian residential real estate. Dotting the skyline and landscape are Luxury developments, the prices of which constitute the highest entry point to any real estate market in Nigeria.

It was indeed a sad surprise that a 21-storey block of residential apartments, Gerard Road, Ikoyi, Lagos, the third in a set of three, collapsed on the 1st of November, 2021. The construction, which was targeted to finish in 2022, was materials would have become already at 80% completion more expensive as the project and priced between \$1.2M and \$5M per unit. It was 65% sold out. According to authorities, the project was not insured as required by the Lagos State Physical Planning Permit Authority (LAPPPA) meaning that compensation for the victims and subscribers will be a very difficult task.

According to reports, a lack of concrete cube test results for each stage of construction been ordered by the authori-

meant that Prowess Engineering, the engineering firm initially involved in the project could no longer guarantee the building's integrity and subsequently pulled out of the project. Again, the original approvals for the structure were originally for 8 floors. This would later be changed to 15 and finally, 21 throwing caution to the wind and the initial calculations supporting the structural integrity of the building out of the window.

The steep decline in the currency's exchange value also meant that building progressed and it's nothing to be unexpected in the Nigerian construction industry. The unanswered question, therefore, remains – what compromises were made that led to the devastating collapse?

Since the collapse last year, the demolition of the other two high-rise buildings adjacent to the collapsed 21-story skyscraper has not ties. While there have been other building collapses in Nigeria over the years, one in an exclusive neighbourhood as Ikoyi, which would normally be home to the highest-end buildings, should represent a turning point in the sector. Outcomes expected immediately by experts were:

Changes in (1)demand in the local real estate market. Location, price, and finish have traditionally trumped quality and even size in real estate demand. With the collapse, a shift in demand for quality was expected. However, due to economic realities, low-grade real estate items continue to be in high demand.

(2) Changes in supply in the local real estate market. The collapse raised questions about both new and existing real estate assets. In the short term, structural integrity tests were supposed to become commonplace and structural integrity given more emphasis in general. The winners will be the construction businesses and developers already known for high quality, who will be able to charge more for the quality assurance they provide.

(3) A variant of this case for stricter regulatory compliance will be self-imposed enforcement by construction and real estate professionals. This is what may foster longer lasting change.

On the part of the government, major changes in the regulation of construction and real estate industry which could play out in stricter regulations enforced for property development for a short period - and then business continues as usual in the long run were expected.

Also, a review of practice qualifications for construction and real estate professionals by the various regulatory associations with stricter regulation and enforcement was expected immediately but about 7 months later, everyone seems to be silent and everything continues as usual.

population according to a population projection of 200million people will be having general elections in 2023 with the effects of the pandemic, being a huge stumbling block to economic growth, leading to the Third Quarter (Q3) foreign trade balance recording approximately negative N3Trn. The present administration is also plagued by weakening non-oil revenues due to insecurity and inflation despite the fact that there was a slight recovery by the Fourth Quarter (Q4) of 2021.

To cushion the effects of all these, the government took to raise record sums in the bond market – N2.6Trn by some estimates. Despite the President signing the Petroleum Industry Bill in a bid to improve energy governance, the perception of corruption remains a major source of concern.

The usual grand announcements of government led expenditures on social projects are expected in 2022 as the authorities rediscover the sensitivities of the average citizen. Millennials and Generation Z now influence spending over

Interestingly, the city of Lokoja in Kogi state ranks fourth on the list with a projected 5.93% growth by the end of 2025.

Recently, the Edo state government signed up the Persianas Group, developers of the Palms Grade A mall in Lagos to develop a retail centre in Benin city and made significant progress with the German government on the return of 7,000 artefacts taken from the Benin Kingdom. Luxury lifestyle brand - Montblanc opened its first standalone boutique in Nigeria.

The prices for land and residential apartments in Nigeria's leading cities which include, Kano, Lagos, Abuja, Lokoja, Port-Harcourt etc have moved up drastically. Secondtier cities have not been too far behind with developers launching small sized gated communities. Warehousing has now become even more critical to the functioning of the economy of Nigeria. Also, flexible terms and smaller space requirements have come to characterise the high grade office market.

Recently, a private equity firm, Development Partners International (DPI), focused on Africa, sold a portion of its stake in fast food chain, Food Concepts - the parent company of Chicken Republic, for an undisclosed amount. The Federal Executive Council approved \$17.47Bn for the purchase of office block Kanti Towers, Victoria Island, Lagos by the Nigeria Maritime Administration and Safety Agency as its new headquarters. Also, Equinix a digital infrastructure company announced its intention to acquire Nigeria's data centre and connectivity giant, MainOne for the sum of \$320million. In another development, Ketron Investments bought out retailers - Shoprite and Purple raised a N5bn Sukuk Bonds Issue, achieving 100% subscription. Local investors across residential, retail, and healthcare have demonstrated a growing and strong confidence in the real estate market in Nigeria.

The migration to e-commerce and remote working is expected to last long after the pandemic has passed, altering the frequency and use of workplaces while enabling digital shopping and growing the digital economy of Nigeria. It is however expected that the demand for warehouses, distribution centres, and other properties that allow eCommerce growth will continue to rise. In places where white-collar occupations are on a steady increase, there is also an upsurge in the demand for office space and living spaces.

Mompha for plea bargain with EFCC over alleged N6b fraud

special offences court sitting in Ikeja, Lagos State has adjourned the money laundering trial of internet celebrity, Ismaila Mustapha, popularly known as Mompha to June 10 for plea bargain agreement with the Economic and Financial Crimes Commission (EFCC)

At the said date, it is expected that both the EFCC and Mompha would have reached a final agreement in the proposed plea bargain over alleged N6billion money laundering charge against the suspect.

A statement by the EFCC said Justice Mojisola Dada on Thursday fixed the date in anticipation of the final agreement between the prosecution and the defence team of both parties.

At the proceeding on Thursday, Kolawole Salami who held brief for Gboyega Oyewole (SAN) informed the court that discussions were ongoing on plea bargain with EFCC. The counsel prayed the court for extension

of time for both parties to reach a conclusion. He added that a meeting was held at prosecution's office at 4:00 p.m. to discuss the terms of the proposal.

EFCC counsel, Mr S.I. Suleiman, confirmed the position of the defence counsel and also prayed for an adjournment.

Justice Dada gave the date after defence and prosecution counsels prayed for extension of time. It would be recalled that Mompha and his company, Ismalob Global Investment Limited was arrested on January 10, 2022 by EFCC, and subsequently arraigned him on a 8-count charge bordering on the offences of conspiracy and money laundering to the tune of over N6billion, along with his company.

The counts include conspiracy to launder money obtained through unlawful activities, and laundering of money obtained through unlawful activities.

He was also charged for retention of proceeds of criminal conduct, use of property derived from unlawful act, possession of document containing false pretenses and failure to disclose assets.

Independent Corrupt Practices and Other Related Offences Commission (ICPC) has said that the Anti-Corruption and Transparency Unit (ACTU) requires management buy-ins to guarantee the enabling environment for it to function effectively.

Chairman of the agency, Professor Bolaji Owasanoye, SAN, who spoke recently at the inauguration of ACTU of National Iron Ore Mining Company (NIOMCO) Limited, Itakpe, Kogi State, held recently by the Kogi State office of the Commission, said without the support of management, ACTUs would not succeed in curbing corruption in Ministries, Departments and Agencies (MDAs) of government.

The Chairman, who was represented by the Commission's Resident Anti-Corruption Commissioner in Kogi State Office, Mr Ulu Okoro James, appreciated the Chief Executive of the Mining Company, principal officers, members of the ACTU and staff of the company for receiving the ICPC team and making the inauguration/induction possible.

While speaking on the establishment of

ACTU, Owasanoye said, "Anti-Corruption and Transparency Unit (ACTU) derives its power from sections 71 and 70 of the Corrupt Practices and Other Related Offences Act 2000, where the Chairman of the Commission is vested with the power to issue administrative orders to be called 'Standing Orders."

He further explained that the ACTU is an initiative of the ICPC approved by the Federal Government since October 2001 to serve as an in-house check mechanism for corruption prevention in MDA's.

Earlier in his remarks, Mr Augustus Nkechika, Sole Administrator/Chief Executive, NIOMCO welcomed the Resident Anti-Corruption Commissioner of ICPC, Kogi State, and his team to the Company, and to the inauguration.

He assured the ICPC's Resident Anti-Corruption Commissioner of full cooperation in carrying out its mandate on prohibition and prevention of corruption in his organization.

He also assured the chairman of ICPC that the unit (ACTU) will succeed in its assignment. He wished the commissioner and his team journey mercies on their way back to their destination. Mr Dennis N. Okoro administered the oath of office to the new members of ACTU.

INTERPOL grants EFCC direct access to 114m criminal records

Chairman of the Economic and Financial Crimes Commission (EFCC), Abdulrasheed Bawa, has, in Lyon, France, signed a Memorandum of Understanding with the Interpol National Central Bureau for Nigeria.

According to the Commission, the agreement on Direct Access to and Use of Interpol Information Systems, grants the EFCC unrestricted access to nine key global databases containing 114 million records of 195 countries, hosted by the Interpol on its i24/7 secure global records and communication system.

"Access to the Interpol databases is a significant boost to the EFCC as it enhances the Commission's operational capabilities by giving it an unparalleled global reach against suspected criminals and wanted persons attempting to flee from the long arm of the law," Uwujaren started.

According to him, "with the global criminal databases the EFCC now has unhindered access to, include: Nominal Database containing records of personal data and the criminal history of people subject to request for international police cooperation; Stolen and Lost Travel and Identity Documents (SLTD) Database containing information on travel and identity documents reported as stolen, lost revoked, invalid or stolen blank; and Travel Documents Associated with Notices (TDOWN) Databases, containing records of all extracted information from all Interpol Notices."

He listed other area of access to include. "Stolen Administrative Documents (SAD) Database, which has records of stolen official documents that serve to identify objects, for example, vehicle registration documents and clearance certificates for import/export; Digital Interpol Alert Library Doc (Dial Doc) containing records of newly detected forms of travel documents counterfeiting; Edison, a Forensic database that contains genuine travel documents; and Fingerprints Database grants authorized users in member countries access to view, submit and cross-check records in the fingerprints database via a user-friendly automatic fingerprint identification system (AFIS)."

Others include, "iARMS contains over a million records of lost, stolen, trafficked or smuggled firearms. iARMS can identify firearms trafficking patterns and smuggling routes and Stolen Motor Vehicles (SMV) Database contains extensive identification details from all types of motor vehicles and identifiable spare parts reported as stolen," the Commission said.

EFCC nabs 131 suspected cyber fraudsters in Ibadan, P'Harcourt

Operatives of the Ibadan Zonal Command of the EFCC on Wednesday arrested thirty-nine (39) suspected internet fraudsters in a sting operation carried out in Ibadan, Oyo State.

The suspects who claimed to be undergraduates of different tertiary institutions in Ibadan were arrested at Apete area of the Oyo State capital, following useful intelligence on their cyber-fraudulent activities.

A statement on Friday by EFCC spokesperson, Wilson Uwujaren, stated however, that following analyses carried out on the devices of the suspects, incriminating documents, and messages of their fraudulent bank transactions were recovered from thirty-four (34).

According to him, the names of the suspects are, "Okeowo Abiodun Akeem, Yekini Ismail Omokayode, Odediran Abdulfatahi Dolapo, Isiaka Olumide Hammed, Obioma Honour Umaduabuchi, Olorunsola Eniola Johnson, Olabiyi Ifeoluwa Joseph, Razaq Adams Lekan, Oladimeji Abdulrahmon Olamide, Oyelaran Olayiwoola Jeremiah, Patrick Simon, Adefowora Omotayo David, Adediran Qudus Wale, Onipede Damilola Zacheaus, Ajayi Ifedolapo Oluwatofunmi, Oluwole Ayomide Oluwasegun, Usman Mubarak Oluwadamilare, Dapo-Ajayi Temitope Faith, Diyaolu Olamide Samuel, Ugbama Daniel Efemena, and Ayoade Taofeek Adekunle."

He said five exotic cars, mobile phones, laptops are among the items recovered from the suspects.

In a similar operation, the Port Harcourt Zonal Command of the EFCC has arrested 92 suspected internet fraudsters in a sting operation in the early hours of Wednesday, June 1, 2022, in Rivers State.

Uwujaren said the suspects were arrested for alleged internet fraud activities at locations including Choba and Ada George axis of Port Harcourt, Rivers State, following an intelligence report.

He said, "Analyses of the devices recovered from the suspects established that 64 of the suspects have incriminating items in their phones and emails.



Questions like this drive my passion for my dear continent. "Shoulder high, too tall," "War never end," "Diversified Unity," "Chained," and "Identify Crisis," "Whispers of

"Identify Crisis," "Whispers of Rainbow," are inspiring whatever we in your work, what inspired them? First of all I am a patriotic African man and I should naturally be passionate about my fatherland. Additionally I believe we are too blessed with both human and natural resources to be where we are currently.

Talking about Africa, where do you think we got it wrong?

Getting it wrong at the beginning wasn't our fault we were deceived and made to suffer. We suffered from colonialization for over 200 hundred years and we still haven't recovered from that horror that happened to our ancestors, which I believe laid, the foundation for our suffering. Numerous generations without transitioning to our own values and system of education, we were made to adopt an alien system which up till today we still don't know how to go about it. Such alien value includes the government we currently practice. Decades after independence from our colonial masters we African still continue to put ourselves in arms way by not choosing and backing the wrong leaders when time comes for us to choose one.

Are you saying proper development is still far from this continent?

It's obvious that Africa is underdeveloped, from our infrastructures to our system of education, to our educational system and in fact all sectors. To say we are far from development would be rather too harsh; we just need to start taking the right steps, making right decisions putting the right people with good and innovative mindset in power

How can we have that desired social change in our continent?

Politics and government have power and control over everything if we get the right people in power and be good people ourselves I believe we will be on the right path to the social change we desire. Young people with bright ideas, technocrats needs to get involved in government

You wrote the poems like someone that has traversed Africa. How many African countries have you been to or read about and what are your observations?

Well as a travel curator, I have visited a couple of African countries and I realized that we are all almost suffering from the effects of two things; effects of colonialization and bad governance as well as separatist and inter-tribal conflicts with countries that are heterogeneous. We need to stop fighting ourselves and get together as one to fight the common enemy we all have.

Do you think Africans in the Diaspora have a role to play, if yes, can you be specific?

Yes! Yes, I believe Africans in the Diaspora need to come to effect the new innovations they are living in and continue to create wealth in their motherland if they can.

It seems you believe so much in Africa and its endowment. How close are you to African culture?

Close enough to know we have a rich culture. I am a Yoruba from Ekiti State, blessed with rich tradition; I have been close to other traditions too across Yorubaland and beyond. I have been a witness of the annual Calabar festivals, which I was actively involved, the Olojo festivals at Ile Ife and numerous others.

What is the problem with the black or do you see the colour as a blessing?

The colour of our skin doesn't make us any less it's in fact a blessing to us. It makes us stronger, we have a strong skin and it makes us healthy infact.

How would you describe African leaders?

I want to be kind with words but I can't help it. They are very clueless and selfish people who don't have the interest of their people at heart.

A lot of them are after their own pocket and personal gains. They do not want to leave the corridor of powers.

What kind of African or Nigerian songs inspire you?

Both the new bees and oldies serve as a source of inspiration to me, but I want to say that Fela's songs stands out as they mostly align with my own ideas

You didn't do a poem on polygamy. Iis polygamy a kind of positive or negative part of African culture?

Polygamy is both a curse and a blessing. The main reason why our ancestors were polygamists was because of their farm work. But in present day, it has been abused that we Africans now give birth to numerous children we can't cater for thereby increasing crime rate, overpopulation and high rate of unemployment. A huge number can be a blessing, I know if we get things right that gives us advantage of a large population.

Would you recommend that Africans should go back to the era of traditional

government or continue with democracy that was imported into the continent? Our traditional government has been bastardized. There are so many discrepancies in our traditional institutions. If we can modernize it and practice a constitutional system of government with respect to tradition it will do us more good than democracy that we do not seem to know how to go about.

Have you been to Ile Ife in Osun State and Oyo Town in Oyo State. If yes, what can you say about them?

The historical town that houses the origin and most important traditional institutions of the Yoruba people is Ile Ife, orisun Yoruba.

The monarch Ooni, is the son of the founder of the Yoruba people, Oduduwa. Ile Ife and Oyo are the two indigenous towns that are blessed with great traditions and culture. The cultural festival, traditional museum and houses are second to none throughout the region. They are the two great and historical settlements of the Yoruba people.

How would you like to be remembered? I want to be remembered as a man that impacted many lives positively.

Are you considering doing a movie on Africa?

If it is a movie that will tell our own side of the story and one that will project my ideas why not? I will gladly be willing to be part of one.

'April Showers' on Amazon, inspiration to shoot another movie soon, says producer Sandra Bremaud



'uan Mata eight years spell at Manchester United has come to an end after the player appreciated the fans for all their support with Erik ten Hag unwilling to include him in his plans for next season.

The attacking midfielder was signed for €43.75m by David Moyes from Chelsea in the 2014 winter transfer window and won the FA Cup and Europa league with Guus Hiddink and Jose Mourinho respectively.

The 34-year-old Spanish international who also won the League Cup under Mourinho, made a total of 285 appearances while he netted 51 for the Red Devils.

Mata, after switching to Manchester United in the second phase of the English top-flight division to bolster David Moyes's campaign for a Premier League triumph, featured 15 times while netting six goals in the 2013-14 season.

The versatile attacking midfielder, who can also play from the wings, became a prominent figure in the Manchester United squad the following season and the one after, making 33 and 38 Premier League appearances respectively.

Several coaches, permanent or interim, that took turns to manage the squad after David Moyes' sack on April 22, 2014, made Mata part of their integral plans until German Ralf Rangnick replaced Ole Gunnar Solskjaer to manage the club in the interim.

With Rangnick as the boss, Mata's inclusion into the United starting lineup declined and this resulted in the player featuring in a pantry number of 7 times in the entire Premier League season without a goal.

However, with the signing of Ajax coach to revive the Manchester United squad back to glory, Erik ten Hag seems not to be interested in the Spanish player whose contract with Paul Pogba's come to an end this June and this has instigated the player to bid the club a farewell to

igeria and Spain have signed a Memorandum of Understanding (MoU) to strengthen the bilateral relations between both countries in sports development and other key areas.

This development is one of the benefits of the visit by President Muhammadu Buhari to his Spanish counterpart, President Pedro Sanchez.

According to the report by the Nigeria Sports Ministry, the Minister of Youth and Sports Development, Sunday Dare on behalf of the Federal Government, signed the MoU alongside his Spanish counterpart Miquel Octavi Iceta I Llorens on Wednesday in Madrid.

The Ministry noted that "the agreement aims to initiate and build collaboration in the area of Sports



as well as strengthen the bilateral exchange between both countries based on reciprocity according to their competencies and mutual benefits in the field of sports."

"Some of the specific areas of cooperation include the following among others;

Building, development and management of sports relations and institutions, exchange of knowledge in the areas of sports science, technology, medicine and the fight against doping. "Sports sponsorship, patronage and organizing of sports events, initiating programmes to support and promote sports for special athletes, protection of young athletes and sportswomen.

"Provision of sports facilities and training centres, organization of friendly and major International competitions among the national teams and clubs of both countries in different sports and the arrangement of joint training sessions were also listed among the areas of cooperation.

"The application and execution of the terms of the agreement are expected to begin immediately and will be automatically renewed on an annual basis," the Ministry stated.

The Trumpet reports that other areas of the agreement that help to strengthen the bilateral relations between the African and European countries are economy and trade, health, tourism, science and technology.
