Will the knives that have been out for the knife fights be sheathed amid President Muhammadu Muhammadu Buhari's silence on his anointed successor despite his call for deeper consultations among governors and other chieftains of the party?

Well, some say Northern governors' nod for a southern condidate's emergence has

candidate's emergence has whittled down the chances of Senate President Ahmad Lawan who at the weekend was said to be strongly in contention for Buhari's greenlight with former Transport minister Chibuike Rotimi Amaechi as his running mate or vice versa or Dr. Ogbonnaya Onu as dark

Surely, APC has a date with history as it goes into a Special National Convention to elect its presidential candidate for the 2023 election.

The party had managed to survive some political and legal undercurrents to reach

this mileage.

A total of 23 aspirants were shortlisted for screening by the party out of the 28 that bought the N100m expression of interest and nomination forms. But after a two-day screening, the John Odigie-Oyegun-led screening committee announced that 13 aspirants scaled the hurdle and were cleared to contest the shadow election while 10

failed.

Declining to mention names of those uncleared gave room to speculation and further heightened the already charged political turf as different names surfaced in the social media.

A clarification was later A clarification was rater made indicating that aspirants cleared were Vice President Yemi Osinbajo, Bola Tinubu, Chibuike Rotimi Amaechi Ahmad Lawan Yahaya Bello, Kayode Fayemi , Emeka Nwajiuba Ogbonnaya Onu Ibikunle Amosun David Amosun David Abubakar Badaru Umahi, Godswill Akpabio and Tein Jack-Rich.

that revealed those Tunde disqualified were Bakare, Rochas Okorocha, Ben Ayade, Sani Yerima Ken Nnamani, keobasi Mokelu Deimeji Bankole, Felix Nicholas, Ajayi Borrofice and Uju Ken-Ohanenye.

One of the 13 contenders preferred by President uhammadu Buhari to succeed him. But he is keeping the new teachers keeping the name closer to chest thereby allowing speculations to grow among party members and Nigerians generally.

The president had at a meeting with APC governors and other stakeholders last Monday and requested that he should be allowed to pick his successor as a sign of

Some dead bodies were seen soaked with blood in the church in a video that has gone viral on social media.

Reacting to the ugly incident, President Muhammadu Buhari said Nigeria will defeat evil and wicked people. He condoled with the families, the Catholic Church, and the Government of Ondo State, while mourning the dead victims

In a statement signed by his Special Adviser on Media and Publicity, Femi Adesina, on Sunday, Buhari ordered emergency agencies to swing into action, and bring succour to those wounded to avoid further casualties.

President, condemned the heinous killing, said only fiends from the nether region could have conceived and carried out such dastardly act, adding that eternal sorrow awaits them both on earth here, and

ultimately in the hereafter.

"No matter what, this country shall never give in to evil and wicked people, and darkness will never overcome light. Nigeria will eventually win," the President said.

Meanwhile, the Governor One State, Arakunrin Akeredolu has owed to hunt down the killers and ensure they are brought to book.

Akeredolu, who visited the scene of the incident to get first hand assessment, described the attack as a satanic assault on the peace-loving Ondo people.

In a statement signed by his Chief Press Secretary, Richard Olatunde, the governor condemned the attack while condoling with the family of the victims.

He said, "It is a black Sunday in Owo. Our hearts are heavy. Our peace and tranquility have been attacked by the enemies of the people. This is a personal loss, an attack on our dear state.

'I have spoken to the Bishop of the Catholic Diocese of Ondo, Most Reverend Jude Arogundade, who is presently on his way to Owo. Similarly, I have had to cut short my party's national assignment in Abuja and visit Owo immediately.

"This is an unexpected development. I am shocked to

say the least. Nevertheless, We shall commit every available resource to hunt down these assailants and make them pay. We shall never bow to the machinations of heartless elements in our resolves to rid our state of criminals.

"I commiserate with my people in Owo, particularly families of the those who lost their lives to this ugly and unfortunate attack. Lextend my condolences to Olowo of Owo. Oba Gbadegesin Ogunoye as well as the Catholic Church.

"I urge our people to remain calm and vigilant. Do not take laws into your hands. I have spoken to the heads of the security agencies. I have equally been assured that security operatives would be deployed to monitor and restore normalcy to Owo kingdom." Akeredolu said.

Many Nigerians particularly northerners felt insulted and termed Tinubu's statement as meant to denigrate the person of the President.

One of the persons who condemned Tinubu's statement was one of his staunch supporters and promoters in the north, Babachir Lawal, a former Secretary to the Government of the Federation.

In a refuttal on Friday, Tinubu said his comments were not meant to disrespect the President and had been taken out of context. He said reactions suggesting he had been disrespectful were sensational and incorrect.

But, the former Lagos State governor was also reprimanded by no other person than the APC national chairman, Abdullahi Adamu threatened possible who sanction.

In an interview journalists on Saturday at the party secretariat, the chairman said "within the last three days, the country, and the world of the social media have been undaunted with the report of one of our leaders Asiwaiu Bola Tinubu. former Governor of Lagos State when he went for his campaign in Ogun -Abeokuta in the course of his address he went as far as to mention what happened between him and president Muhamadu Buhari.

"He went as far as to tell his audience how Buhari went to him, even prostrating in tears, begging him to endorse him for the presidency. He claimed Buhari went to him.

"The words in Youruba language, the interpretation was very very insulting, very very unbecoming of a person of that standing to do what he did to a sitting president produced by the votes of APC. It is amazing how a fellow APC person to make that kind of comments about the president.
"We take exception to this

and this doesn't show any appreciable level of respect for the office of Mr President and the person of Mr President. Therefore, we want to make it public that we are saddened about the audio and video in that reportage and we condemn it in the strongest those of APC terms... extraction to make those kind of unbecoming comments.

"Between yesterday and this morning it was retract but that effort is not adequate, it doesn't wipe out the impression that event has left in our minds. This our position. I as chairman of the ruling party has the duty to come out and stand by our government, to stand by our president."

Asked whether punitive measure could affect Tinubu's screening outcome, chairman national said "I don't want to take this together because they are mischief laden. I don't want to take the primary screening to answer this question because doing so is finding the way to justify, give some reasons that may have caused what he did. For one thing I know at the time this event took place the screening committee had not made the report to us at all.

"The question of punitive measure yes and no. This morning we saw some traces of withdrawal statements. You see these are statements that can emerge not with the intention of the actual actions. So yes, we can't say we don't see in the papers what was reported. It happened. What is out is out. It is not an apology, it is trying to retract. We will be on the watch...for us to penalise any member of the party not just Bola Tinubu, anybody. We will watch events as they unfold."

Rising in defence of Tinubu discarding Adamu's sanction threat as empty, the APC National Vice Chairman (North West), Dr. Salihu Lukman it was unfortunate that Tinubu made those statements and it is his right to express his frustration, but should be recognised as such.

Challenging Adamu's threat, he said "but nobody, no matter the position of the person can use it against him unless the party follow due process through the rightful organs of the party to discuss

"So, the opinion expressed Abdulahi Adamu was his personal opinion and it is his own right to present it to any organ of the party for consideration. But until that opinion is adopted by organ the party, it cannot be considered as the position of party. It is not the position of APC, it is his personal opinion".

Also, there is a legal case challenging the eligibility of Tinubu to contest the party's primary election.

Some APC members under the aegis of Gaskiva Youth Movement, had approached the Federal High Court in Abuja asking the court to disqualify Tinubu, from the party's presidential primary.

In a suit marked FHC/ABJ/ CS/774/2022, filed before the Court, the plaintiff listed the APC and Tinubu as first and second defendants, while the Independent National Electoral Commission (INEC) is listed as the third defendant.

Part of their prayers include, asking the court to determine whether Tinubu can participate in the APC primaries or that of any other political party, given "questionable educational background and date of birth".

They are also asking the court to declare that "upon consideration of the relevant laws, Tinubu cannot participate or contest in the primary election on the platform of the first defendant (APC)".

They are also seeking a "declaration that given the guestionable educational background and date of birth, (Tinubu) among other questionable issues, the first defendant (APC) cannot allow and/or permit his participation in the primary election for the office of the president".

The group also wants the court to declare that Tinubu "cannot participate by presenting himself in any primary elections with any political party in Nigeria to be nominated as a presidential aspirant for the 2023 general election."

This no doubt will be great distraction to the Tinubu's ambition.

However, the national chairman, Adamu cleared the air on delegates eligible to vote in today's convention.

This is coming against purported court ruling Kano which allowed delegates participate at the convention.

Adamu said "well, I am a lawyer,. We have serve notice of appeal and matter is in the court and as far as we are concerned, this convention concerned, statutory delegates are excluded."

Party members look up to the 2322 elected delegates across the country to do APC proud by electing its flag bearer in the 2023 presidential election.

Last minute intrigues and the resolve by some APC Governor's to teach Vice President Prof. Yemi Osinbajo a political lesson he will not forget in a hurry, have revealed that at least 17 APC governors may have backed the presidential aspiration of their Ekiti State counterpart,,

The Trumpet gathered that 17 governors include Babagana Zulum of Borno and Abdullahi Ganduje of Kano States, among some loyalists of Tinubu.

Multiple sources confirmed diverse re-alignmenis were on-going to ensure that the APC state helmsmen put Fayemi, who is the Chairman of Nigerian Governors Forum, on the party's ballot for the 2023 presidential election.

Sources further confirmed that that the Ekiti helmsman has been able to reach and regrouped 17 out of the 22 governors delegates who are sympathetic to his presidential ambition. But five governors have prevented him from having access to their delegates.

The source said: "In light of the push by the governors for one of their own to take over as president, Fayemi has been rallying them around his candidacy.

Contrary to reports that Buhari had during a meeting with presidential aspirants, discussed that the Presidency should go to the South in 2023, Malam Garba Shehu ,a Senior Special Assistant, Media and Publicity to the President, has said that nothing as such was discussed.

Speaking in an interview with the BBC Hausa Service on Sunday, Garba said "the meeting was among the series of meetings that President Muhammadu with Buhari commenced the chieftains and party bigwigs in the APC, to ensure that the APC Presidential primary election is conducted peacefully; and to make sure the APC is placed on the right pedestal that will bring victory to the party during the forthcoming presidential election in 2023.

When asked if the issue of power shift was discussed at the meeting, Malam Garba Shehu said " no,that was not discussed. What President Muhammadu Buhari said was that he had called them to advice them. That they should go and discuss within themselves, in their capacity as Presidential aspirants, they should deliberate among themselves and with the party on how they could bring forth a sole candidate for the presidency.

When told that some Nigerian newspapers had written that the President was in support of power to go to the South, Garba Shehu said " nothing as such was discussed as even if the President had such an opinion, he did not come out to say it at the meeting. "

When reminded that, that were rumours President Buhari might come out to announce the person he was supporting to succeed him, Malam Shehu explained that "what the President was saying was that he was prepared to continue providing the leadership that would lead to the emergence of a candidate through a peaceful and harmonious process that the aspirants, governors and other party leaders would adopt .But these talks that the President had said he alone would bring out the presidential flagbearer of the party, no, this is not Buhari's character. That is not even democratic."

Asked if time was by their side, Shehu recalled that such had happened previously when the party leadership was elected.

It was on the edge that the party stood firm and agreed on one person to be the leader. Also, in 2015 it was a day to the election that the governors gave the delegates the direction to follow, who to vote.So I don't think it would be any different, this time around," he said.

asked what When President Buhari would do if the aspirants fail to arrive at a consensus arrangement, Garba Shehu said President would've no choice . " We have to follow the election process," concluded.

following And decision of the northern APC governors to cede power to the south, the race for the presidential ticket was trimmed down to just seven southern aspirants.

A source said the northern governors in specific terms want the ticket to go to the South West. This leaves Osinbajo, Tinubu, Fayemi and former Ogun State Governor bikunle Amosun as

This it was learnt was followed up with another meeting Sunday which further reduced the contest to Osinbajo and Tinubu.

As at press time, there were conflicting stories speculating that either of the two had stepped down for the other.

Our source said leaders of the party persuaded Tinubu to consider stepping down for the Vice President.

Reasons advanced according to the source were that Osinbajo has age on his side and that having served under Buhari for two terms, he will be preferred by the President as a reliable successor.

Also, Osinbajo is seen by interests close to the Presidency as a veritable vehicle for the continuity agenda of the APČ administration. The leaders thought Osinbajo will be sellable to Nigerians than either Tinubu or Fayemi. It will also douse southwest tension and resentment to the APC at the 2023 polls.

Our source said after much ado, the former Lagos State governor agreed in the interest of the zone, accepting to once again make sacrifice for the South West not to lose the offer which Buhari might give on a platter of gold.

The leaders, the source added assured Timubu that certain interests of his would be taken care of if the APC retains power under Osinbajo.

According to the source, there was no much ado in convincing Fayemi who was said to be willing to step down for Osinbajo.

But earlier, an unconfirmed report had it that Tinubu was given the nod as a consensus Yoruba candidate because of the belief that he has political structure, sagacity and financial muscle to tackle Atiku.

The proponents of the Tinubu candidature the meeting were said to have argued that Osinbajo is a neophyte in politics, who has no structure and political associates across regions. Giving the ticket to him, they argued, may spell doom for the APC because of the believe that Osinbajo can easily be trounced by Atiku and the PDP in 2023.

It is expected that a few moments to the ballot, a clearer picture of who really will be the APC candidate, will emerge.

# SERAP, others sue INEC for not extending voter registration

"ndependent National Electoral Commission (INEC) is facing a lawsuit asking the court to "declare unconstitutional, illegal, and incompatible with international standards" the failure of the body to extend the deadline for voter registration "to allow eligible Nigerians to exercise their rights.

Socio-Economic Rights and Accountability Project (SERAP) and 185 concerned Nigerians have filed the suit, saying:

Against its earlier stance, INEC recently extended the deadline for the conduct of primaries by political parties by six days, from June 3 to June 9. But the commission has failed to also extend the online pre-registration which ended May 30 2022 and the Continuous Voter Registration (CVR) ending 30 June 2022."

In the suit number FHC/L/ CS/1034/2022 filed at the Federal High Court, Lagos, SERAP is asking the court to determine "whether the failure of INEC to extend the deadline for voter registration is not a violation of Nigerian Constitution, 1999 [as amended], the Electoral Act, and international standards."

SERAP is asking the court for "a declaration that the failure of INEC to extend the deadline for voter registration is a violation of eligible Nigerians' rights to participate freely in their own government, equality and equal protection.'

SERAP is also asking the court for "an order of mandamus to direct and compel INEC to extend voter registration by a minimum of three months and take effective measures to ensure that eligible Nigerians are able to register to exercise their right to vote in the 2023 general elections."

SERAP is arguing that: "Enforcing unrealistic voter registration deadline while extending the deadline for party primaries would deny and abridge the constitutional and international human rights of eligible voters.

"INEC mandates ought to be exercised in a fair, just and non-discriminatory manner. The extension of voter registration would ensure that Nigerian voters are treated equally and fairly. The future of Nigeria's democracy depends on it.

"Voters are also critical stakeholders in the electoral process. Treating all eligible Nigerian voters fairly would advance the people's right to vote and to participate in their own government.

"INEC must not only be independent and impartial in the exercise of its constitutional and statutory responsibilities, but must also be seen to be independent and impartial.

"An order restraining INEC, its agents, privies, assigns, or any other person(s) claiming through it from discontinuing the continuous voters' registration exercise from the 30th June 2022

or any other date pending the hearing and determination of this suit."

The suit filed on behalf of SERAP by its lawyers Kolawole Oluwadare and Opeyemi Owolabi, read in part: "Extending the voter registration exercise would also bolster voter confidence in the electoral process.

"One of the people's most sacred rights is the right to vote. The commission has a constitutional and statutory responsibility to ensure the effective exercise of the right of all eligible voters to participate in their own government.

"Extending the deadline for party primaries without providing adequate time and opportunity for eligible voters to register and participate in 2023 general elections would amount to an unfair and discriminatory treatment of Nigerian voters, and violate other human rights.

"Extending the voter registration deadline would provide more time for eligible voters, including young people, the elderly, people living with disability, as well as those resident in states facing security challenges and living in IDP camps to participate in the 2023

"Extending the deadline for voter registration would be entirely consistent with constitutional and international standards, and the Electoral Act. Any such extension would also not impact negatively on INEC's election calendar and activities.

"The public perception of the independence and impartiality of INEC is essential for building public confidence in the electoral process, and ensuring the credibility and legitimacy of the 2023 elections.

Where Nigerians have doubts about the independence and impartiality of INEC, they are more likely to have less confidence in the electoral process thereby undermining

"Extending the deadline for voter registration would also be justified, given reports of challenges in the voter registration exercise, especially for young people, the elderly, persons living with disabilities, and those resident in states facing security challenges and living in internally displaced persons (IDP) camps.

"The will of the people is expressed through democratic elections. This requires that people should be afforded adequate time and opportunity to register to vote. Extending the voter registration deadline is crucial for promoting the independence and impartiality of INEC and building public confidence in the electoral

"The Nigerian Constitution 1999 (as amended) provides in Section 14(1)(c) that, 'the participation by the people in their government shall be ensured in accordance with the provisions of this Constitution.

'Section 9(6) of the Electoral Act 2022 provides that 'the registration of voters, updating and revision of the Register of Voters under this section shall not stop not later than 90 days before any election covered by this Act.'

"Similarly, the International Covenant on Civil and Political Rights, the African Charter on Human and Peoples' Rights, and the African Charter on Democracy, Elections and Governance guarantee the right to political participation.

"These human rights treaties also require states parties including Nigeria to ensure the independence and impartiality of national electoral bodies responsible for the management of elections, as well as to promote the establishment of the necessary conditions to foster citizen participation.

"The right of people to participate in their government is a fundamental feature of any democratic society, and any undue restriction of the right would strike at the heart of representative government."

No date has been fixed for hearing of the suit.

'My appeal is to all those who have grievances to adopt the rule of law to ventilate them. The bloodshed in the land is too much and no reason can be advanced for this desperate act of wickedness.

"Owo, being the hometown

of Governor Oluwarotimi Akeredolu, I pray that this datardly act has nothing to do with his principled stand on national issues such as restructuring, resource control, power rotation, restriction on open grazing and

"The Governor has been at the forefront of the implementation of the regional security outfit, Amotekun; which has been hugely successful in crime reduction. I urge him not to relent in any of these noble pursuits, if that is the genuine desire of the people that he represents.

"My heartfelt condolences go to the families of the innocent souls that were brutally terminated, the Catholic Church and the people

According to a statement on Sunday by the Force Public Relations Officer, CSP Olumuyiwa Adejobi, the officer, Isaac Mathew, who is attached to the Ebonyi State Police Command, was demoted from Corporal to Constable.

Recall that the officer was caught in a viral TikTok video on May 7, 2022, dressed in full Police uniform while singing, dancing and brandishing an AK47 rifle in praise of a secret confraternity.

"This decision follows the outcome of the Orderly Room Trial of the concerned officer and a review of the recommended punishment for the offences of Discreditable Conduct, Promoting Secret Cults and violation of the Social Media Policy (SMP) of the Nigeria Police Force.

The Force is currently looking into many other disciplinary cases of unprofessionalism and misconduct by officers in encounters with members of the public. Meanwhile, orderly room trials are ongoing and decisions reached at the end of such trials will be made known as the current police administration is committed to a transparent, accountable and proactive policing system in

"Several attempts by agents of drug cartels to break through the security at Nigerias main airports in Lagos and Abuja with large consignments of assorted illicit substances have been thwarted by operatives of the National Drug Law Enforcement Agency, NDĽEA.

"No fewer than 11 members of the trafficking syndicates have been arrested in connection to the seizures," the statement said.

Ikeja, Lagos, on May 20. "On the same day, 10 cartons of khat with a gross weight of 354.600kg were also seized at the NAHCO import shed of the airport. The following day, Saturday 21st May, a freight agent, Roland Orinami was arrested by NDLEA operatives attached to the local wing of the Lagos airport with 1.90kg Loud, a variant of cannabis, factory packed in some bottles while trying to send same via flight

"A follow up operation in Abuja led to the arrest of a taxi driver, Nsikak Evans sent to collect the consignment. His confession also led to the arrest of the actual owner, Adesanya Olakunle Isaac at his house in Life Camp area of Abuja. Adesanya who claims to be into Information Technology, accepted ownership of the seized drug, which he said was meant for an upcoming birthday party of one of his friends," the statement

In another development on May 24, another freight agent, Moshood Azeez Olaide was arrested at NAHCO export shed of the MMIA when he presented a cargo containing psychotropic substances heading to Dubai. According to the statement,

"The illegal consignment was packed into other items such as can drinks, liquid bitters and other non-controlled drugs. The seized drugs include Tramadol 225mg, Rohypnol and MDMA. A follow up operation led to the arrest of another suspect linked to the crime, Olagboye Selim on Friday 27th May.

"Also on the same day, operatives of the Nigerian Customs Service at NAHČO import shed transferred 15 cartons of khat leaf with a gross weight of 256.70kg, which came into the country on Royal Air Moroc to NDLEA command at the airport."

Similarly, another freight agent, Lasebikan Felix Gbega was arrested with 200 bottles of pentazocine injection, with a brand name "Drutapent" weighing 1.05kg on May 23rd. The consignment was said to be heading to the United States of America.

Also, on May 26, another agent, Akuta Chioma Lucy was arrested at the SAHCO export shed while attempting to export 14.75kg of khat concealed inside other vegetable leaves and food condiments such as bitter leaf, scent leaf, pepper, all packed in bags for shipment to the United Kingdom.

The statement further revealed that "At the Nnamdi Azikiwe International Airport, Abuja, a 45-year-old Ezika Ugochukwu Nicholas from Ichida, Anocha area of Anambra state was arrested on Thursday 26th May for ingesting 60 pellets of cocaine weighing 1.037kg on arrival from Addis Ababa on board Ethiopian airline.

"Ezîka who claims he's into shoe business before his arrest travelled to Ethiopia on 23rd May on the invitation of the person who gave him the drug, which he ingested before returning into the waiting arms of NDLEA officers at the Abuja airport."

In the same vein, efforts by drug cartels to export 4kg methamphetamine concealed in nylon rolls to New Zealand were also frustrated by anti-narcotic officers attached to a courier company in Lagos.

The officers also blocked different quantities of cannabis sativa and Tramadol hidden in soles of slippers from being shipped to Oman through the same firm.

Meanwhile, no fewer than 335,820 tablets of Tramadol, Exol 5, Diazepam and Rohypnol as well as 400 bottles of codeine syrup concealed in bags of vegetables have been intercepted in Abuja in a hummer passenger bus coming from Enugu on 30th

May.
"The bus driver, Augustine James, 35, is currently helping investigation," the statement said.

It added, "In Imo state, 1,111kg of cannabis sativa heading to the Orlu forest, which has become a fortress for non-state actors, was intercepted on Thursday 26th May.'

## Terrorists abduct 'many' in Katsina

Terrorists have abducted an unspecified number of people, including women and children, at Farfaru and Kwari communities in Jibia Local Government Area of Katsina state.

The Farfaru incident happened at about 3pm on Saturday, while the Kwari incident occurred at about 9.30pm of the same day.

It was gathered that the terrorists also rustled several domestic animals from the two communities, and shot some of the residents that were trying to flee from the attack.

No lives were said to have been lost, however, several persons were said to have been injured and currently receiving treatment at the hospital.

It was also gathered that the attack led to a mass exodus of residents from the two communities, with several of them currently located at Jibia town.

A source living in the area said the number of those abducted were "many", and that several community members were yet to know about the whereabouts of their loved ones.

He said several of those abducted were women and children, including the elderly ones, as they were not able to flee into the bush when the terrorists stormed both communities.

He said that as at Sunday afternoon, some of the residents were still making frantic efforts to know about the fate of their

loved ones.

One of the residents of Farfaru community said the terrorists were on a reprisal mission.

According to him, the terrorists were unhappy because of the arrest of some of their colleagues few days ago by security operatives.

He added that the terrorists were suspecting that some people in the community gave security operatives the information that led to the arrest of their col-

"Only God knows the number of our villagers that the terrorists kidnapped. They also burnt down our houses and rustled our animals.

"Security operatives who arrived Farfaru later saved us from further punishment in the hands of the terrorists. The Security operatives drove them back to the forests. Many of us have relocated to Jibia for our own safety," he said.

Terrorists also ransacked Kwari village, shot several people and rustled dozens of animals.

Some of those injured are receiving treatment at the Jibia hospital, while the village is said to have been deserted.

When contacted, spokesperson for the Katsina Police Command, SP Gambo Isah confirmed the incidents, but did not provide

Isah said he would need to get across to the DPO in charge of the two communities to know what actually happened.

# Showdown looms over abandoned N85b East-West road project

•Indorama, PHRC, Onne port, others to be cut off

There are indications that stakeholders who bar-ricaded the ever busy 18-kilometer Eleme axis of the popular East-West road in Rivers State in July last year are planning a fresh showdown over the failure of Federal Government to fulfill the pledge to construct the expressway which is in a

terrible state of disrepair.

The road which leads to the Onne Oil and Gas Free Zone, and the Nigeria Ports Authority, all in Onne equally services heavy duty trucks lifting petroleum products from the Port Harcourt refinery, Alesa, Eleme and those lifting fertilizer from Notore and Indorama-Eleme Petrochemical and Fertilizer Company, among others. Experts say an estimated 10, 000 vehicles, mostly heavy duty, ply the road every hour, a situation they say accounts for the regular collapse of the

A youth leader who was one of the arrow heads of the protest last year hinted that plans were afoot for the stakeholders to return to the action suspended last year following assurances by the then Minister of Niger Delta Affairs, Chief Godswill Akpabio that government had awarded the contract for the reconstruction of the road to Reynolds Construction Company, (RCC).

"I can assure you that we are mobilizing internally and talking to ourselves because this time it is going to be massive. We have seen that this government does not take the life of our people as anything. You can see the road yourself how it has degenerated since the rains started pounding on it. We have no option left than to go back to the road and occupy it till we see concrete action being taken to put the road in a good

shape", he said. The youth leader who would not want to be mentioned further said they were waiting for the chairman of Eleme Local Government Council, Hon. Obarilomate Ollor who championed the action last year to conclude his consultations for a hitch-free action.

The Trumpet recalls that following the deplorable condition of the 18 kilometer section of the road spanning from Trailer Park to Eleme Junction, linking Port Harcourt –Aba express road and the consequent series of fatal accidents and frustrating traffic jam on the ever busy road without redress, stakeholders made up of Ogoni and Eleme youths, civil society groups and representatives of some of the companies operating within the Eleme industrial hub occupied the Akpajo Junction of the road for one week, using heavy duty trucks that the tires were deflated to create a barricade both at the Akpajo and refinery junctions.

The action which took place July last year paralyzed social and economic activities and brought untold hardship to people. Importers and clearing agents using the Onne water channel to bring and clear their goods and other multinational companies operating at Onne were worst hit by the action as they counted their losses.

However, *The Trumpet* learnt that the Federal Government responded by sending the Permanent Secretary in the Ministry of Niger Delta Affairs, representing the minister, Godswill Akpabio who came and dialogued with the protesters, with an assurance that government was sourcing the sum of N85 billion to fund the project after securing N2.5 billion for the contractors, Reynolds Construction Company, (RCC) as mobilization fee to begin work immediately on the road.

It was gathered that RCC actually mobilized to site and started clearing and soil testing, but after a while disappeared unceremoniously. A community source in Eleme however told our correspondent that officials from the Federal Ministry of Works came to the community and informed them that the project had been taken over by the ministry and listed it to be funded from the Federal Infrastructure Development Fund

The Trumpet learnt that what is fuelling anxiety among the stakeholders is that the rains are coming heavily and washing away the remedial restoration work RCC had done before pulling out of site, yet the ministry of works is not forthcoming on their own side with the intervention from Federal Infrastructure Development Fund.

Checks at the Federal Ministry of Works, federal secretariat, Port Harcourt confirmed the take- over of the road project from the Niger Delta Ministry, but a source in the office said the necessary paper work were yet to be concluded.

When our correspondent visited the road, vehicles were moving on snail speed and at the same time making dangerous detours as they meander around large potholes and gullies, while commuters usually have their hearts in their mouth until they escape the 18 kilometer stretch as they journey on the road.

"The anguish on the road is terrifying", says a staff of one of the companies in Onne who plies the road daily while going to work. "I have never been diagnosed of having high blood pressure, but since I was transferred to our branch at Onne, I have been on BP drug occasioned by the anxiety of passing through this

road.

"You can imagine the prospect of coming face to face with a container laden truck meandering and dodging the potholes littered are the road on a single lane single. on the road on a single lane since the other lane has been completely abandoned. It is terrifying to say the least", he crooned.

Dr. Okey Okoro, Chairman Onne Seaport chapter of the National Association of Freight Forwarders lamented the challenges members of the association are facing as a result of the dilapidated road.

He told The Trumpet: "The dangers we face are uncountable. The colossal loss cannot be quantified. We have cases and cases again where entire container get wasted.

"Land freight insurance com-

panies don't touch containers on that road. If you insist on doing land insurance, the premium is very prohibitive. The level of insecurity has increased. Hardly does any month pass without the news of our member being kidnapped or robbed on that road because vehicles move very slowly", Okoro explained.

According to him, the condition of the road has scaled down the level of business coming to Onne port as people now seek alternative to Lagos or Port Harcourt ports. Added to this he said is the rising cost of haulage bills.

"Before now, it was N150,000 we used to pay for a truck to Onitsha, but it is now N400,000. Port Harcourt was 75,000, it is now, N250,000. The wear and tear of the vehicles we use on the road have also worsened", he pointed out.

He wondered why the government would not rise to the occasion and fix the road given its economic importance to the nation.

### Unknown gunman killed in failed kidnap attempt

A n unknown gunman on Sunday met his waterloo in Anambra State as the effort of his gang to kidnap someone was resisted by gallant security operatives.

Gunmen who eyewitnesses said were four in number stormed Oko community in Ekwulobia, Aguata local government area of the state where they planned to execute the Kidnap.

They came in a Jeep but the timely intervention of the officers led to the killing of one of them

while the others escaped.

"They came through Nanka road and heading towards Ekwulobia before they were repelled by security agents," an eyewitness told our correspondent.

"Their operational vehicle was also recovered by the military

The lifeless body of the dead gunman was seen in a video with the body having many objects suspected to be charms.

Confirming the development, the Anambra State Police Command Public Relations Officer, DSP Ikenga Tochukwu told journalists that the operation followed the information received by the command in the afternoon.

"Following information gathered of an abduction that took place today 5 June 2022 about 1:30pm along Oko and Ekwulobia.

"The Police embarked on a rescue operation which resulted in the neutralising some of the armed hoodlums and recovery of some of their operational vehicles.

"The operation is ongoing now. I will get back to you with full details as soon as Í can please," Ikenga said.

Anambra State in the recent time have come under heavy attack by the dreaded unknown gunmen and this has led to many bloodletting.

**¬** ffects of vote buying on Nigeria's democratic journey have been ■ alarming such that the outcome of elections cannot be adjudged outright to be free, fair and credible.

Voters inducement has had a very negative impact on the outcome of elections across the country; often than not, the highest bidder with cash to throw around emerges winner of elections not the most popular, most preferable, most competent, or most intelligent candidate with the technical know-how to fix the nagging problems bedeviling the country.

The urban areas to the remotest rural areas, most electorates look forward to political seasons, which are largely seen as a time that politicians dish out free money to the people. This has not just made politics expensive, it has also opened doors of public services to the very corrupt people in the society without clues to grow the country.

When in office, the political elites take

pride in impoverishing the electorates and show up every four years after to buy their votes and consciences with peanuts rangingfrom N500 to N10,000, making it appear as a form of favour being done to the people.

As the 2023 elections approach, critical stakeholders are wondering if the Independent National Electoral Commission (INEC) would in collaboration with anti-graft agencies arrest the menace of votes buying and conduct a credible polls.

So far, the news of voters inducement are already overwhelming the polity with the conduct of the ongoing party primaries, where it is being alleged that some aspirants are going as far as using hard currencies to induce delegates.

It was based on such rumours that operatives of the Economic and Financial Crimes Commission (EFCC) stormed the presidential primary venue of the People's Democratic Party (PDP) days

The anti-graft agency in a bid to

sensitize Nigerians on the implications of votes buying, has called on the electorates to refrain from every act of vote buying and vote selling in the nation's electoral processes.

EFCC made the call in Abuja on Friday, June 3, 2022, by the Secretary of the Commission, Dr George Ekpungu, while receiving a delegation of th Civil Society Partners on Electoral Reform (CISPER) who paid a courtesy visit to the EFCC.

Ekpungu noted that every leadership's recruitment process in the country is very vital, and called on Nigerians to avoid selling their votes and their future to the highest bidder in the course of

He commended CISPER for coming forward to partner with the EFCC in curbing the menace of vote buying and selling and called on other well-meaning Nigerians to come and partner with the Commission to aid the fight of all sorts of economic and financial crimes in the country.

#### EFCC detains Zulum's aide over post allegedly linking lawmaker to Accountant-General in N174b fraud saga

Borno Zonal office of the Economic and Financial Crimes Commission (EFCC), has reportedly invited and detained Abdullahi Yusuf, senior special assistant to Governor Babagana Zulum, for questioning over a Facebook post.


Abdullahi had, on May 29, published a post saying it was rumoured that a prominent federal lawmaker from Borno may be linked to the N174 billion fraud case involving the suspended Accountant-General of the federation, Ahmed Idris.

Although the aide did not name the lawmaker, supporters of Muktari Betera, a member representing Biu federal constituency, went under the post to allege that he was referring to the lawmaker.

On May 30, Abdullahi, in a bid to provide more clarification on his post, again took to Facebook to explain what he meant.

"I did not mention any name. Unfortunately, some supporters of one particular lawmaker started raining all sorts of insults and threat directed at me. I only posted it because it was a trending issue.

"I never in anyway mentioned any name. I just reposted it the way I read it. If anyone feels offended, let the person rest assured that it was not intended for any malice. I just saw a trending issue online and shared

it," he said.

Abdullahi was then said to have received an invitation from the EFCC zonal office in Maiduguri.

He was reported to have arrived the EFCC

office the next day and asked to provide the source of the information he shared on Facebook.

The aide, however, reportedly said he picked the post randomly from Facebook and flagged it as a rumour being made by others which was misinterpreted.

Abdullahi was said to have been detained afterwards despite efforts by family members to get him released, as the zonal head insisted that he was following a directive from the EFCC headquarters.

However, when contacted, Wilson Uwujaren, EFCC spokesman, told newsmen that he was yet to get information on the matter.

"I will find out. I don't have the report,"

Recall that the suspended Accountant-General has been released from detention by the anti-graft agency.

Uwujaren, while confirming his release said, "The suspended Accountant-General is out on bail. He was released last night (Wednesday)."

Idris was arrested by operatives of the EFCC on May 16, 2022, in connection with a series of frauds that was initially thought to be N84 billion.

Three days after his arrest, Idris was suspended by the Minister of Finance, Budget and National Planning, Zainab Ahmed, to enable him face his probe

Her body has been deposited in the hospital's morgue, while the EFCC officials reported the matter at the police station and made statement.

When our Correspondent put a call to EFCC Spokesman, Mr Wilson Úwujare, for his reaction, he promised to call back, but never did. "Really, I am not aware of the story, so I have not been briefed. I will call you back when I get information about what transpired," he said.

### Buhari's senior aide, Darazo rallies support for Tinubu

# Research unveils healing without medicines

't is very necessary to understand the primary causes of sickness before addressing the above subject matter. What are the causes of sickness? Persons from different countries or background causes sickness. Take for example, a baby gets diarrhea; and you asked - why? (a). People in small villages may say it is because the parents did something wrong, or perhaps because they made a god or spirit angry. (b). A doctor may say it is because the child has an infection. (c). A public health officer may say it is because the villagers do not have a good water system or use latrines. (d). A social reformer may say the unhealthy conditions that lead to frequent childhood diarrhea are caused by an unfair distribution of land and wealth; while a teacher

may place the blame on lack of education. Therefore people see the cause of sickness in terms of their own experience and point of view. Who then is right about the cause? Possibly we can say everyone is right; or partly right. This is because sickness usually results from a combination of causes. Each of the causes suggested above may be a part of the reason why a baby gets diarrhea. To prevent and treat sickness successfully, it helps to have as full an understanding as possible about the common sickness in your area and the combination of things that causes them. However, despite there many types of sicknesses; for most sicknesses no medicines are needed for treatment. Naturally our bodies have their own defenses, or ways to resist and fight disease. In most cases, these natural defenses are far more important to our health than are medicines. People will get well from most sicknesses -- including the common cold and 'flu' -- by themselves, without need for medicines. Therefore, to help the body fight off or overcome a sickness, often all that is needed is to keep clean your body, wear neat clothes and clean environment; get plenty of rest especially when you are exhausted and to eat well. Even in a case of more serious illness, when a medicine may be needed, it is the body that must overcome the disease; the medicine only helps. Cleanliness, rest, and nutritious food are still very important. Much of the art of health care does not -- and should not depend on use of medications. Even if you live in an area where there is no modern medicines, there is a great deal you can do to prevent and treat most common sicknesses--- if you learn how it is done. Many sicknesses can be prevented or treated without medicines if people simple learned how to use water correctly --- this alone might do more to prevent and cure illnesses than all the medicine they now use... and misuse. HEAL-ING WITH WATER. The reality of life is that most of us could live without medicines. But no one can live without water. In fact, over half (57%) of the human body is water. If everyone living in farms and villages made the best use of water, the amount of sickness

and death — especially of children could probably be cut in half. For example, correct use of water is basic both in the prevention and treatment of diarrhea. In many areas diarrhea is most common cause of sickness and death in small children especially in Africa rural communities. Contaminated (unclean) water is often part of the cause. An important part of the prevention of diarrhea is to boil water used for drinking or for preparing foods. This is especially important for babies. Babies' bottles and eating utensils should also be boiled. Washing one's hands with soap and water after a bowel movement (shitting) and before eating or handling foods is just as important. Treatment-- The common cause of death in children with diarrhea is severe dehydration, or loss of too much water from the body. By giving a child with diarrhea plenty of water (best with sugar or honey and salt), dehydration can often be prevented or corrected. Giving lots of liquids to a child with diarrhea is more important than any medicine. In fact, if enough liquid is given, no medicine is usually needed in the treatment of diarrhea. Times when the Right Use of Water May Do More Good than Medicine to PREVENT: (1.) Diarrhea, worms, gut infections--- boil drinking water, wash hands, etc. (2.) Skin infections--- bathe often.

tetanus--- wash wounds well with soap and boiled water.

4. Guinea worms in the legs or body--- do not let people step into the water when drawing water from a water hole, filter water or boil it before drinking. WATER TO TREAT: (1.) Diarrhea, dehydration, illnesses with fever— drink plenty of liquids. (2.) High fever— soak body with cool water. (3.) Minor uninary infections (common in women)--- drink plenty of water. (4.) Cough, asthma, bronchitis, pneumonia, whooping cough--drink a lot of water and breathe hot water vapors ( to loosen mucus). (5.) Sores, impetigo, ringworm of the skin or scalp, pimples--scrub with soap and water. (6.) Infected wounds, boils--- hot soaks or compresses. (7.) Stiff, sore muscles and joints, itching, burning -- hot compresses. (8.) Minor burns--- hold in cold water. (9.) Sore throat or tonsillitis---gargle hot salt water. (10.) Acid, dirt, or irritating substance in eye--- flood eye with cool water at once, and continue flooding with water for at least 15 minutes. (11.) Stuffed up nose--- sniff salt water. (12.) Constipation, hard stools,--- drink lots of water. Finally, in each of the above cases (except pneumonia) when water is used correctly, often medicines are not needed.

Chances of Vice President Yemi Osinbajo to win thepresidential primary election of the All Progressives Congress has been described as bright and assured.


Giving this assurance, the Osinbajo Youth Organisation claimed the backing of Prof. Osinbajo by 13 governors of the party who are plotting his emergence.

### Nasarawa politicians demand N150m from Faleke, Tinubu support group

The petition titled "A Demand For Compensation for Harvest of Delegates" read "Recall that on the first of June, 2022, you, through one of your staff, by name Mr Bisi Oyo Osun, approached us to supply delegates lists from Nasarawa and Plateau States

"We did as required and the 2nd of June,

being the following day, we personally handed over the lists to you in your office, in the presence of Mr Bisi Oyo Osun

"Right there, you directed your officer, one Malam Zakari to vet the list and invite us for further discussions

"The official in question, now, fixed an appointment with us for the following day at 10am for the result of his verification

at 10am for the result of his verification "But, he never turned up in the office

to honour the appointment
"When we reached him on his phone
for updates on the assignment, that you
gave him, he told us that the list from

Nasarawa State had been changed "We smelled a rat, and quickly got across to the National Secretariat of the All Progressives Congress, APC to verify the information, and this was promptly debunked by the National Organising Secretary.

"We immediately reached Zakari to inform him that his information about a change of delegates list was false, having confirmed from the National Secretariat of the Party

"Our suspicion heightened, when Zakari refused to engage with us in further discussions, until late in the evening of that day, that we discovered to our shocking dismay that Zakari and your good self had entered into negotiation with the same delegates on the list that we gave you, without our knowledge

"When we asked Zakari to explain to us, how the same delegates were brought to the Campaign Office without our knowledge, he simply claimed that some people brought them

"We then demanded to know why we were not contacted as promised, since we had an understanding that the Campaign Organisation will provide them with accommodation and other logistics, after finalising all negotiations between us and them, only for him to claim that he didn't know how they came, but that he only saw the delegates in their campaign office

"From our findings, through one of the delegates who spoke with us, Mr Zakari in connivance with some people, secretly got in touch with them using our list and sidelined us

"This is a clear case of betrayal and double crossing

"We hereby demand a compensation of One hundred and fifty million Naira (150m), for our efforts in harvesting the delegates who have now been cornered by your campaign organisation.

"Please note that, we shall address the media on this issue if our demands are not met quickly."

# Does Nigeria need debt restructuring to borrow more?

In the early 1960s, Nigeria used to lend money to the International Monetary Fund (IMF), but the country has now become one of the highest indebted nations in the world in relation to its revenue earnings, Gross Domestic Product (GDP) and other financial parameters. At a time when most Nigerians are complaining that the country's debt profile has become a huge burden to the economy, the IMF has suggested ways to enable Nigeria to keep borrowing. In this analysis, **JOHNMARK UKOKO** wonders whether the country actually needs debt restructuring and fresh loans to survive.

uring the era of former Military Head of State, General Yakubu Gowon, he was said to have made what became a popular saying to the effect that "Nigeria's problem is not money, but how to spend it."

That was during the crude oil boom when the country earned plenty of dollars from oil sales. At that time, the naira was more valuable than the United States of America (USA) dollar, as it exchanged for 75k to \$1 and in the 1970s up to the early 1980s the nation's currency exchanged at par for N1 to \$1.

Following the mismanagement of the country's resources, economy, corruption and unbridled foreign loans have all combined to devalue the naira to an all time low.

For instance, in the last few months, the naira has exchanged for between N550 and N600 to the dollar at the official rate and much higher at the black market.

The Nigerian situation has been worsened by the fact that despite being one of the world's top 15 most endowed countries in terms of crude oil and gas resources, its inability to refine its crude oil since the late 1980s till date has contributed to the constant erosion of the value of the naira.

Nigeria has also been riddled with massive crude oil theft by top government and military officials, militants and foreigners in collaboration with their Nigerian accomplices, which have reduced the country's crude oil exports, thereby affecting the country's foreign reserves, put at \$38 billion as of the first quarter of 2022.

The country has massive natural gas reserves, most of which is being wasted through flaring in the Niger Delta, while the price of Liquefied Natural Gas (LPG) continues to rise on a daily basis, as the country has to depend on imported gas for cooking and other commercial purposes.

President Muhammadu Buhari's administration has been adjudged to have the penchant for highest borrowing most in the history of the country.

As the country prepares for the 2023 general elections, some economists have argued that President Buhari's successor will use most of the country's earnings to service loans if the country's revenue generation failed to improve drastically.

They insisted that Nigeria has over borrowed, a situation they said, portrays great danger for the country's economy.

While most Nigerians at home and in the Diaspora have raised concerns over the country's huge debt burden and have called on the president to exercise restraint in further borrowings, the IMF has suggested debt restructuring for Nigeria to qualify for additional fresh loans

Director for Africa at IMF, Abebe Salasie, who stated this recently during a virtual press conference, said the bank was ready to assist Nigeria and other countries to diversify their economies to enable them to qualify for new credit facilities.

"IMF will help to facilitate economic diversification in the African region. We, therefore, advise the countries to be a little bit less dependent on their natural resources exports and more on the kind of labour-intensive economic sectors like manufacturing and other services that we can utilise," he stated.

He disclosed that the bank recently created a Resilience and Sustainability Trust that will help the IMF to ensure that the country's resources are used to provide required policy support for longer-term funding for many African countries.

Speaking further, he said:
"As a bank, we feel the needs
to go further for example, by
removing obstacles for quicker
debt restructuring under the
Common Framework. That
should allow for swift and efficient debt restructuring. The
second policy challenge area is
balancing the need to address
inflation without undermining
the ongoing recovery."

It is also common knowledge that in the last two years, the Central Bank of Nigeria (CBN) has struggled to manage the country's foreign exchange, with the real sector and other sectors that require forex being unable to access it through the Import and Export (I&E) window.

The commercial banks that the CBN mandated to provide forex facilities have been largely unable to do so, as scarcity of dollars have forced real sector to rely on the parallel market for its forex needs.

Moreover, the various measures the CBN initiated to tackle forex challenges and the consistent crash of the value of the naira had not yield the desired results.

Salasie noted that most countries in Africa were in Nigeria's league as they have been unable to balance their acts between curbing inflation and supporting growth.

supporting growth.

According to the National Bureau of Statistics (NBS), the inflation rate for March 2022 stood at 16.3 per cent, even as efforts by the CBN to tackle the country's inflation have not succeeded as the trend continued for over 12

months consistently.

While most European countries are lamenting that their inflation had risen to about eight per cent, which is still a single digit increase, Nigeria's inflation has risen above 14 per cent for over 12 months, with no hope of reducing.

of reducing.
Salasie pointed out that the central banks of most countries face a difficult balancing act between curbing inflation and supporting growth

supporting growth.

It would be recalled that late last year, the IMF predicted that Nigeria's economy would grow

by about 2.5 per cent and has not changed its position, as it announced recently that the country's economy was growing at over three per cent.

A major challenge for CBN governor, Godwin Emefiele and his colleagues at the apex bank has been the issue of exchange rate, which remains one area in the many areas Emefiele and management of CBN had failed in the last two years.

Curiously too, the IMF admitted that Nigeria and many countries in Africa are struggling to tackle their exchange rate as Salasie tasked them on the need to address exchange rate pressures stemming from higher global interest rates and heightened global uncertainty.

global uncertainty.

Speaking to The Trumpet recently, Chief Executive Officer (CEO) of the Centre for Promotion of Private Enterprise (CPPE), Dr. Muda Yusuf, decried the IMF for prompting Nigeria and other Africa countries that are already in huge debt burden to seek further credit facilities.

He said the loans from the IMF and World Bank have not helped African countries and charged Nigerians to reject further borrowing as the country currently use most of its revenue to service debts.

Yusuf charged managers of the Nigerian economy to work harder by tackling the country's financial challenges without having to borrow from the global financial institutions.

Respondents cautioned President Buhari and Nigeria's economic team against falling prey to IMF's bait insisting that most African countries that accessed IMF or the World Bank loans in the past have not recovered from them.

Citing Zambia, Zimbabwe and Togo that have not recovered from the credit facilities they accessed from IMF or the World Bank, they said the more loans they take from IMF and the World Bank, the poorer they become insisting that with the stringent conditions attached to such loans, the worse off the real sectors of such countries become.

They expressed concern that Nigeria was endowed enough to overcome its financial challenges if its leaders and managers of the economy to look inwards and appealed to the Federal Government not to go for fresh borrowings from the IMF and the World Bank.

They say despite the various foreign loans the President Buhari administration has sourced from the global financial institutions, not much progress has been made in the country.

Nigerians also expressed reservations over IMF's subtle invitation to African countries to seek fresh credit facilities, maintaining that it was a ploy to further enslave the continent and destroy the struggling African economies.

The days ahead will determine if African countries will fall for IMF's ploy by approaching the global financial institutions to request fresh loans, but the sad reality remains that African countries have not been able to use the huge borrowings to turn around the fortunes of their countries.

### NCC seeks consumers support to improve telecoms service delivery

Addressing consumers of telecoms services and traditional rulers at the forum, Danbatta who was represented by NCC's

Director, Technical Standards and Network Integrity, Bako Wakil, said to ensure improved telecoms services delivery, communities should protect telecoms infrastructure in their vicinities by allowing the installation of equipment and maintenance of repairs on sites by technical employees of service providers.

Danbatta also enjoined members of respective communities to guard against destruction of telecoms infrastructure, through prompt notification of service providers of ongoing road construction by companies or government agencies to avoid service disruption that might arise from damaged infrastructure.

He added that protecting telecoms infrastructure was important in any community, as the ability to connect and communicate was fundamental to human existence considering its centrality in improving businesses, government services, education, communities and families to share information through seamless connections.

He also pointed out that technological advances have assisted people to gain access to learning opportunities outside traditional schooling.

# WHO blames tobacco industry for global health, environmental hazards

**7** orld Health Organisation (WHO) has declared that the tobacco industry is responsible for the destruction of human health and environments globally and should be held accountable for the environmental violations caused by its activities around the world, especially in lowincome countries.

In a statement issued by the WHO, the organisation revealed new information on the extent to which tobacco damages the environment and human health and advocated steps to make the industry more accountable for the damage it was causing.

It added that the tobacco industry costs the world over eight millions human lives, 600 million trees, 200,000 hectares of land and 22 billion tons of water yearly.

The WHO also accused the industry of depriving human beings and plants of potable water, food and farmlands, especially in developing and low-income countries.

"Most of the tobacco plants grown in low-and-middleincome countries where water and farmlands are often desperately needed are to produce food for those regions. Instead, they are being used to grow deadly tobacco plants, while more land and forests are being cleared," the statement reads.

WHO further highlighted that the industry's carbon footprint from production, processing and transporting tobacco was equivalent to onefifth of Co2 produced by the commercial airlines industry yearly which further contributes to global warming and climate change challenges.

Director of Health Promotion at the WHO, Dr. Rucdiger Krech, noted that about 4.5 trillion cigarette filters pollute oceans, rivers, city sidewalks, parks, soil and beaches yearly, adding: "Tobacco products are the most littered items on the planet, containing over 7,000 toxic chemicals, which leech into our environment when discarded."

While stressing that filters

have no proven health benefits, WHO urged policy makers to treat cigarette filters as single used plastics and consider banning them to protect public health and the environment.

The WHO, therefore, urged countries and cities to emulate France, Spain, San Francisco and California that have adopted the polluter pays principle, which makes the tobacco industry responsible for clearing up the pollution it creates to relieve taxpayers of the costs of cleaning up littered tobacco.

It further advised countries

and cities to follow the example and support tobacco farmers to transit to sustainable crops, implement strong tobacco taxes that could also include environmental tax and offer support services to help people quit smoking and the use of other tobacco products.

#### ABCON urges CBN to use BDCs in promoting market stability

President of the Association of Bureaux De Change Operators of Nigeria (ABCON), Alhaji Aminu Gwadabe, has appealed to the Central Bank of Nigeria (CBN) to use Bureaux De Change (BDCs) to end multiple rates and promote stability in the foreign exchange (forex) market.

CBN operational manual defines BDCs as small retail and institutions licenced to do the business of selling Personal Travel Allowance (PTA), Business Travel Allowance (BTA) and payment of school fees and medical bills abroad, among others roles at the critical part of the forex market.

Gwadabe said the various policies of CBN on the operations of the sub-sector continue to hinder and limit the BDCs from providing their constitutional role in the forex market and

The various polices of the CBN on the operations of the sub-sector continues to inhibit and limit the BDCs from providing their constitutional roles in the forex market and the economy,"

He, therefore, canvassed better collaboration between the CBN and the BDCs in the implementation of market-friendly policies, adding that such synergy would enable the BDCs to impact more positively on the market and promote exchange rate stability in the economy.

Gwadabe said the hasty generalisation that criminalises the BDCs sub-sector was responsible for market crisis and infractions like selling dollars with higher premium above regulatory limit, promoting loss of confidence in the market, adding that multiplicity of the exchange rates was not in the best interest of the market and the economy.

"It is in view of this disturbing situation and the need to strengthen BDCs value chains obtainable in organised climes that we urge the regulators and policy makers to consider BDCs as the most potent tool in liberalising the foreign exchange market and ending multiple exchange rates in the system," he said.

He restated the association's commitment to boosting liquidity in the forex market, fulfilling its regulatory mandate of bringing forex closer to the end users and supporting the CBN's goal of achieving sustainable exchange rate stability.

"We, therefore, urge the regulators to consider our proposal for the creation of Bureaux De Change Autonomous Foreign Exchange Market (BAFEX) to replicate the Import and Export (I&E) window initiative and address concerns of stakeholders like Nigerians in the Diaspora, foreign investors, international financial institutions and others about the market stability," he

# OPEC raises Nigeria oil exporting quota for July

Organisation of Petroleum Exporting Countries (OPEC) has raised Nigeria's oil production quota from the 1.772 million barrels per day (mbpd) to 1.799mbpd for July, 2022.

OPEC said this at the weekend during the resolution was taken at its 29th OPEC and non-OPEC ministerial meeting. The new target of 27,000 barrel per day is higher than the approved quota for June 2022.

According to the statement, OPEC has also adjusted upward

the monthly overall production by 646,000 barrels per day in July 2022 with a target production of 43,000 million barrels per day for OPEC members.

The meeting noted that the most recent reopening from lockdowns in the major global economic hubs and highlighted the importance of stable markets for OPEC and the non-OPEC members.

It also stressed the importance of stable and balanced markets for OPEC and non-OPEC members for crude oil and refined products, adding that the meeting extended the period to the end of December 2022 as requested by some underperforming countries.

It added that the meeting directed that compensation plans should be submitted in accordance with the statement of the 15th OPEC and non-OPEC ministerial meeting.

A survey showed that Nigeria's production output averaged 1.4 million barrels per day in May 2022, amounting to 70,000 barrels higher than the average daily crude oil production in April, which stood at 1.3 million barrels per day.

Union Bank has also notified the NGX that with the completion of the transaction, TGI Group, parent company of TTB now becomes the majority shareholder in Union Bank.

The bank further said the completion of divestment of the bank's shareholding in its record as of March 4, 2022 pro rata to its existing shareholding interest in the financial institution.

Consequently, Union Bank United Kingdom (UKBK) was not included in the transaction with Titan Trust Bank.

Also, Union bank notified the NGX of the resignation and retirement of directors from the board of Union Bank including the Chairman, Mrs. Beatrice Hamza Basset; non-Executive Director, Emeka Okonkwo.

Others are non-Executive Director, Mrs. Obafunke Alade-Adeyefa; Independent non-Executive Director; Richard Burret, non-executive directors, Ian Clyne; Kenroy Dowers; Paul Kokoricha and Emeka Ogbechie, among others.

Speaking on behalf of the outgoing directors, Basset, said: "We have recorded a significant milestone with the completion of the transaction after regulatory approval of the announcement in December between the bank's core shareholders and Titan Trust

"As is normal for transactions of this nature, the board and Chief Executive Officer (CEO), Emeka Okonkwo, has retired and handed over management of the bank to a new board with Mudasir Amray as Chief Executive Officer (CEO). The board congratulates the parties on the landmark transaction."


### NACCIMA, Spain chamber of commerce sign MoU

# 'Nigeria removed from piracy-prone countries' list'

• Says collaboration with French Naval Ship would build technical strength

lag Officer Commanding (FOC), Western Naval Command (WNC), Rear Admiral Yakubu Wambai, has said Nigeria was recently delisted from countries prone to piracy attacks.

Wambai said this when he hosted the visiting French Naval Ship BORDA and its crew weekend at the Headquarters Office of the Naval Base in Apapa, Lagos, adding that the technical collaboration between the Nigerian Navy and the French Naval Ship BORDA, for trainings and Sea passage

exercises would enhance the improved security experience in the Gulf of Guinea (GoG).

He said, "The French Naval Ship BORDA is on a port call, which is customary. Though this is a specialised ship, a hydrographic ship, which is here in fulfilment of technical support to NNS LANA.

"While here, they will work and train together, to continue to build our ability in the hydrographic field. This is the continuation of our collaboration with France. They have been our technical partners, building our ships and training us.

"It marks a remarkable turning

point for our collaborative efforts as we continue to seek better times in the Gulf of Guinea.

"Not long ago, Nigeria was delisted from piracy-prone states, and this was possible as a result of our collaborations, not only of Nigerian Navy, but other stakeholders as well. We hope to see more of this kind of visits and hope to go back to the old days when we also pay port calls to foreign nations."

In his remark, Commanding Officer of the French Naval Ship - Lt. Commander Pierre - Henry Lavergne, described his experience so far with the Nigerian Navy Ship LANA as very welcoming, saying he looked forward to more engaging activities.

"It is a great pleasure for me and my crew to be in Lagos for the hydrographic cooperation with NNS LANA since four days of being here," the Commanding Officer said.

Meanwhile, French Defence Attaché, Col. Dujon Guillaume, stated that the first step in the cooperation since the acquisition of NNS LANA from a French company, OCEA, has shown that they would want more engagement with the Nigerian Navy in the future as well.

He said, "Here for some

Commissioner of Police (CP) in charge of the Lagos State Command, CP Sylvester Alabi has said that any society that undermines the strategic role of journalists in fighting crime would be doing so at its own peril.

Alabi made the remark while interacting with the newly elected officers and members of the Crime Reporters Association of Nigeria (CRAN) at Mike Okiro Press Centre, Ikeja Lagos at the weekend.

The Police Commissioner noted that experience had shown that enforcement of the law by the police and dissemination of relevant crime information would not be possible without journalists.

He restated his commitment to

always collaborate with journalists and crime reporters in a bid to promote a crime free society.

Alabi also assured the visiting Crime Reporters that his administration would always carry them along as strategic partners in law enforcement and crime fighting.

He congratulated the new Executive Committee of CRAN headed by Mr Lekan Onabulo, assuring them of his cooperation.

While commenting on the recent ban on commercial motorcycles in Lagos by the State Government, the CP said as law enforcement agency, his Command has been complying with the directive of the government.

He, therefore, enjoined journalists and crime reporters to fully cooperate with the police in terms of crime reportage.

### Police confirm identity of victim stoned dead, lynched by zealots

Federal Capital Territory (FCT) Police Command has said that it is investigating the killing of a young man by Islamic fanatics for alleged blasphemy weekend in the Lugbe area of Abuja.

The Command's Public Relations Officer, Josephine Adeh, confirmed the development to newsmen, pledging that it would soon arrest the perpetrators.

Adeh identified the victim as Ahmad Usman, a 30-year-old man who is said to be a vigilante.

She said, "Normalcy has since been restored to the area concerning the situation while monitoring, and surveillance of the area continues.

"Residents are, however, urged to go about their lawful duties without fear or apprehension of any kind from any quarters as discrete investigation continues to unravel facts surrounding the ugly incident and to effect the arrest of the perpetrators therein.

"We understand that one Ahmad Usman a 30 years old member of the local vigilante around Tippa garage at Federal Housing Estate in Lugbe Area of the Federal Capital Territory got into an argument with a Cleric (Mallam) whose name is yet unknown from the same area.

"The heated argument degenerated into an outbreak of violence that led to the murder and setting ablaze of Ahmad Usman by the enraged mob mobilized by the clergy numbering about two hundred.

"Upon the receipt of this infor-

mation, a quick intervention team comprising of the Surveillance and Ambush team of the Command attached to the Lugbe Divisional Police Headquarters was drafted to the scene where the enflamed victim was rescued suffering severe degrees of burn and taken immediately to the hospital where he was confirmed dead by a Doctor on call."

The Commissioner of Police, Babaji Sunday, who also spoke to newsmen, warned against the indiscriminate resort to jungle justice

"We are outrightly against jungle justice. The law is against it, and adequate sanctions will be meted on subscribers of this crude and dastardly act," he said.

### CSO asks INEC to lead presidential aspirants on protest over insecurity

A Civil Society Organisation (CSO), the West African Action Network on Small Arms – Nigeria (WAANSA – NIGERIA) has called on the Chairman of the Independent National Electoral Commission (INEC), Professor Mahmood Yakubu, to mobilise all presidential aspirants of political parties for the 2023 general election on a one week protest against worsening insecurity in the country.

This was contained in a letter signed by WAANSA – NIGERIA President, Temitope Lamidi and Director of Media and Advocacy, Martins Igwe, which was obtained by The Trumpet.

According to the CSO, the protest should be part of activities to mark this year's Global week of Action against Gun Violence scheduled for 1st June – 8th June 2022.

The letter reads, "We will not be doing justice to Nigeria and Nigerians, if we refuse to advise your office that is working day and night to ensure that 2023 general election is a thing of reality. United Nations International Children's emergency fund confirmed that over 1000 students were abducted since 2020. 200 are still in captivity.

"Professor Osibanjo's class mate, son of Northern Elders Forum and Sixty two others are still in captivity, this may not include Chibok, Dapchi, Kaduna and Kebbi abductions. This remains a sad reality which demands for urgent attention as you mobilize for a peaceful elections.

"We advise strongly on the need to liase with the Inter-Agency consultative committee on election security to lead all Presidential aspirants to an intensive one week of protest and constructive engagement with our security agencies until Nigerians who are victims of gun violence all over the country are released.

"It will serve as a reassurance that they have the political will to overcome national challenges and a palpable move by INEC leadership to peace."

WAANSA – NIGERIA described the state of insecurity in the country as a sad reality which demands urgent attention, and noted that there must be a guarantee of peace before INEC sends 1.5million proposed Adhoc staff to the 176,846 polling units across the country.

"Presently, the continuous voters registrations exercise is not taking place in some frontline local governments with heightened insecurity while in others It is restricted in local Government and state offices. The victims of gun violence presently in captivity and internally displaced centers can determine the faith of a presidential candidate hence the urgent need to join this protest in solidarity to 2022 Global week of action against gun violence.

"There must be a guarantee of peace in our local communities before sending your proposed 1.5million Adhoc staff at 176,846 polling units. Presidential aspirants will compliment the sacrifice of our security Agencies and this will directly affect the turnout of elections come 2023.

"If you make yourself available, Nigerians will be happy to see Bola Tinubu, Rochas Okorocha, Atiku Abubakar, Prof Yemi Osibanjo, Rotimi Amaechi, Peter Obi, Yerima Bakura, etc, unite for this course before their campaigns

"As we mark the beginning of global week of Action Against Gun violence, led by international Action network on small arms and light weapons aimed at eliminating gun violence and misuse of small arms, we appeal to your office to do anything in line with the dictates of law to reassure Nigerians of a peaceful environment where they will exercise their franchise without threat to your staffs and general public," the letter added.

### NWFL sanction Naija Ratels, Bayelsa Queens' chairmen

League (NWFL) have sanctioned the chairmen of Ratels Football club, Abuja and Bayelsa Queens over disciplinary conduct.

NWFL in a letter addressed to the Chairman NWFL letter of Naija Ratels, Barrister Edeh, stated that the club in one of their matches in the NWFL Premier League Super Six tourney at Benin City, refused to wear Tulcan Energy sponsored jersey which contravened the NWFL Statutes on Sponsorship, in Articles 7.8, 7.9, 7.10.

According to the letter signed by Chief Operating Officer of the NWFL, Modupe Shabi, the board said, "We kindly refer you to the Match No. 2 between Nasarawa Amazons FC and Naija Ratels FC, scheduled for the 16th May, 2022 in Benin City, Edo State.

"You will recall that your club failed to wear the Tulcan Energy branded jerseys even though the other participating teams agreed to wear the sponsor's jersey.

"This single action by Naija Ratels FC almost brought the game disrepute and the credibility of the league into question,' the NWFL stated.

However, the league governing board decided that following the breach of NWFL Statutes on Sponsorship, in Articles 7.8, 7.9, 7.10 by Naija Ratels, invoked Article 23.2.2 which says: "Any club owner/ official that brings the game into disrepute or ridicule the NWFL in public through utterances, misconduct, communication or any form of communication will be sanctioned with the payment of the sum of (N2,000,000) Two million naira, and three months suspension."

In a related development, the champions of the Super Six tournament, Bayelsa Queen were also charged for unguided utterances capable of tarnishing the image of the NWFL.

In a letter addressed to the chairman of Bayelsa Queens, Mr Robin Aprela, the NWFL stated that Aprela

Aisha Falode of being biased while trying to favour a team ahead of others.

The letter reads: "We refer you to the incident before the kick-off of the Super Six, ahead of the match between Bayelsa Queens and Rivers Angels held in Benin City, where you made some disparaging comments about the Nigeria Women Football League and also accused the Chairperson (Madam Aisha Falode) of manipulating to favour certain club.

"The action of the Bayelsa Queens FC Chairman almost brought the game to disrepute and credibility of the league to question, which contravened the following Articles 23.1 which states that 'Players, club officials and every person involved in the league shall at all times act in the best interest of the game and comply with the principles of fair play, sportsmanship, the rules and regulations governing the league and not act ( whether through words, conducts or behaviour) in a manner capable of bringing the game into disrepute; failure of which constitutes misconduct and a breach of the league rules.

"Article 23.2.2 reads: club owner/official Anv that brings the game into disrepute or ridicules the NWFL in public through utterances, misconduct, communication or any form of communication will be sanctioned with the sum of (N2,000,000) Two million naira, and three months suspension.

Consequently, your club (Bayelsa Queens) has been fined the sum of (N2,000,000) Two million naira only for bringing the game to disrepute and ridiculing the NWFL in public. We believe this fine will serve as a deterrent and strong warning to Bayelsa Queens FC," the letter stated.

NWFL Chief Operating Officer, Modupe however, waived off the 3 months suspension served on both chairmen after they tendered an unreserved apology for their misconduct.

# Pope urges 'real' talks in Ukraine war

atholic Pontiff has Francis reiterated negotiations to resolve the war in Ukraine, which he described as "increasingly dangerous escalation.

"As the fury of destruction and death the rages and clashes flare, fueling an escalation that is increasingly dangerous for all, I renew my appeal to the leaders of nations: Please do not lead humanity to destruction," the pontiff said from the window of the apostolic palace in St Peter's Square.

More than a hundred days since the start of the war, the pope called for real negotiations for a ceasefire and a solution to end it.

On Saturday, the 85-yearold pope confirmed his desire to visit Ukraine, but said he wanted to wait for "the right moment".

Since Russian President Vladimir Putin authorized an all-out assault on his pro-Western neighbor on February 24, tens of thousands of people have been killed, millions have been forced to flee, and communities have turned into rubbles.

# Philippines volcano eruption leaves ash over towns

A huge, dark cloud was spewed by a volcano in the eastern Philippines at weekend, prompting evacuations from ash-covered while authorities towns warned of possible further eruptions.

The blast from Bulusan volcano in the rural Sorsogon province lasted about minutes, sending a grey plume shooting up at least 1km, according to the Philippine Seismology (PhiVolcs).

No casualties were reported, but authorities raised the alert level to one on the five-level system, indicating "low-level unrest"

"There was a phreatic eruption of the Bulusan volcano, meaning the explosion was caused by the boiling water under the crater," institute head Renato Solidum told local radio DZBB.

A group of 14 hikers and four local guides were midway down the 1,565m mountain,

shooting up on the other side of the mountain, civil defence official Leo Ferreras of nearby Barcelona town told AFP by

"All of them got down safe and sound," he added.

The local government of Sorsogon, about 500km south of the capital Manila, said 10 villages in two towns were affected by the ashfall.

Pictures of the aftermath showed houses, roads, and trees in Juban town covered in ash, with vehicles struggling to

navigate the road due to poor

Authorities deployed a fire truck to clear the area and residents helped sweep the ash off the roads.

"The evacuation is ongoing there, but our priority is senior citizens and those with asthma," Juban disaster official Dennis Despabiladeras said.

The Manila airport authority said no flights have been affected by the eruption so far, though pilots were warned about coming near the area.

four-kilometre radius around the volcano is prohibited and advised those living next to it to be cautious "due to the increased possibilities of sudden and hazardous phreatic eruptions"

Residents near the valleys and rivers were also alerted about the danger of mud and stream flows in the event of heavy rainfall.

Bulusan volcano has been active in recent years, with a dozen similar eruptions recorded in 2016 and 2017.
